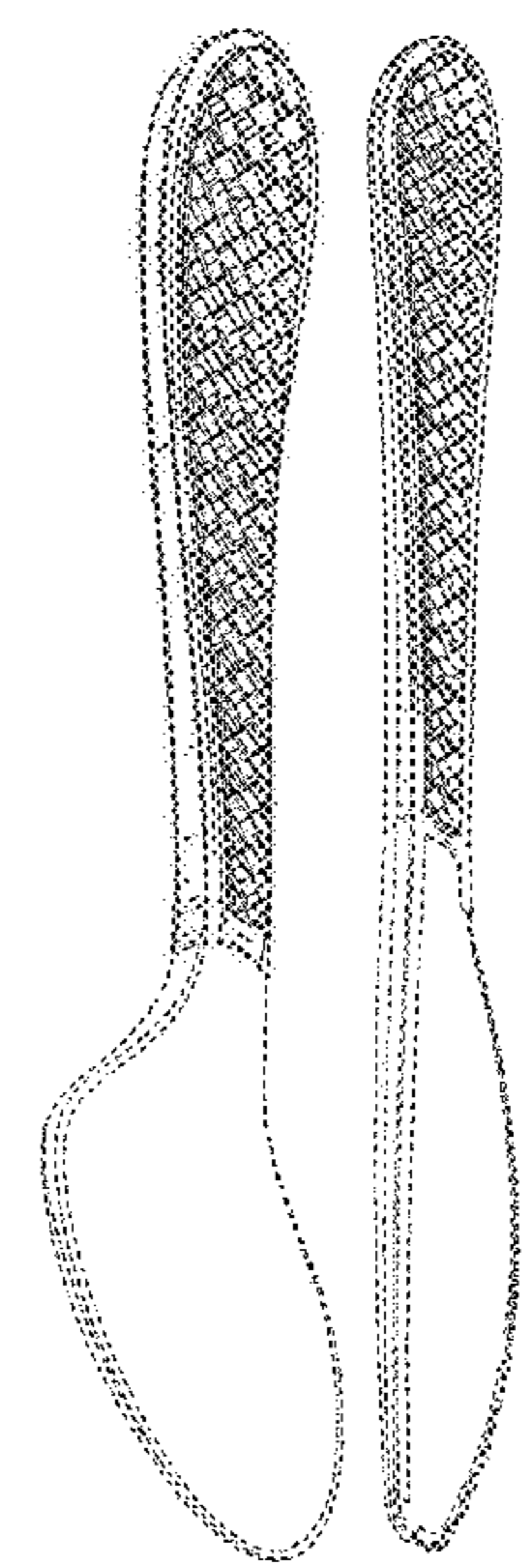

The ornamental design for flatware handle, as shown and described.

DESCRIPTION
FIG. 1 is a top perspective view of a flatware handle in accordance with a first embodiment of my invention;
FIG. 2 is a side perspective view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is bottom view thereof;
FIG. 5 is a left-side view thereof;
FIG. 6 is a right-side view thereof;
FIG. 7 is an end view taken from the curved tip of FIG. 1;
FIG. 8 is an opposite end view of FIG. 7;
FIG. 9 is a top perspective view of a flatware handle in accordance with a second embodiment of my invention;
FIG. 10 is a side perspective view of the flatware handle of FIG. 9;
FIG. 11 is a top view thereof;
FIG. 12 is bottom view thereof;
FIG. 13 is a left-side view thereof;
FIG. 14 is a right-side view thereof;
FIG. 15 is an end view taken from the curved tip of FIG. 9; and,
FIG. 16 is an opposite end view of FIG. 15.

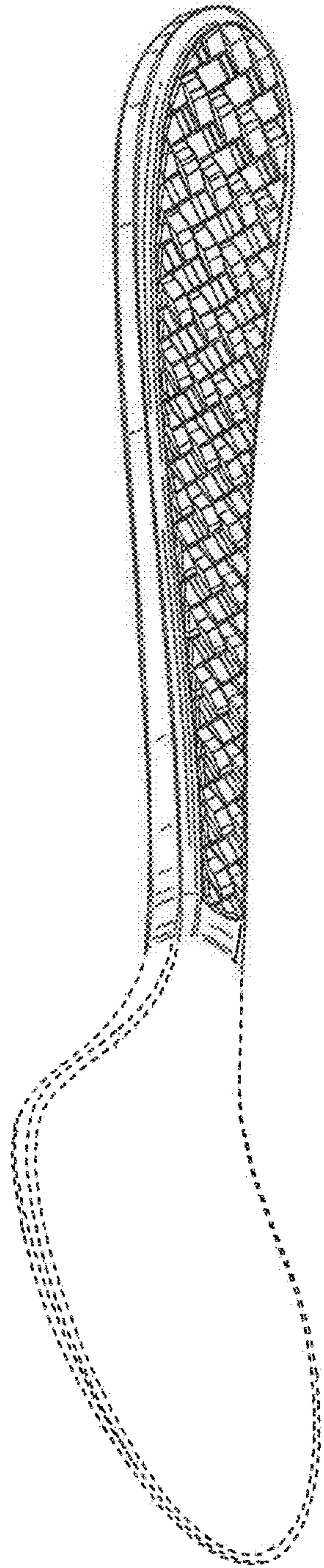

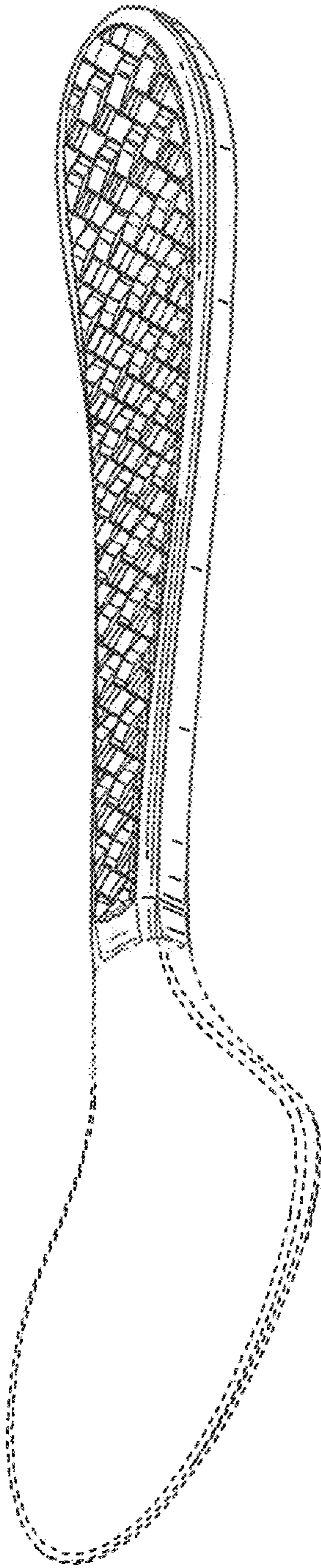

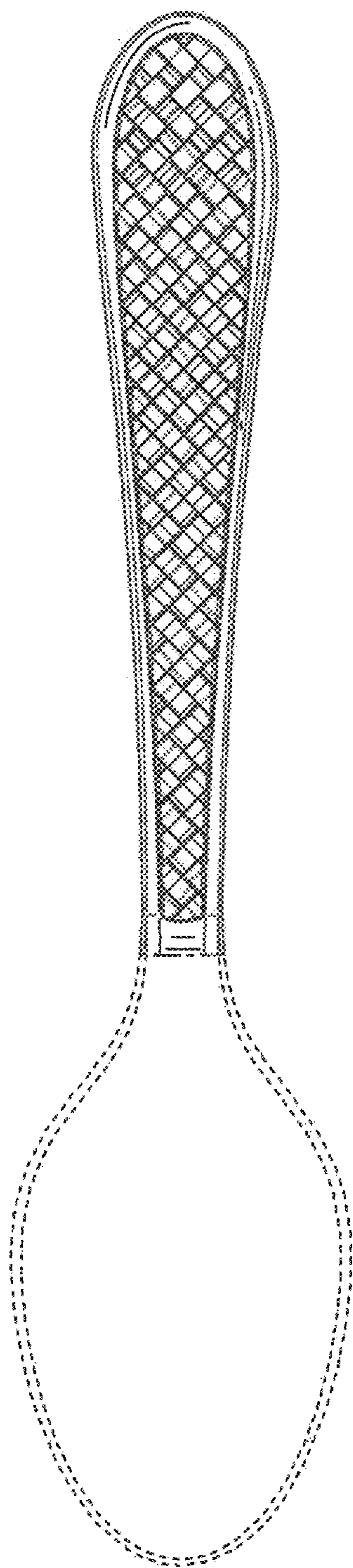

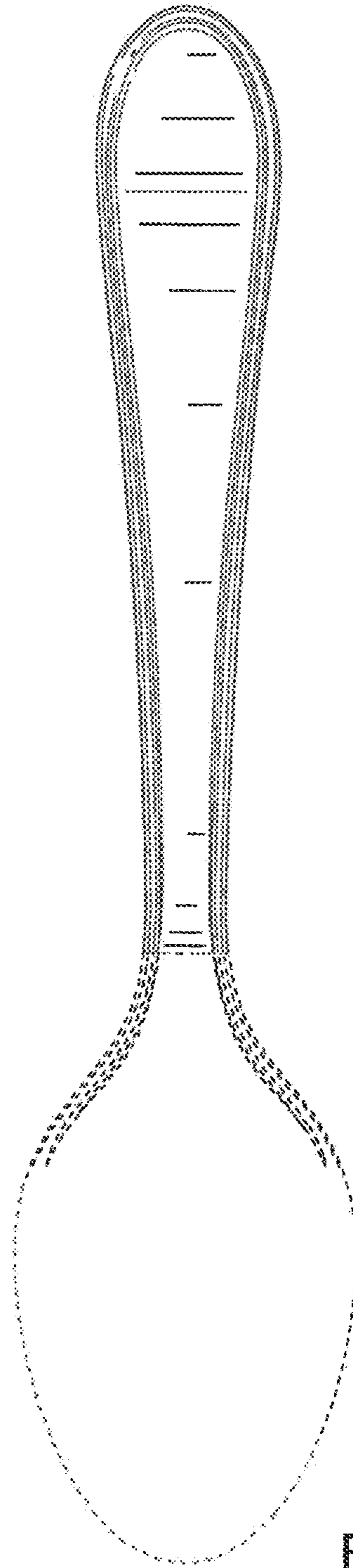

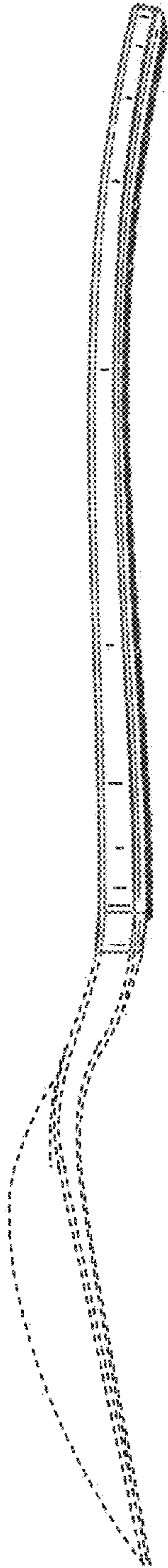

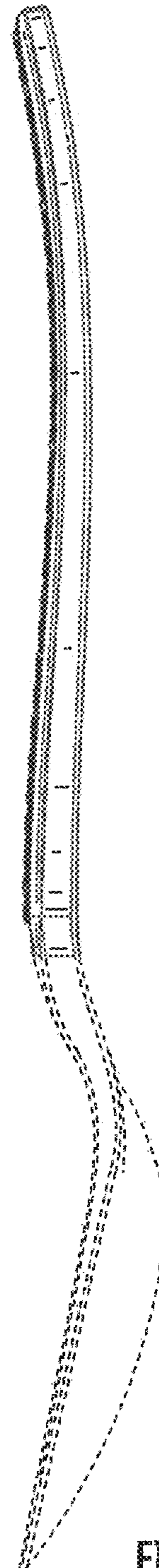

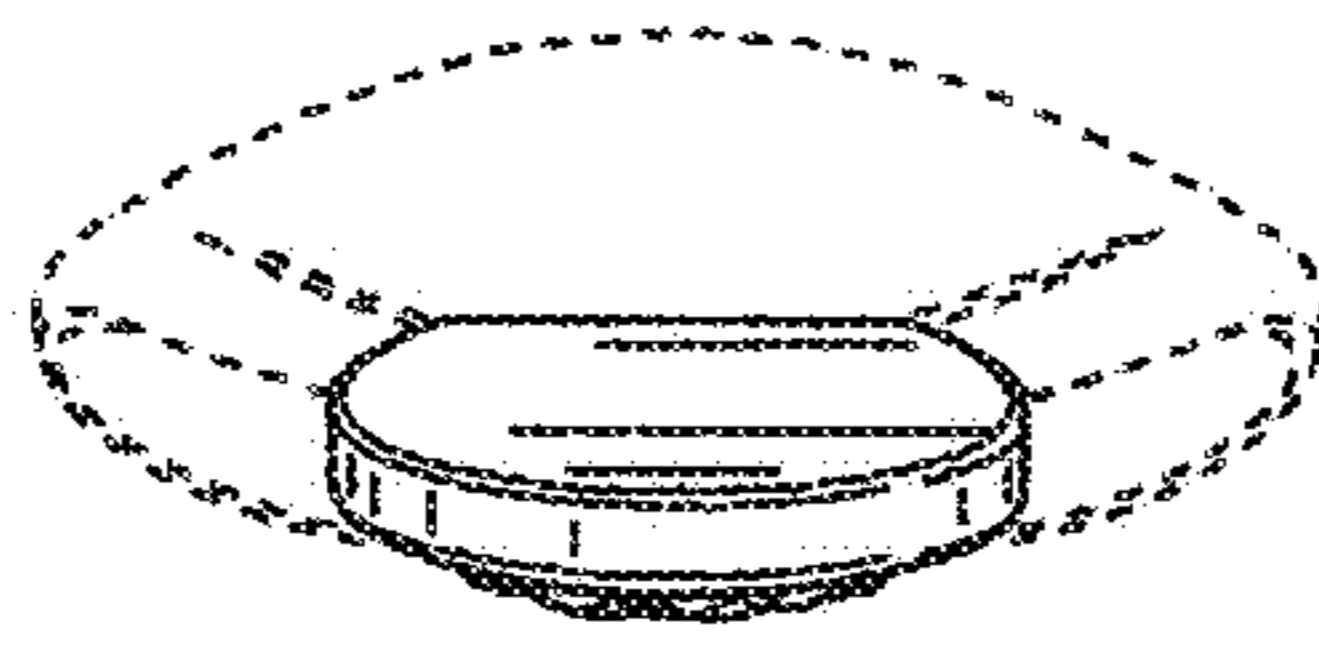

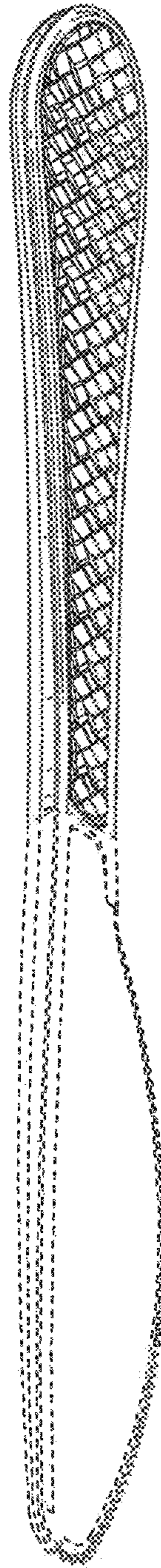

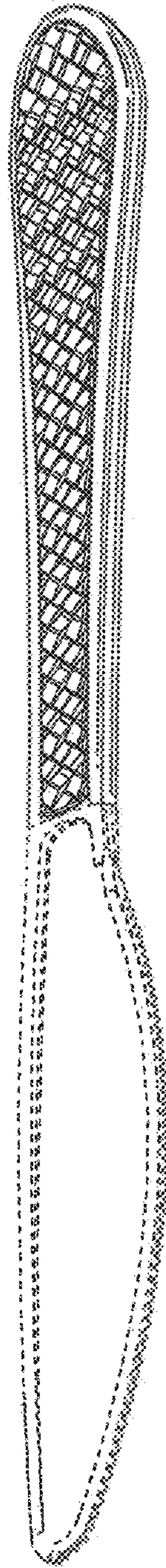

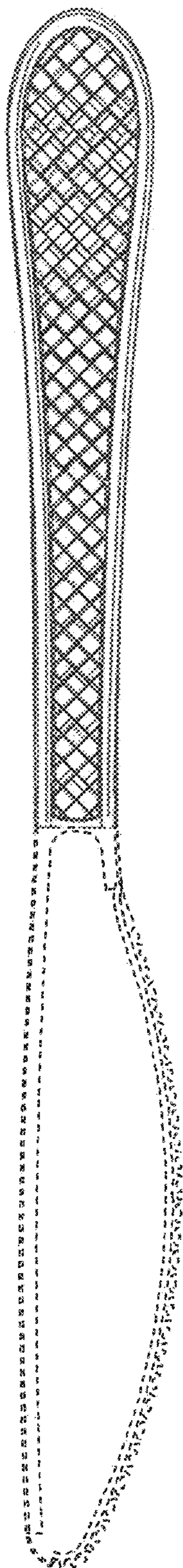

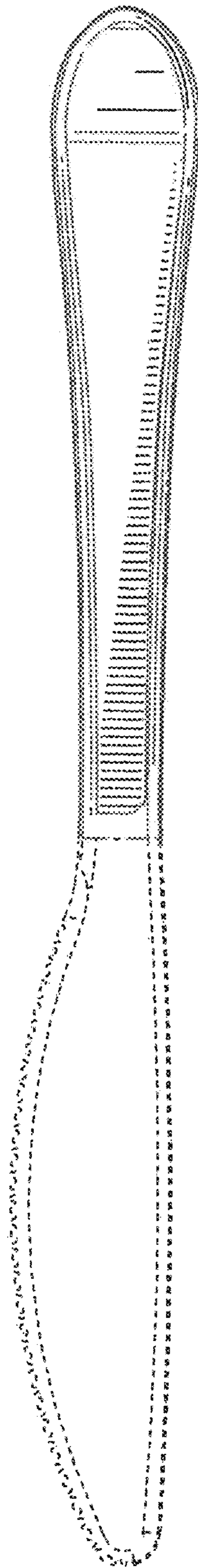

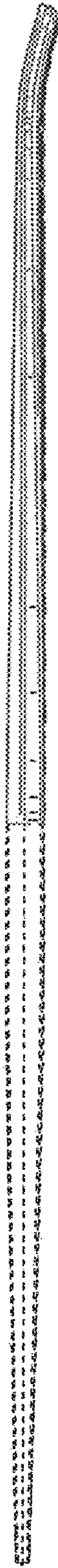

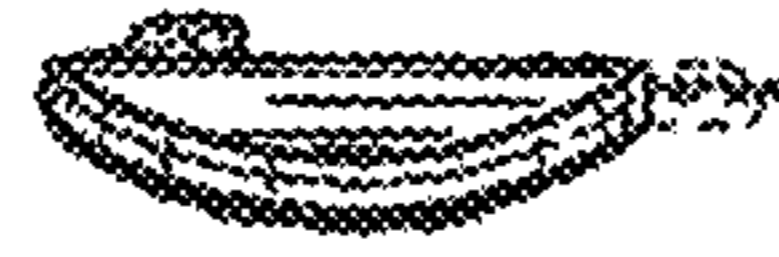
