**DESCRIPTION**

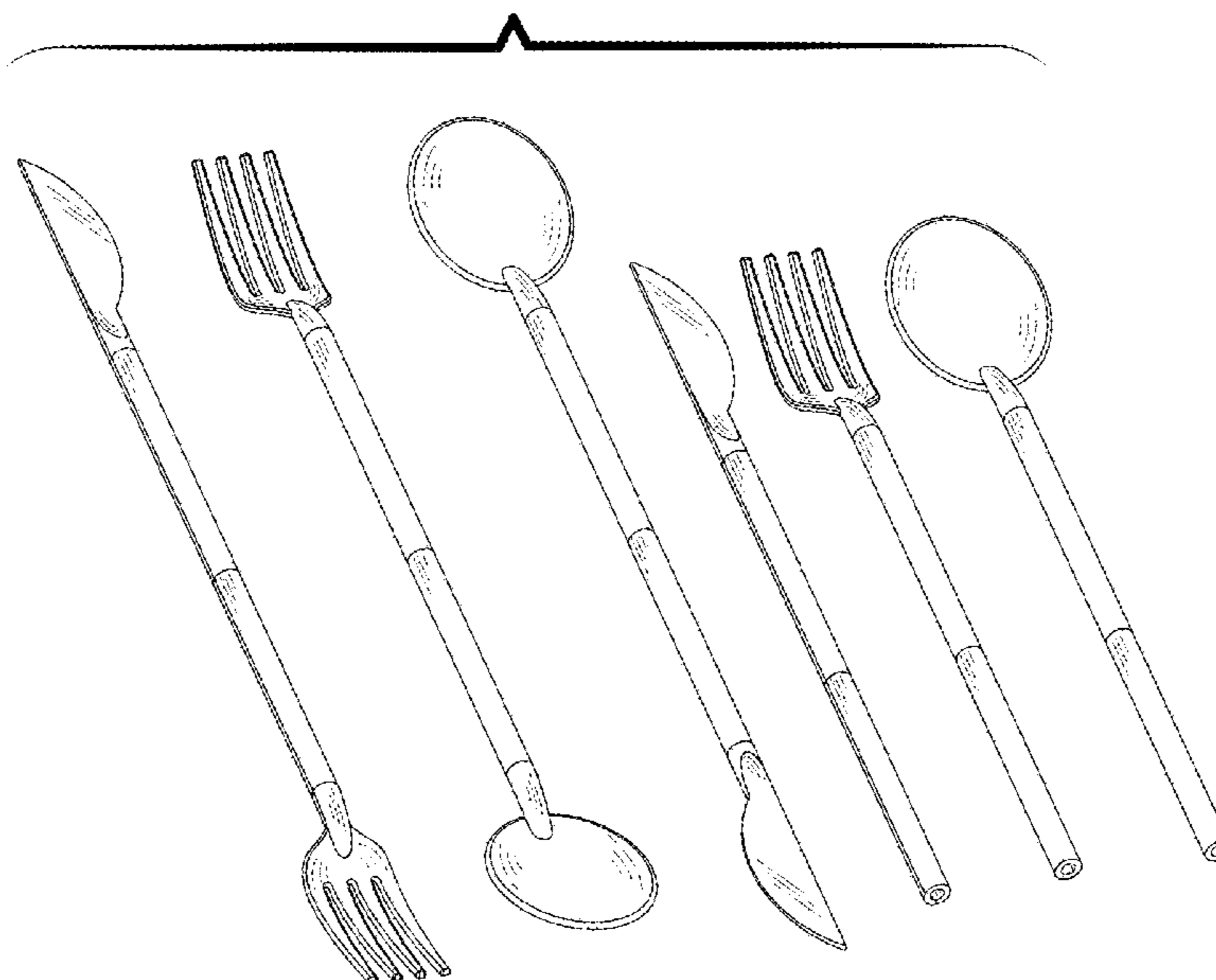
FIG. 1 is a perspective view of a portable cutlery set showing my new design;

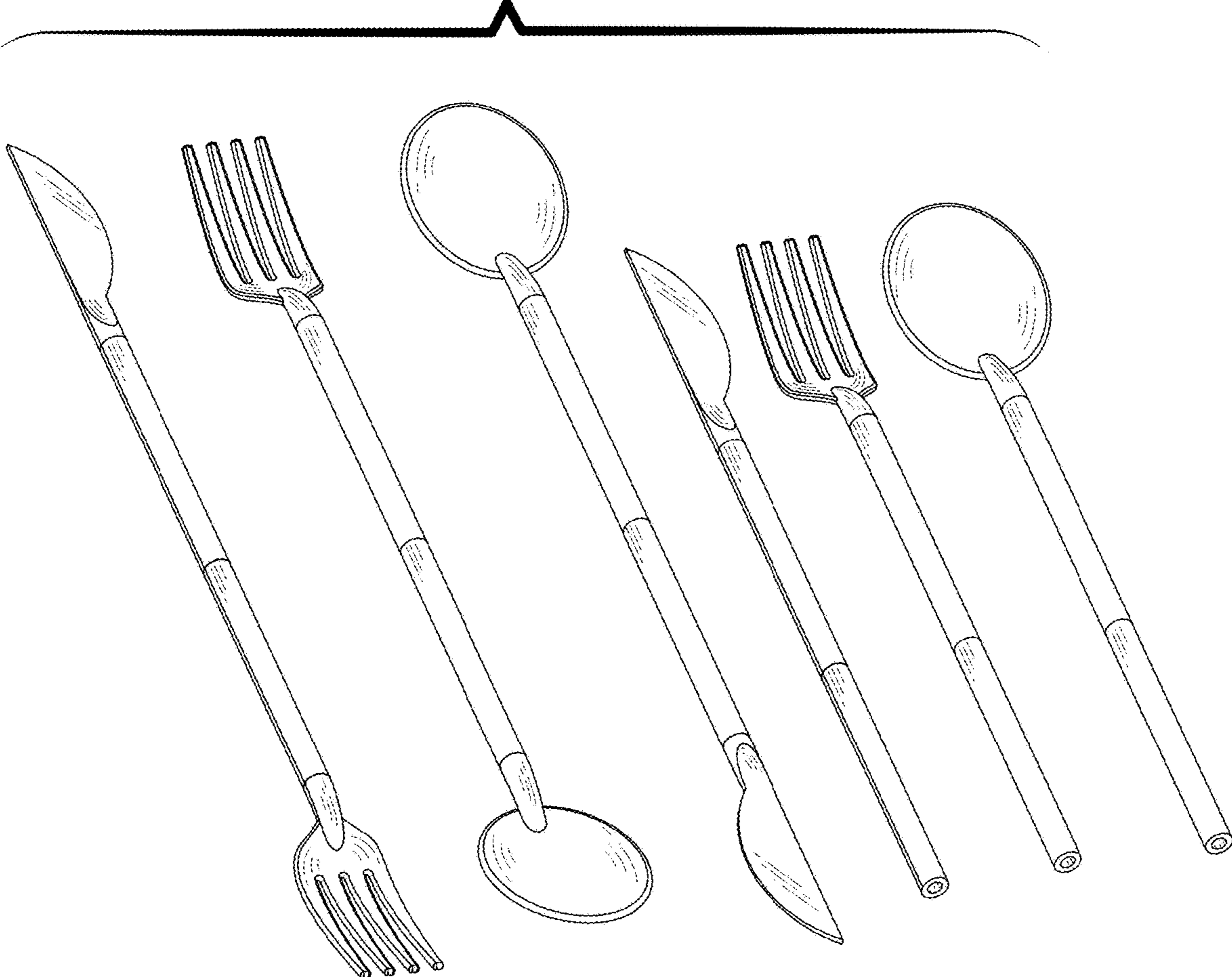

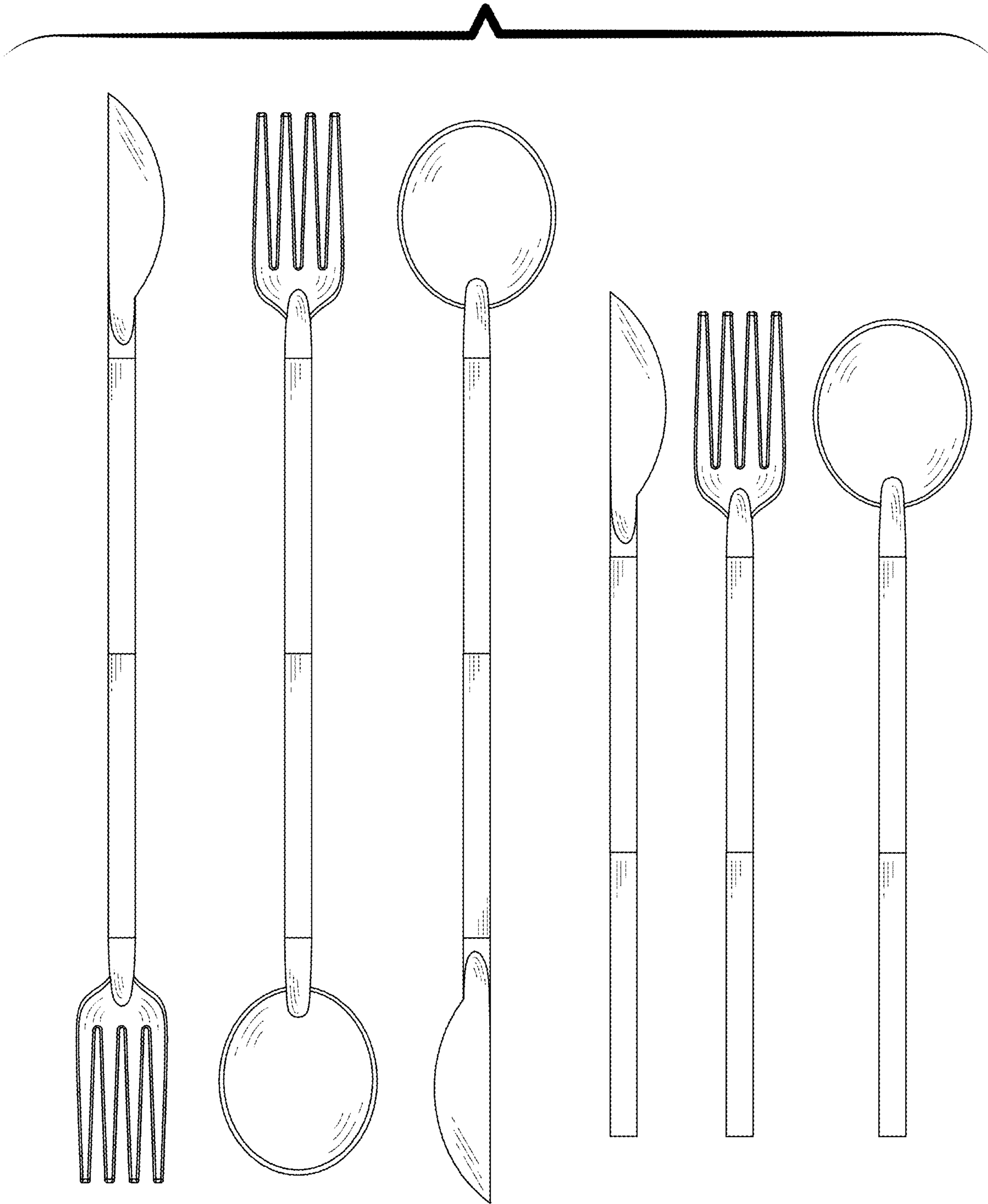

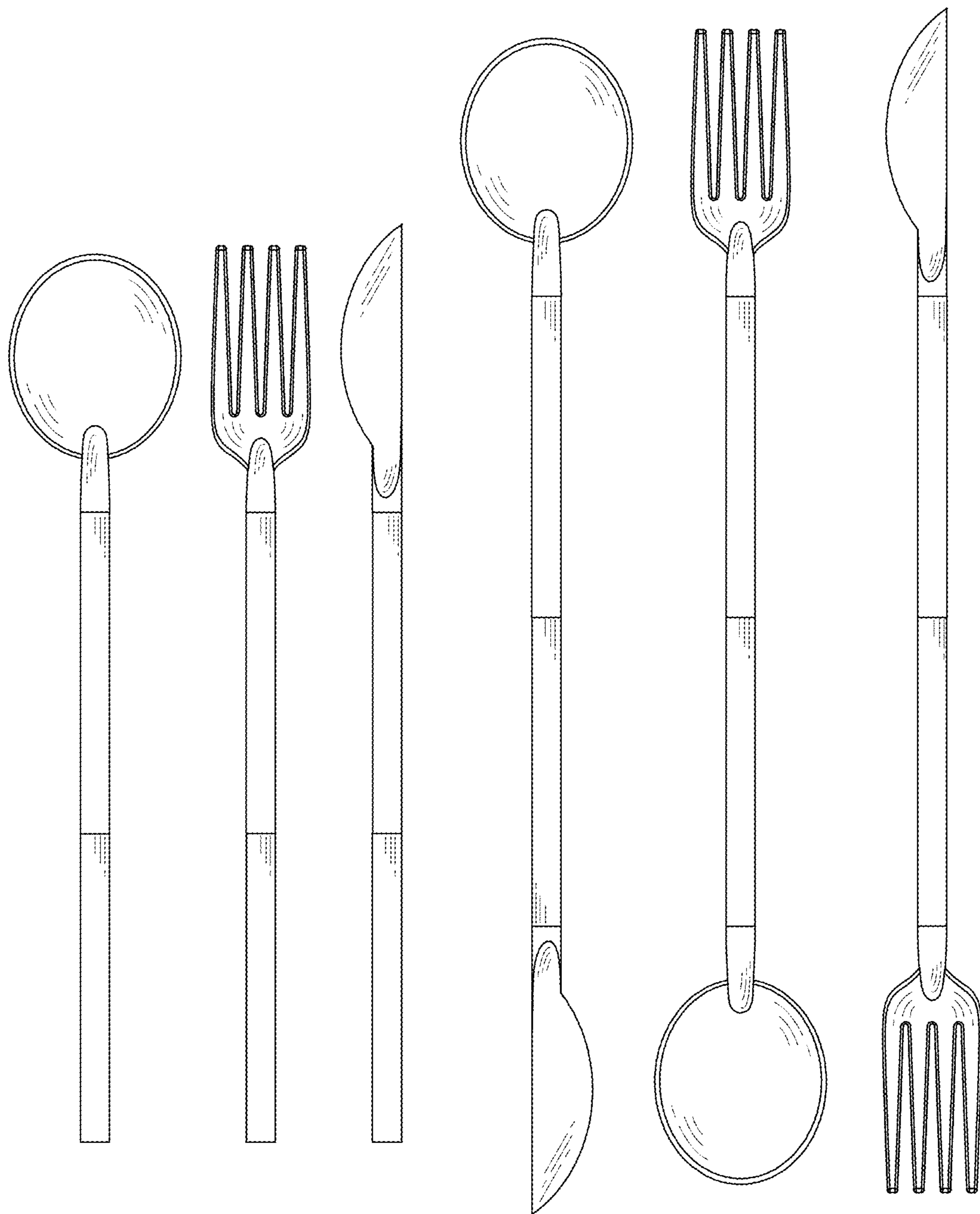

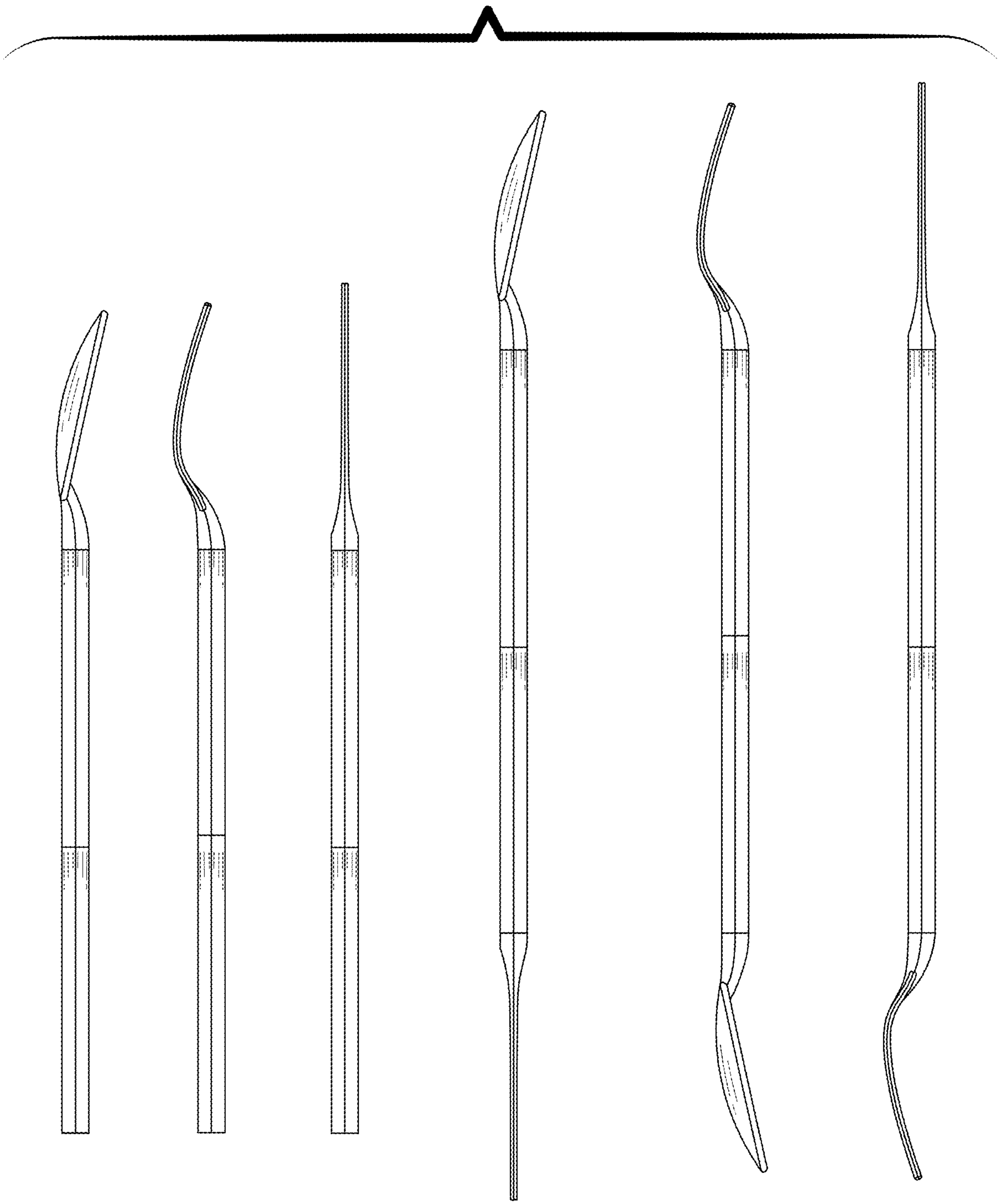

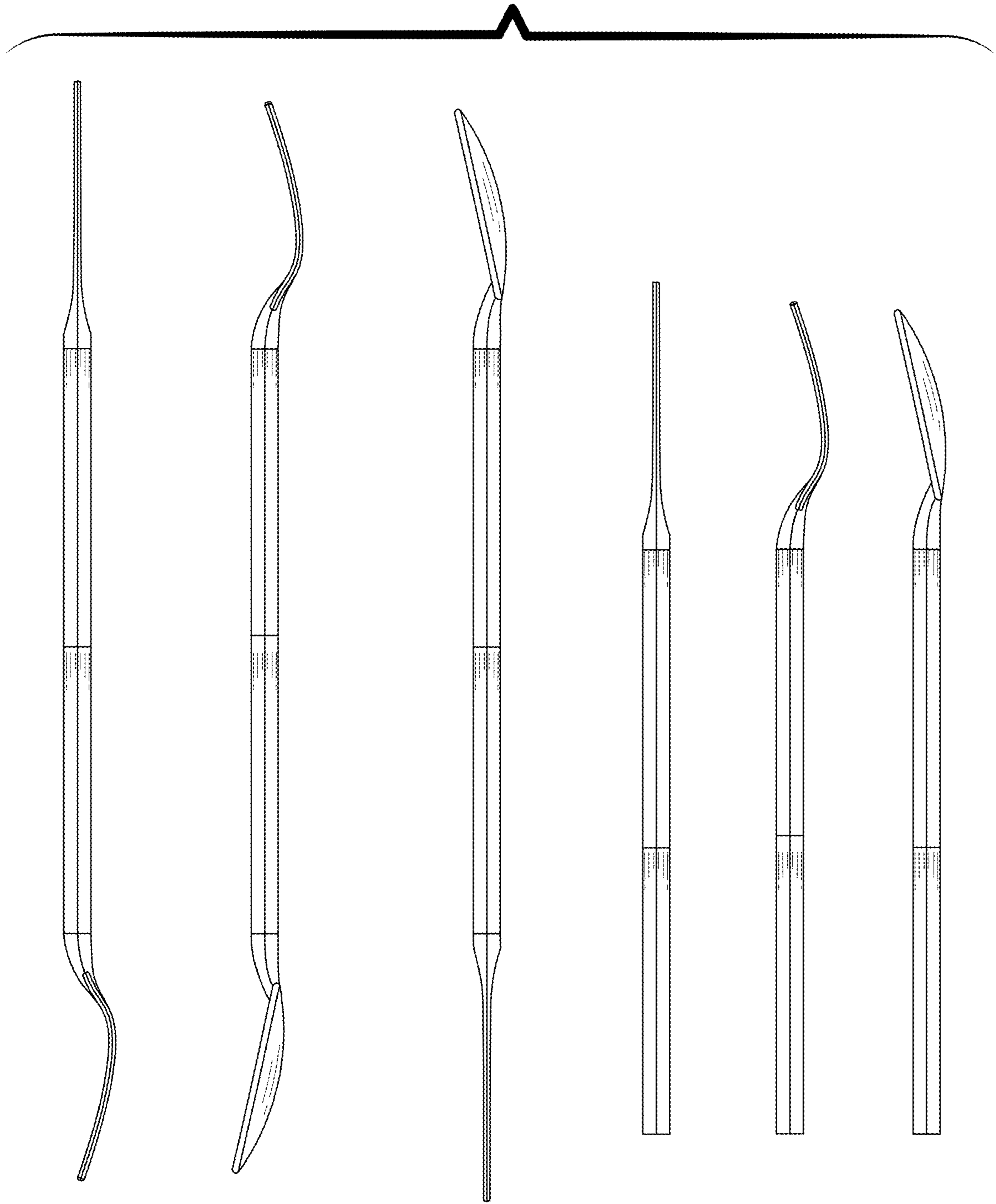

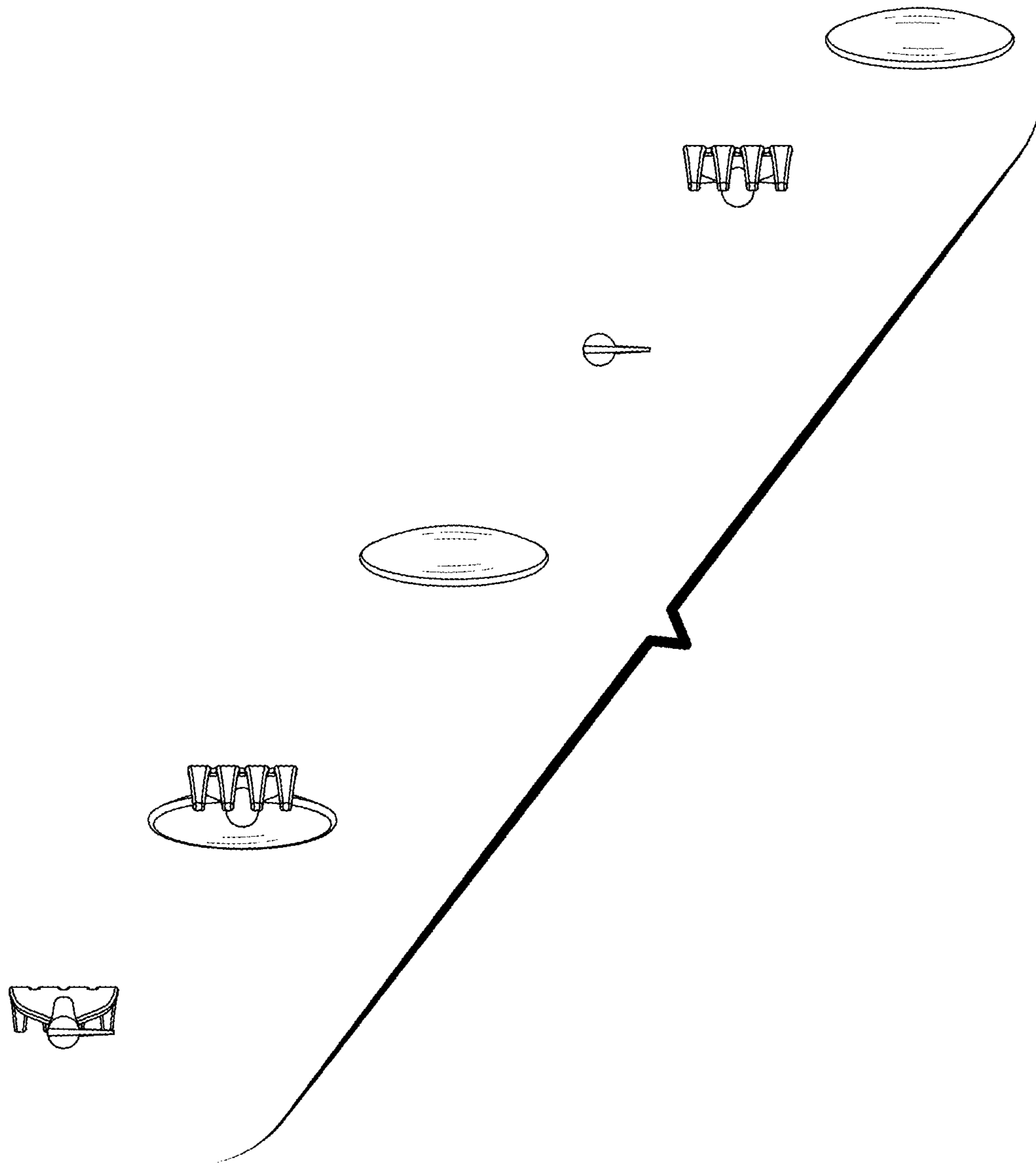

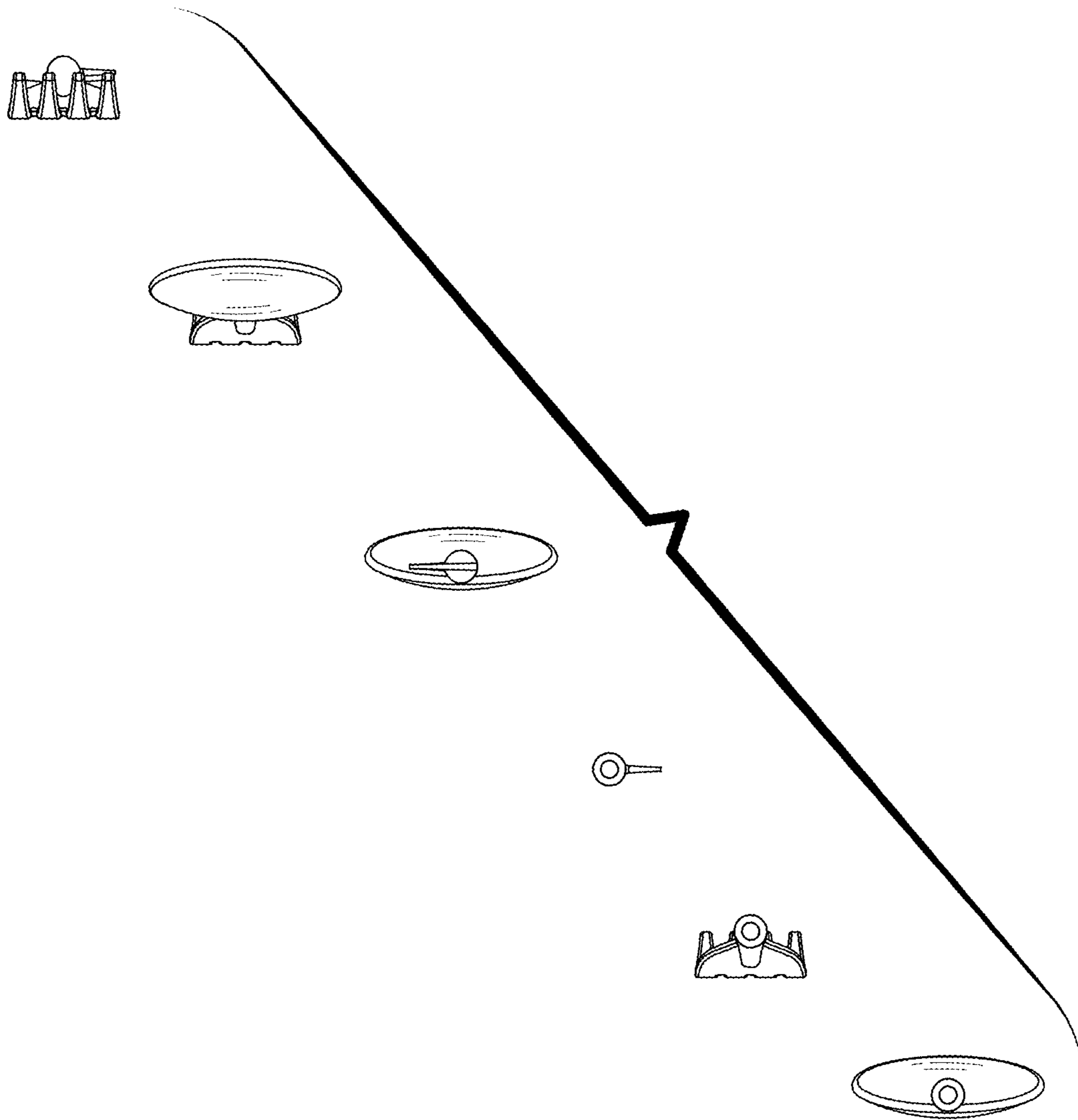
