Figure 2.1 is a perspective view thereof;

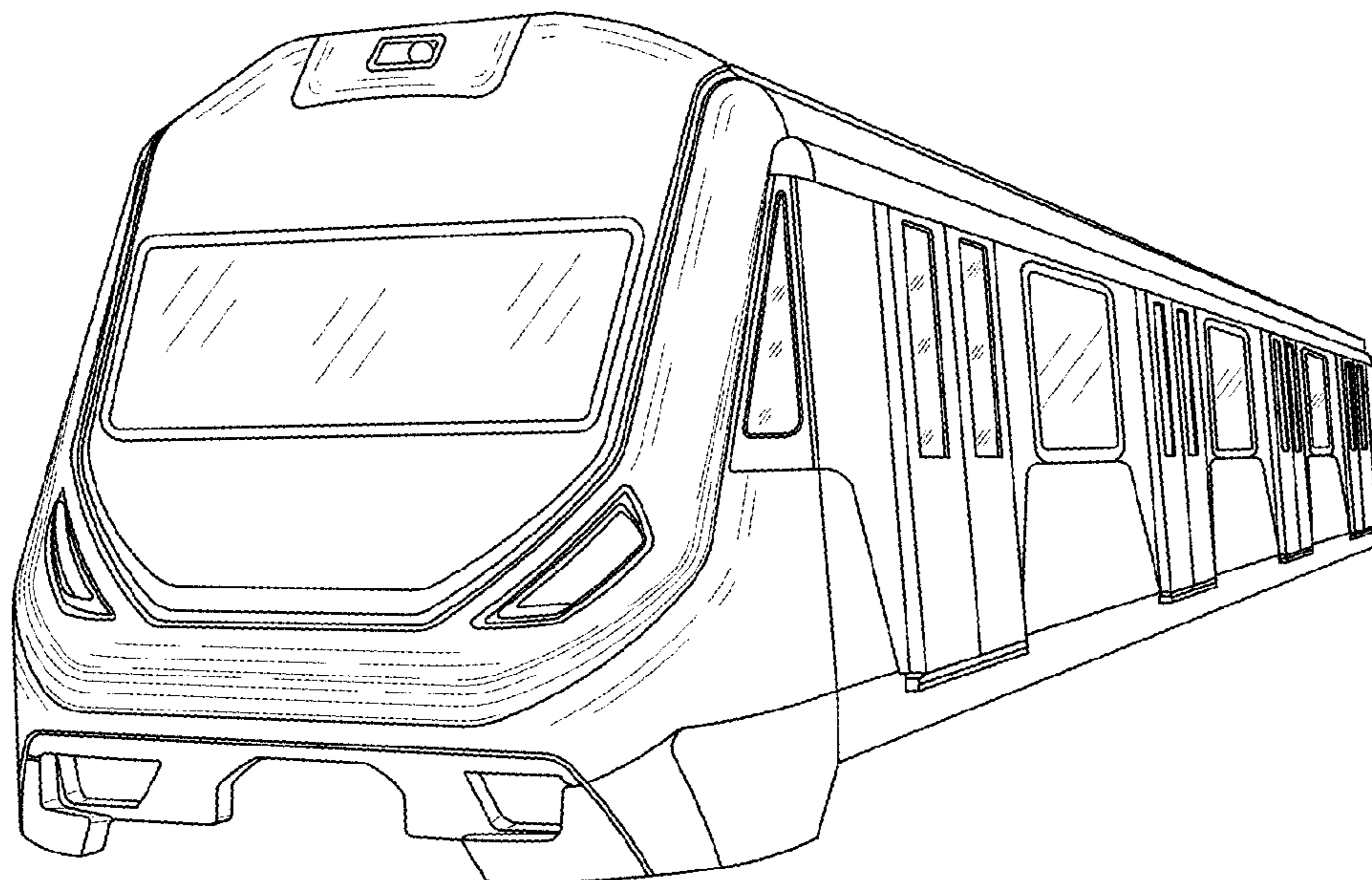
Figure 2.3 is a front elevation view thereof;

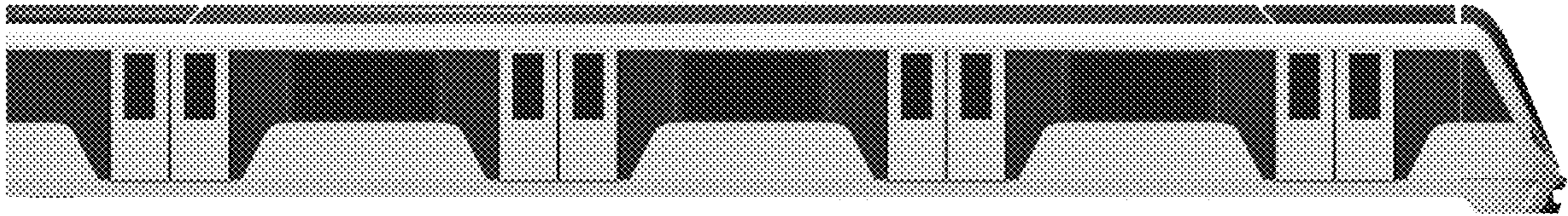

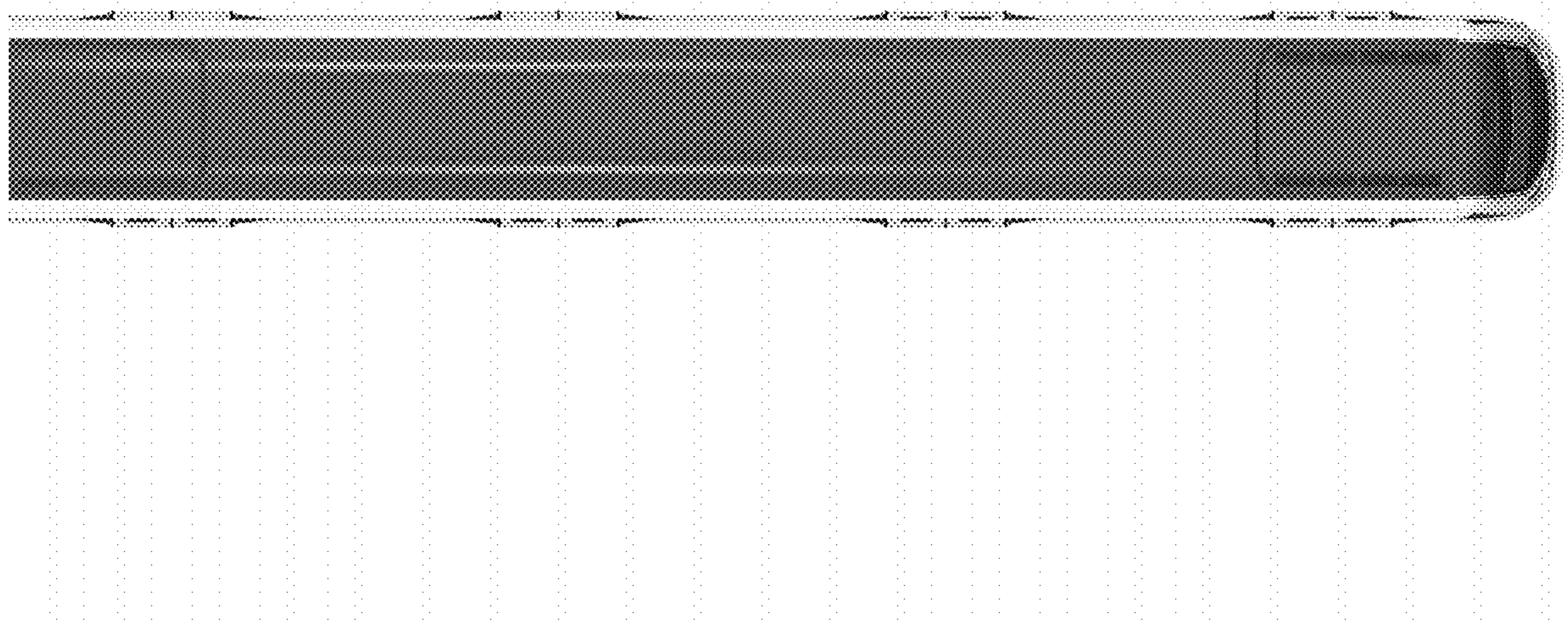

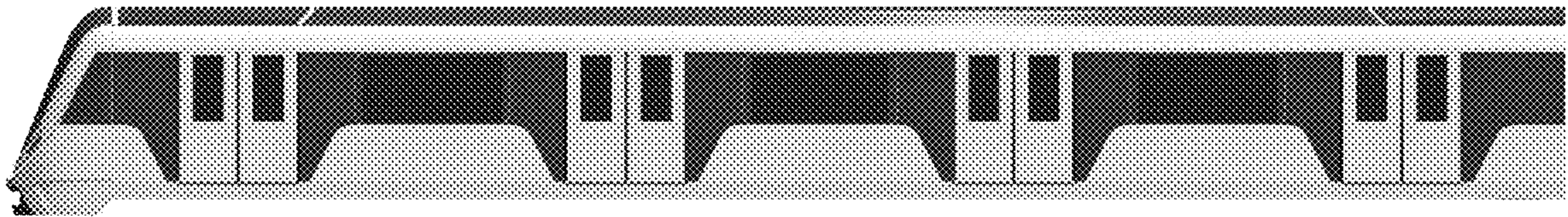

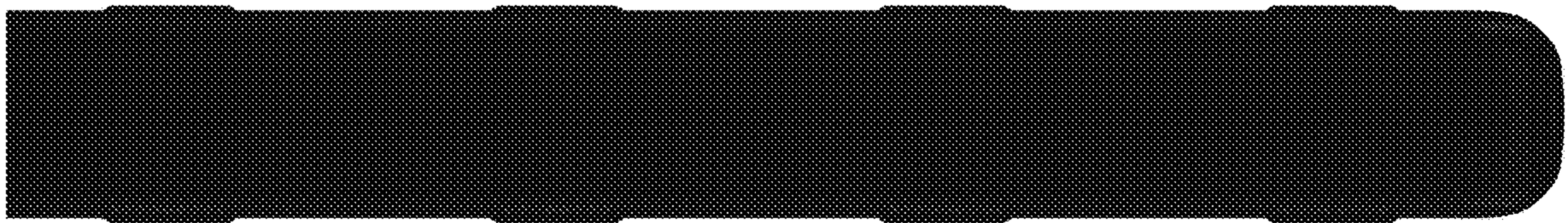

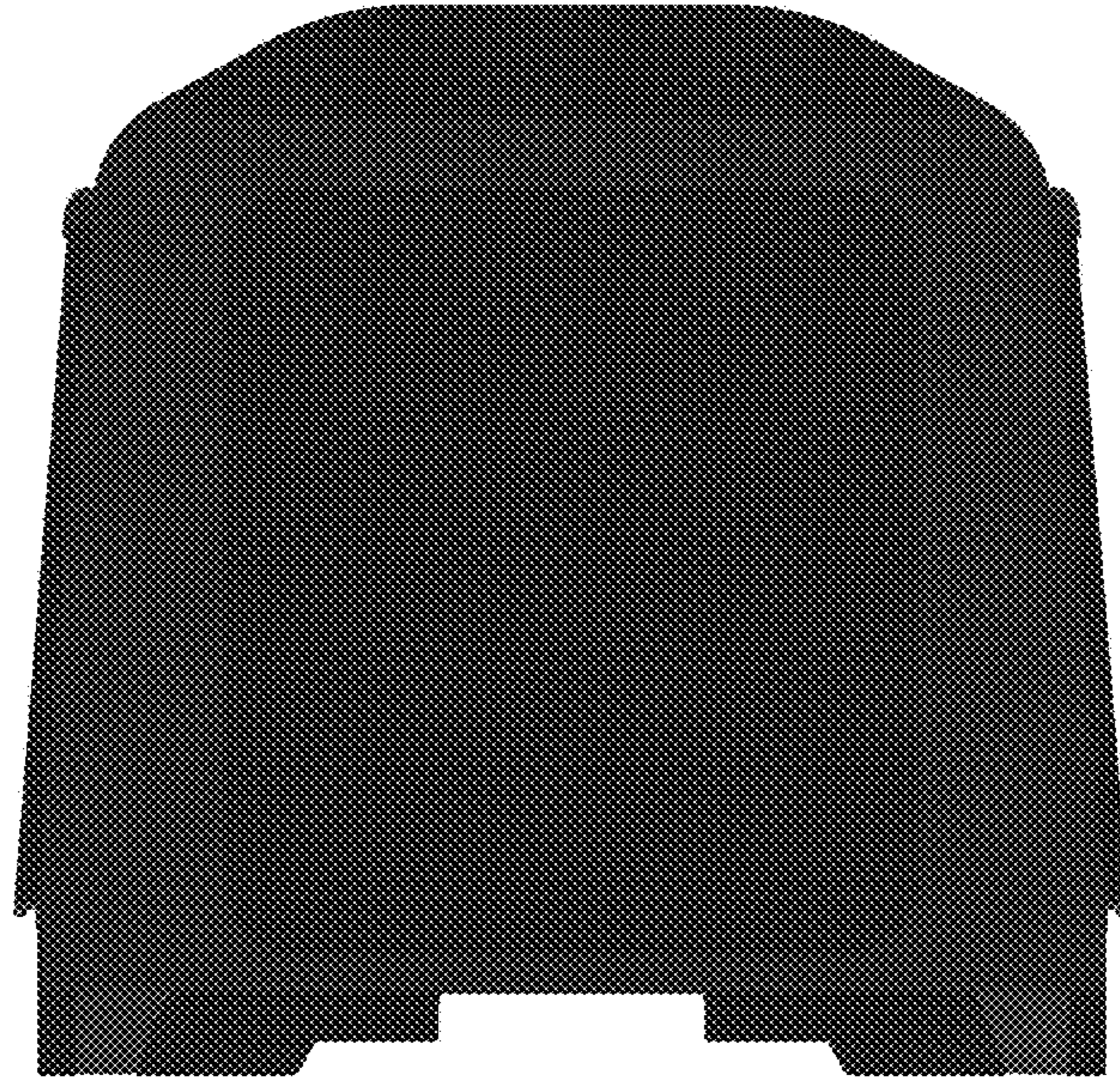

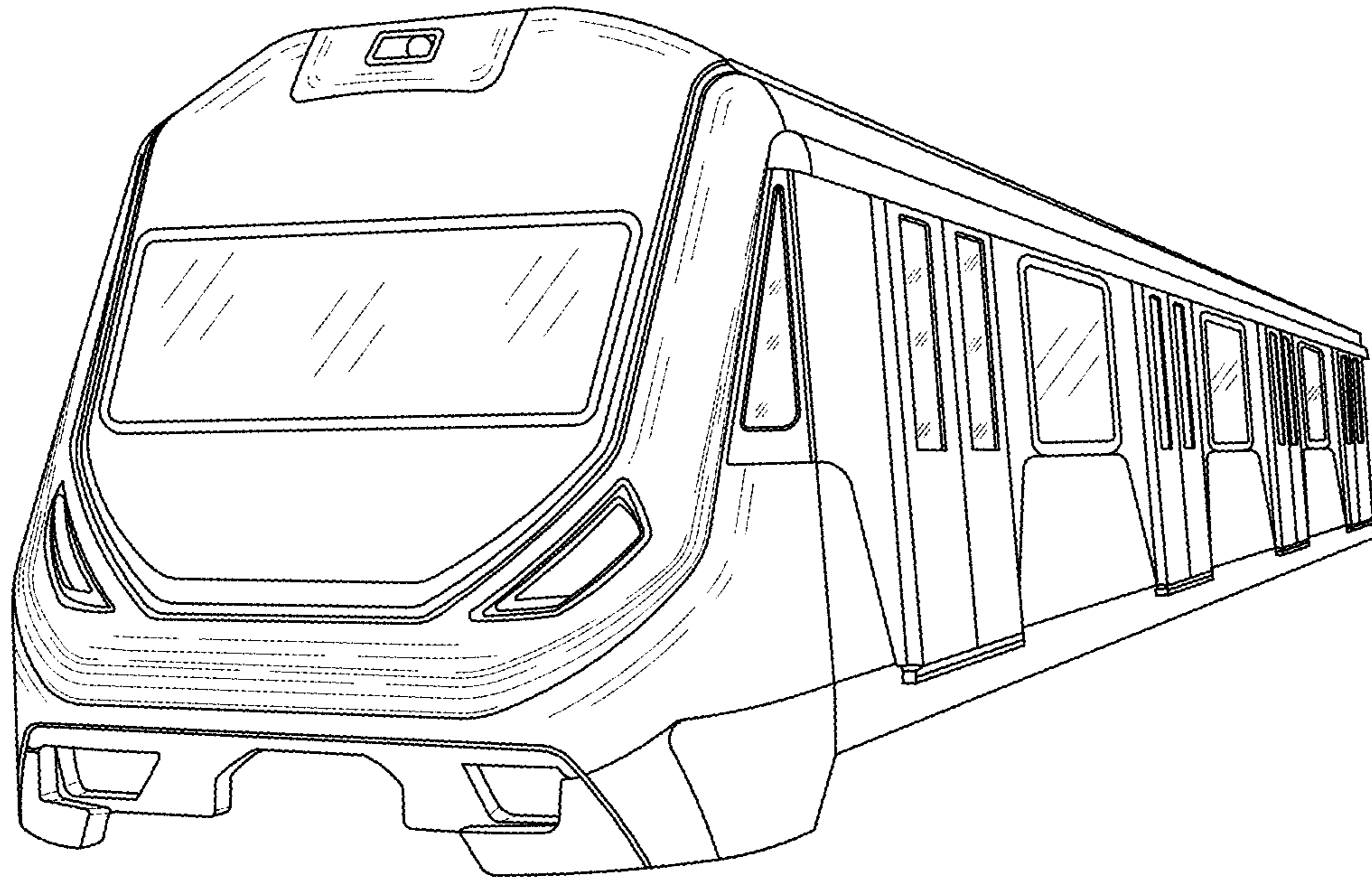

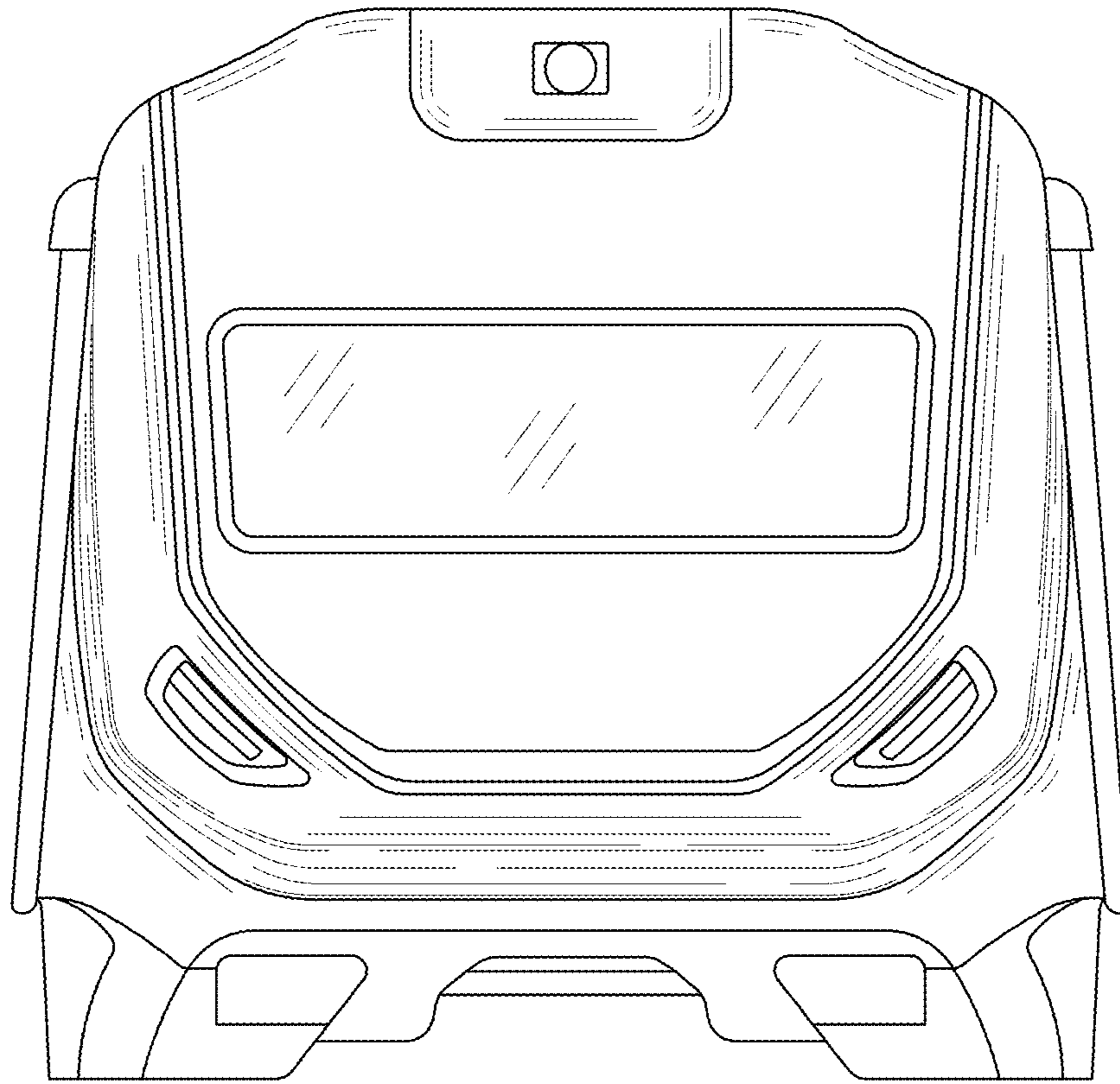

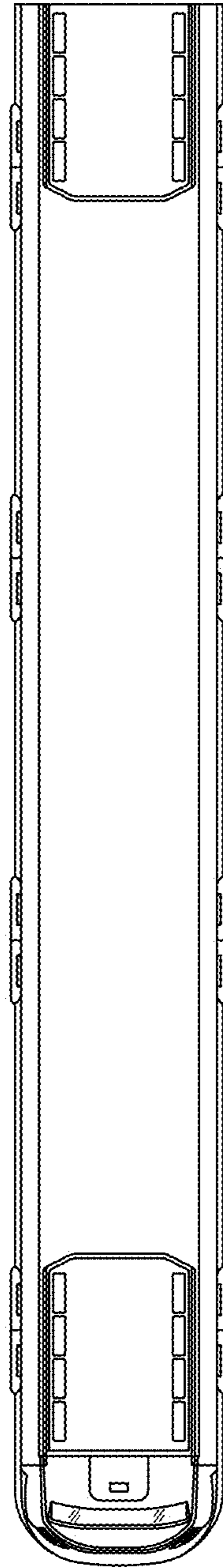

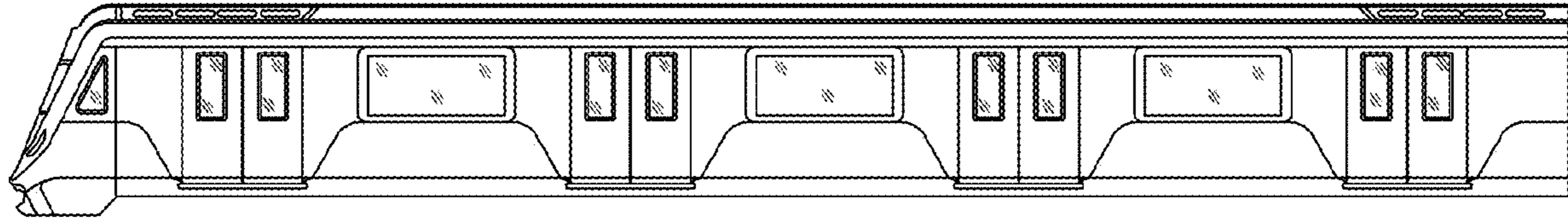

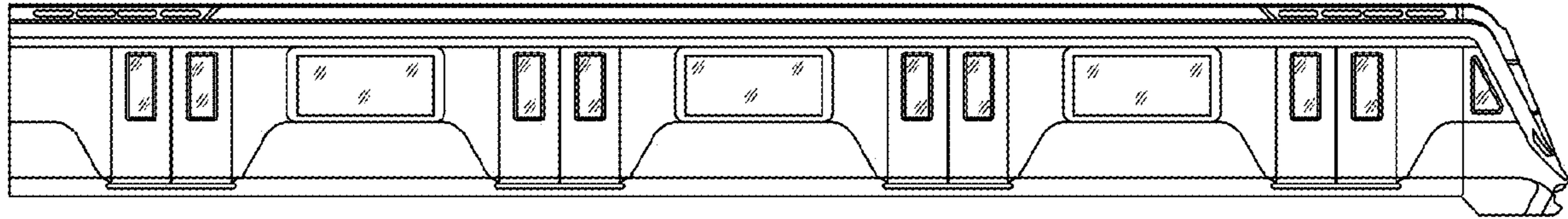
