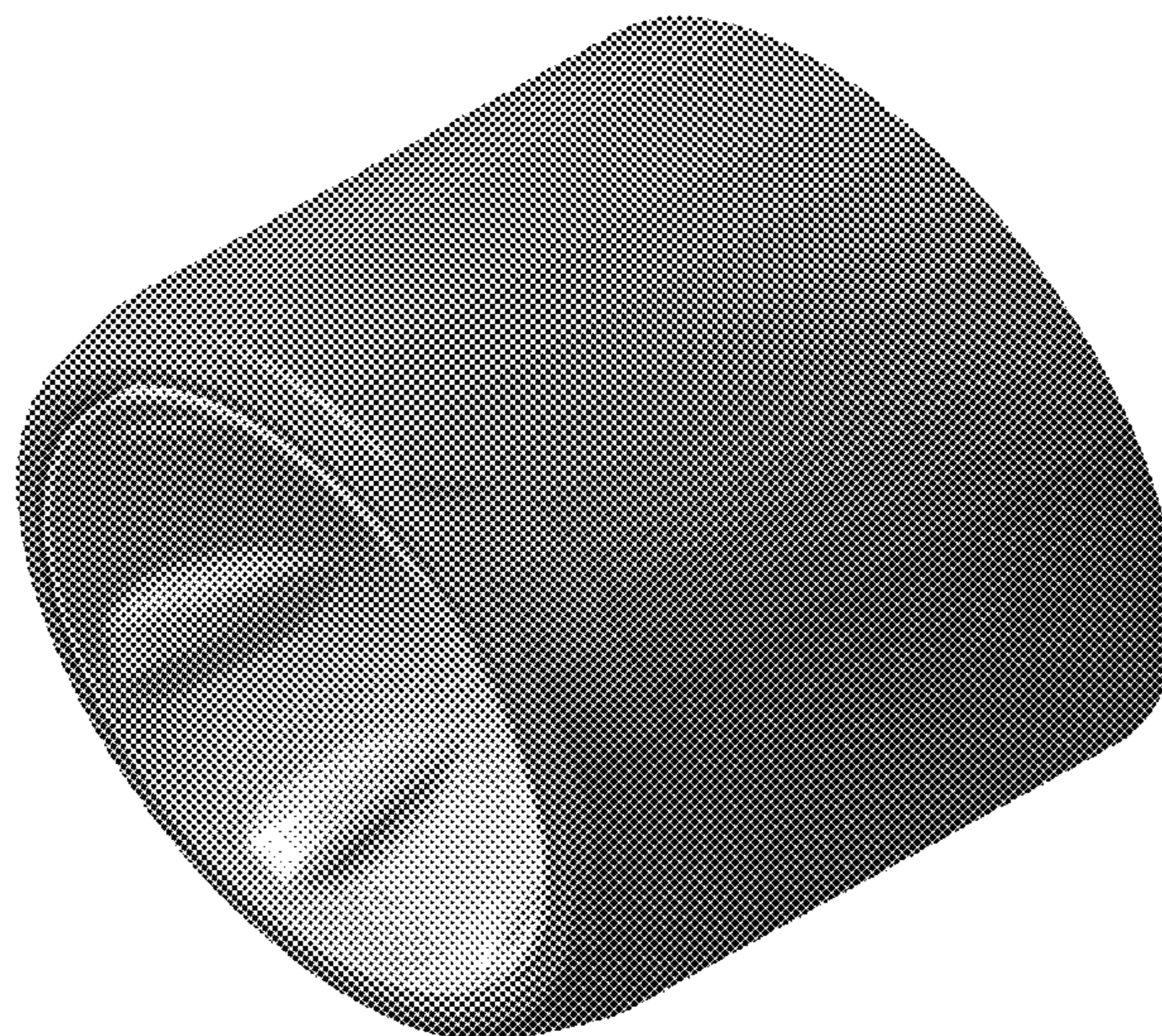

The ornamental design for a tailpipe, as shown and described.

**DESCRIPTION**  
1. Tailpipe  
1.1 is a top, rear, and right side perspective view of a tailpipe embodying our new design;  
1.2 is a right side elevation view thereof;  
1.3 is a rear elevation view thereof;  
1.4 is a top plan view thereof;  
1.5 is a top, rear, and left side perspective view thereof;  
1.6 is a bottom plan view thereof;  
1.7 is a front elevation view thereof;  
1.8 is a top, front, and left side perspective view thereof; and  
1.9 is a left side elevation view thereof.

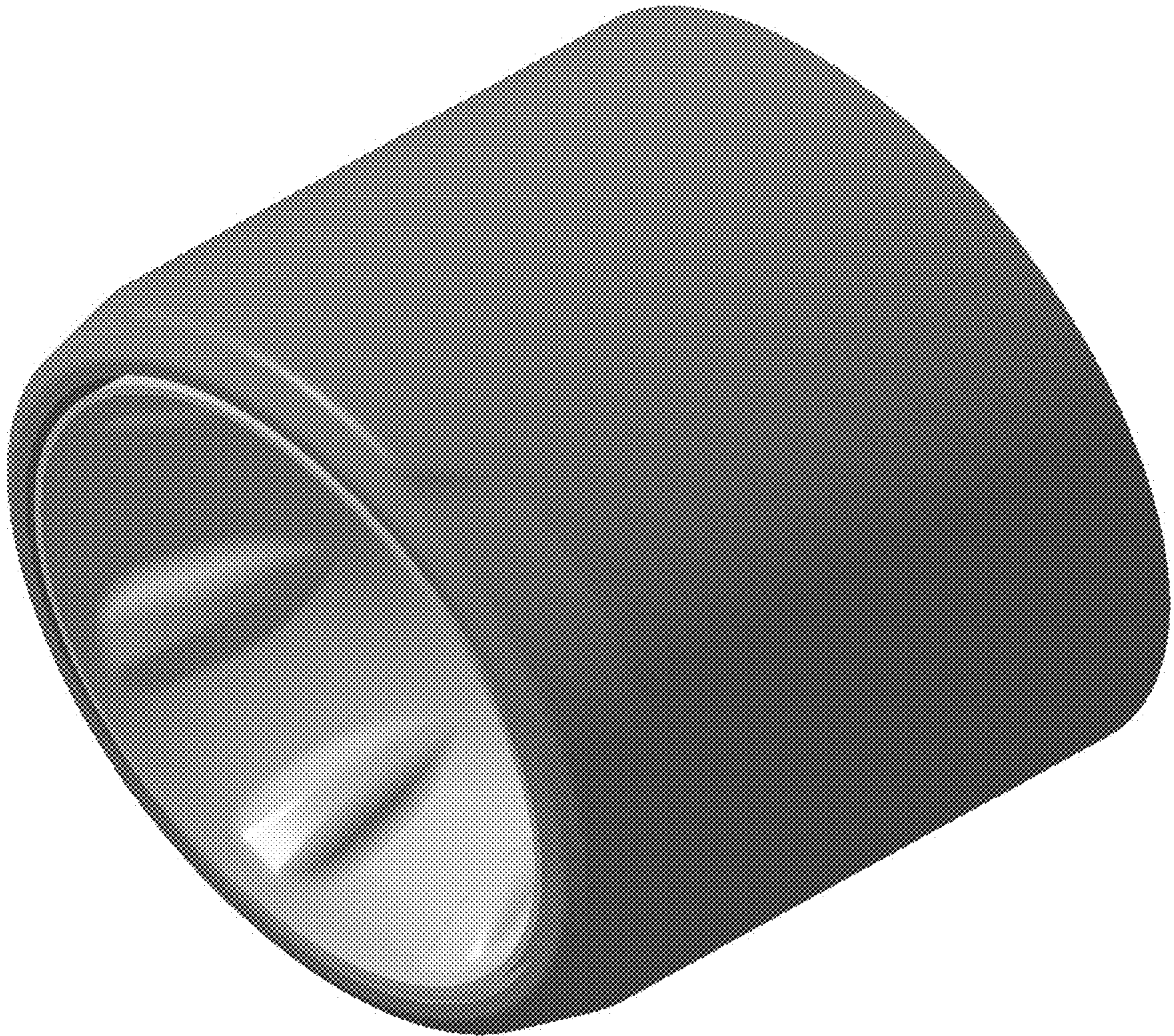

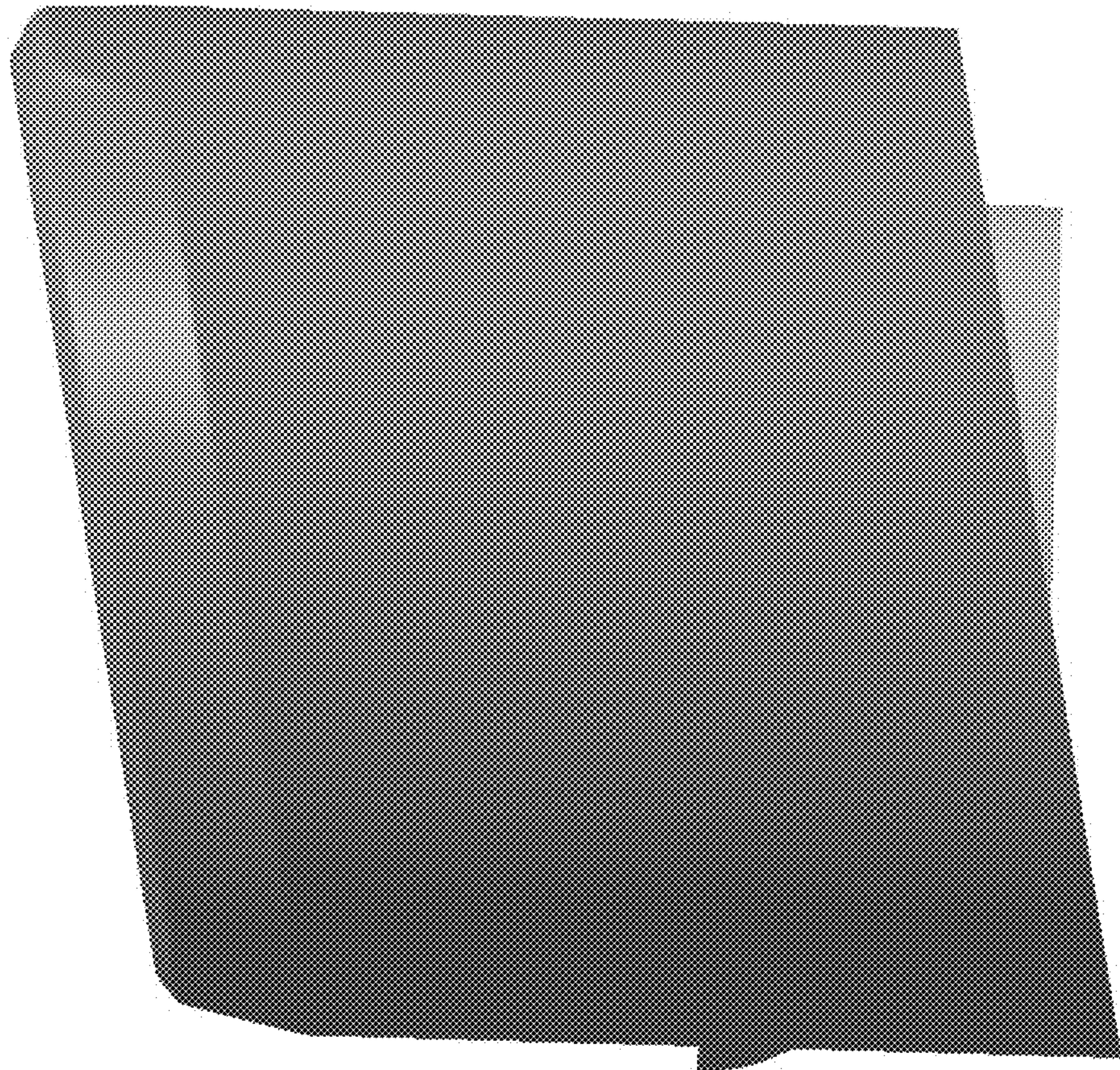

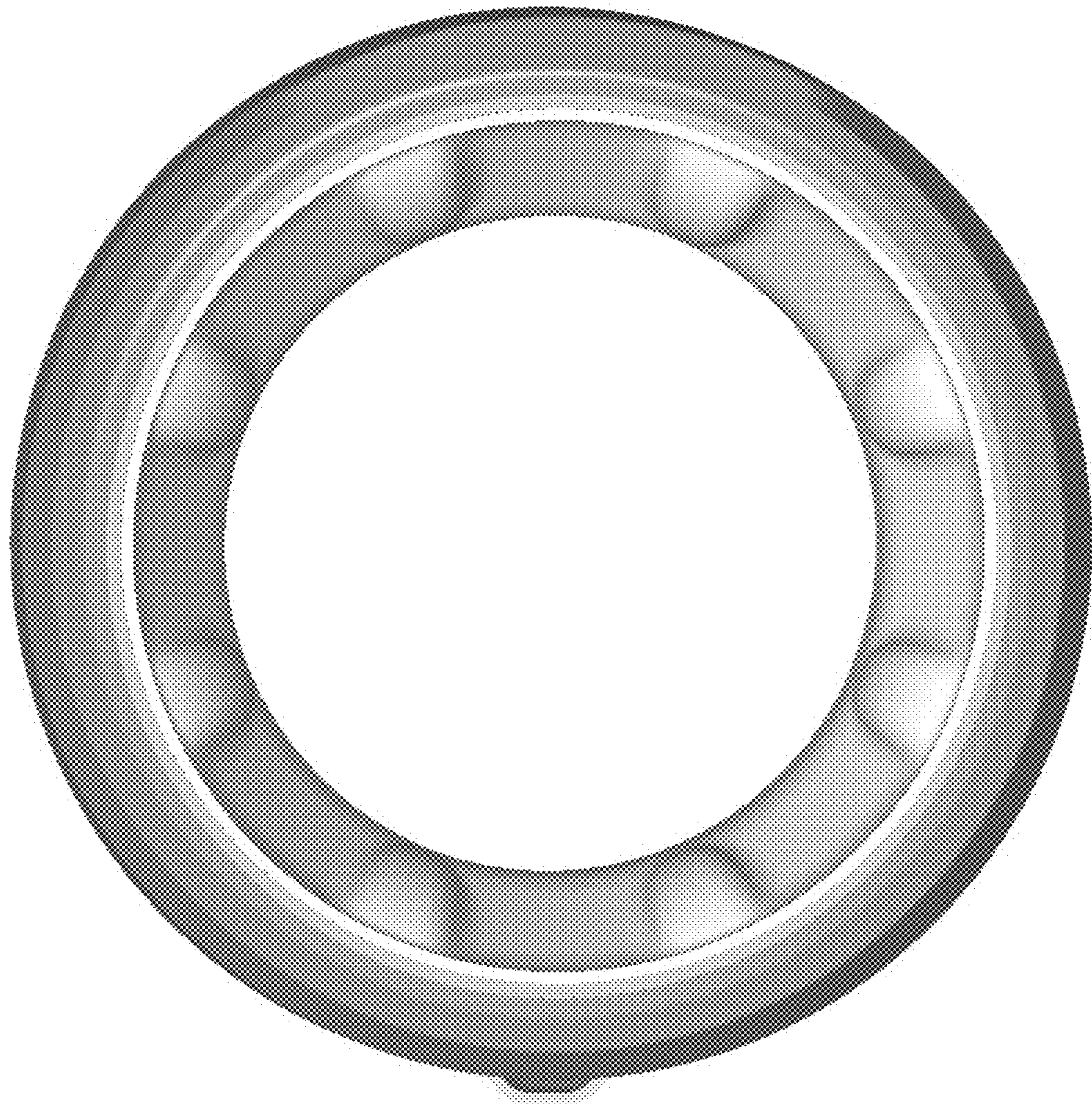

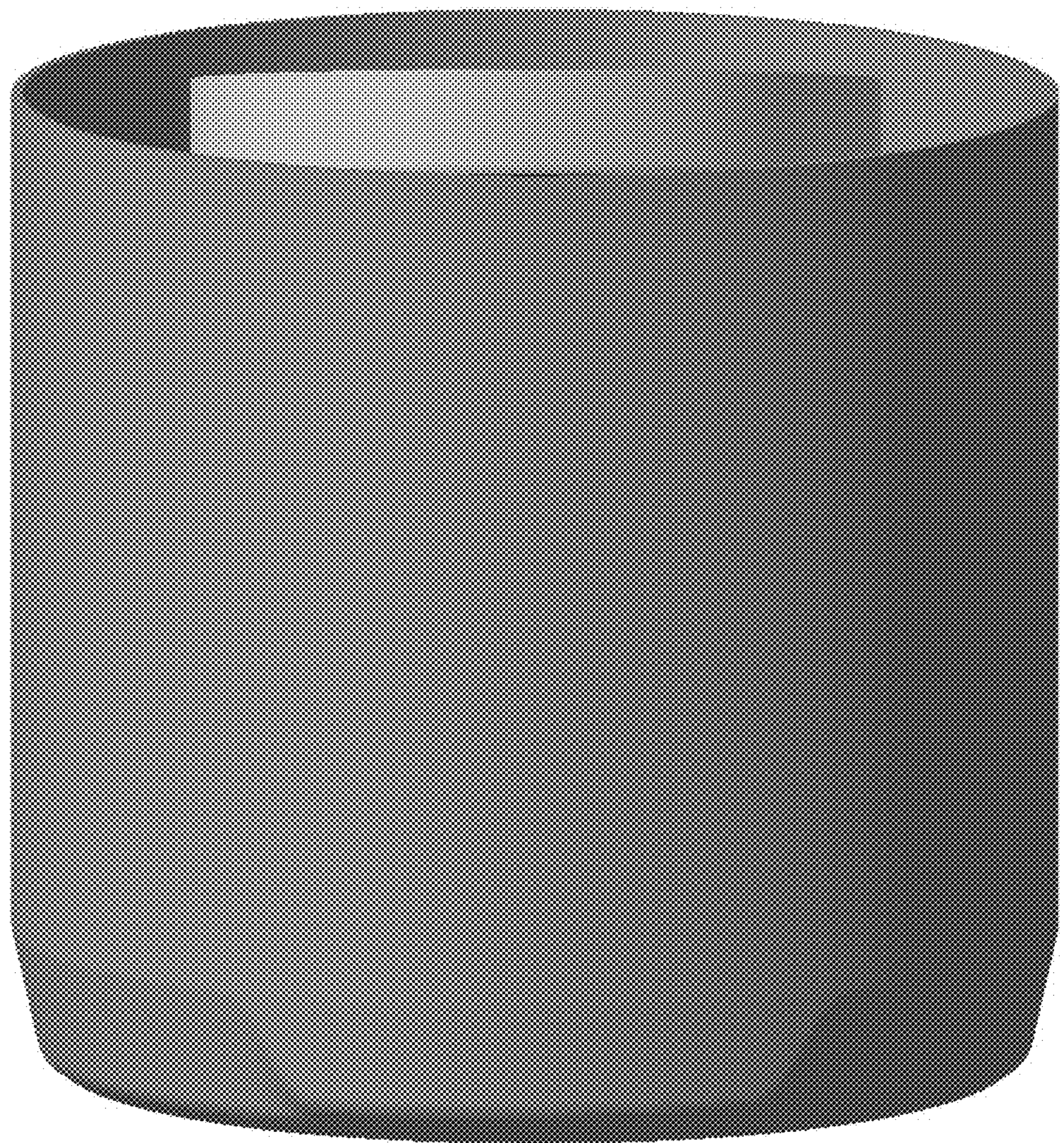

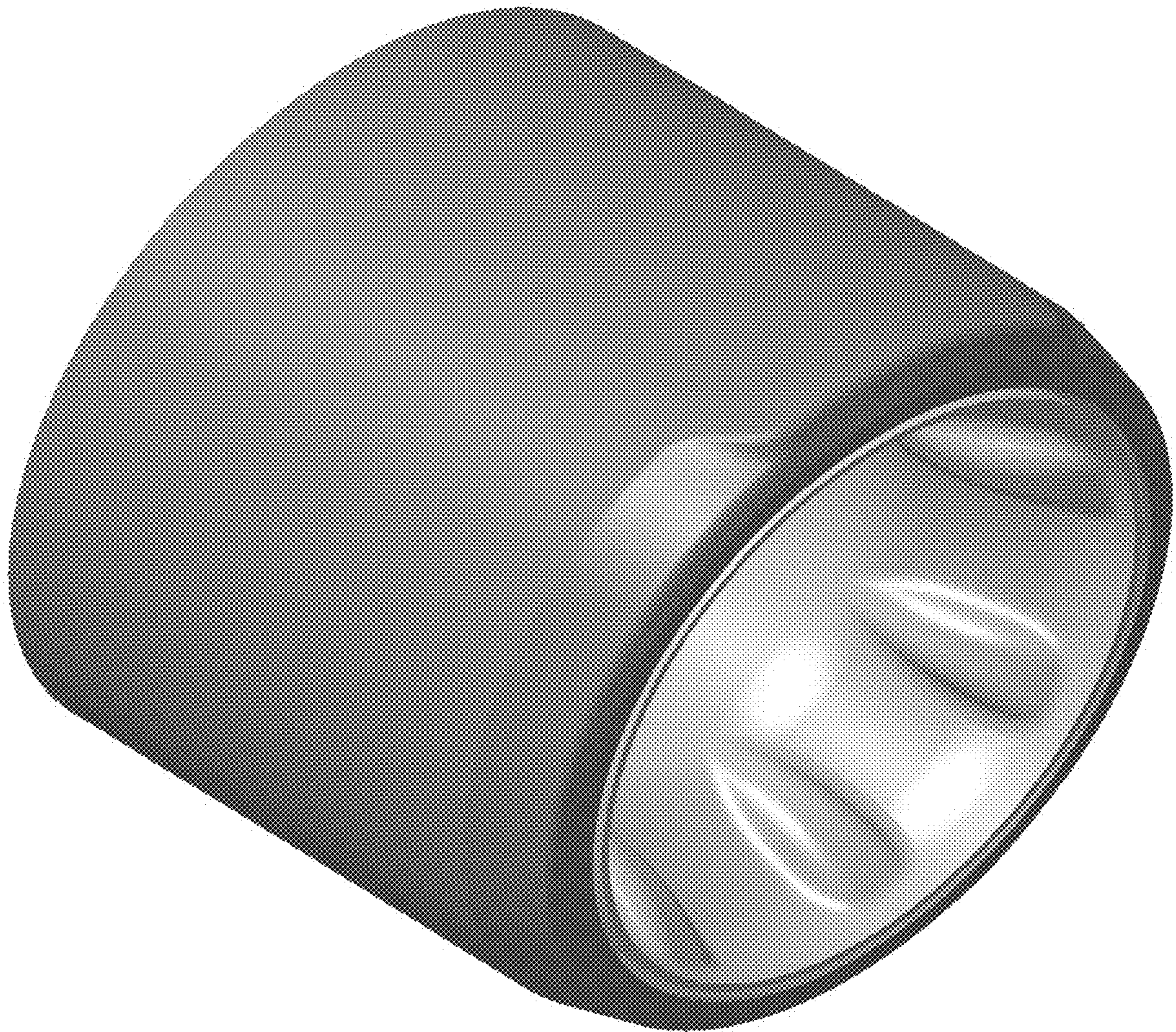

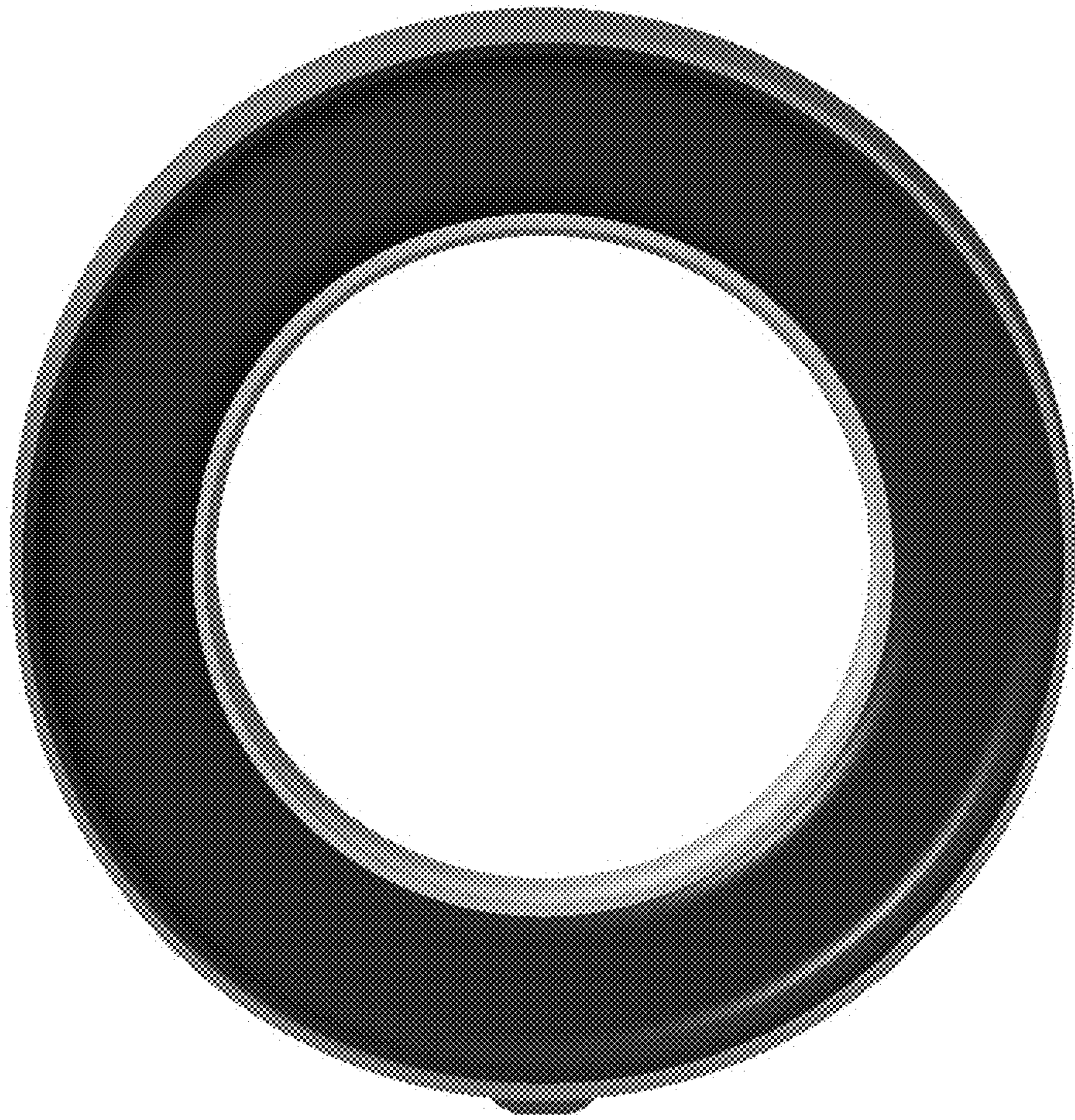

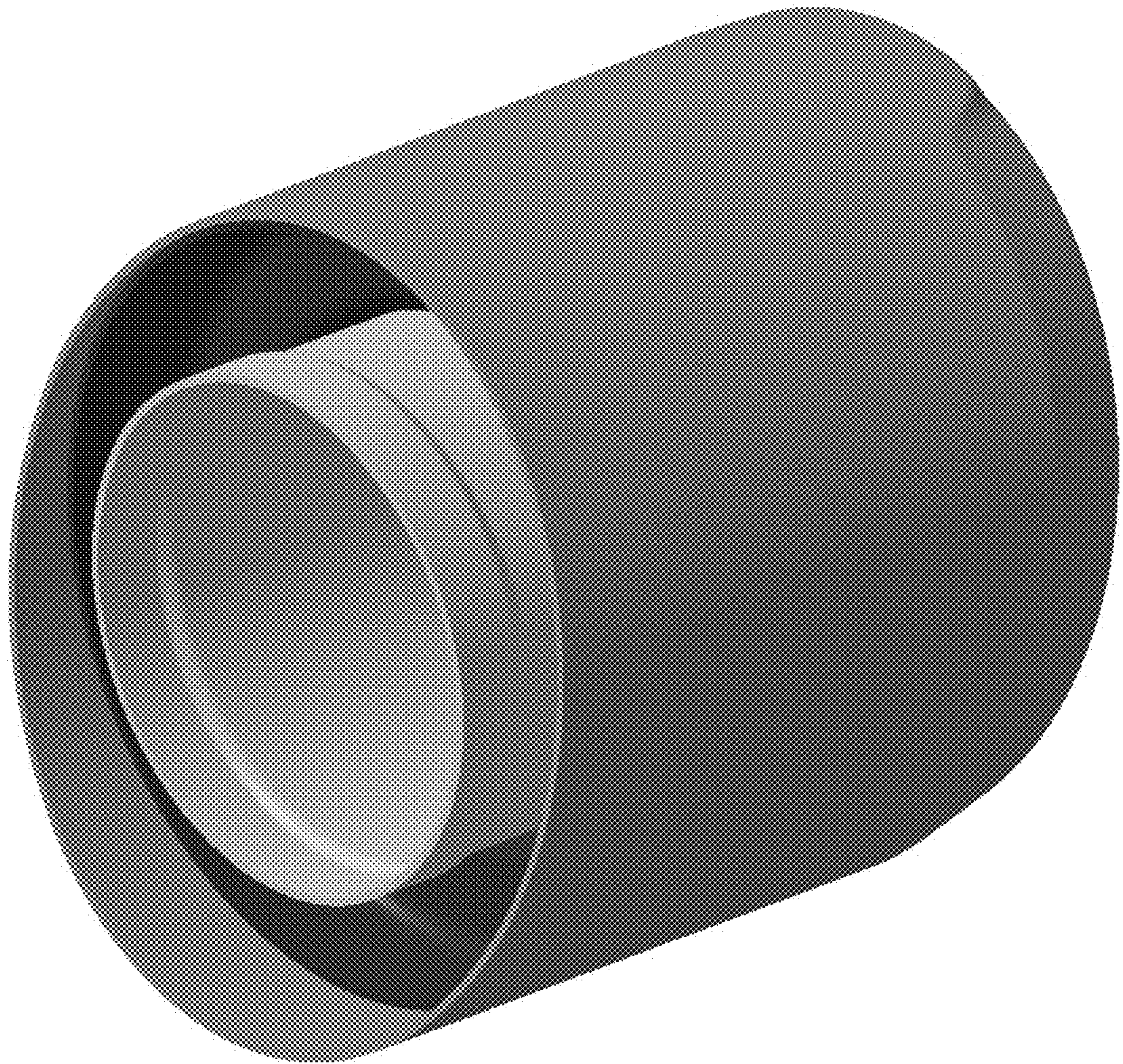
