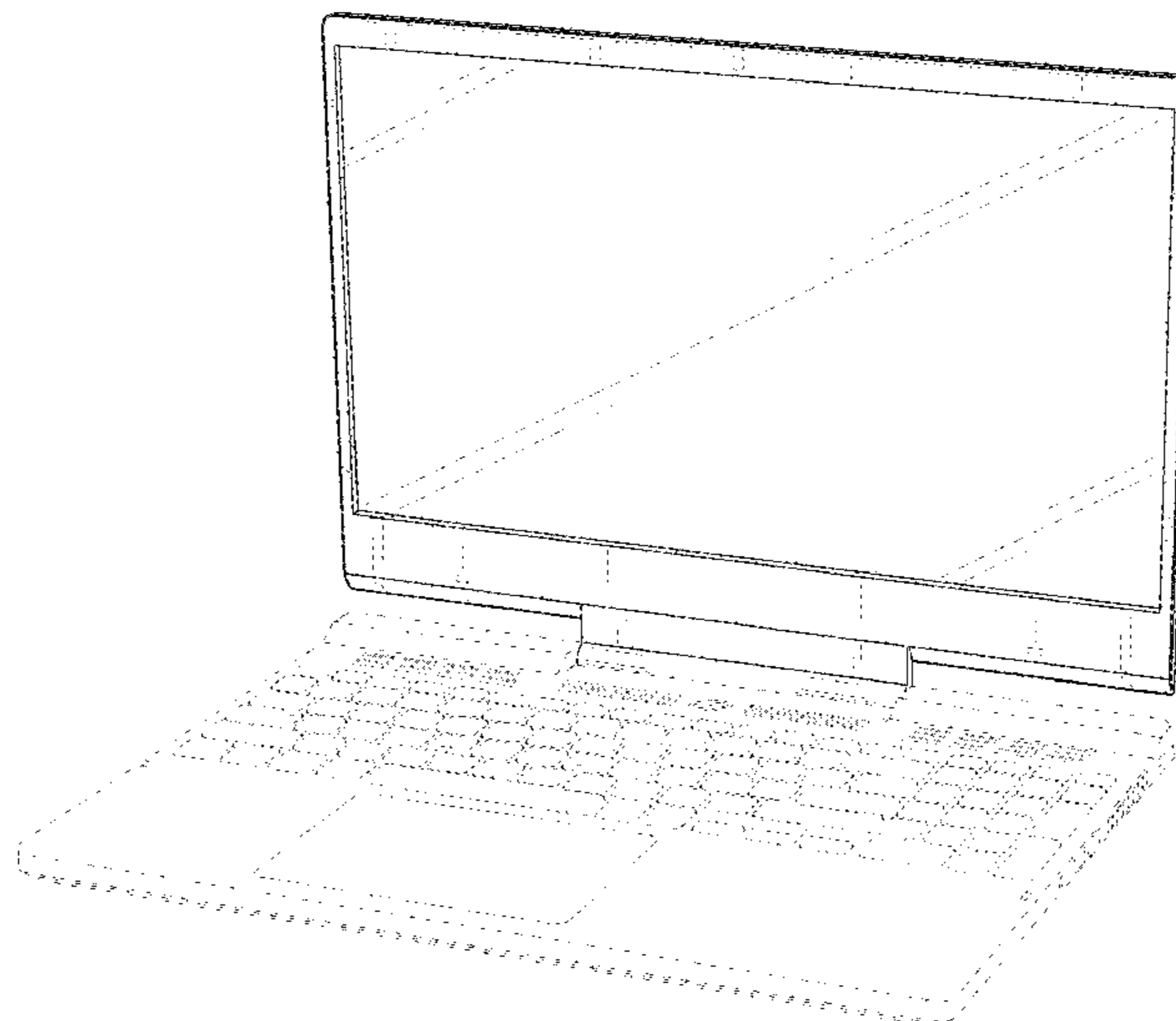
FIG. 1 is a front perspective view of a laptop computer, showing our new design;

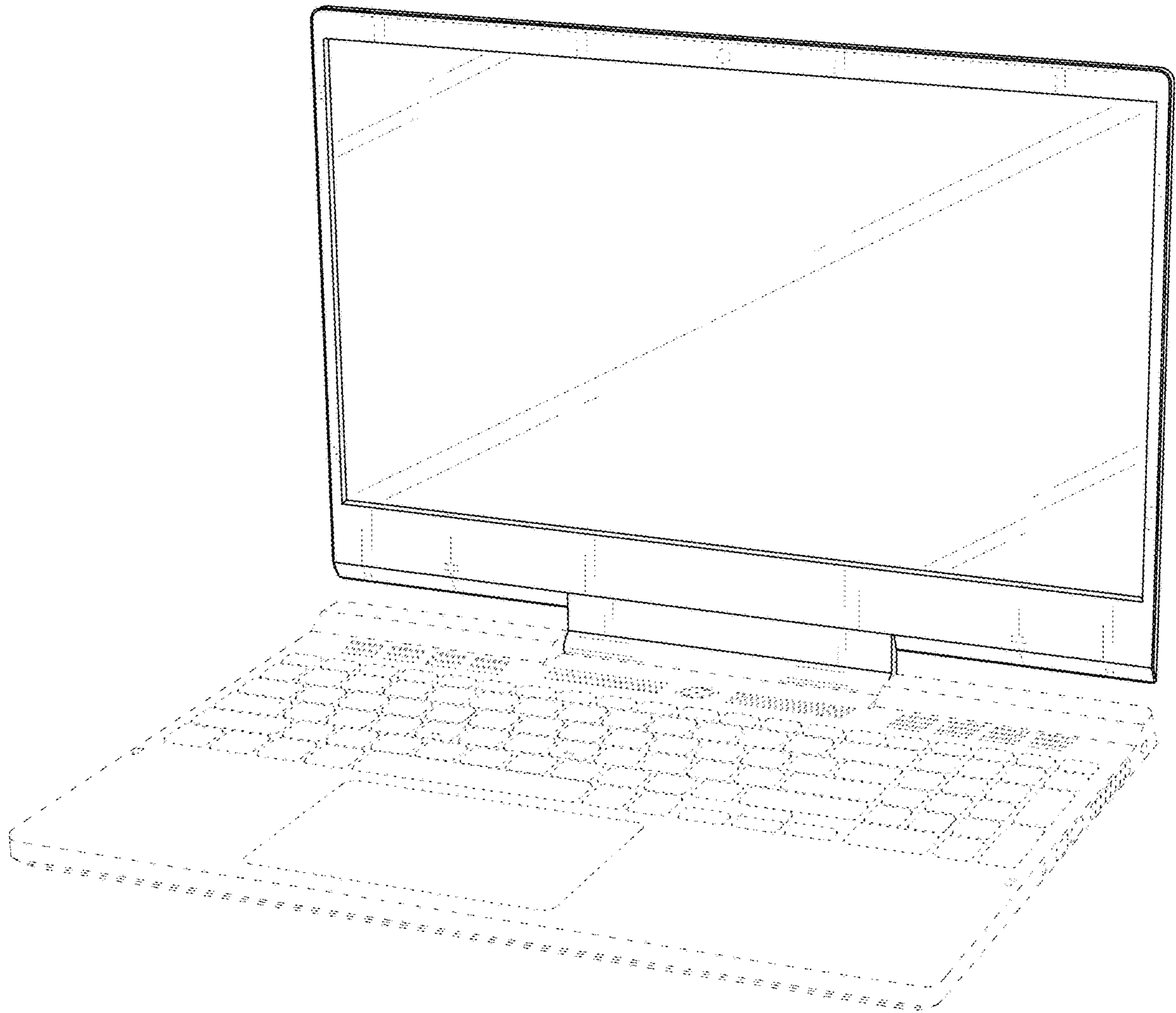

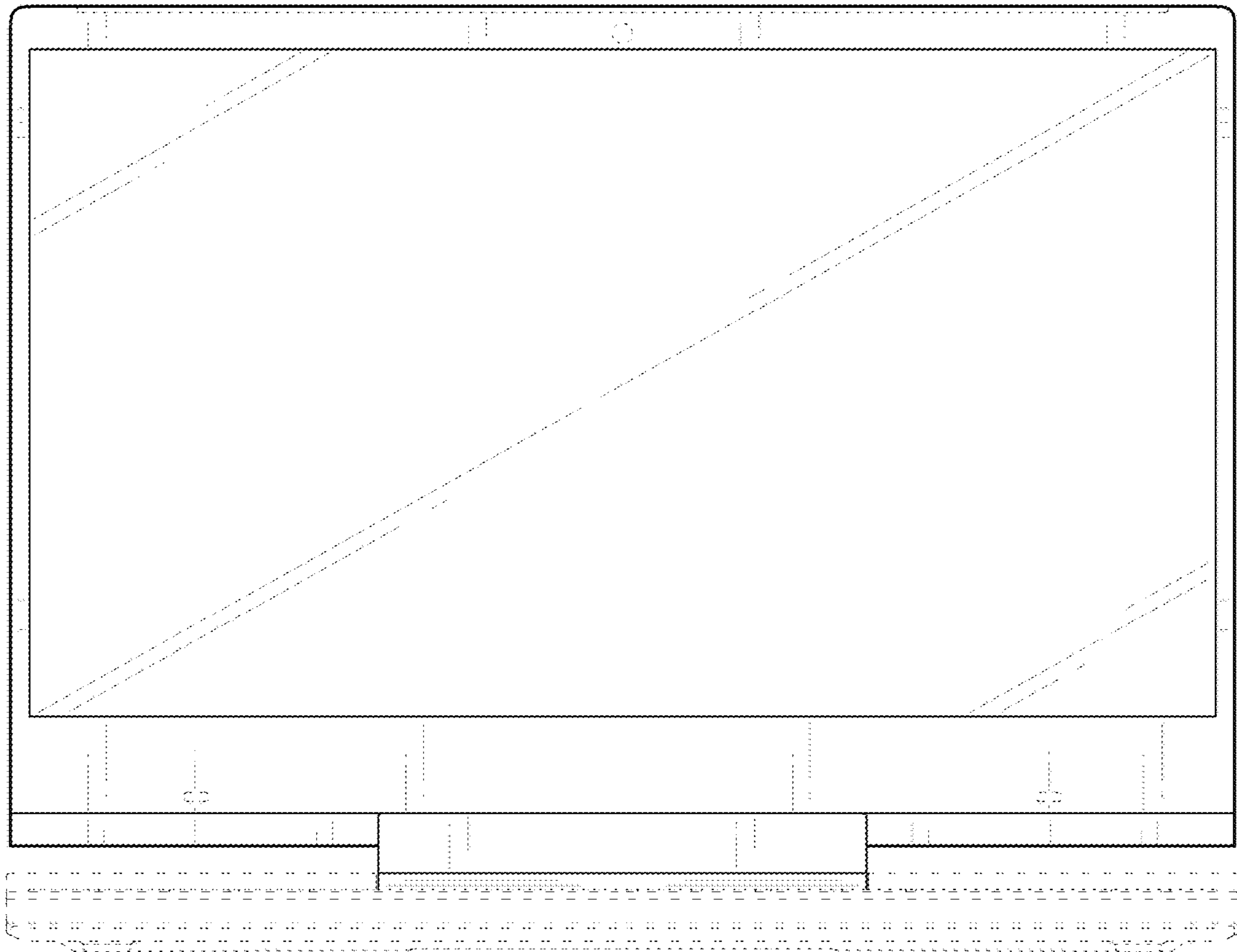

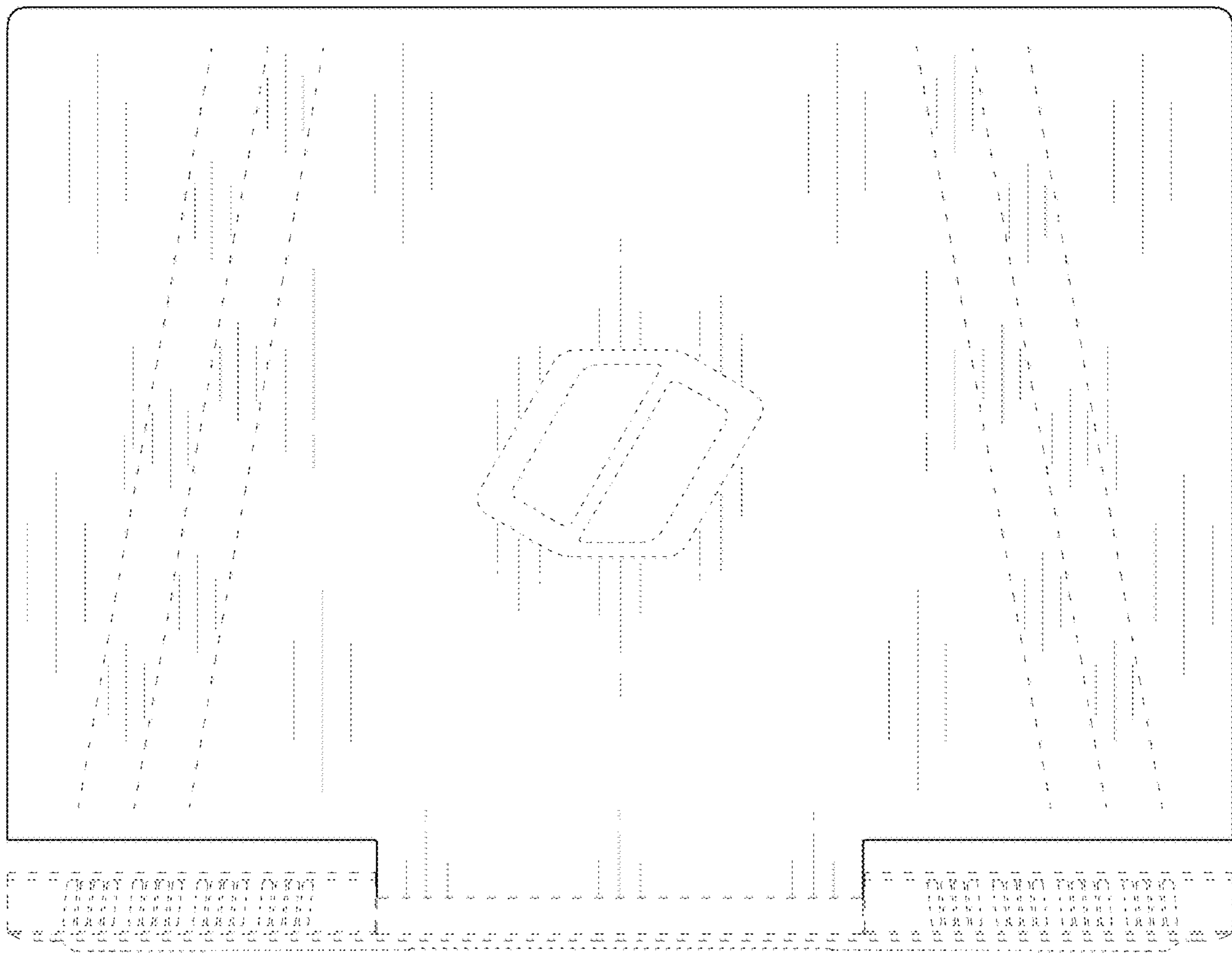

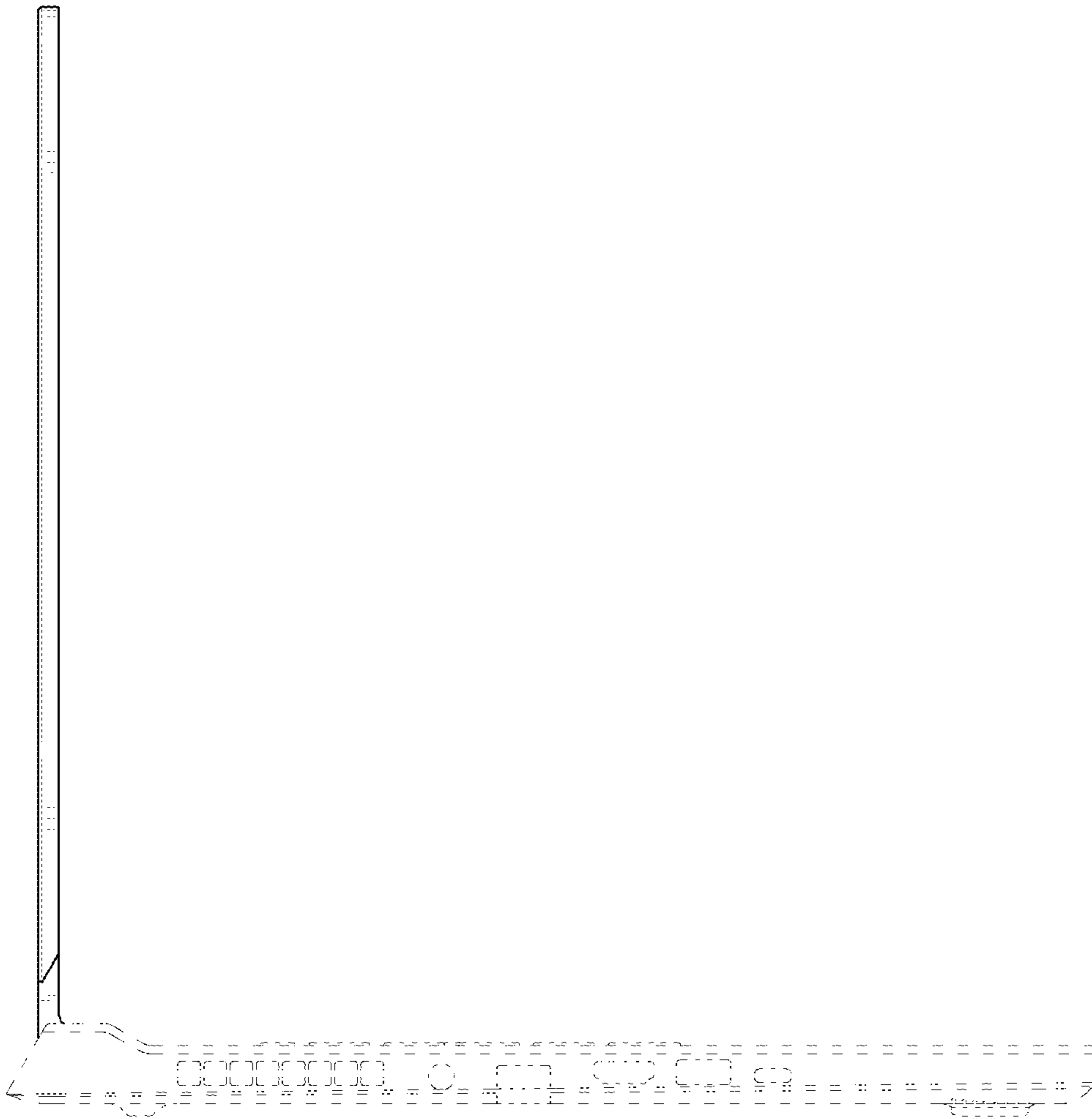

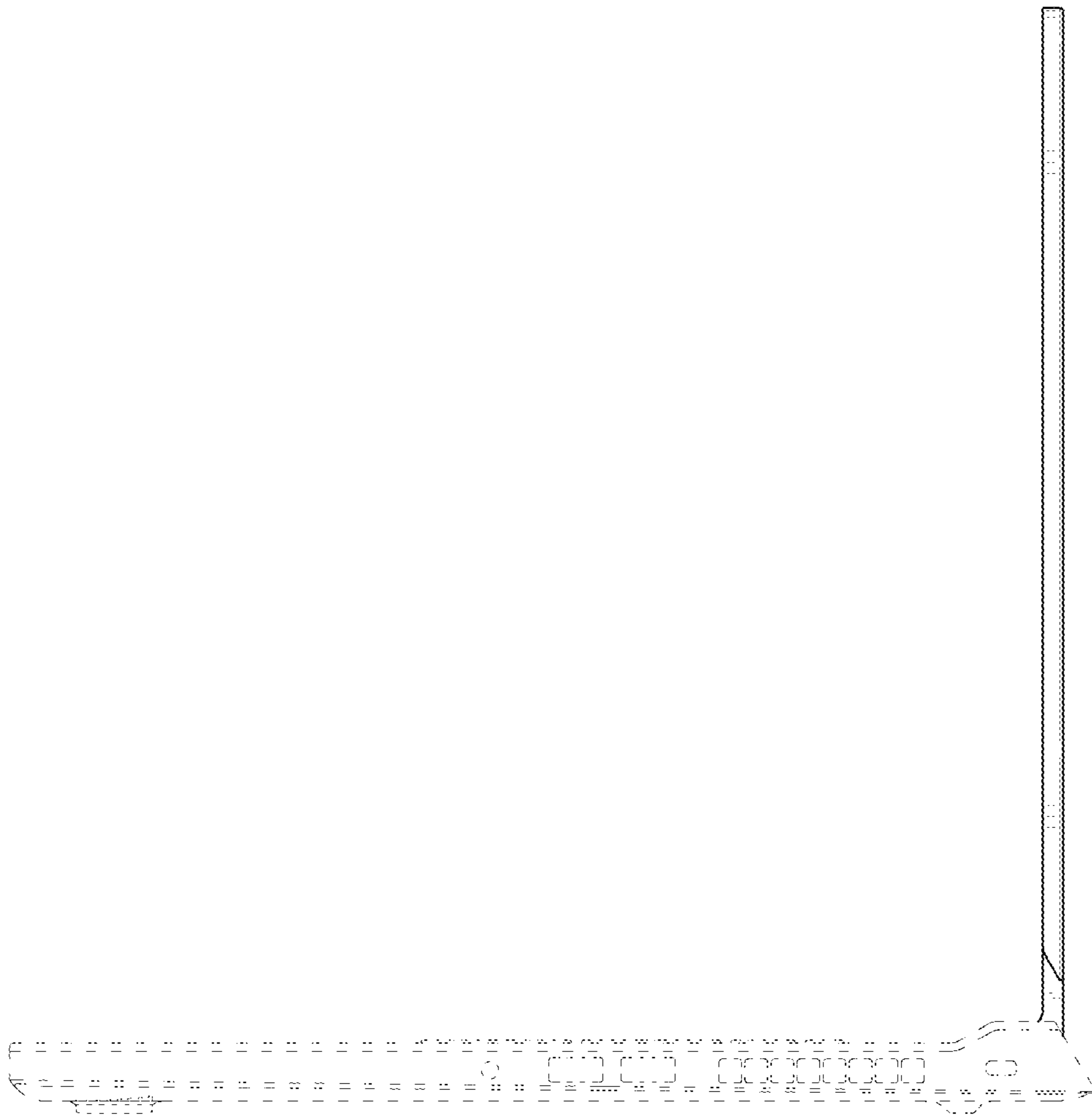

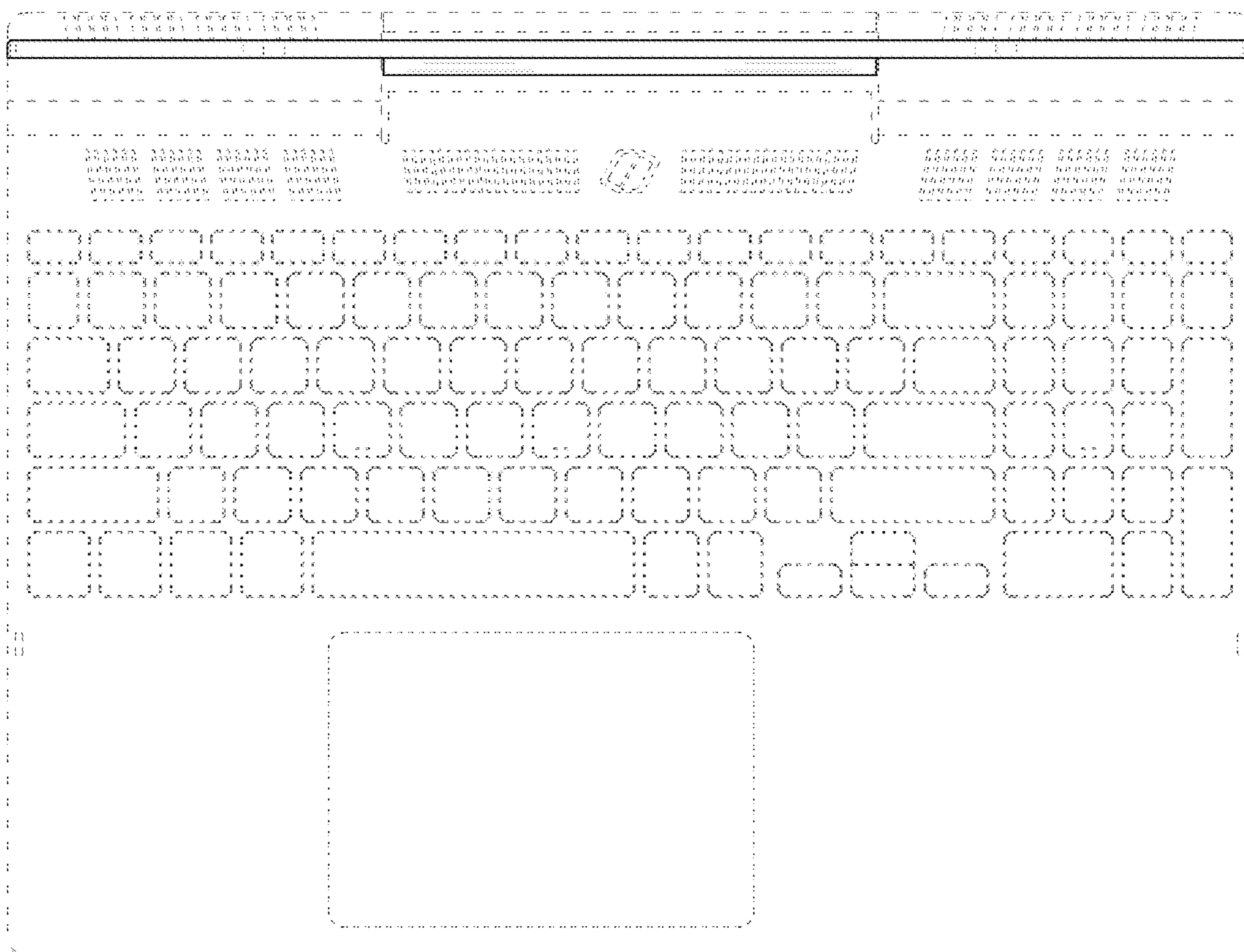

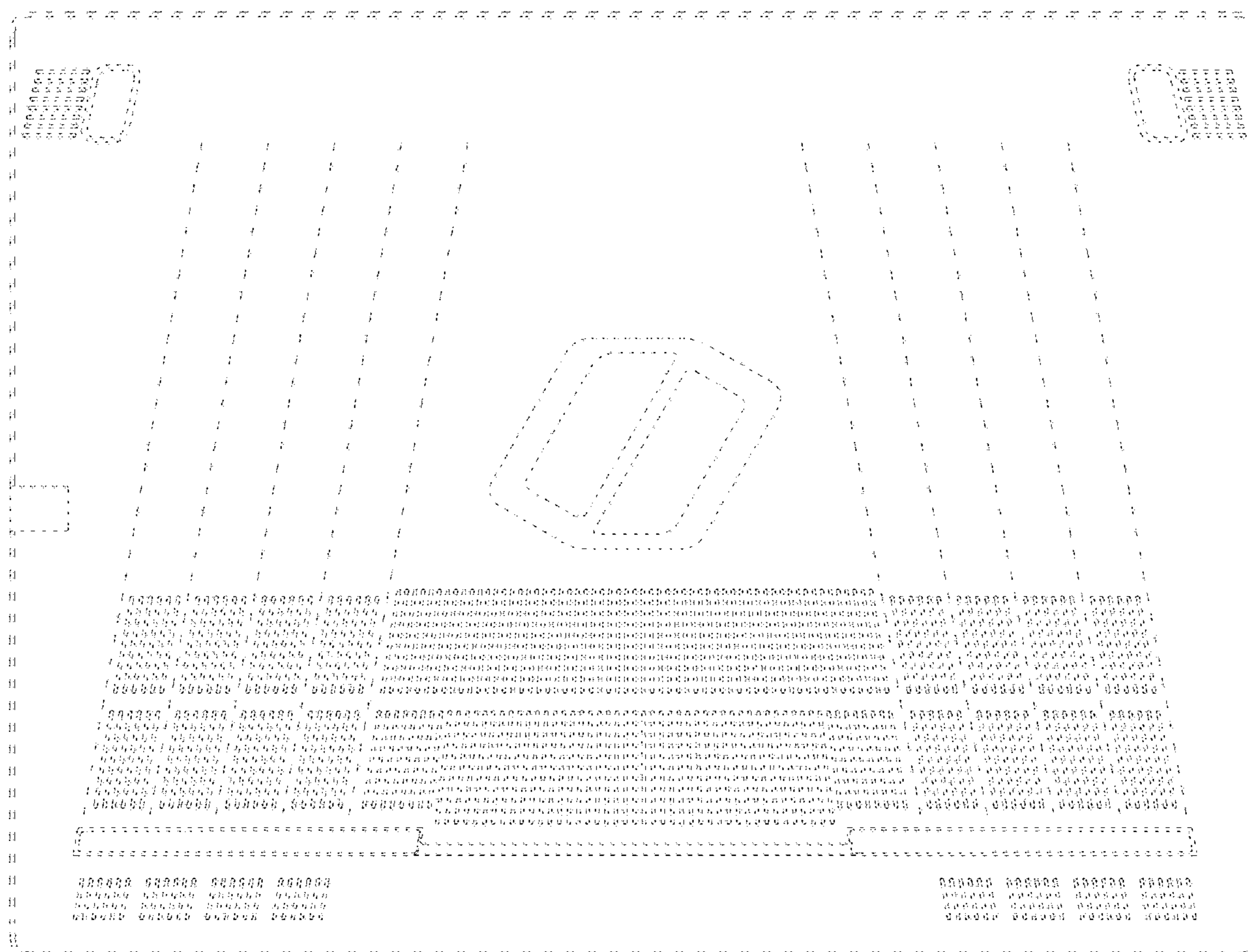
