FIG. 26 is a front view thereof with a twenty-sixth image;

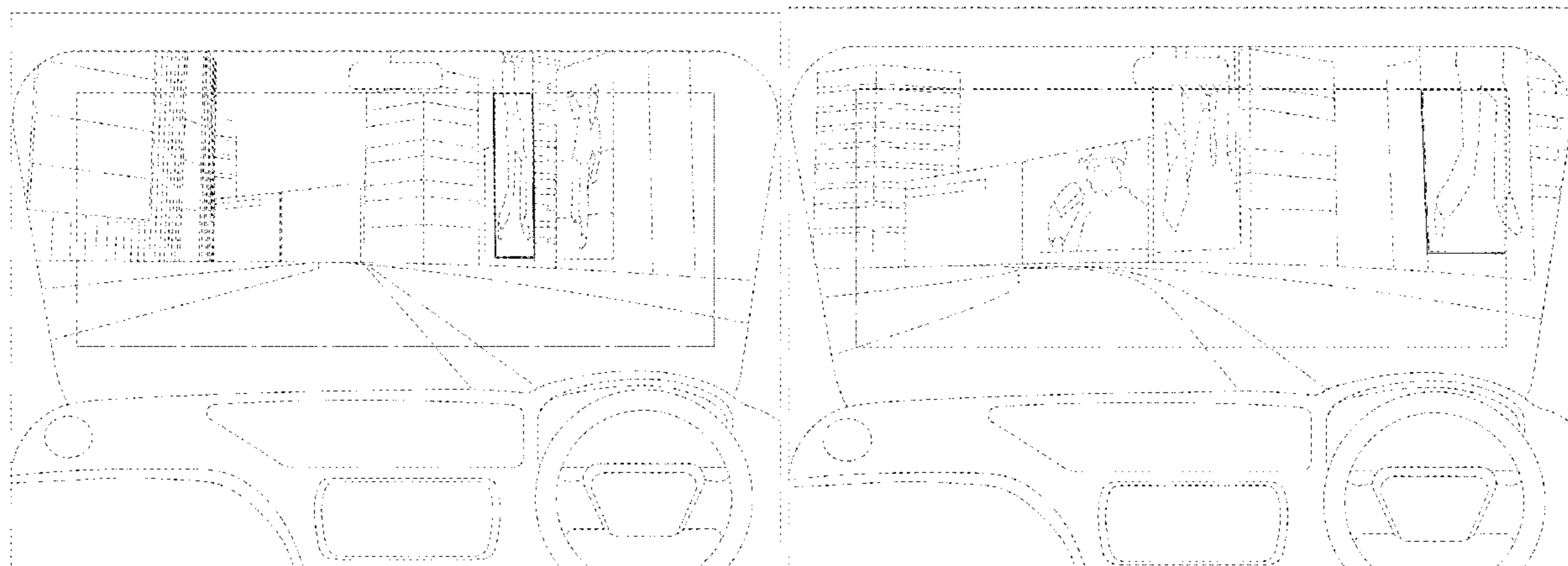
FIG. 27 is a front view thereof with a twenty-seventh image;

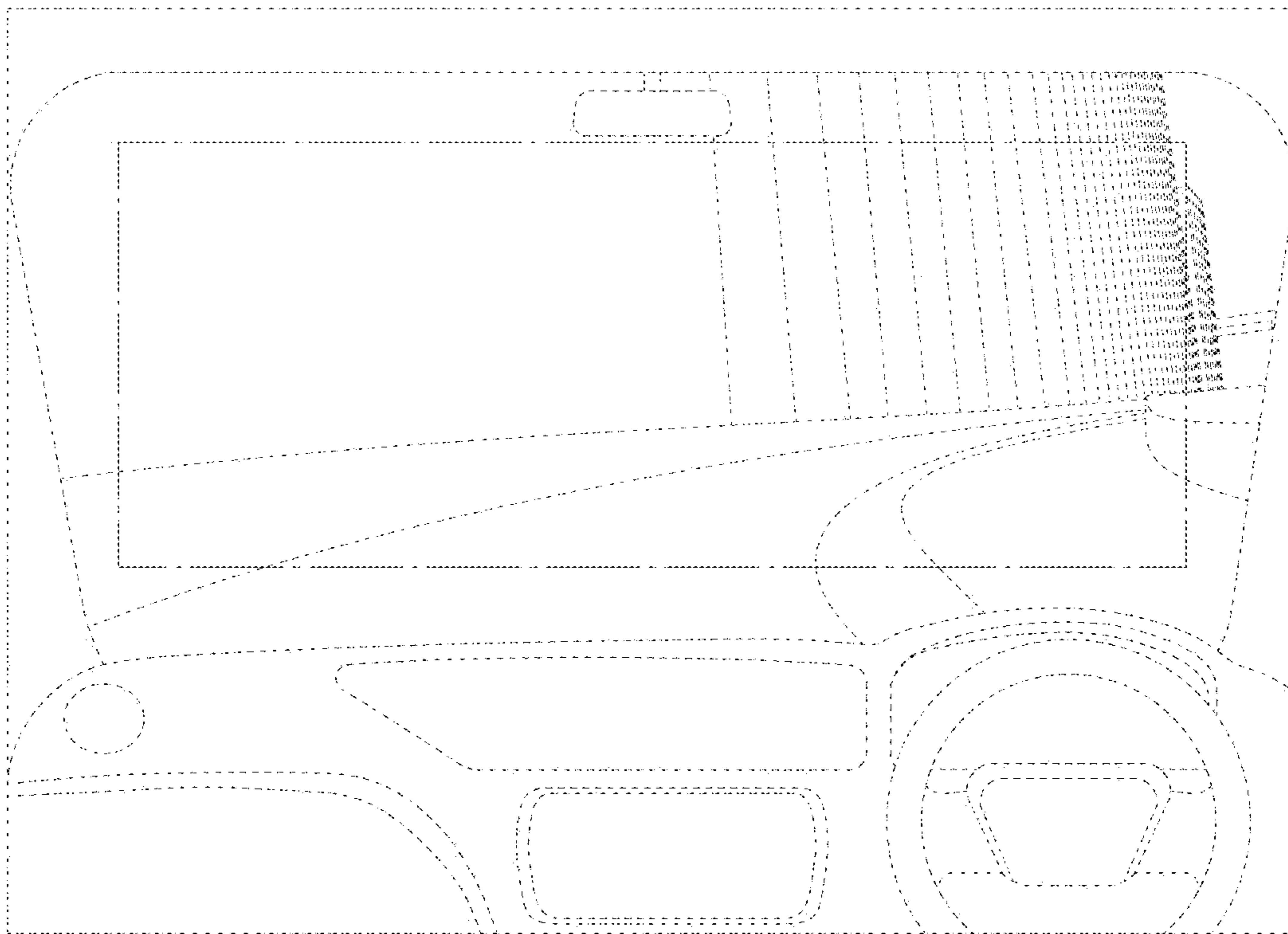

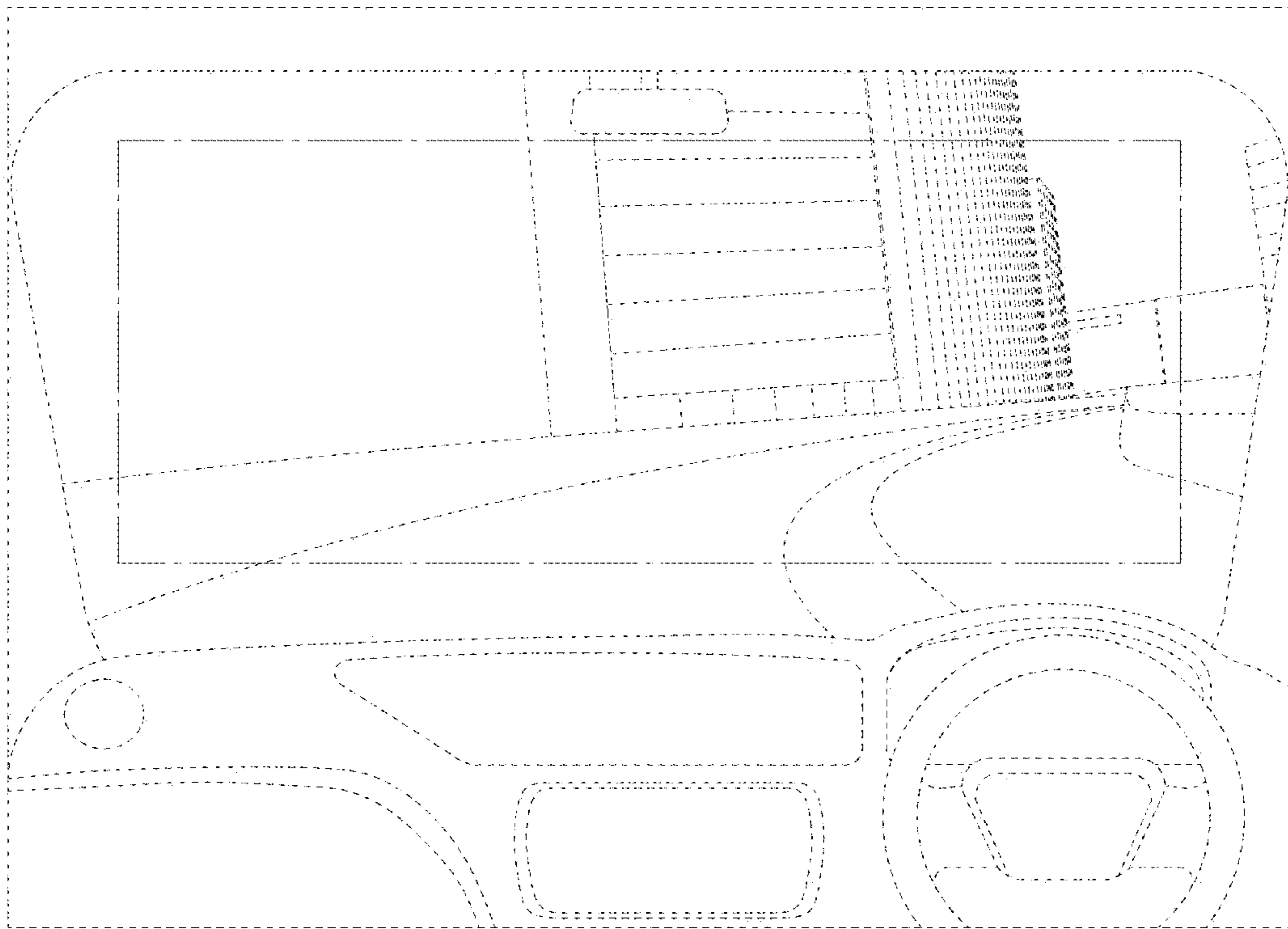

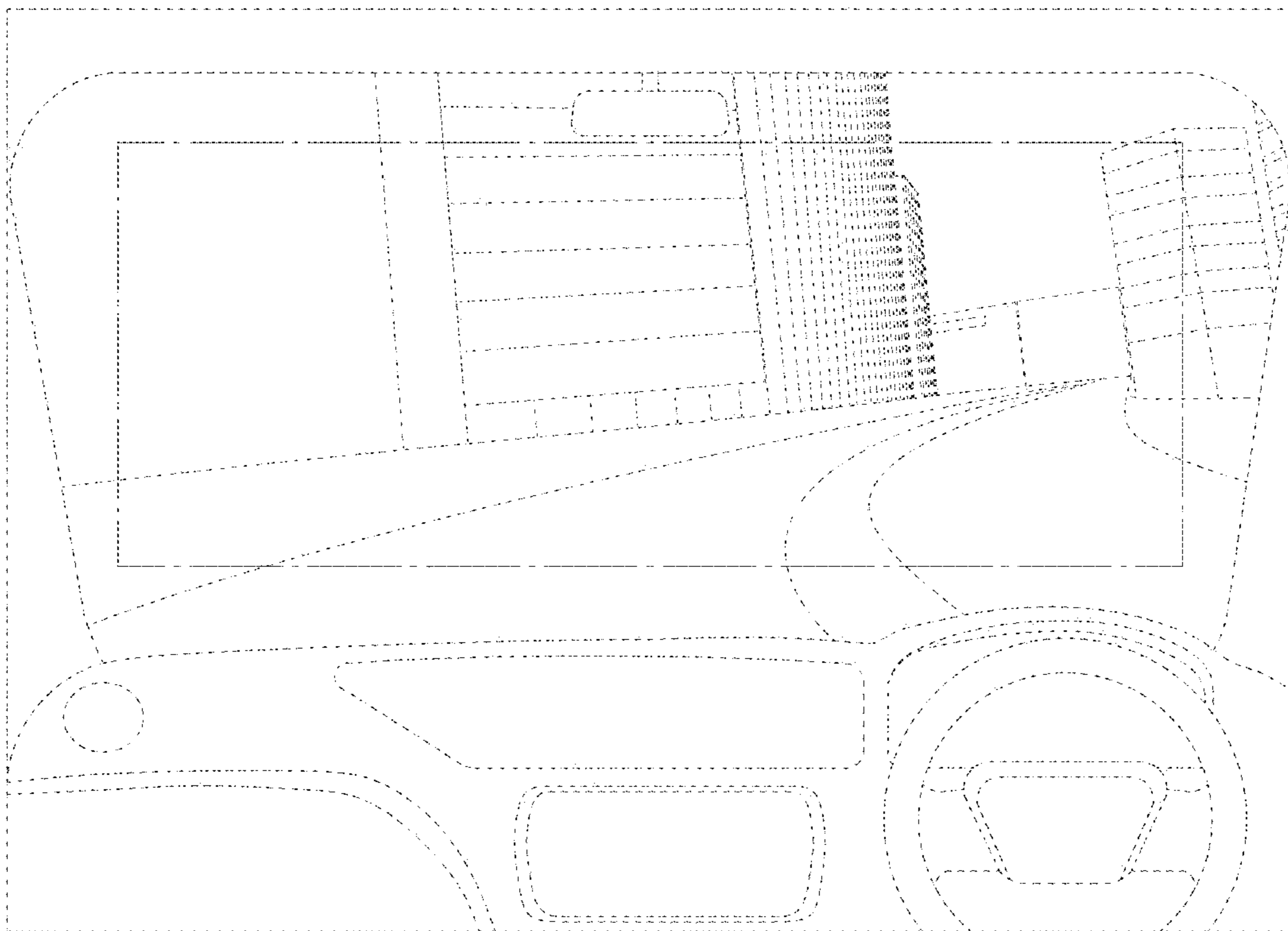

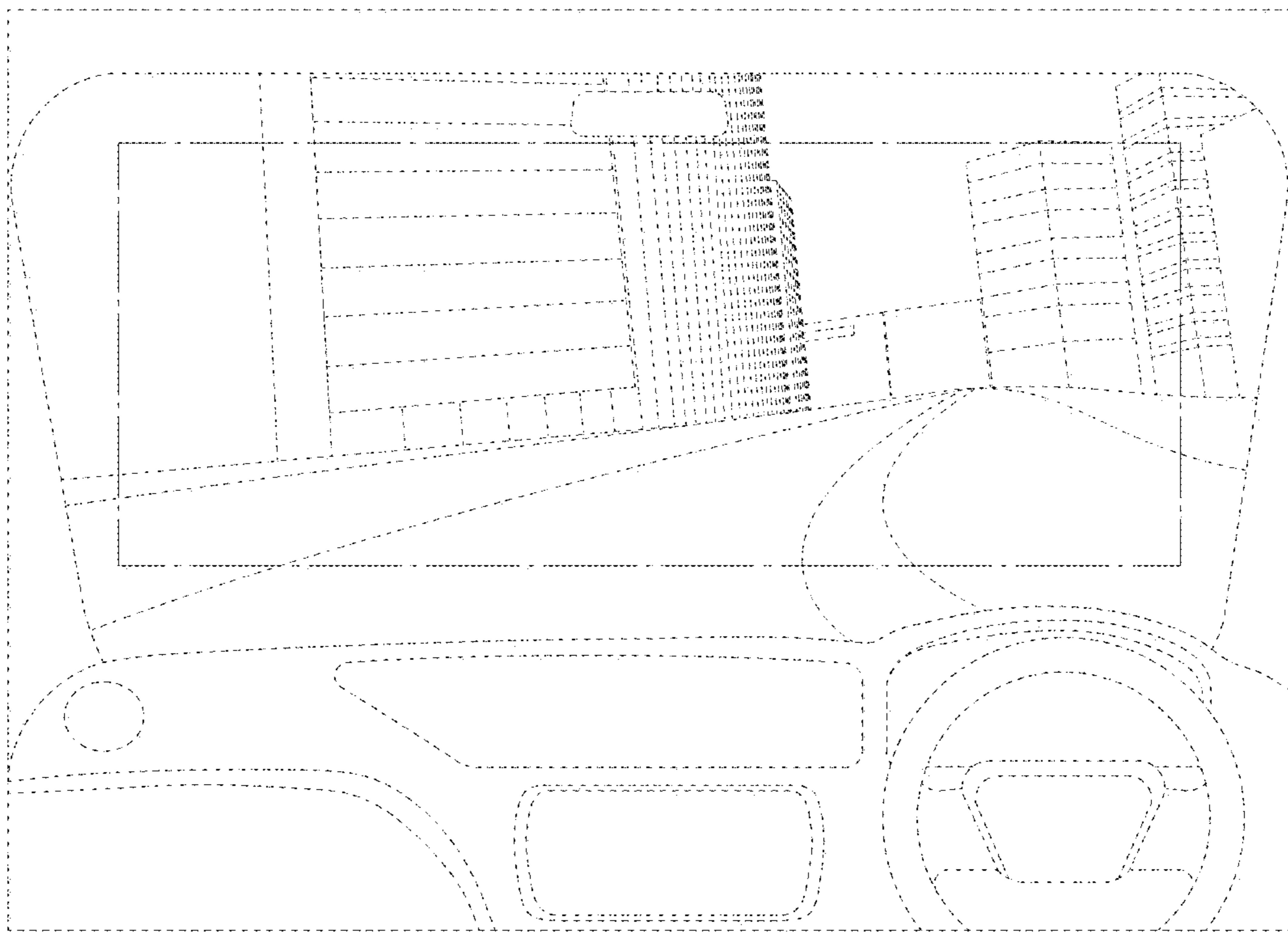

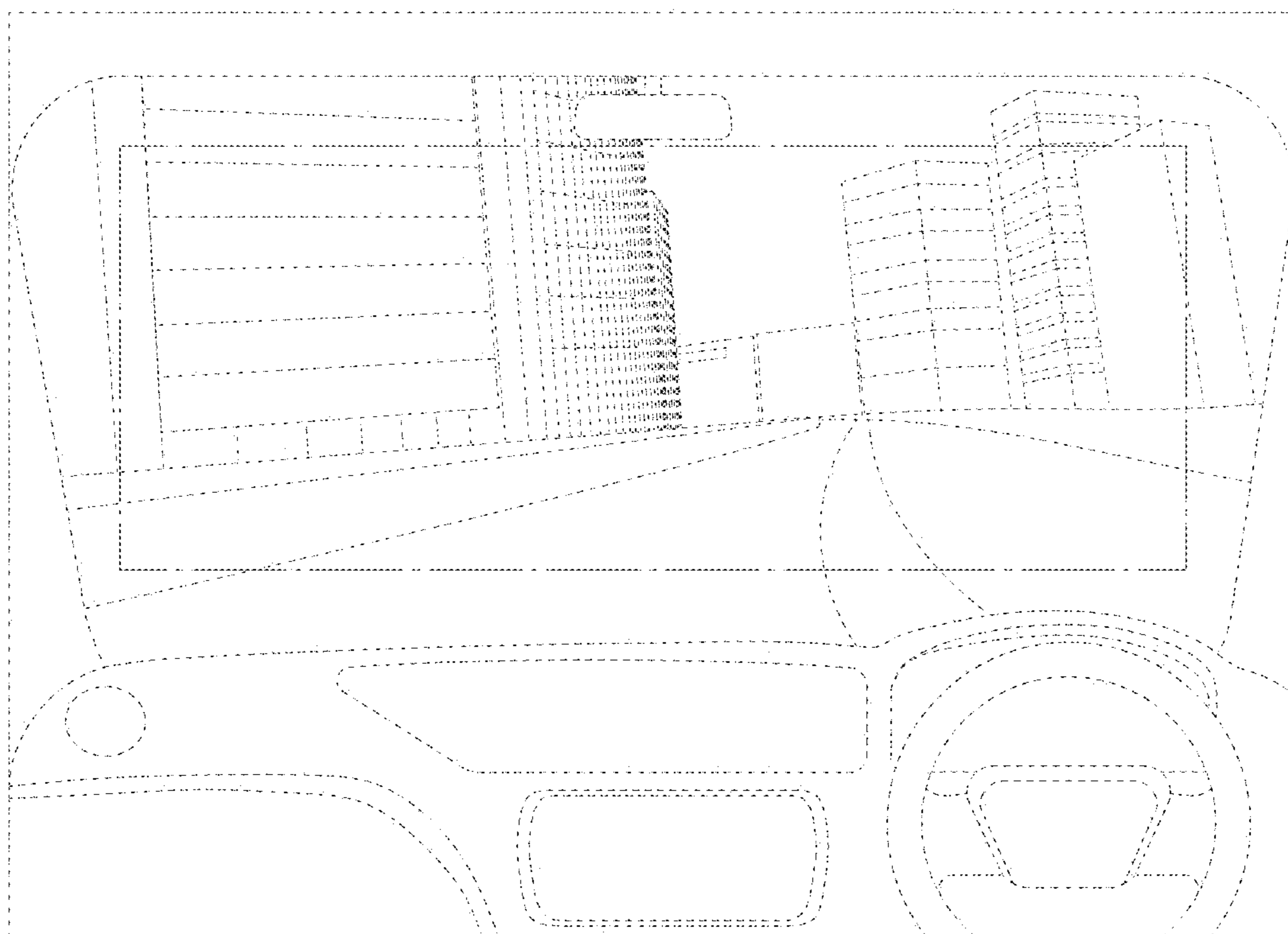

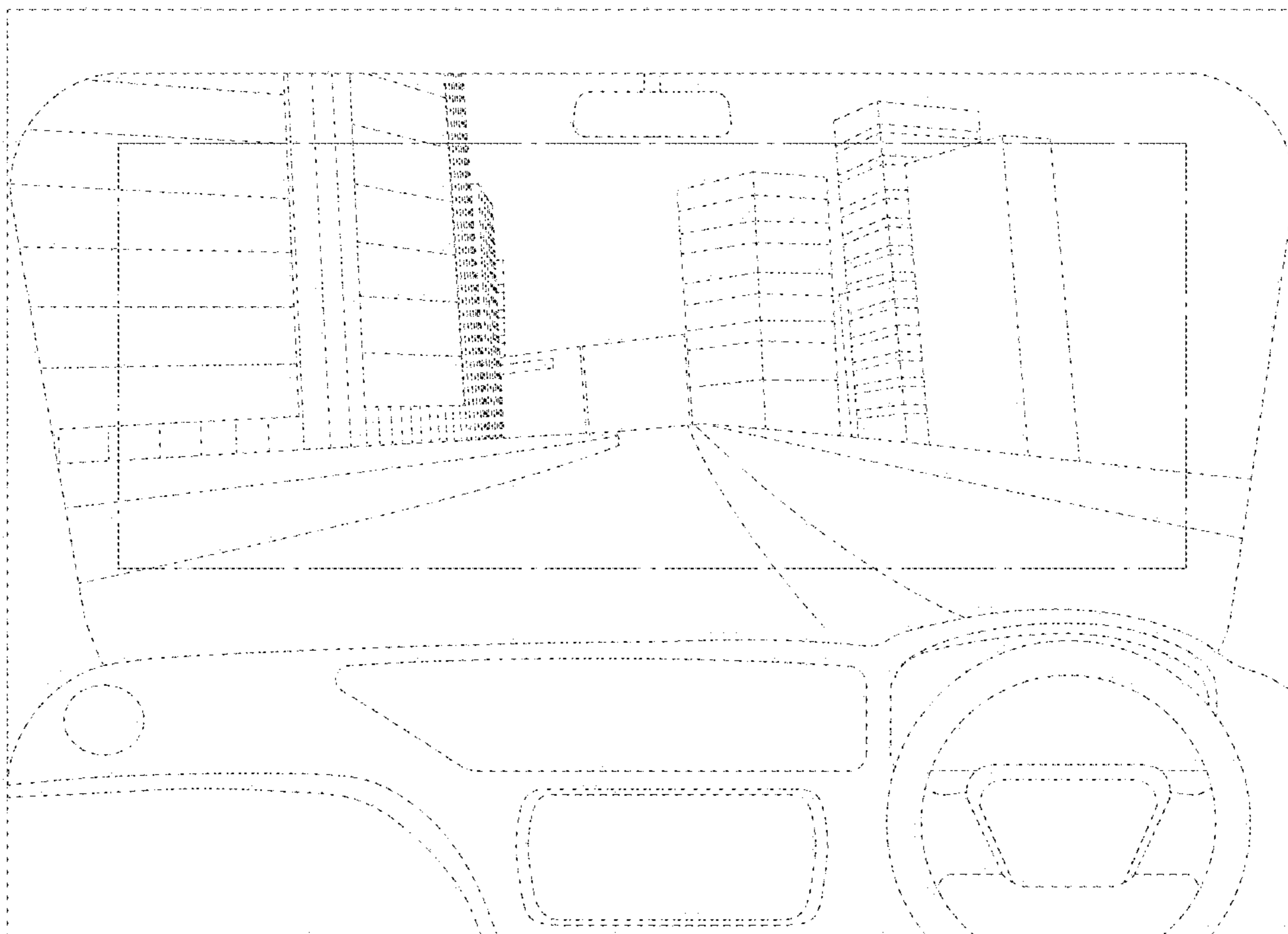

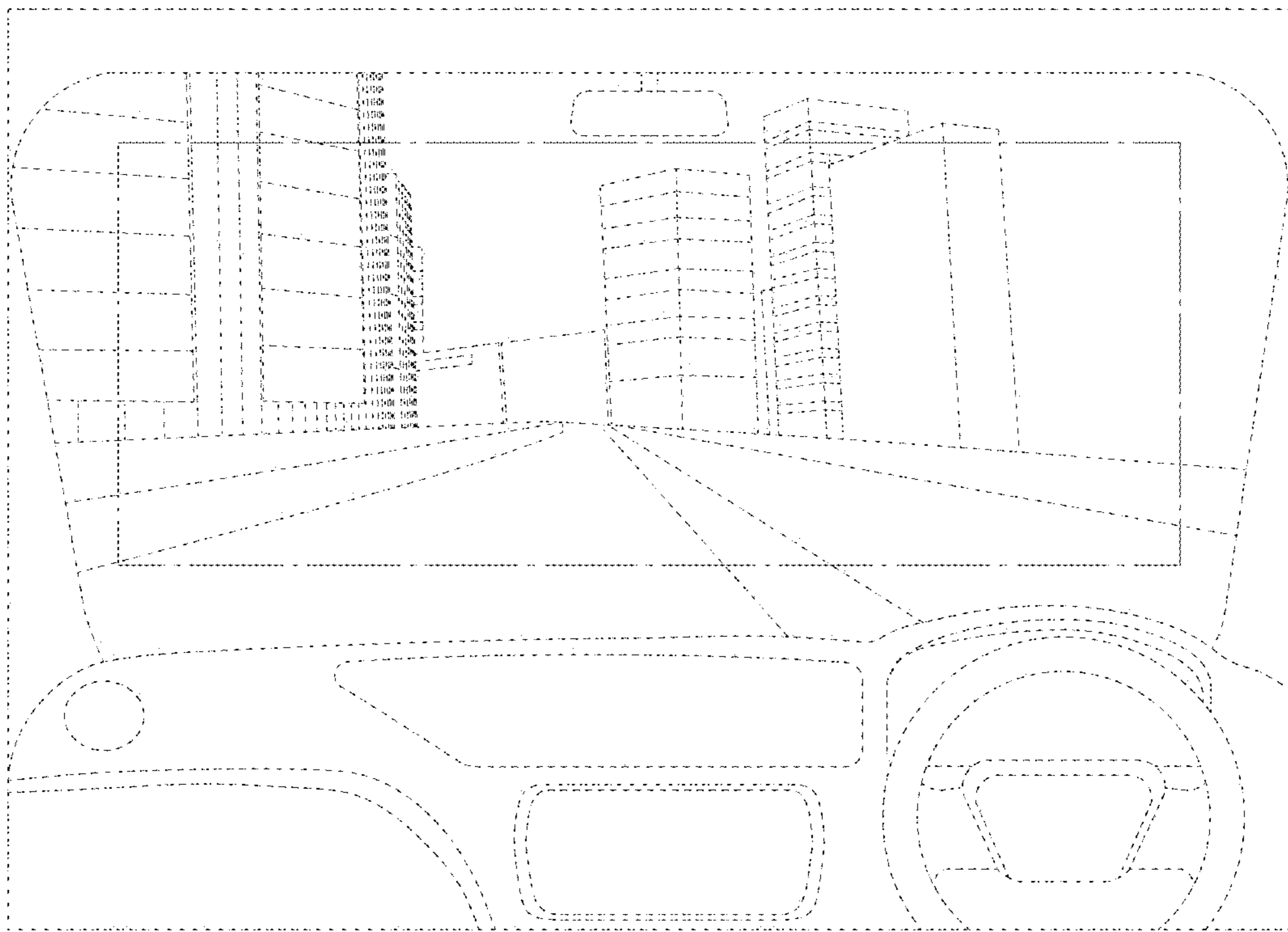

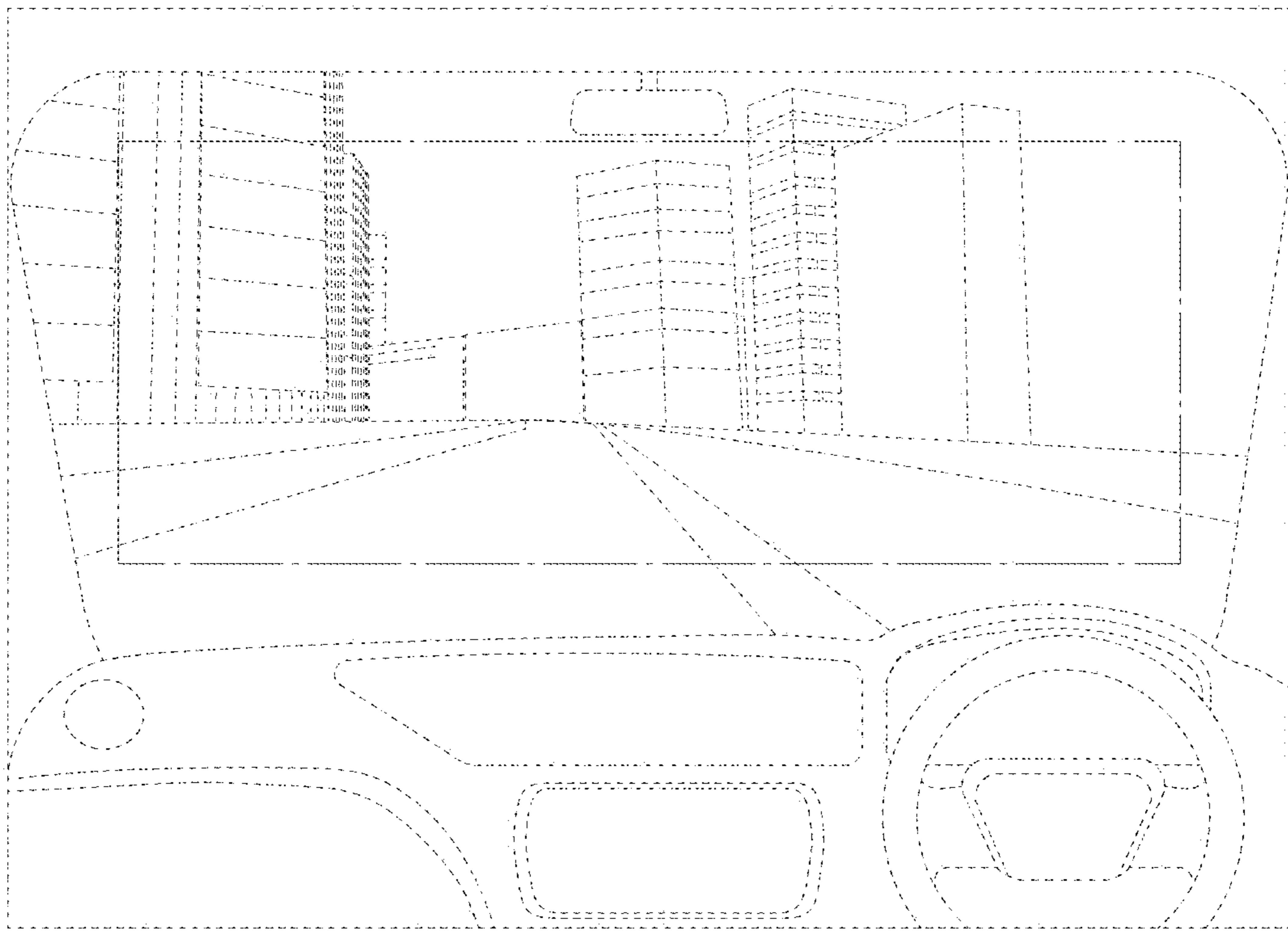

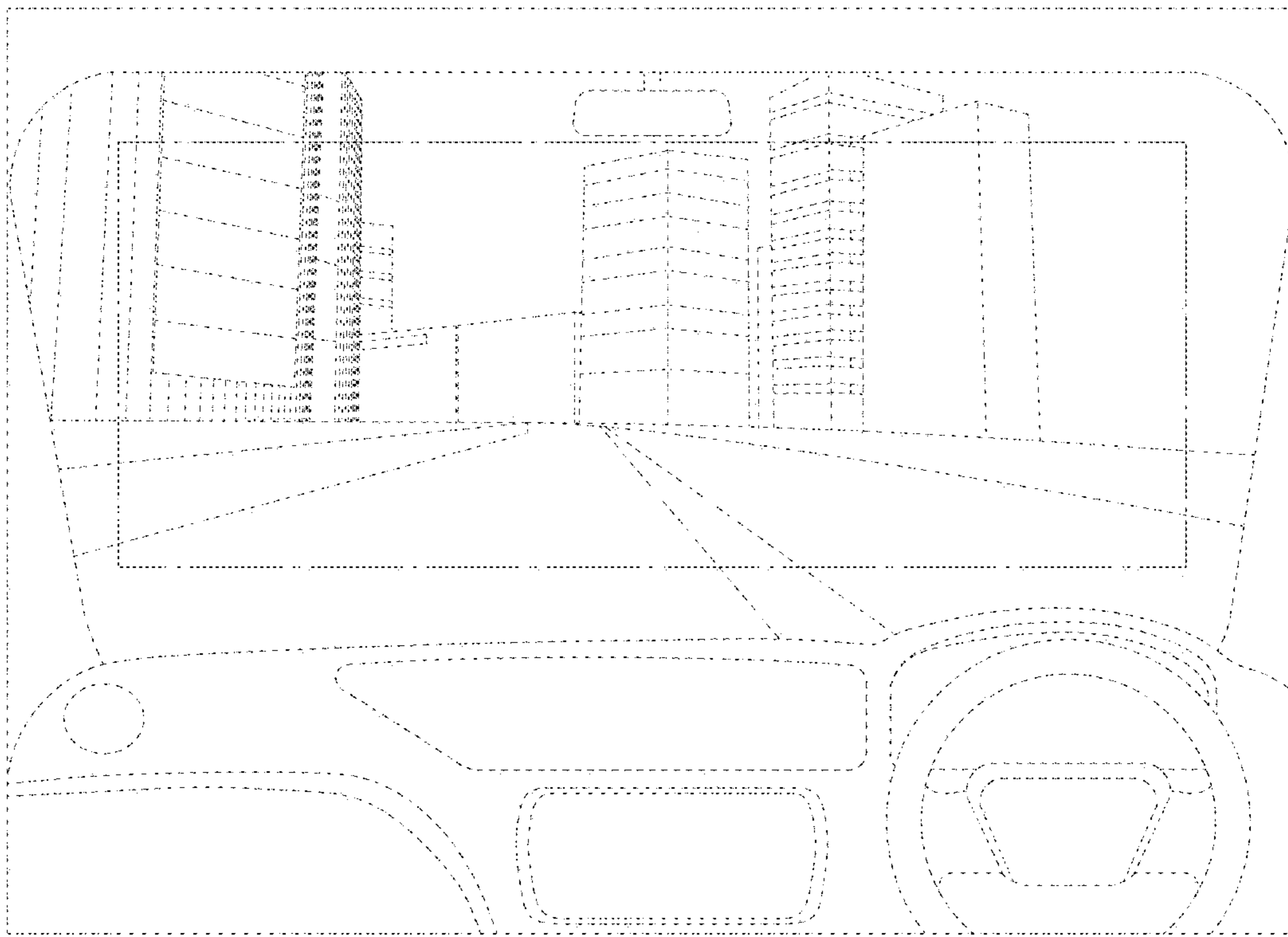

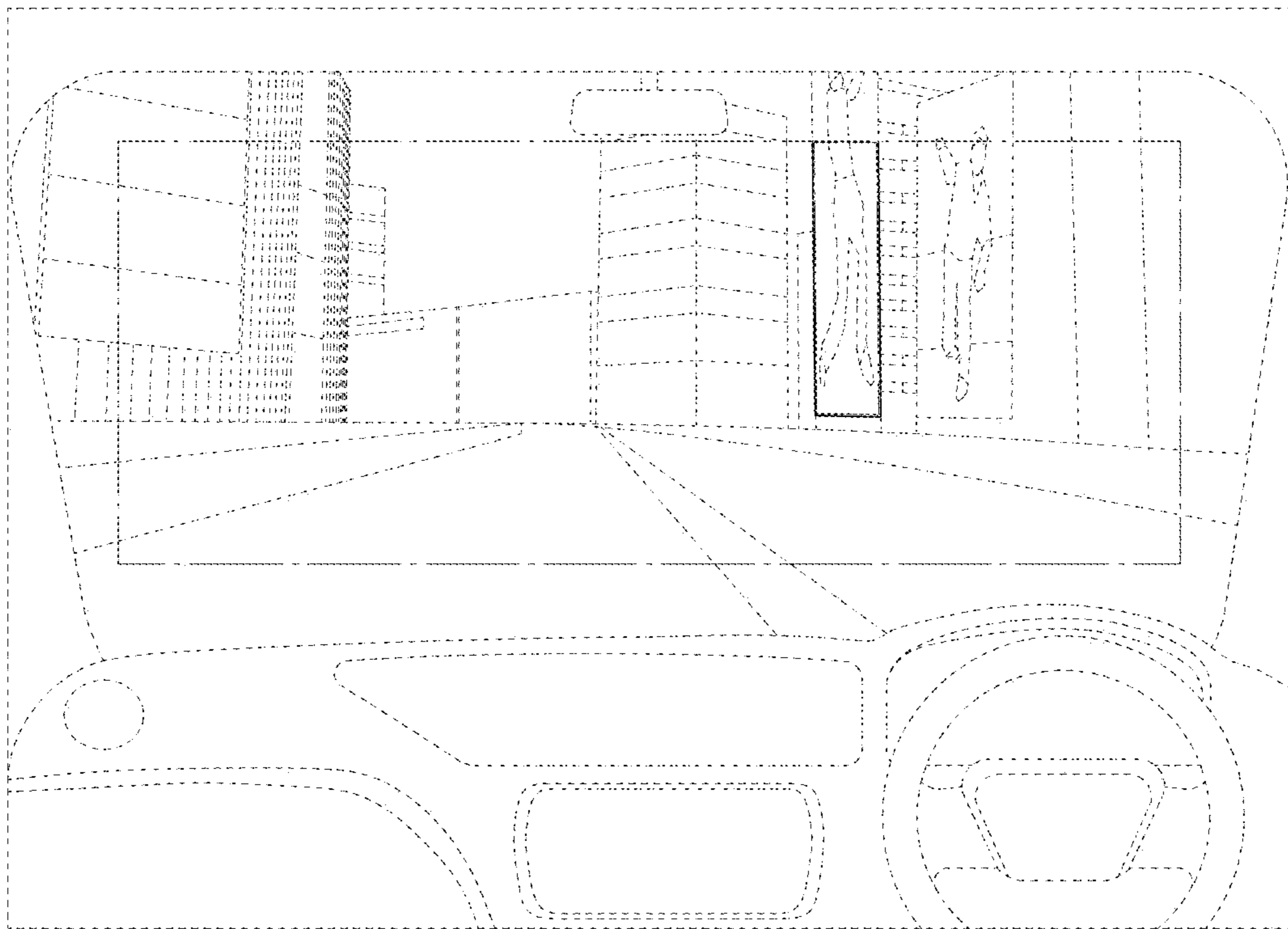

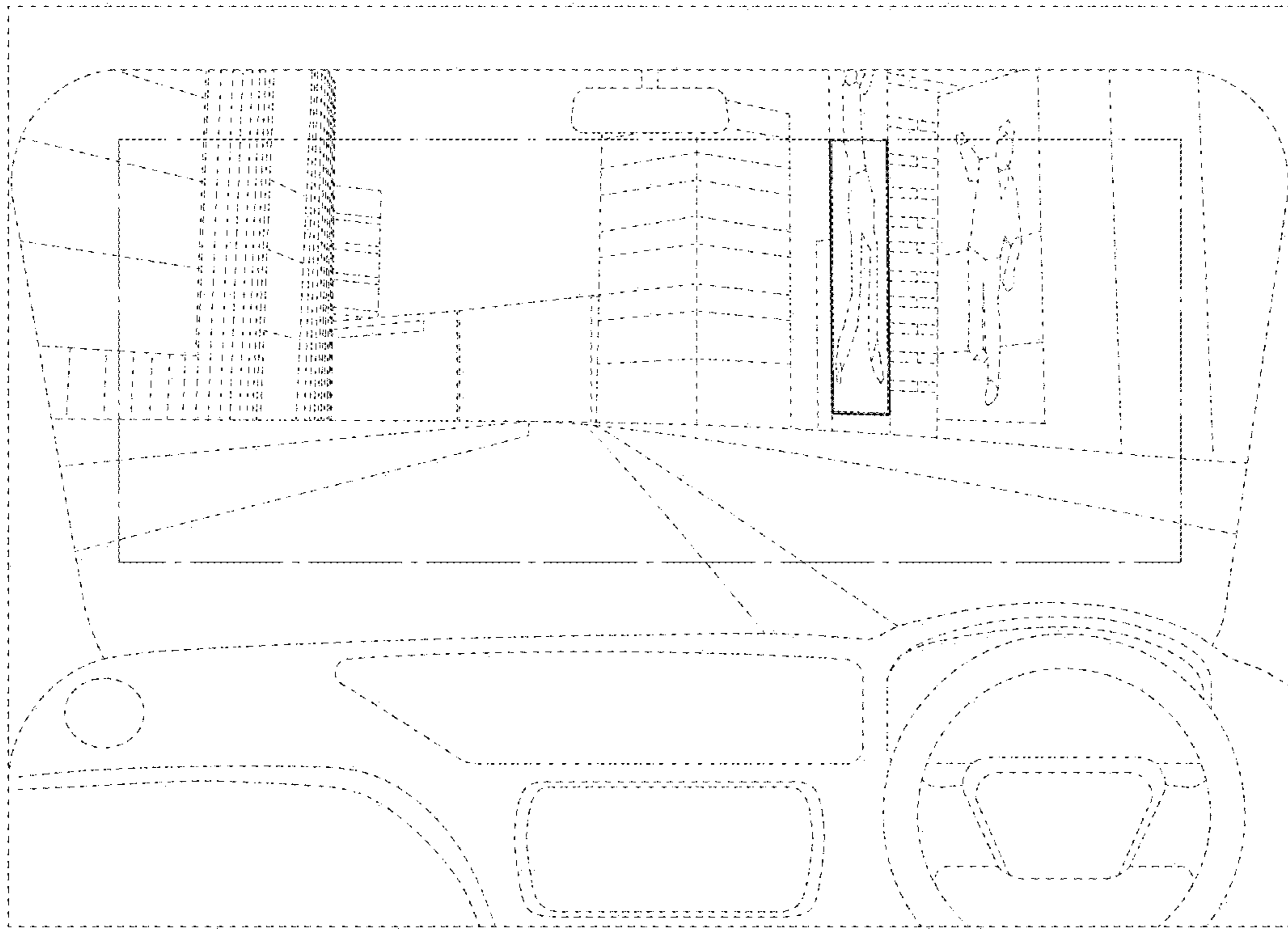

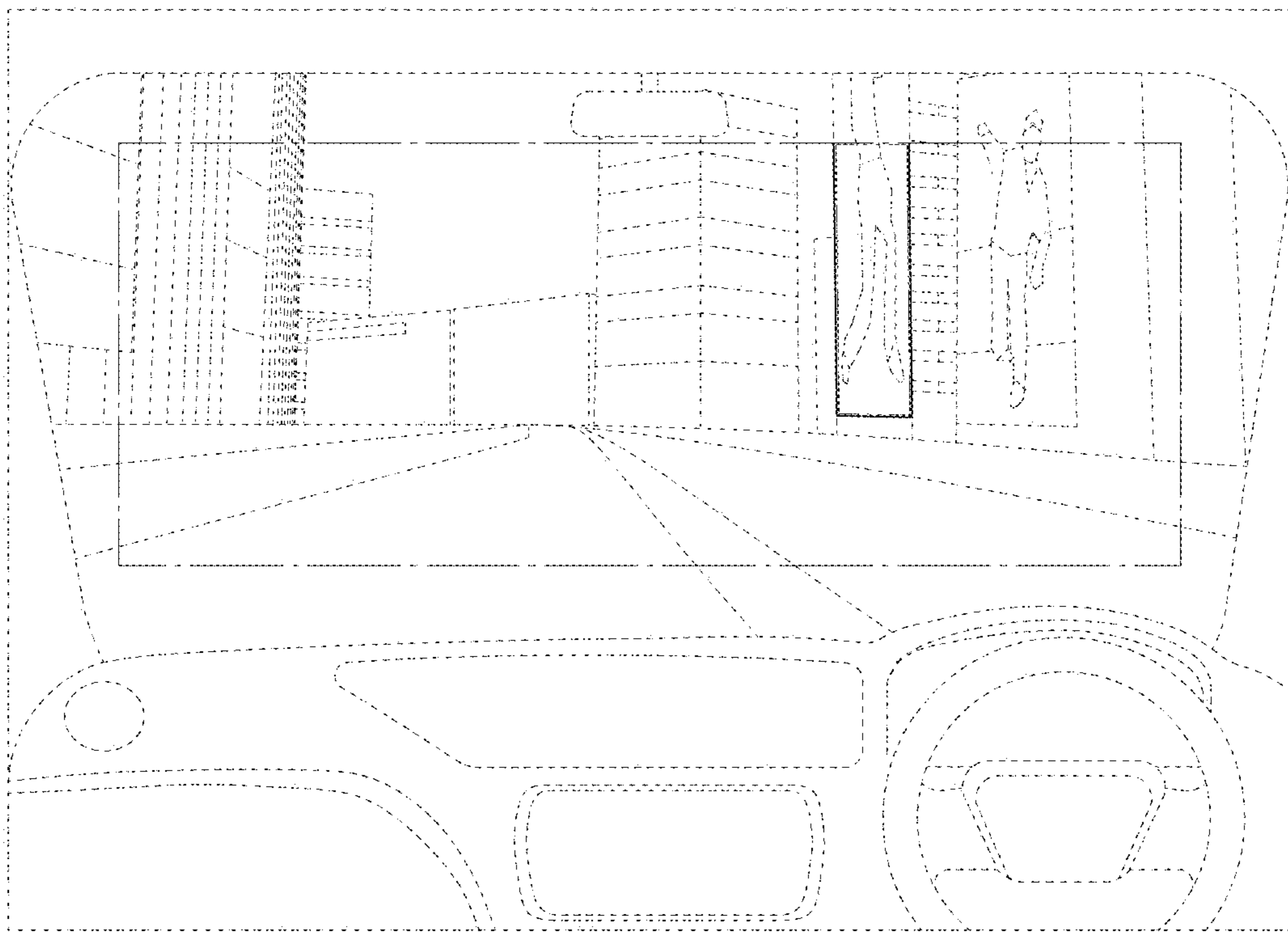

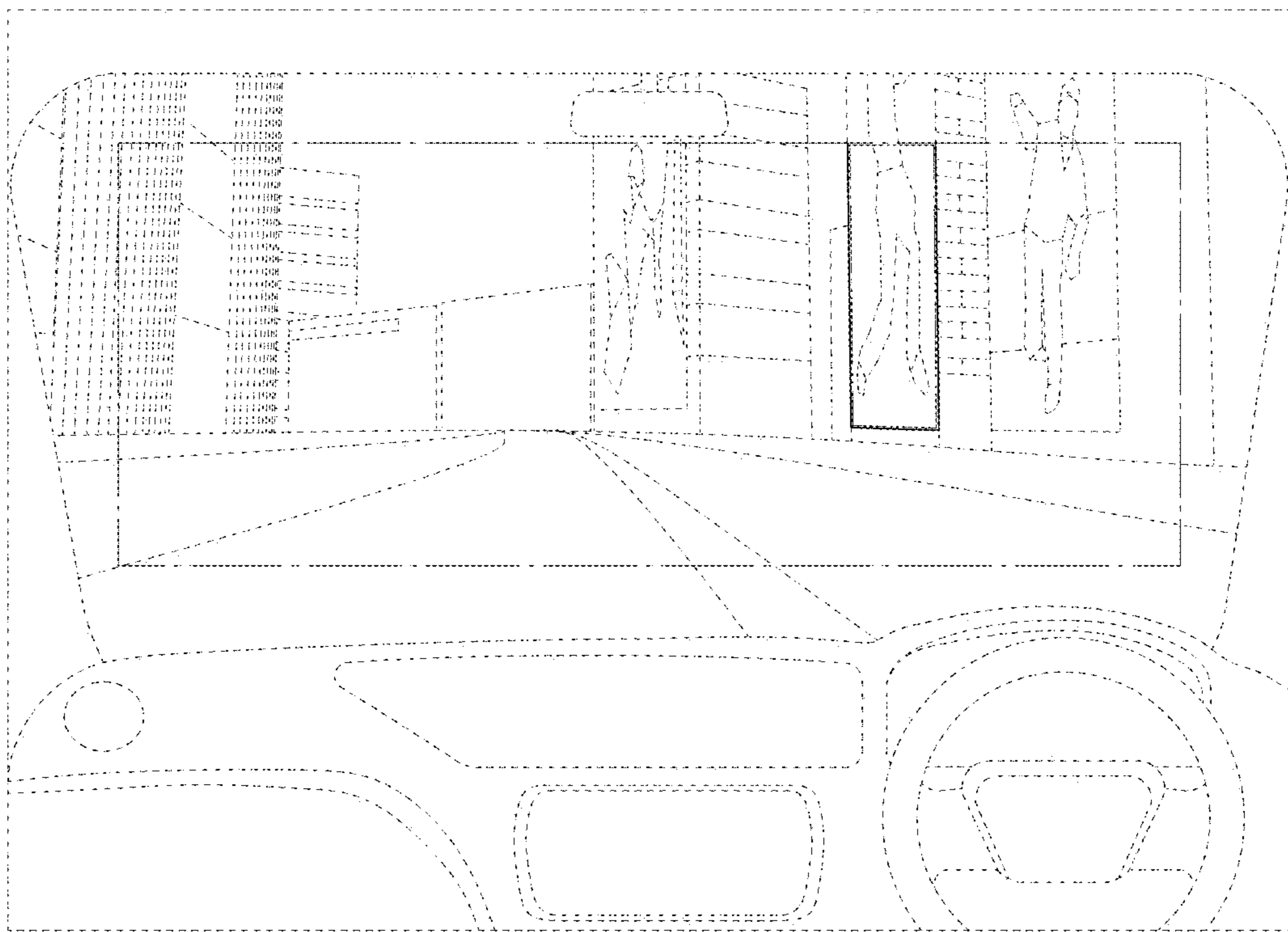

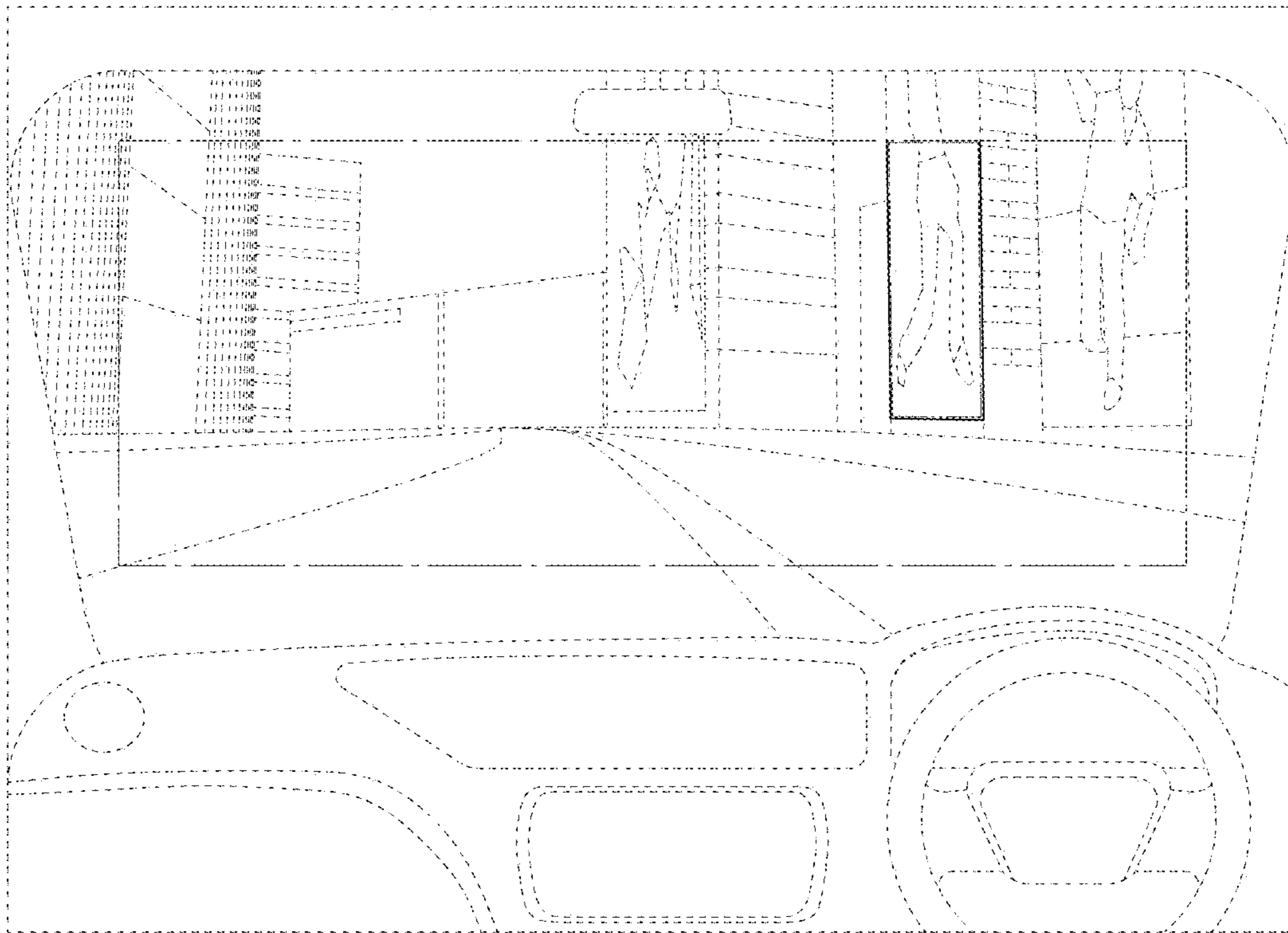

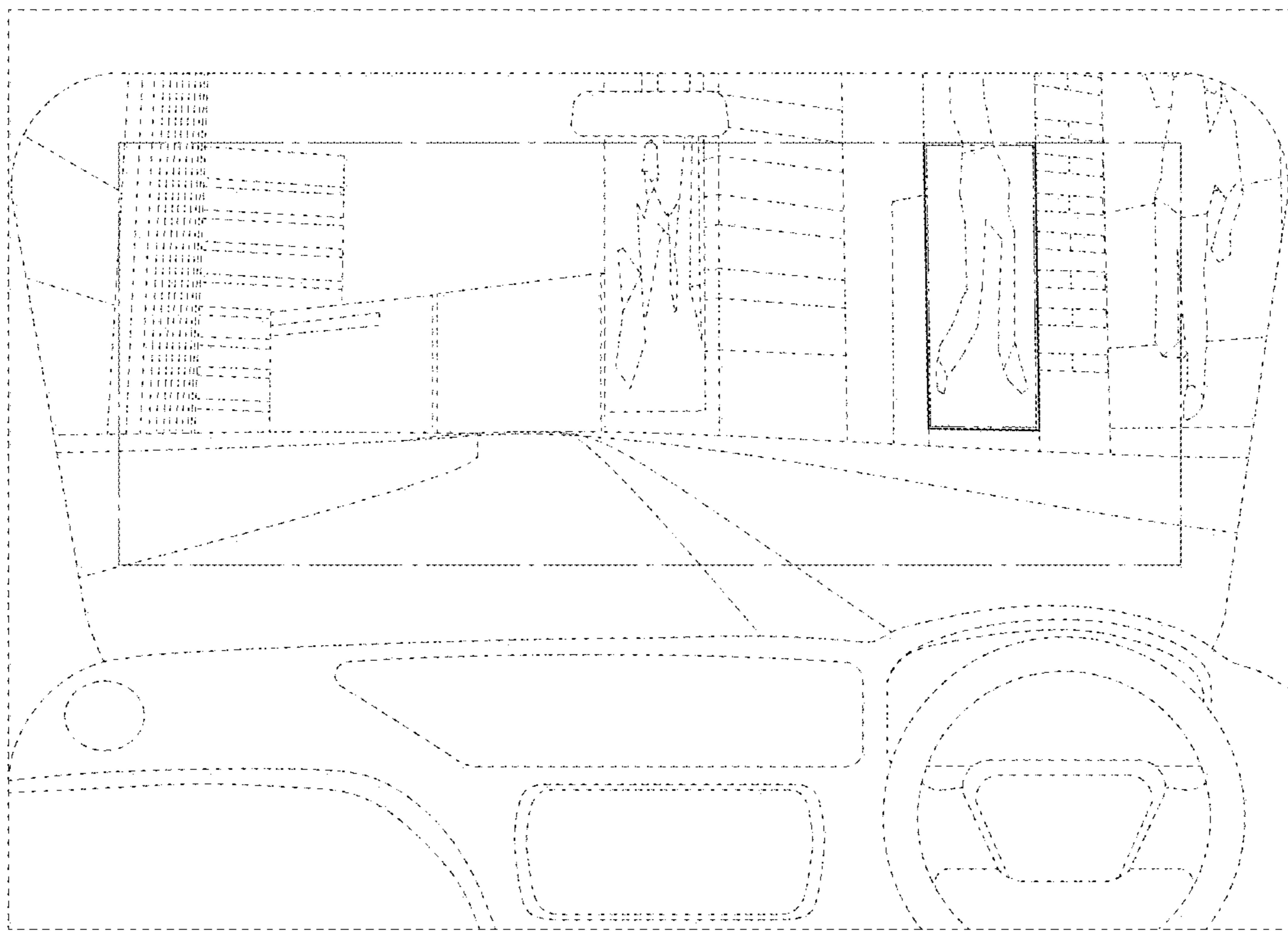

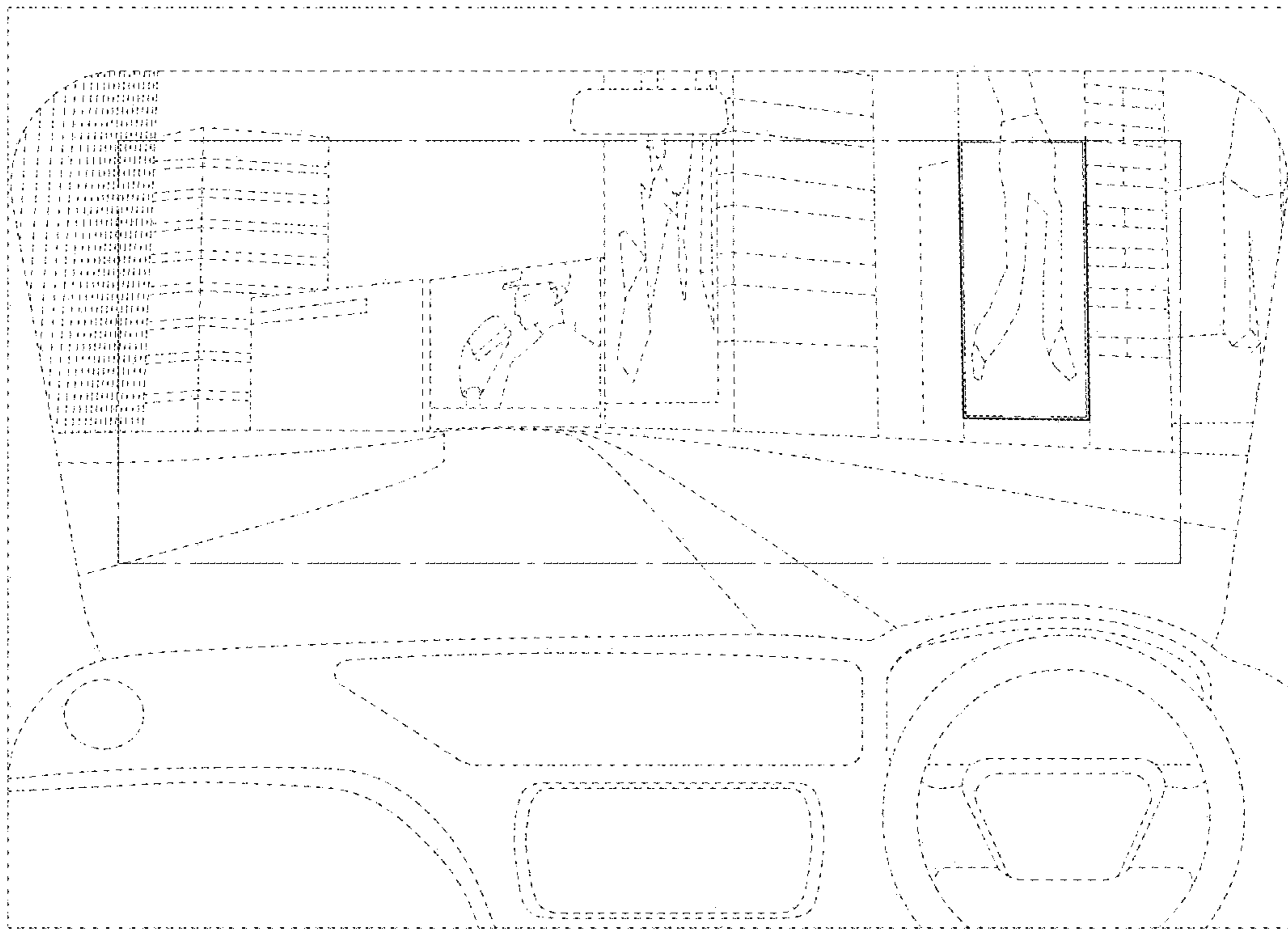

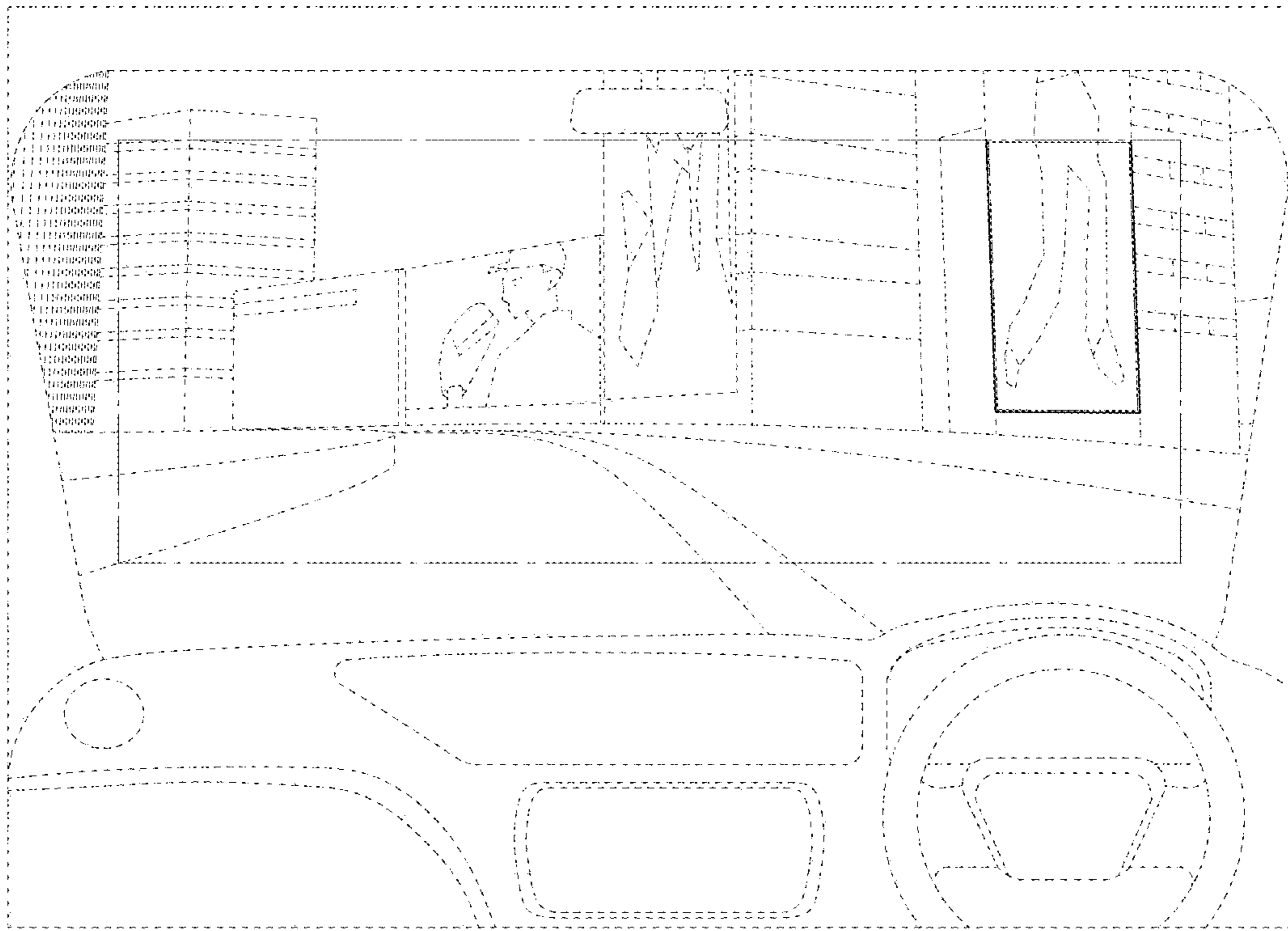

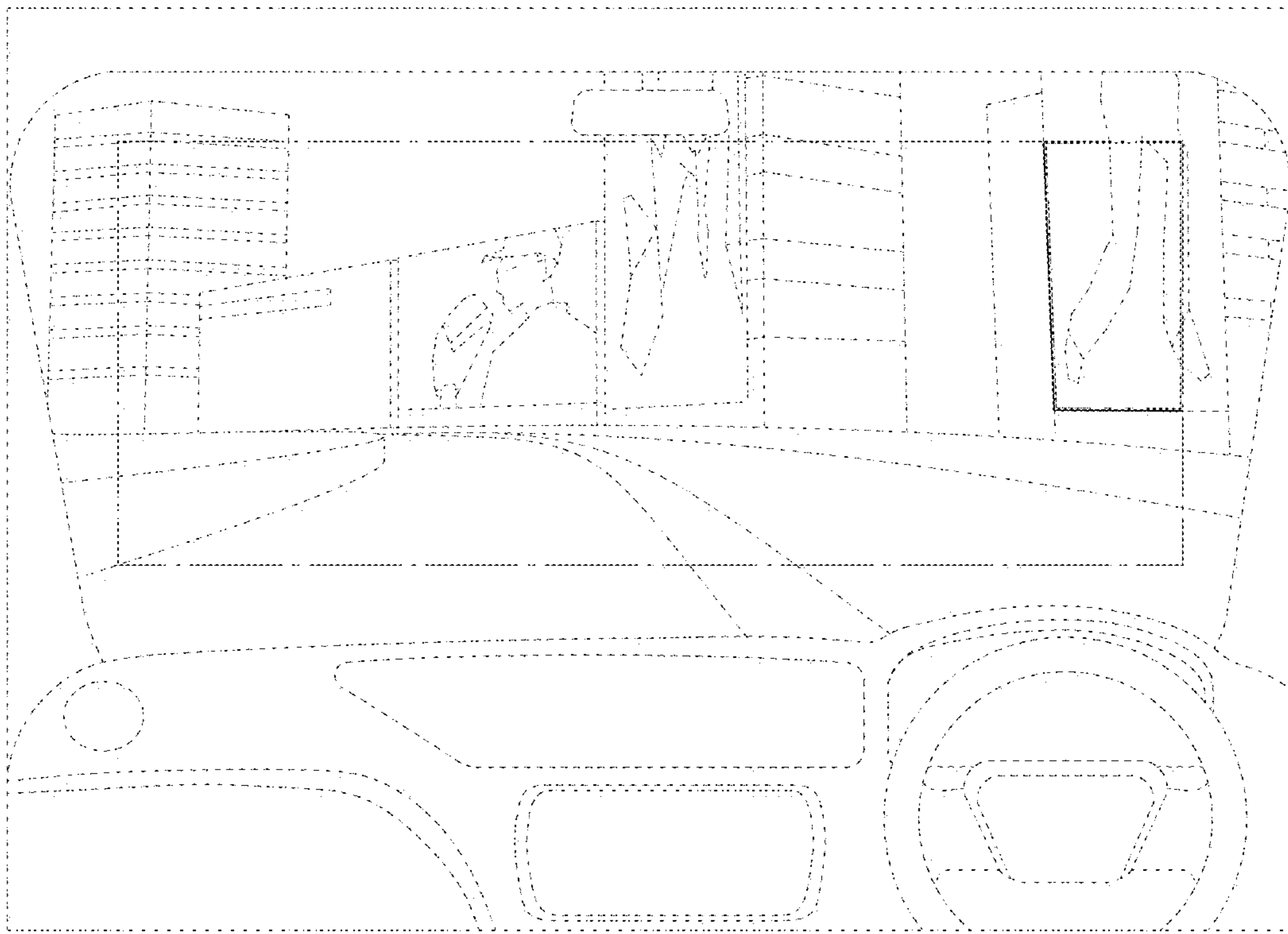

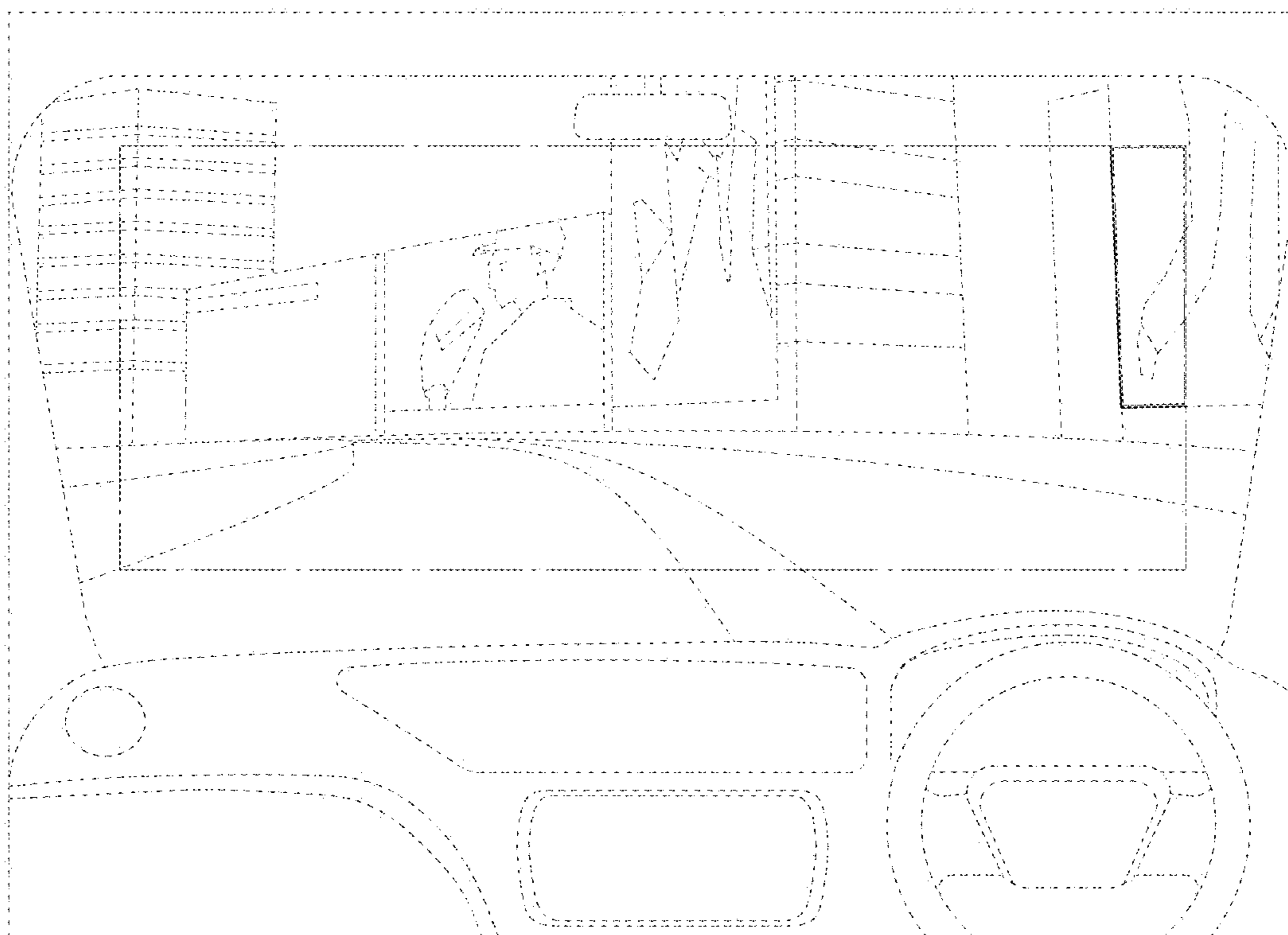

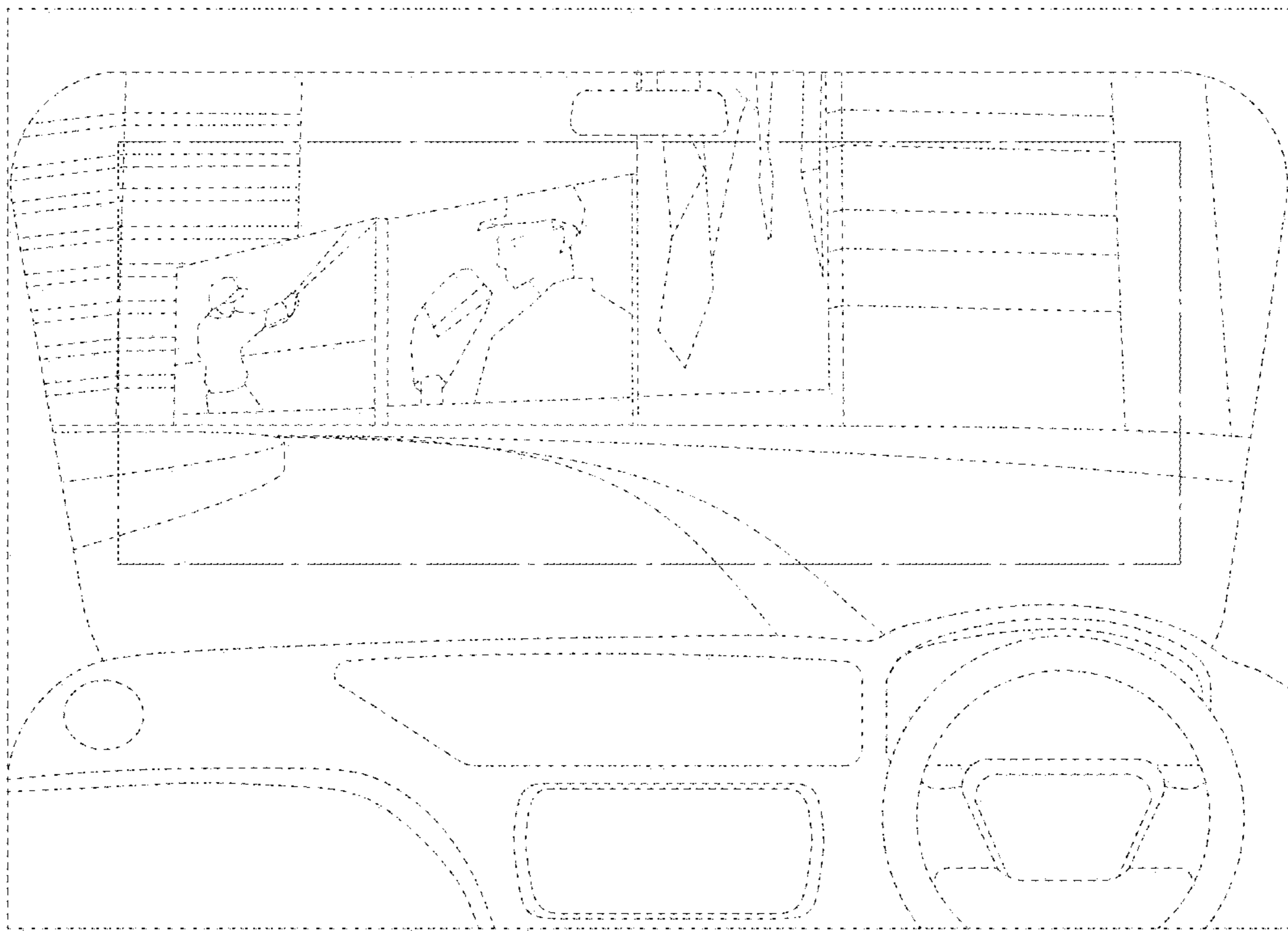

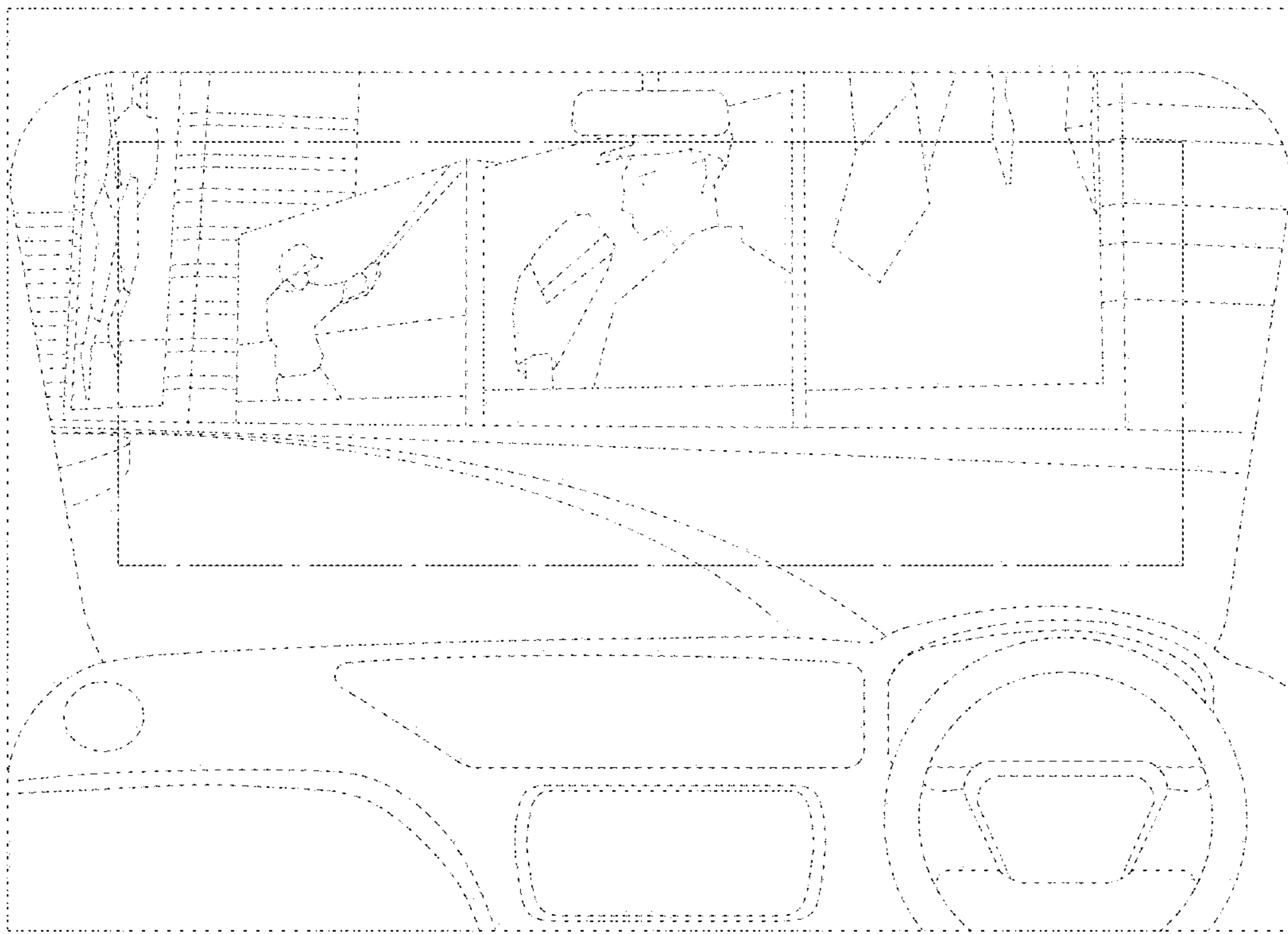

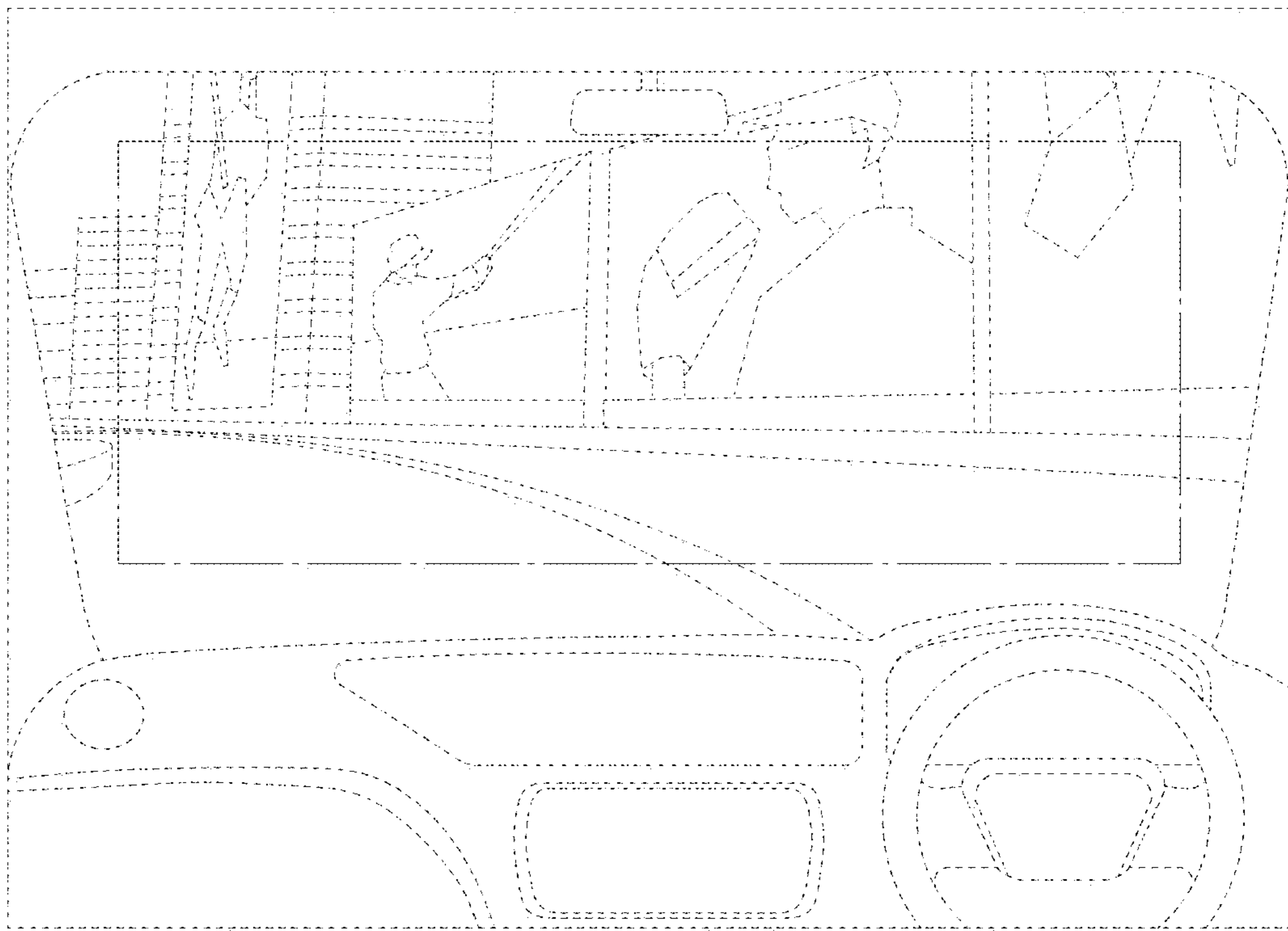

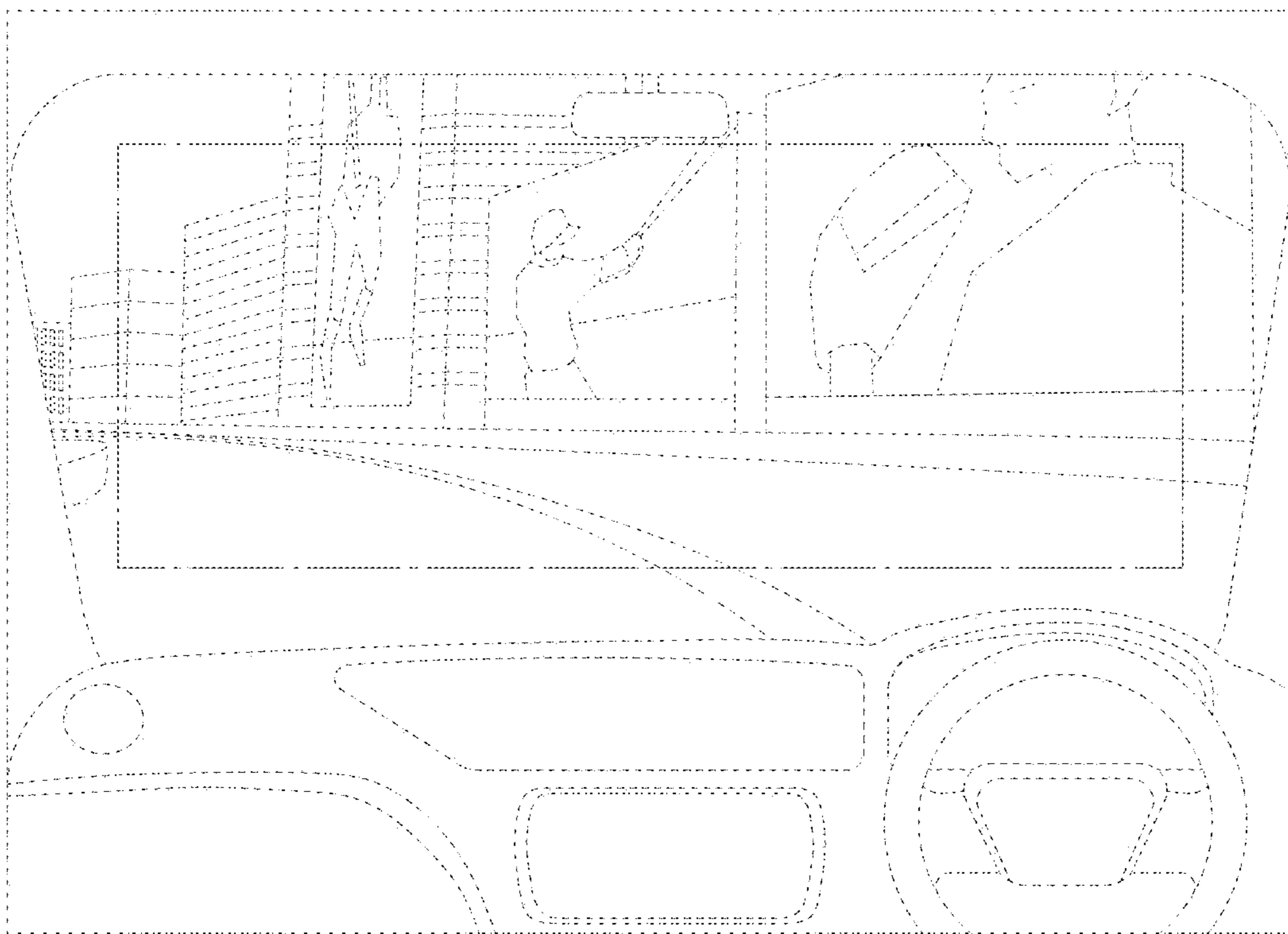

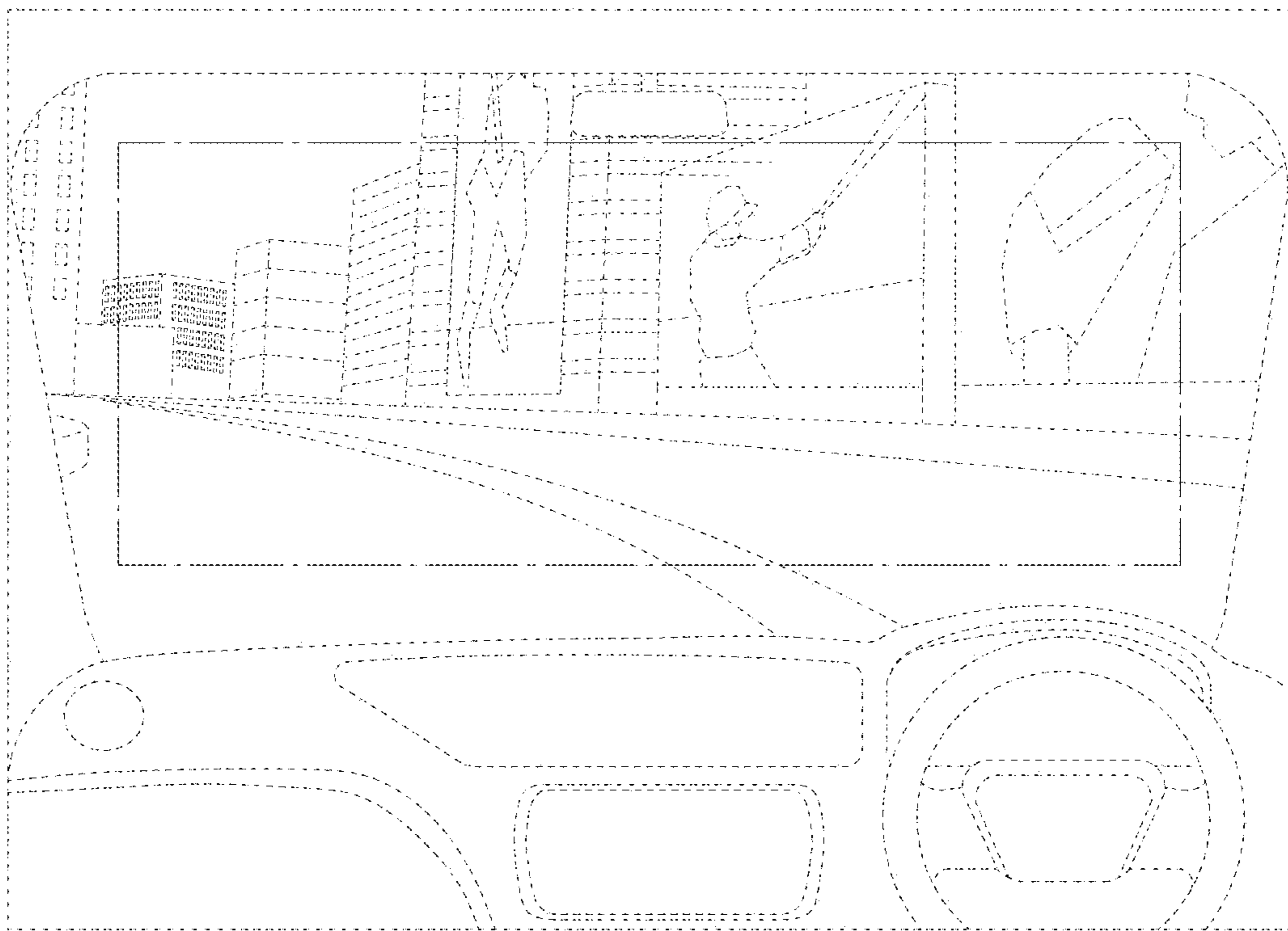

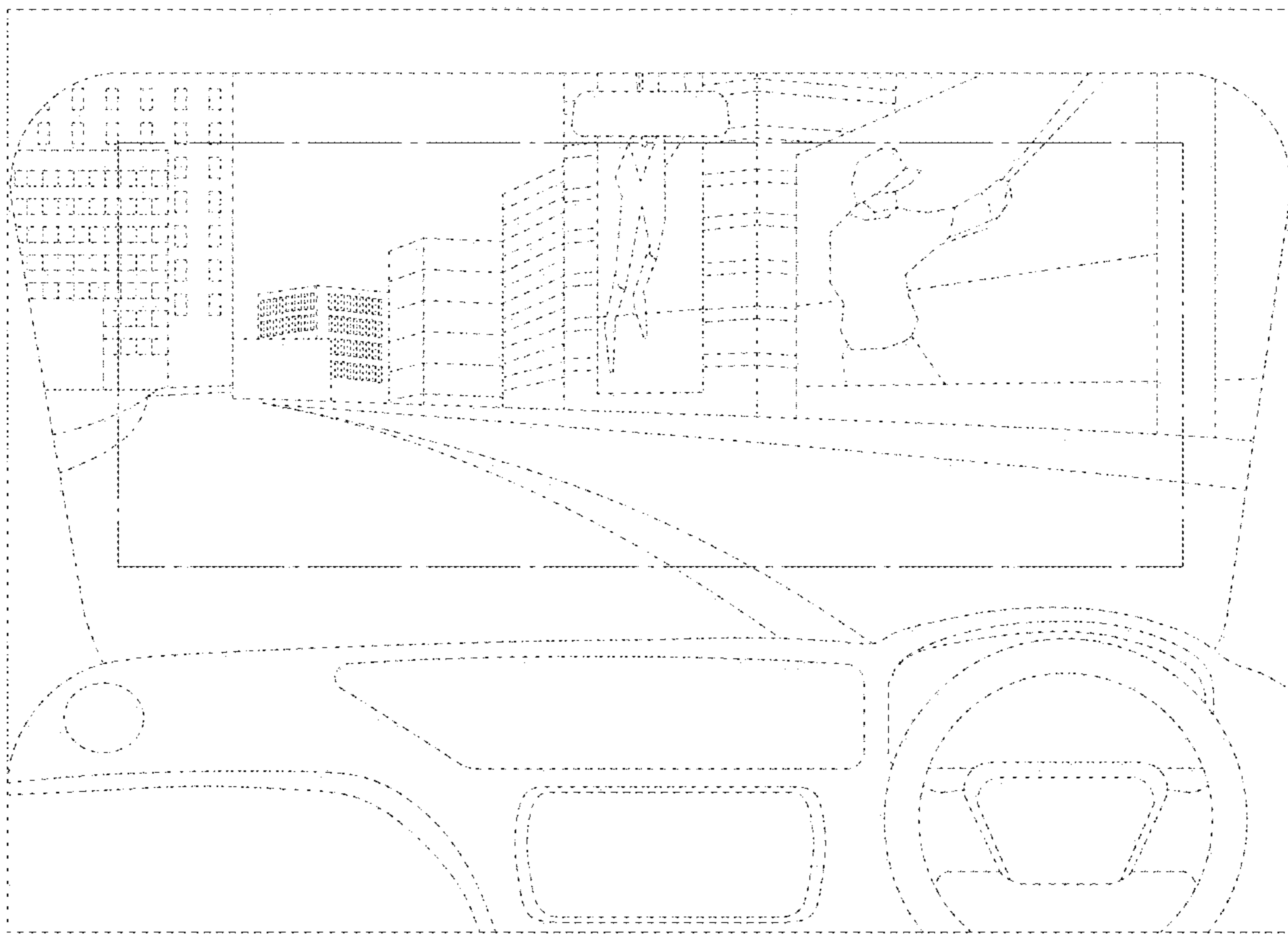

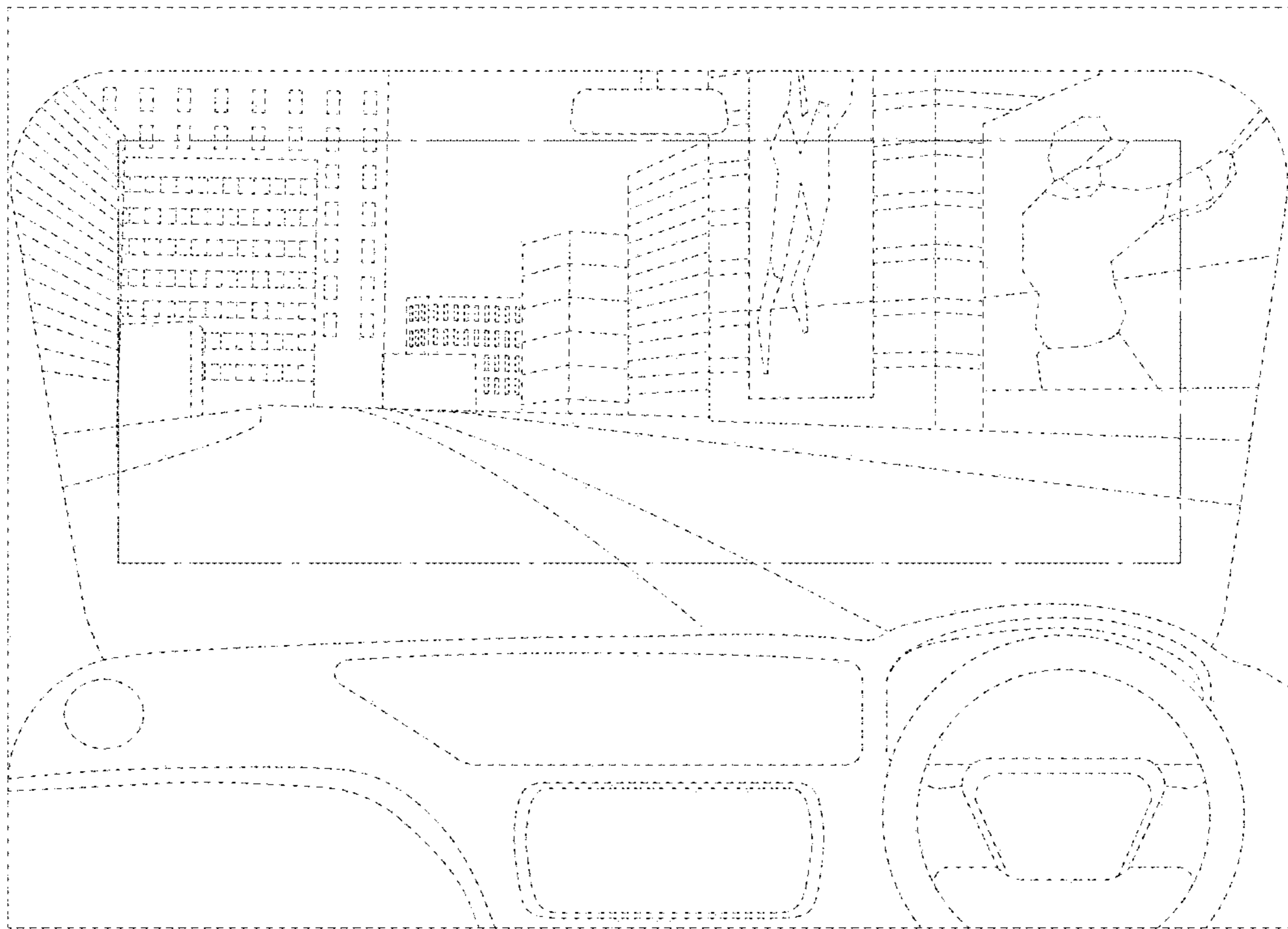

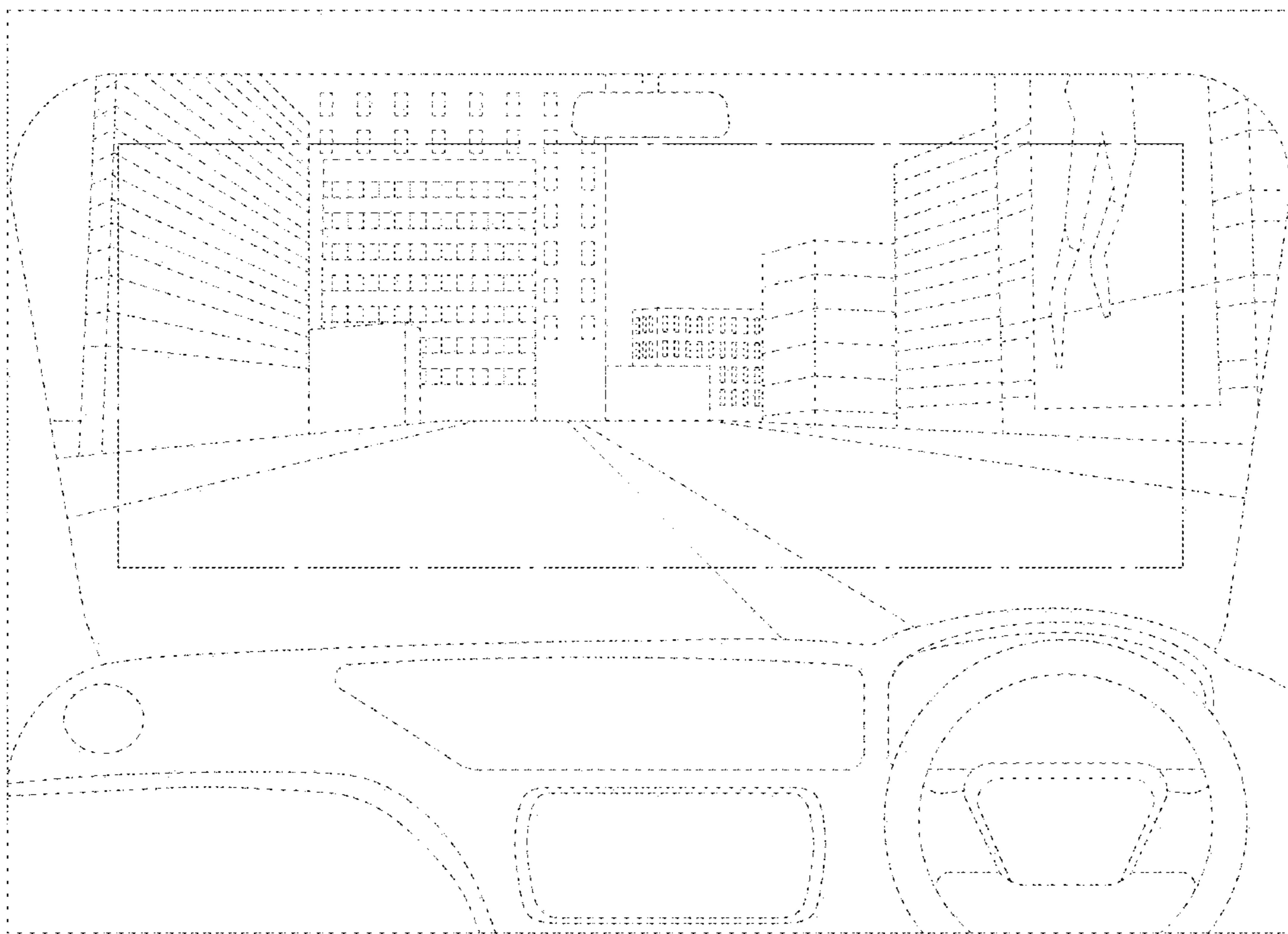

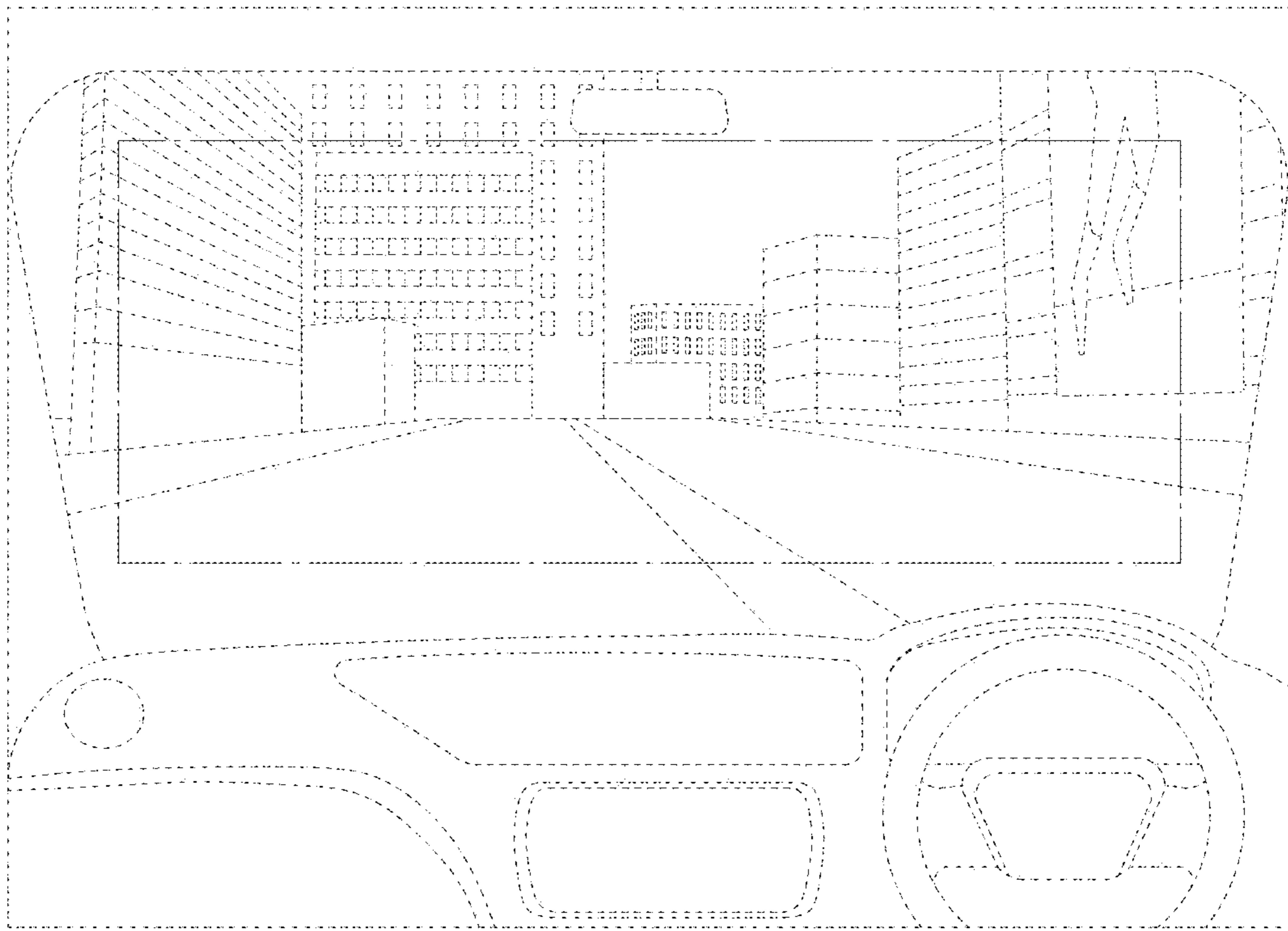
