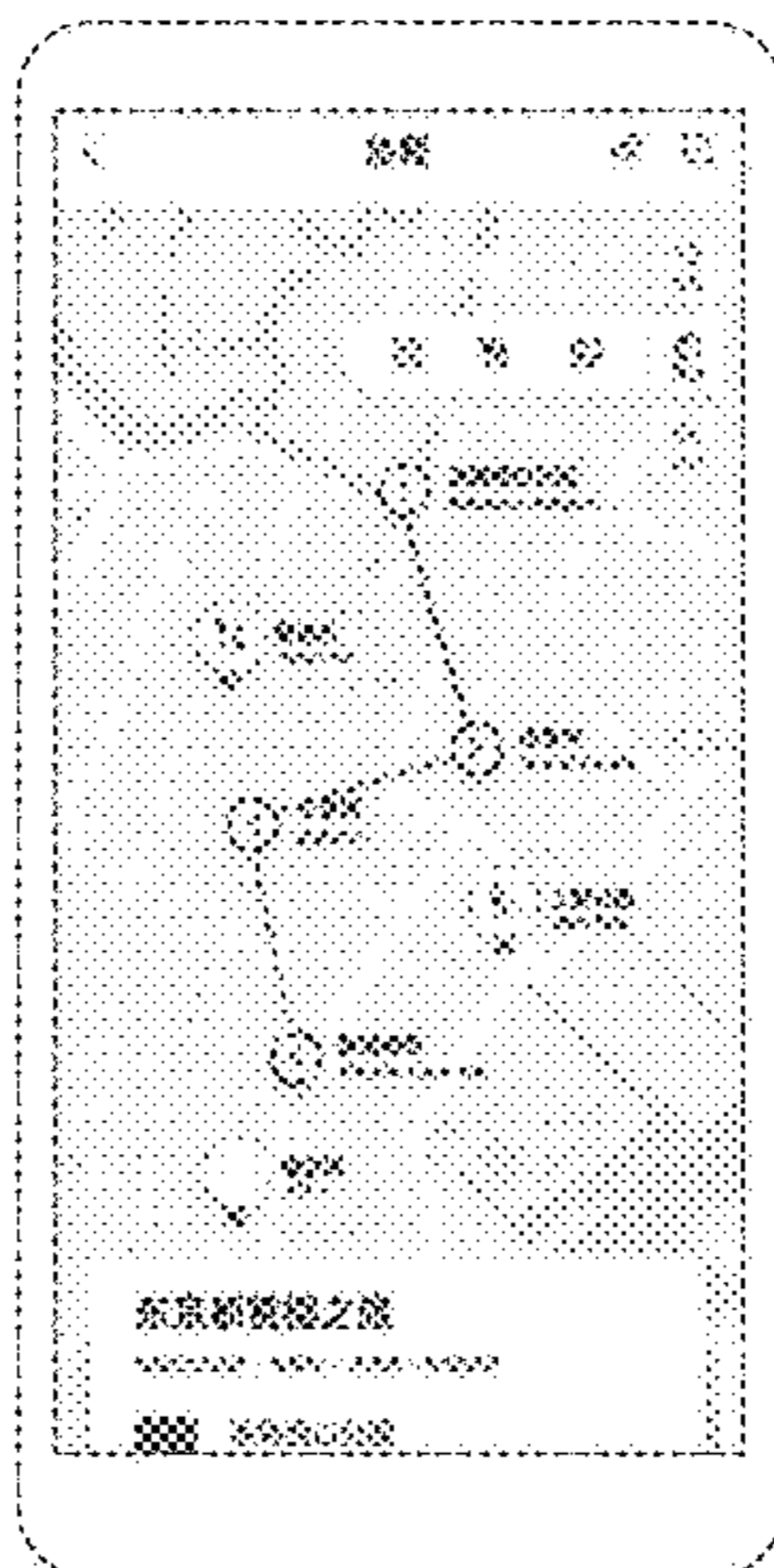
FIG. 1 is a front view of a mobile phone or portion thereof with graphical user interface, showing a first embodiment of our new design.
