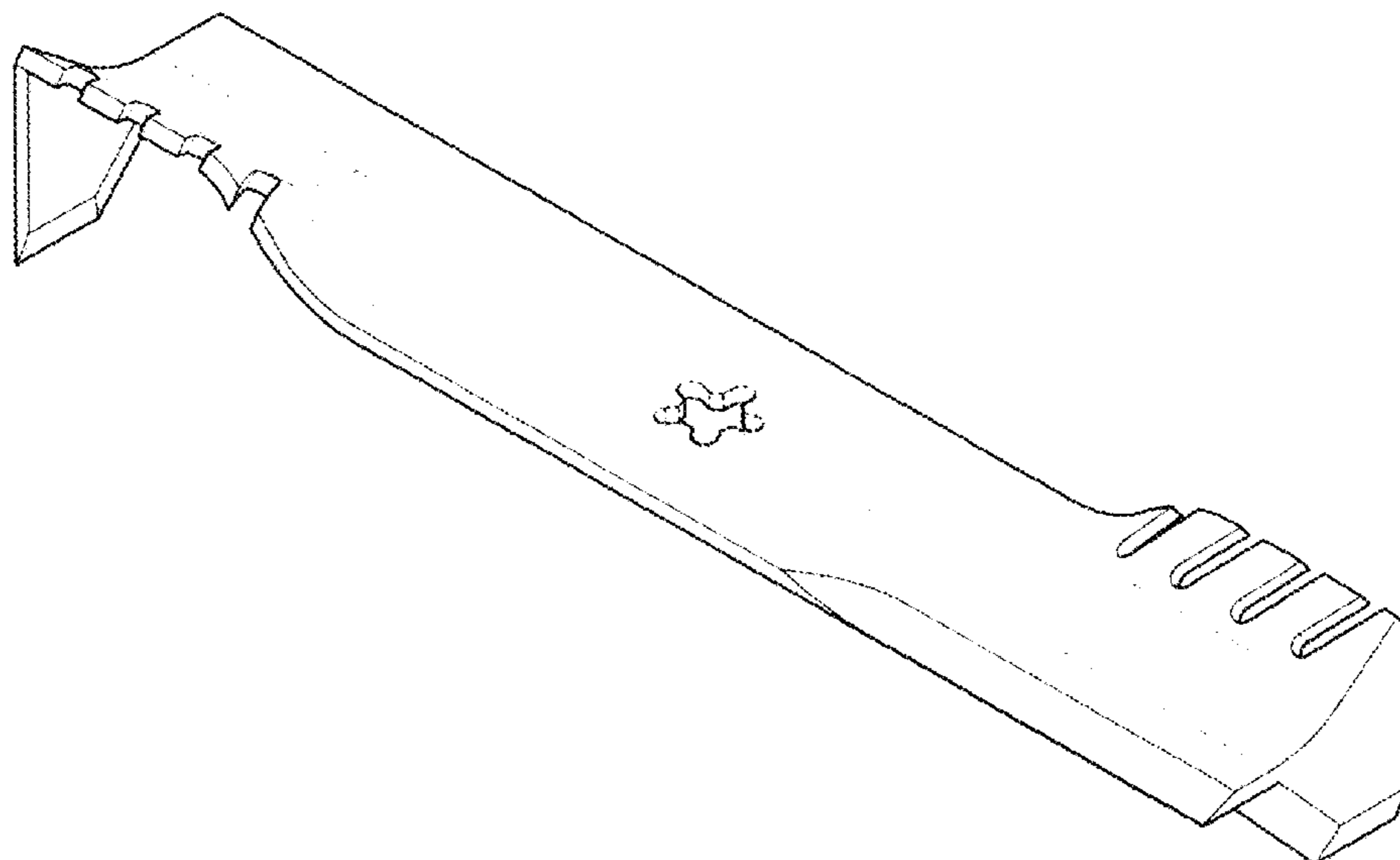
(57) **CLAIM**

The ornamental design for a cutting blade, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a cutting blade showing the present design;
FIG. 2 is a front view of the cutting blade of FIG. 1;
FIG. 3 is a left side view of the cutting blade of FIG. 1;
FIG. 4 is a bottom, rear perspective view of the cutting blade of FIG. 1;
FIG. 5 is a rear view of the cutting blade of FIG. 1;
FIG. 6 is a right side view of the cutting blade of FIG. 1;
FIG. 7 is a top view of the cutting blade of FIG. 1; and,
FIG. 8 is a bottom view of the cutting blade of FIG. 1.

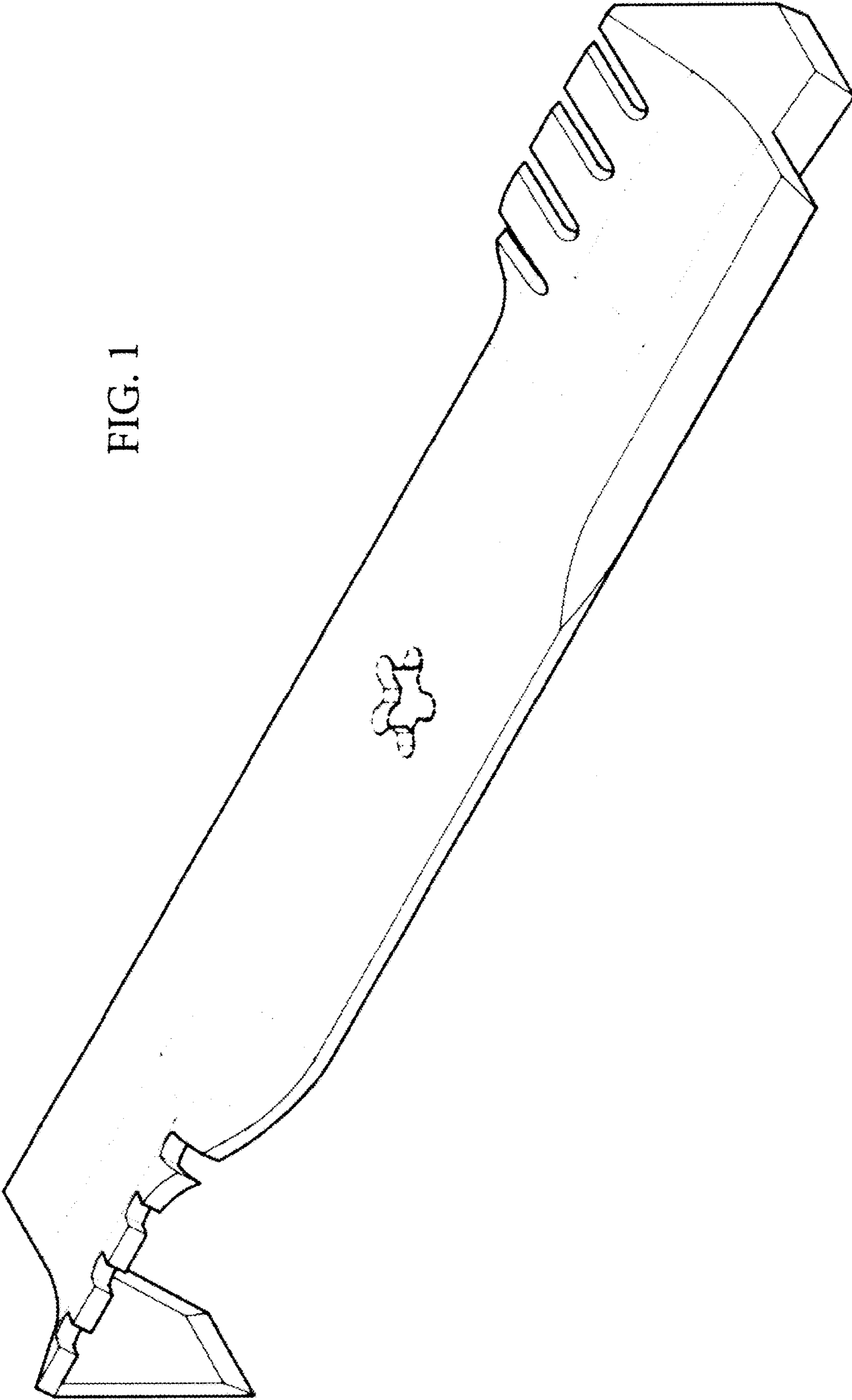

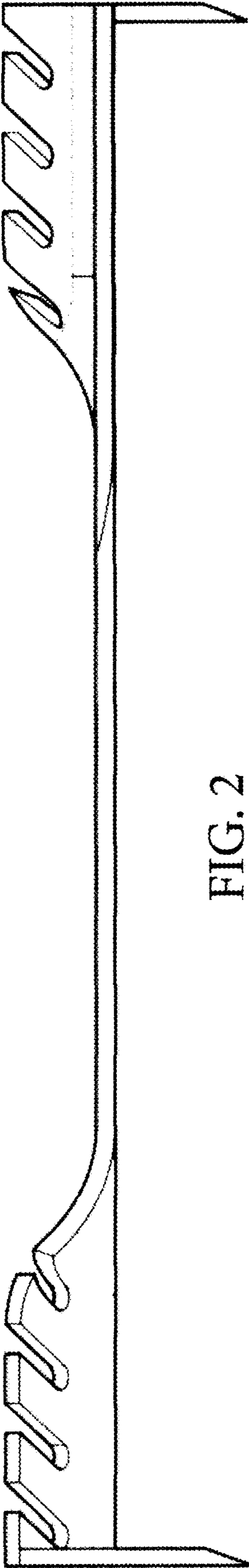

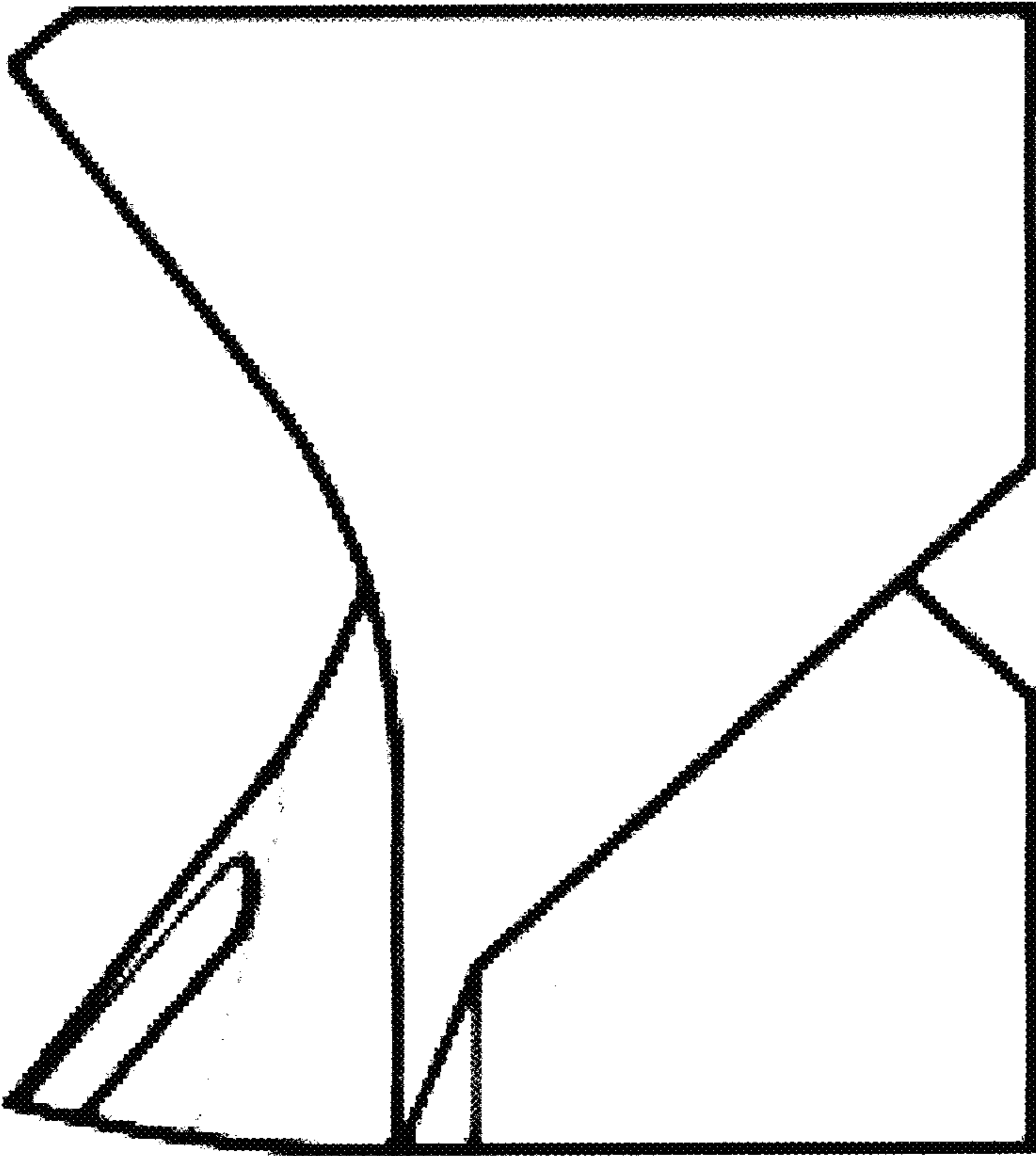

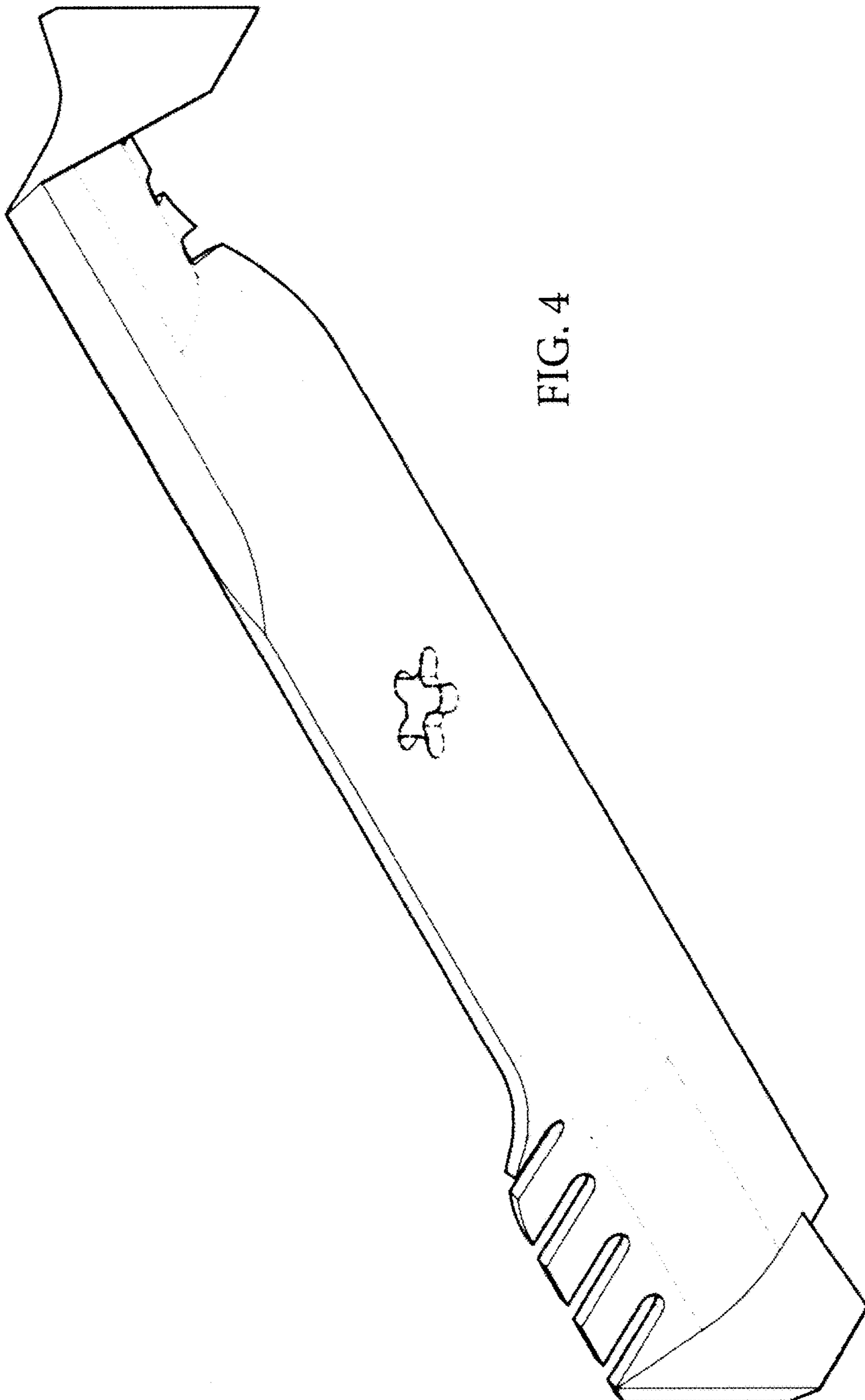

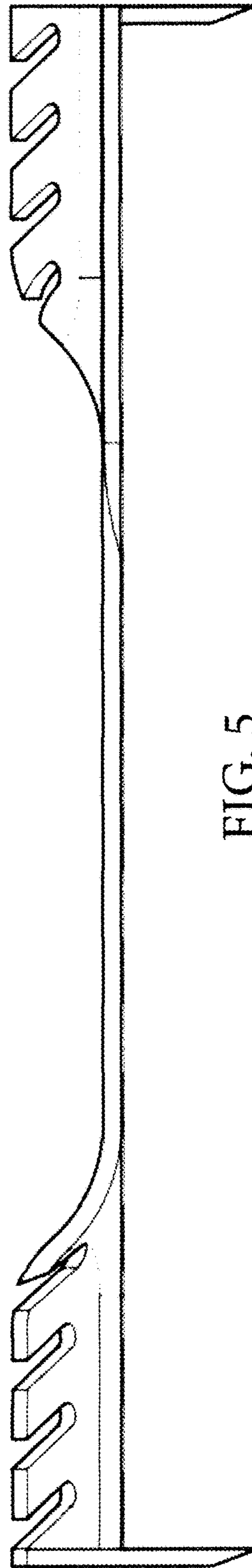

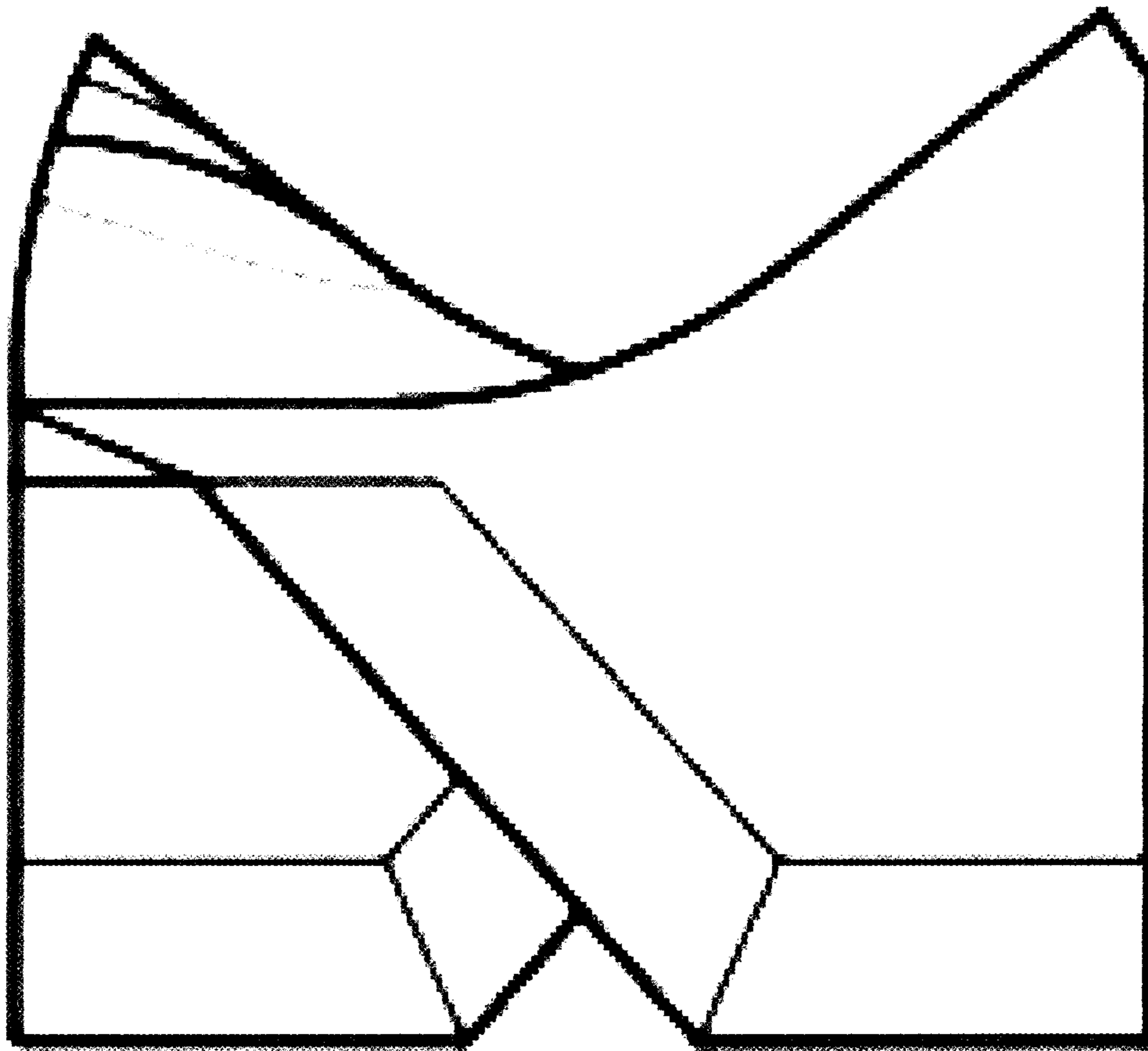

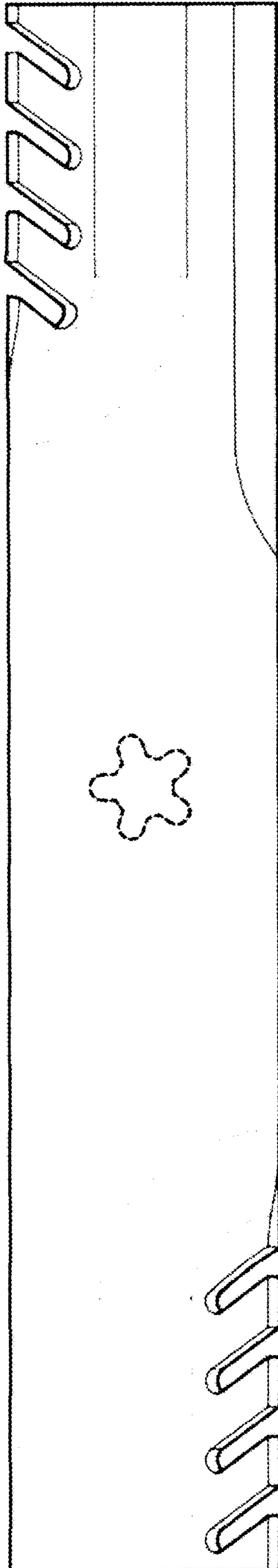

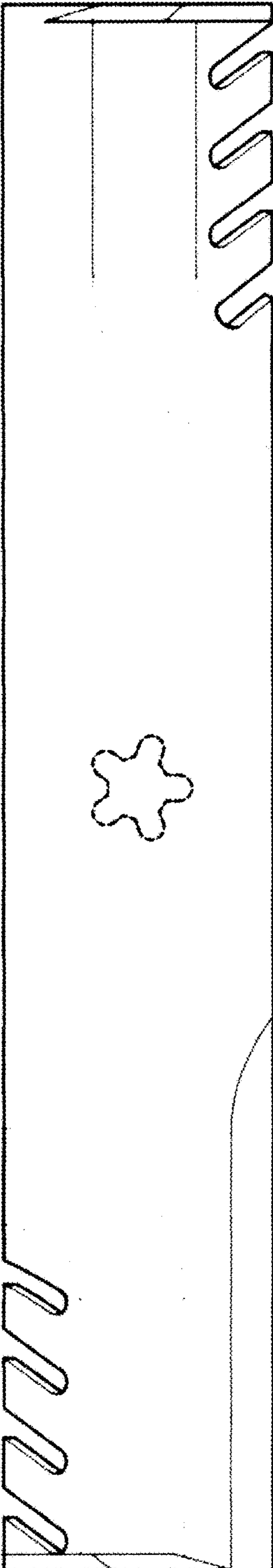
