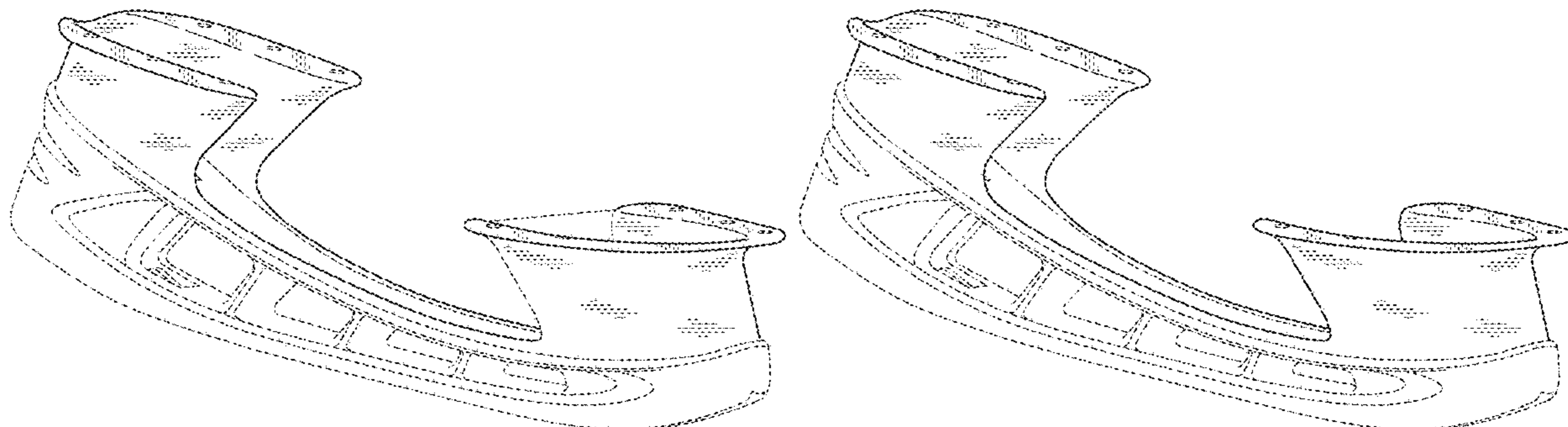


FIG. 21 is a top plan view of the ice skate blade holder of FIG. 17;

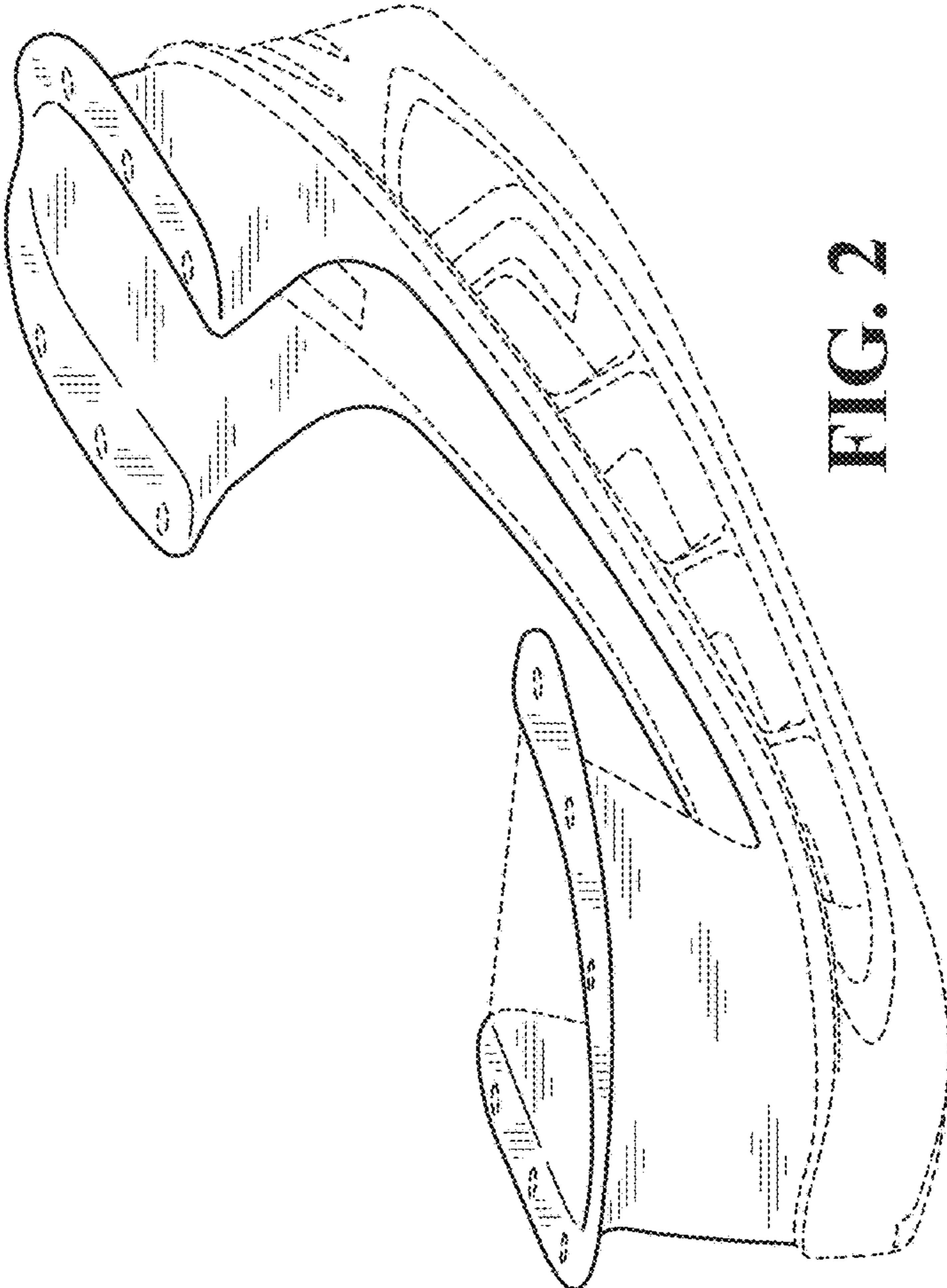

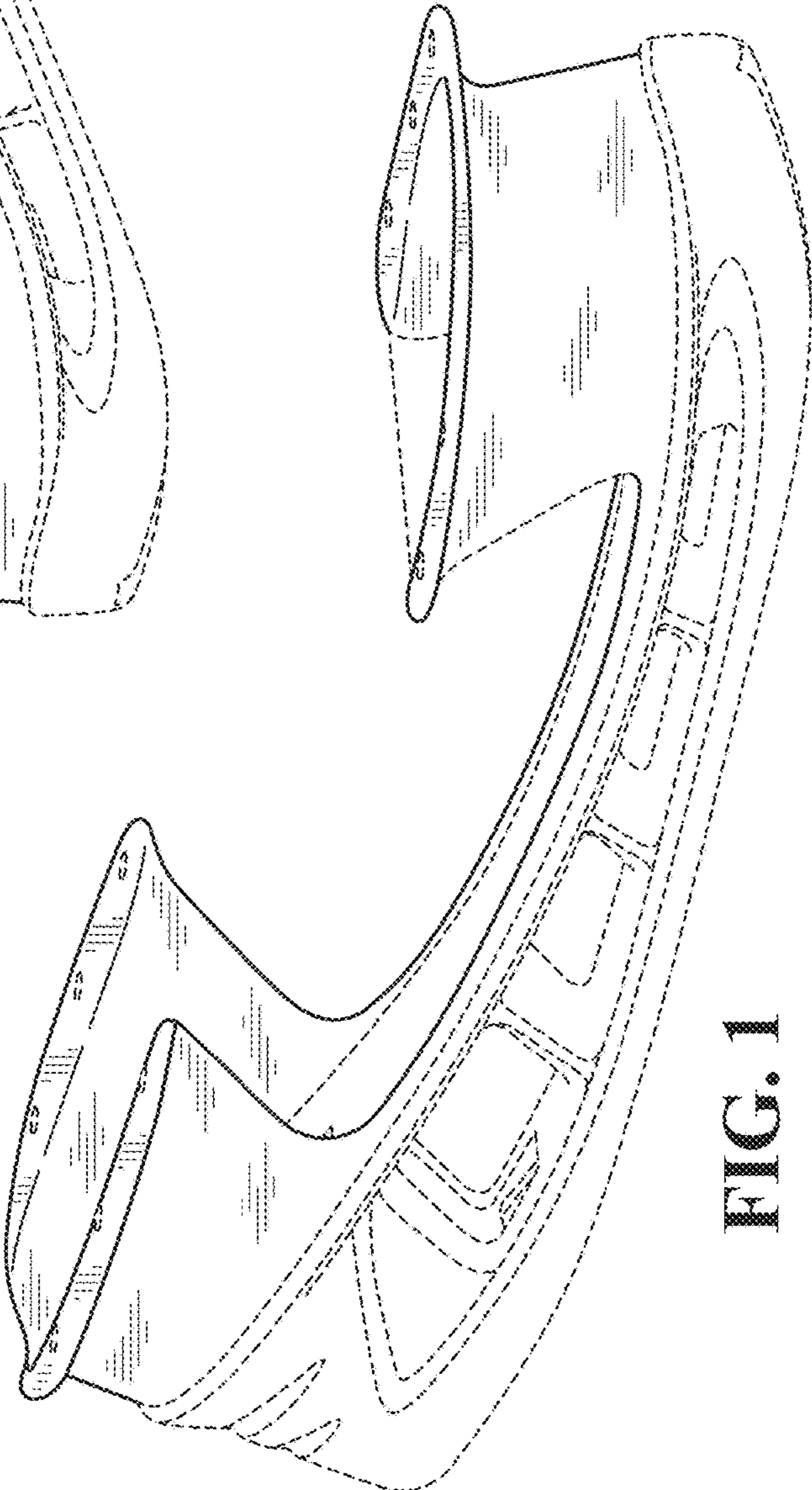

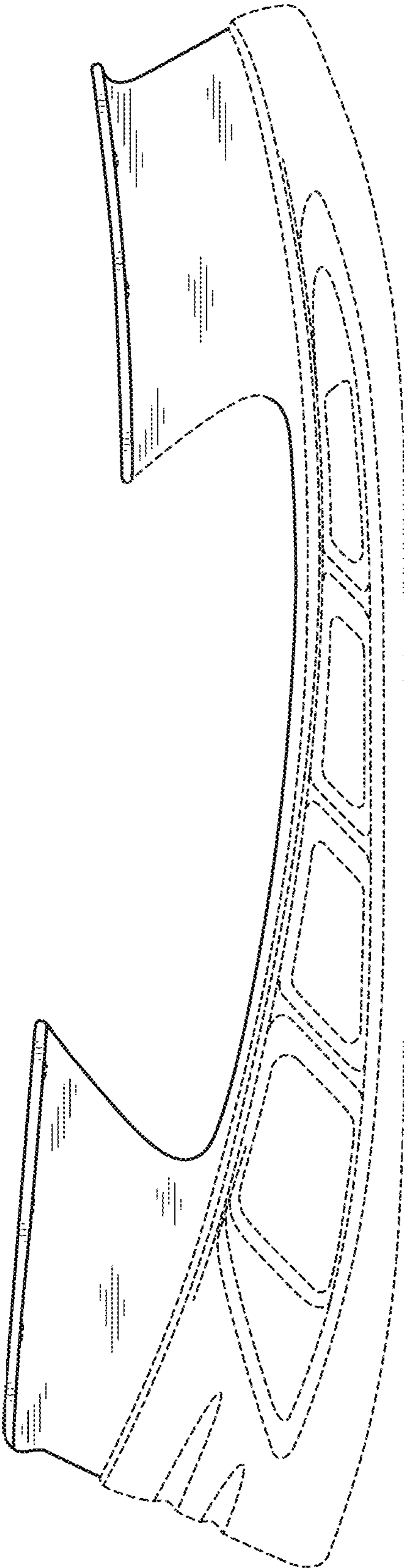

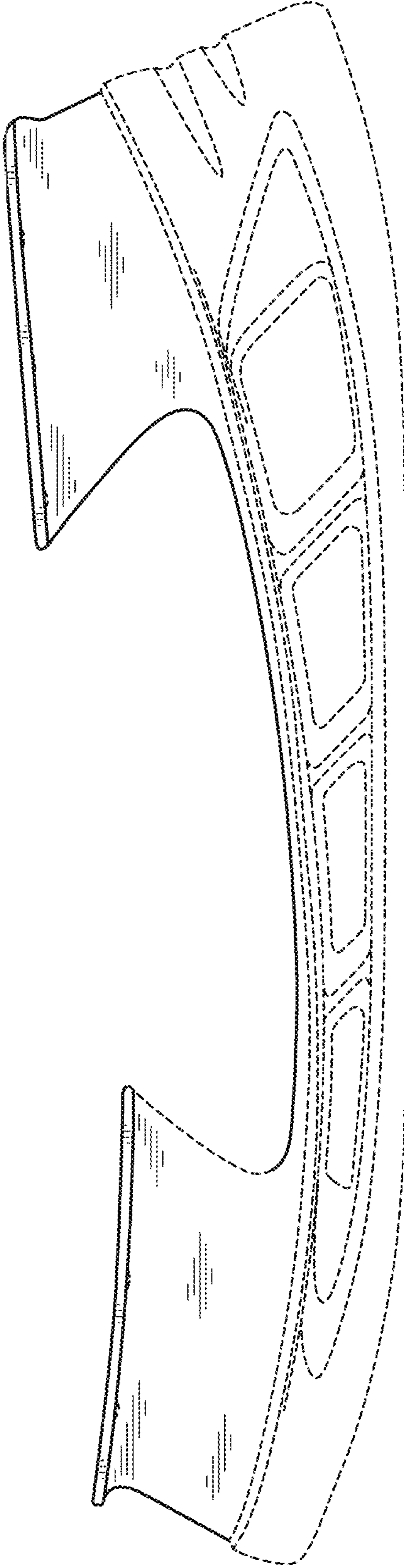
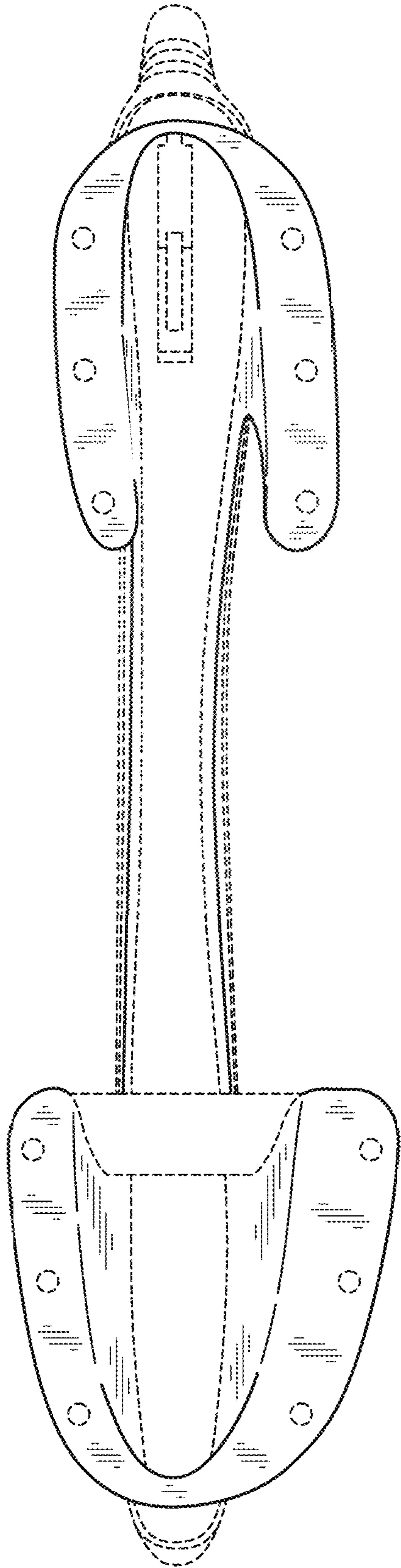
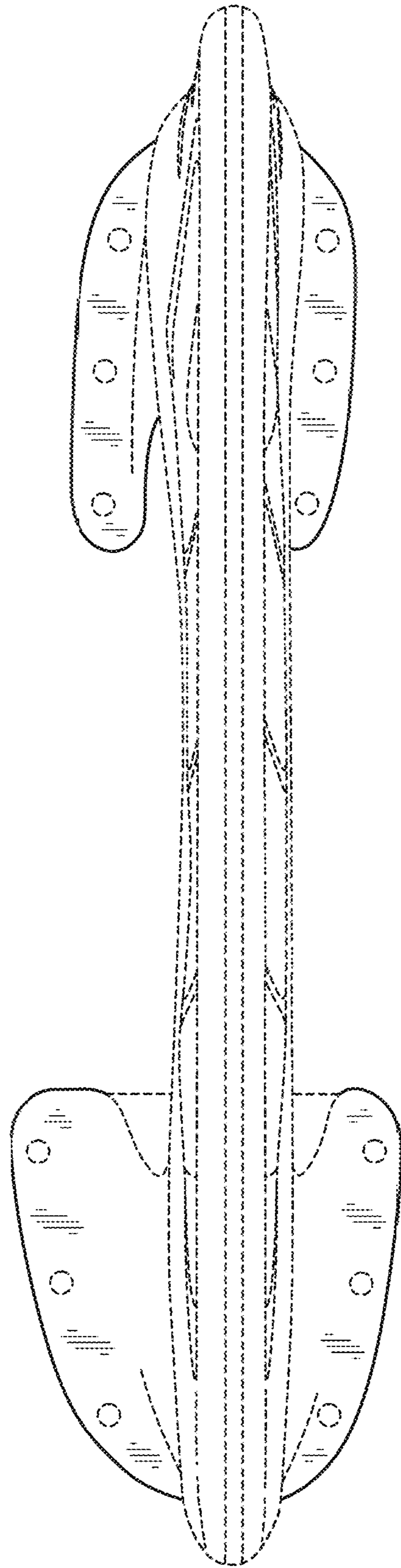

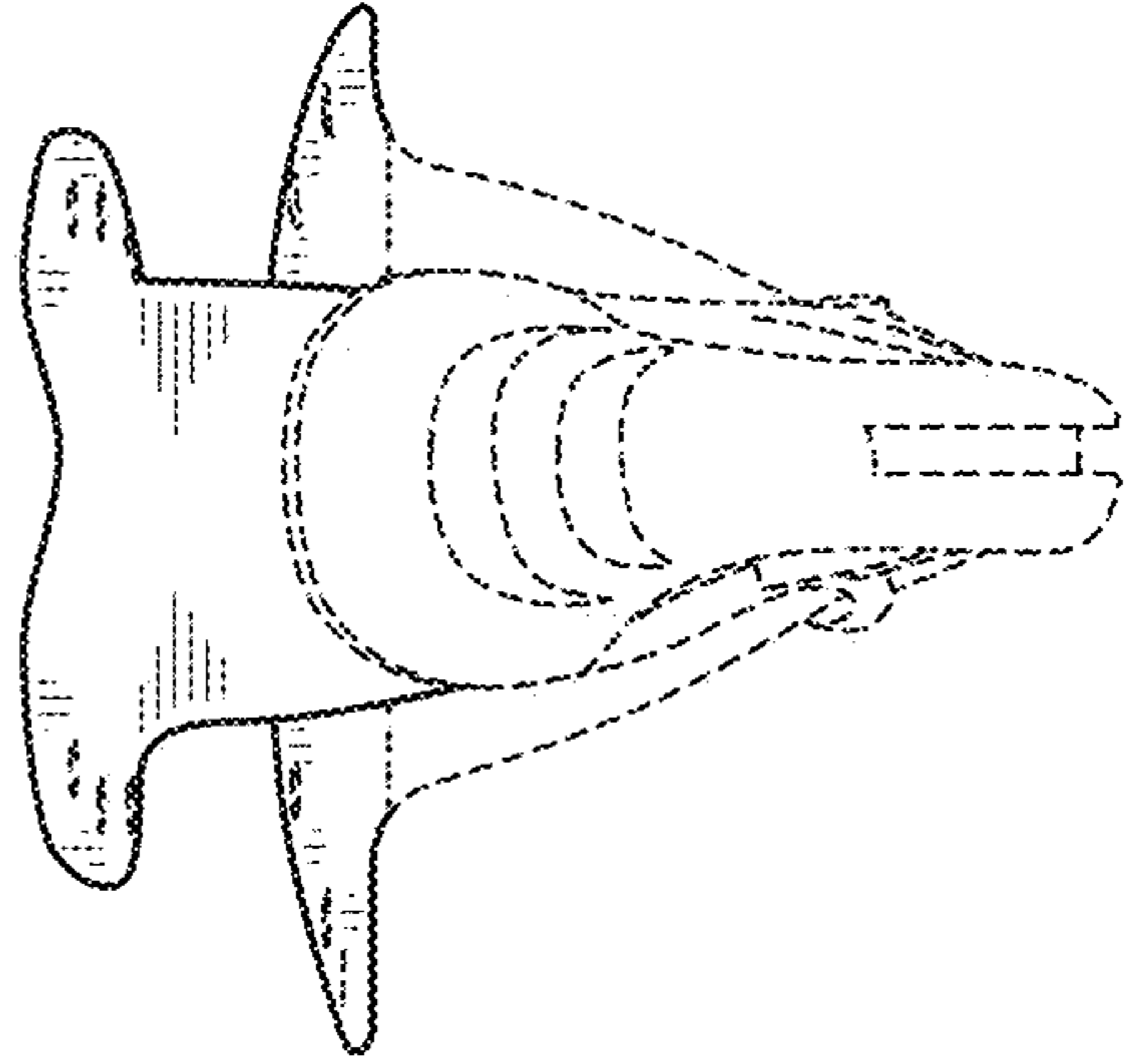

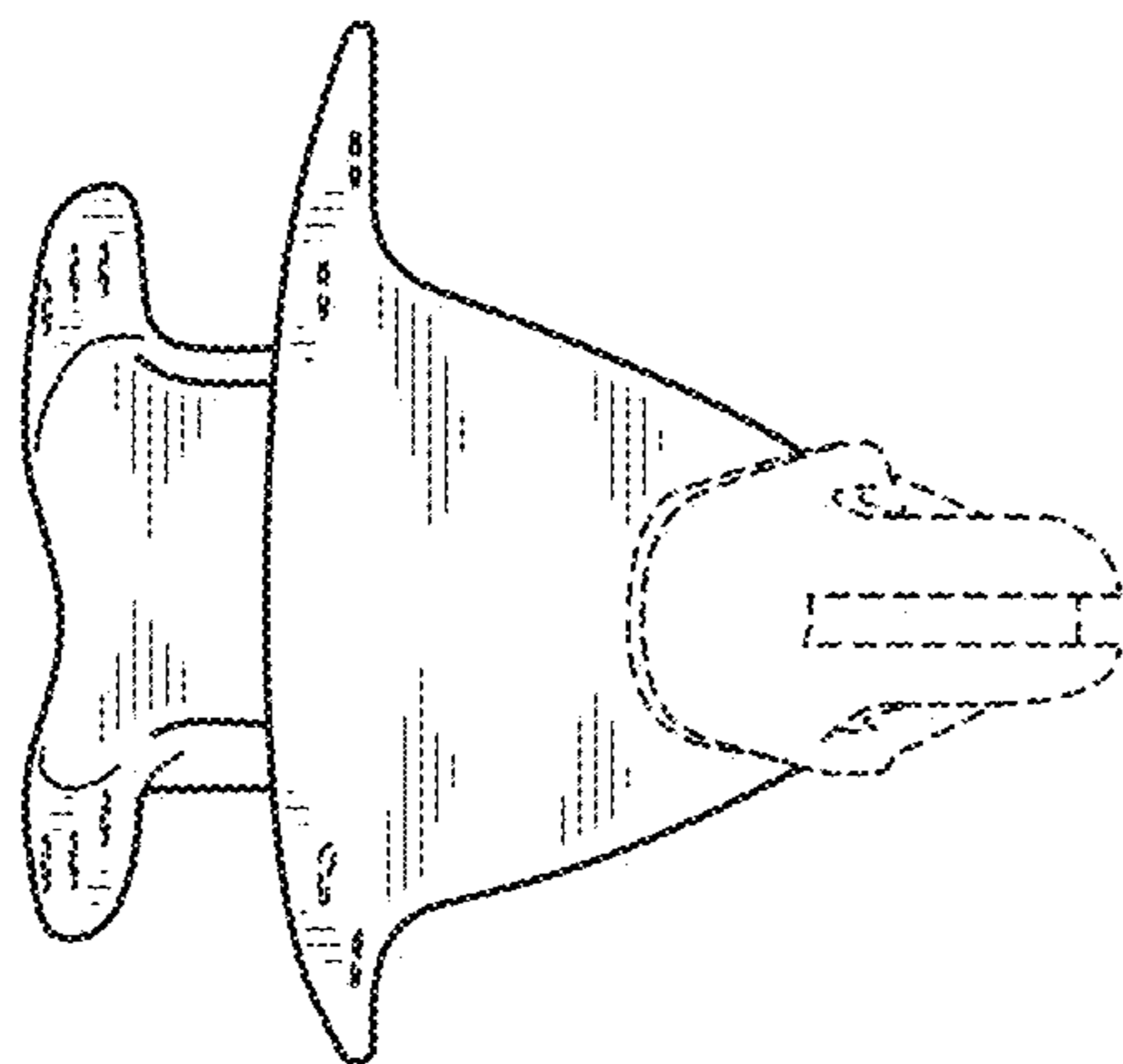

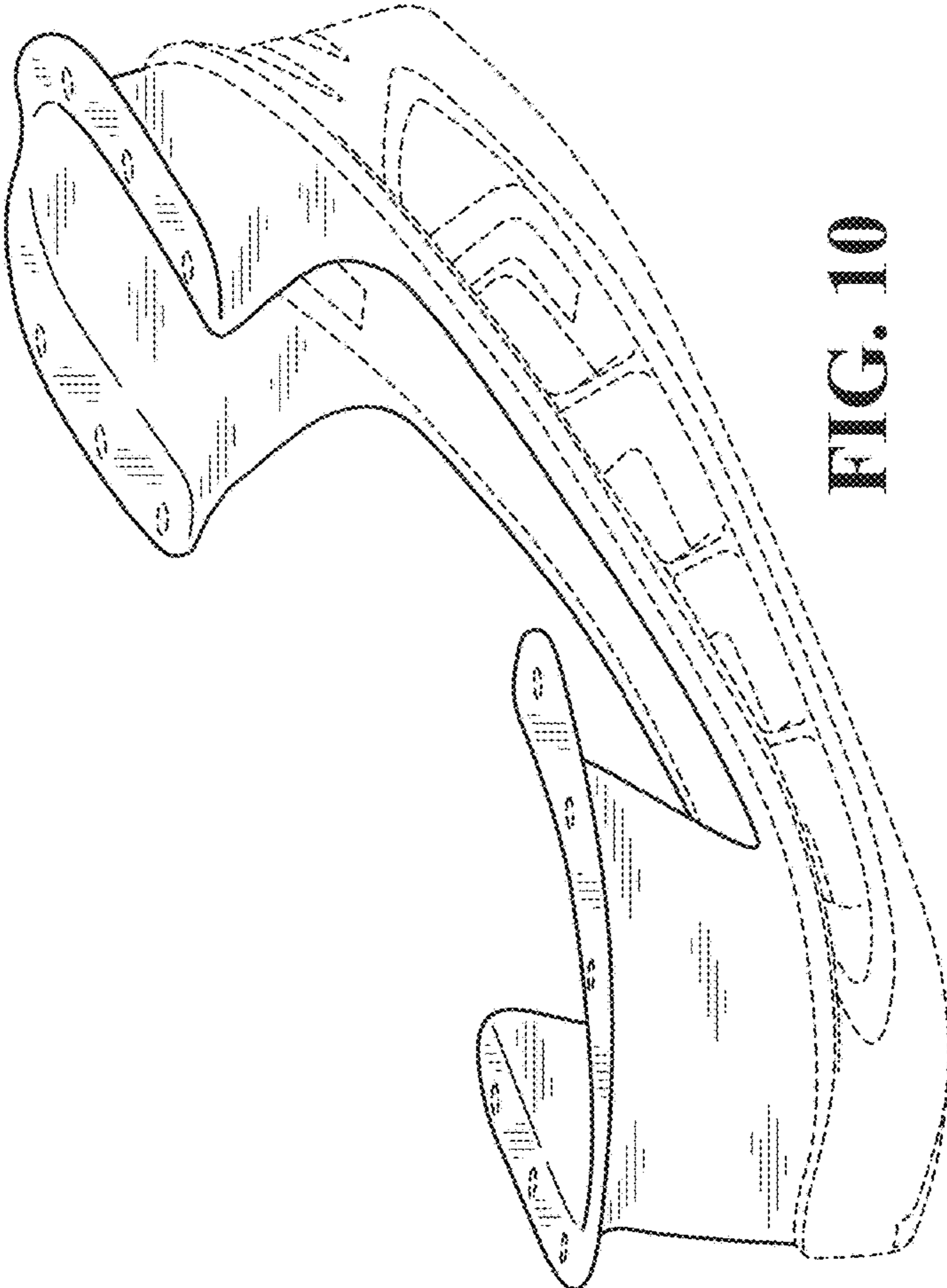

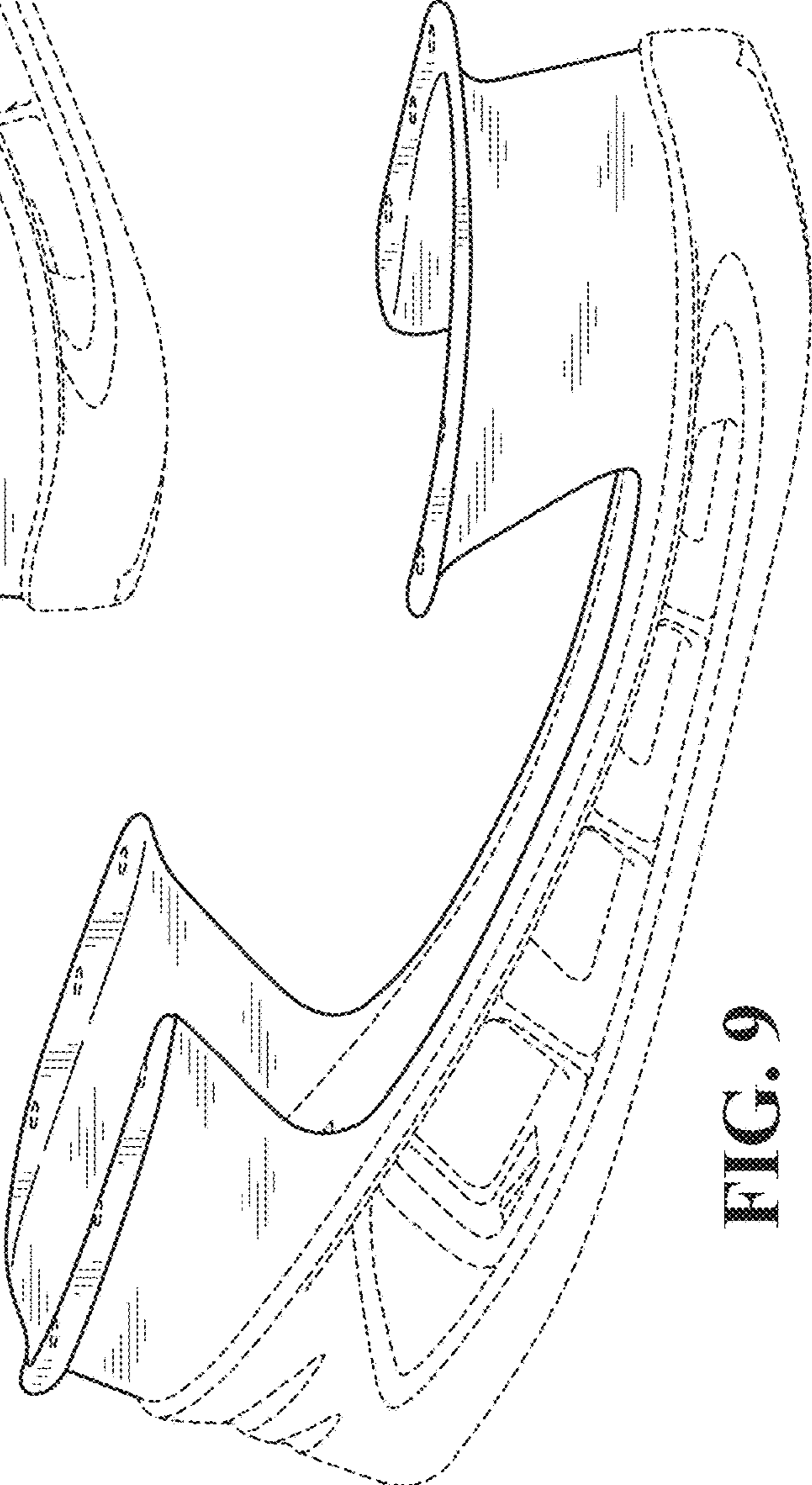

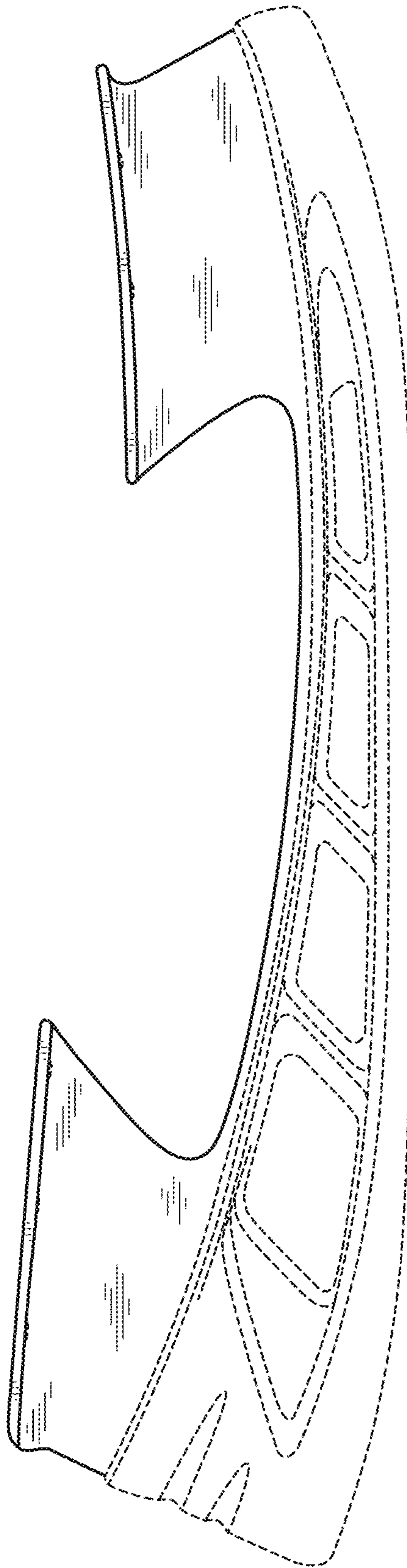

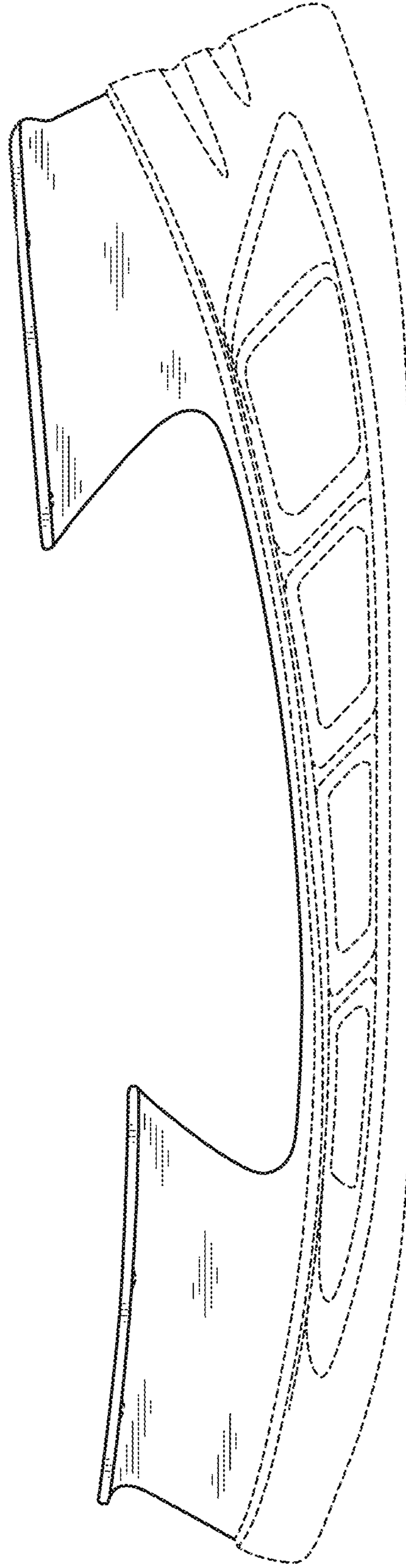

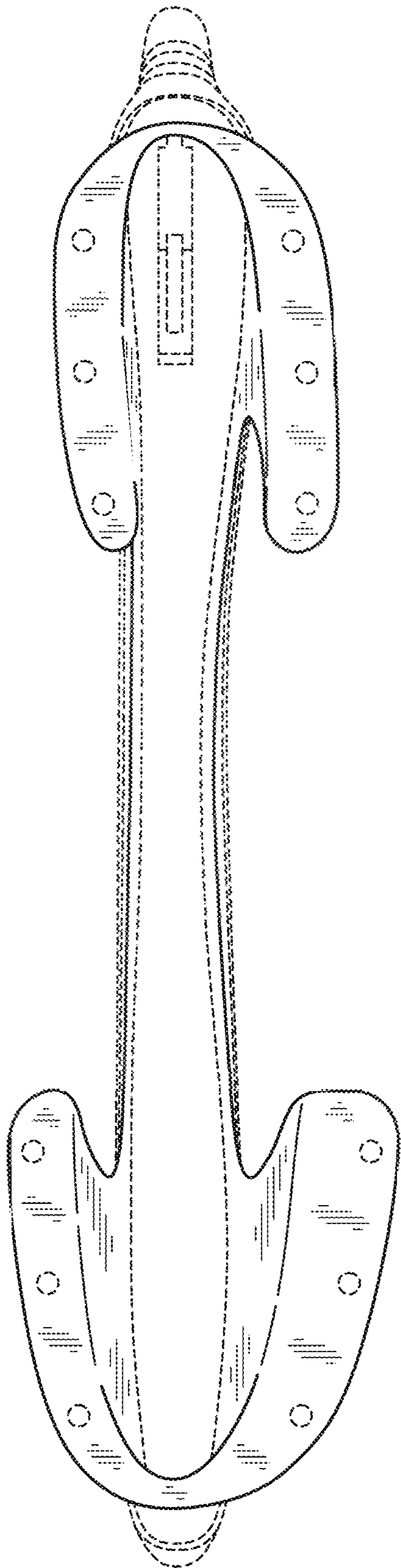

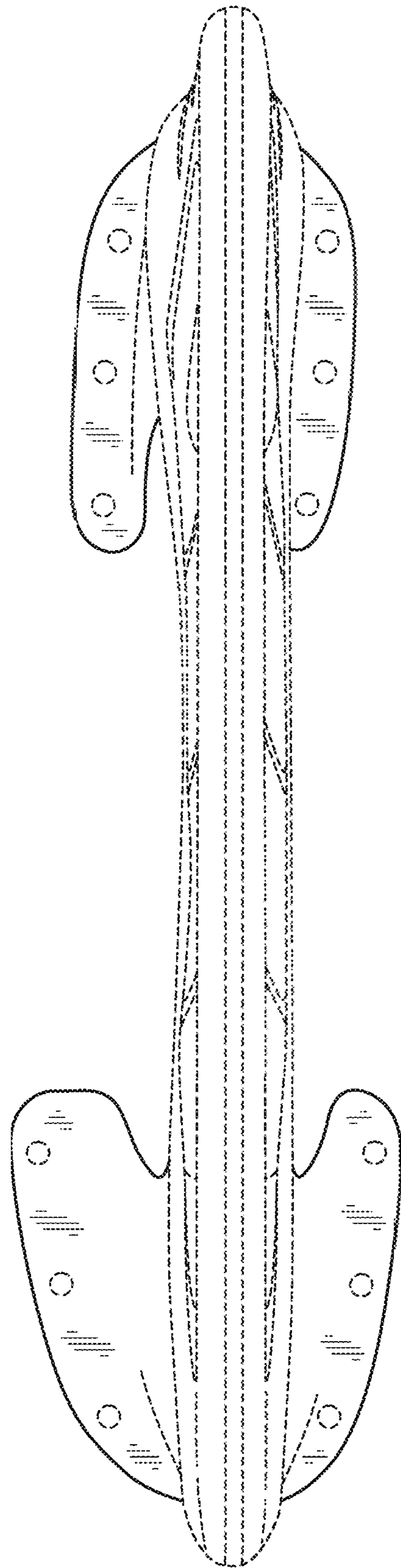

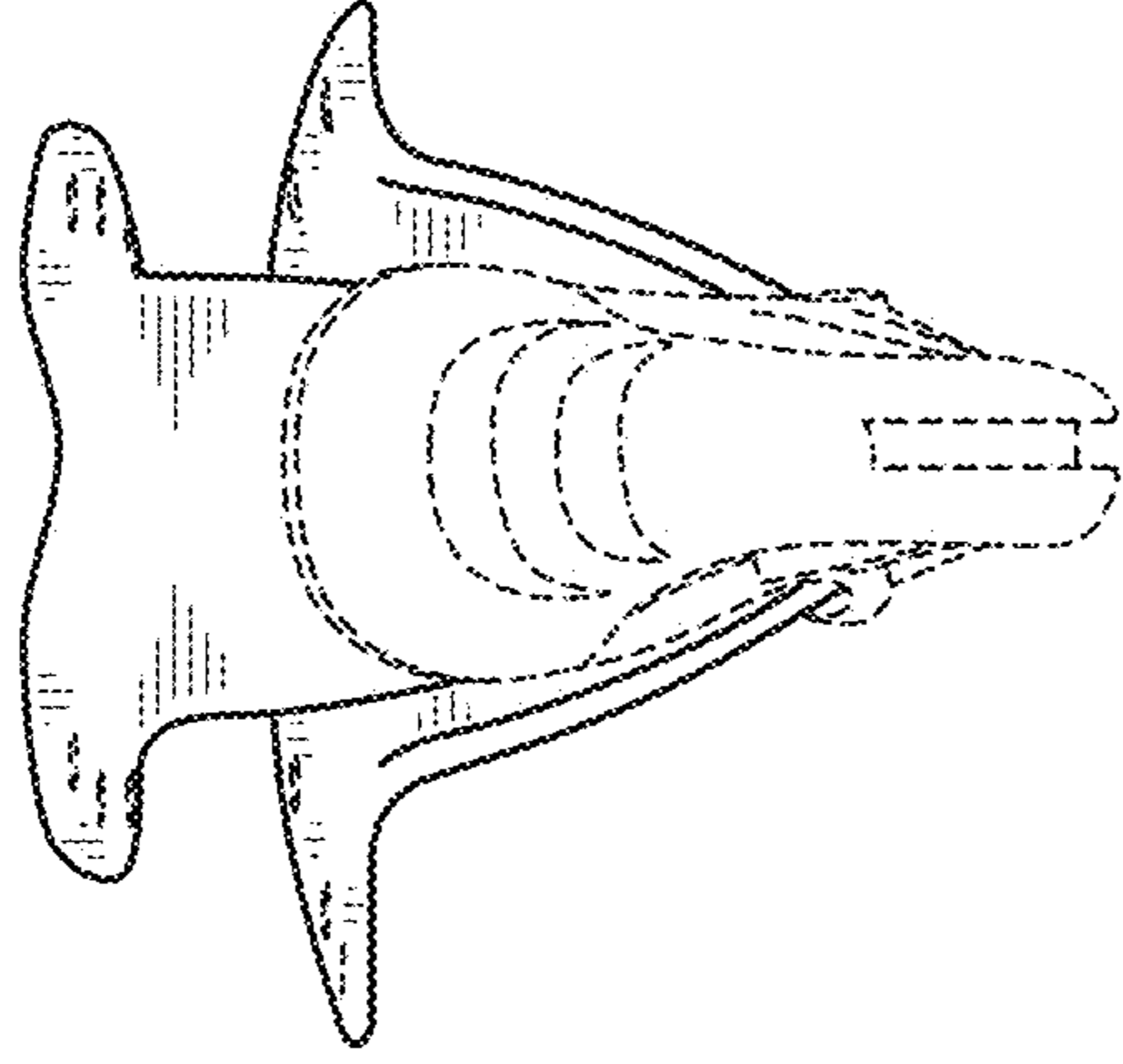

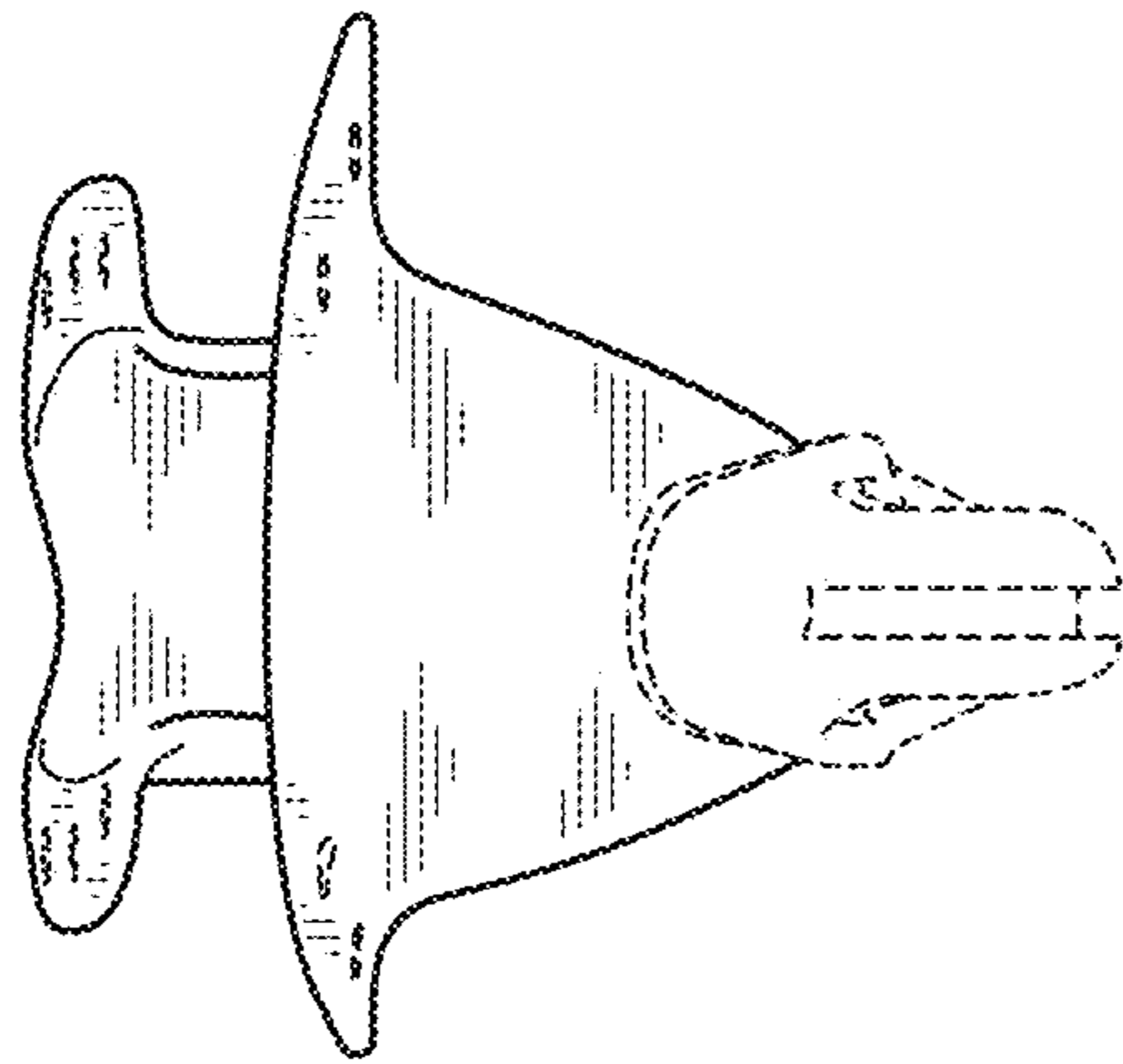

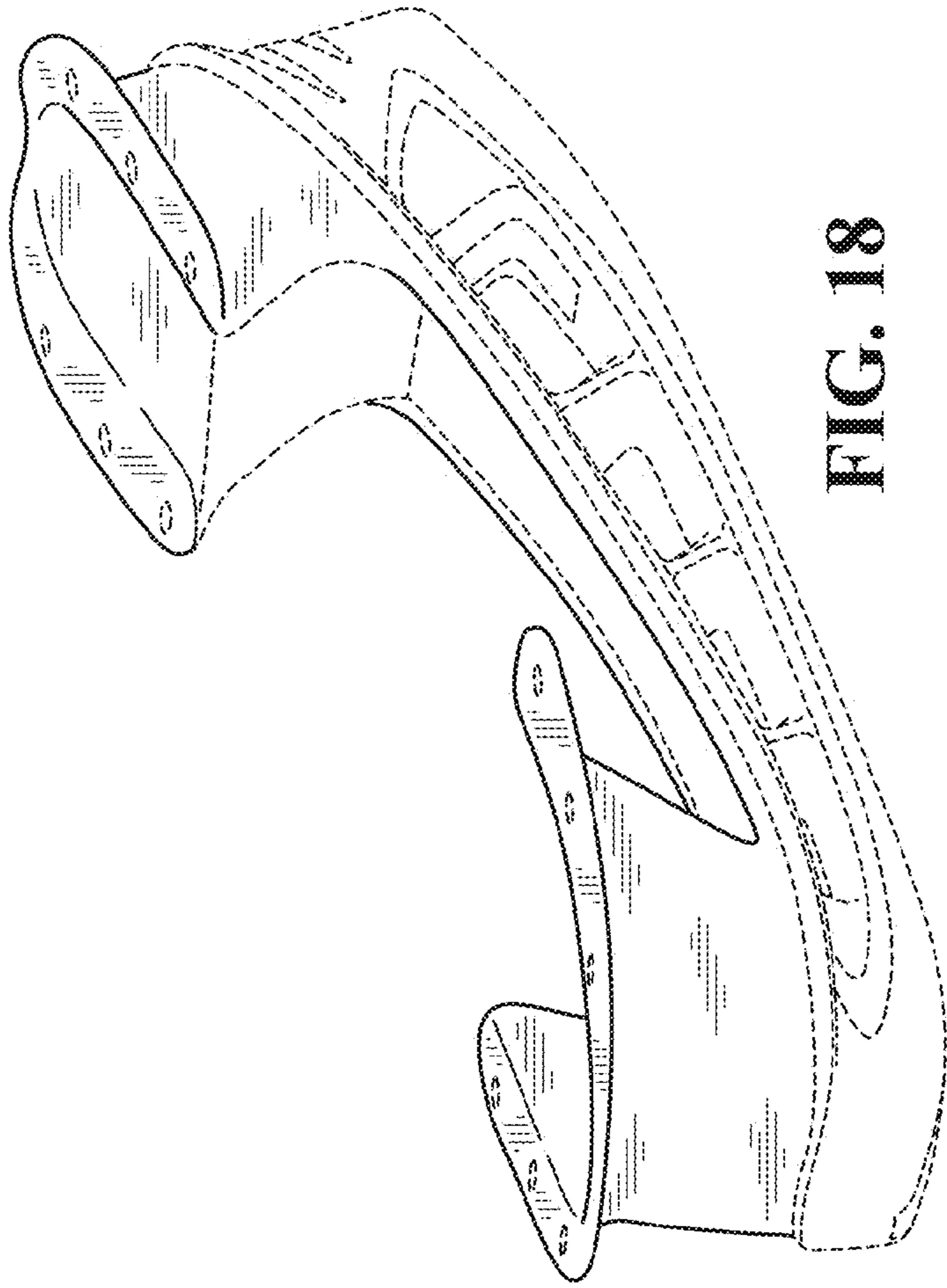

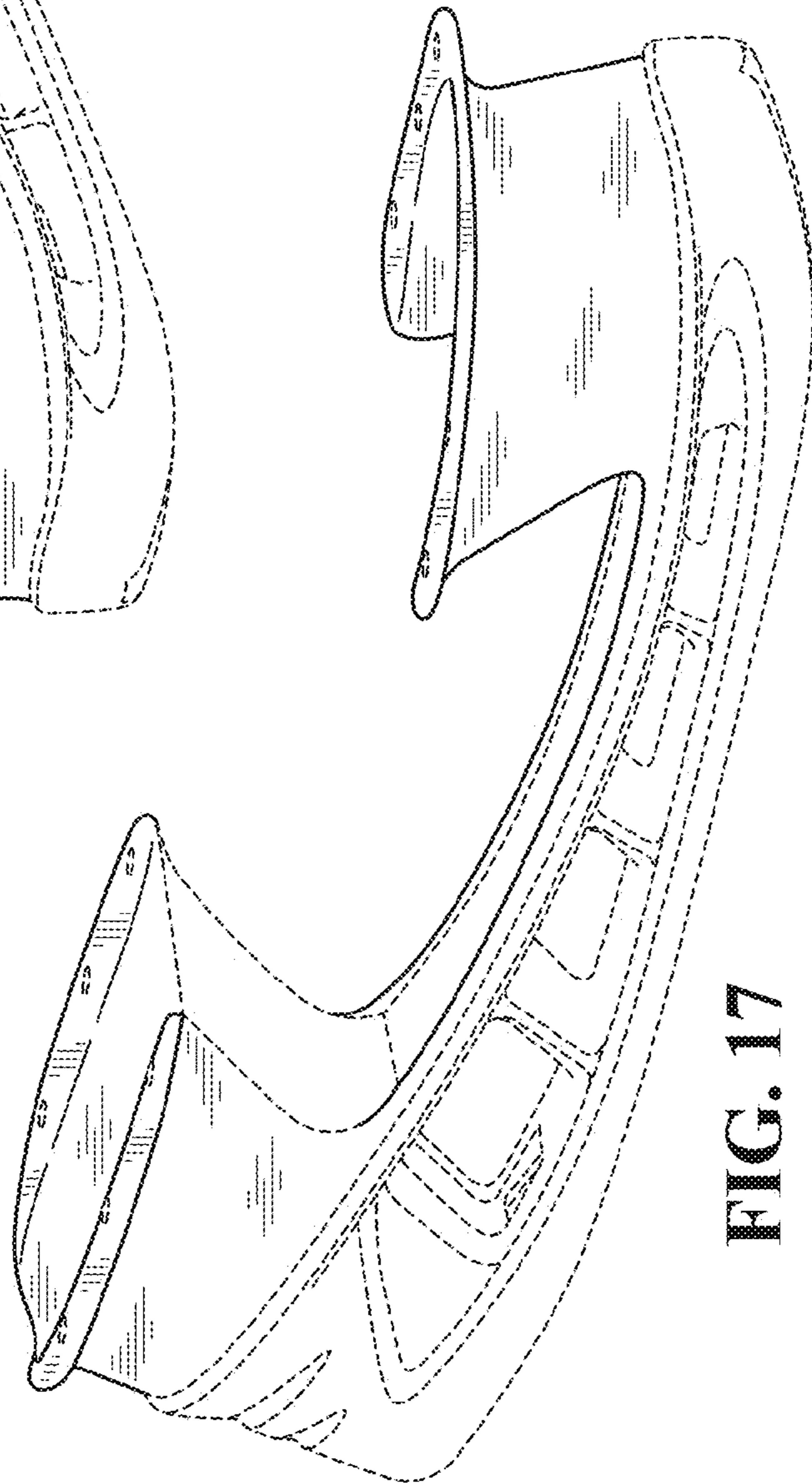

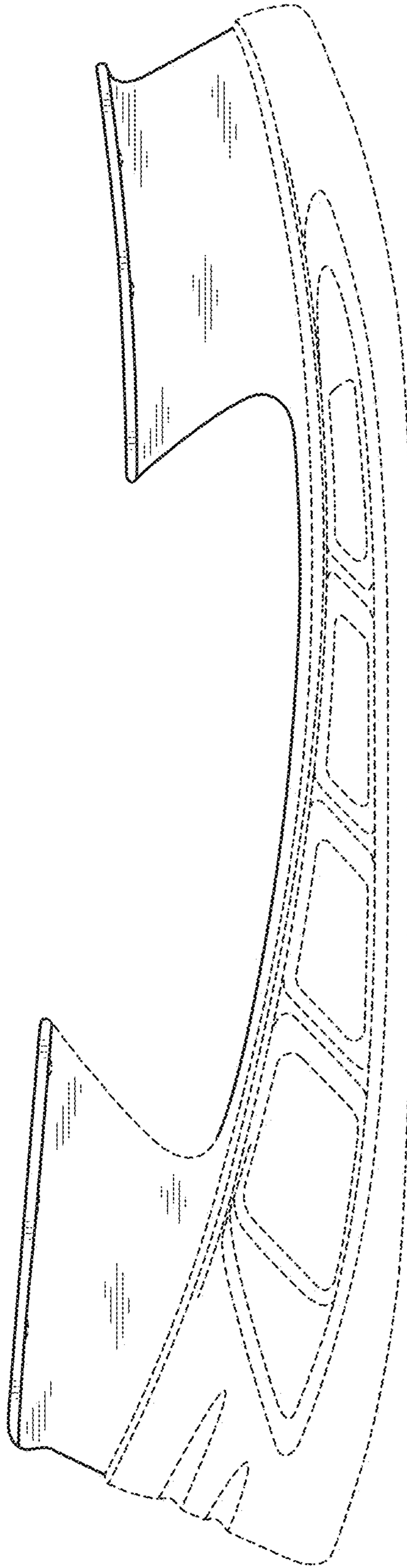

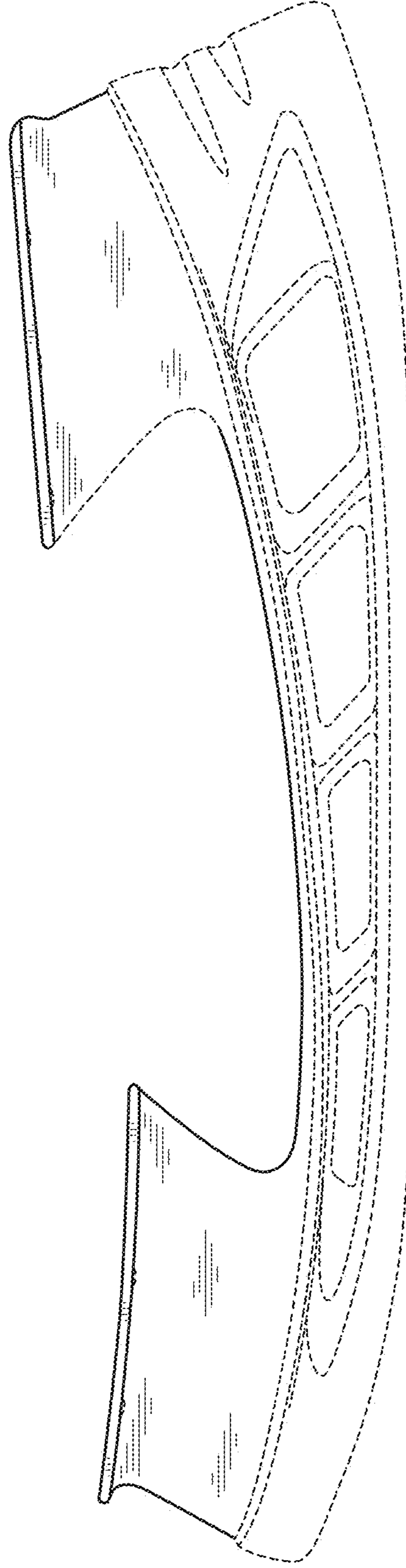

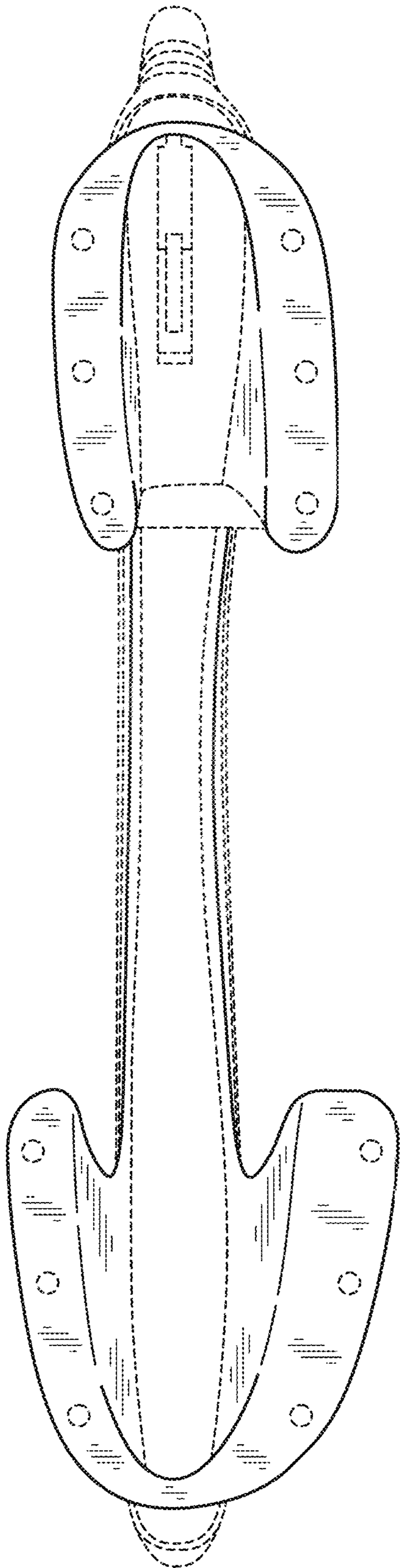

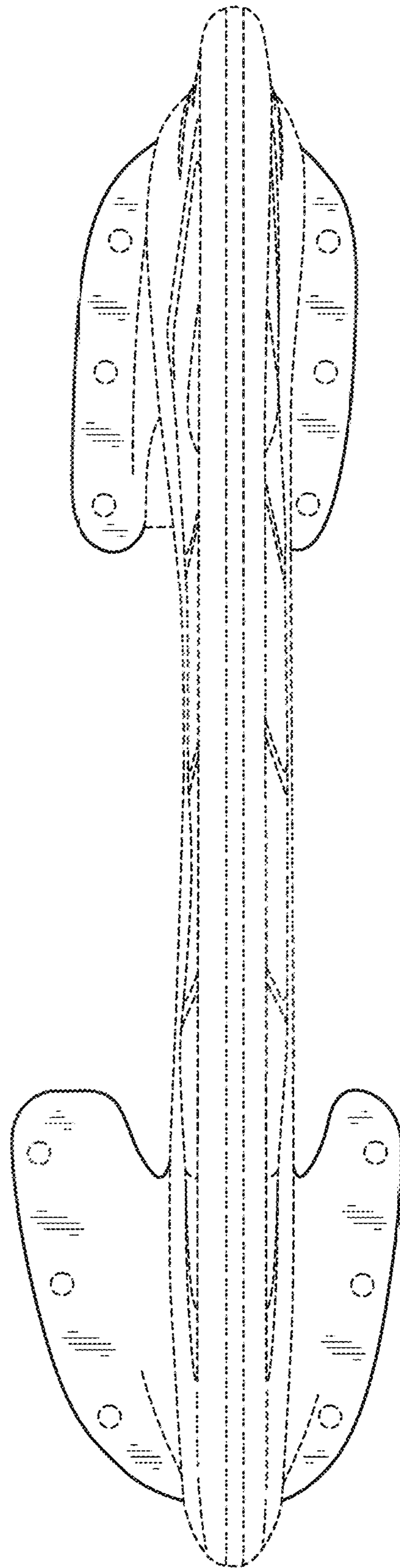

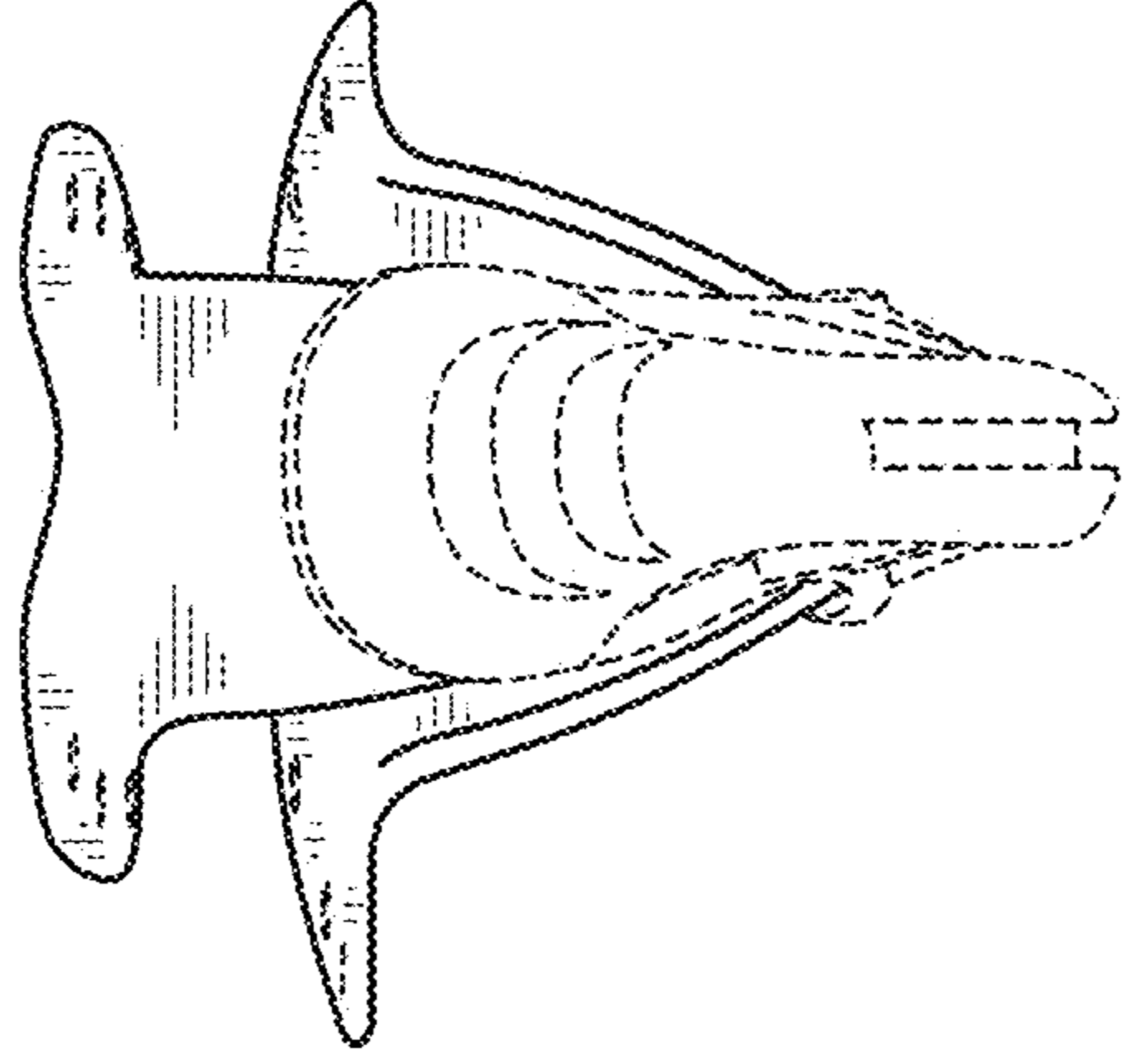

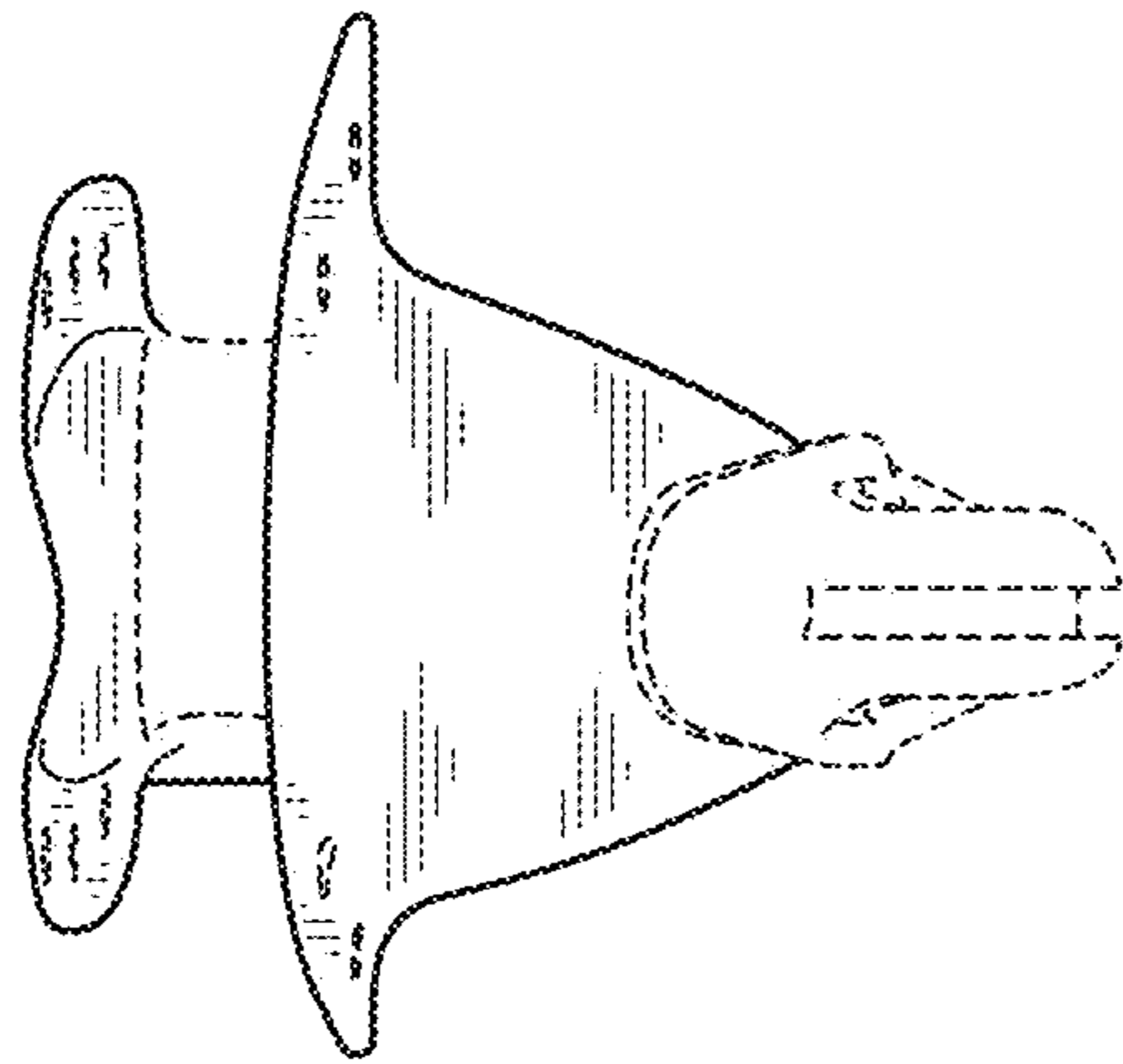
