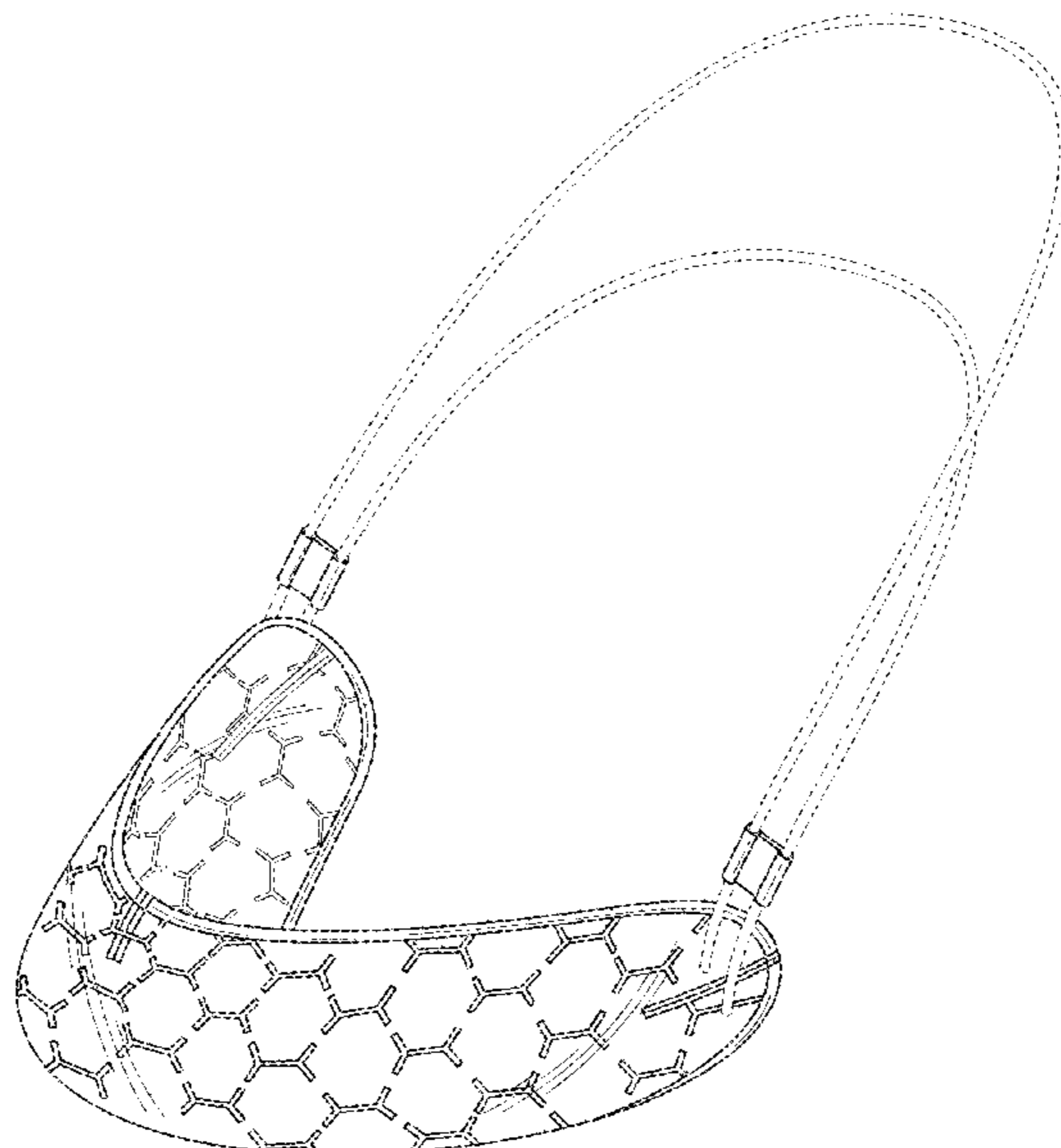
(57) **CLAIM**

The ornamental design for a hot and cold pack for medical purposes, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hot and cold pack for medical purposes in accordance with the invention with attachment straps shown in broken lines;  
 FIG. 2 is a back view of FIG. 1 with attachment straps shown in broken lines;  
 FIG. 3 is a front view of FIG. 1 with attachment straps shown in broken lines;  
 FIG. 4 is a right view of FIG. 1 with attachment straps shown in broken lines;

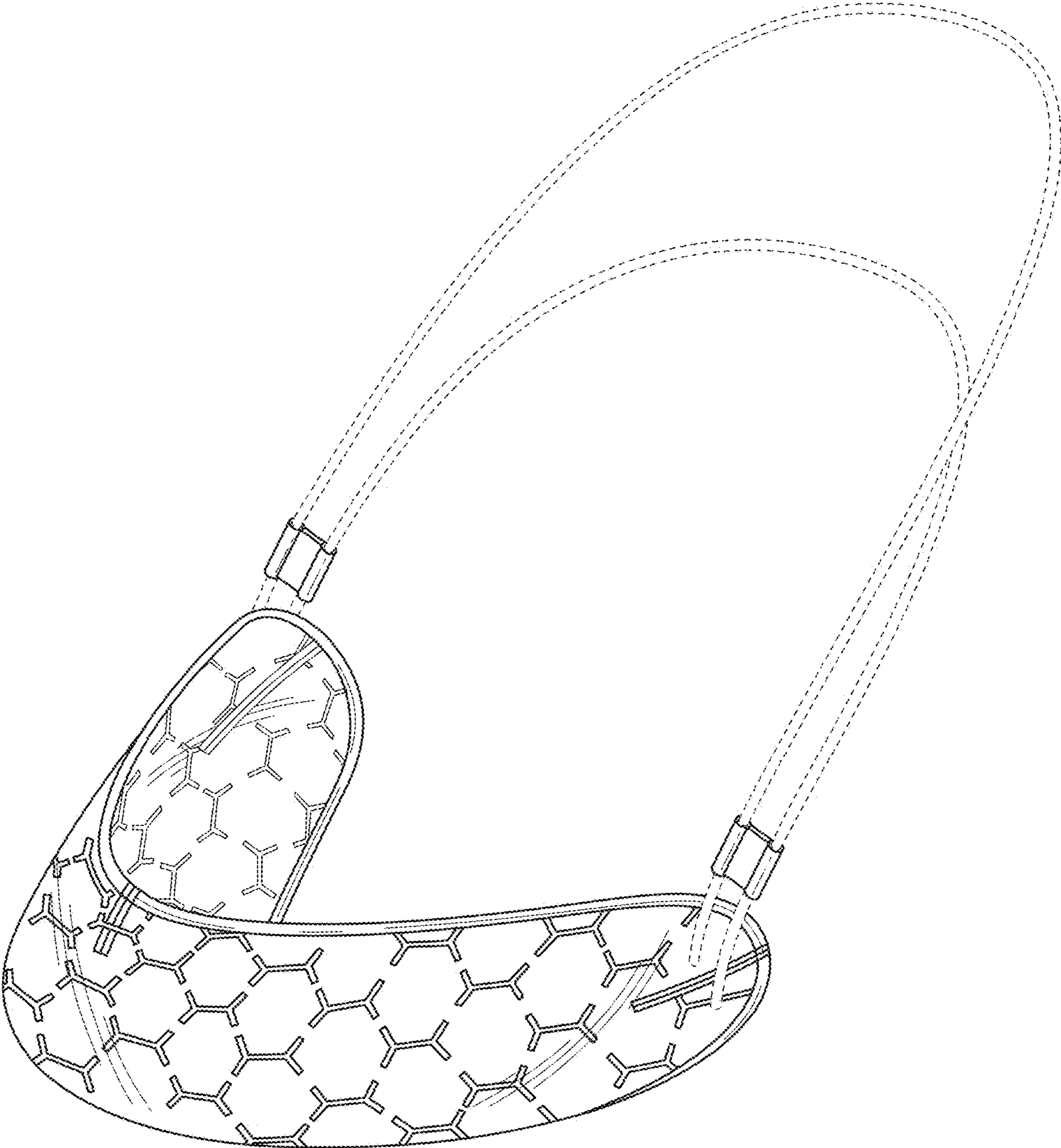

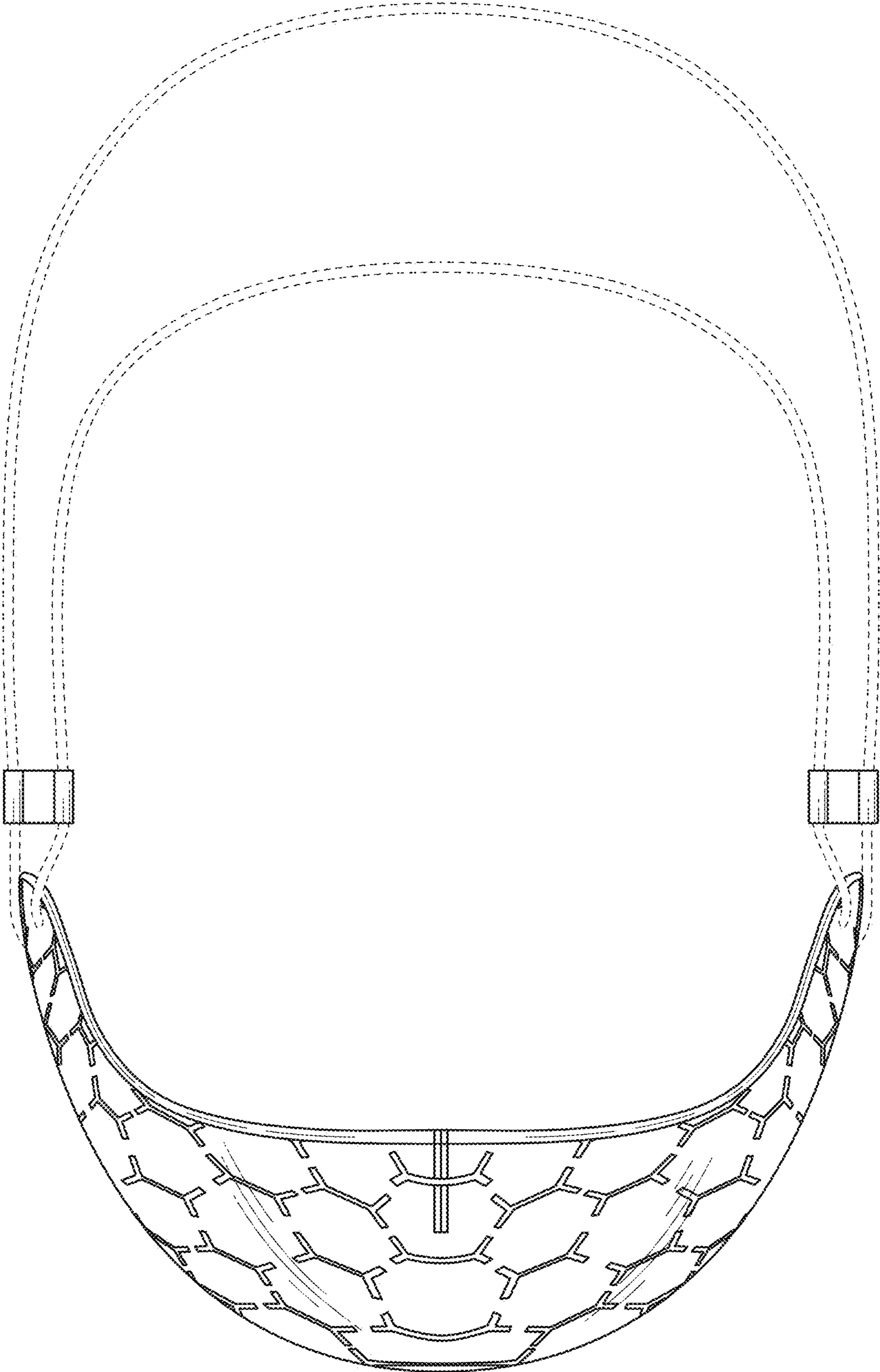

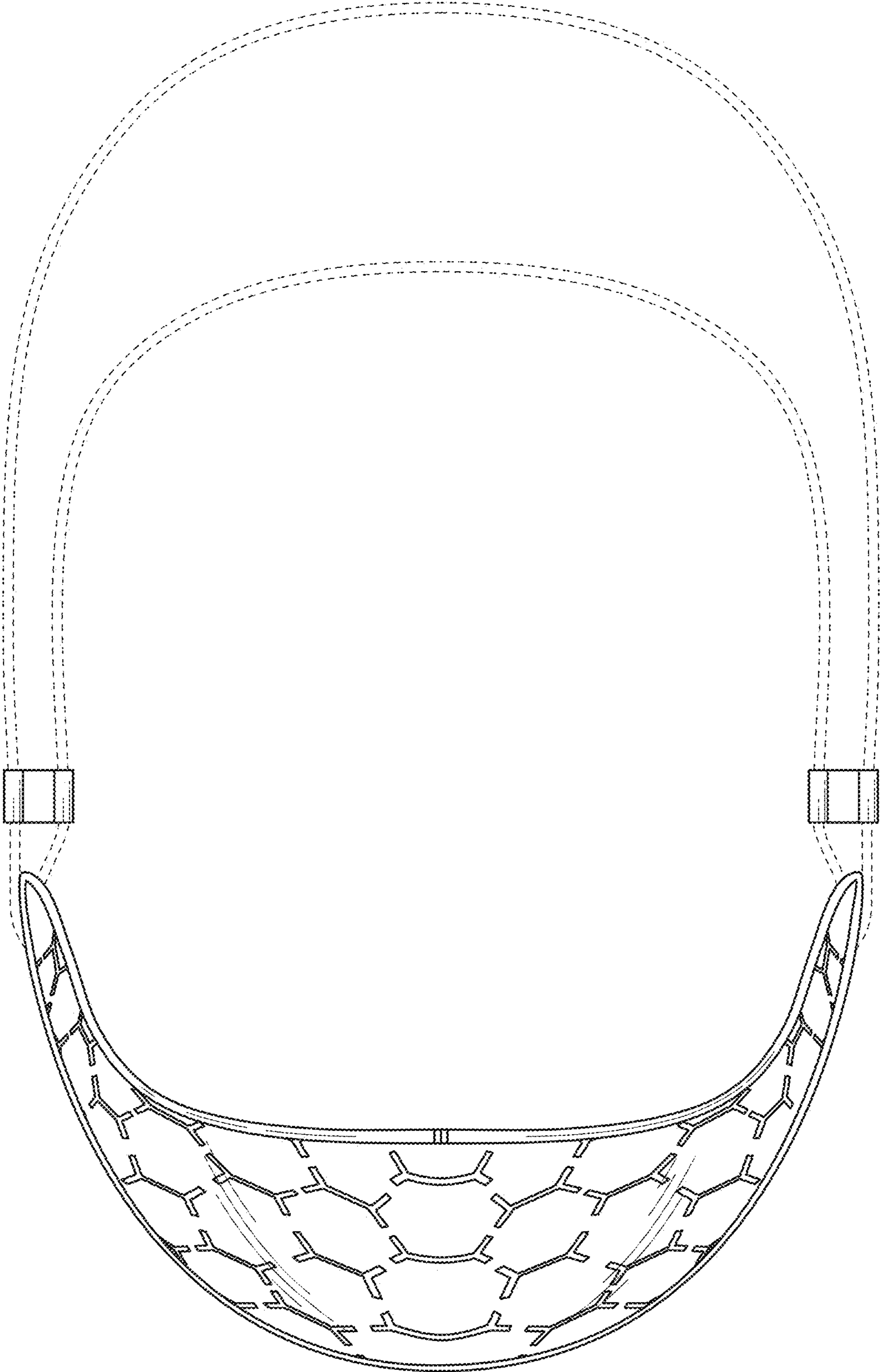

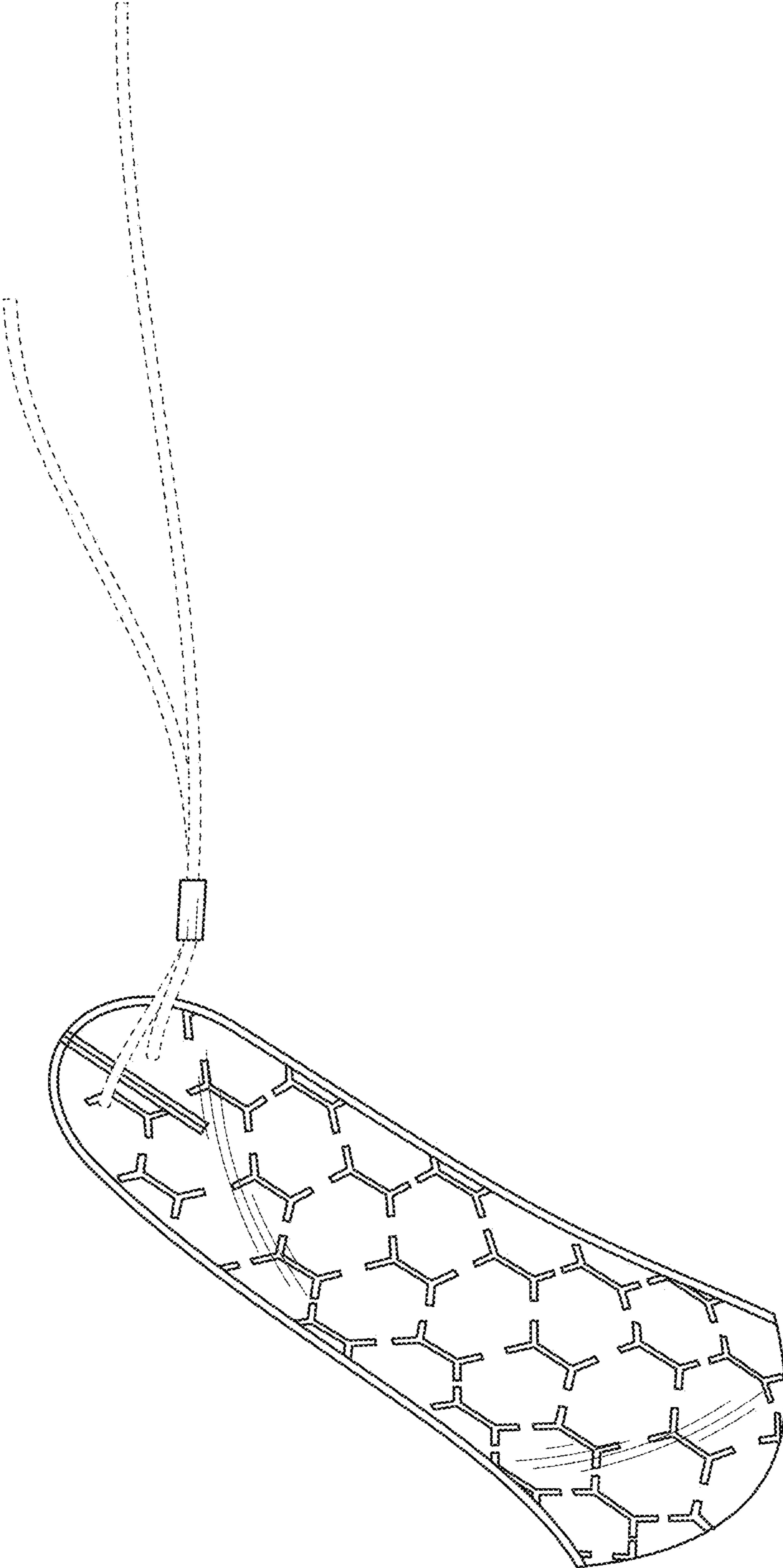

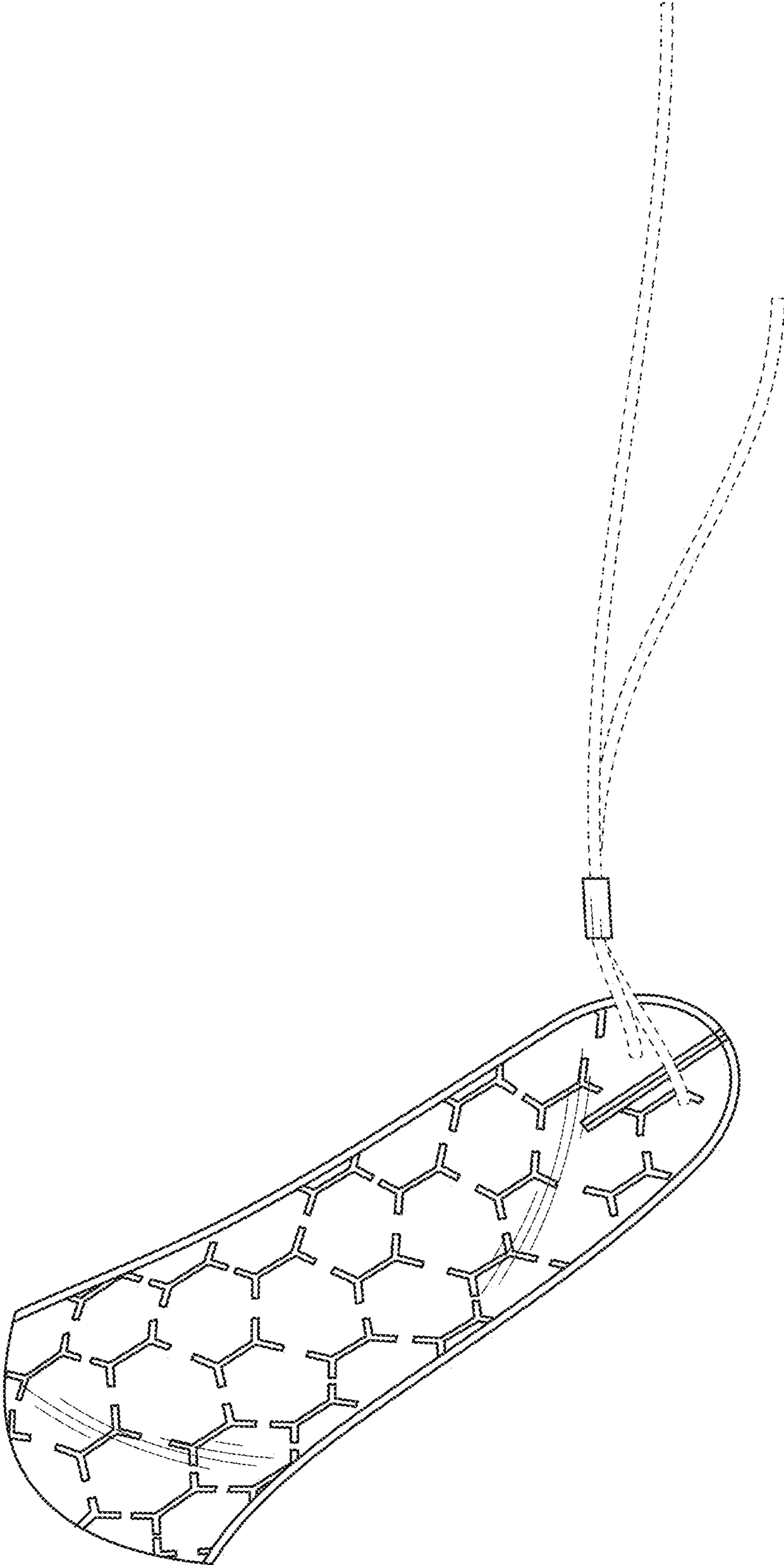

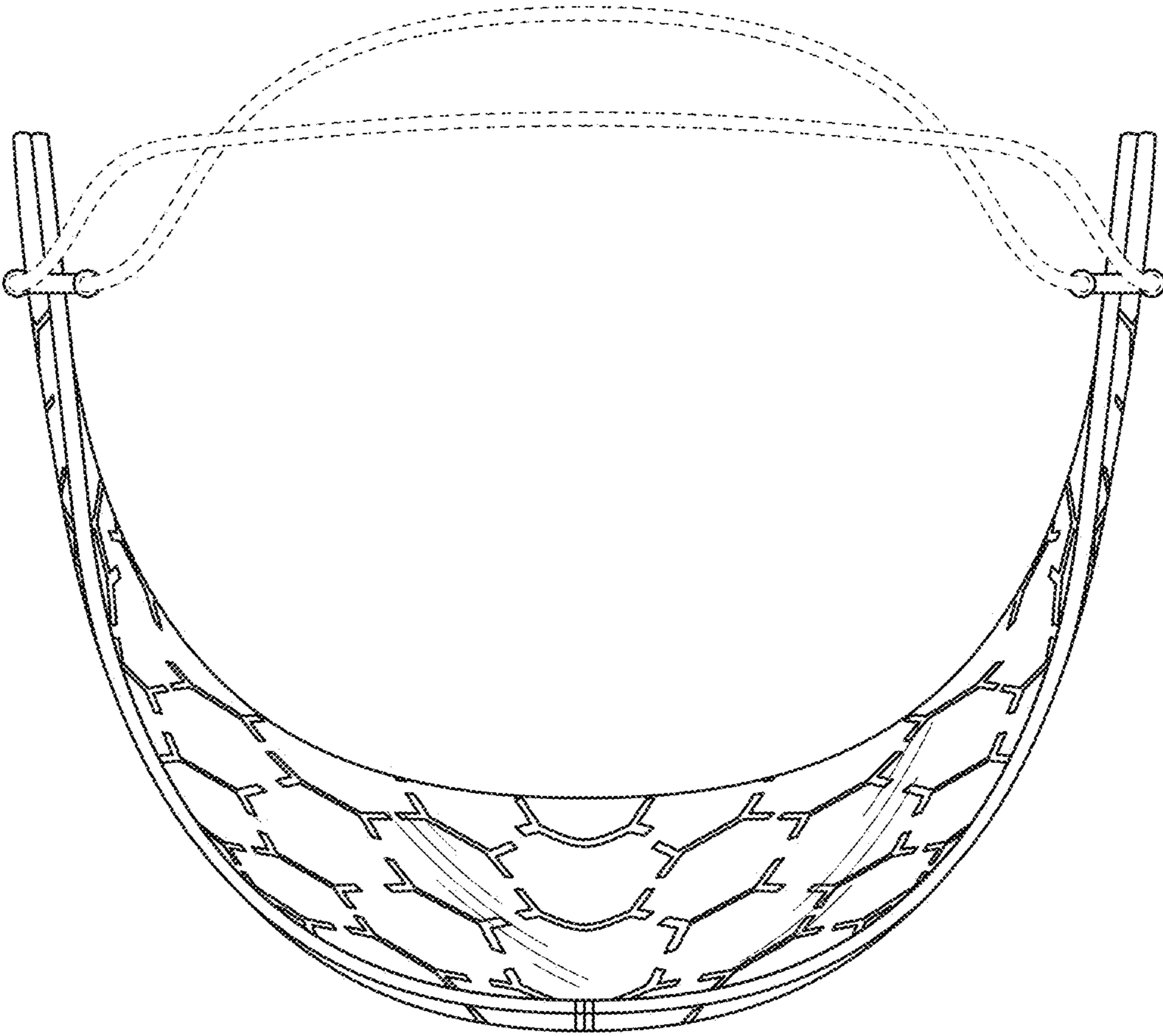

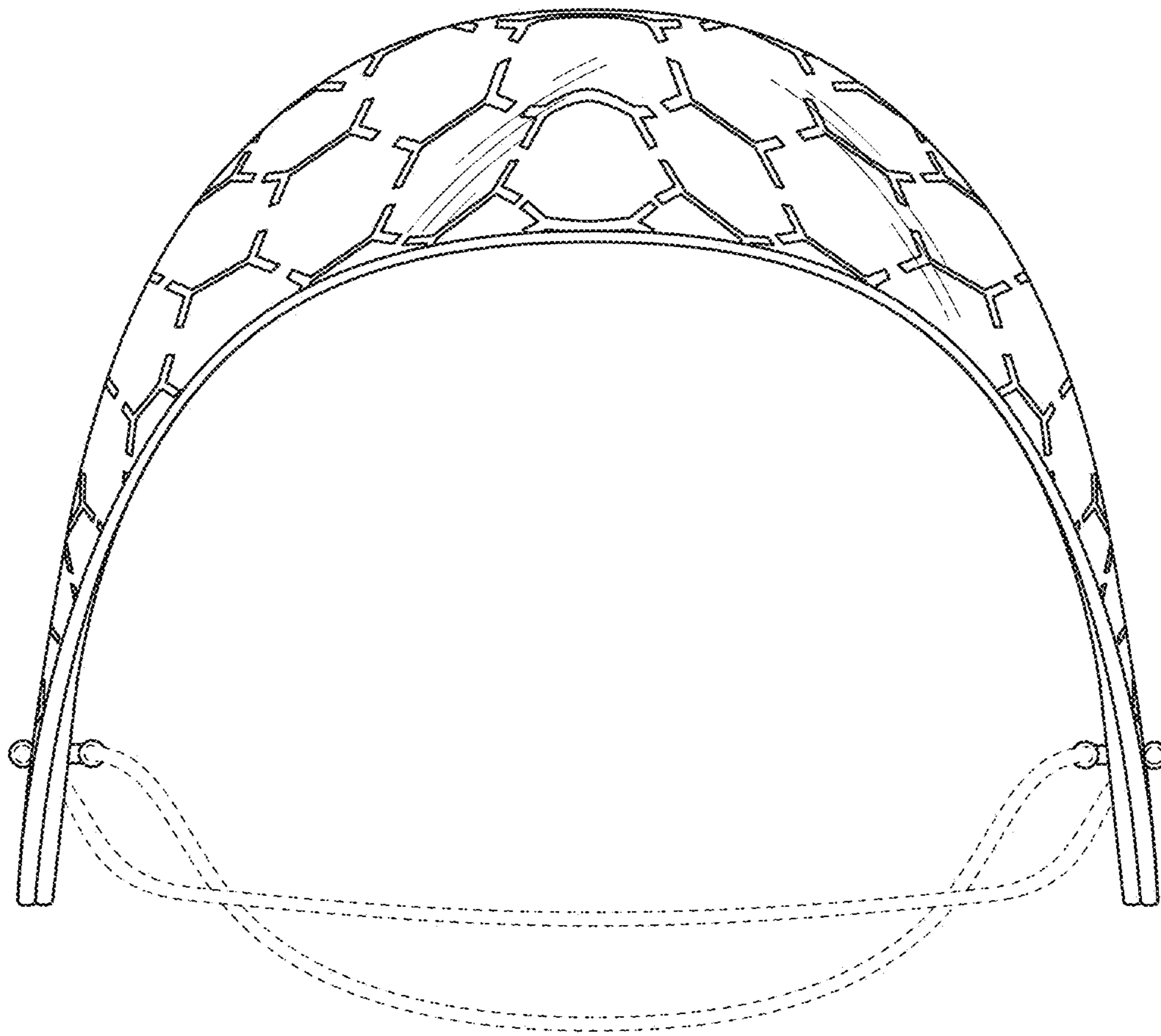
