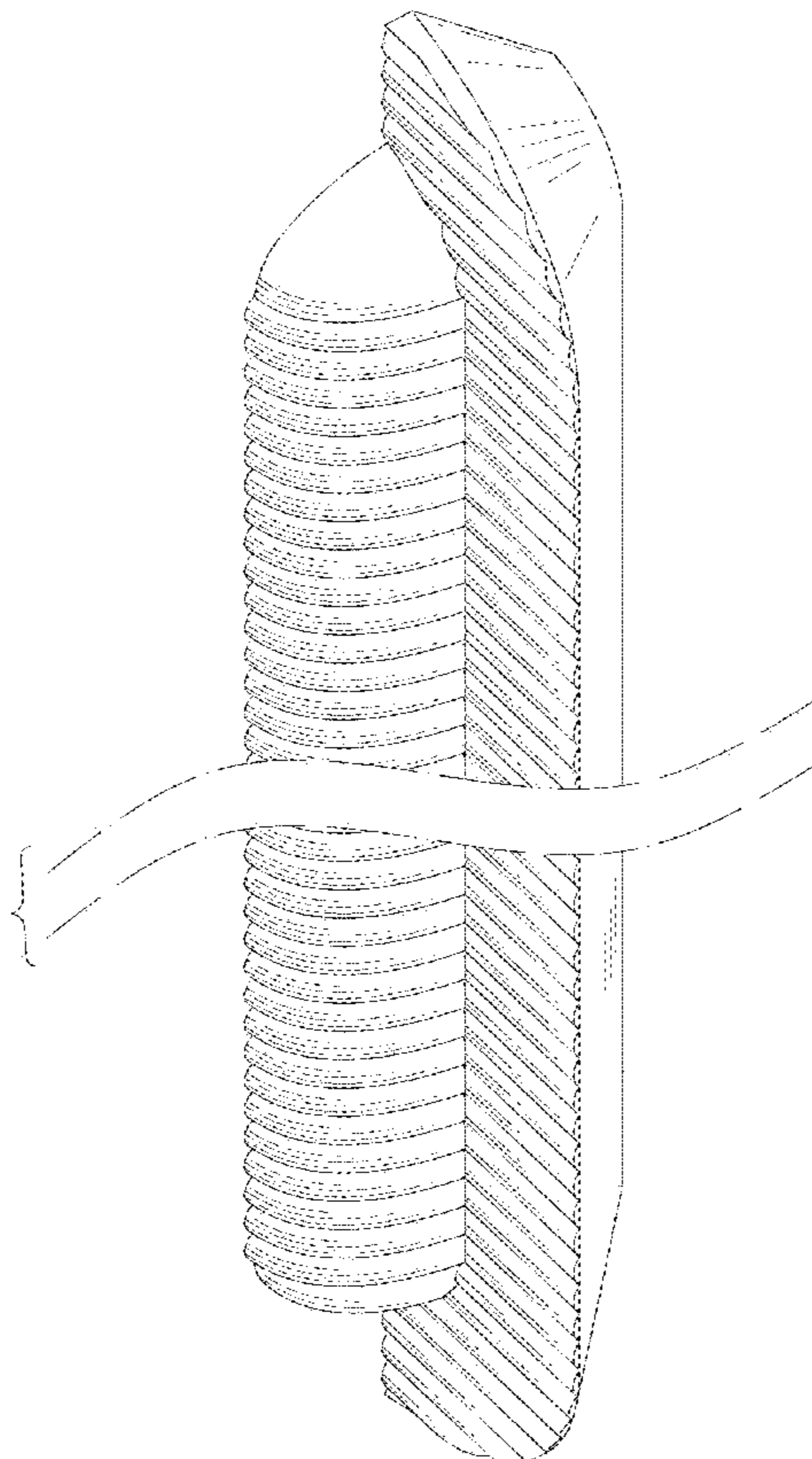
The optical element for vehicle lighthouse has been shown separated and bound by dot-dash broken lines and a bracket to indicate indeterminate length.

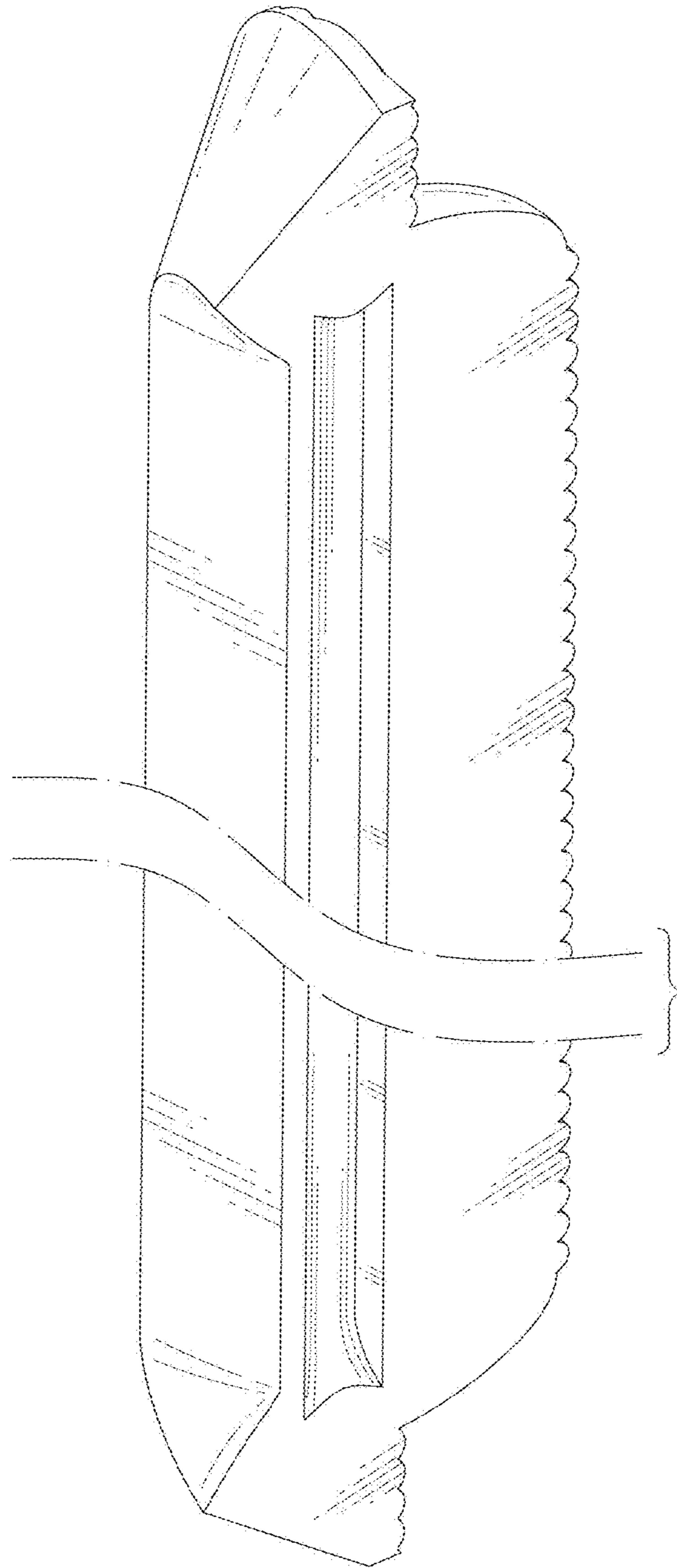

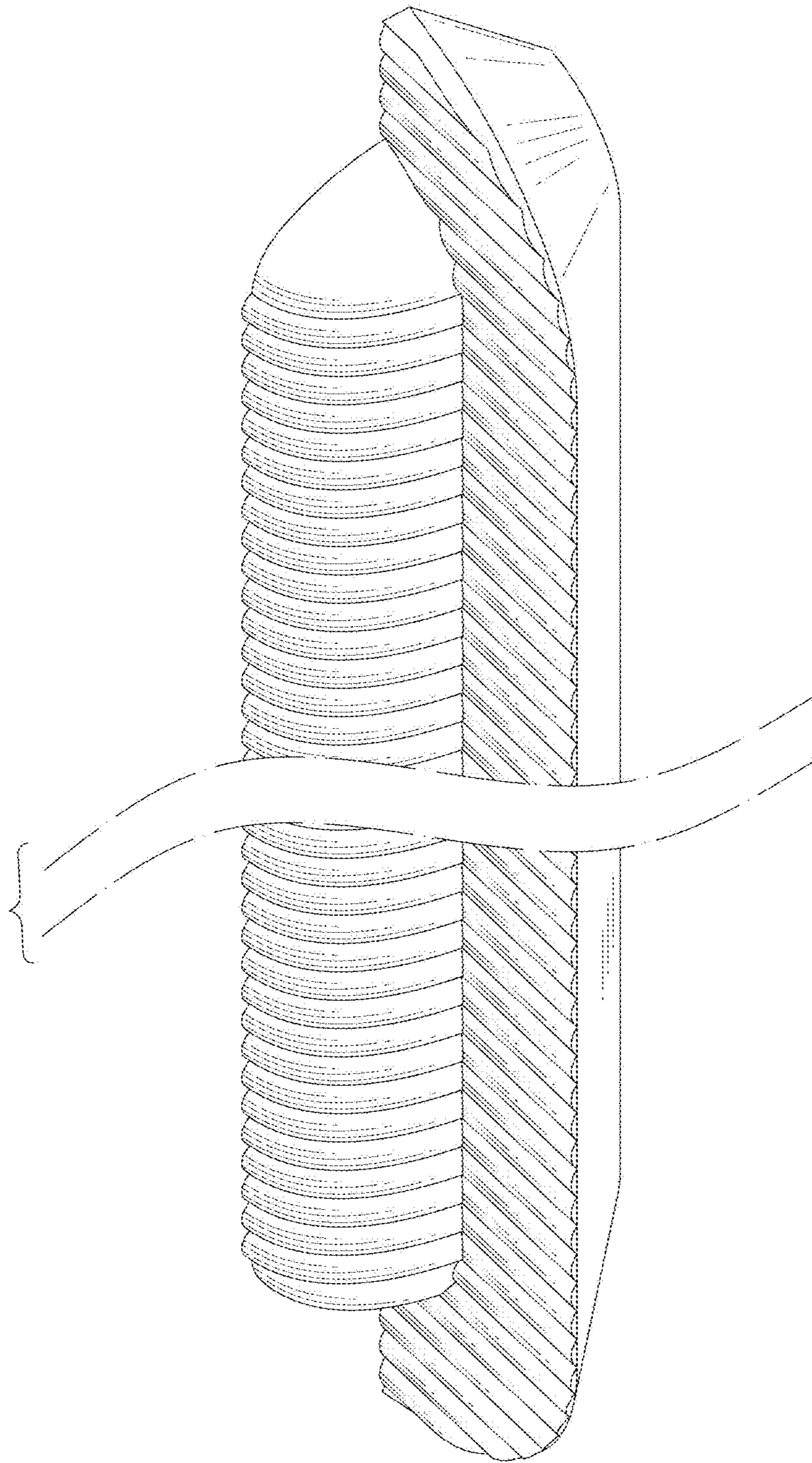

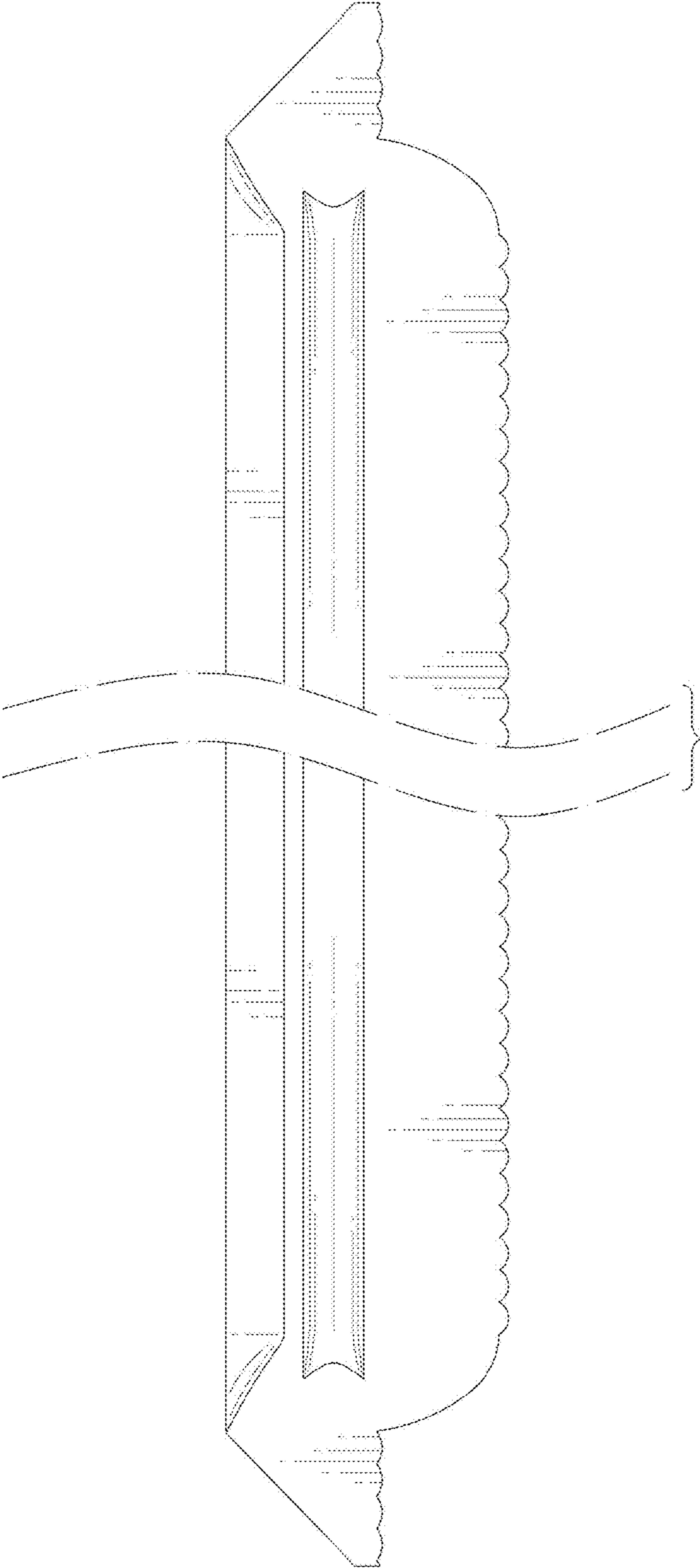

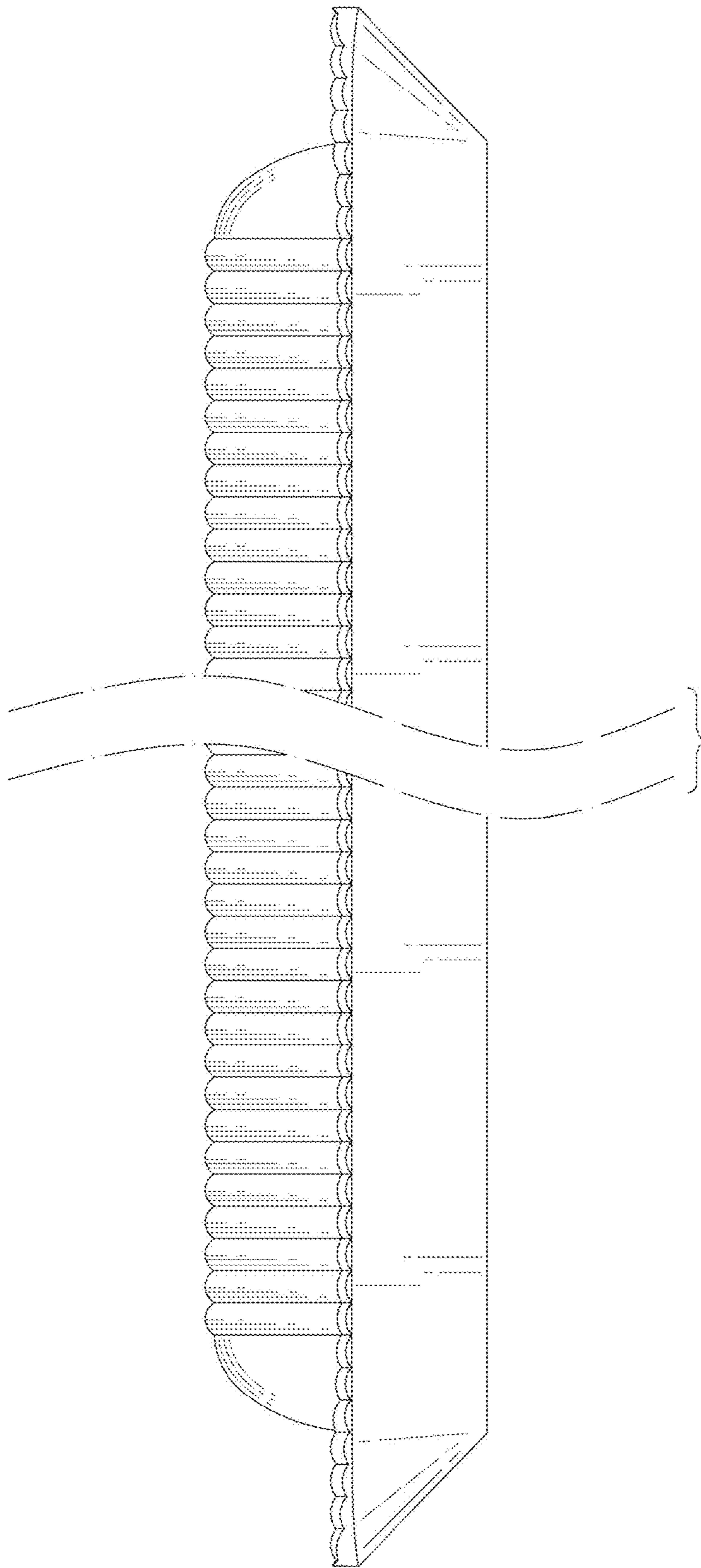

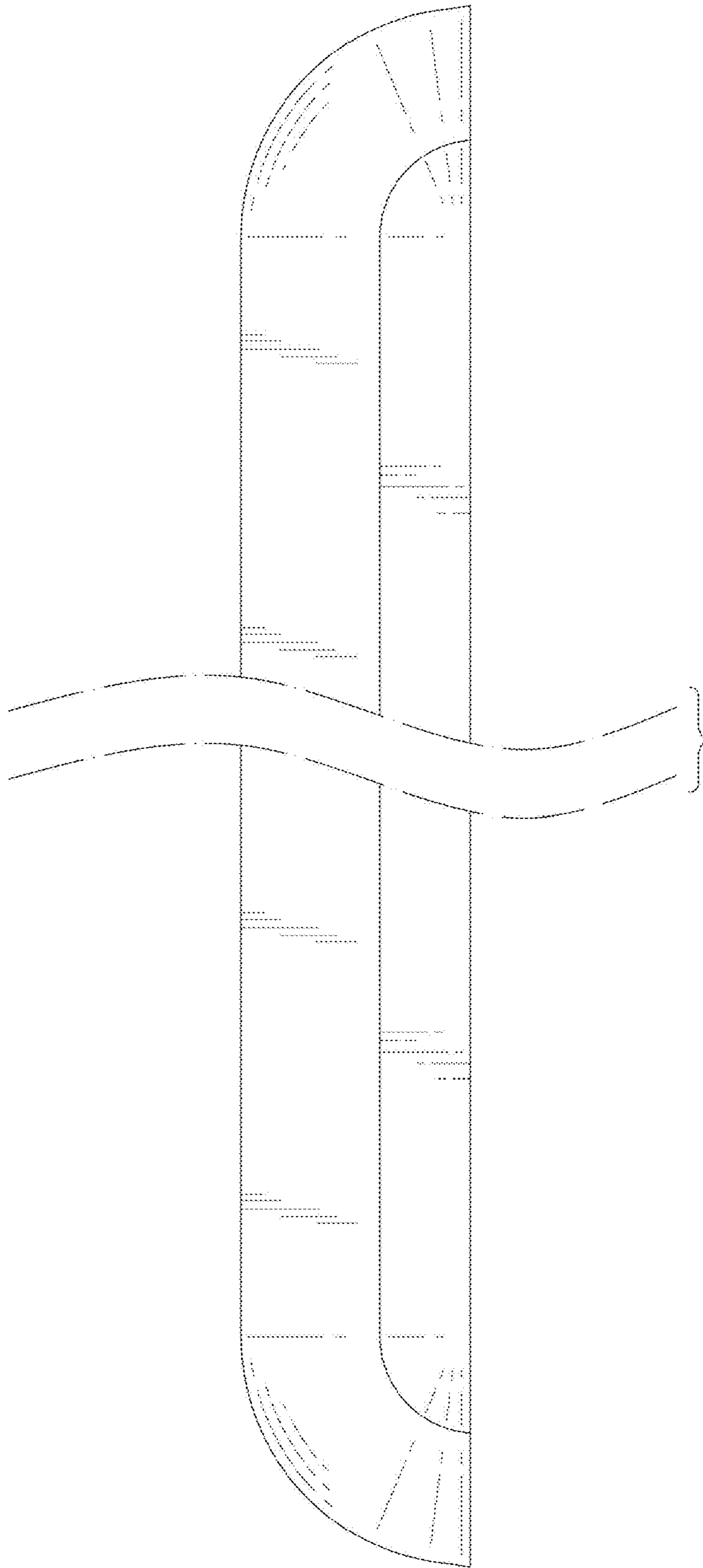

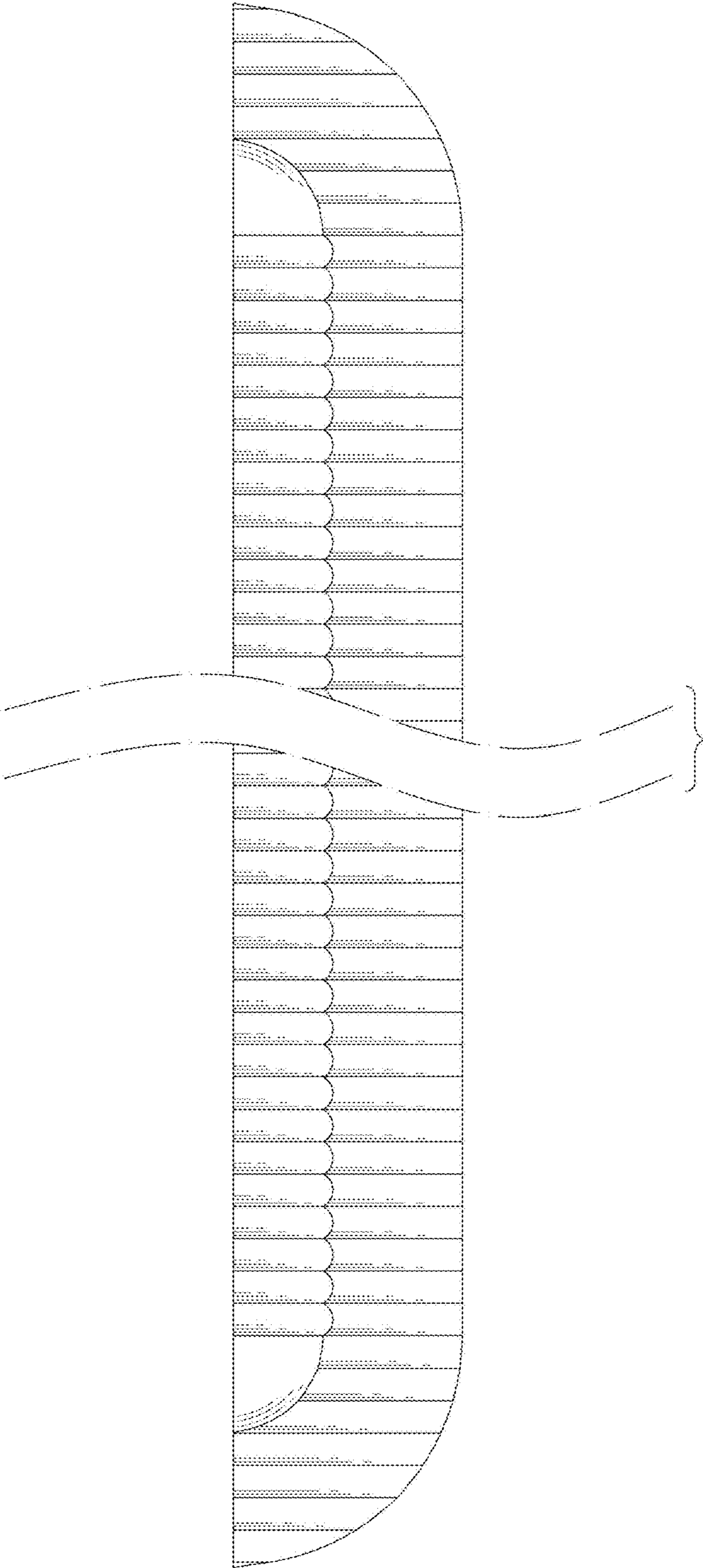

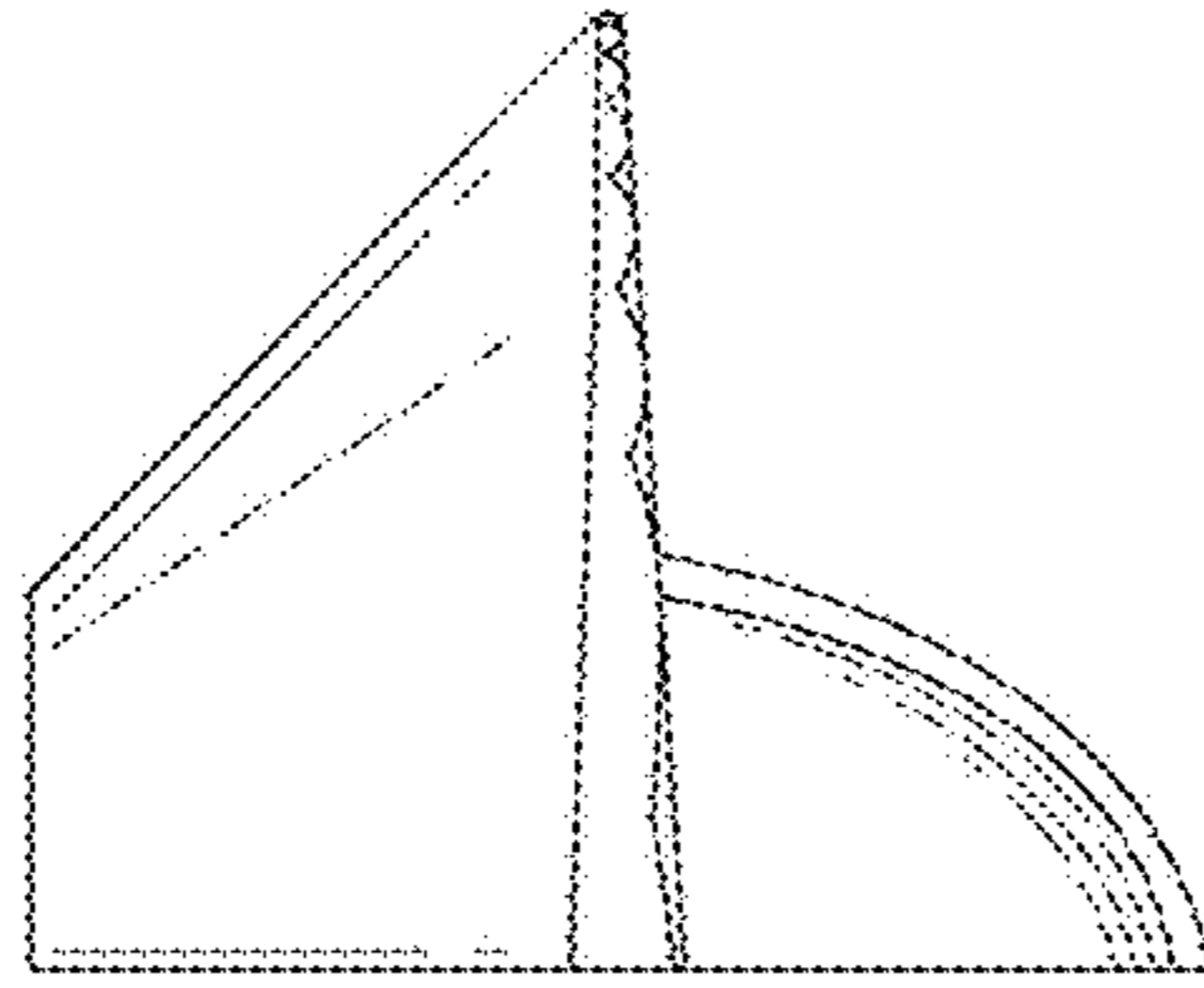
