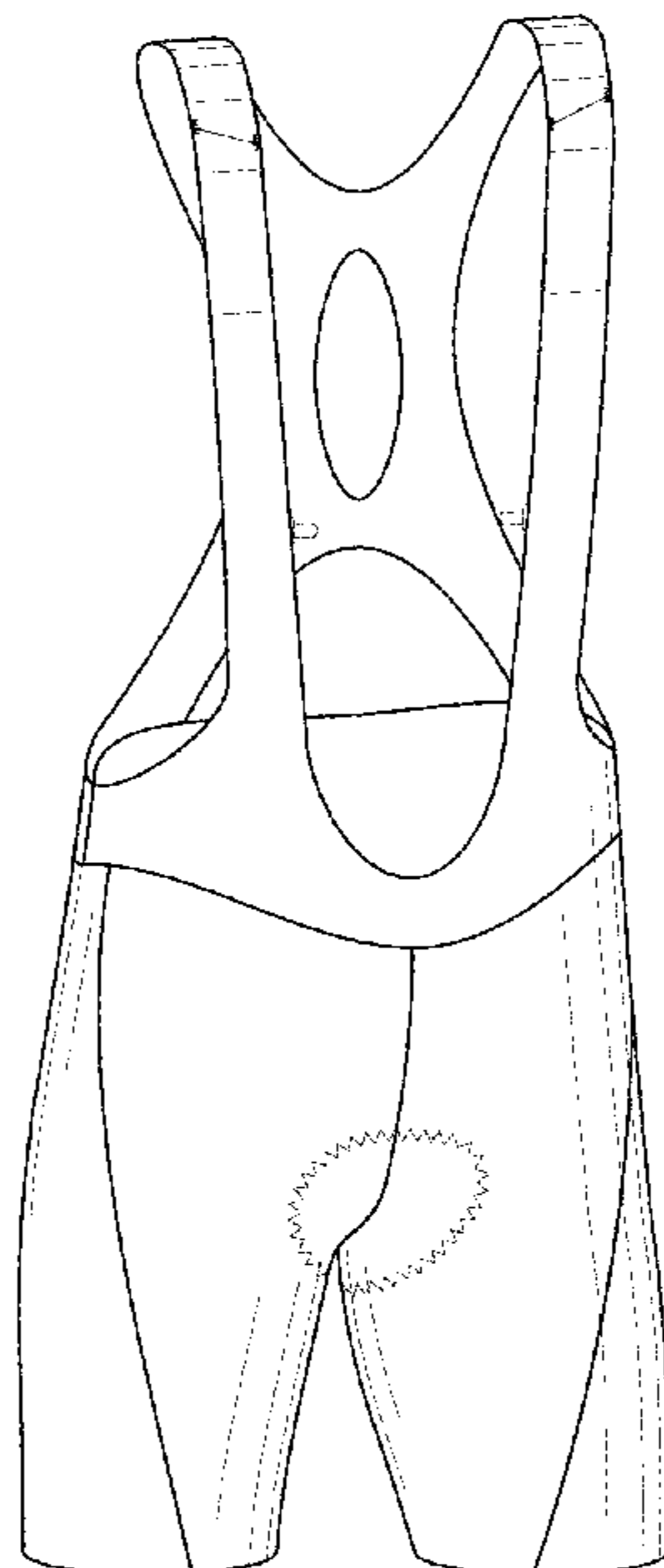
The ornamental design for a cycling bib, as shown and described.

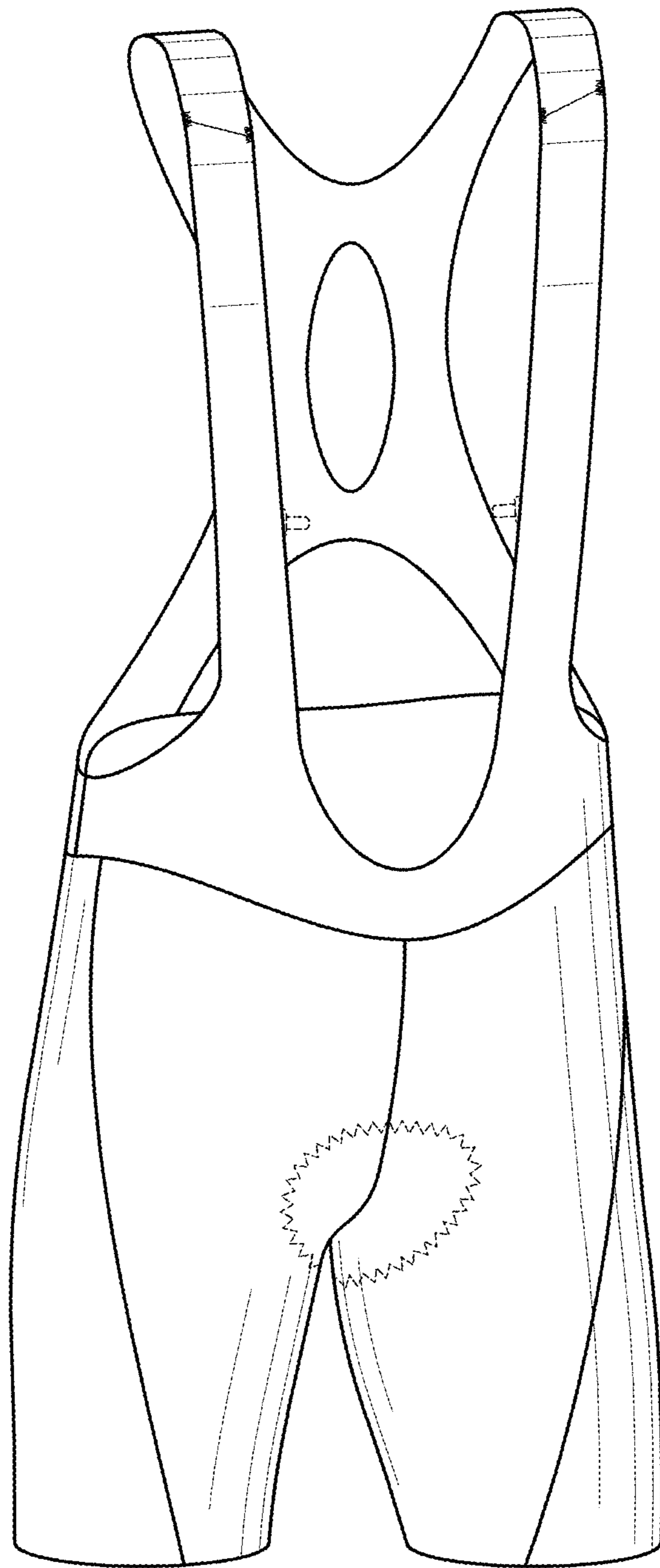

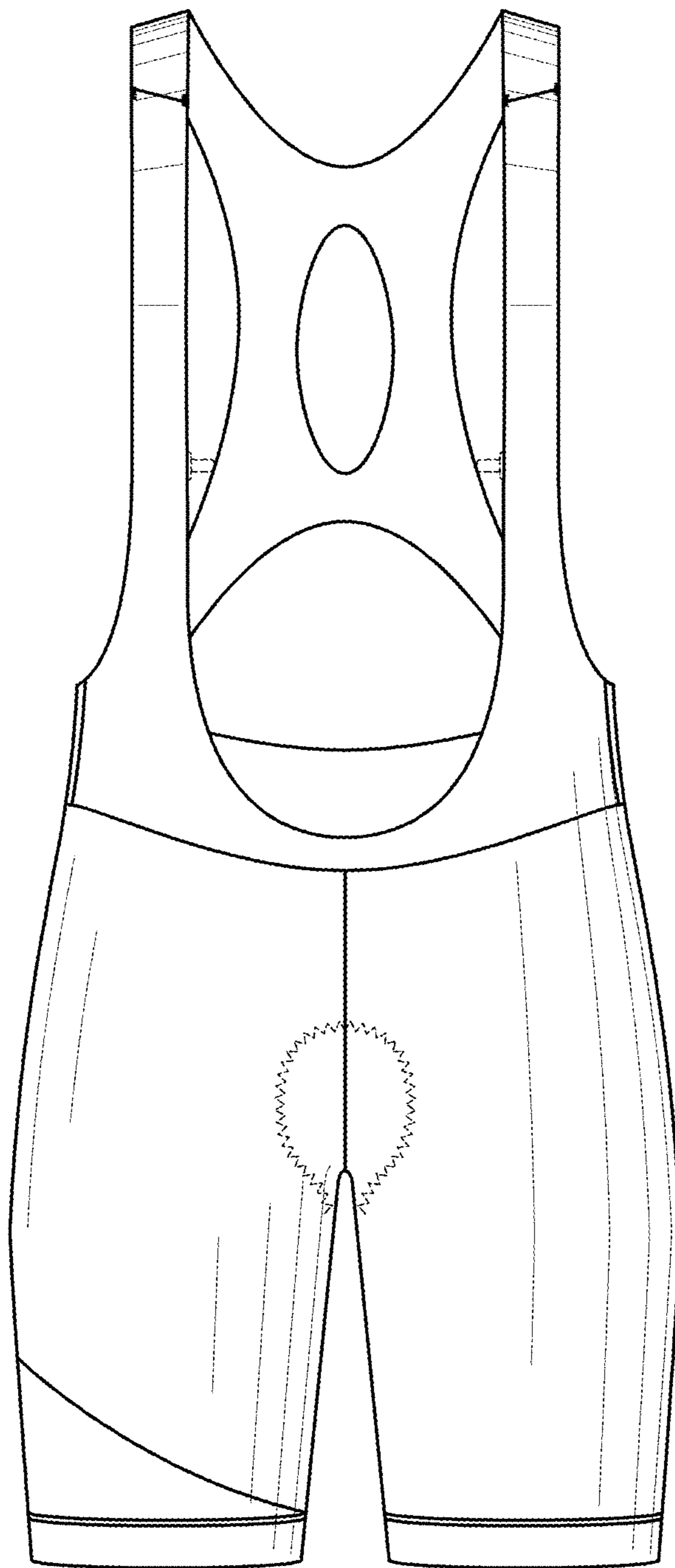

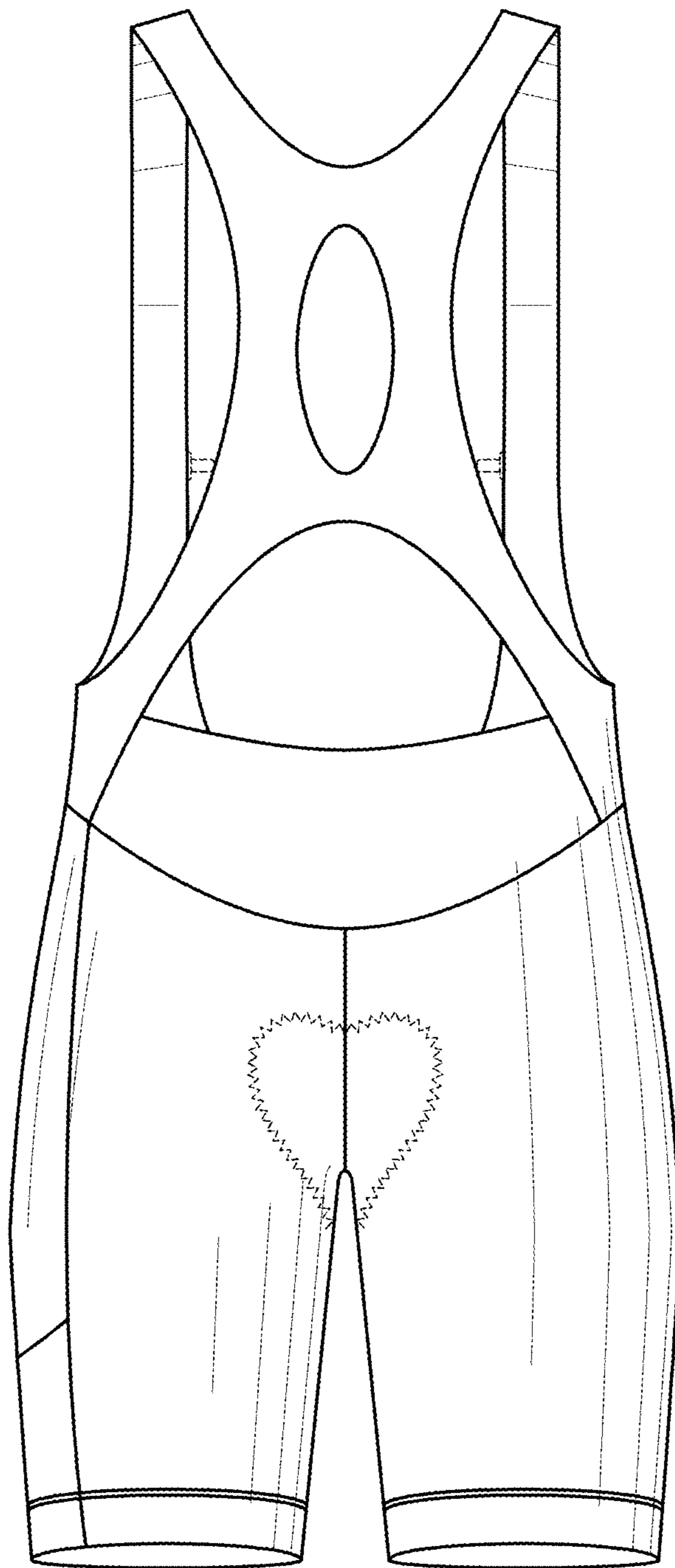

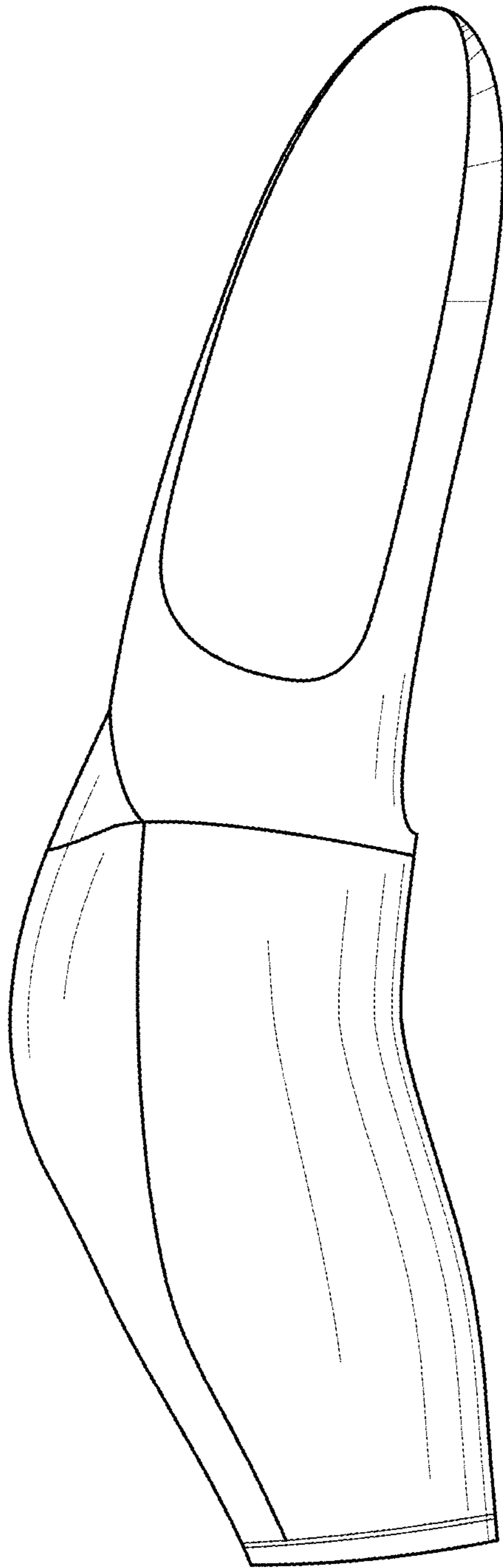
