**DESCRIPTION**

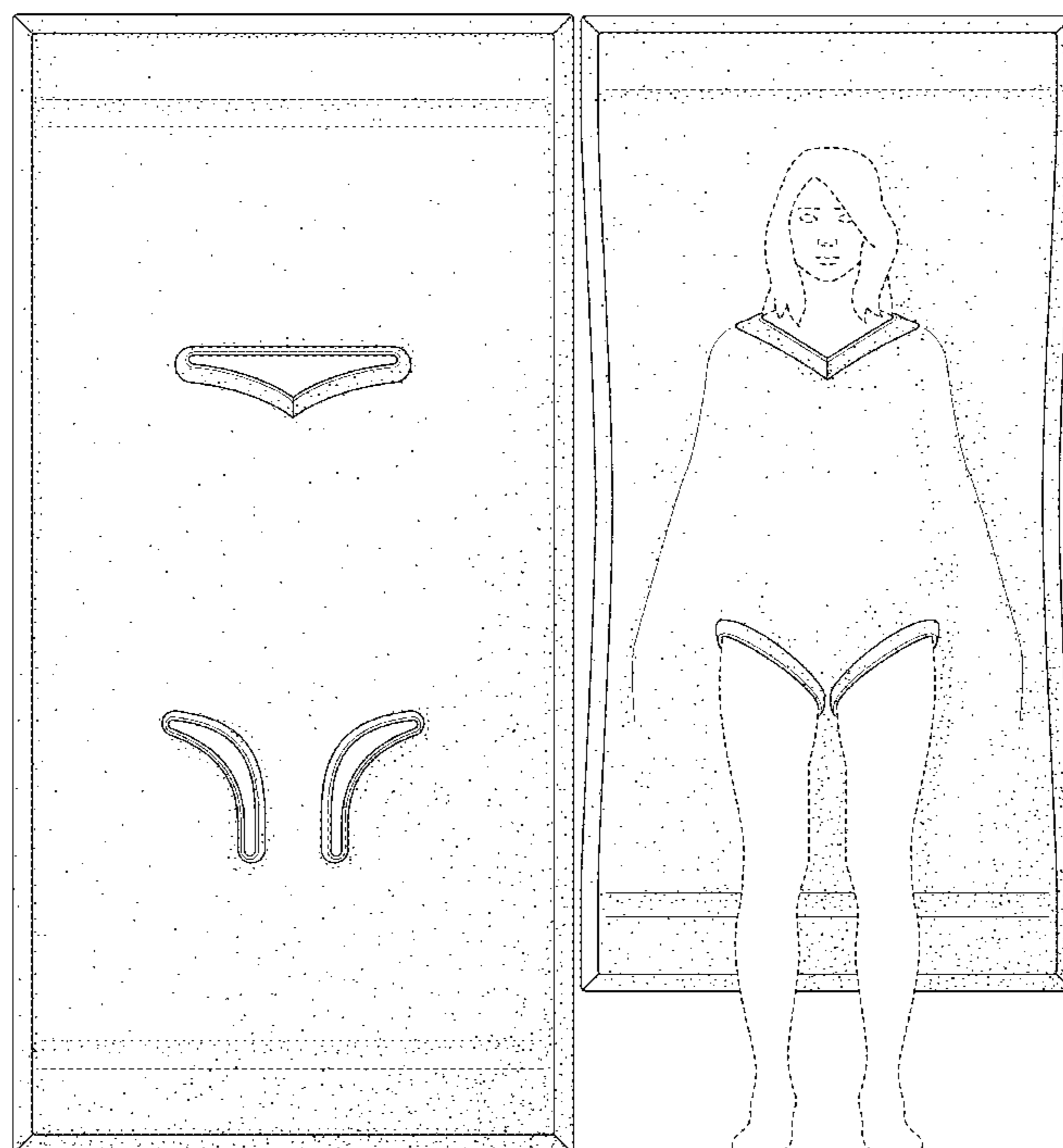
FIG. 1 is a front view of a wearable towel according to the present invention;

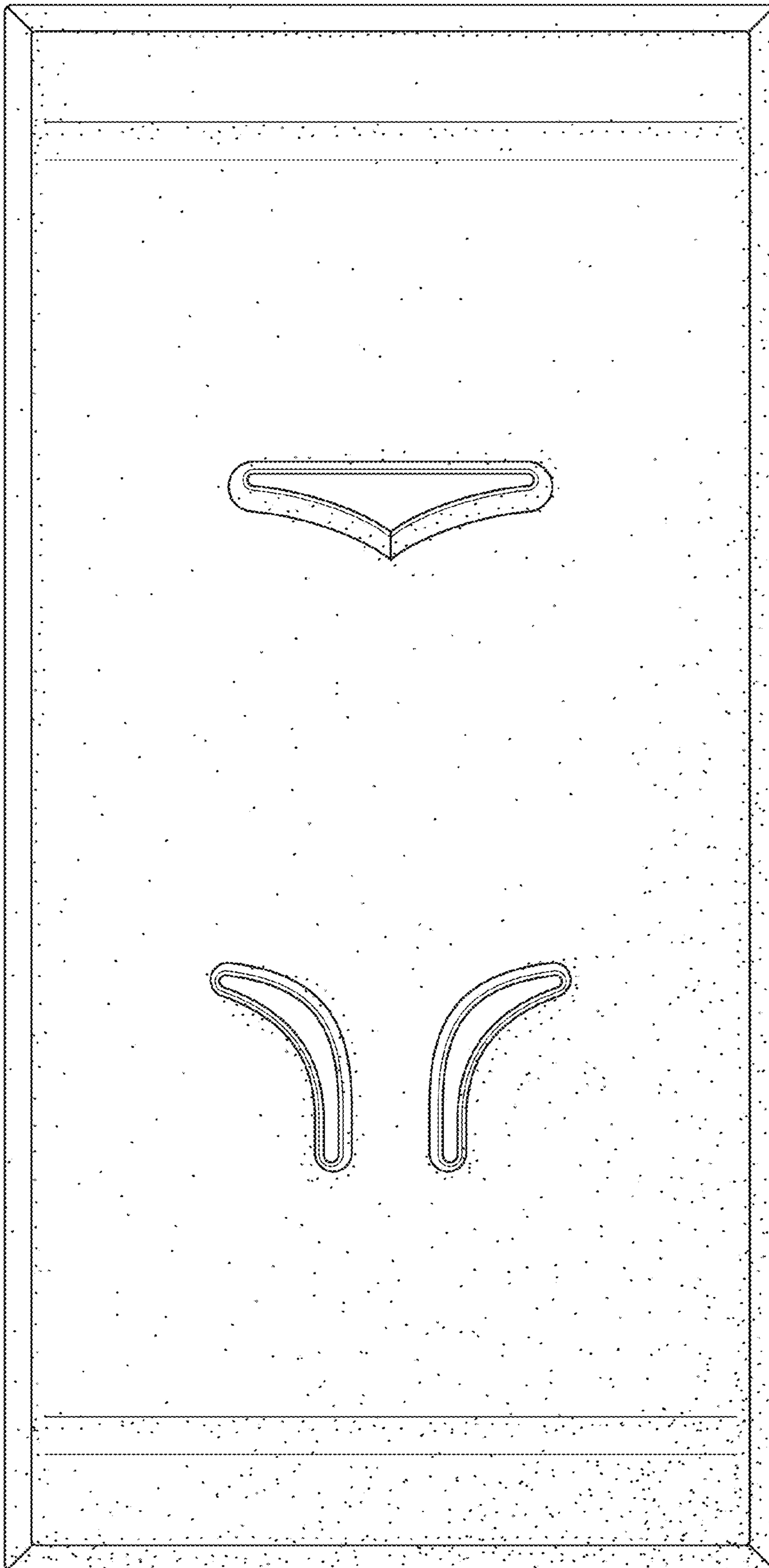

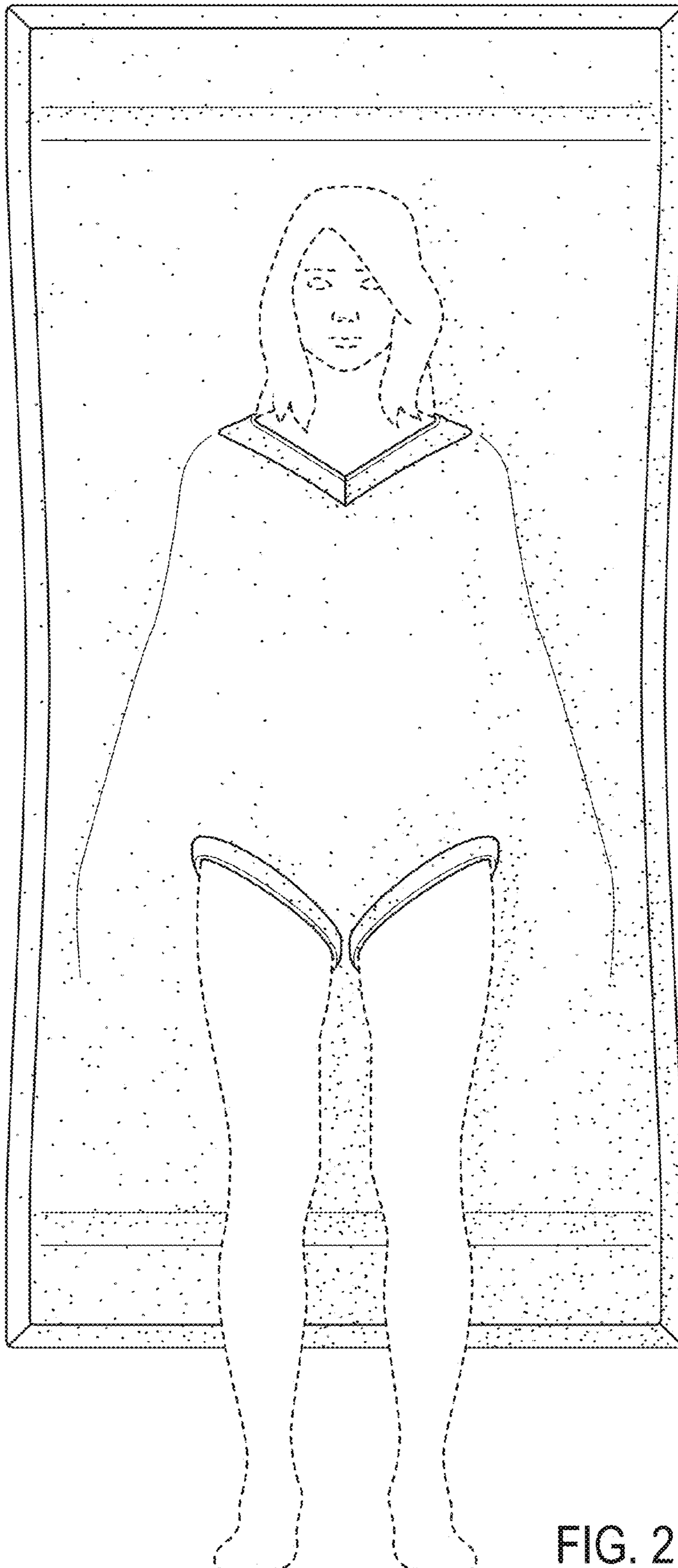

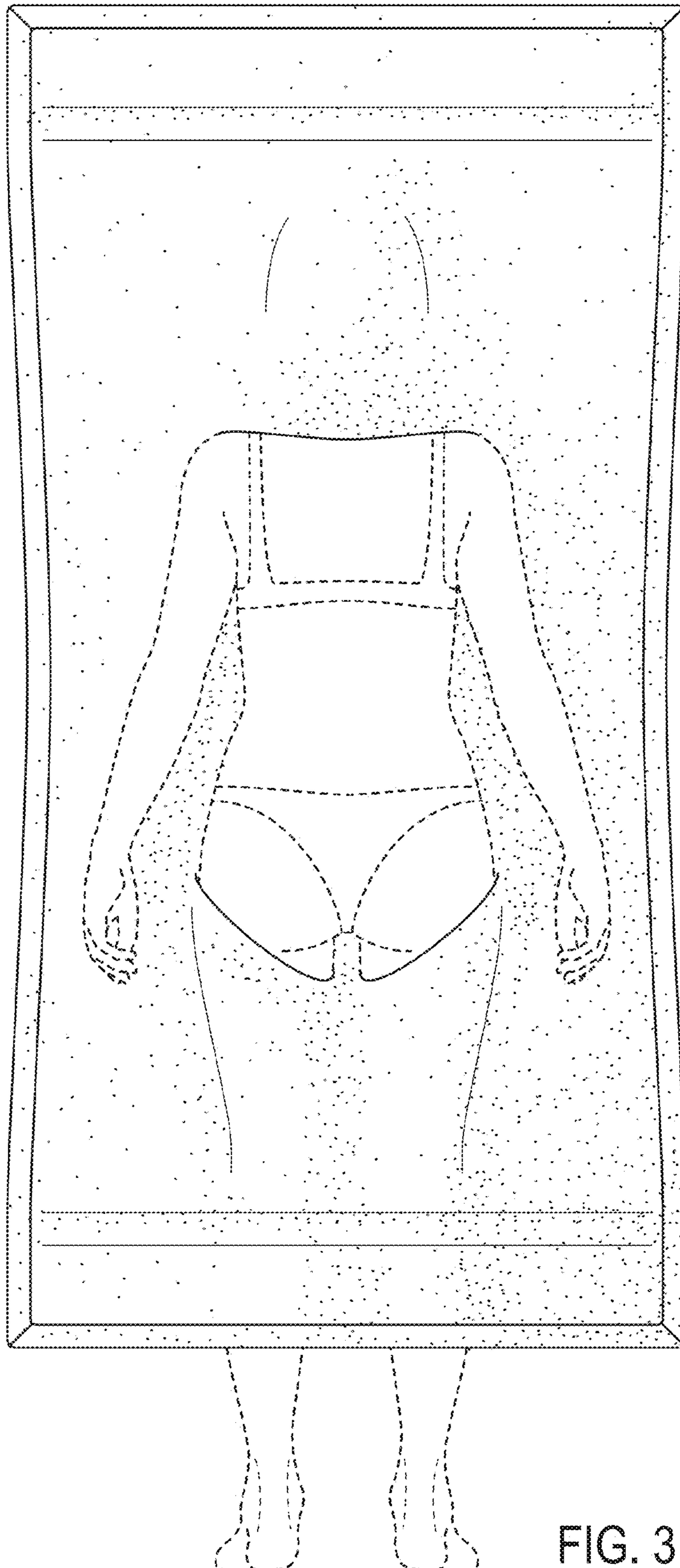

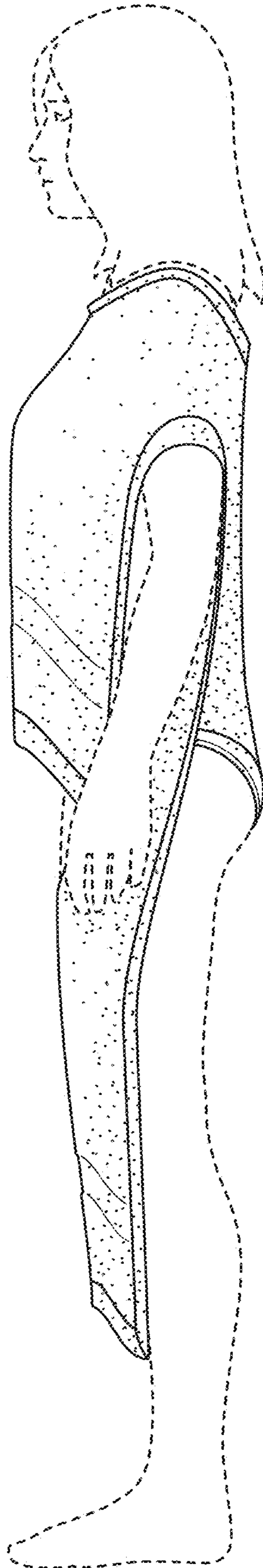

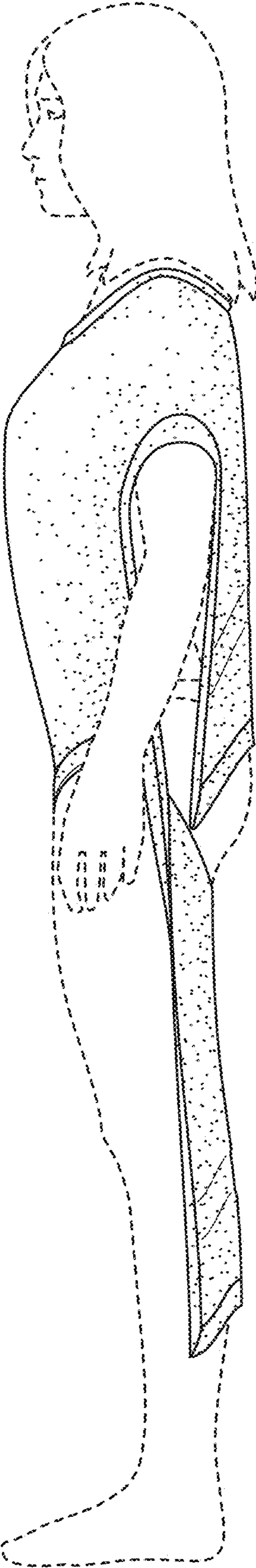

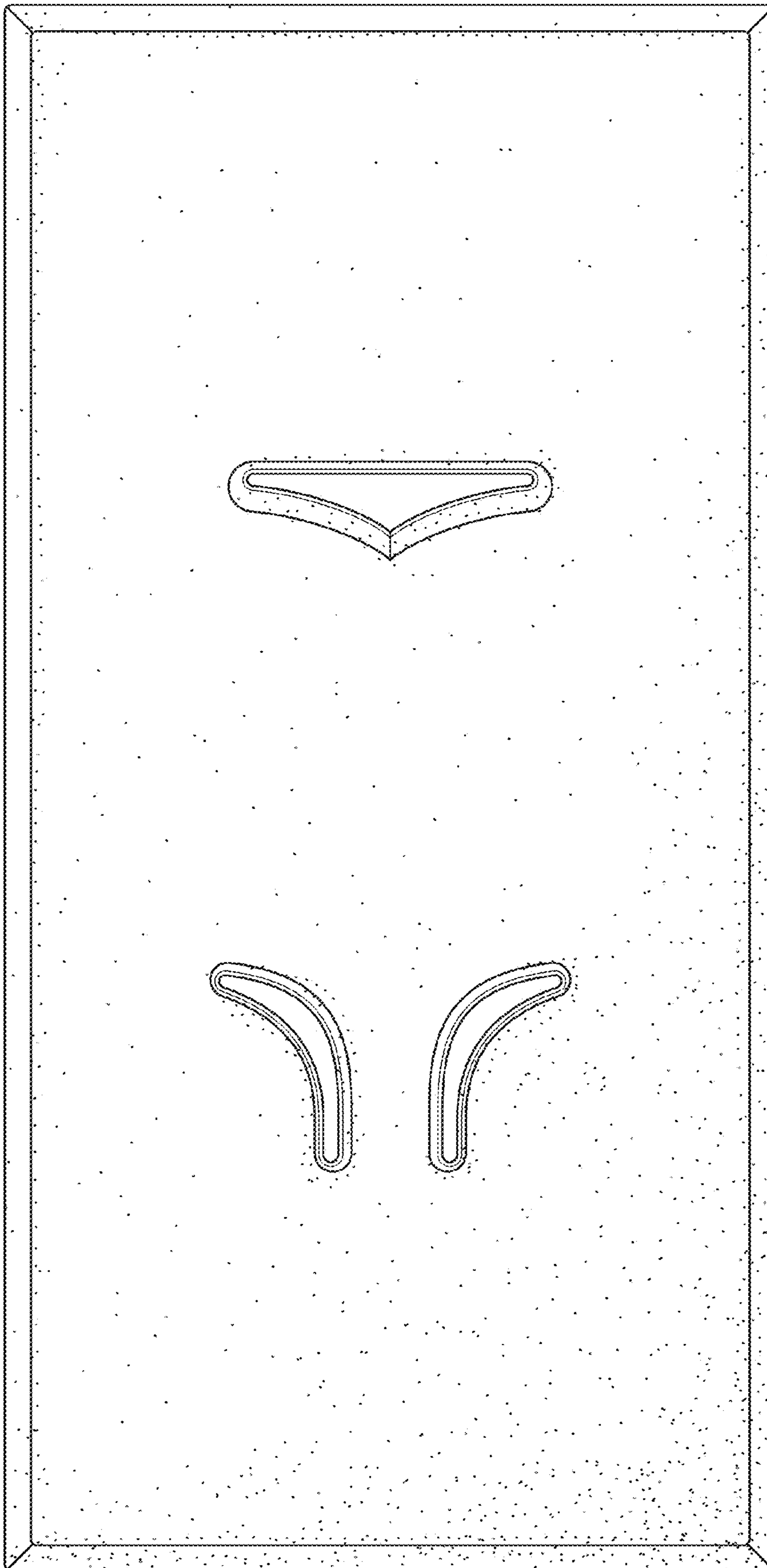
