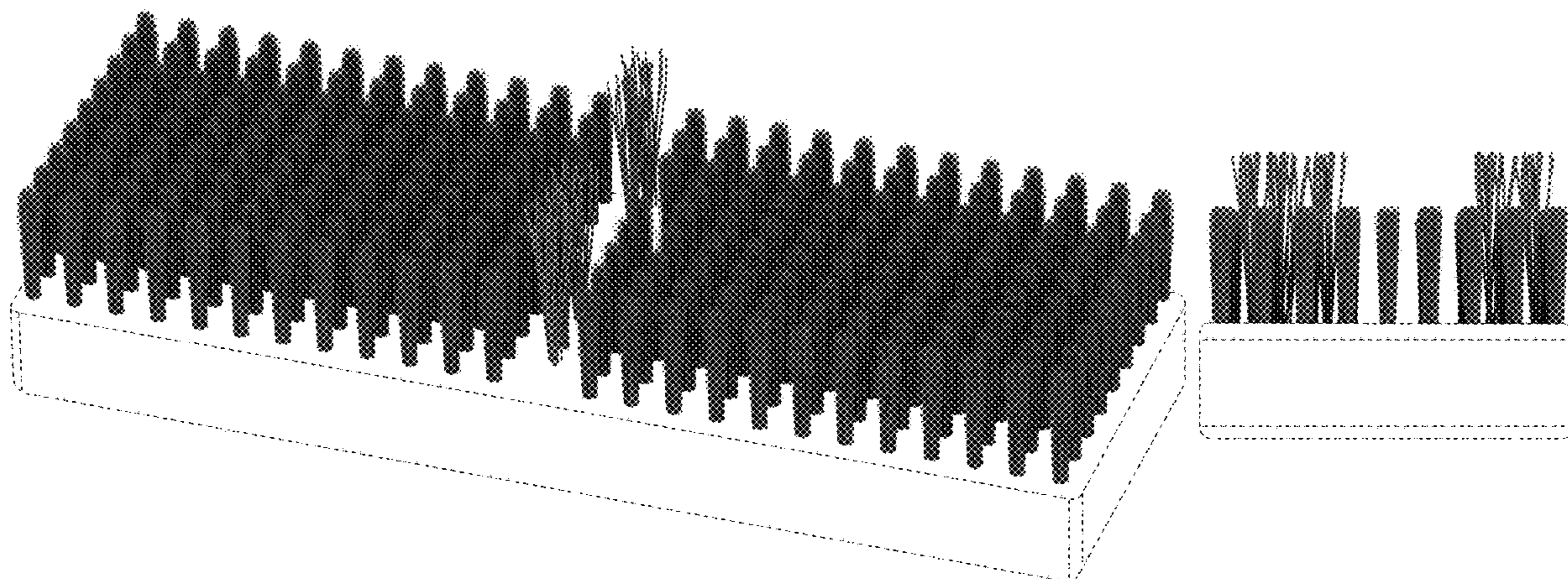
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a brush, showing my new design;
 FIG. 2 is a front, bottom and left side perspective view thereof;
 FIG. 3 is a rear, top and right side perspective view thereof;
 FIG. 4 is a rear, bottom and right side perspective view thereof;
 FIG. 5 is a front elevational view thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a left side elevation view thereof;
 FIG. 8 is a right side elevational view thereof;
 FIG. 9 is a top plan view thereof;
 FIG. 10 is a bottom plan view thereof;
 FIG. 11 is an enlarged fragmentary view taken from the central portion of the top of the article, illustrating the bristle arrangement in greater detail;
 FIG. 12 is an enlarged fragmentary view taken from the rear and left side portion of the article, illustrating the bristle arrangement in greater detail; and,
 FIG. 13 is an enlarged fragmentary view taken from the front and top portion of the article, illustrating the bristle arrangement in greater detail.
 The broken lines in the drawing figures illustrate environmental structure and form no part of the claimed design.

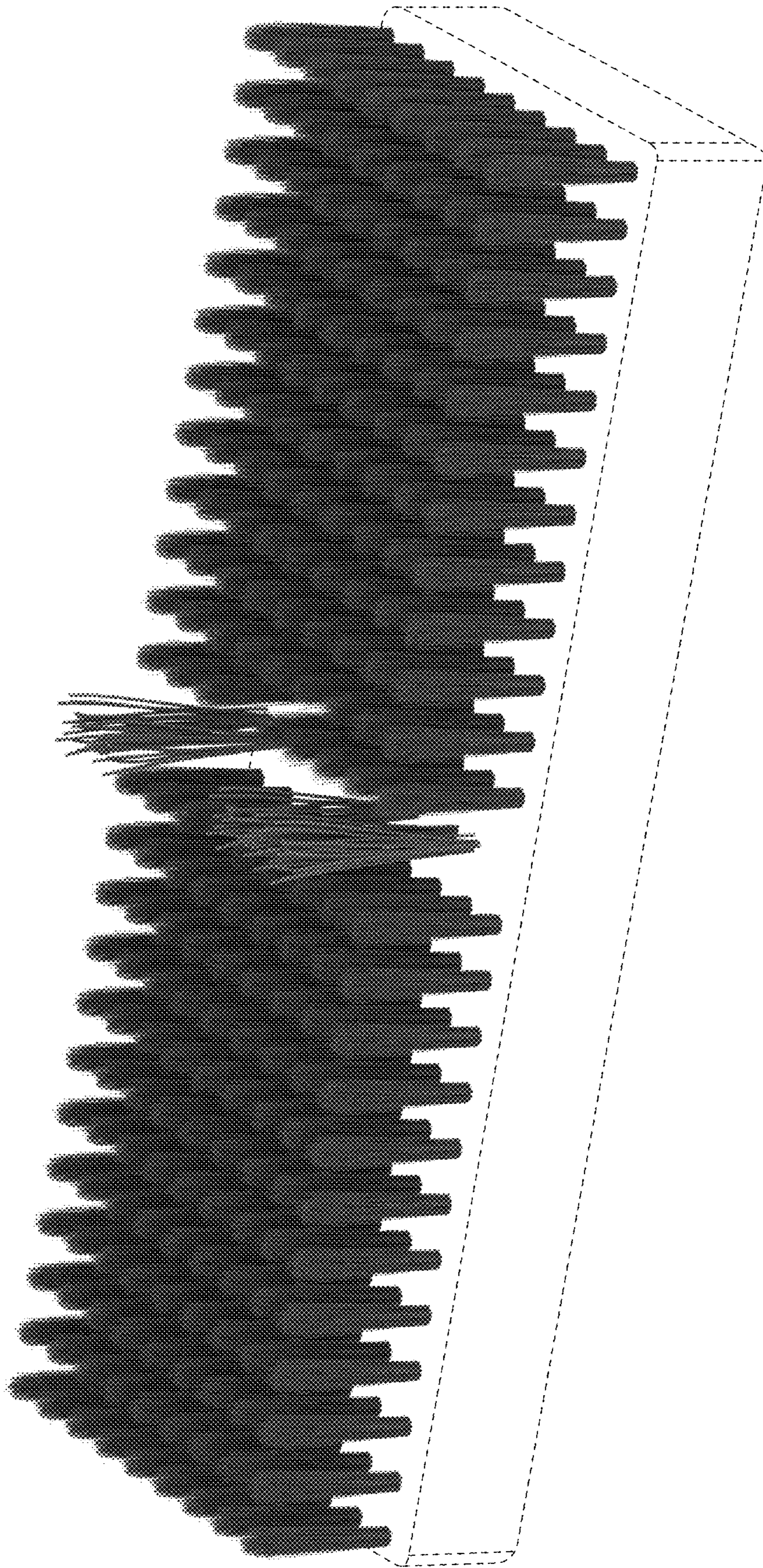

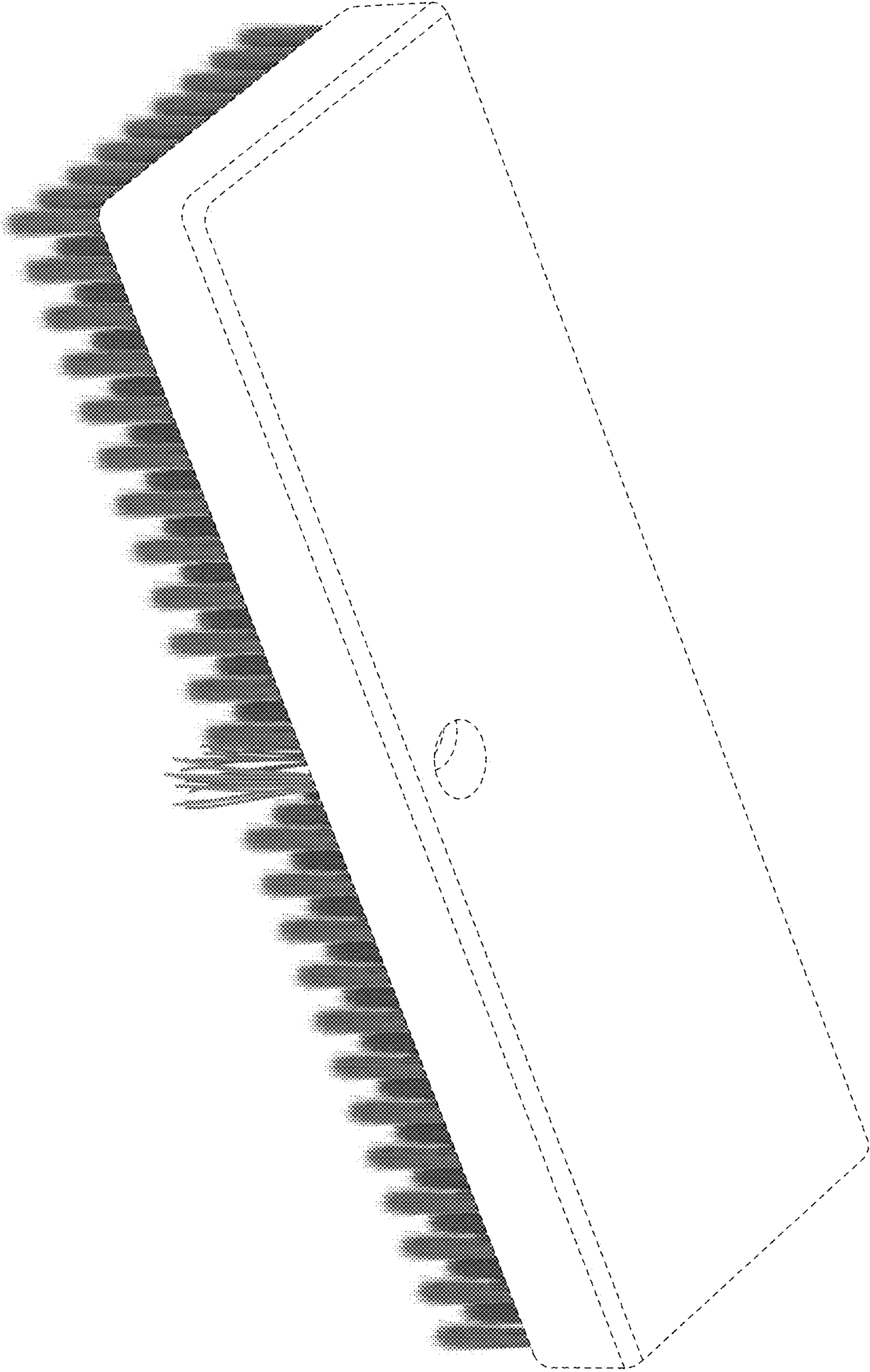

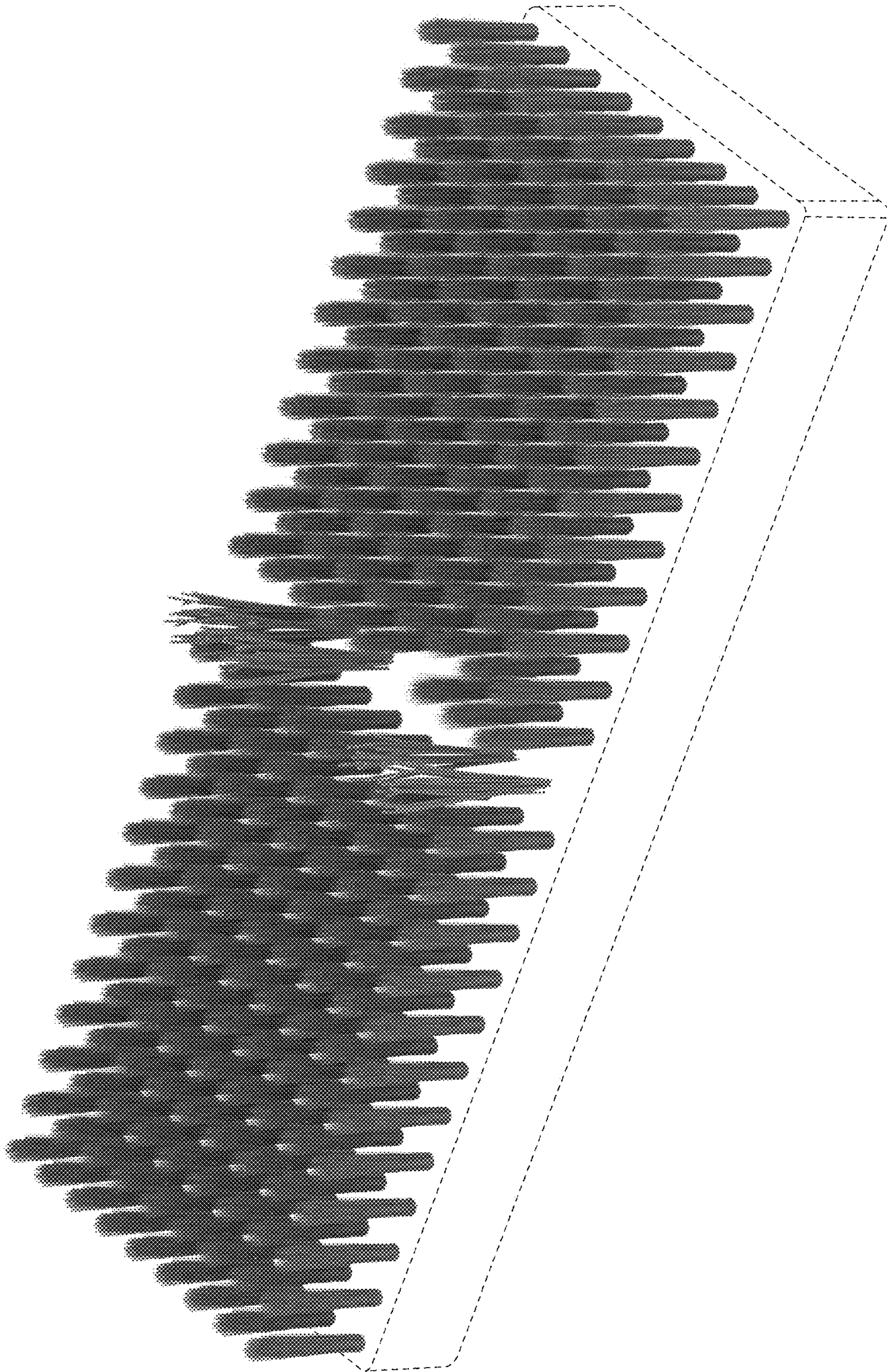

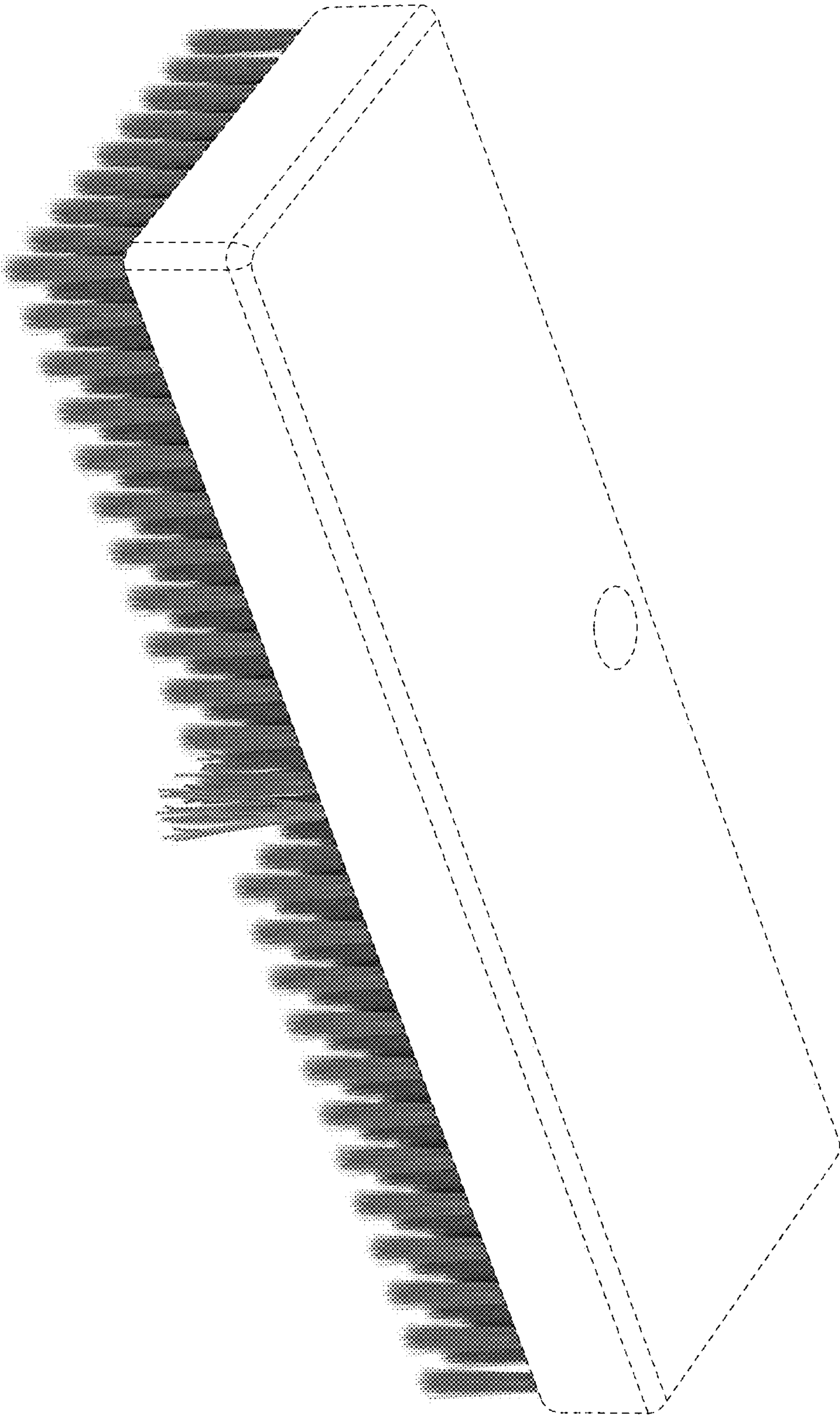

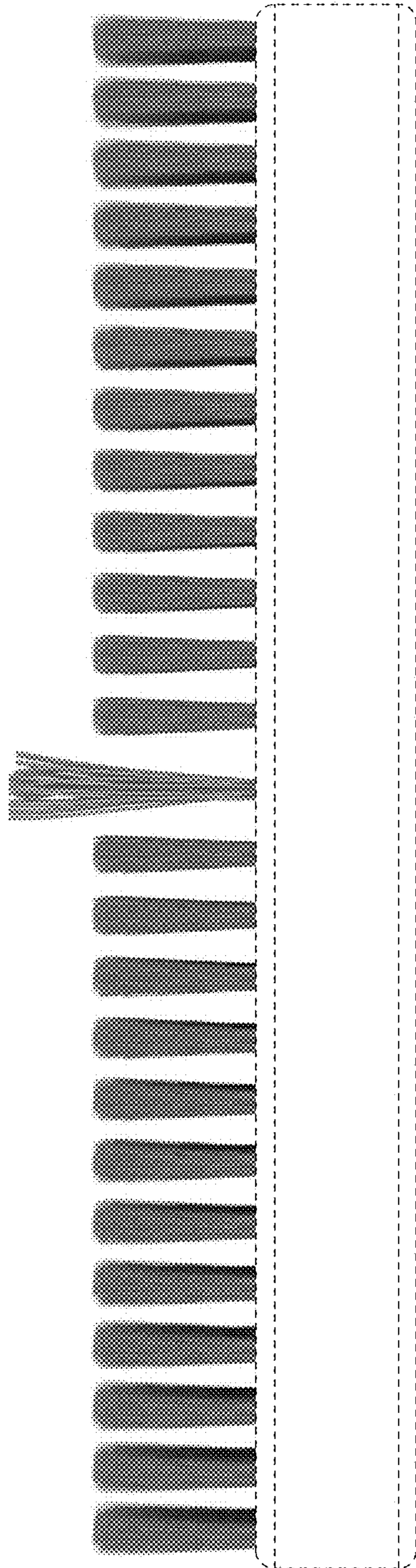

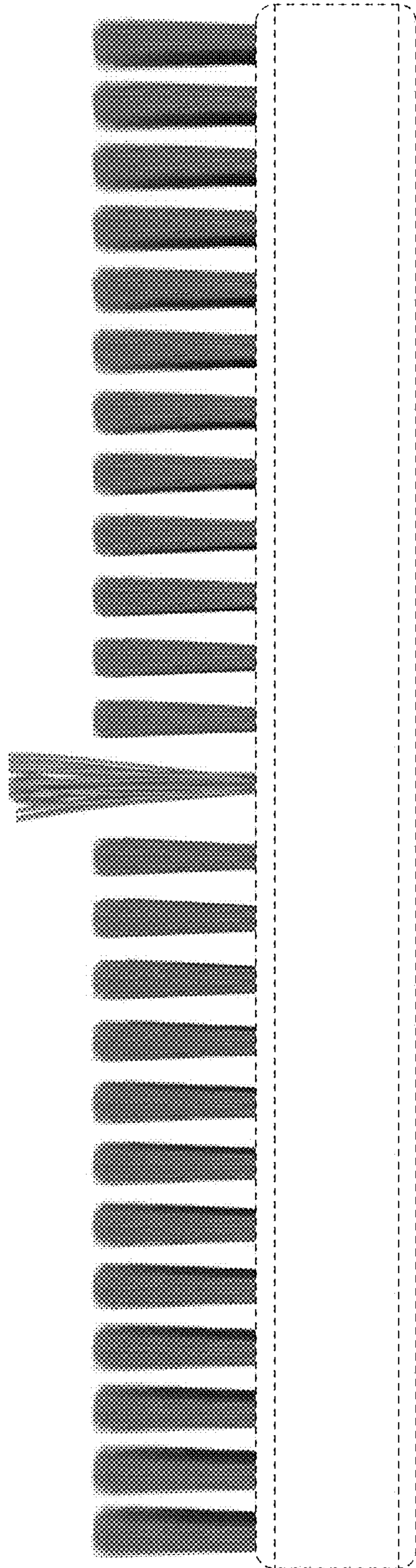

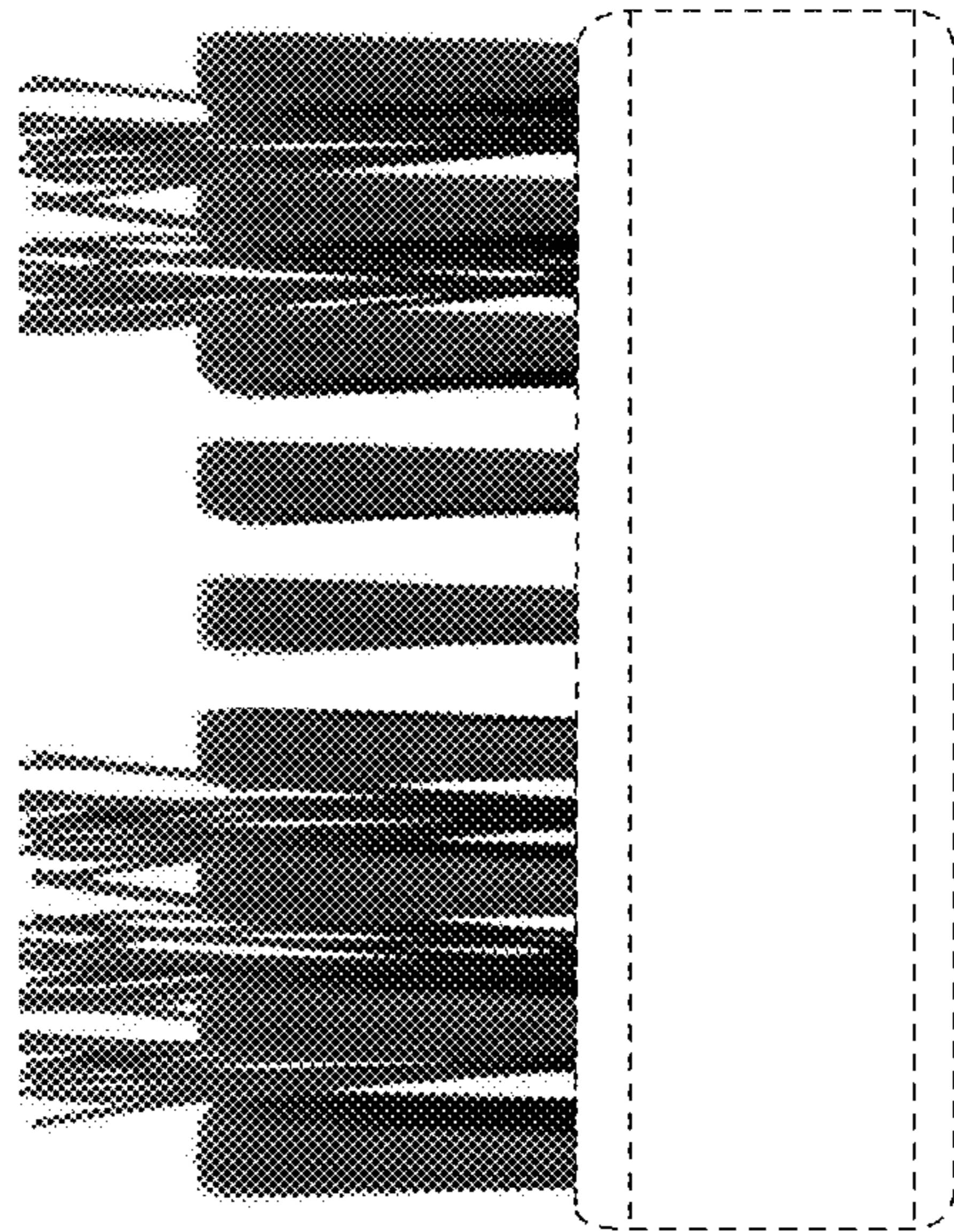

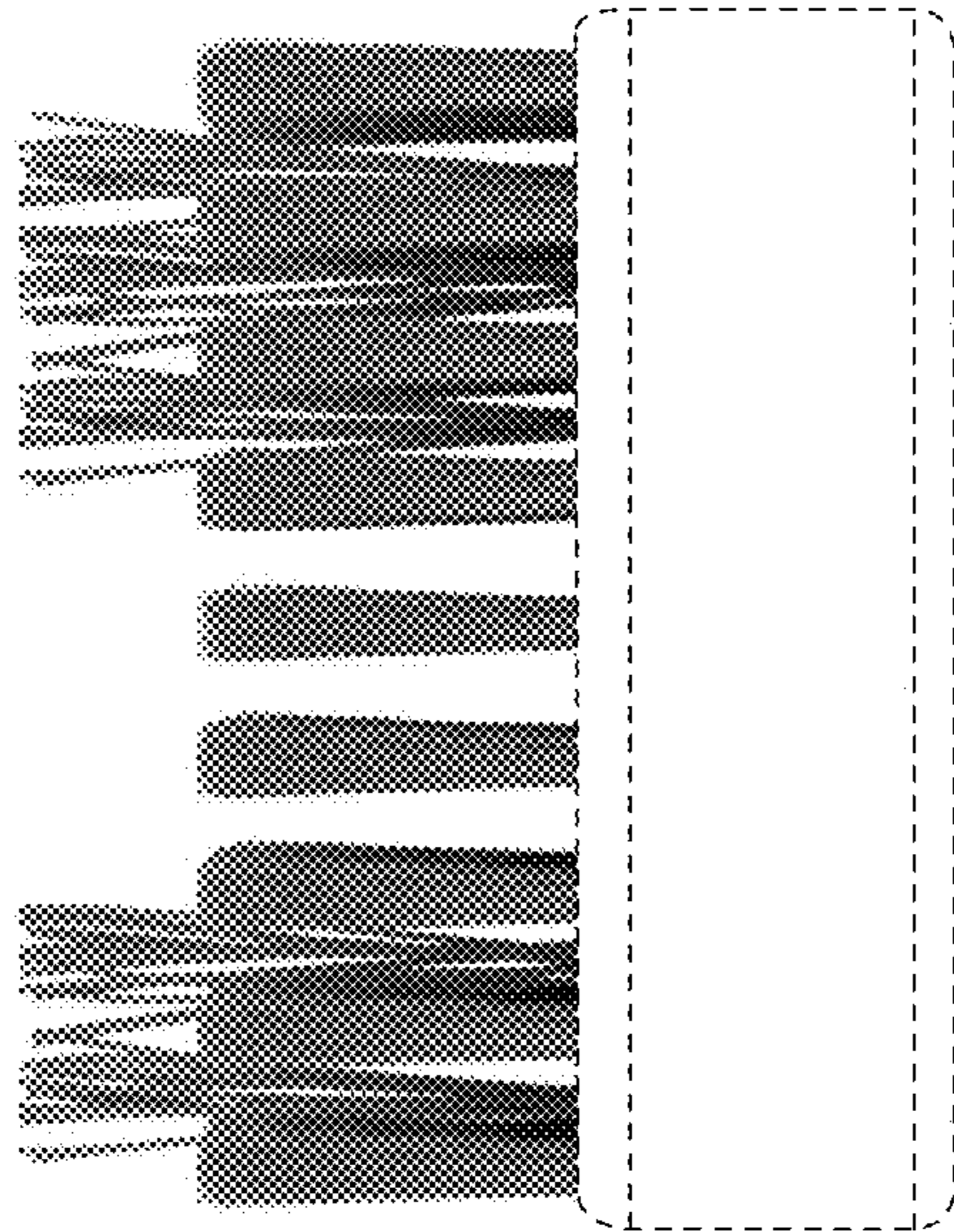

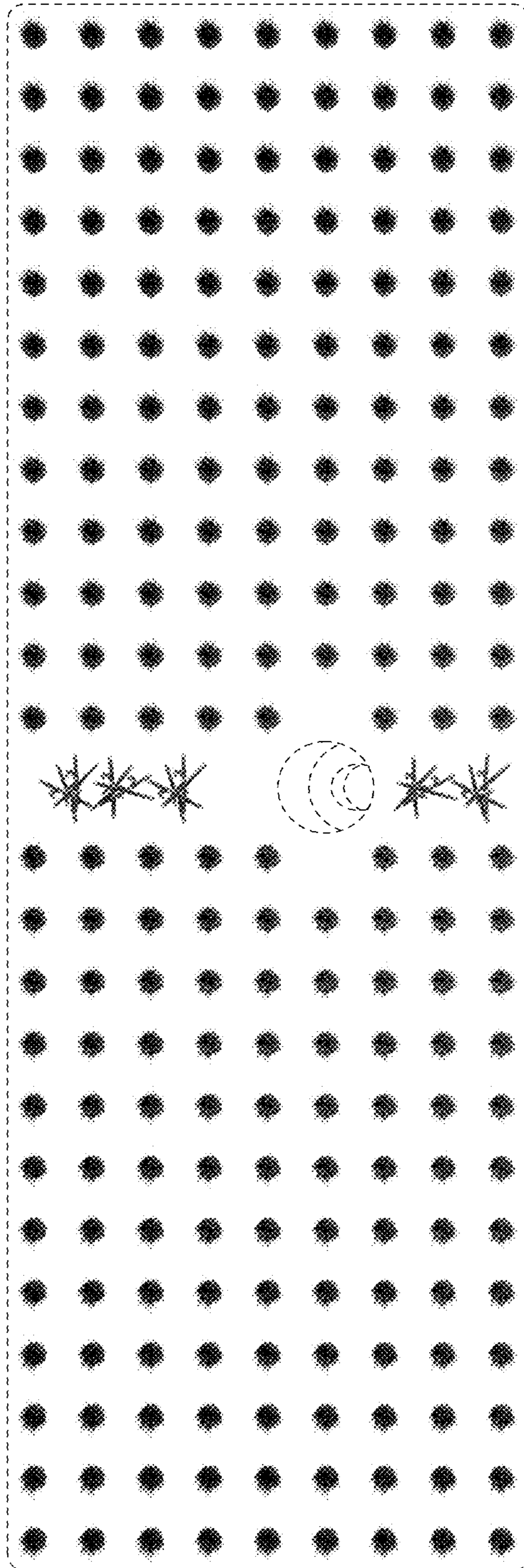

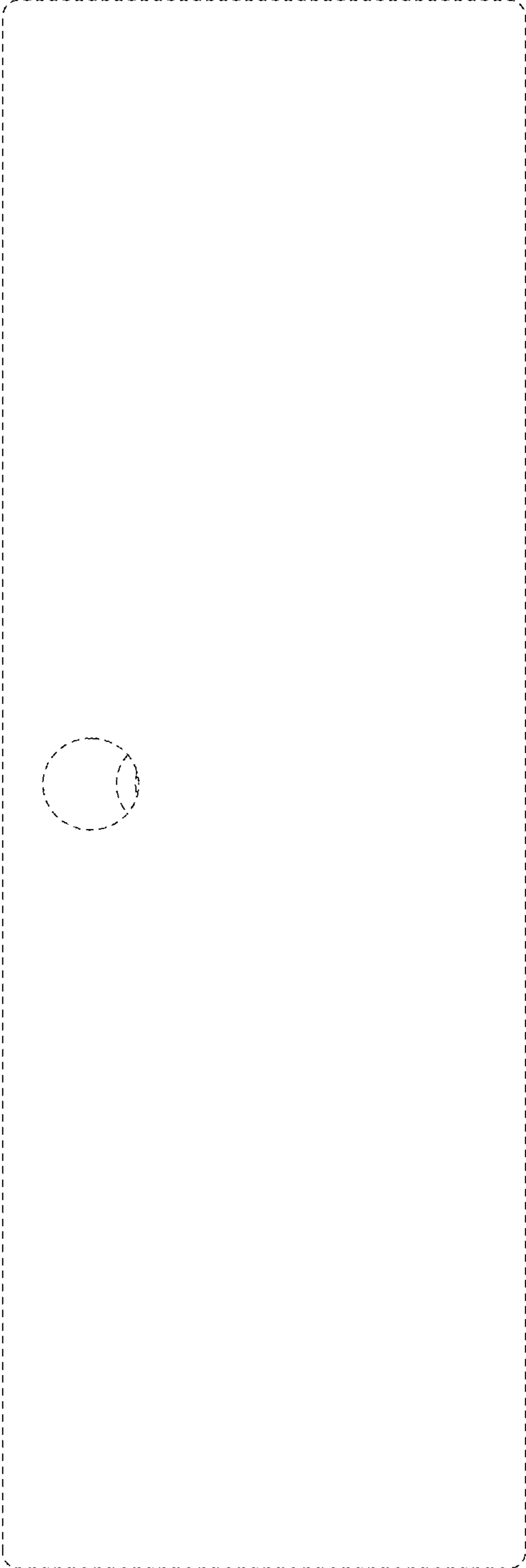

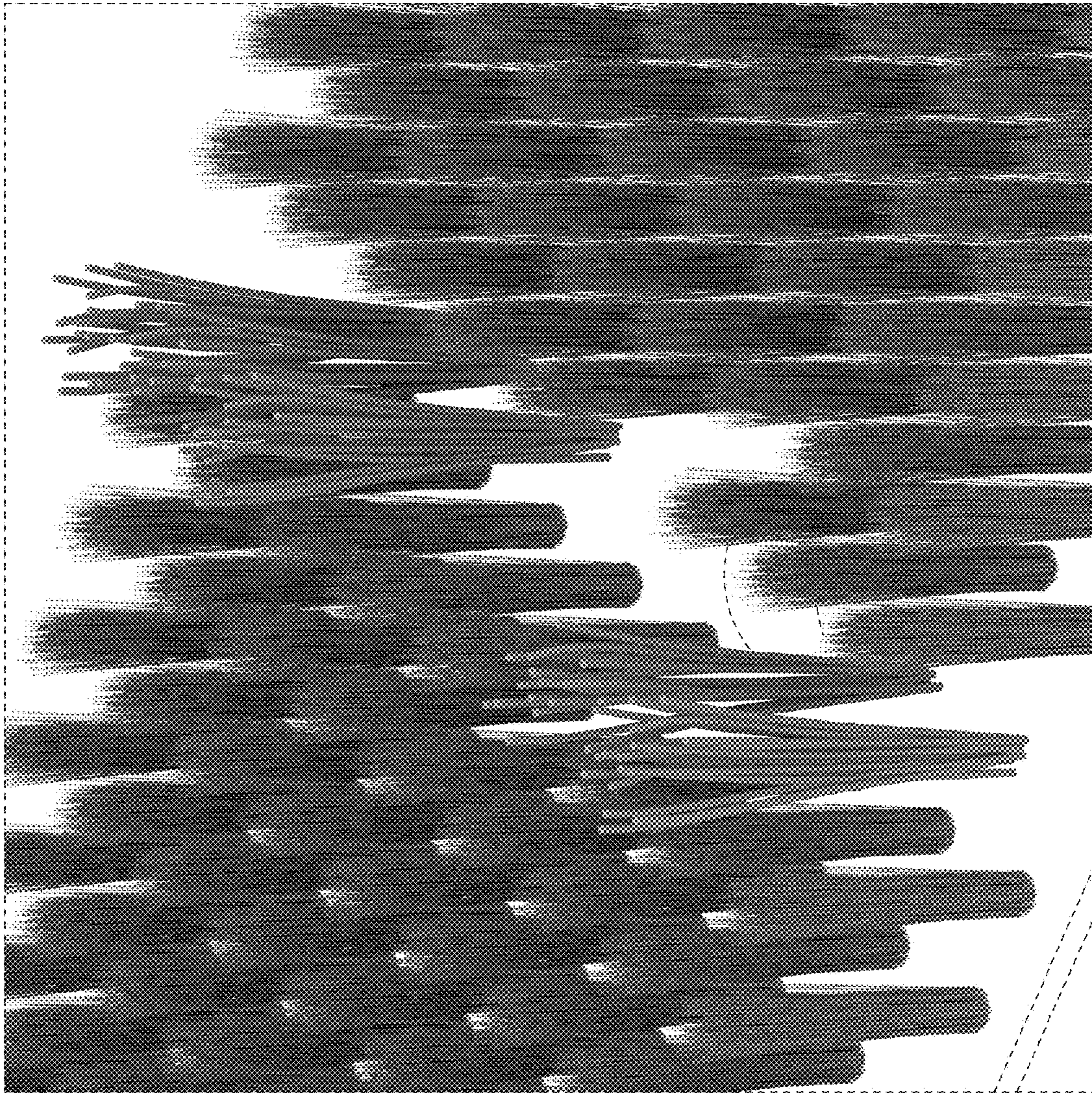

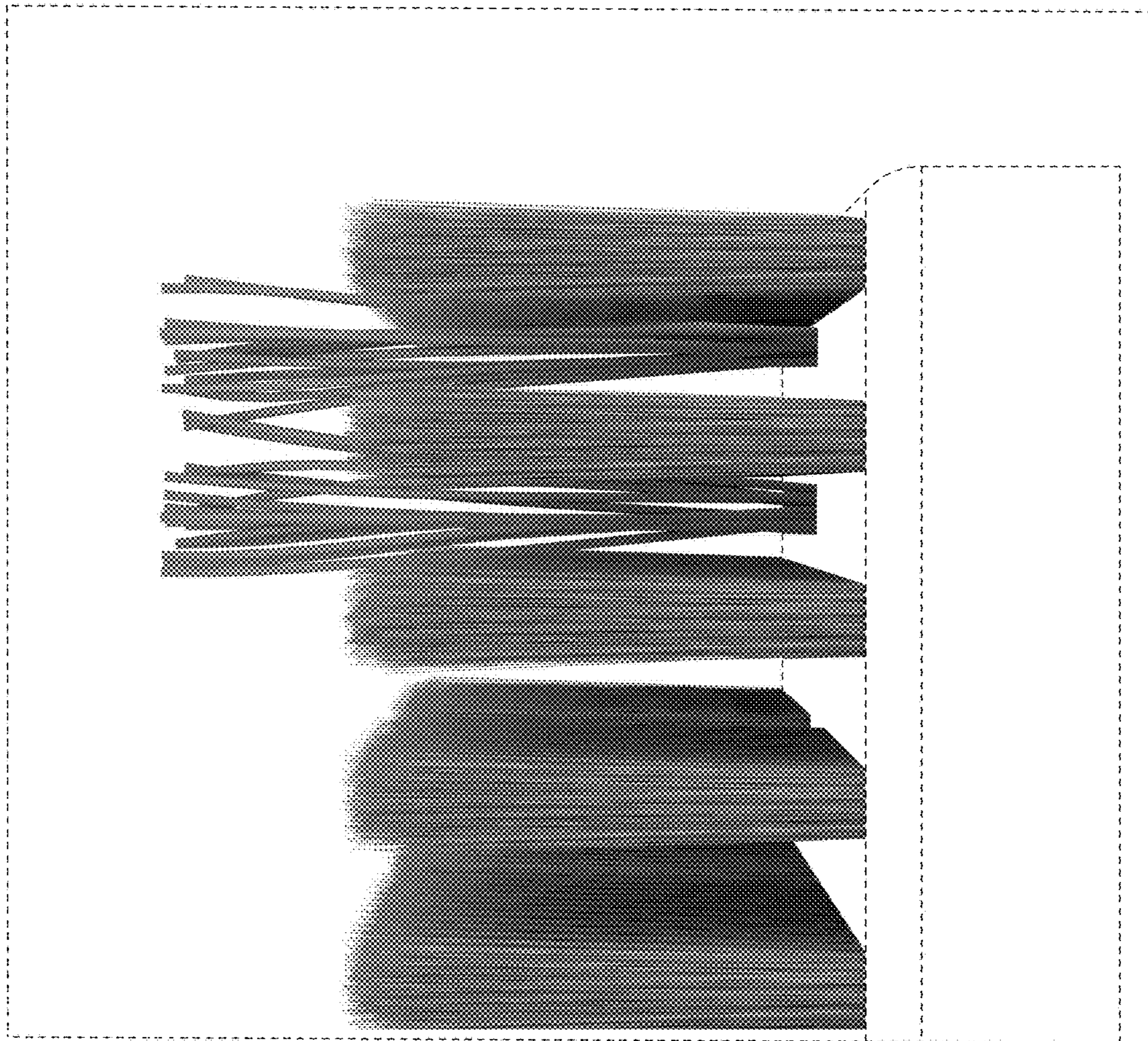

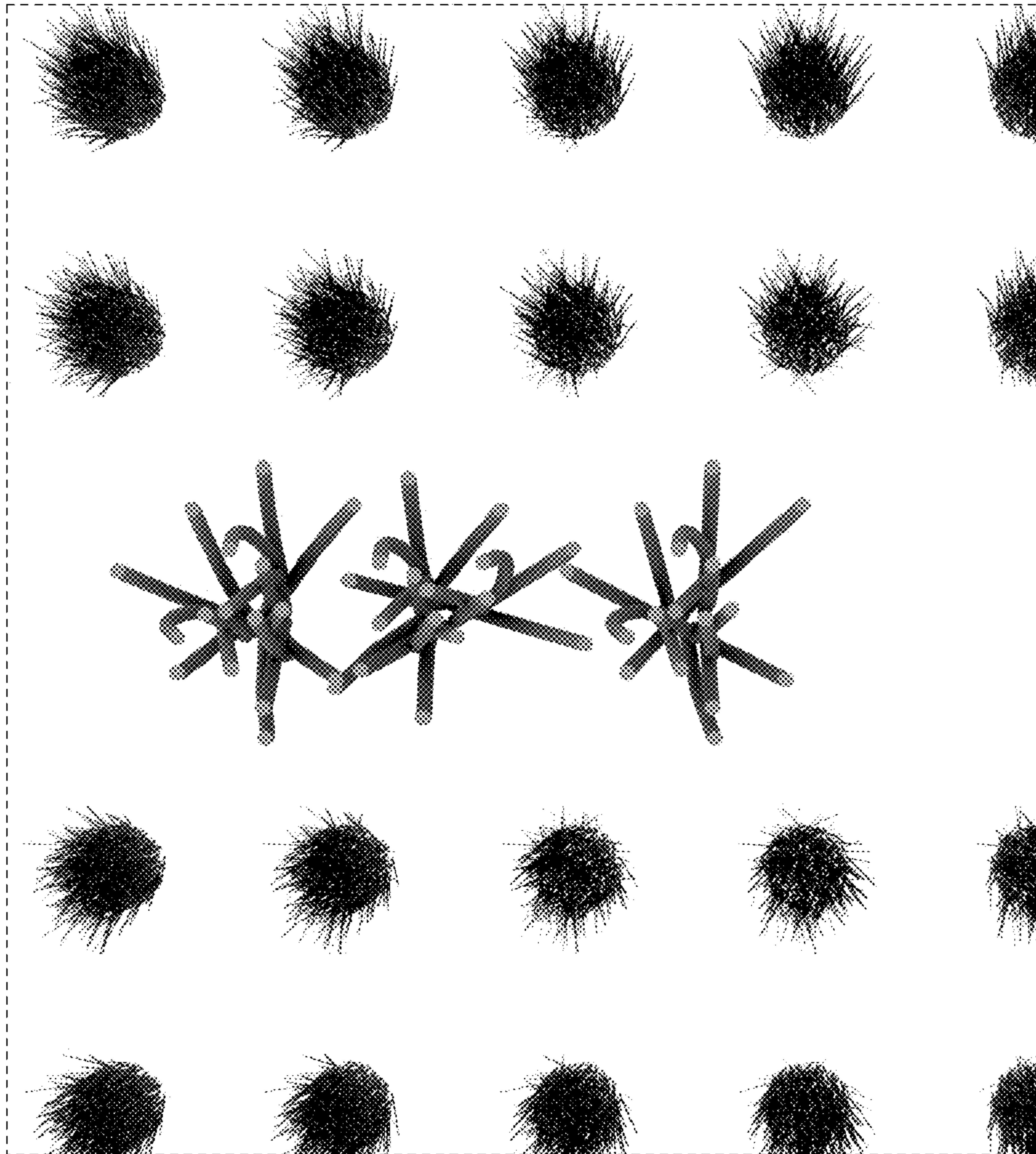
