(57) **CLAIM**

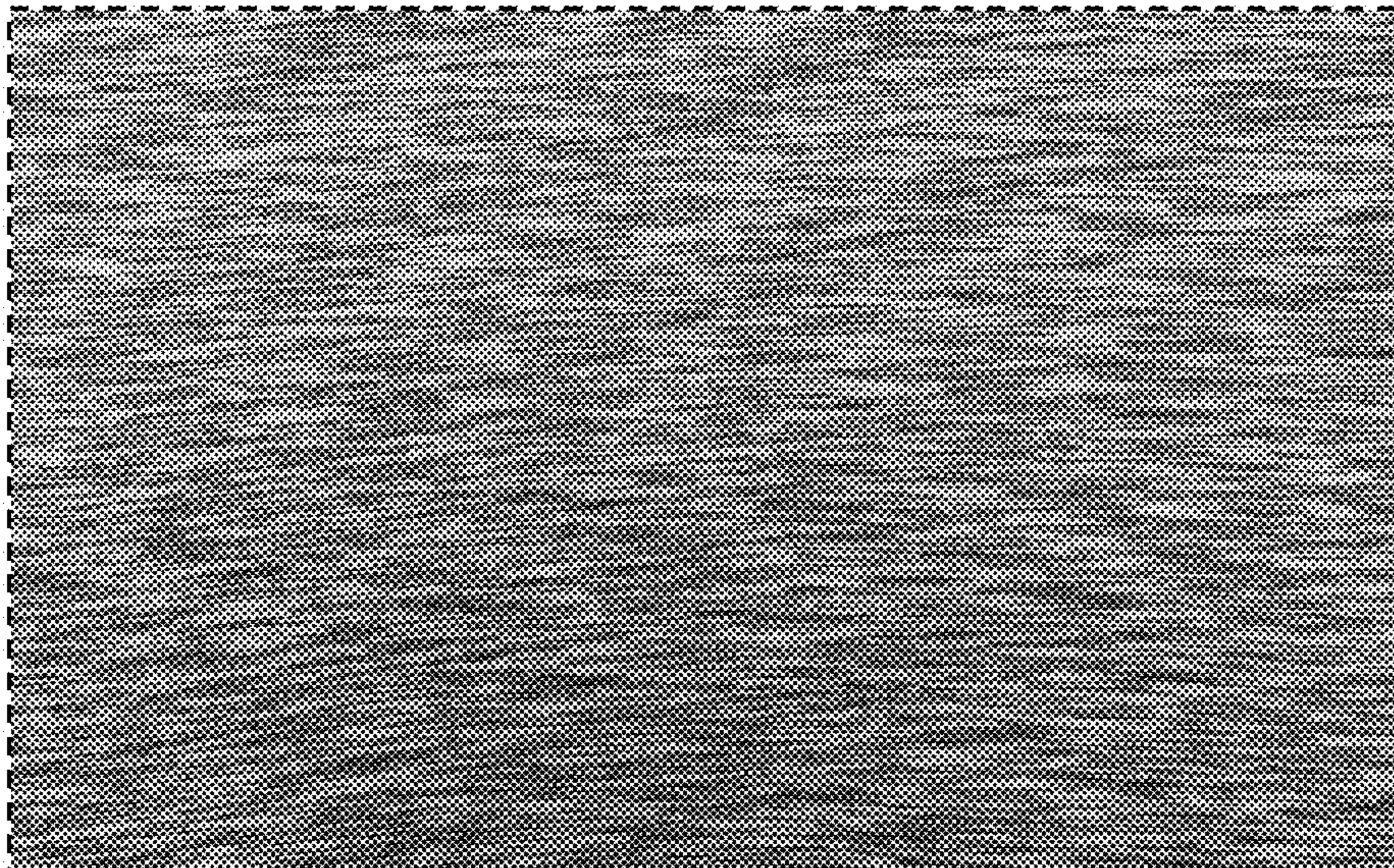
The ornamental design for a textile with camouflage pattern, as shown and described.
