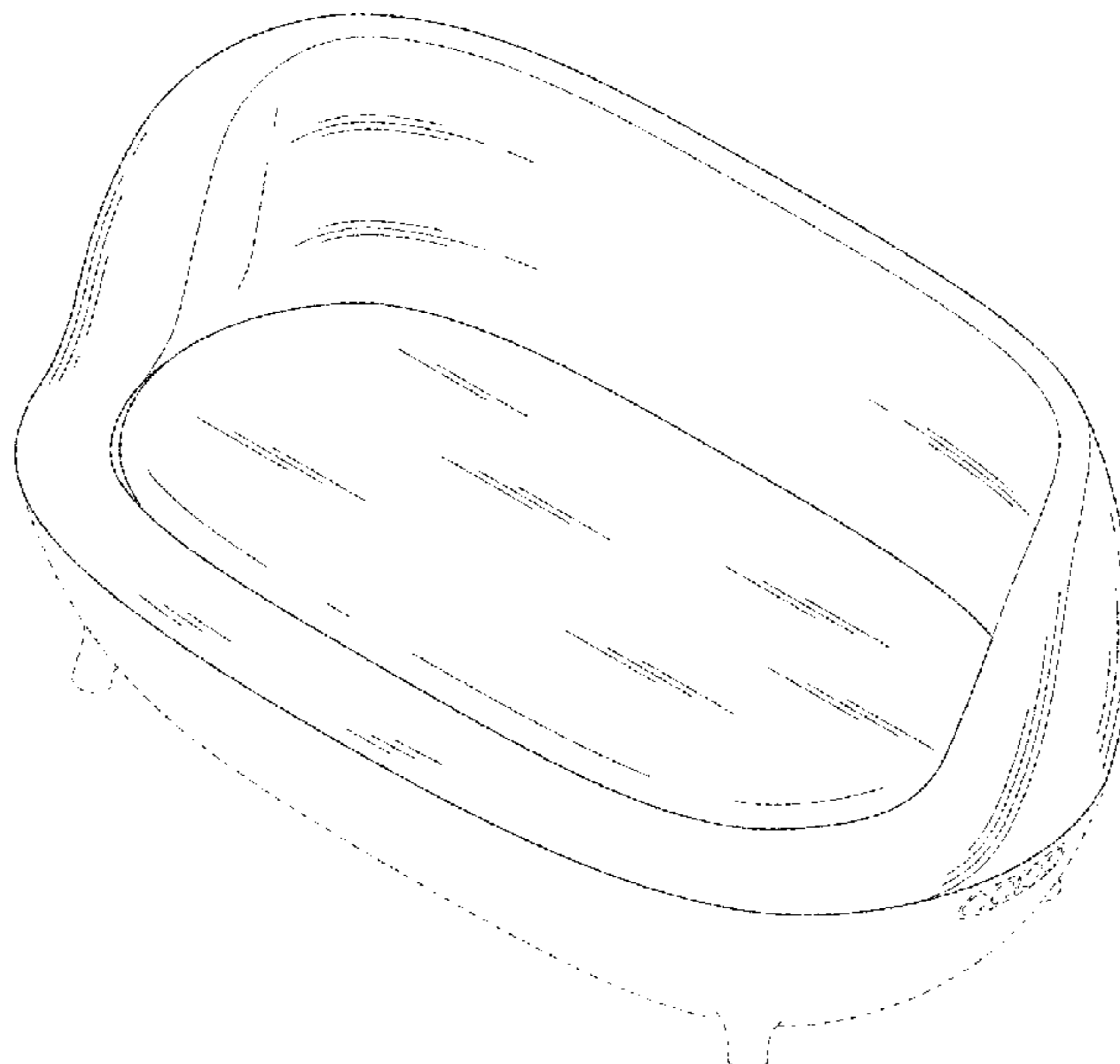

DESCRIPTION
FIG. 1 is a front perspective view of the infant sofa showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is another front perspective view thereof, but showing legs and a camera with lighting in broken lines.
The broken lines depict portions of the infant sofa that form no part of the claimed design.

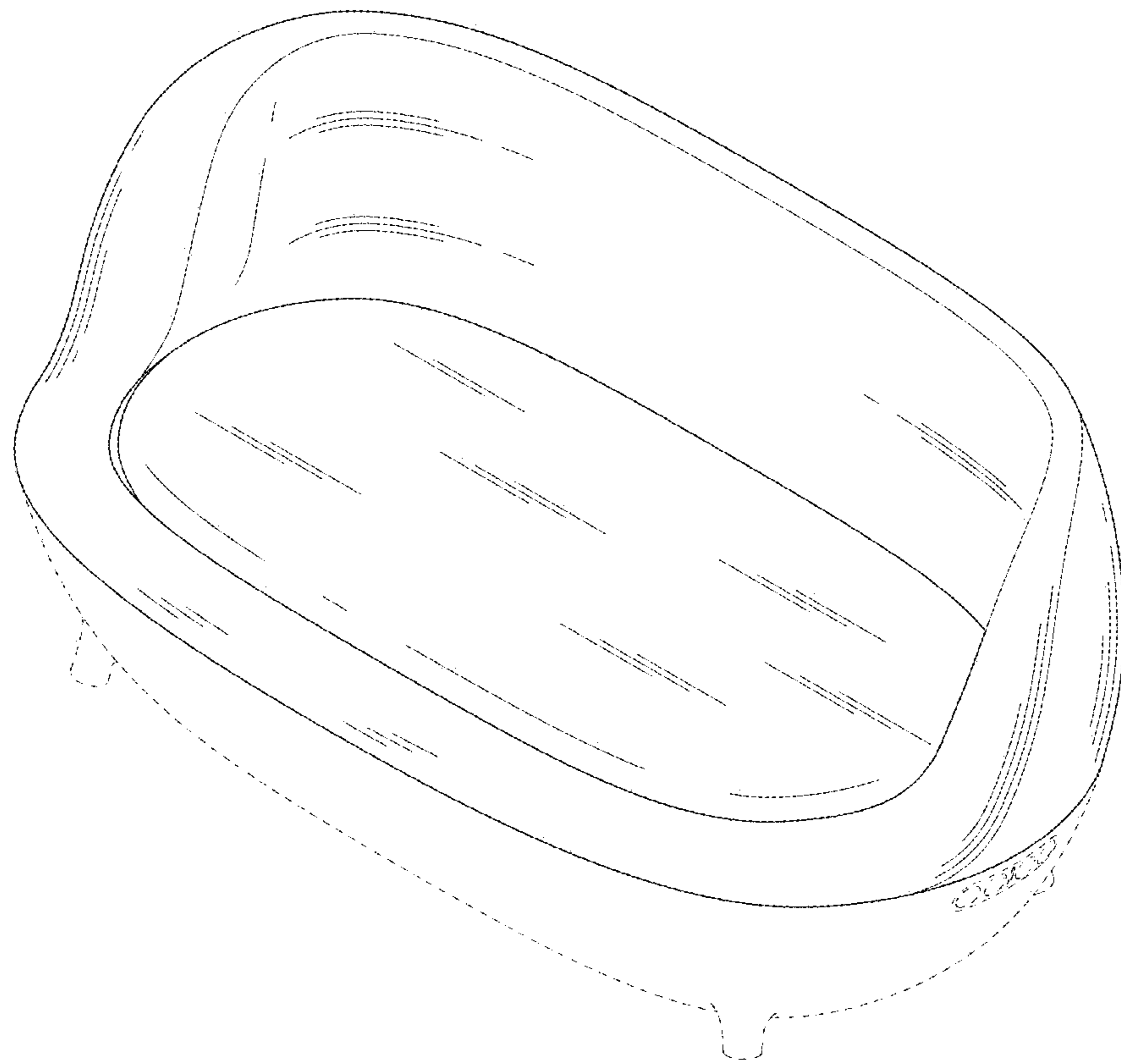

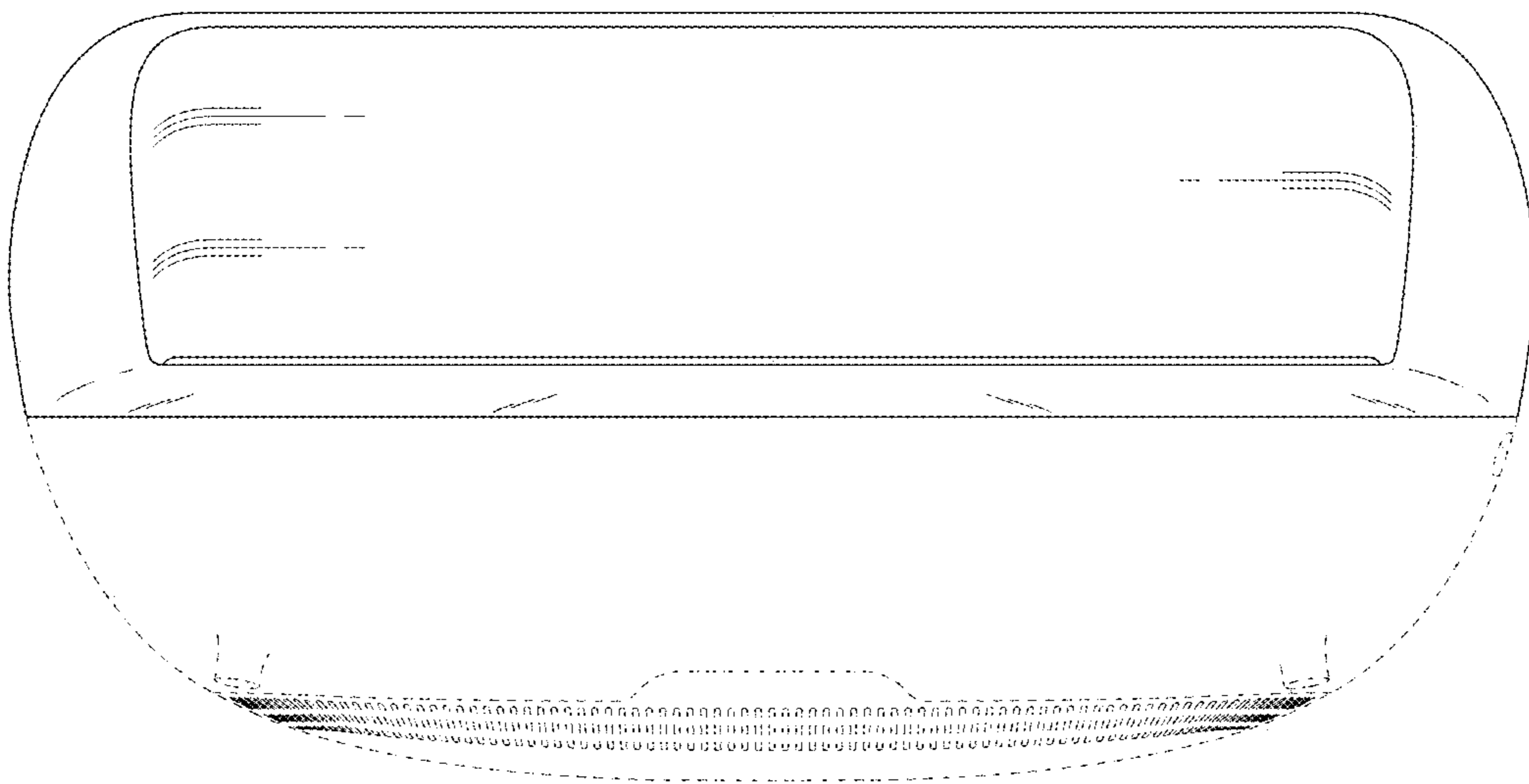

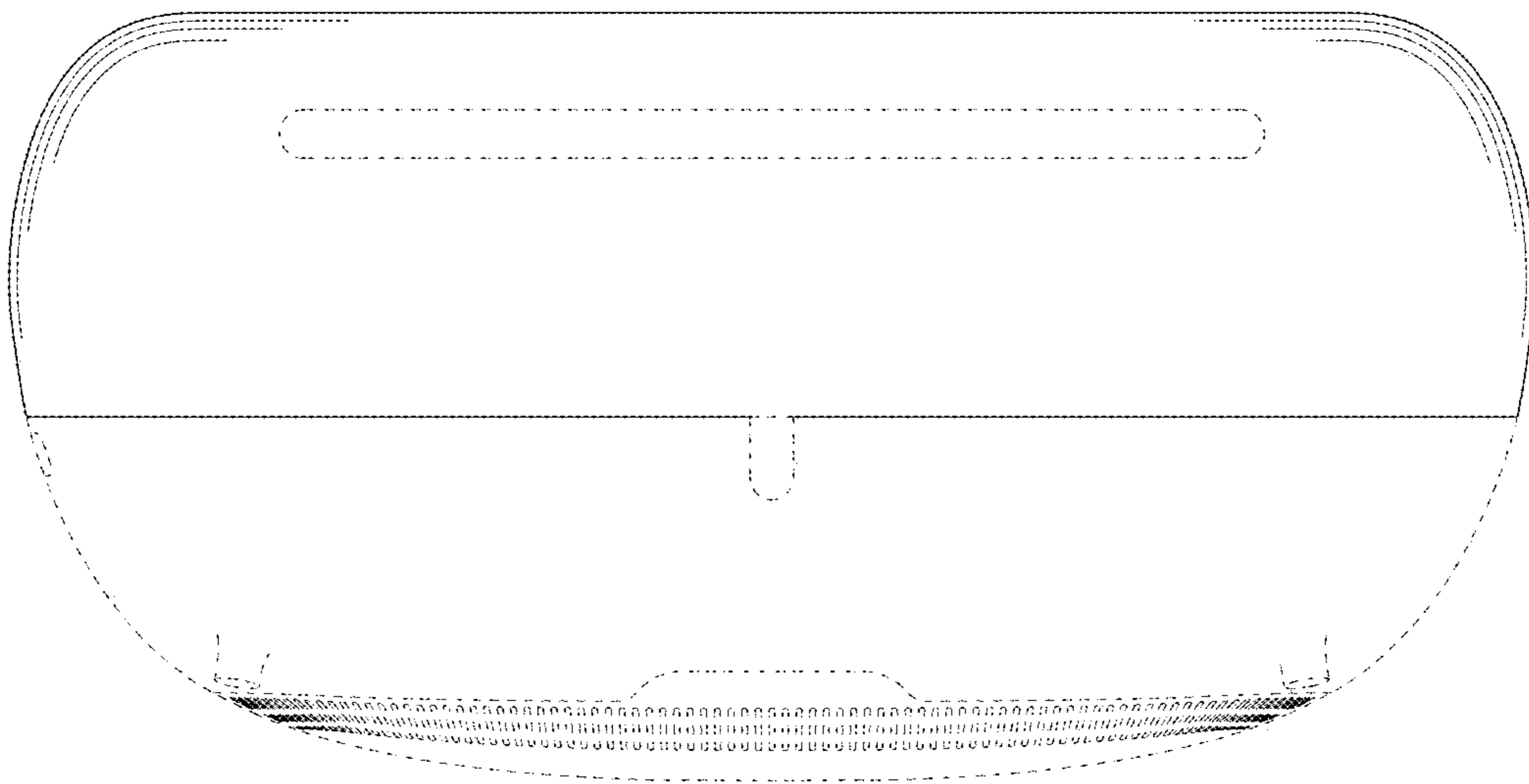

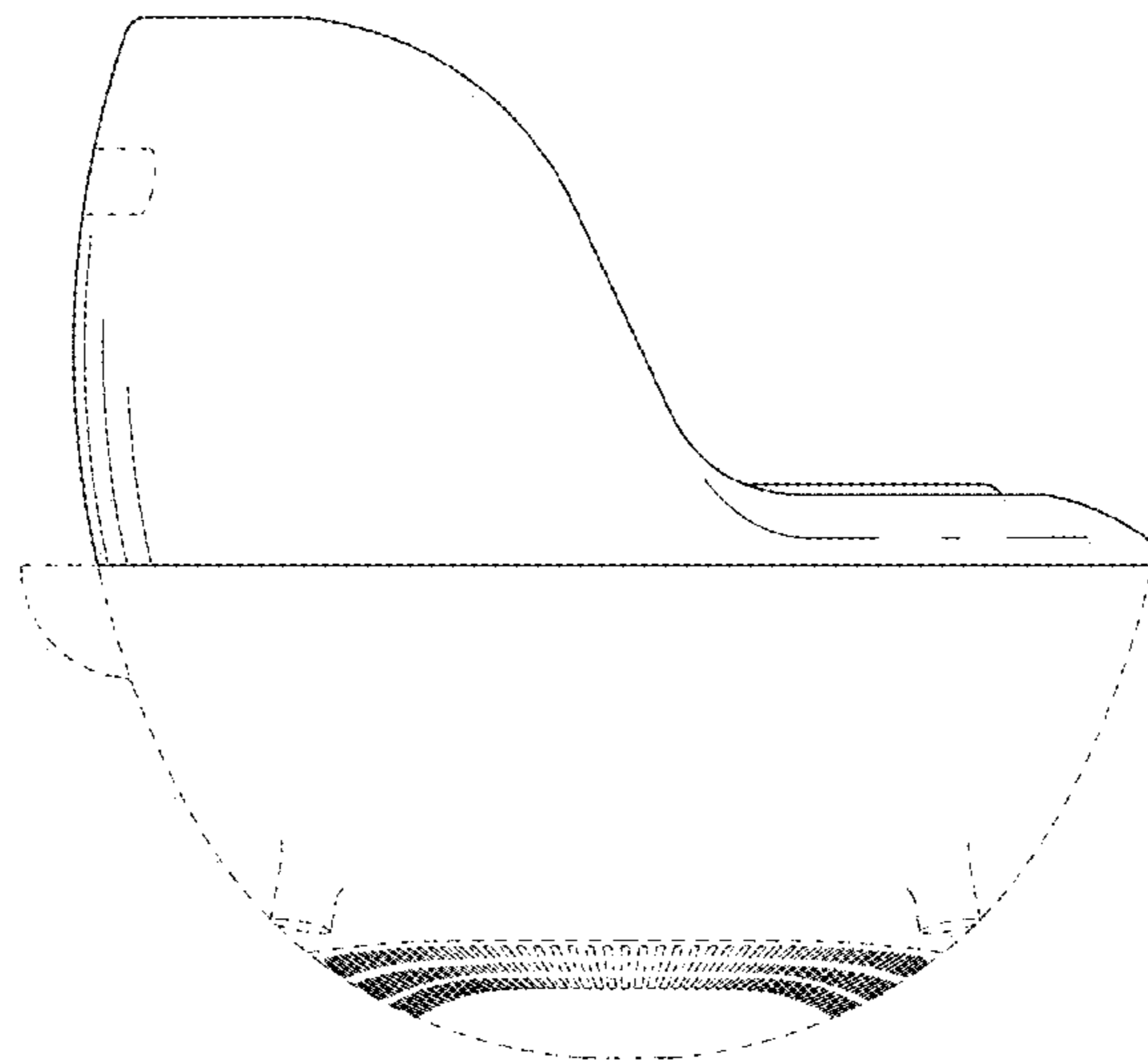

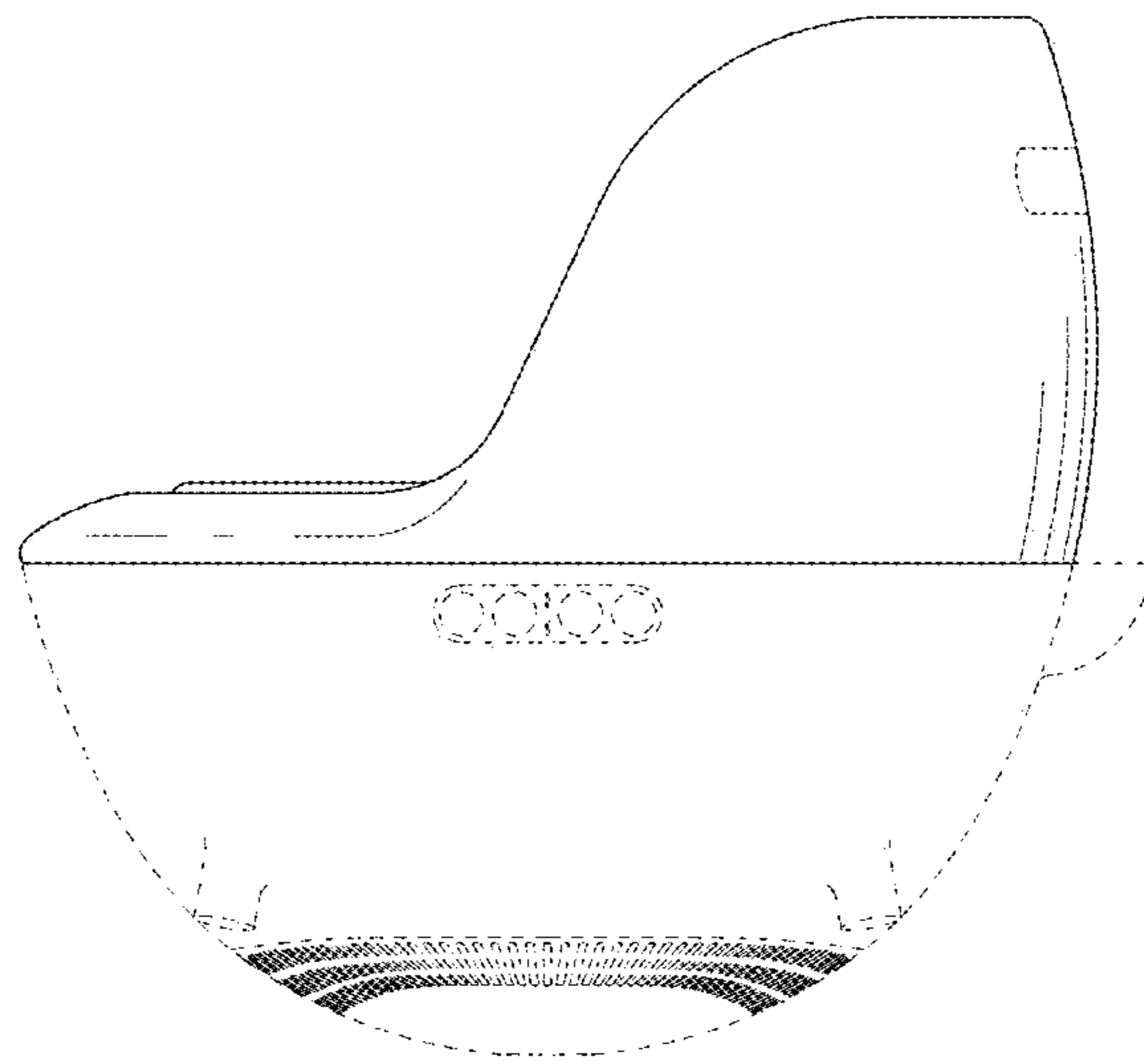

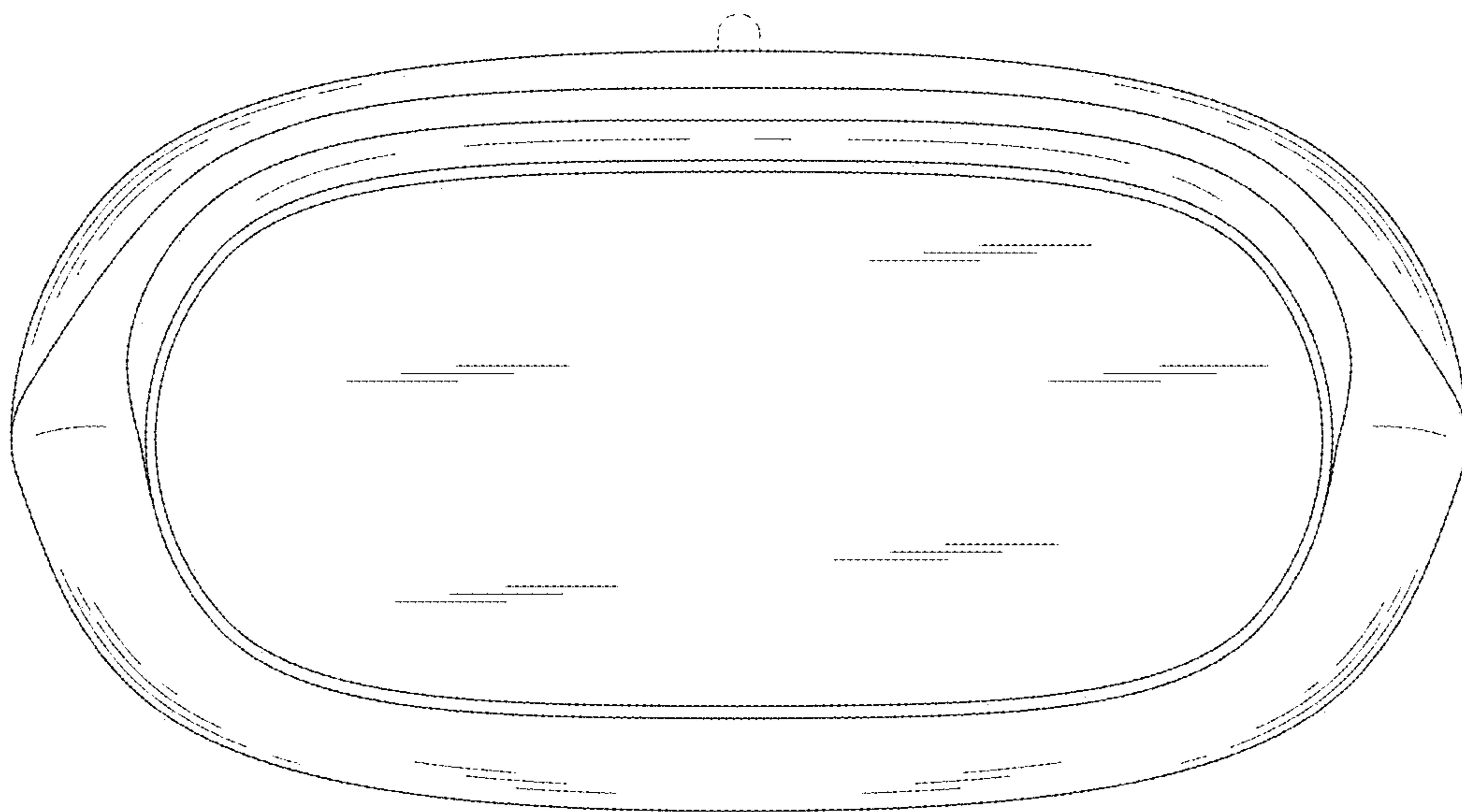

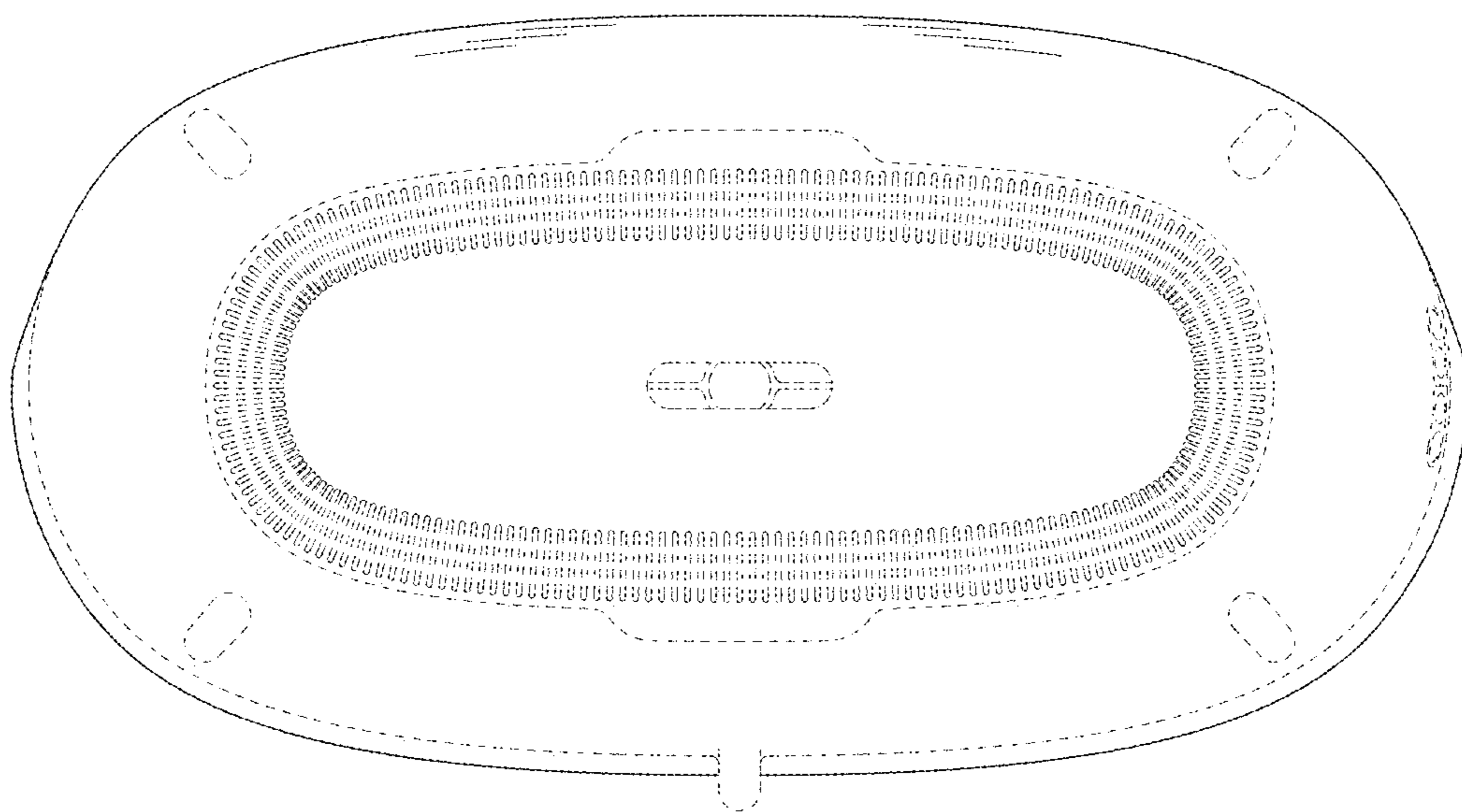
