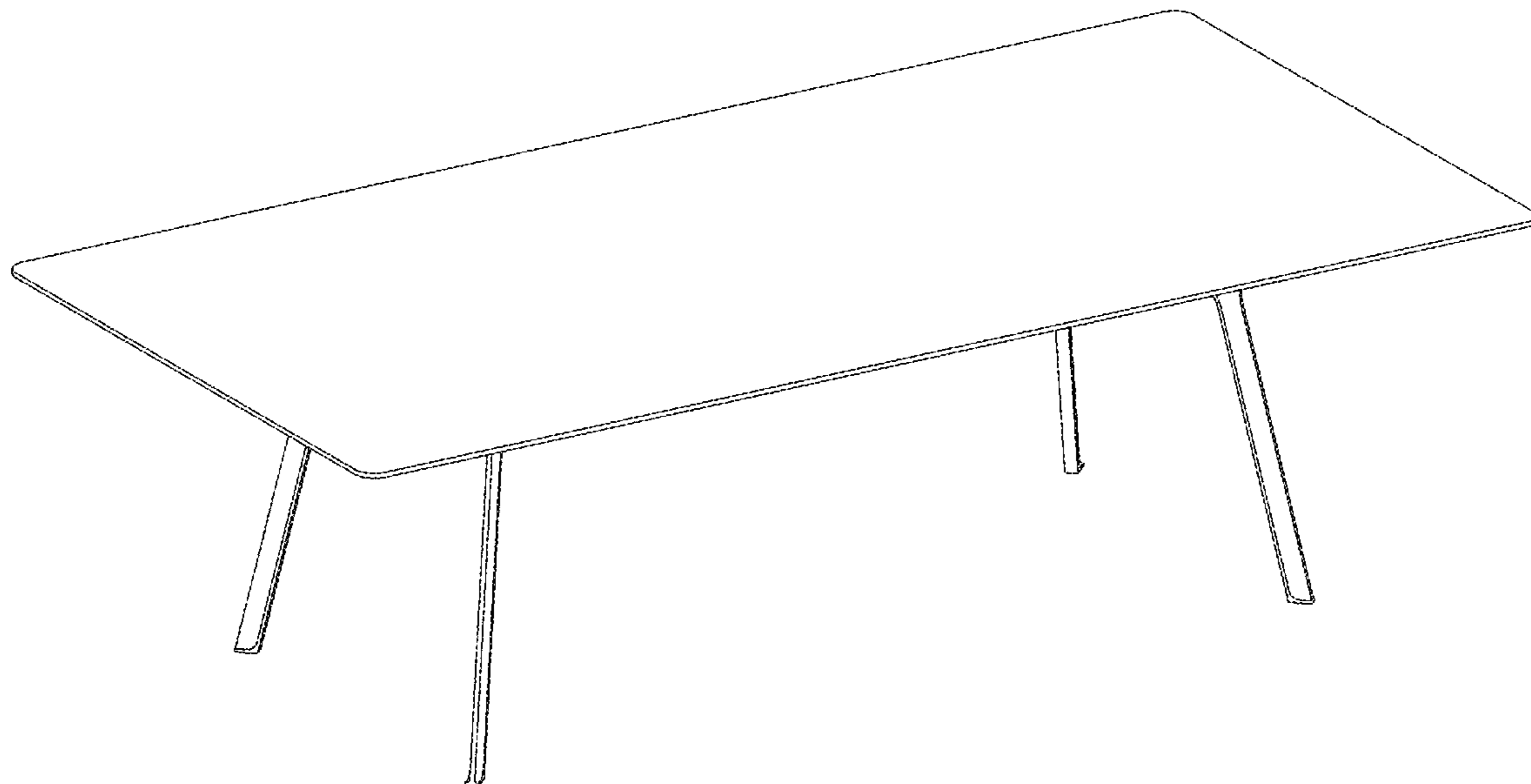
(57) **CLAIM**

We claim the ornamental design for a table, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a table, showing our new design;
FIG. 2 is a front view of the table thereof; the rear view is a mirror image of the front view of FIG. 2;
FIG. 3 is a right-side view of the table thereof; the left-side view is a mirror image of the right-side view of FIG. 3;
FIG. 4 is a top view of the table thereof; and,
FIG. 5 is a bottom view of the table thereof.
The broken lines are for purposes of illustrating boundaries and form no part of the claimed ornamental design.

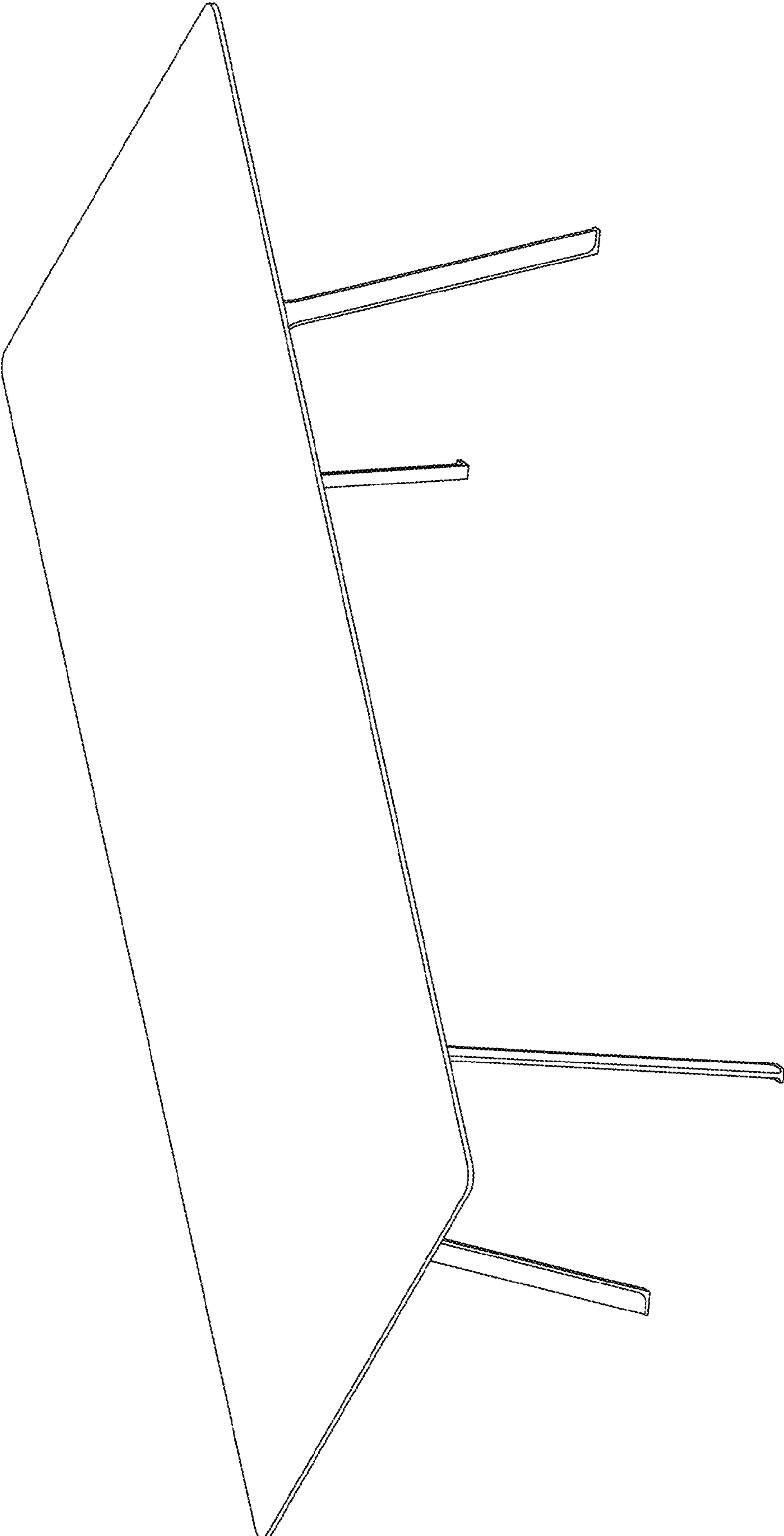

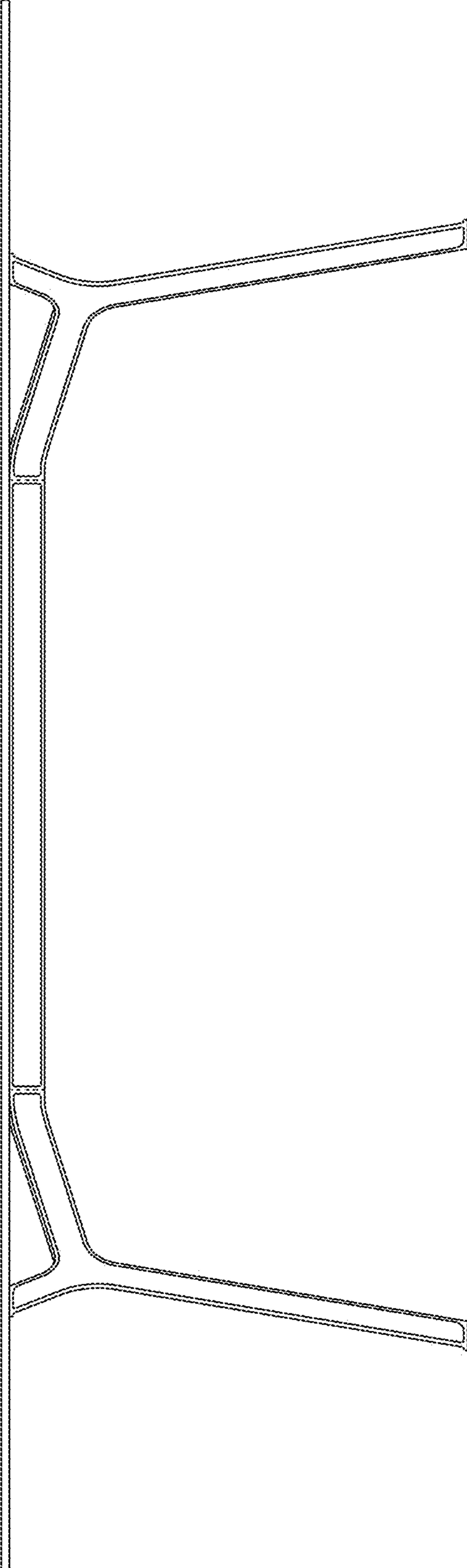

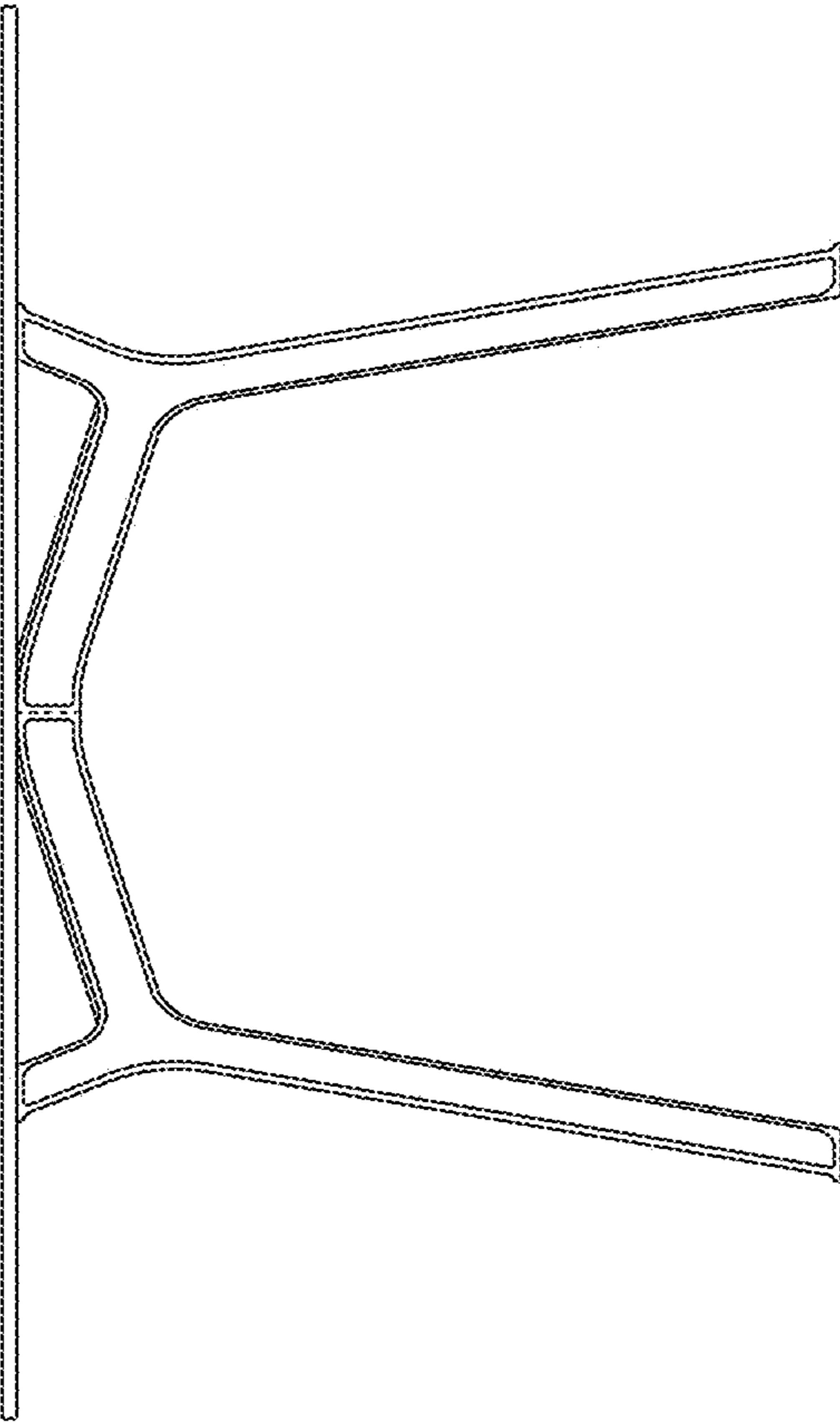

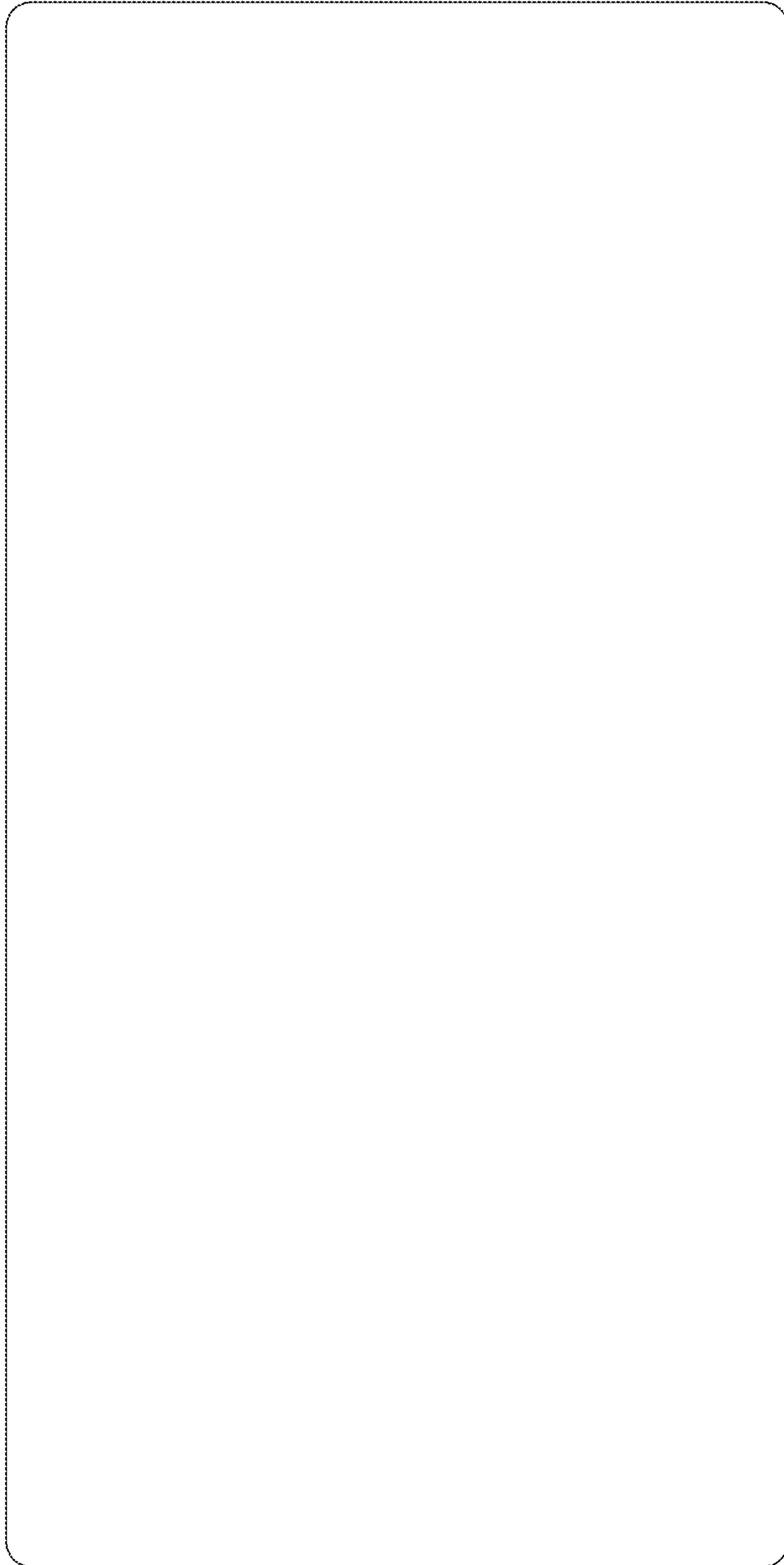

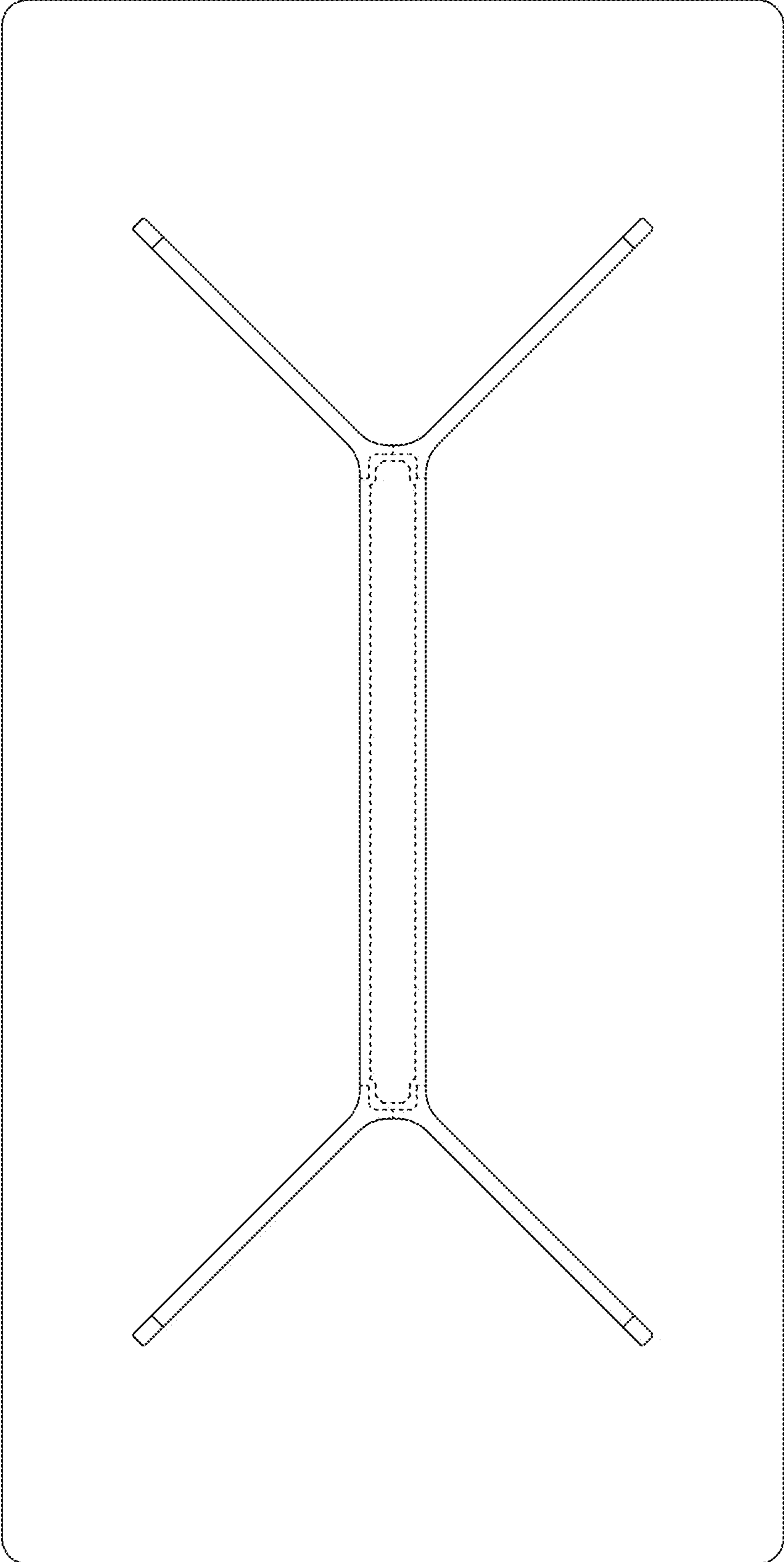
