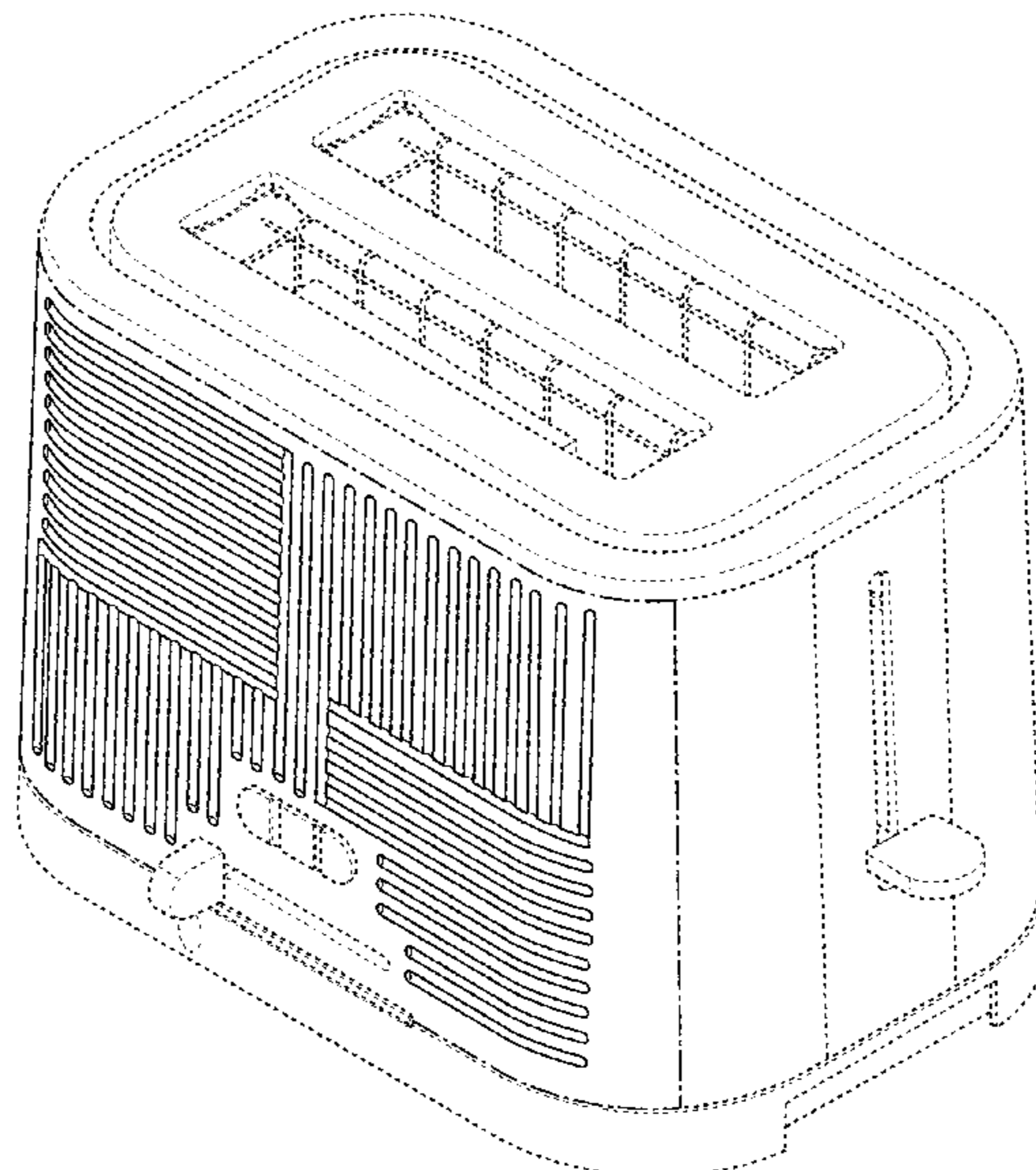
(57) **CLAIM**

The ornamental design for a toaster, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a toaster showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof; and,  
FIG. 5 is a top view thereof.  
The uneven length broken lines define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the toaster show features that form no part of the claimed design.

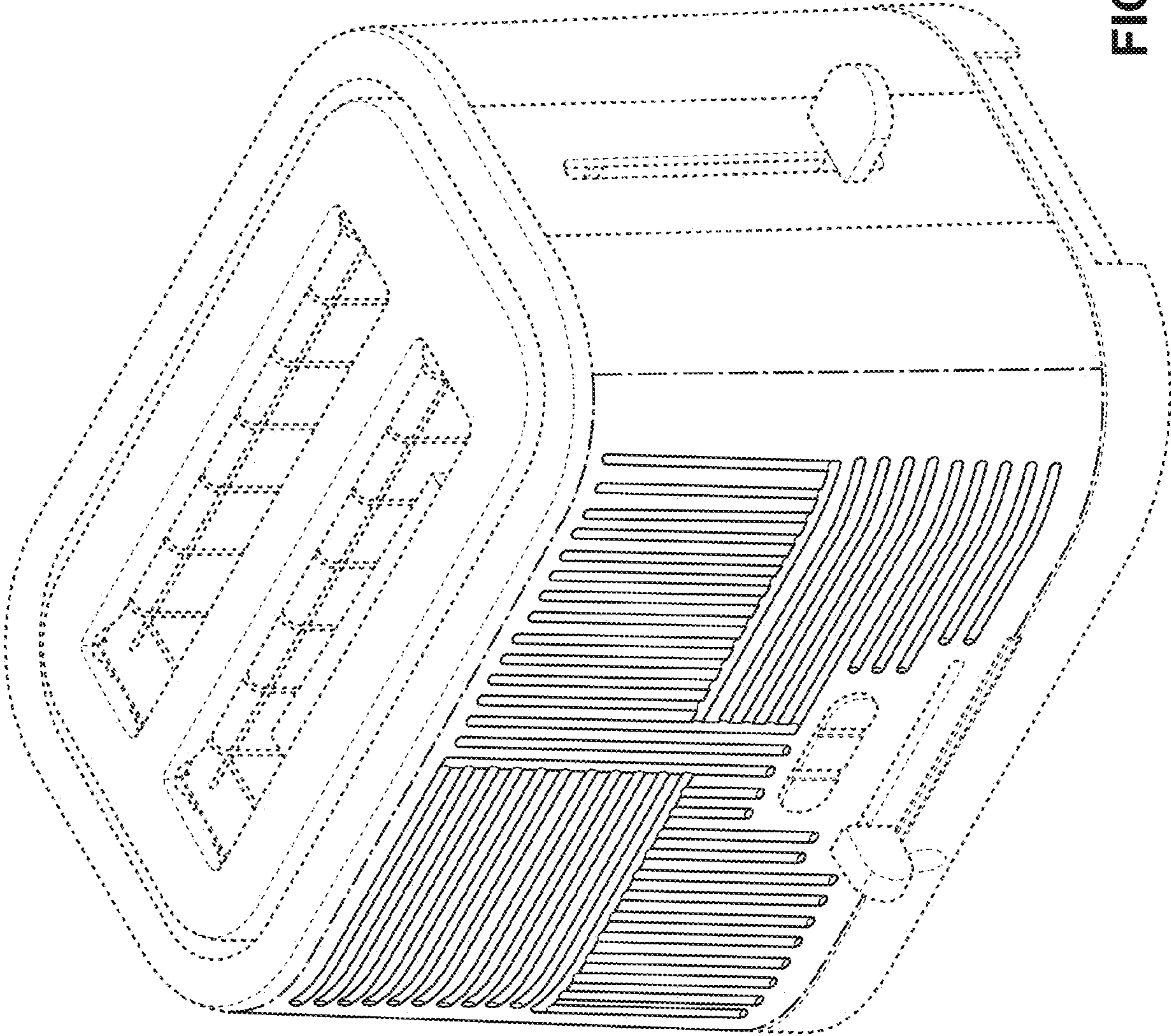

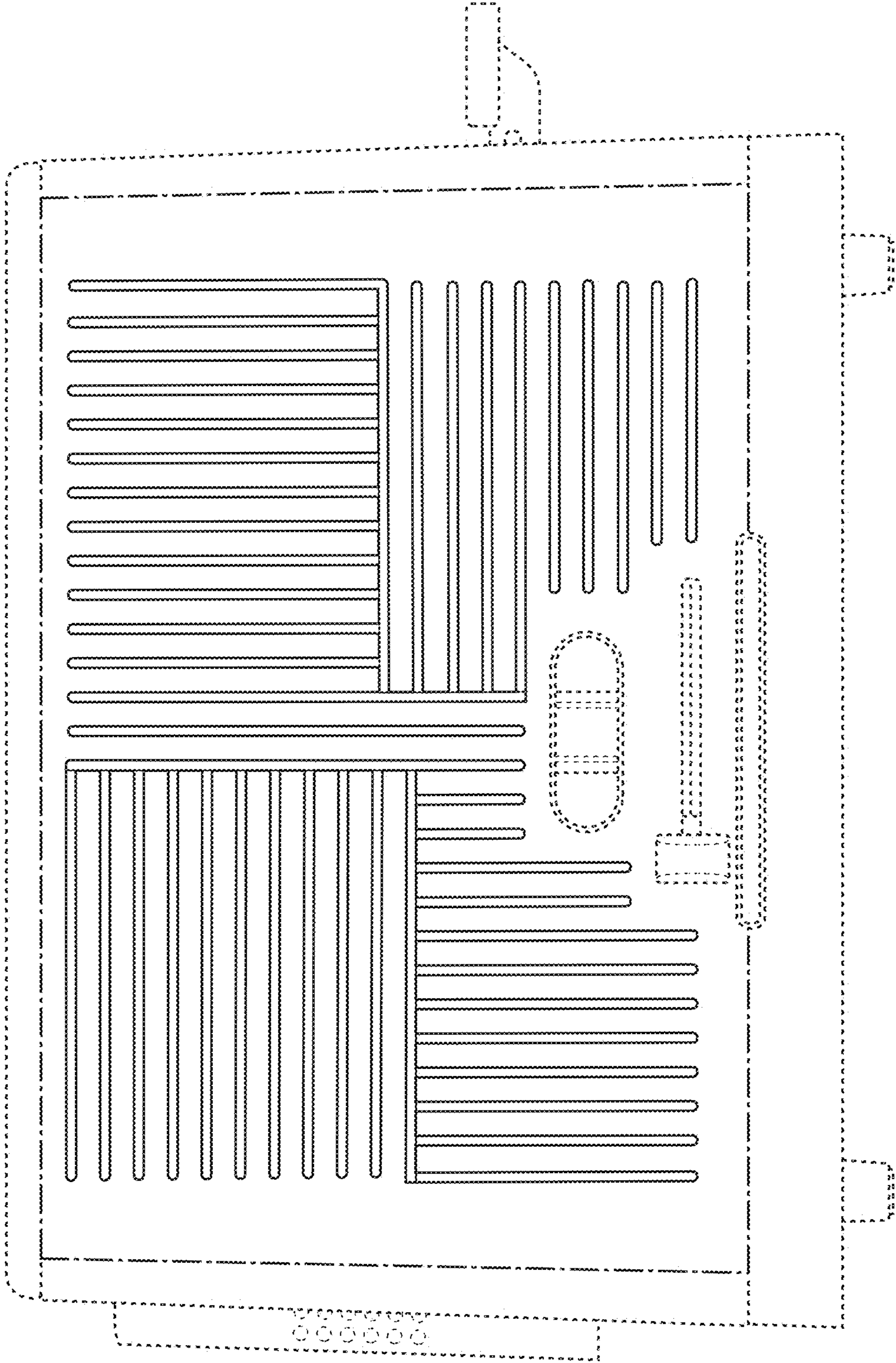

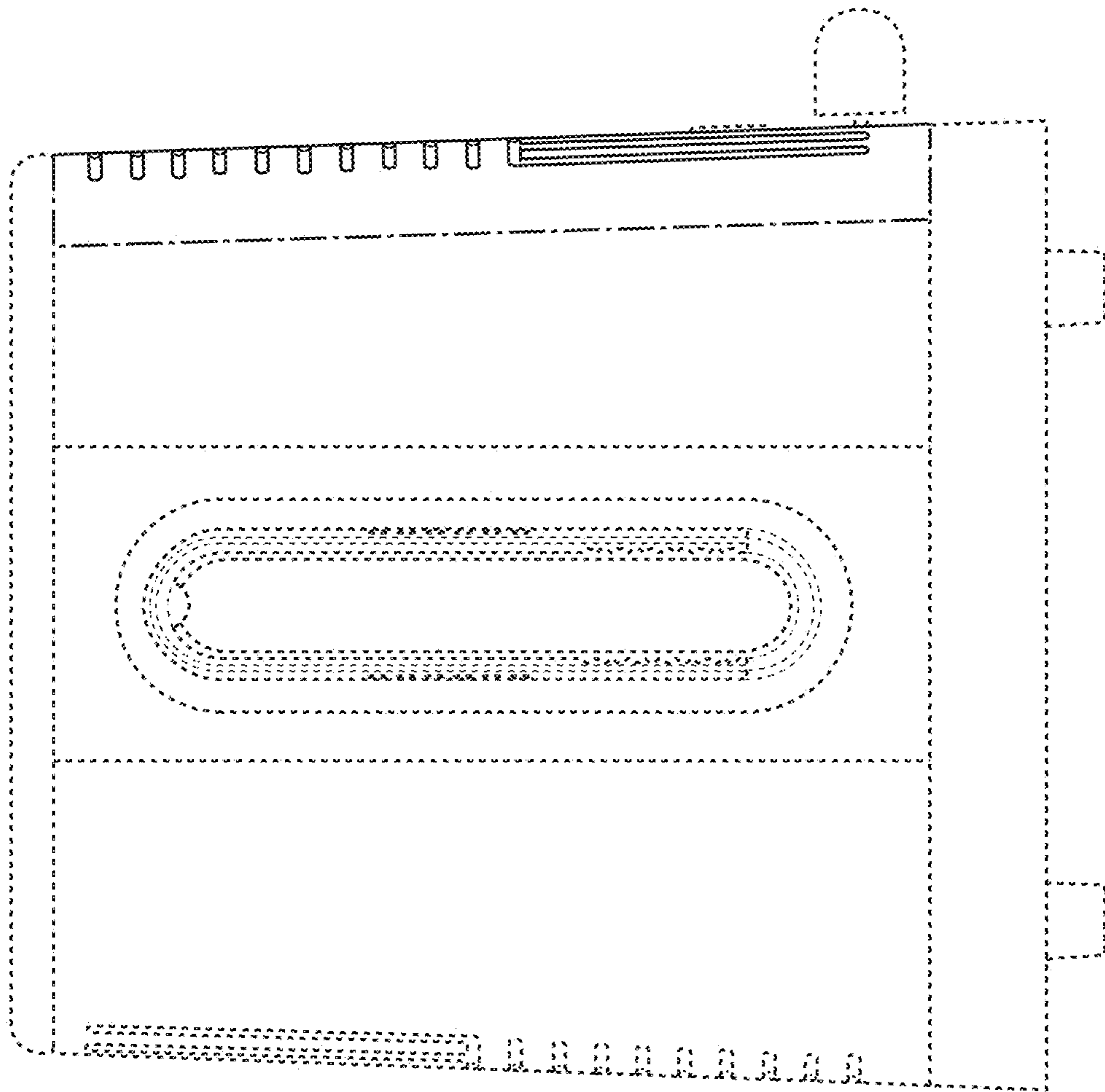

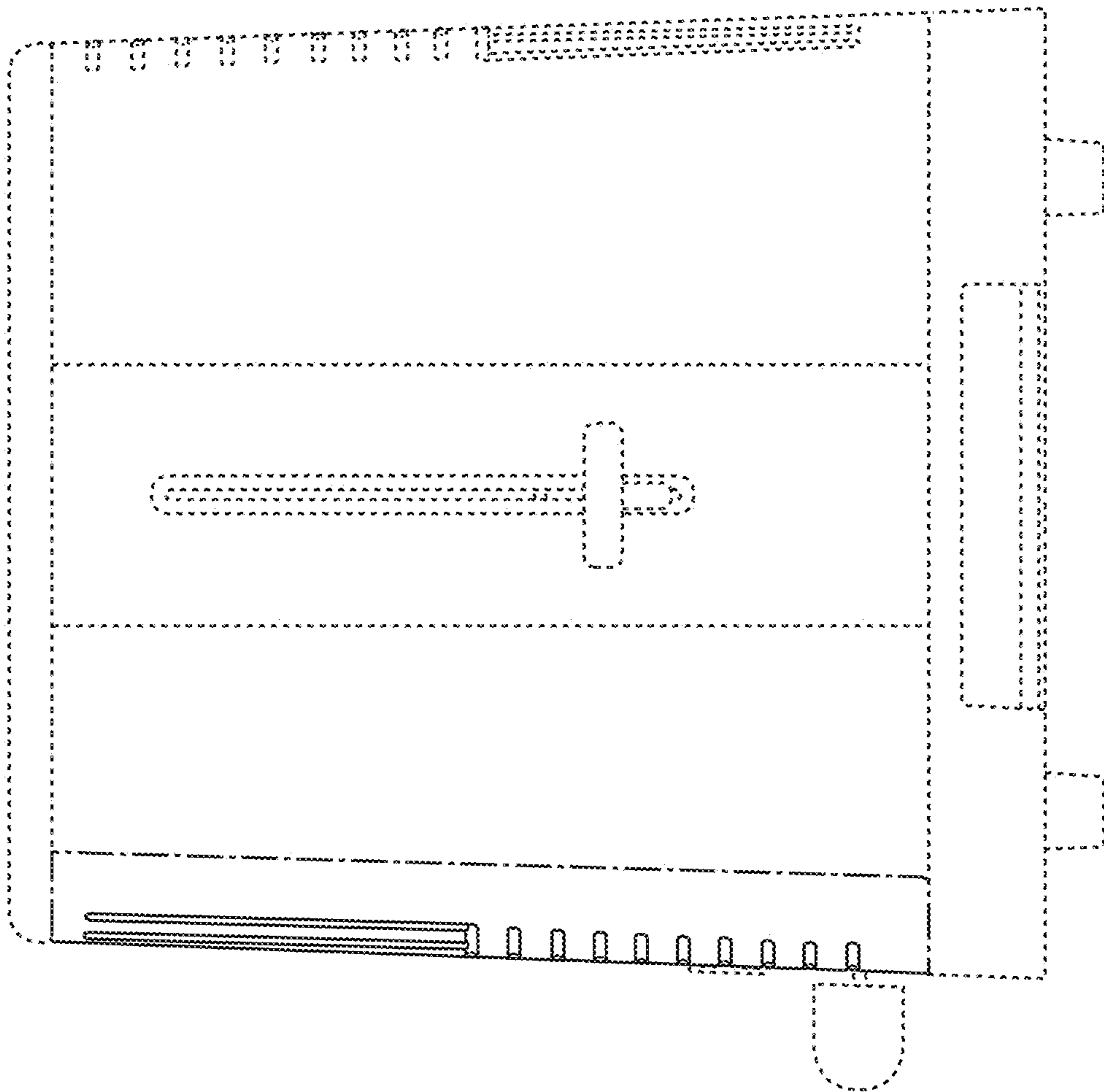

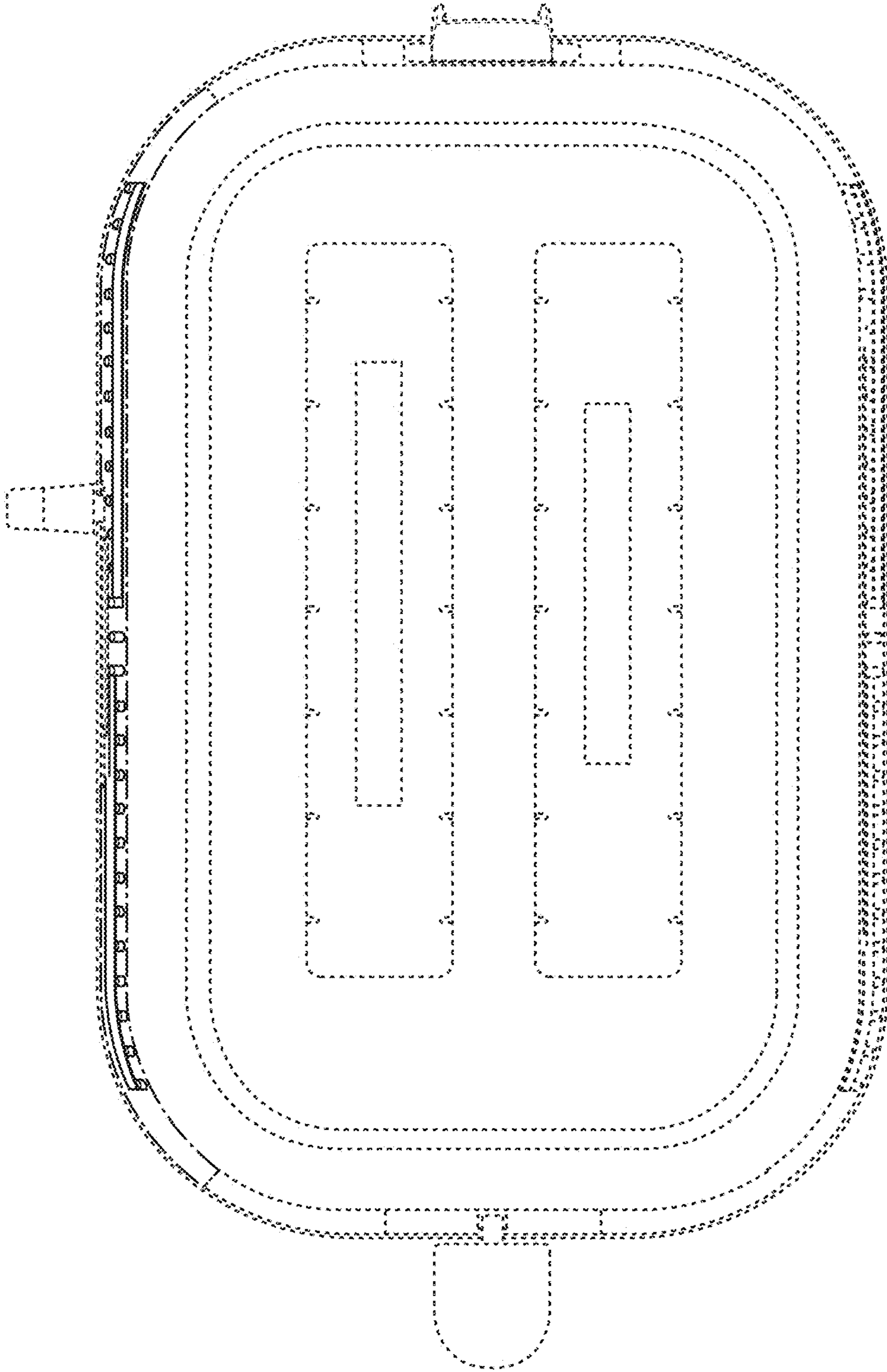
