**DESCRIPTION**

FIG. 1 is a top plan view of a two-handed file showing my new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a left side elevation view thereof, the right side elevation view being identical;  
FIG. 4 is a front elevation view thereof, the rear elevation view being identical;  
FIG. 5 is a top perspective view thereof; and,  
FIG. 6 is a bottom perspective view thereof.

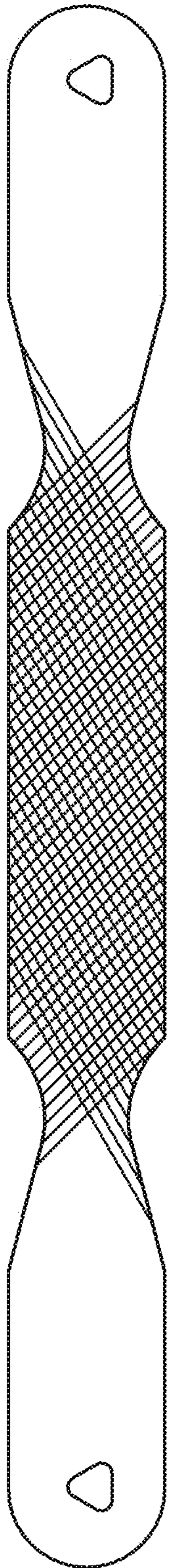

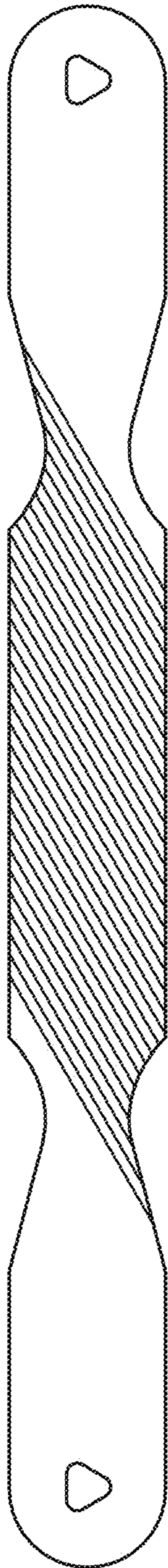

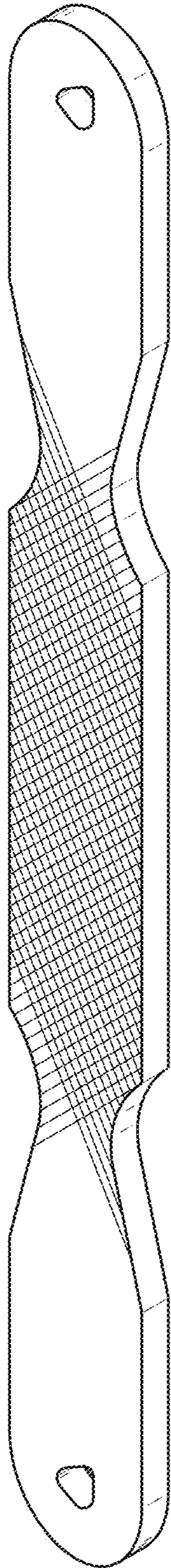

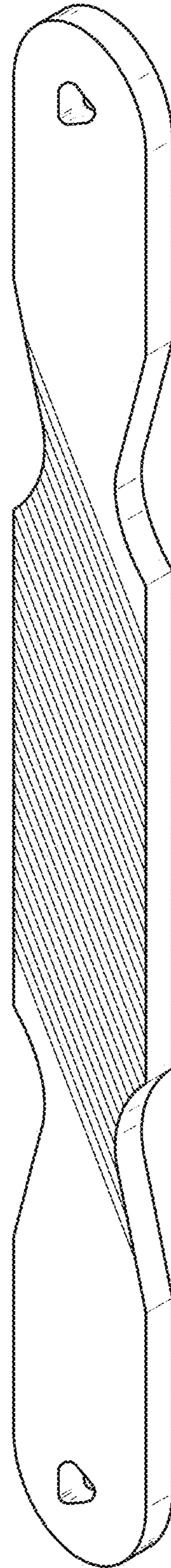
