(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a bottle showing my new design; the rear, right side, and left side views being identical thereto;

FIG. 2 is a top view thereof with details of the bottom portion omitted for clarity purposes;

FIG. 3 is bottom view thereof with details of the spout omitted for clarity purposes; and,

FIG. 4 is a perspective view thereof.

The inner surfaces of the bottle form no part of the claimed design.

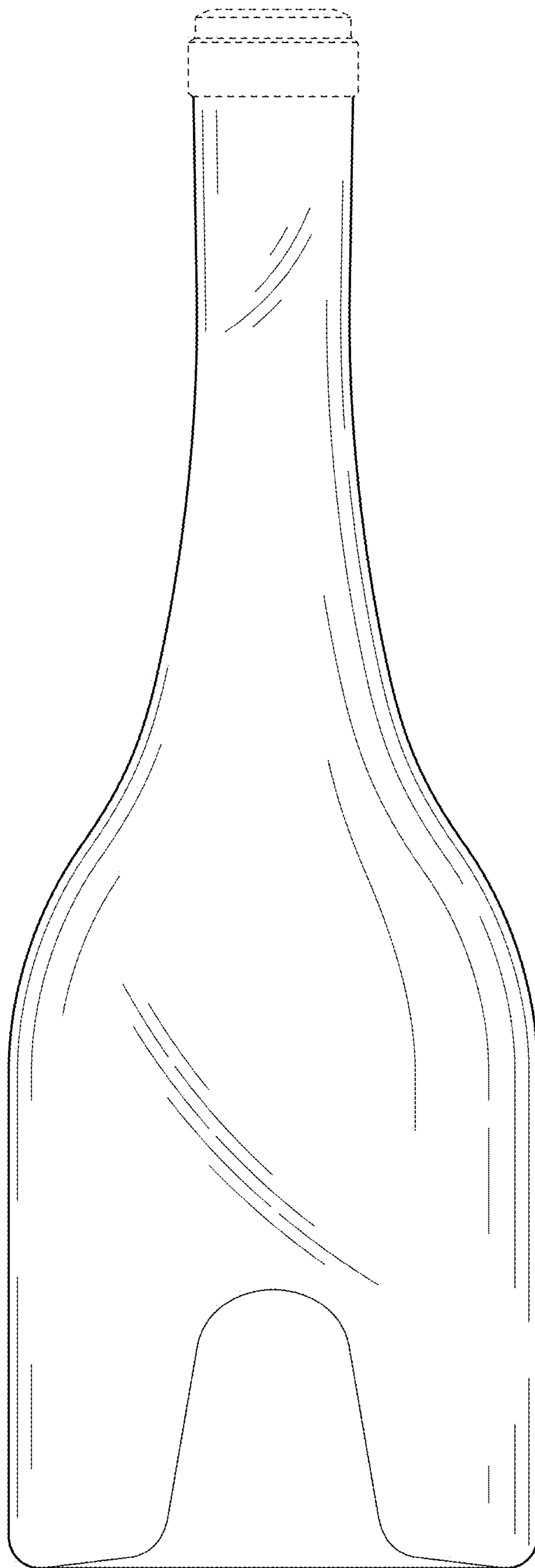

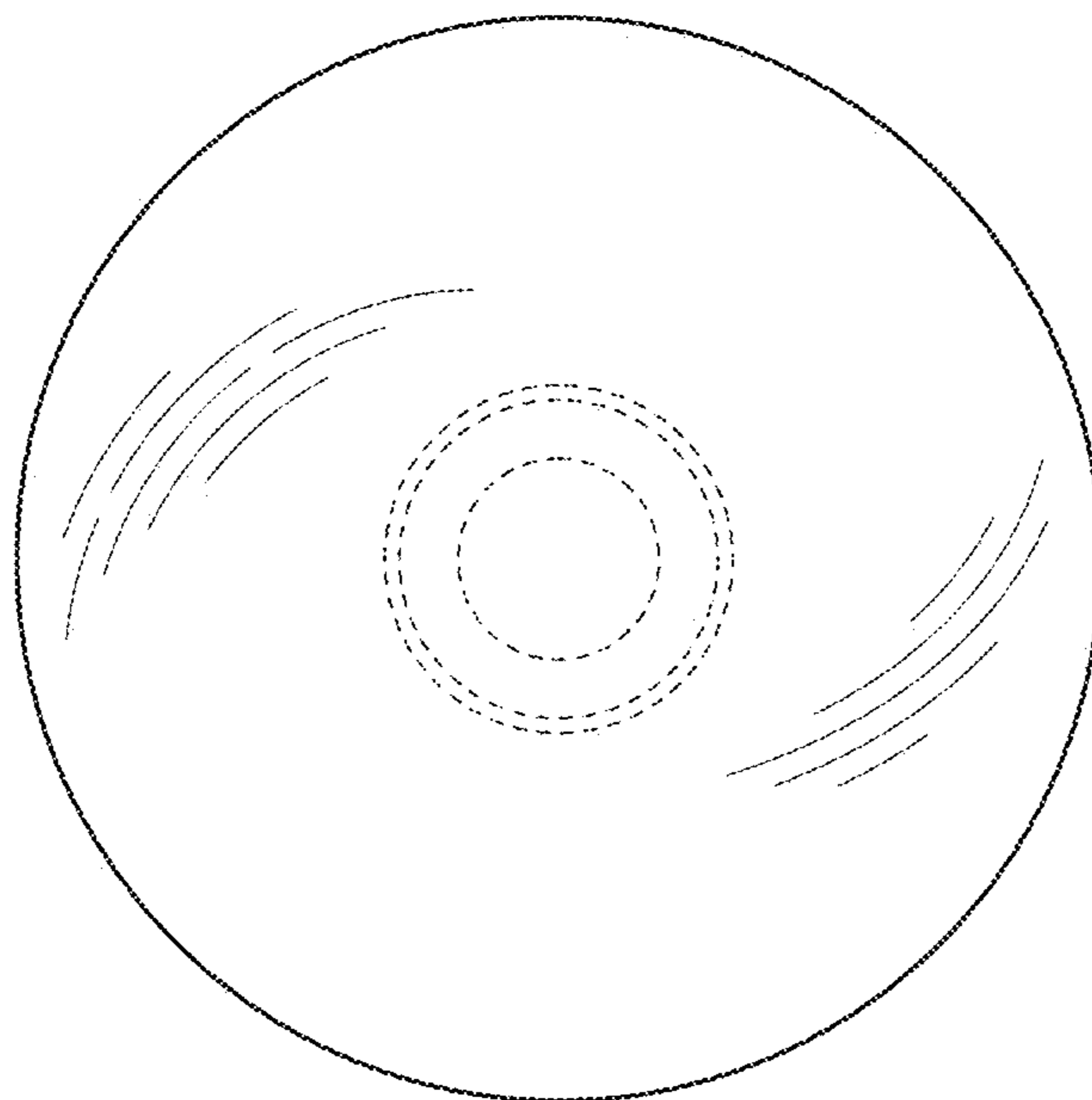

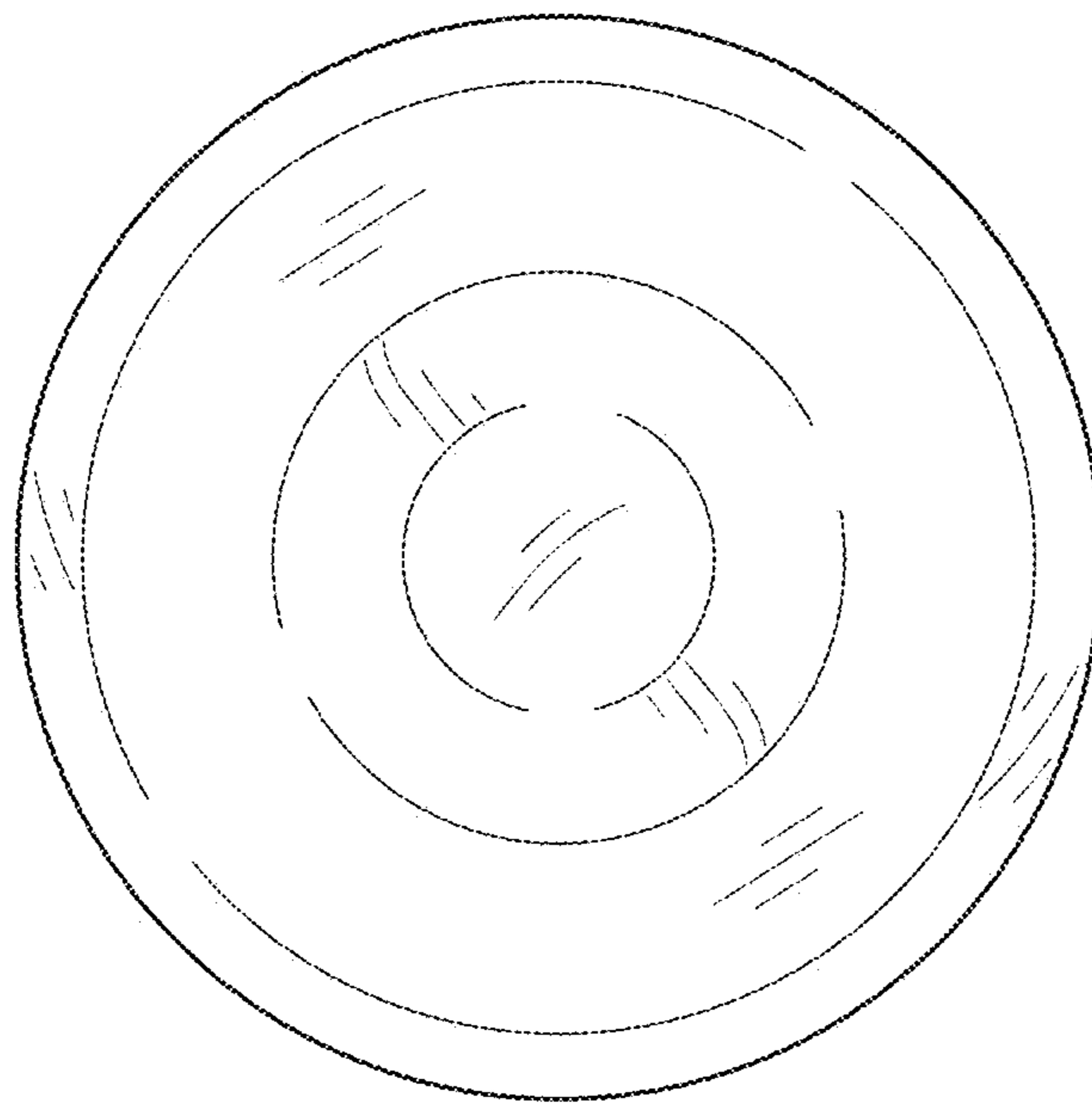

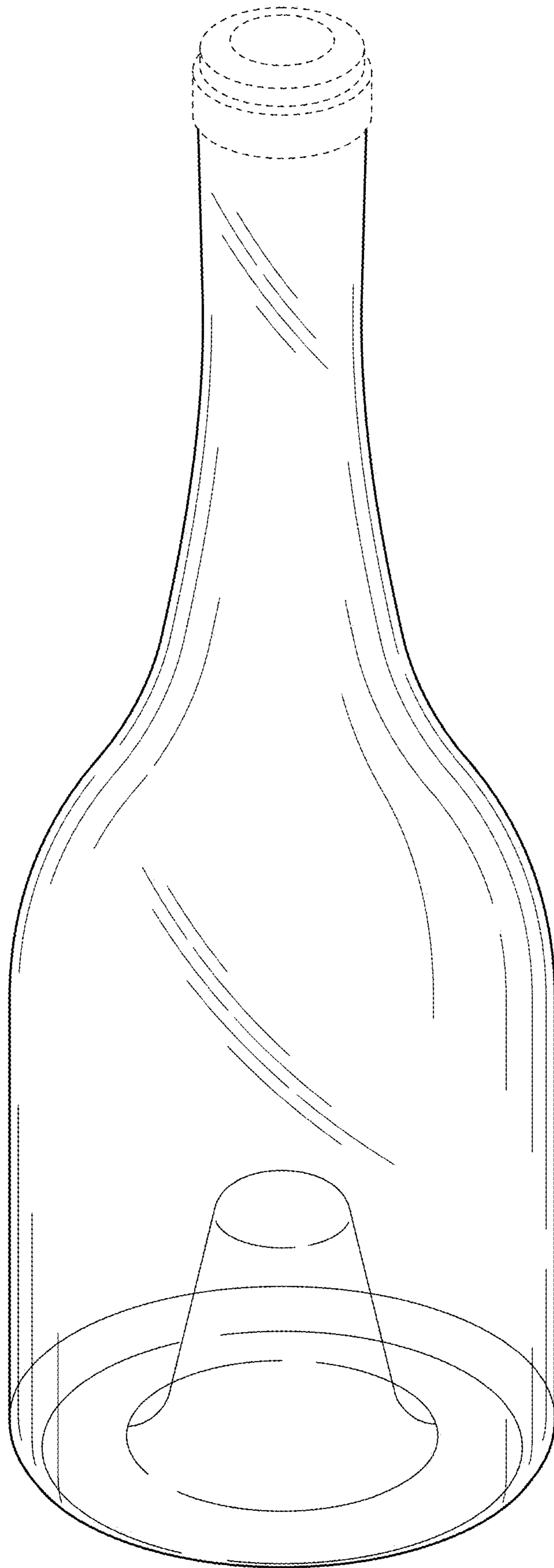
