(57) **CLAIM**

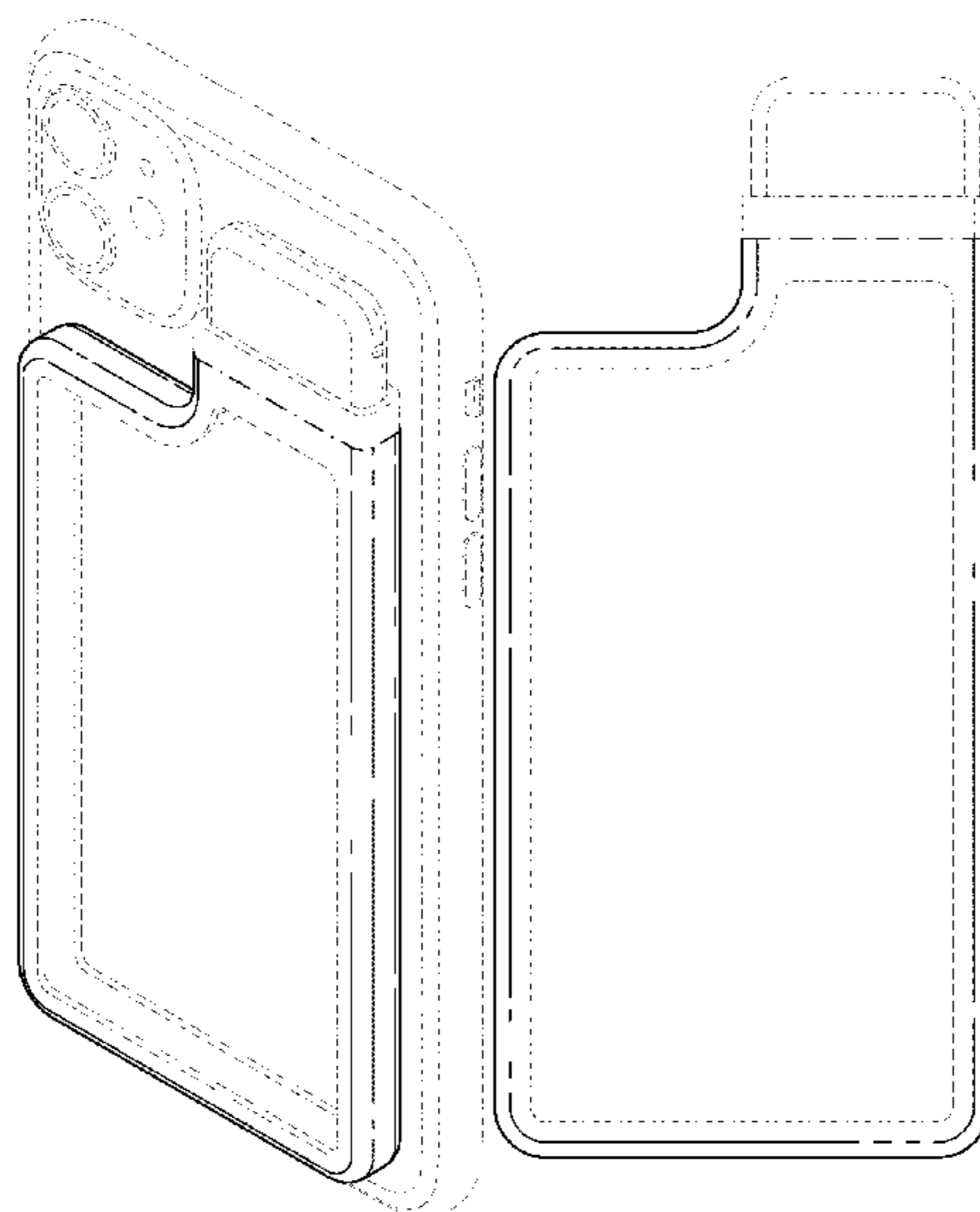
The ornamental design for a mobile phone-attachable dispensing container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a mobile phone-attachable dispensing container showing my new design; FIG. 2 is another top front, perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The broken lines in the figures show portions of the mobile phone-attachable dispensing container and/or environmental subject matter that form no part of the claimed design. The dot-dash-dot lines represent boundary lines and form no part of the claimed design.

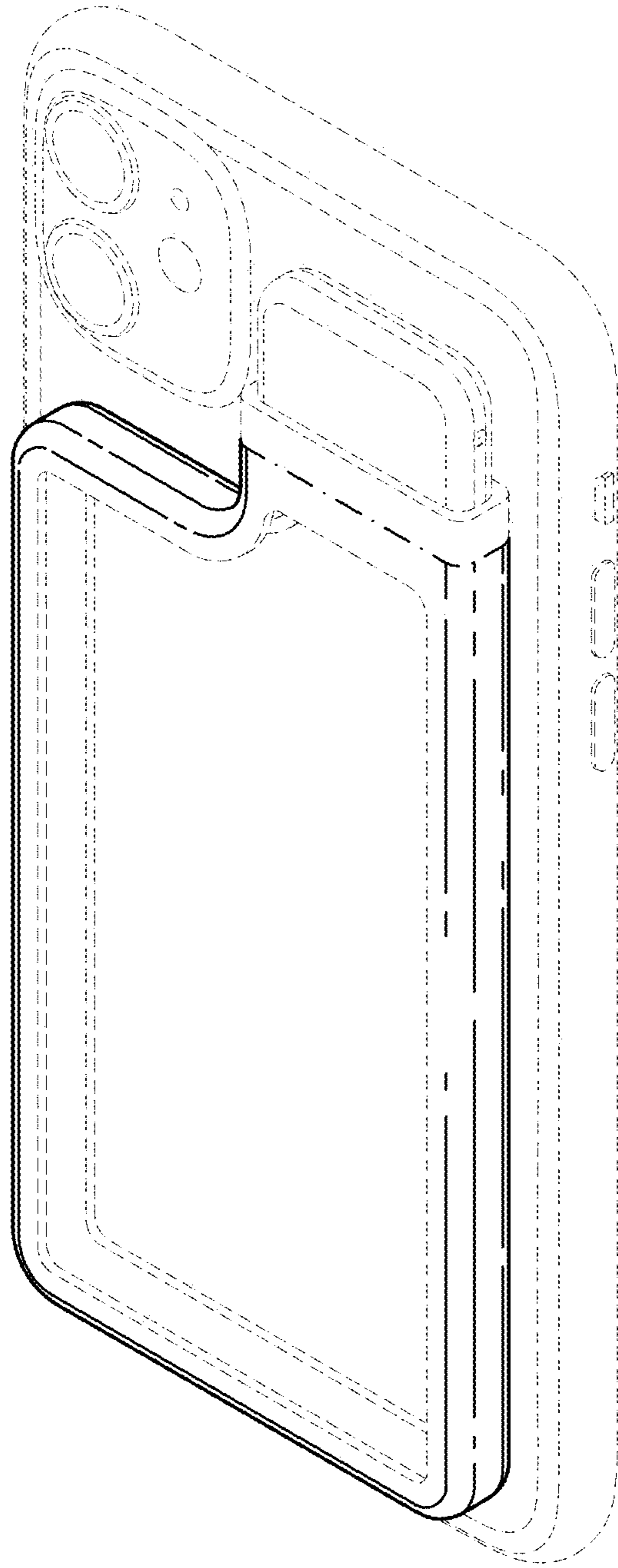

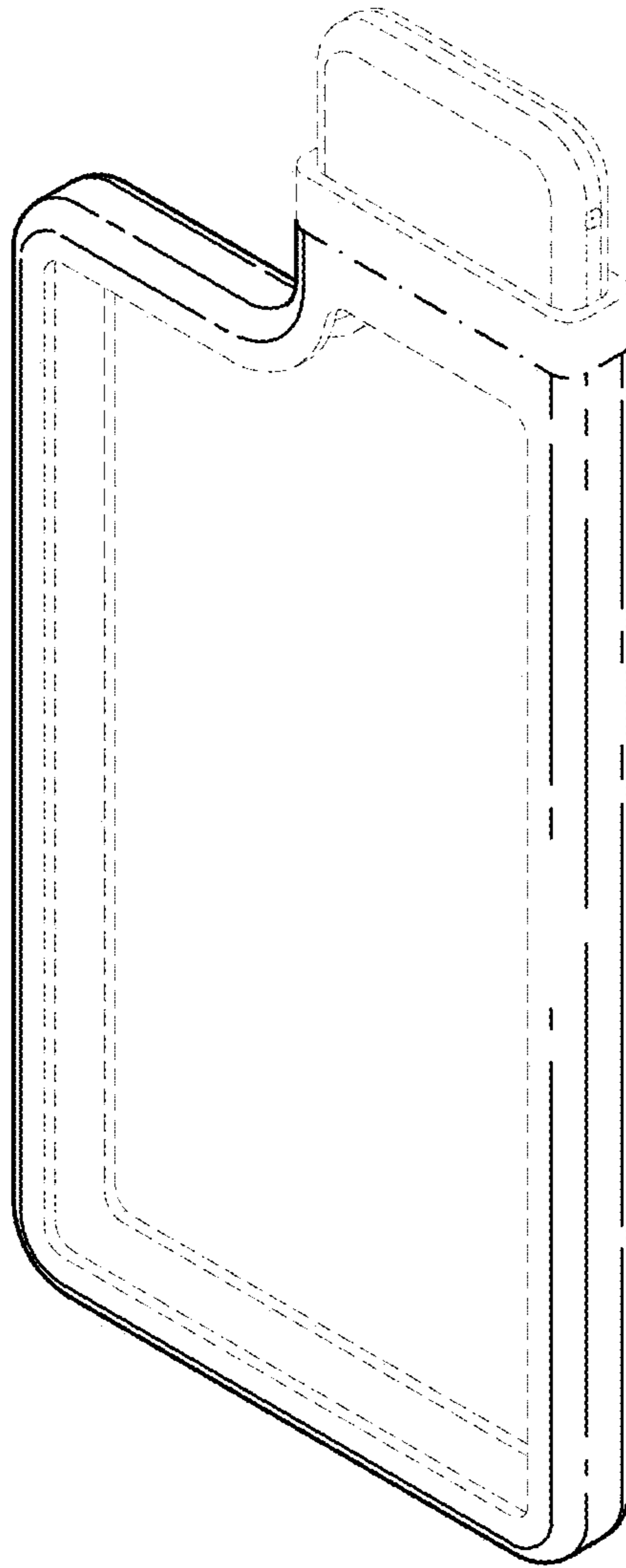

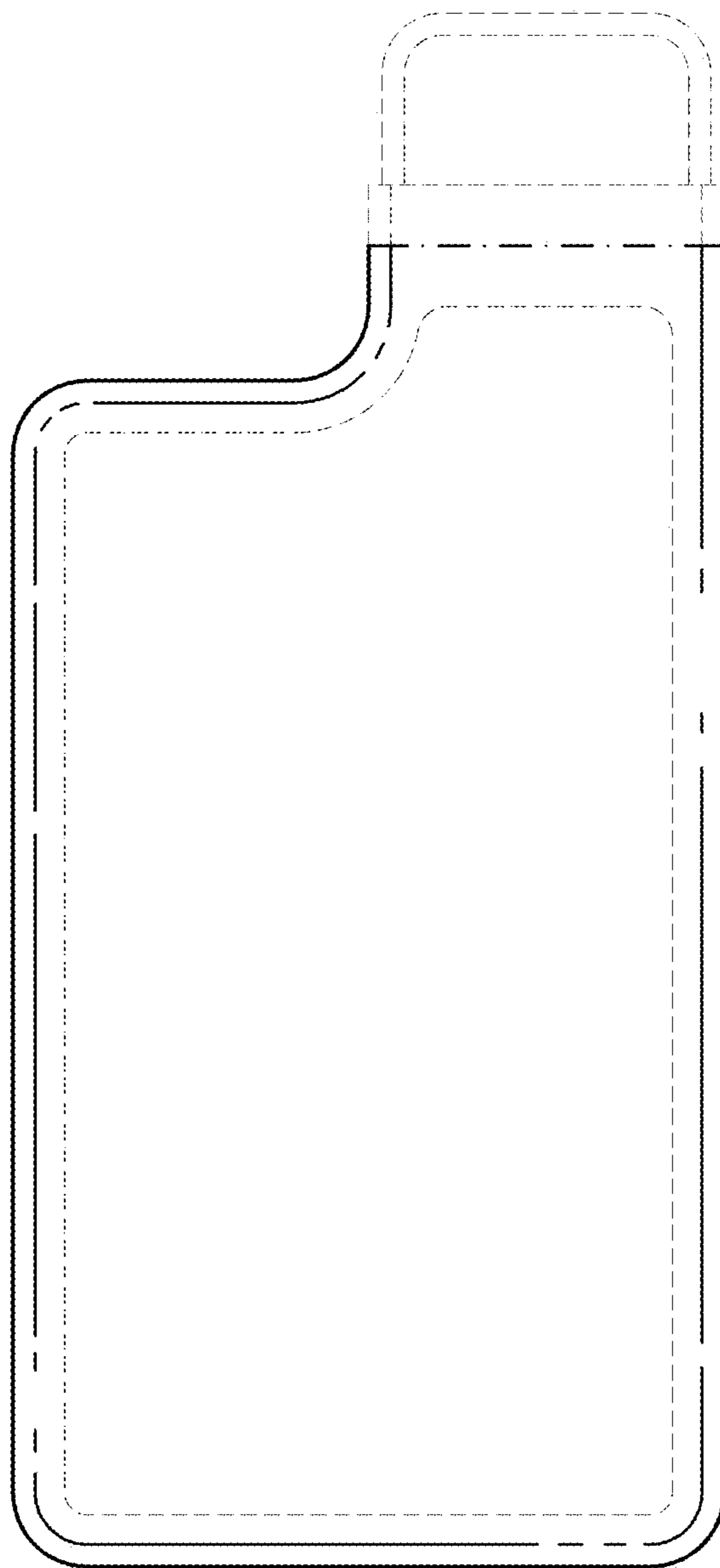

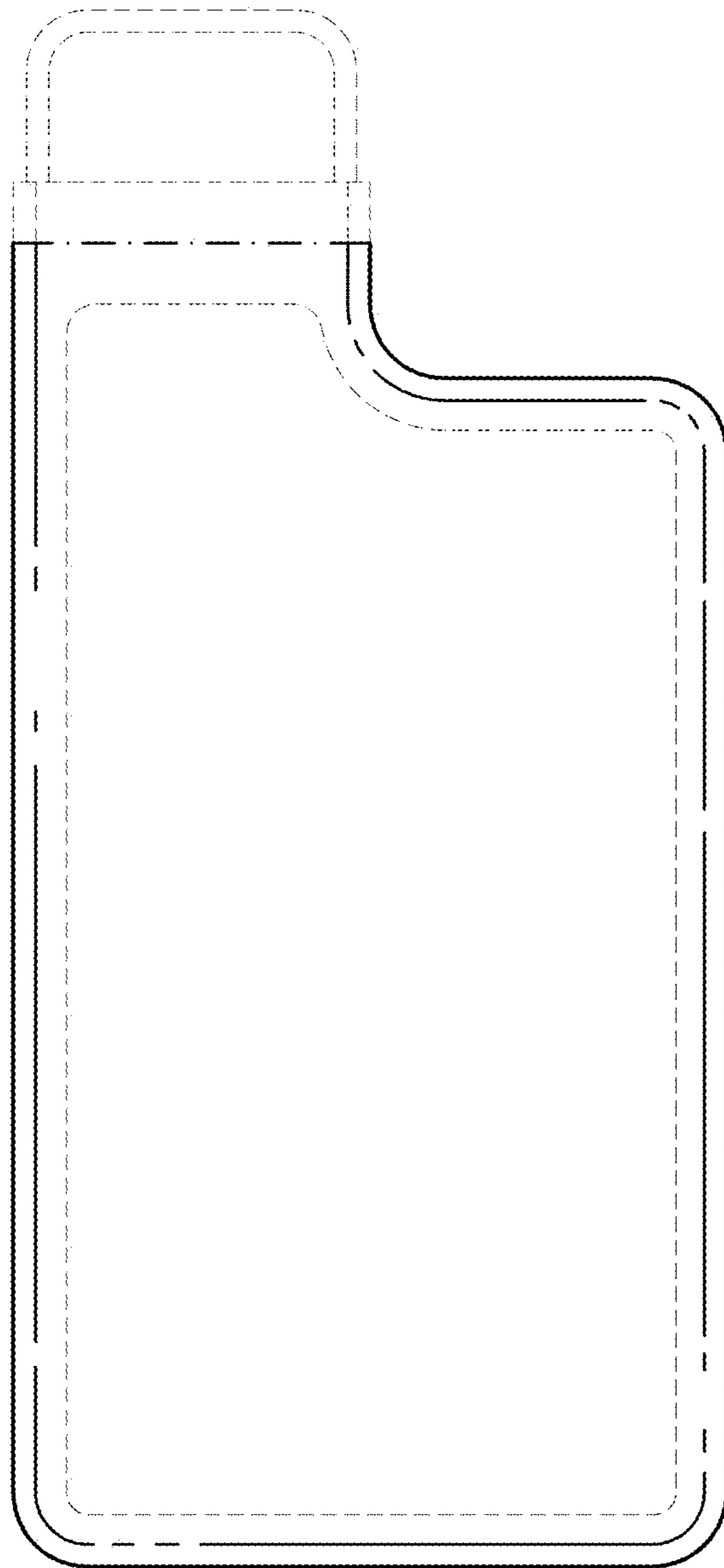

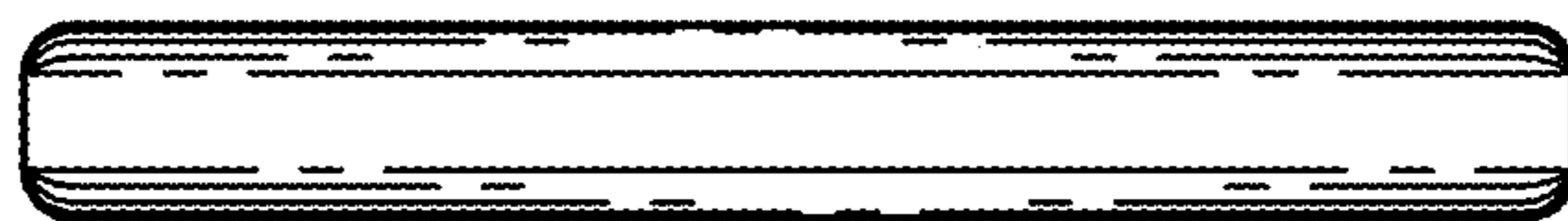
