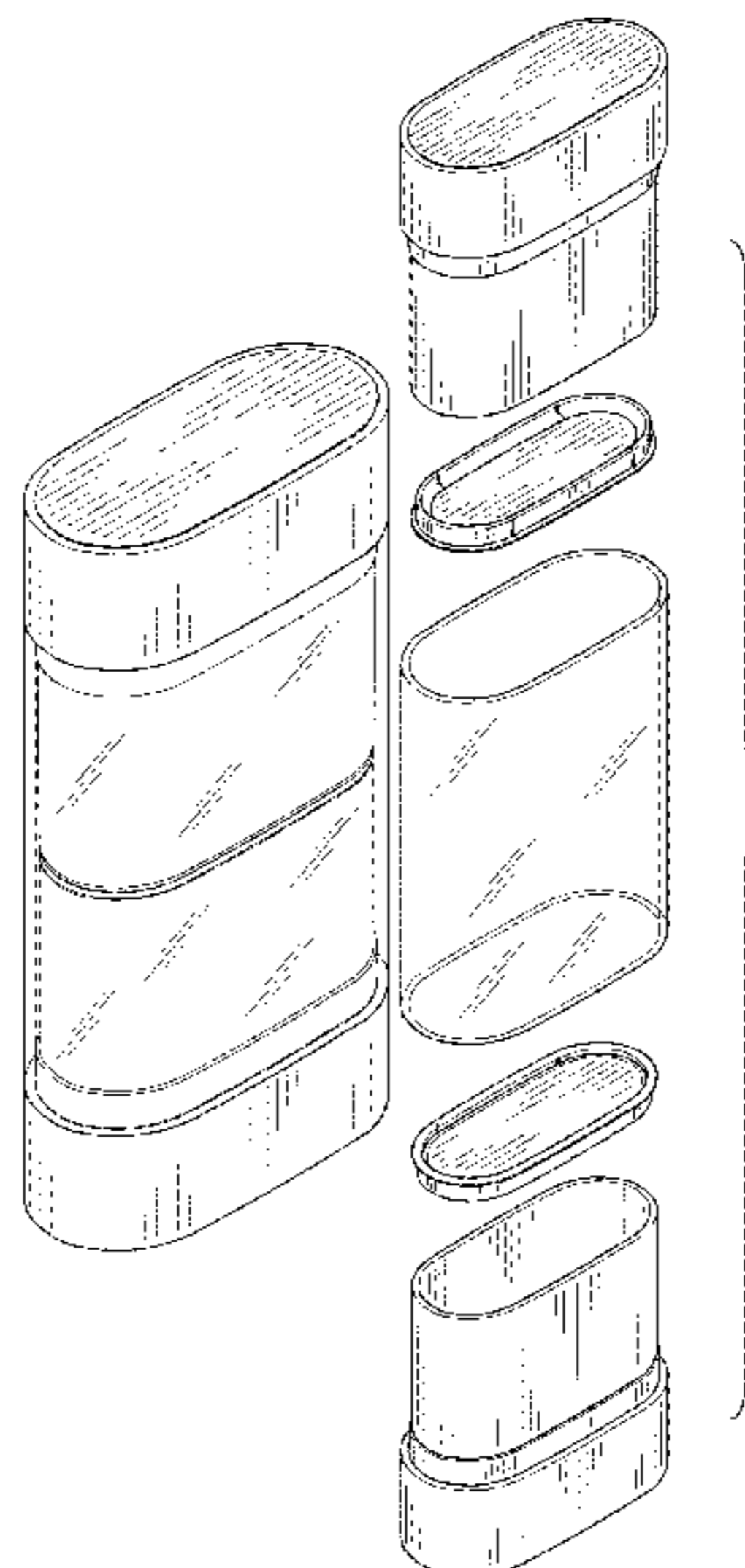
(57) **CLAIM**

The ornamental design for a cosmetic container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cosmetic container showing my new design;  
FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;

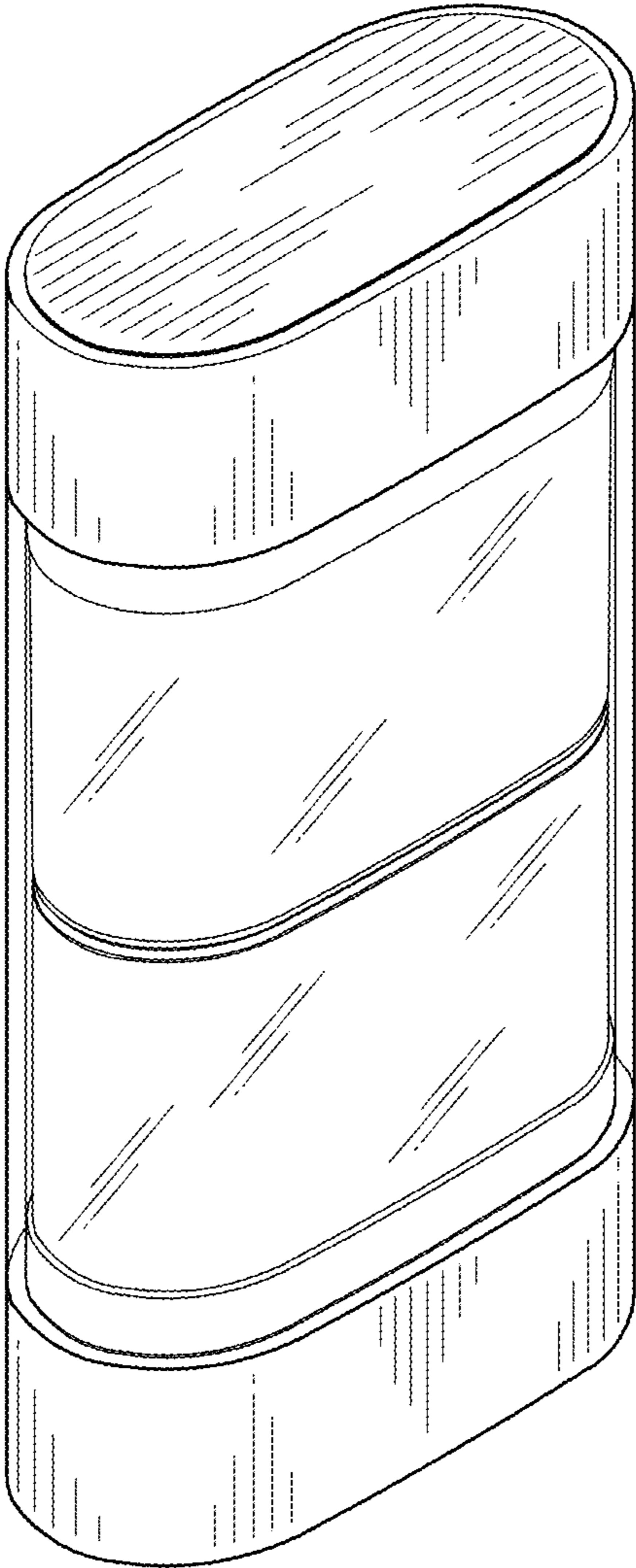

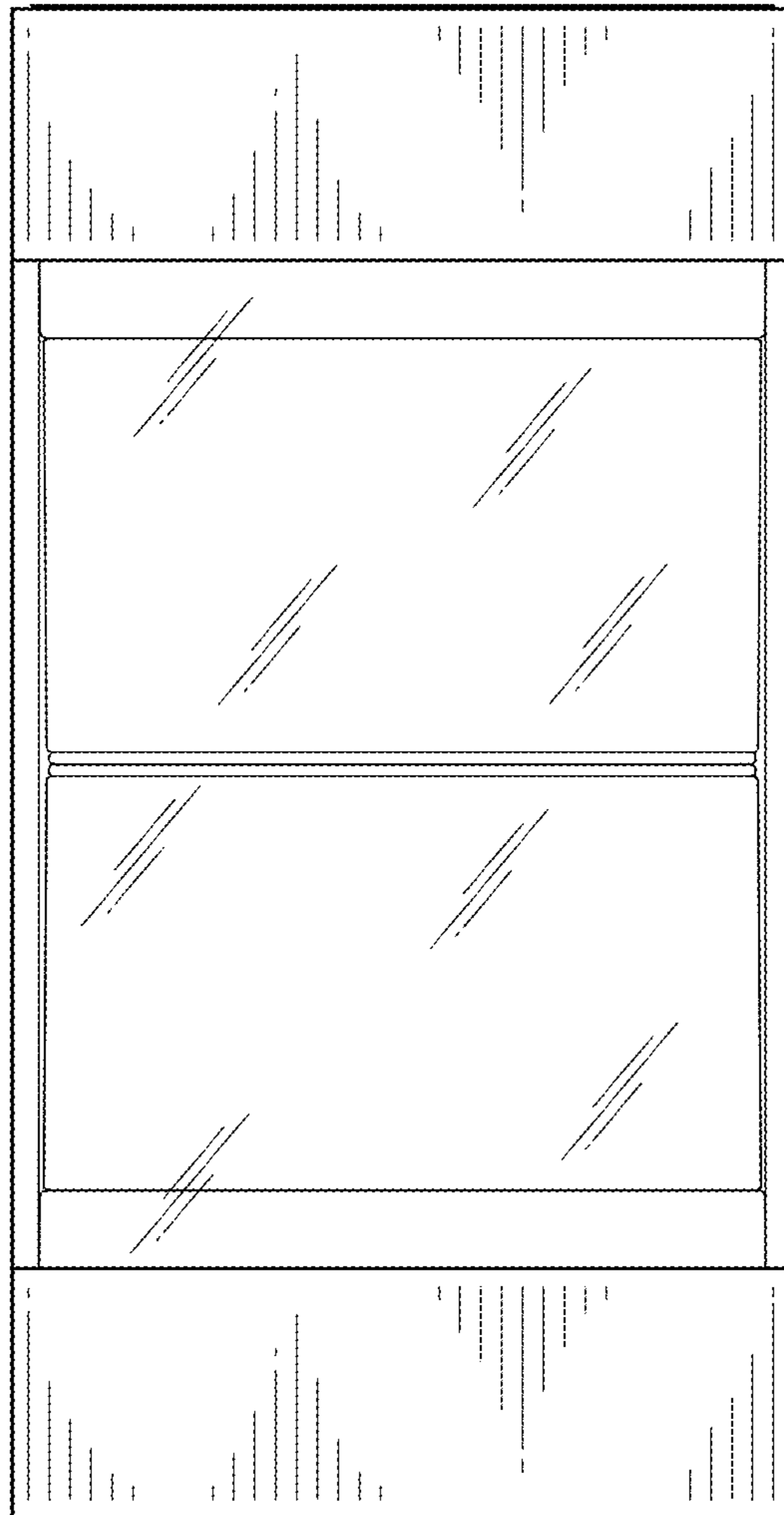

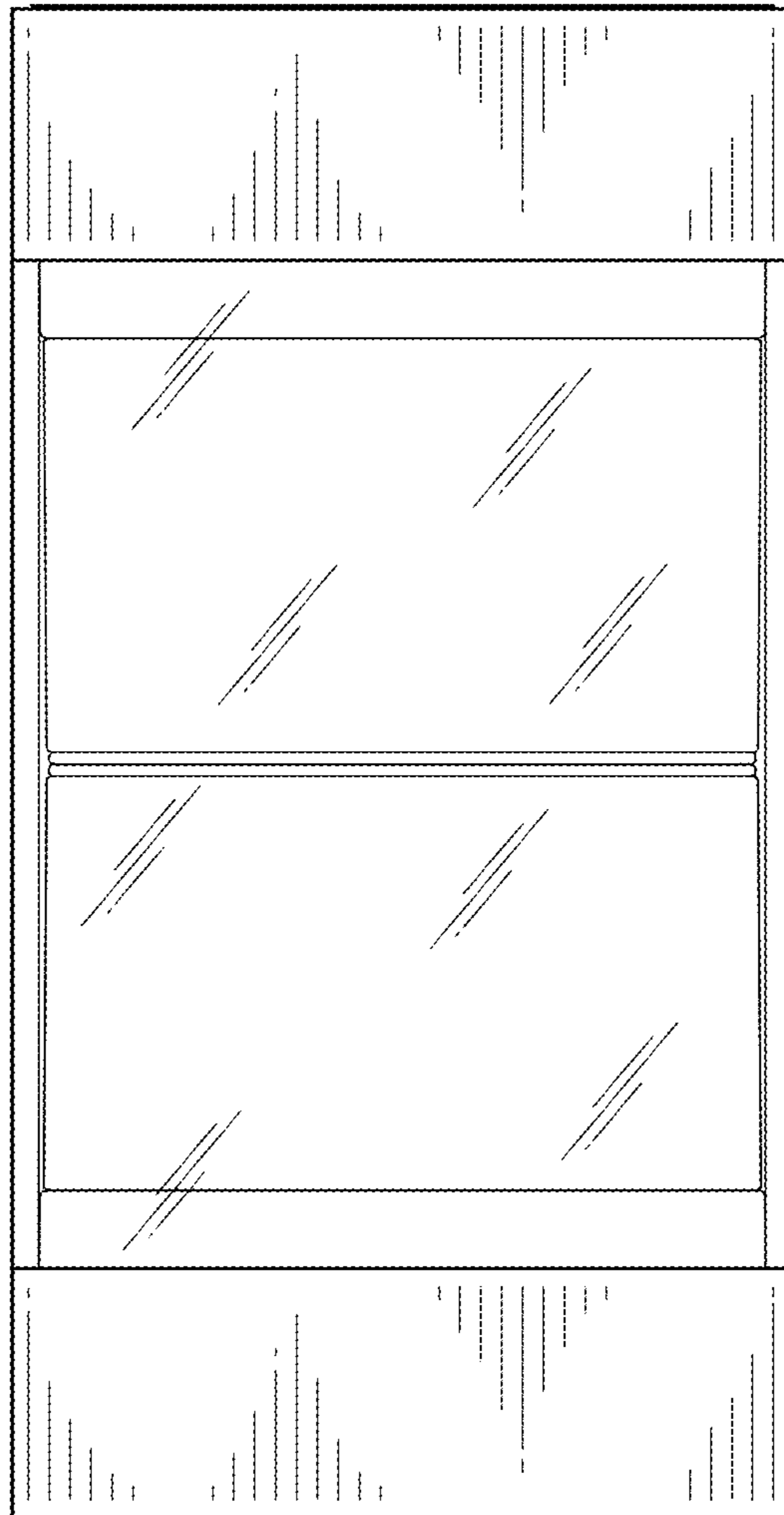

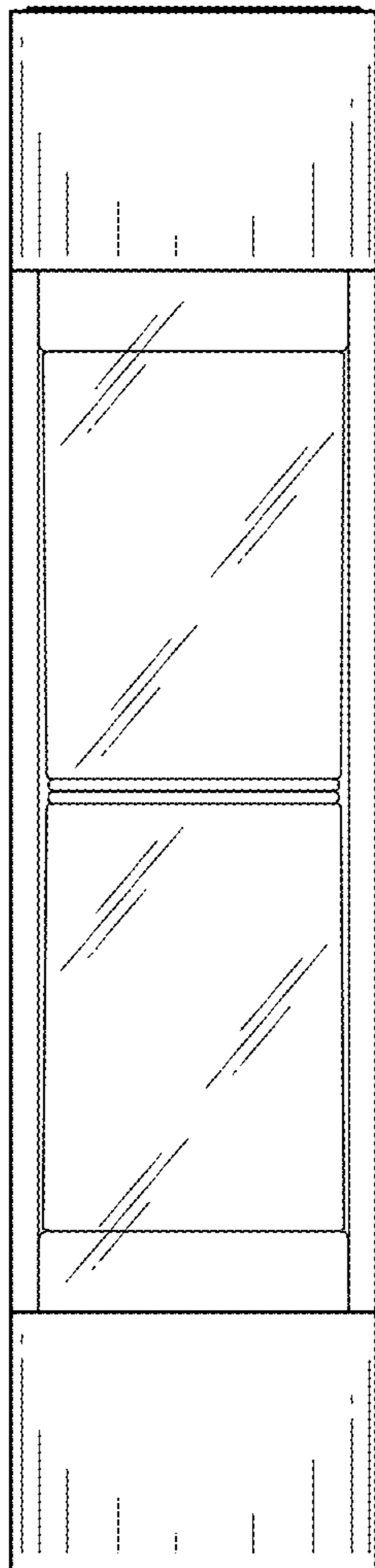

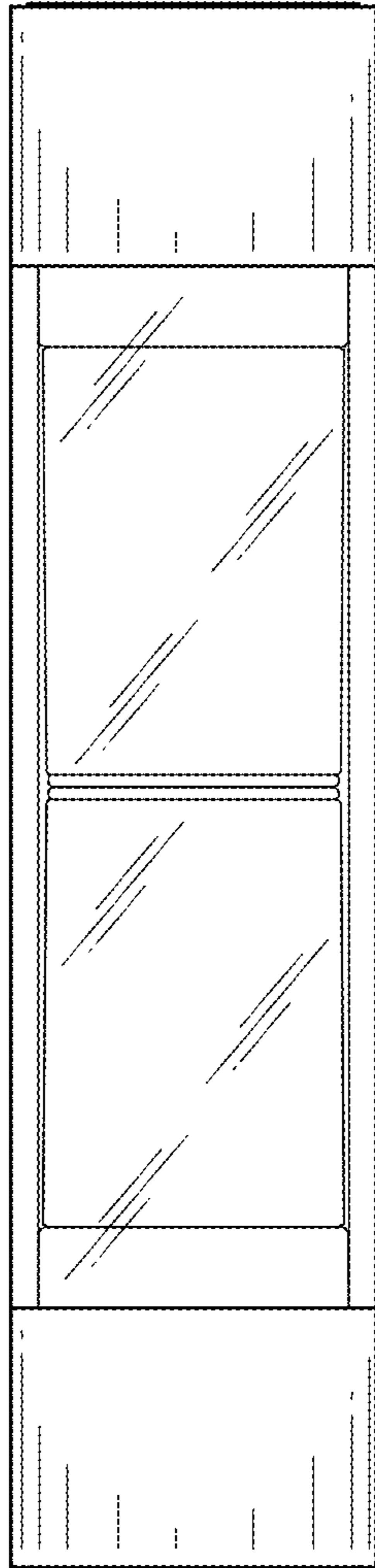

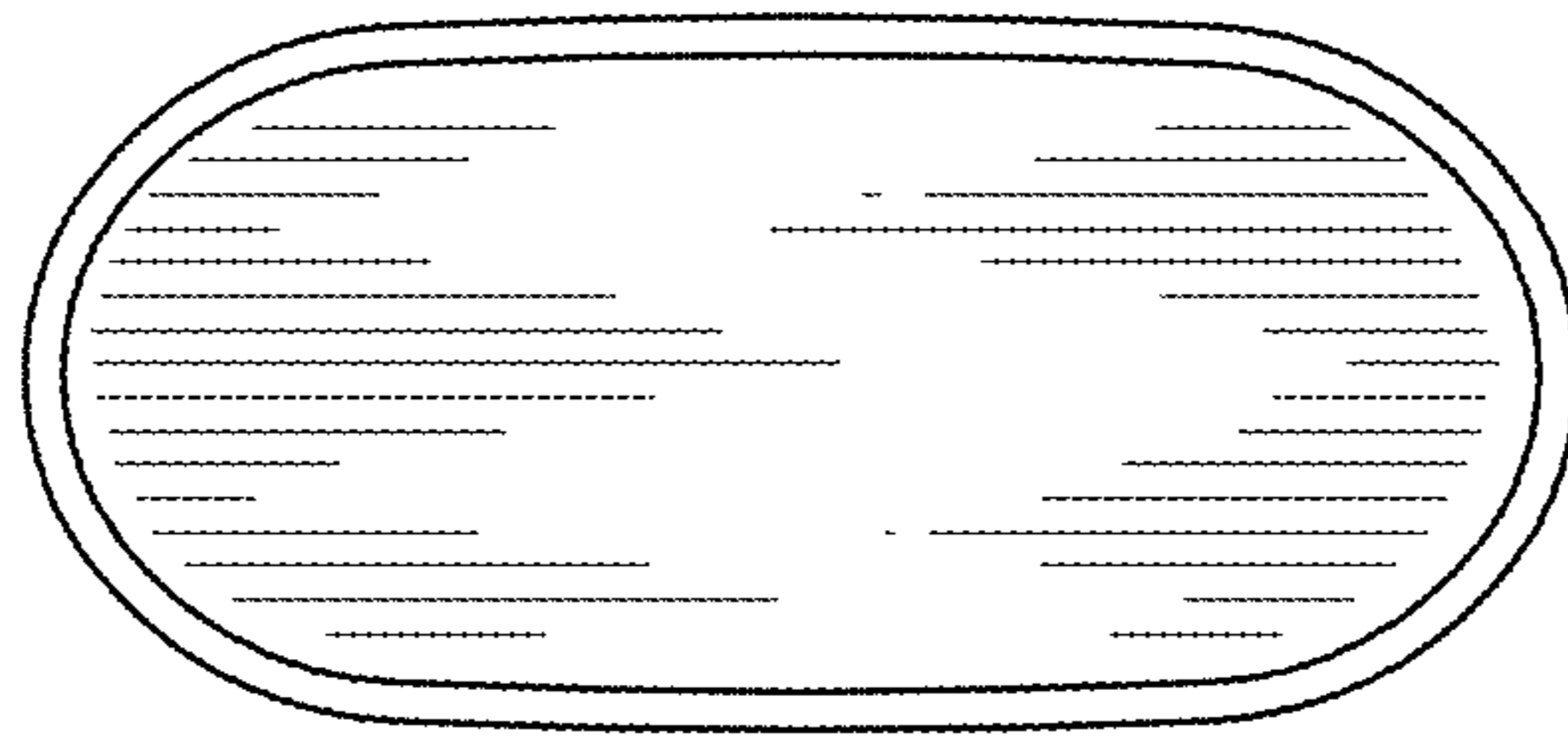

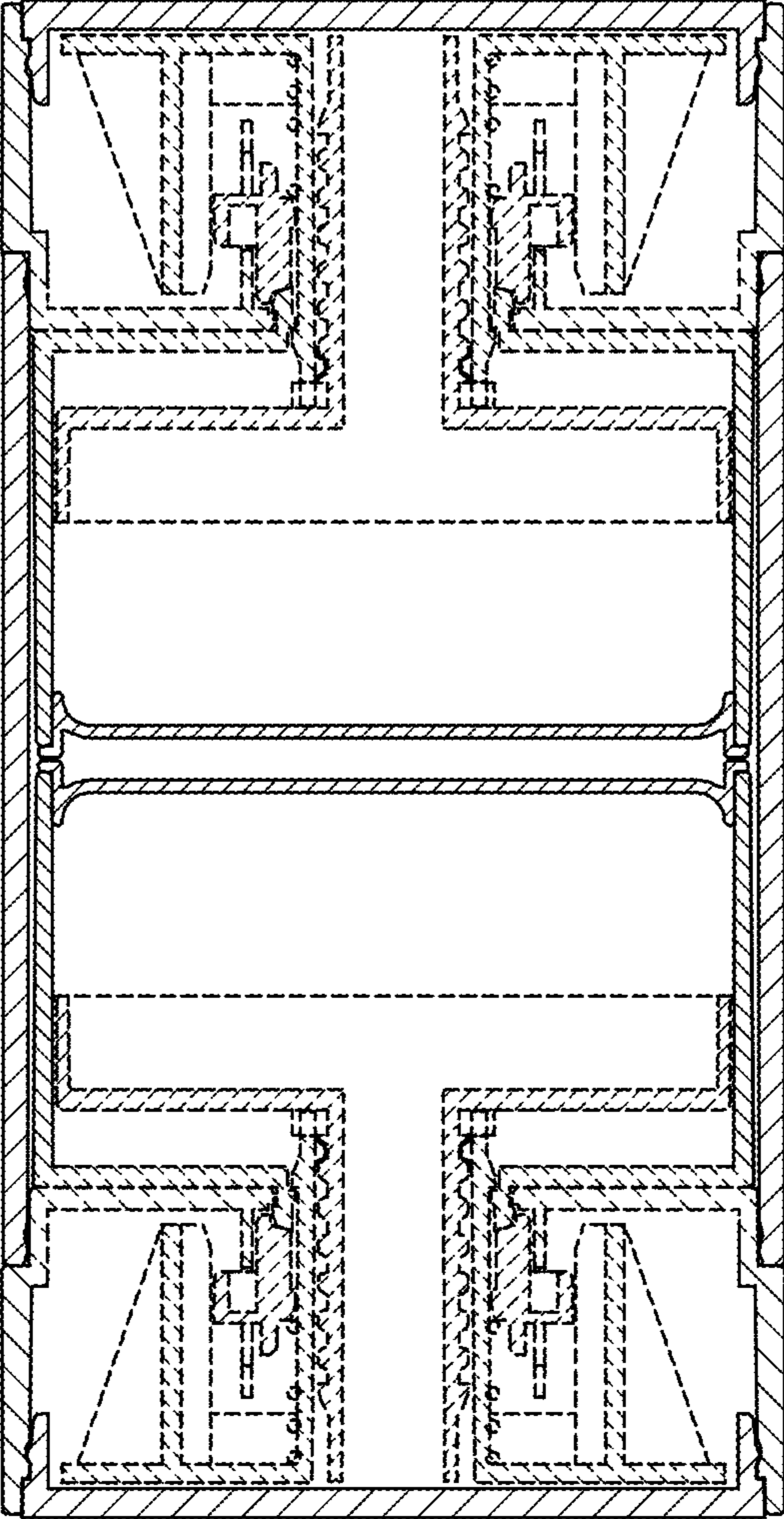
