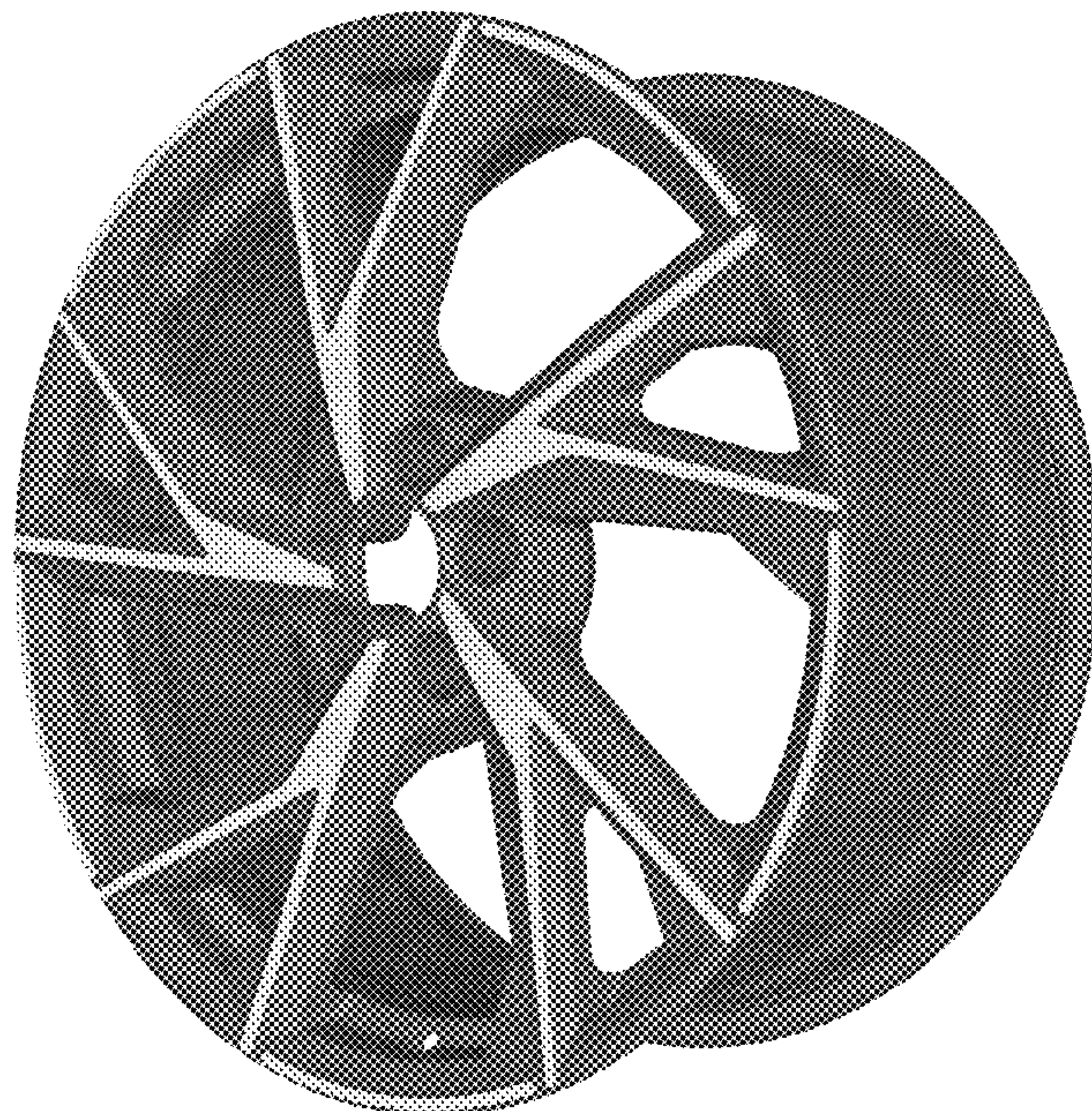
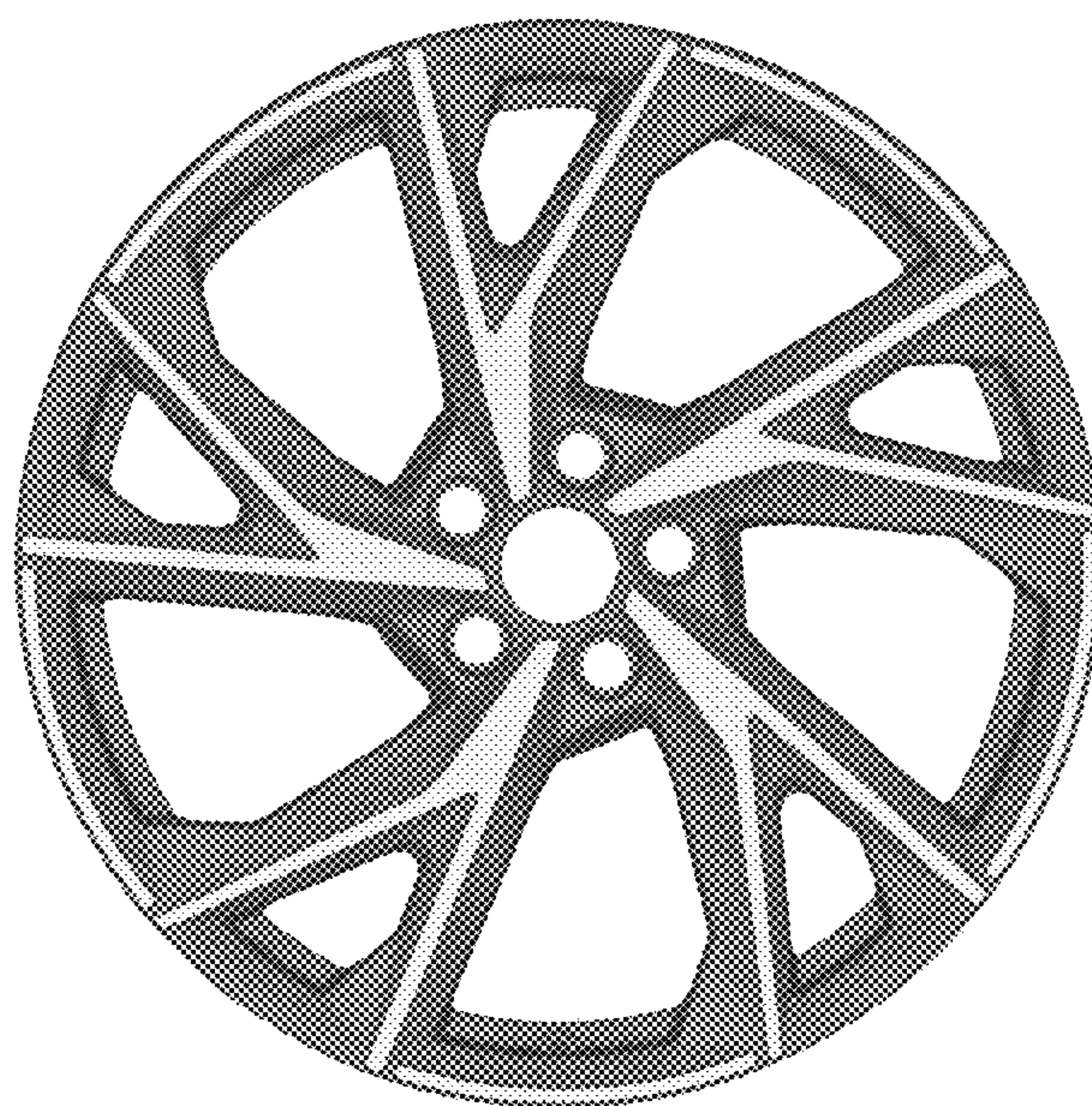
(57) **CLAIM**

The ornamental design for a vehicle wheel rim, as shown and described.

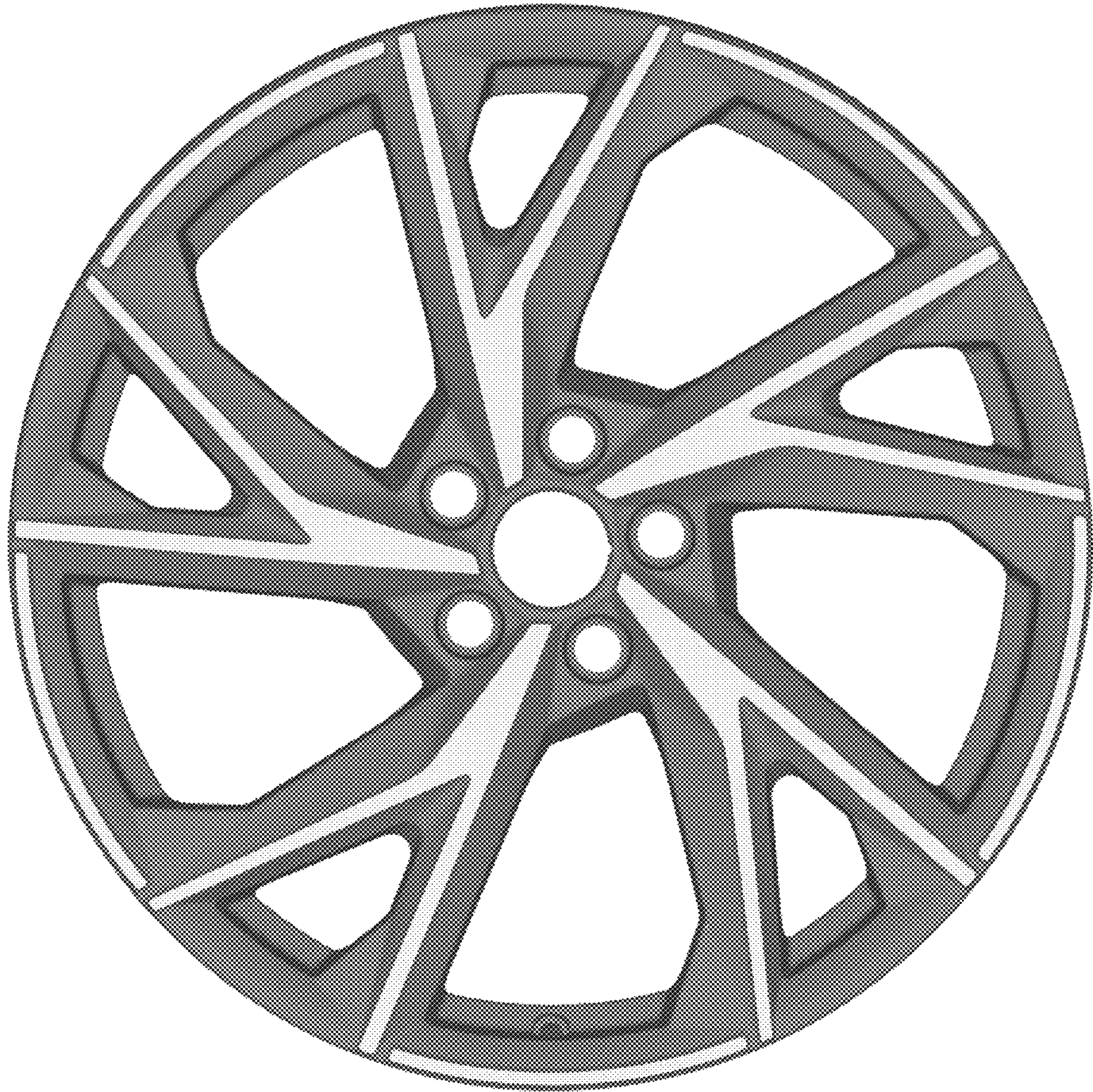
**DESCRIPTION**
