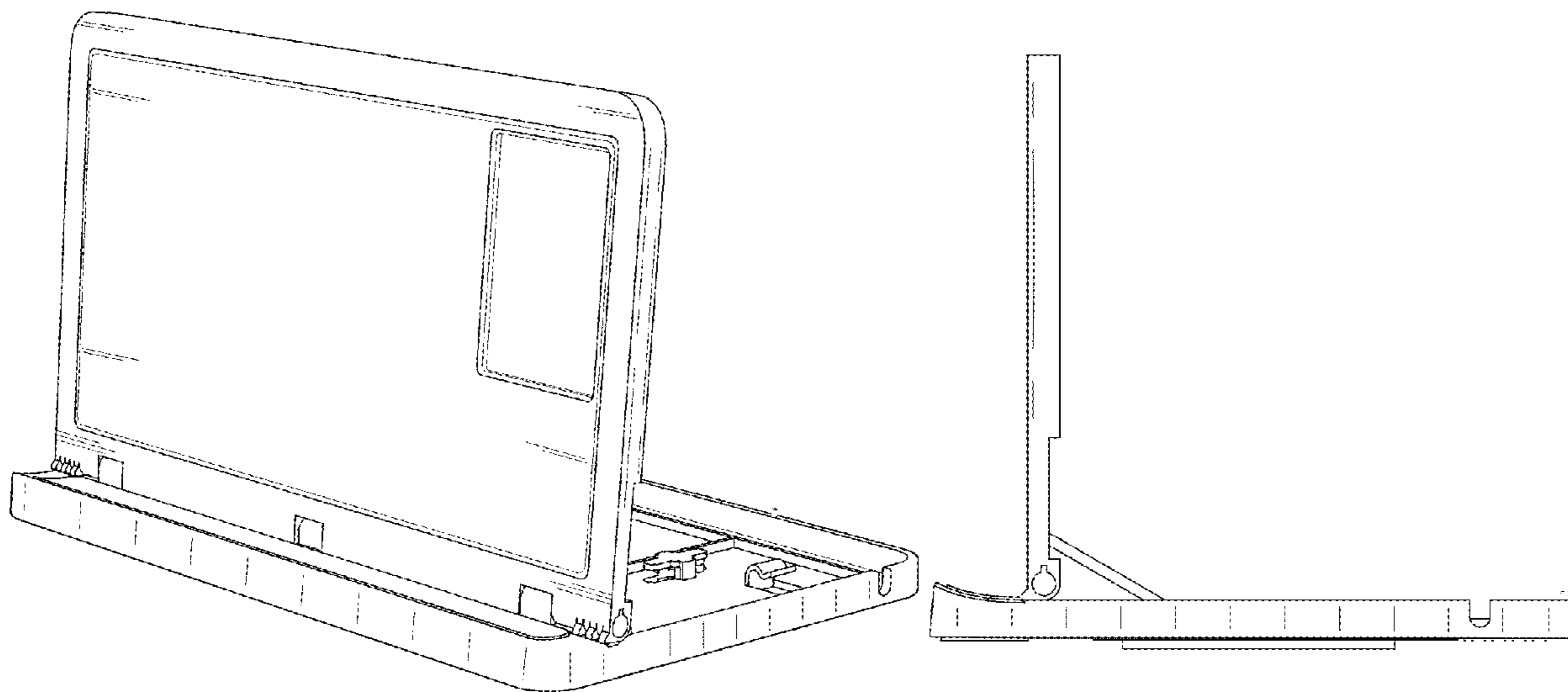
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a cell phone stand and wall shelf combination, showing my design.
FIG. 2 is a front elevation view thereof.

FIG. 4 is a left side elevation view thereof.

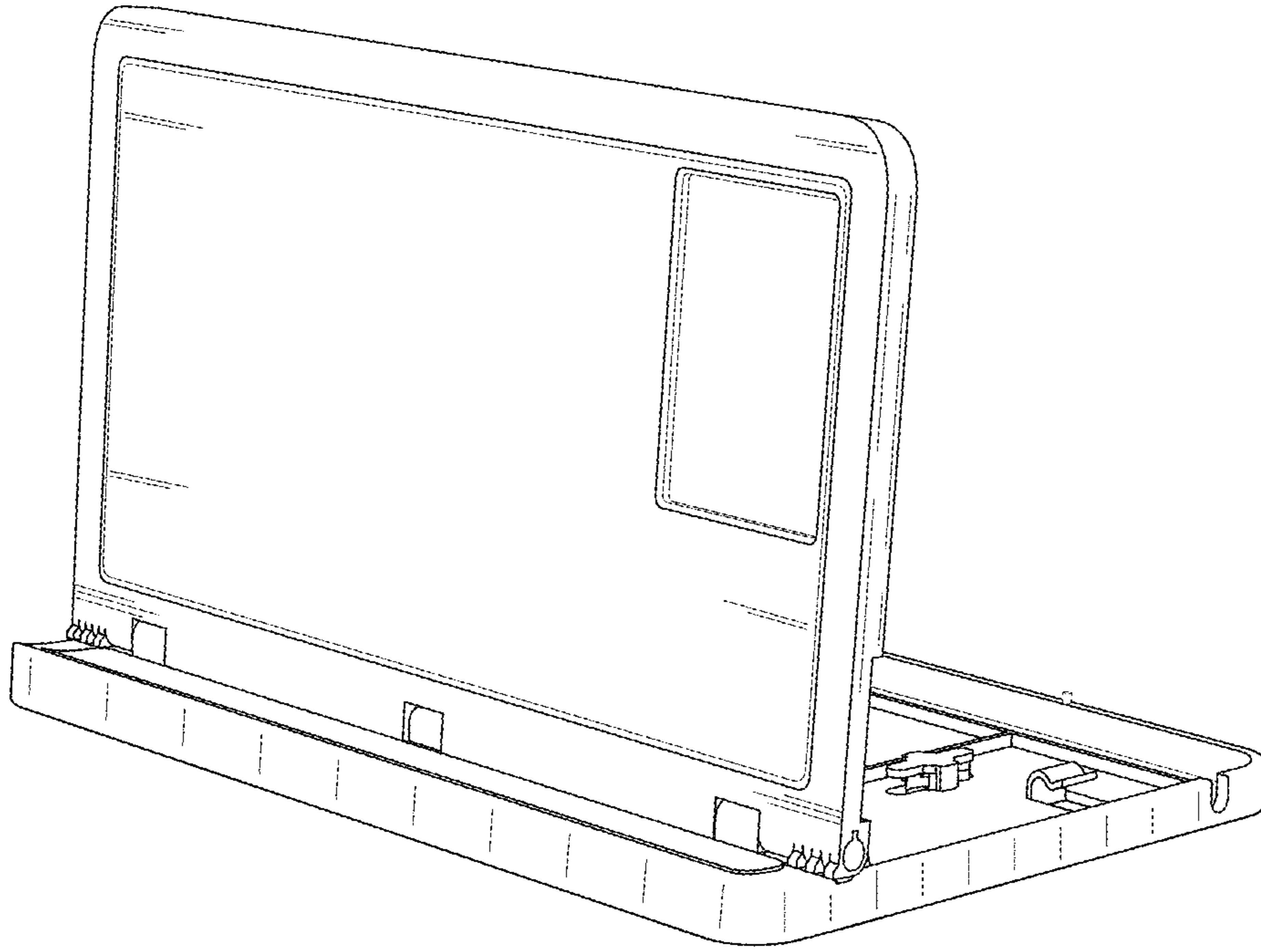

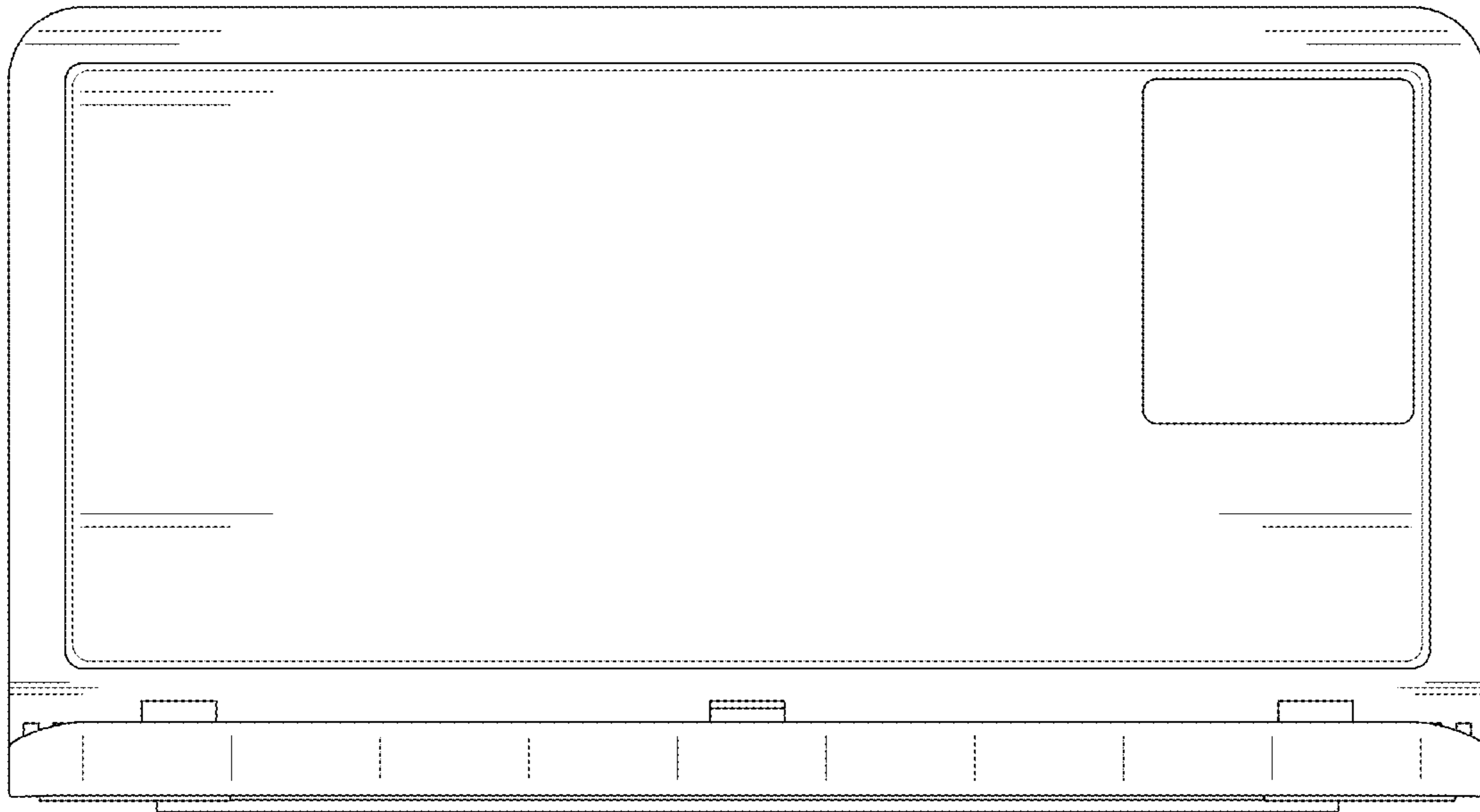

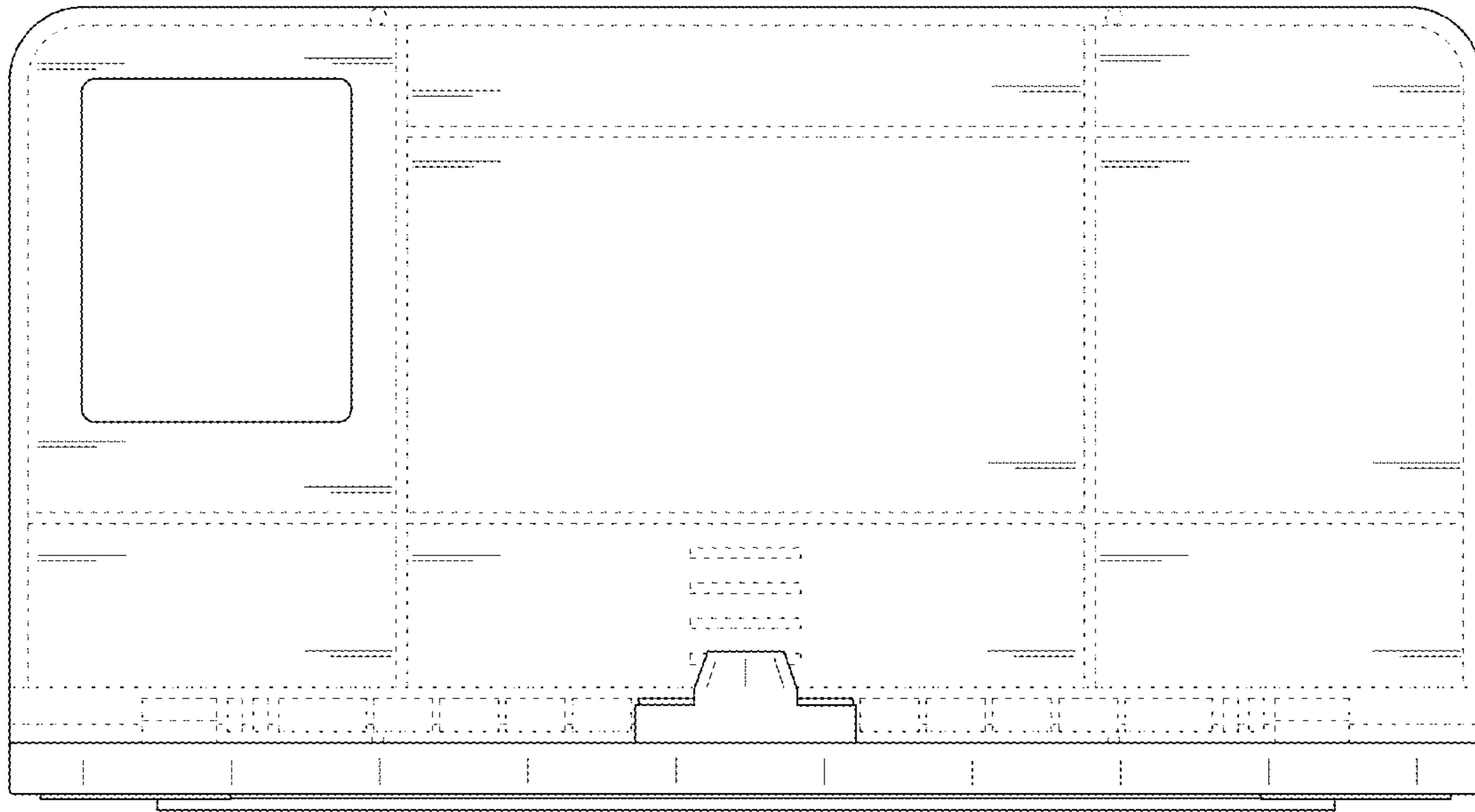

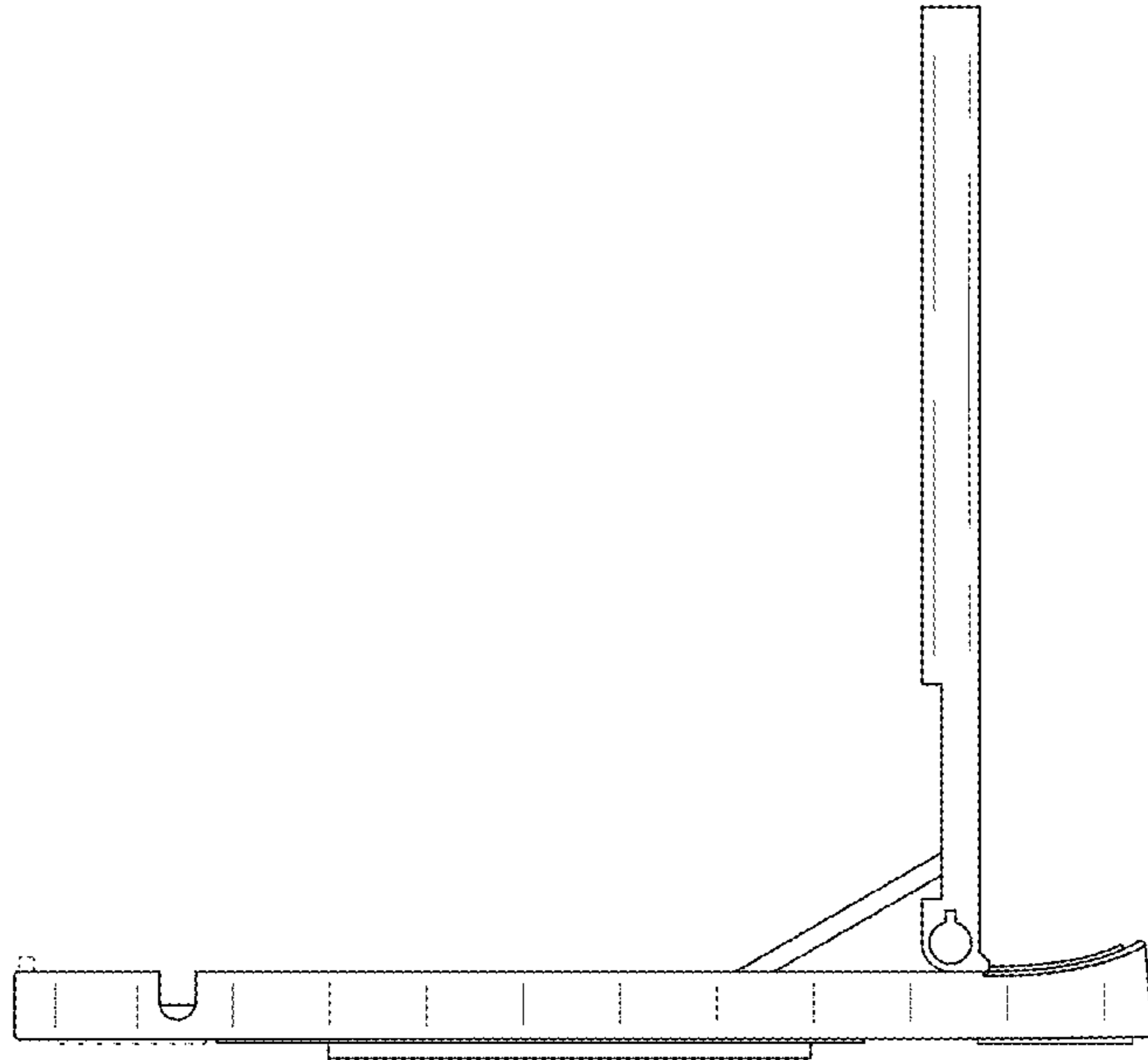

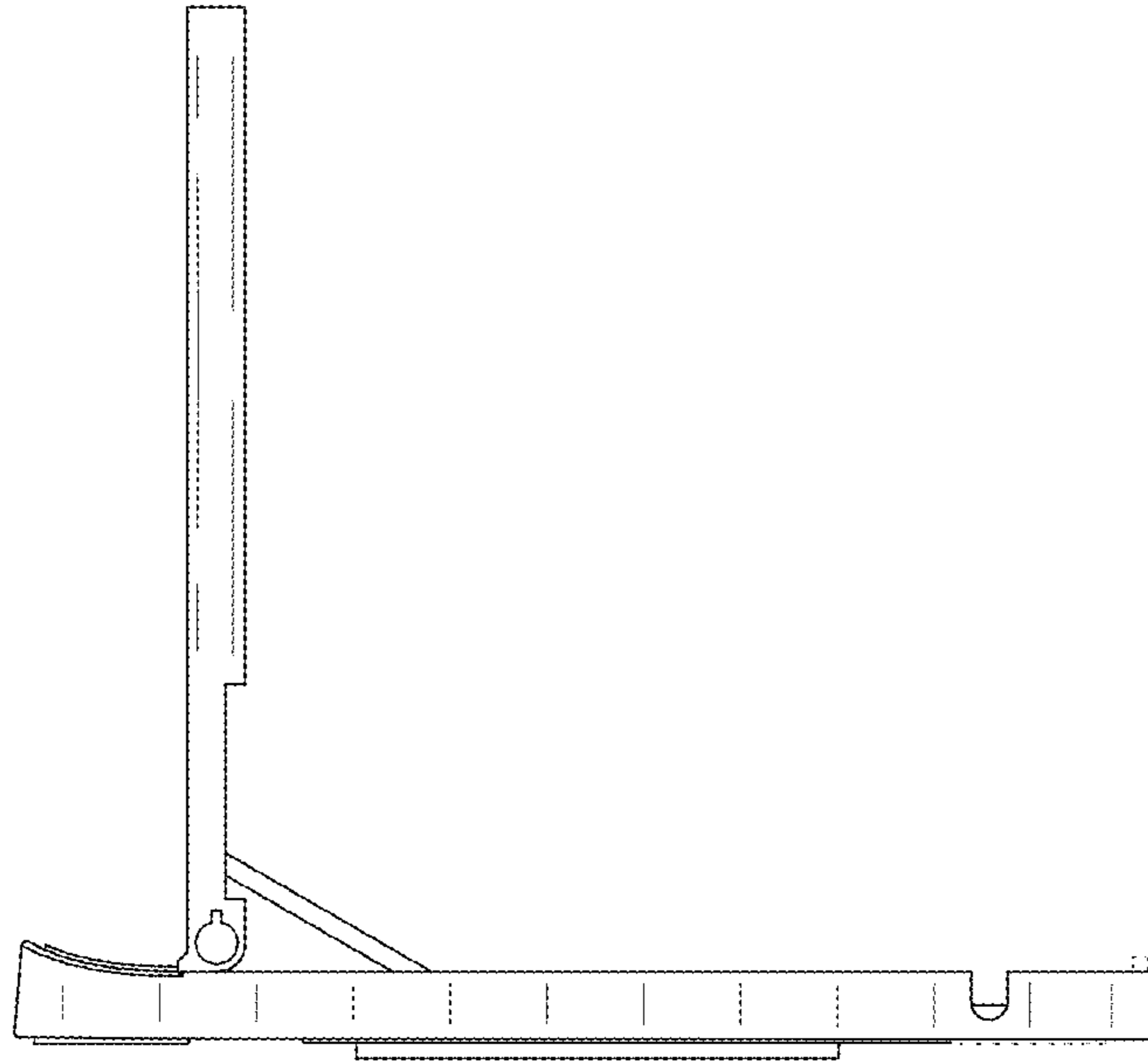

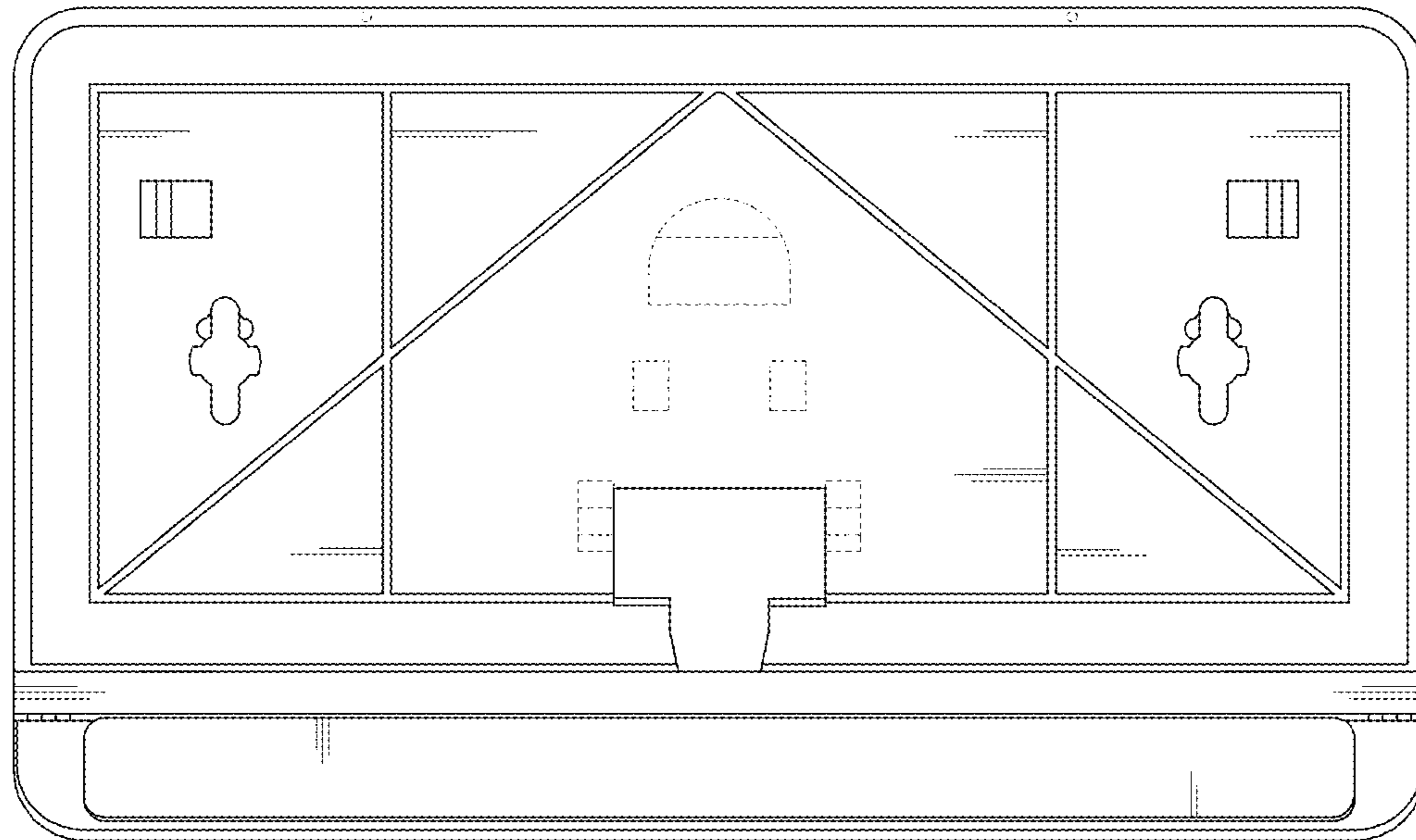

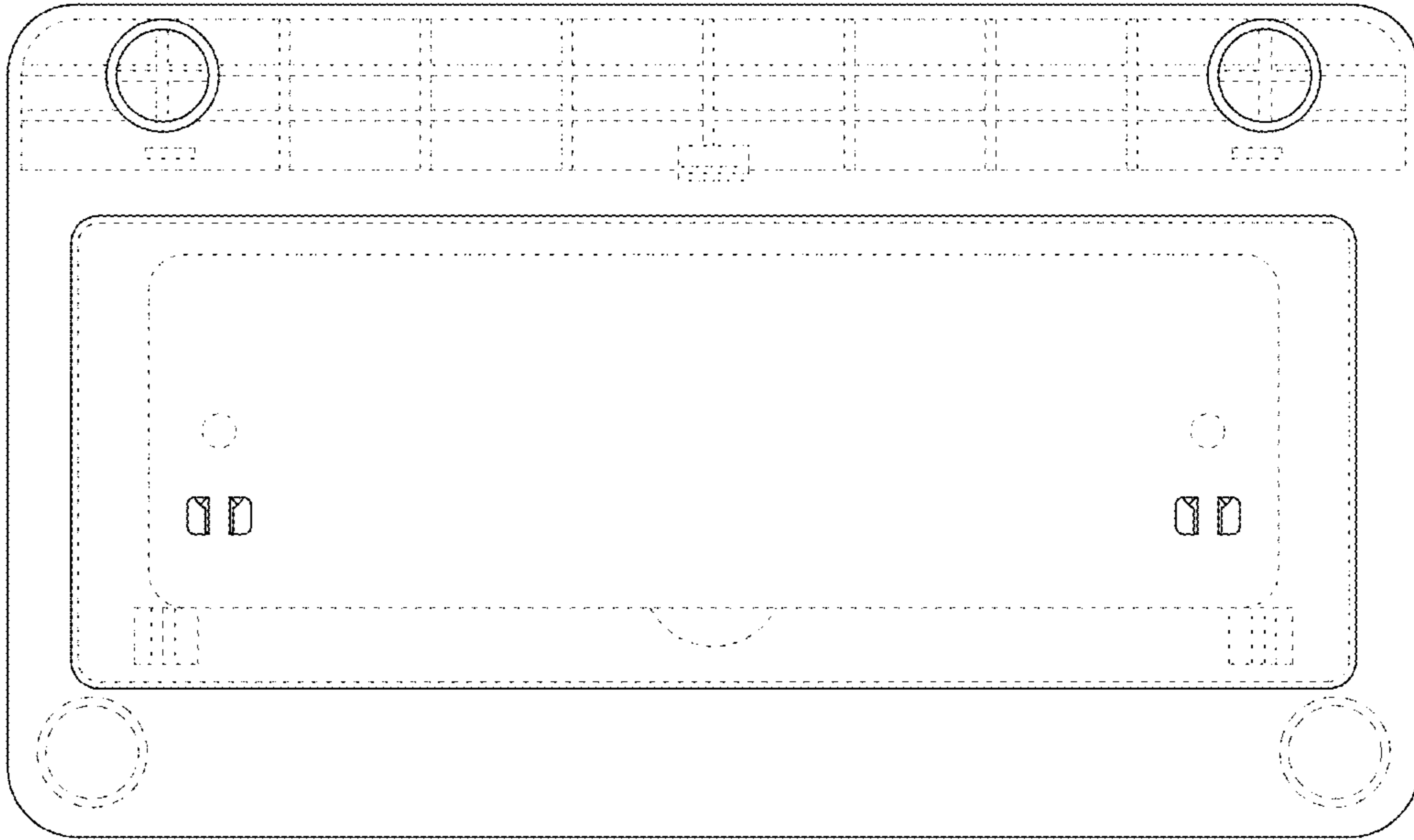
