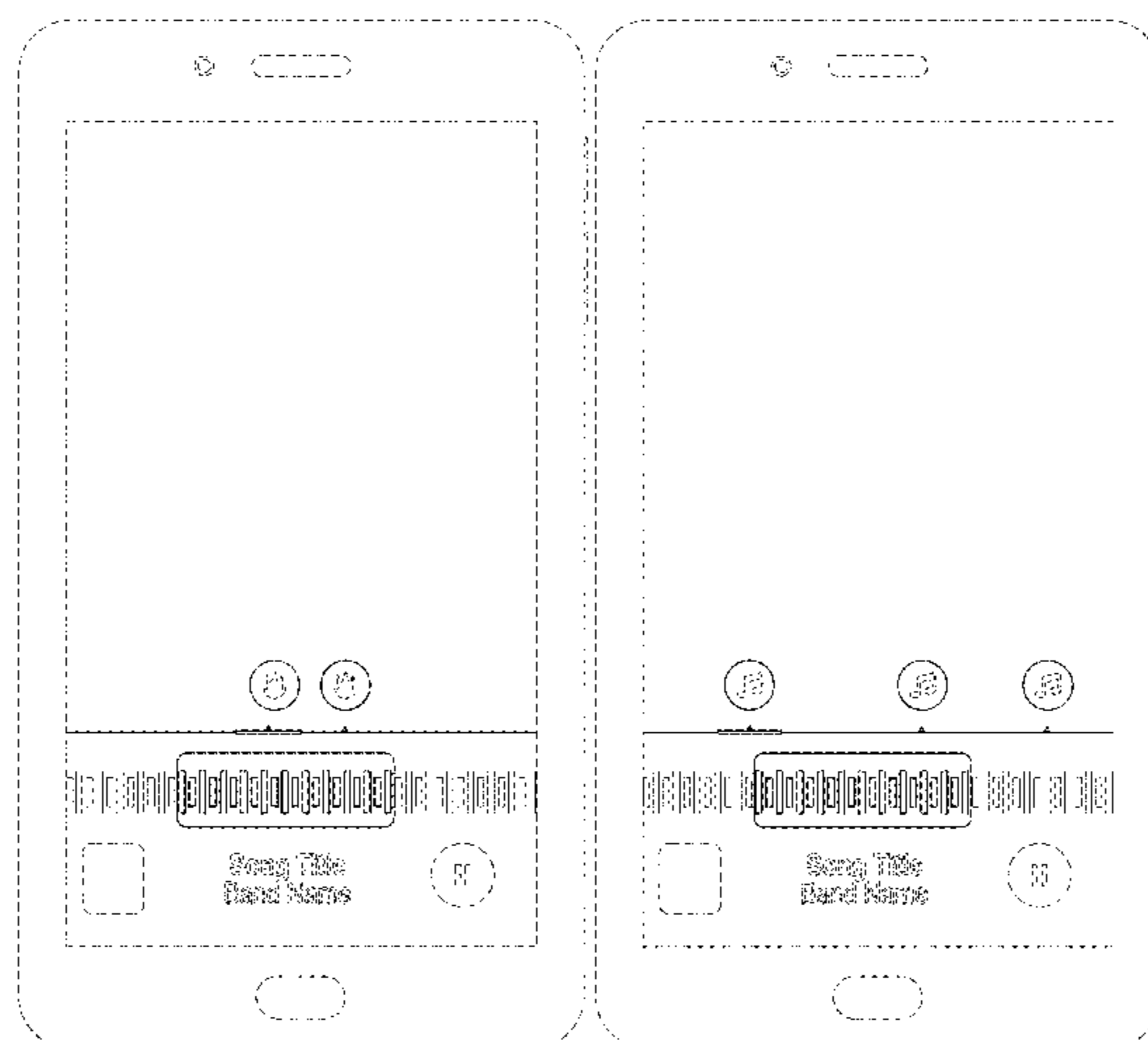
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with a graphical user interface showing the new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; FIG. 4 is a front view of a fourth embodiment thereof; FIG. 5 is a front view of the design shown in FIG. 1 but in a different broken line environment; FIG. 6 is a front view of the design shown in FIG. 2 but in a different broken line environment; FIG. 7 is a front view of the design shown in FIG. 3 but in a different broken line environment; and, FIG. 8 is a front view of the design shown in FIG. 4 but in a different broken line environment.

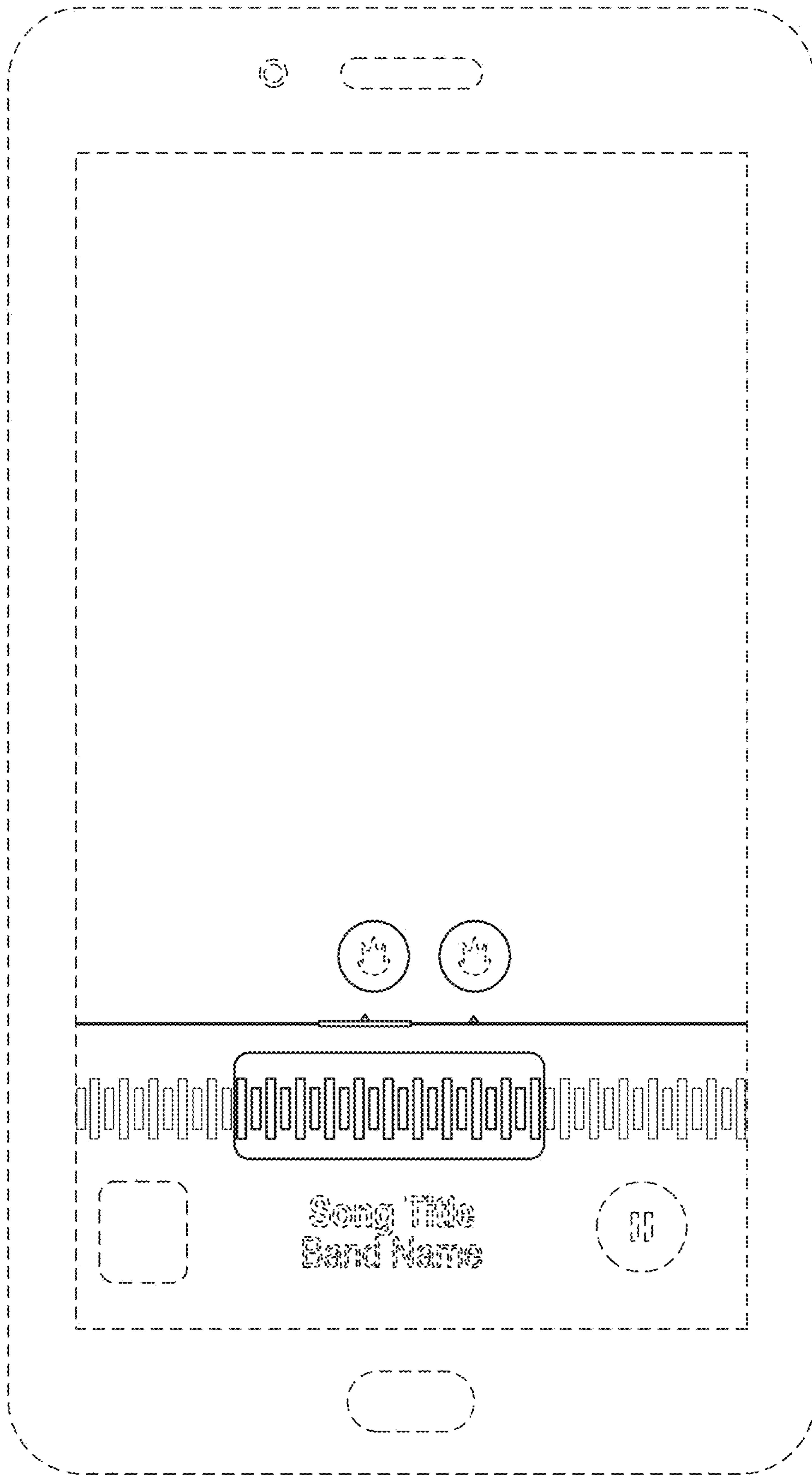

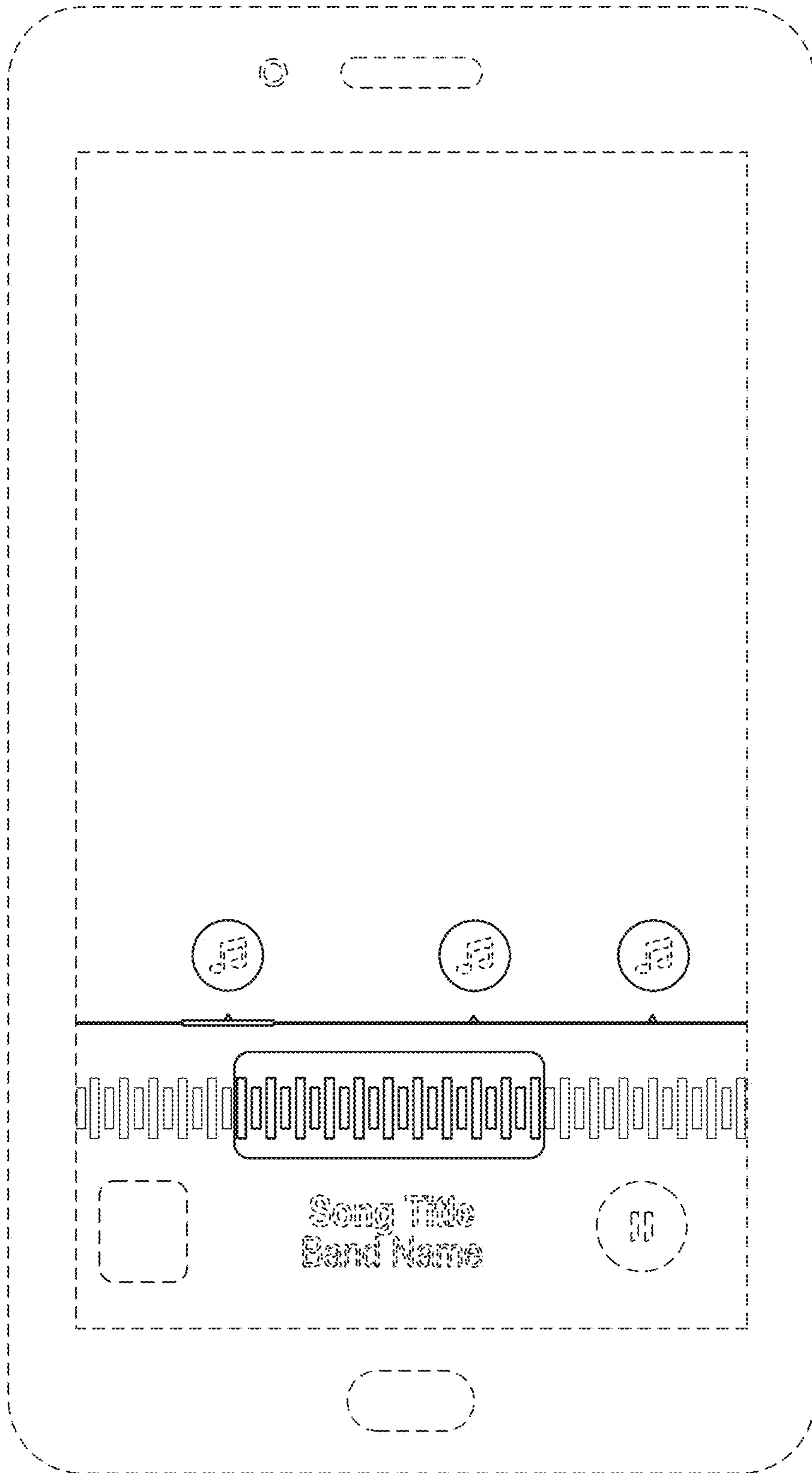

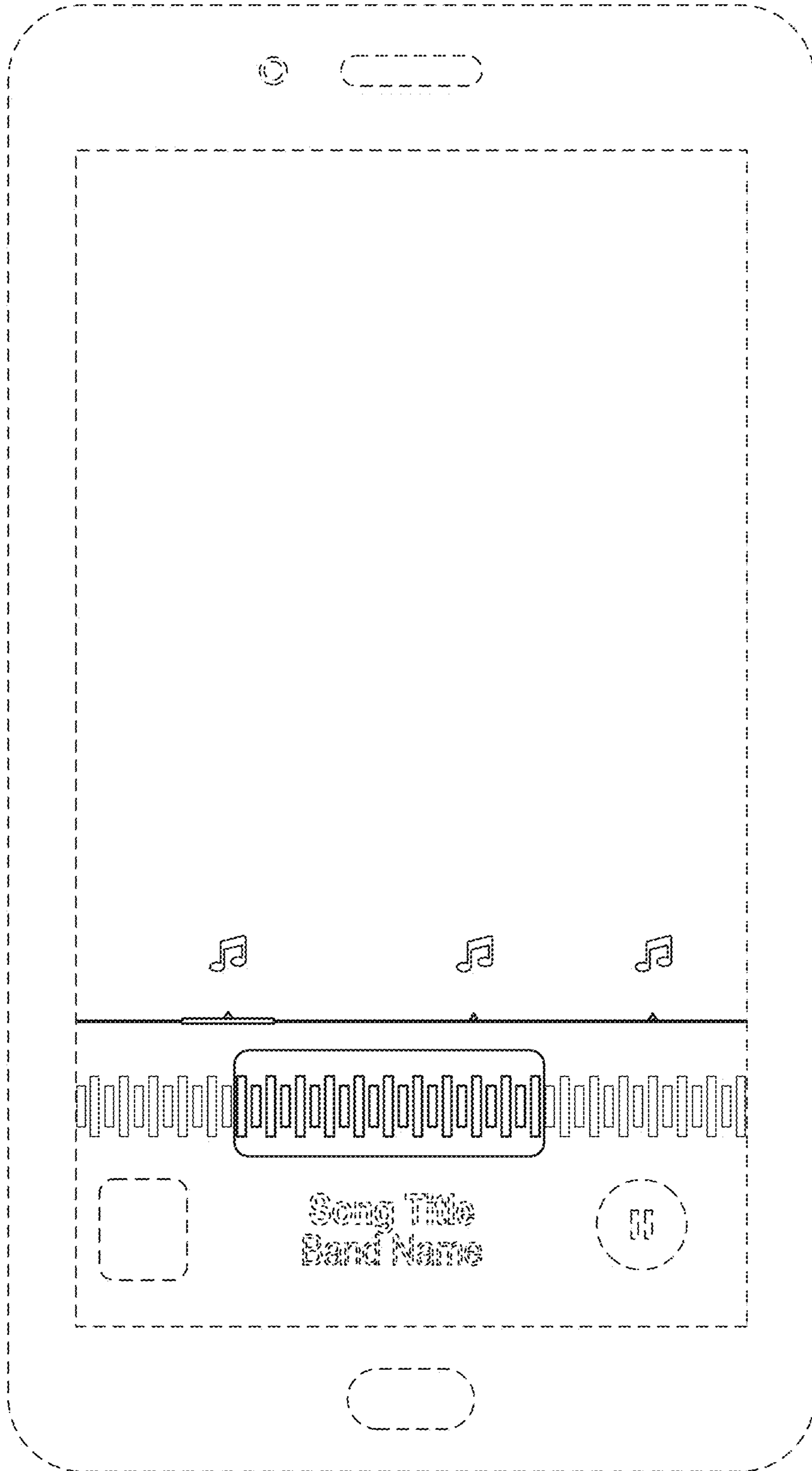

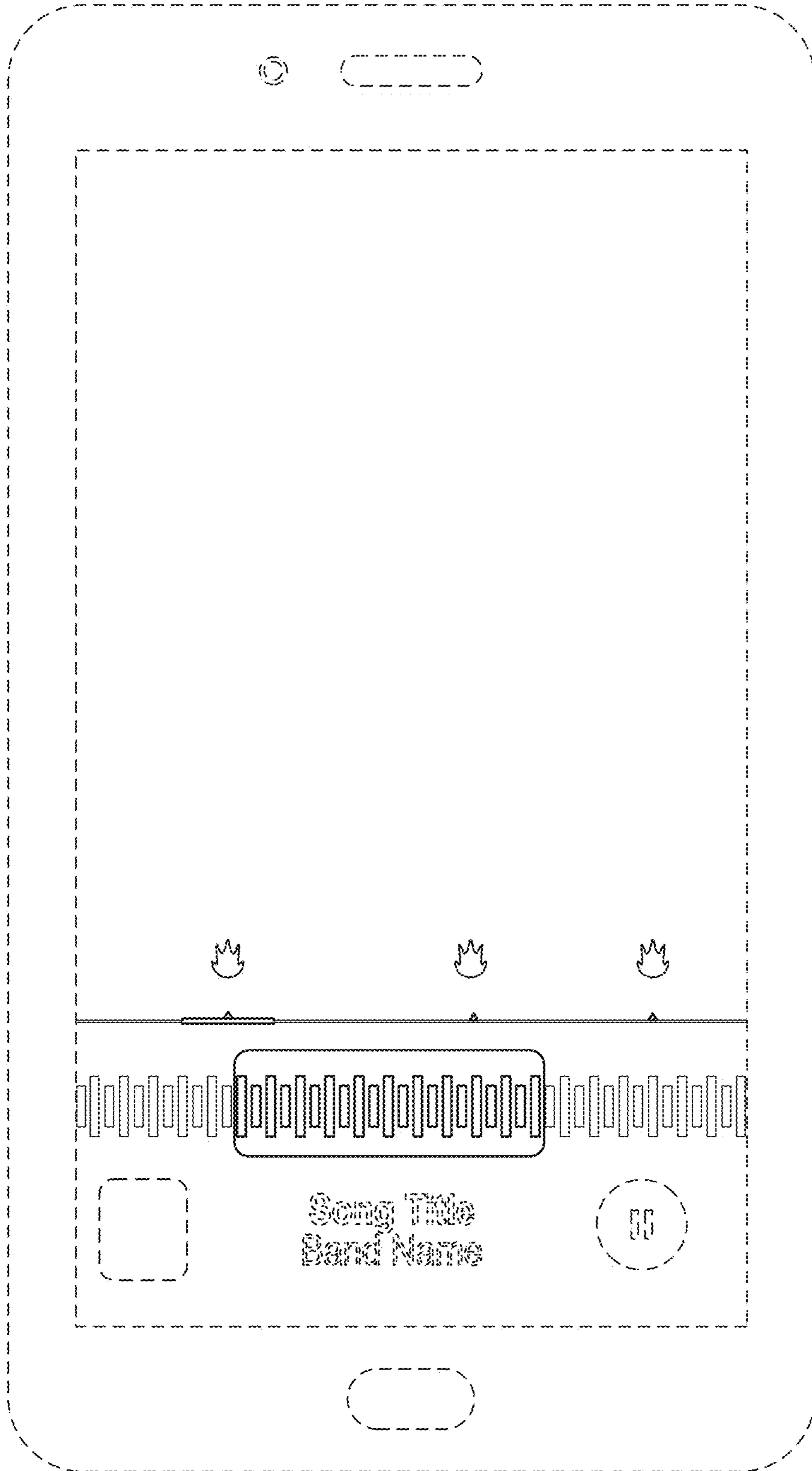

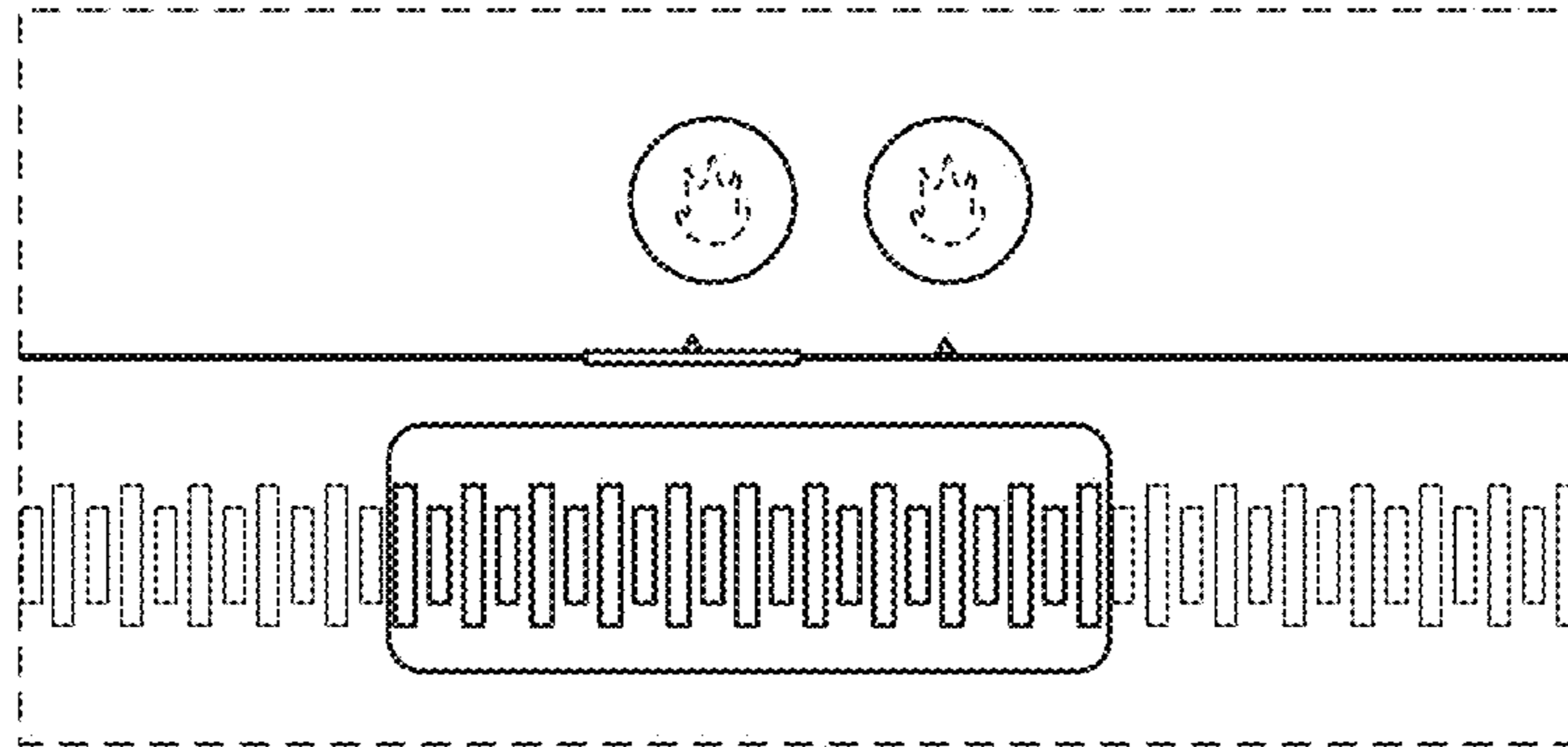

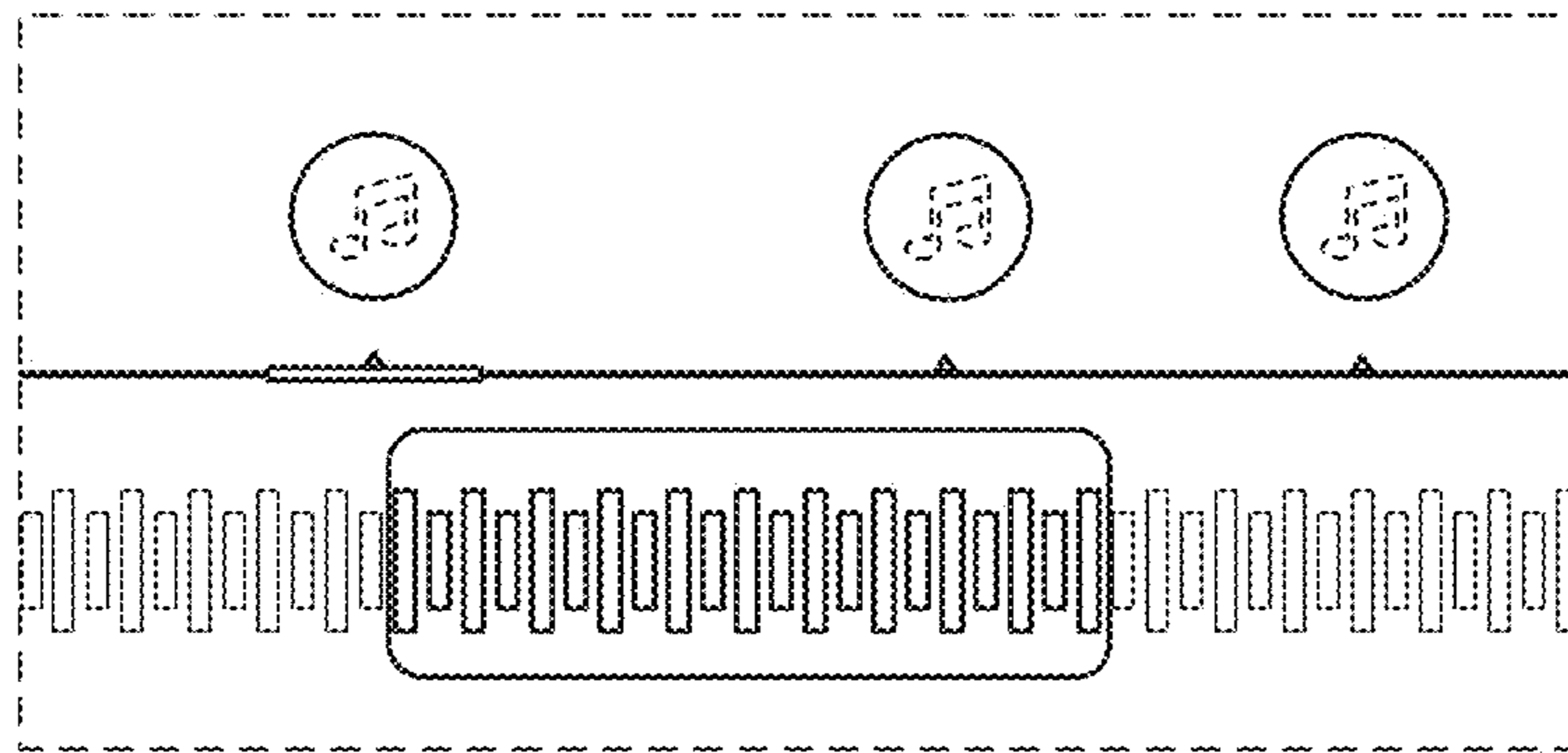

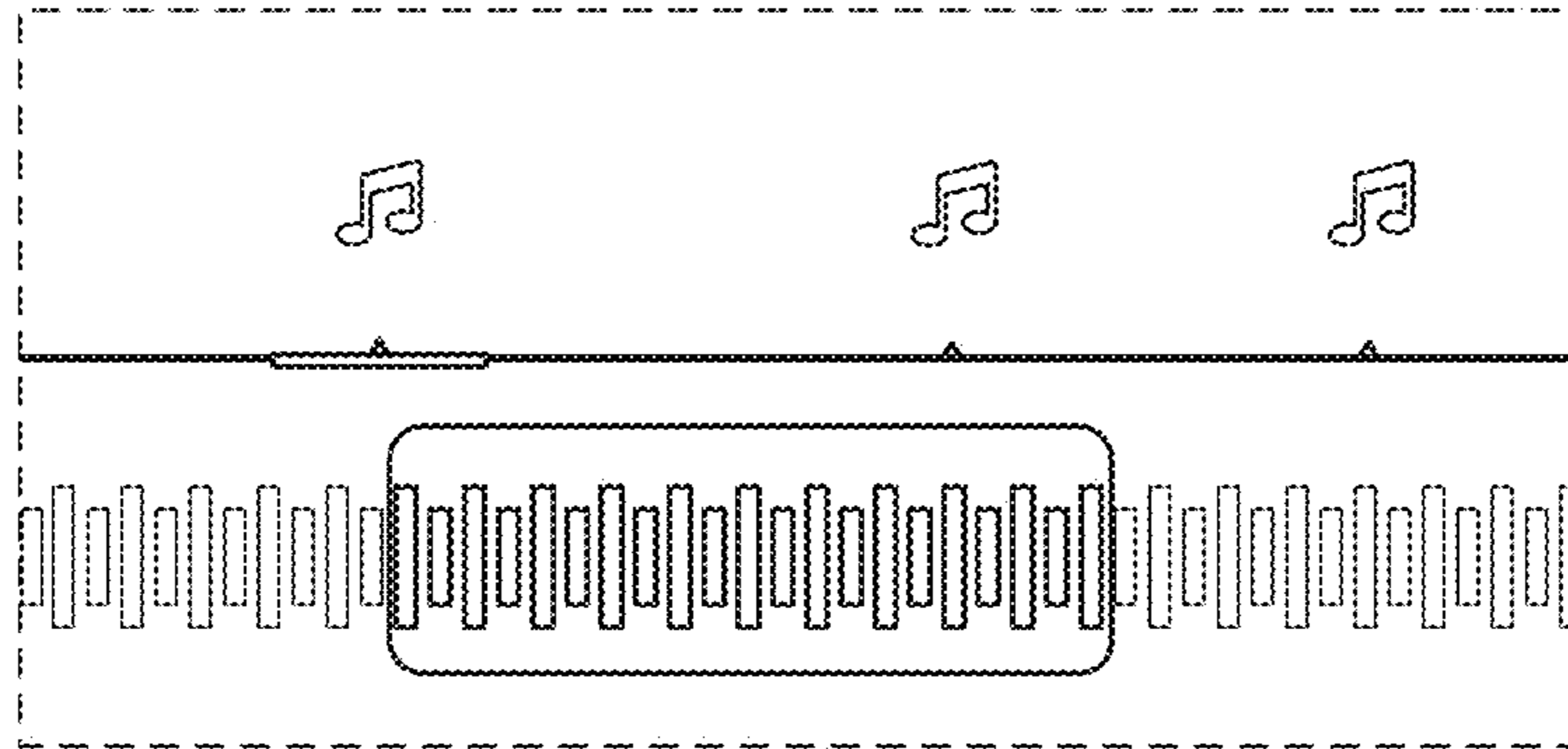

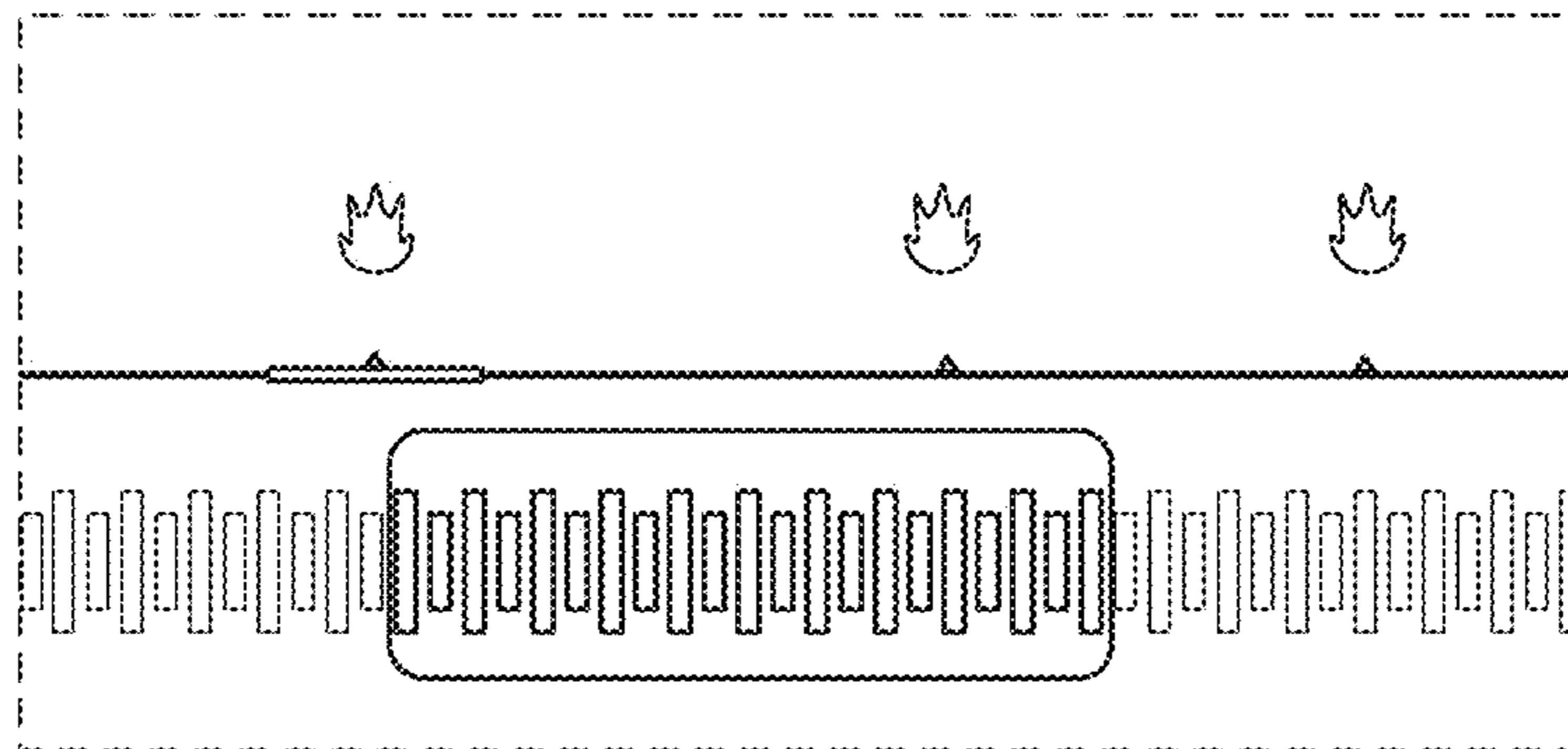
