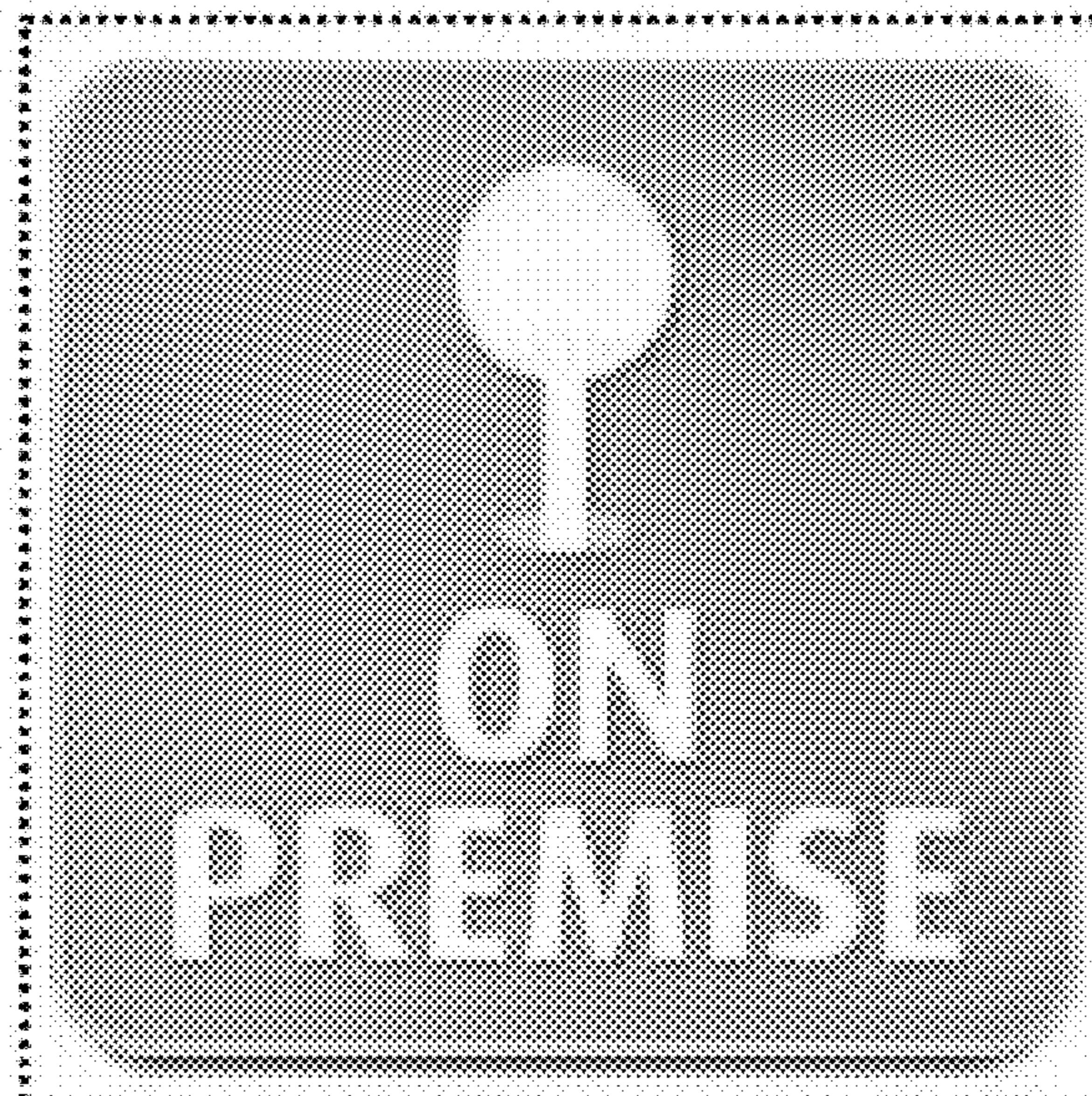
FIG. 1 is a front view of a display screen or portion thereof with a computer-generated icon, according to a first embodiment our new design; and,

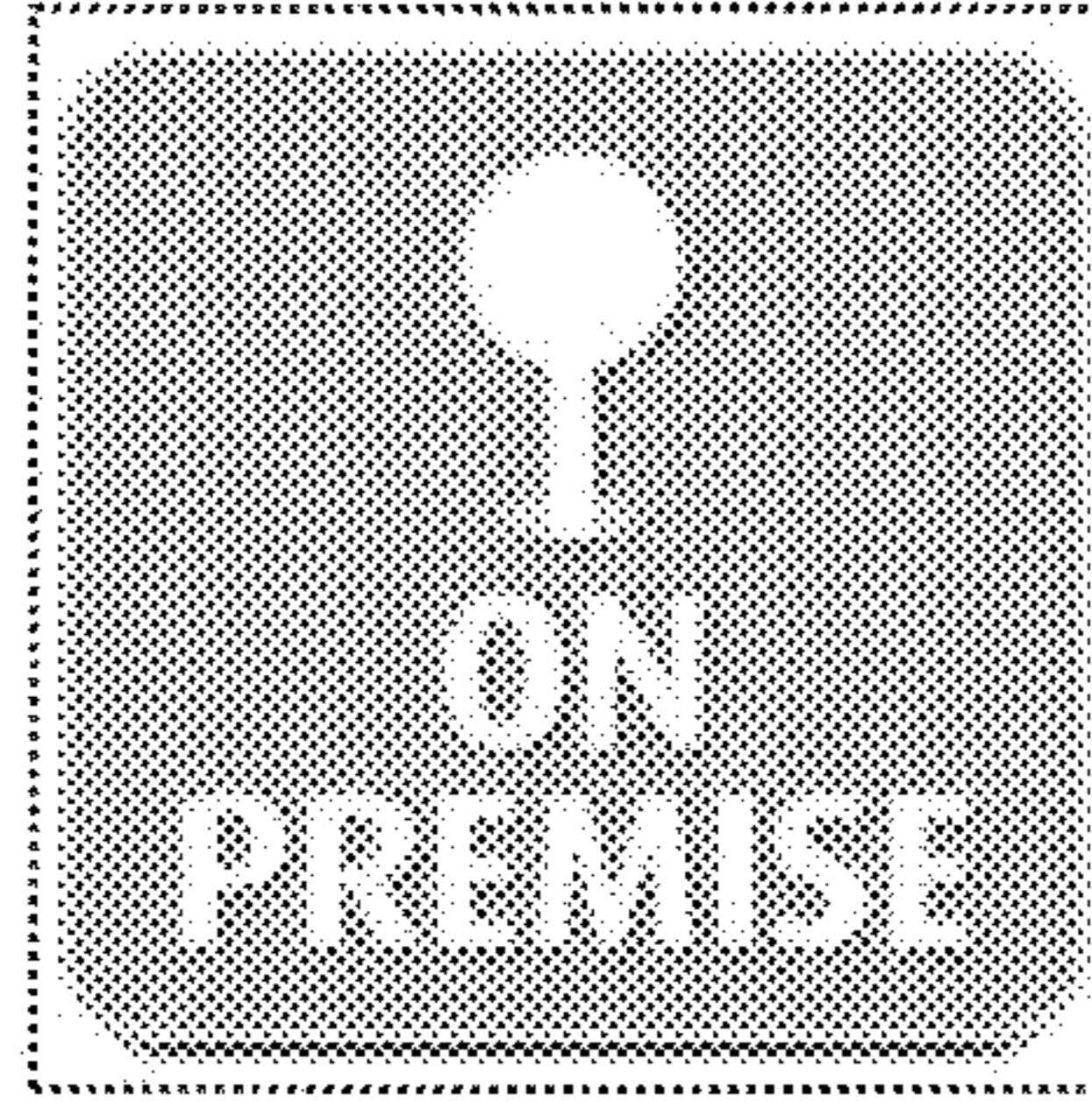

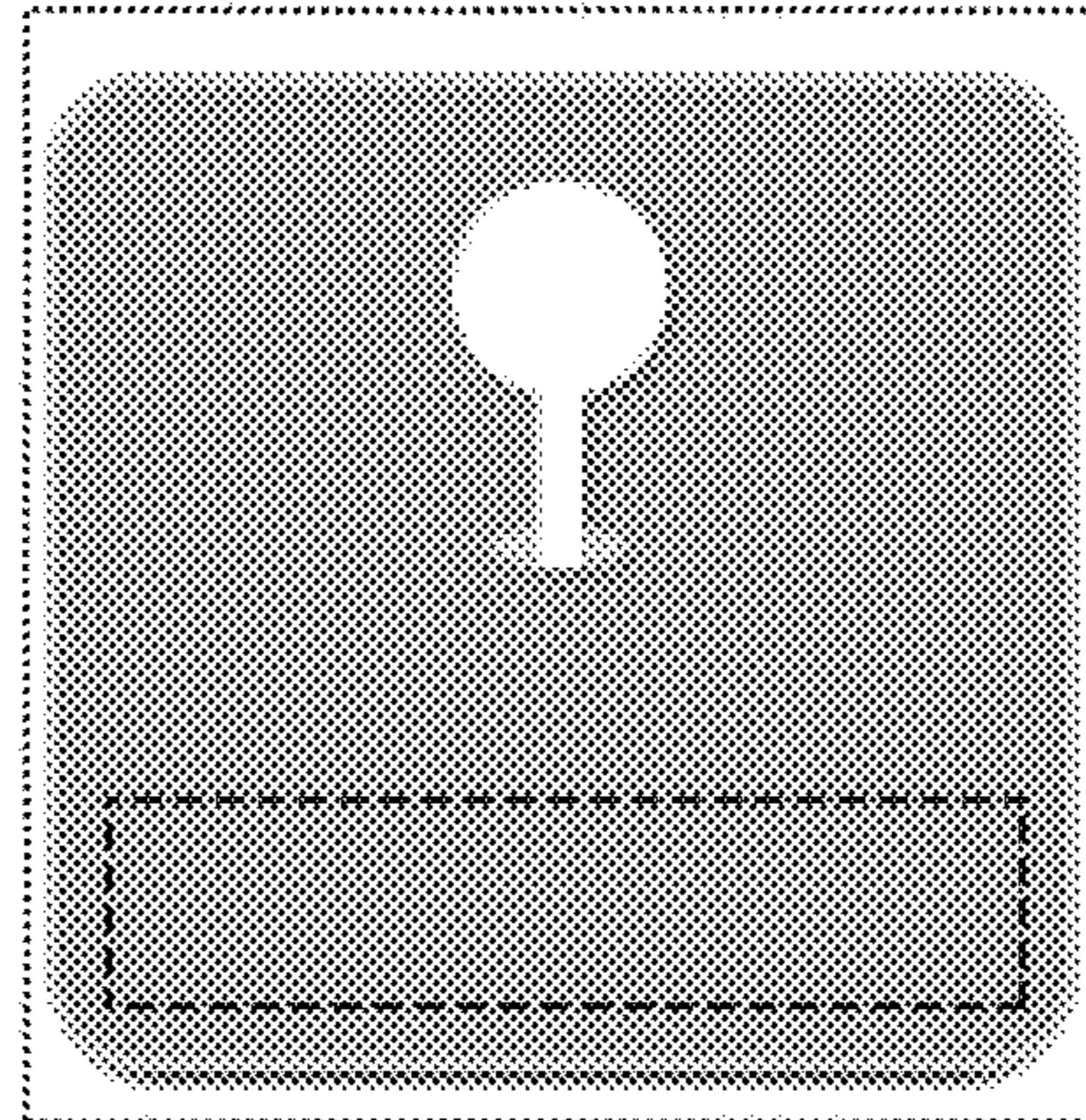
