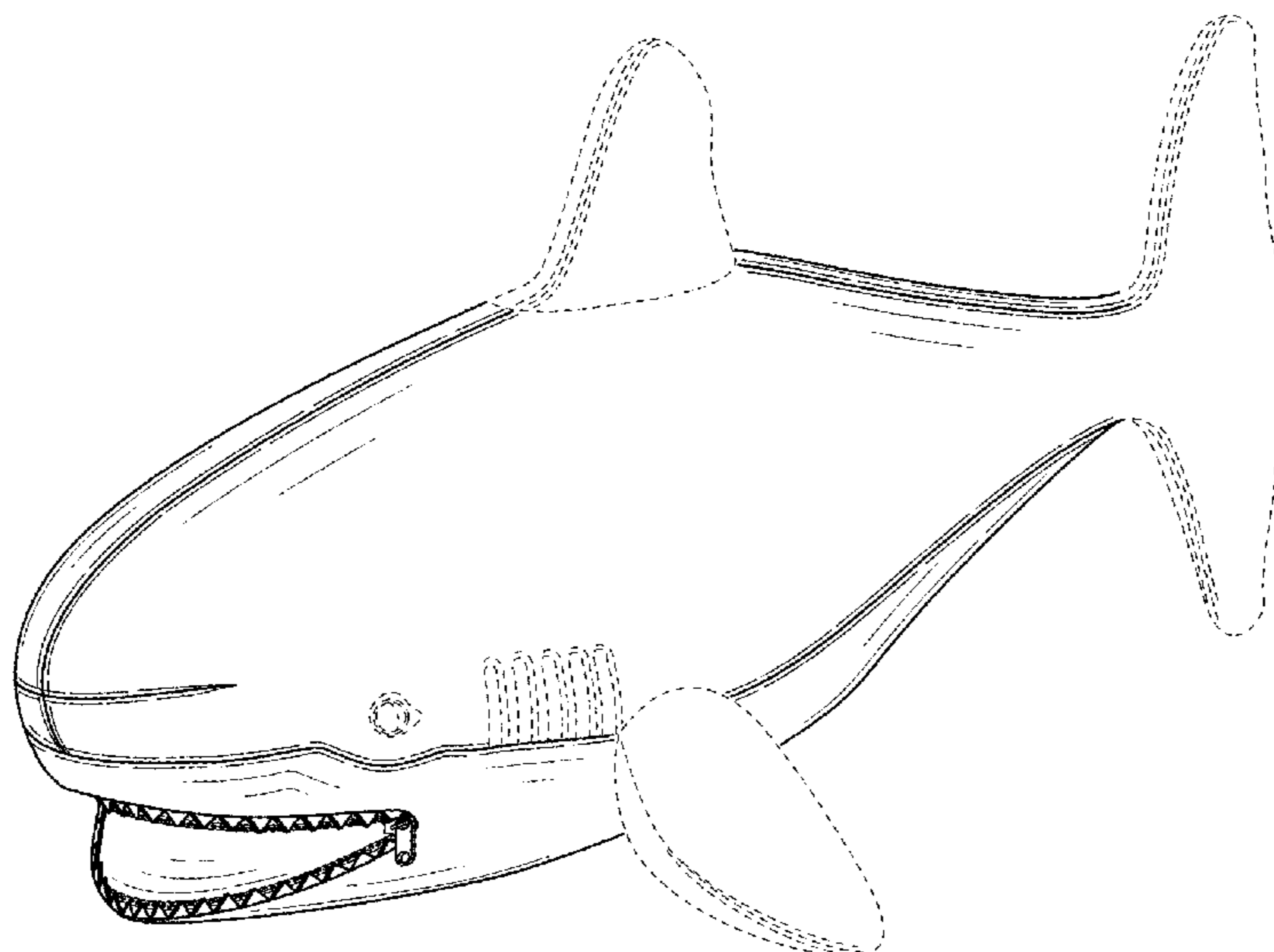
(57) **CLAIM**

The ornamental design for a stuffed animal, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of the stuffed animal with a zipper in a closed position;  
FIG. 2 is a bottom, rear, left side perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a left side view thereof;

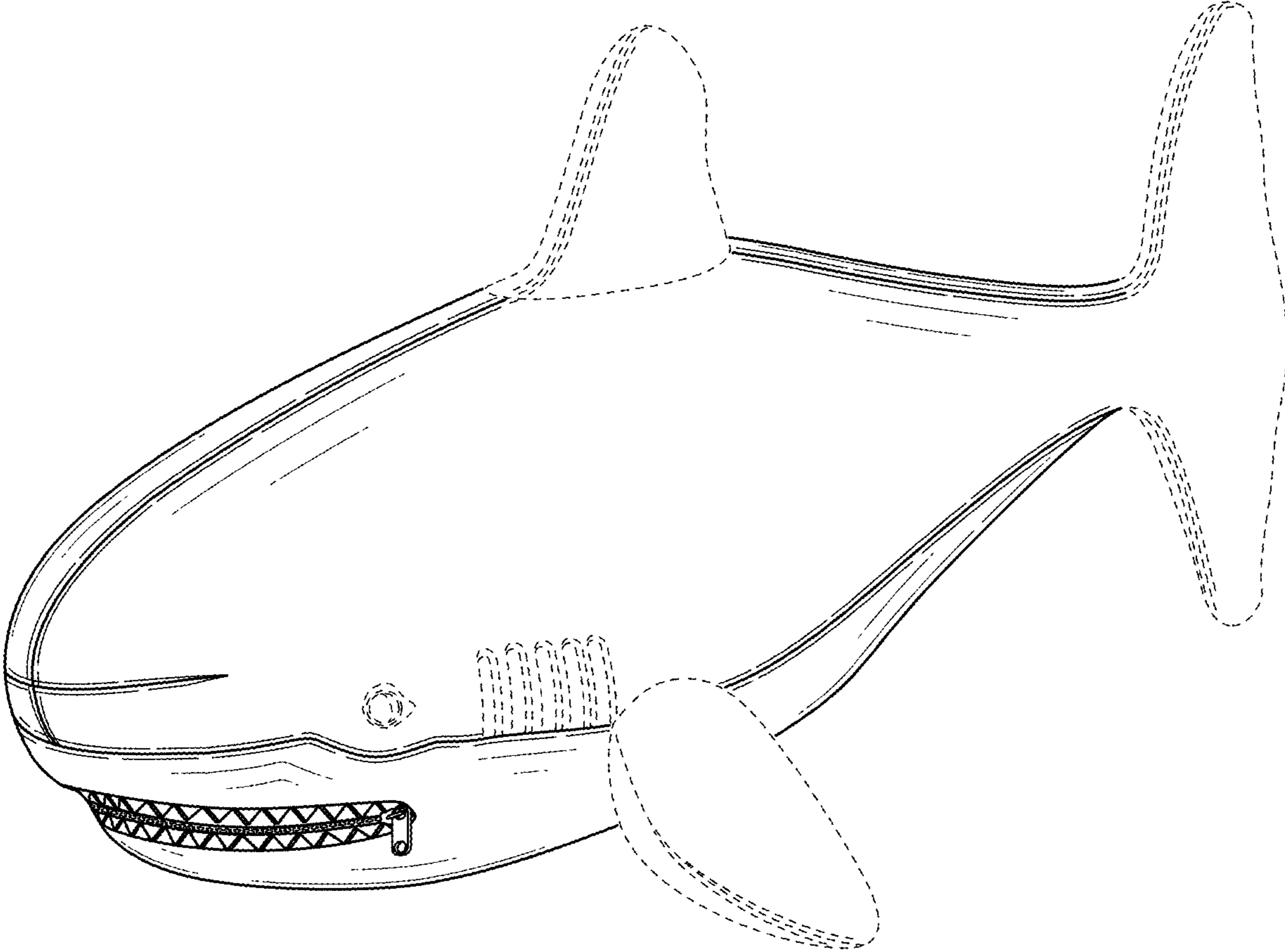

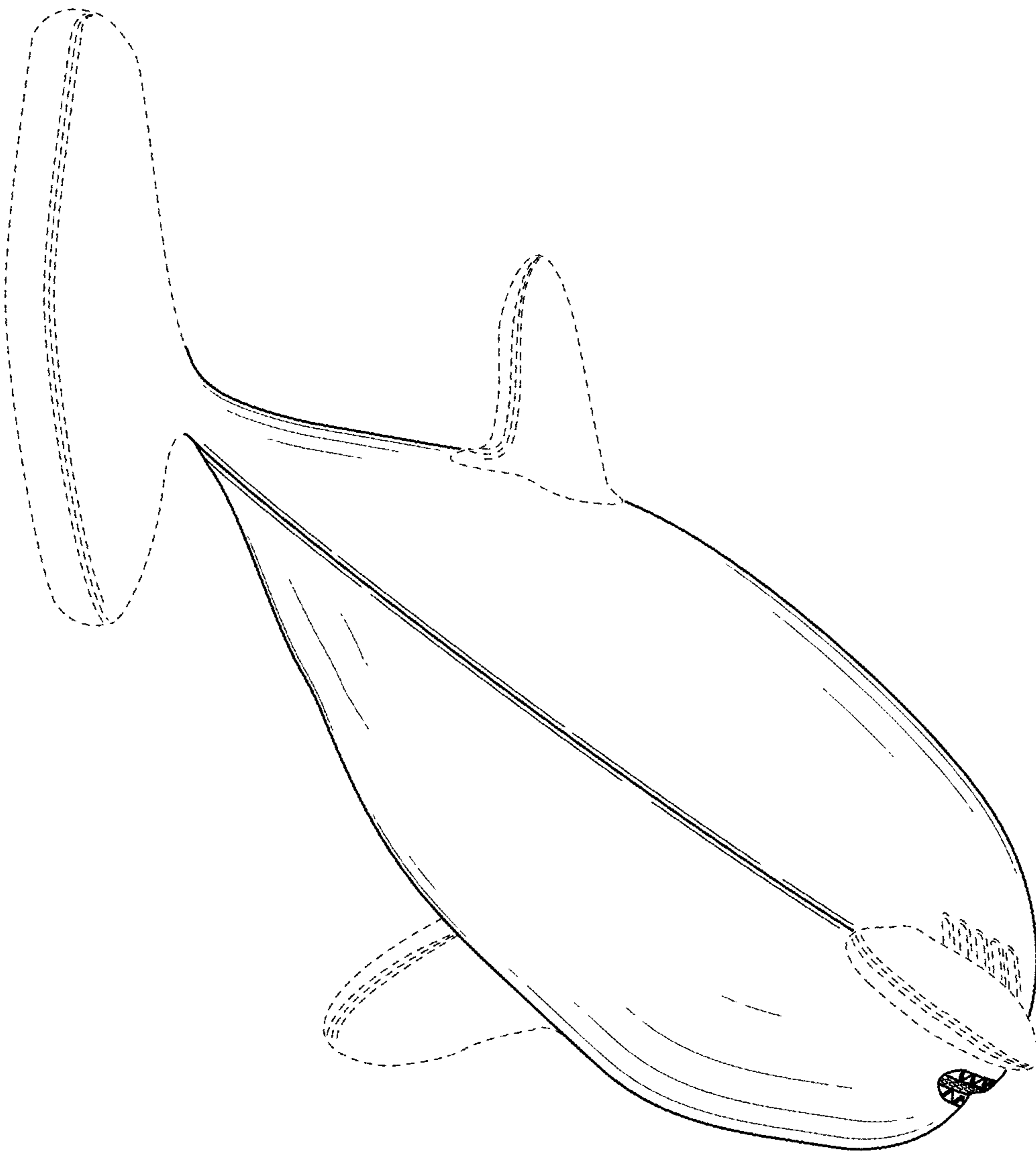

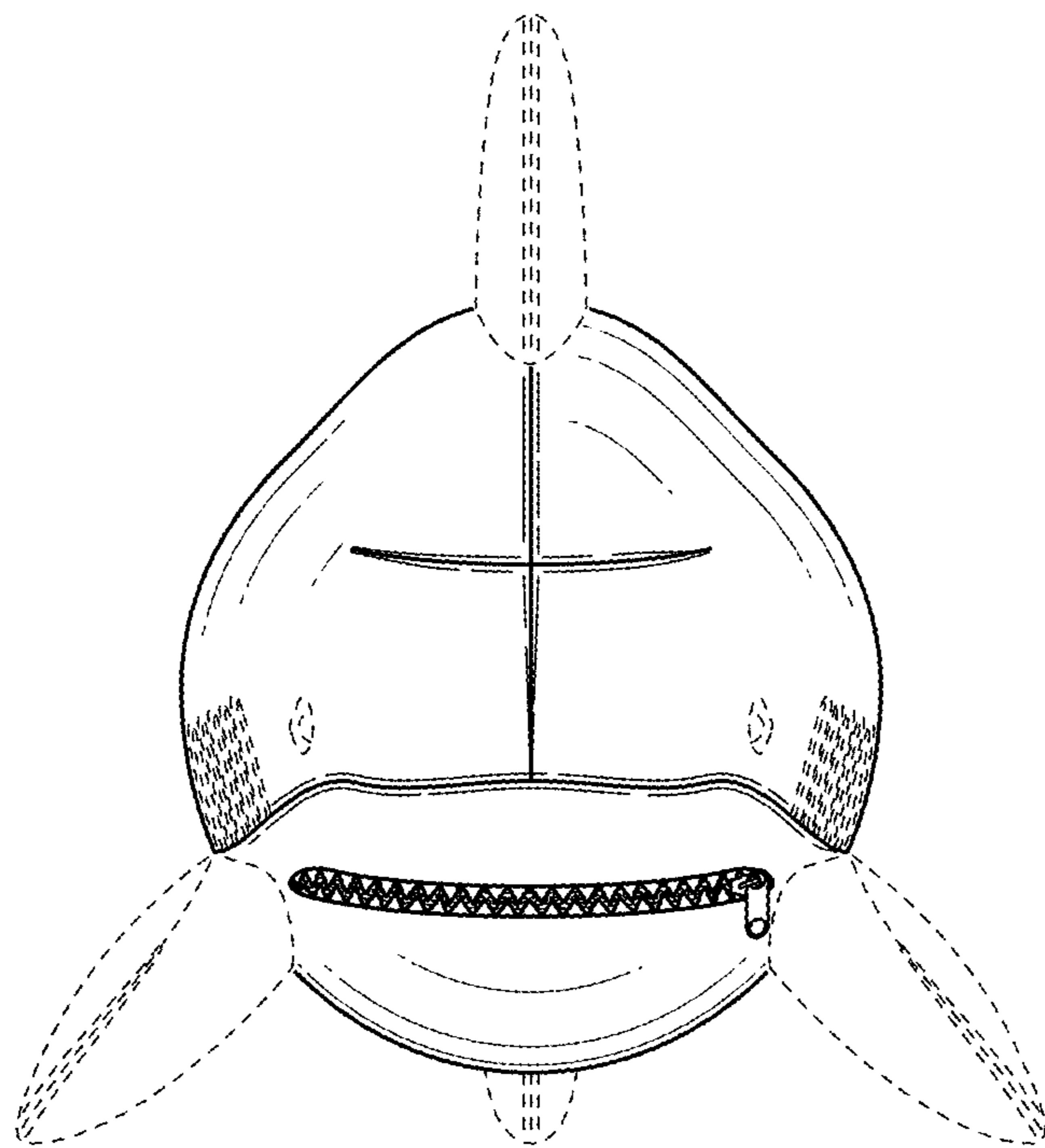

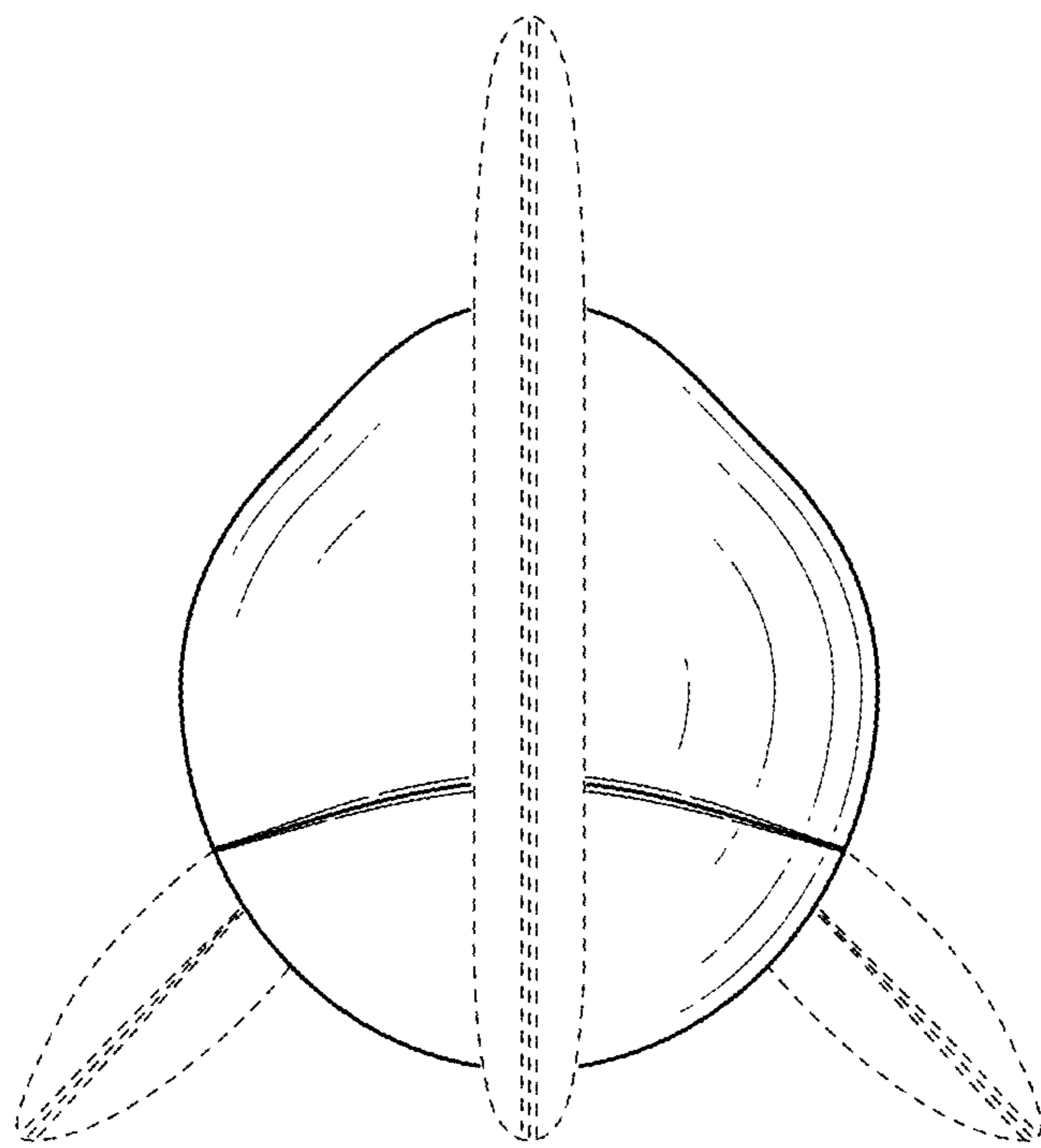

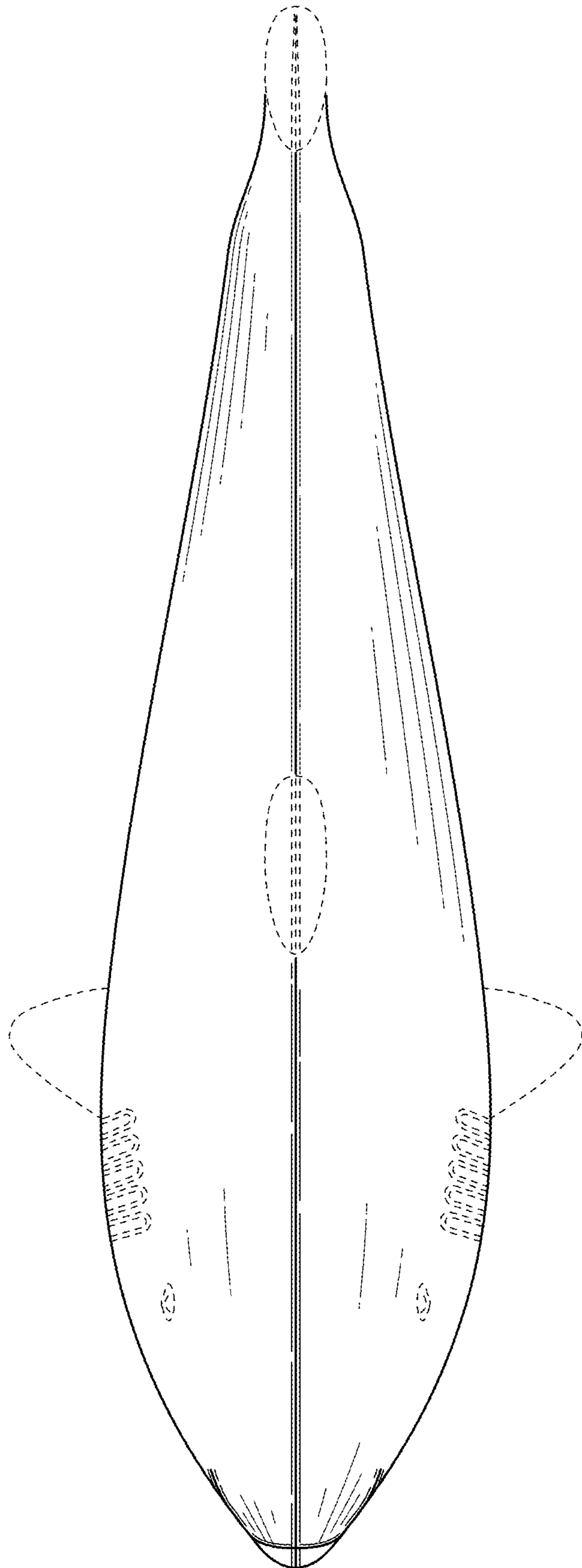

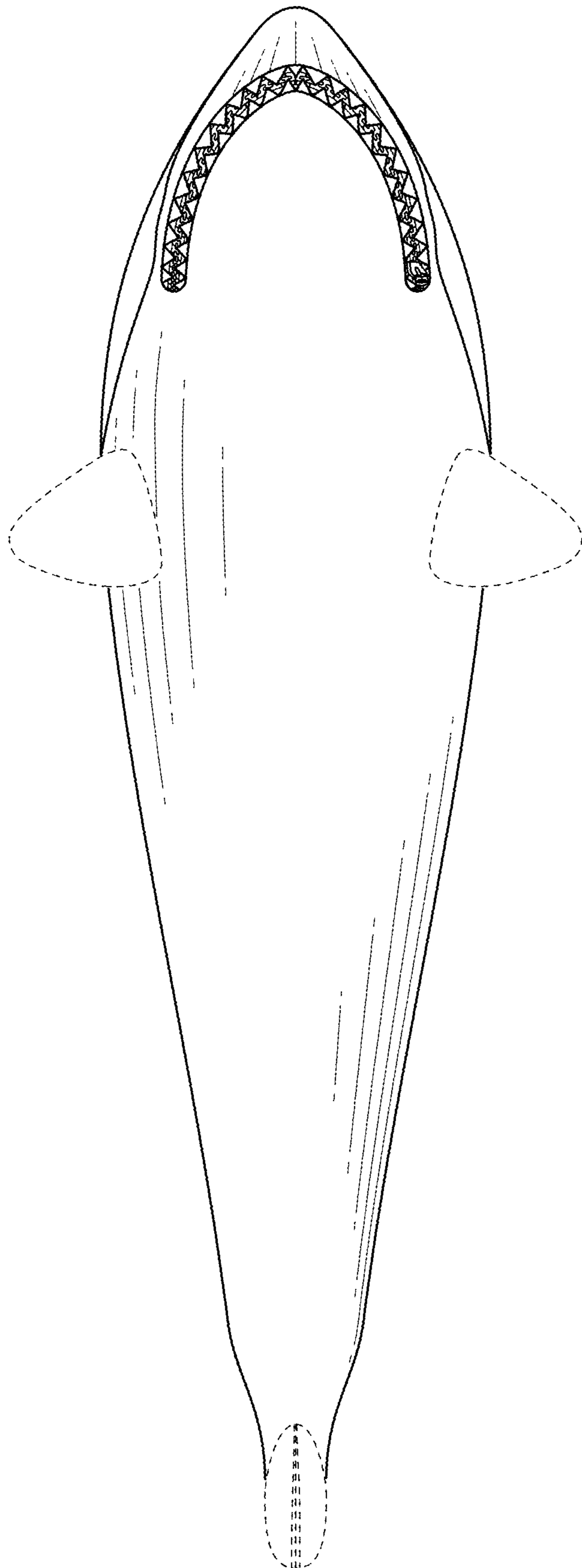

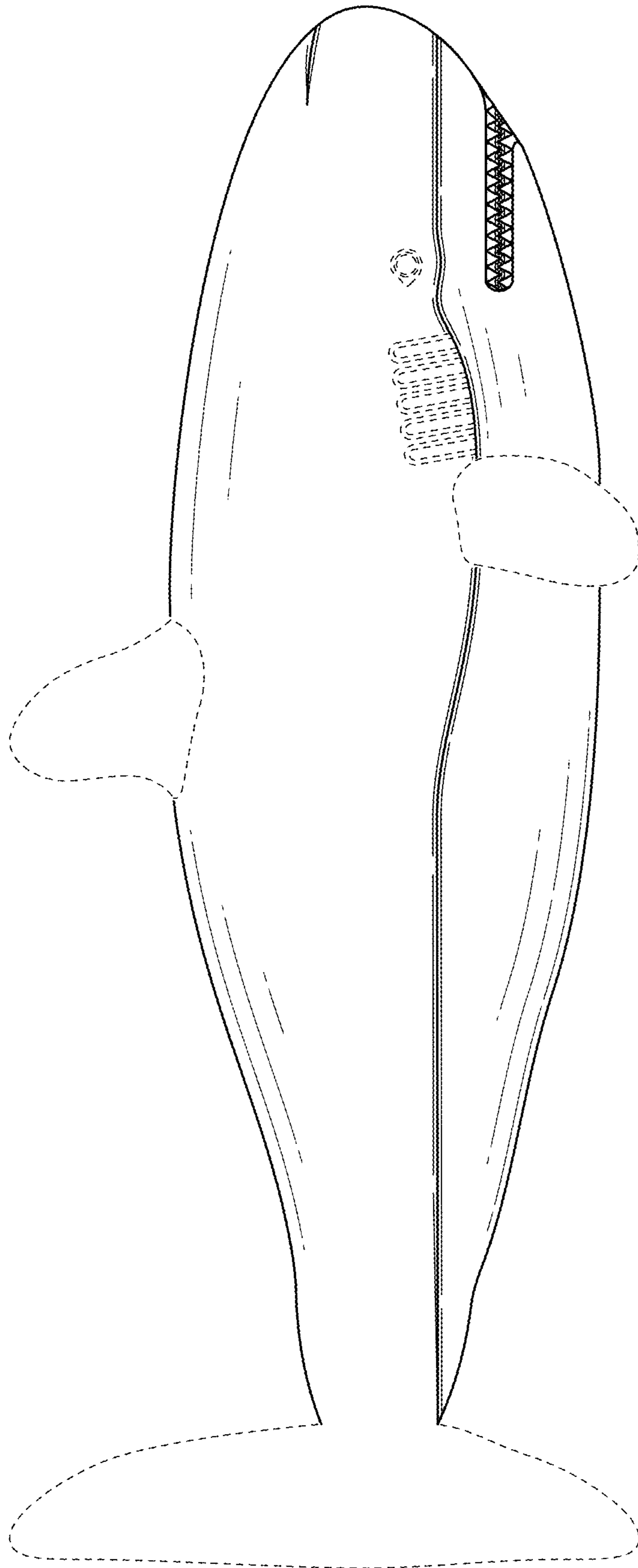

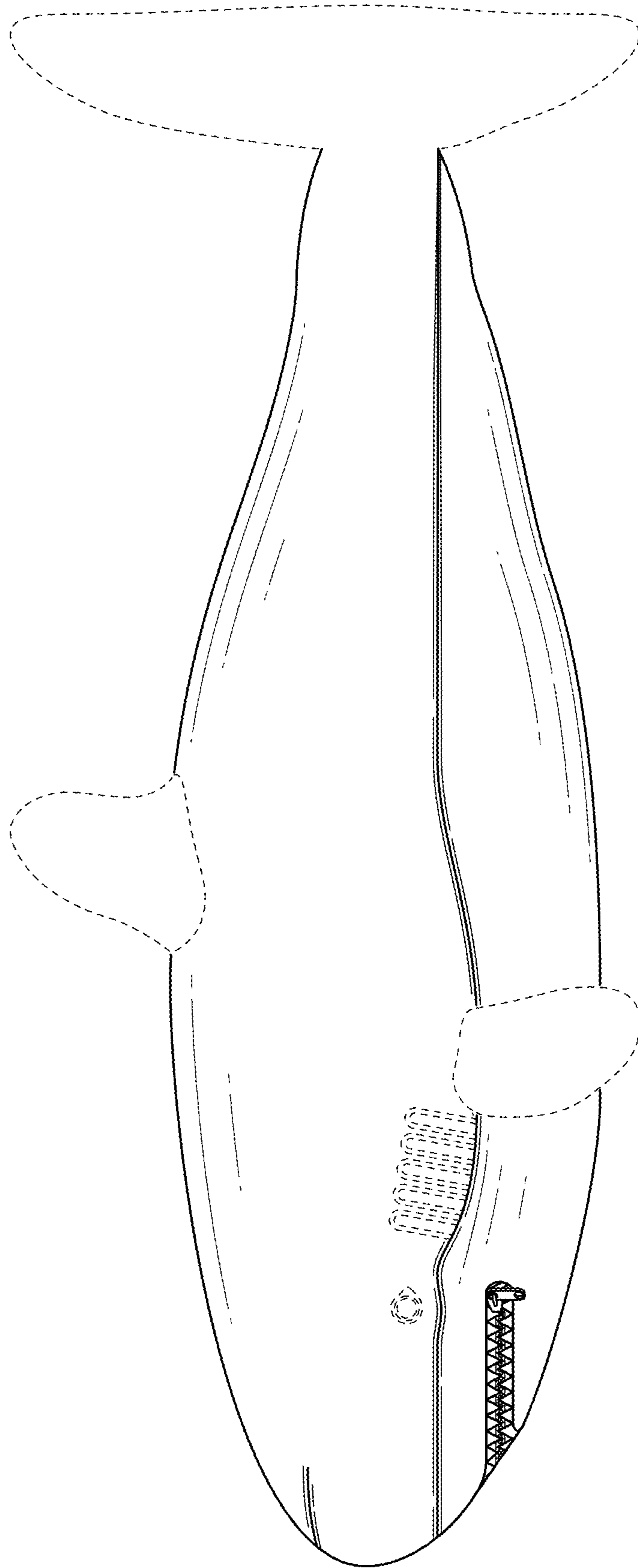

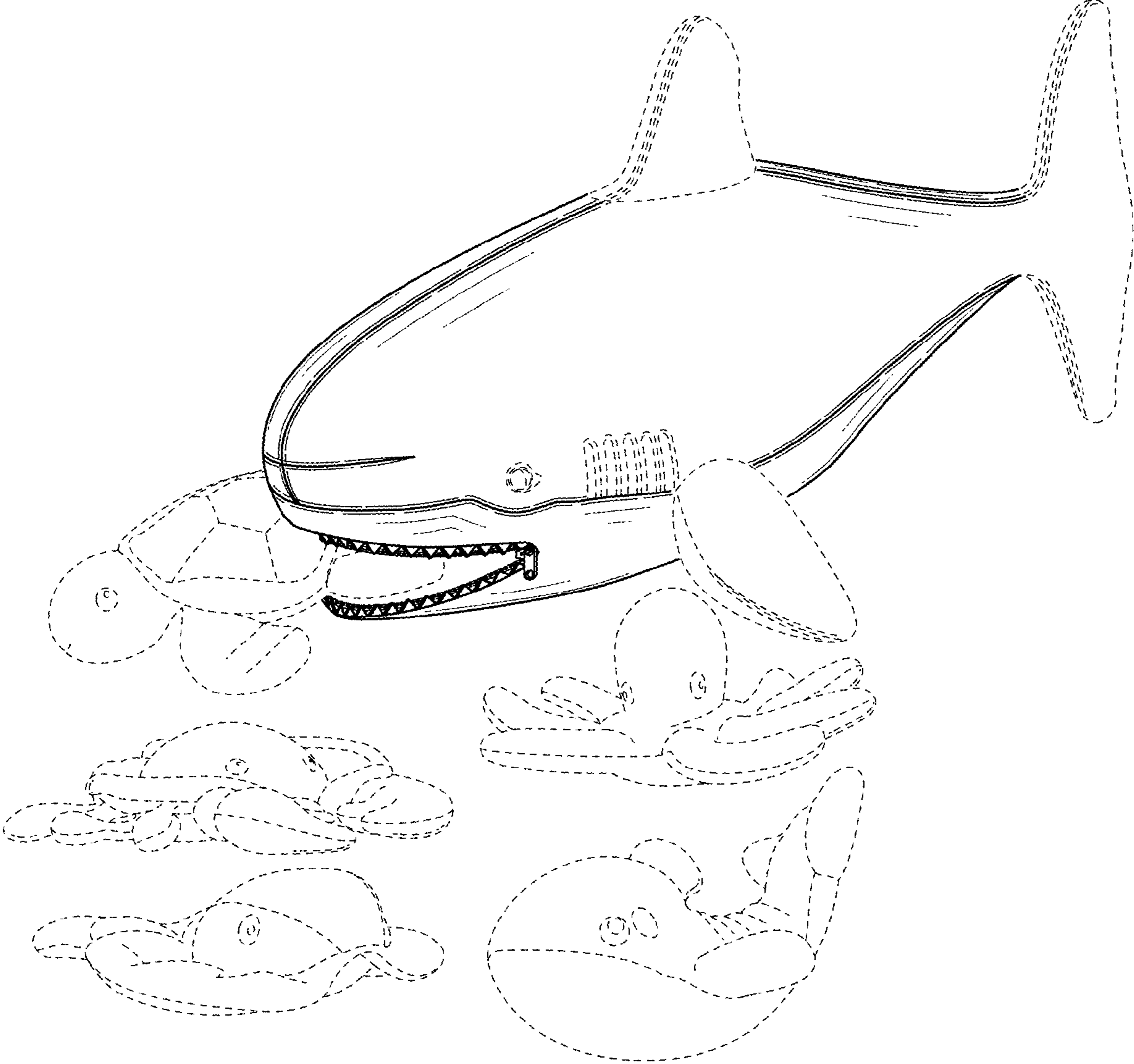

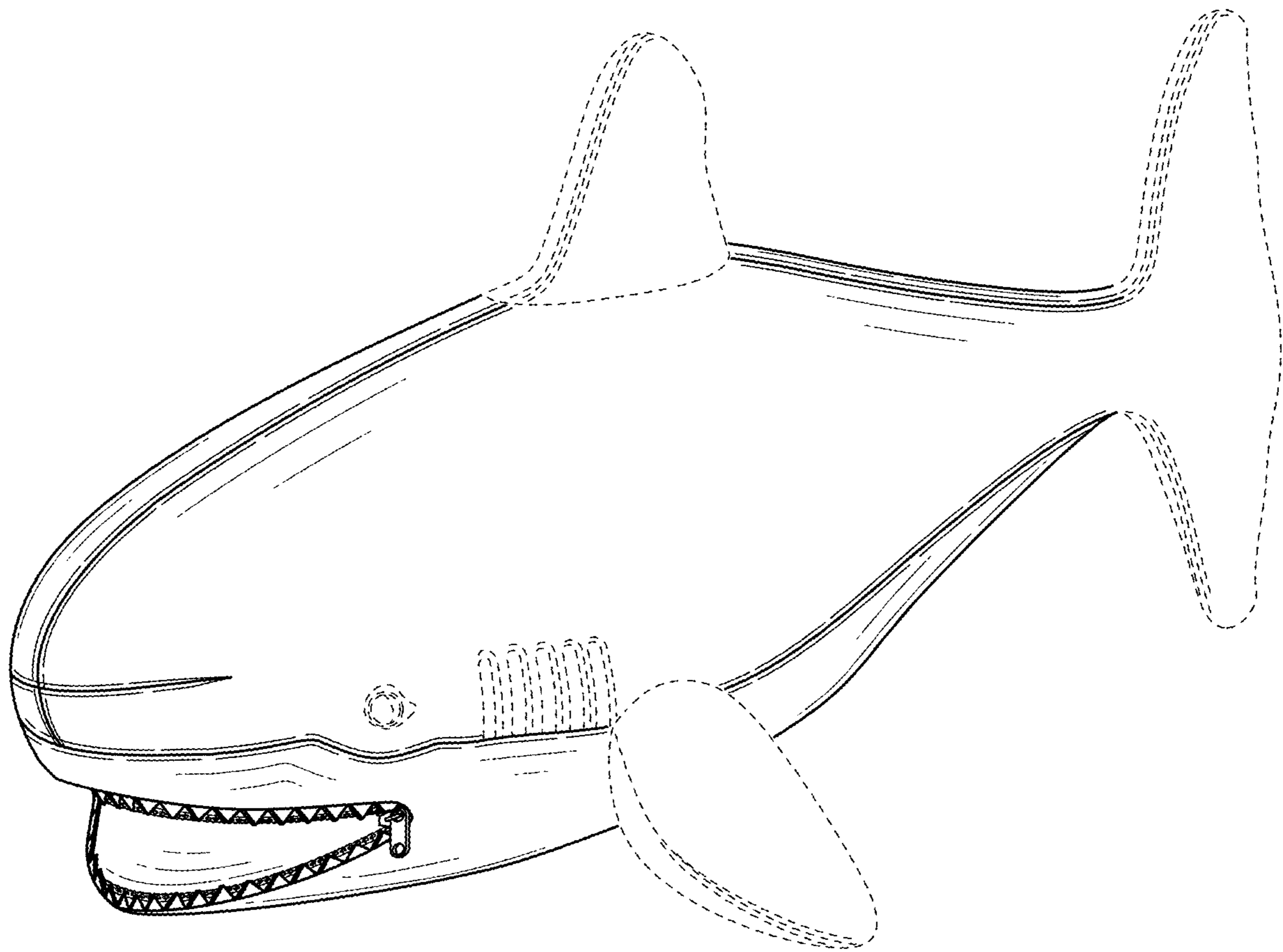

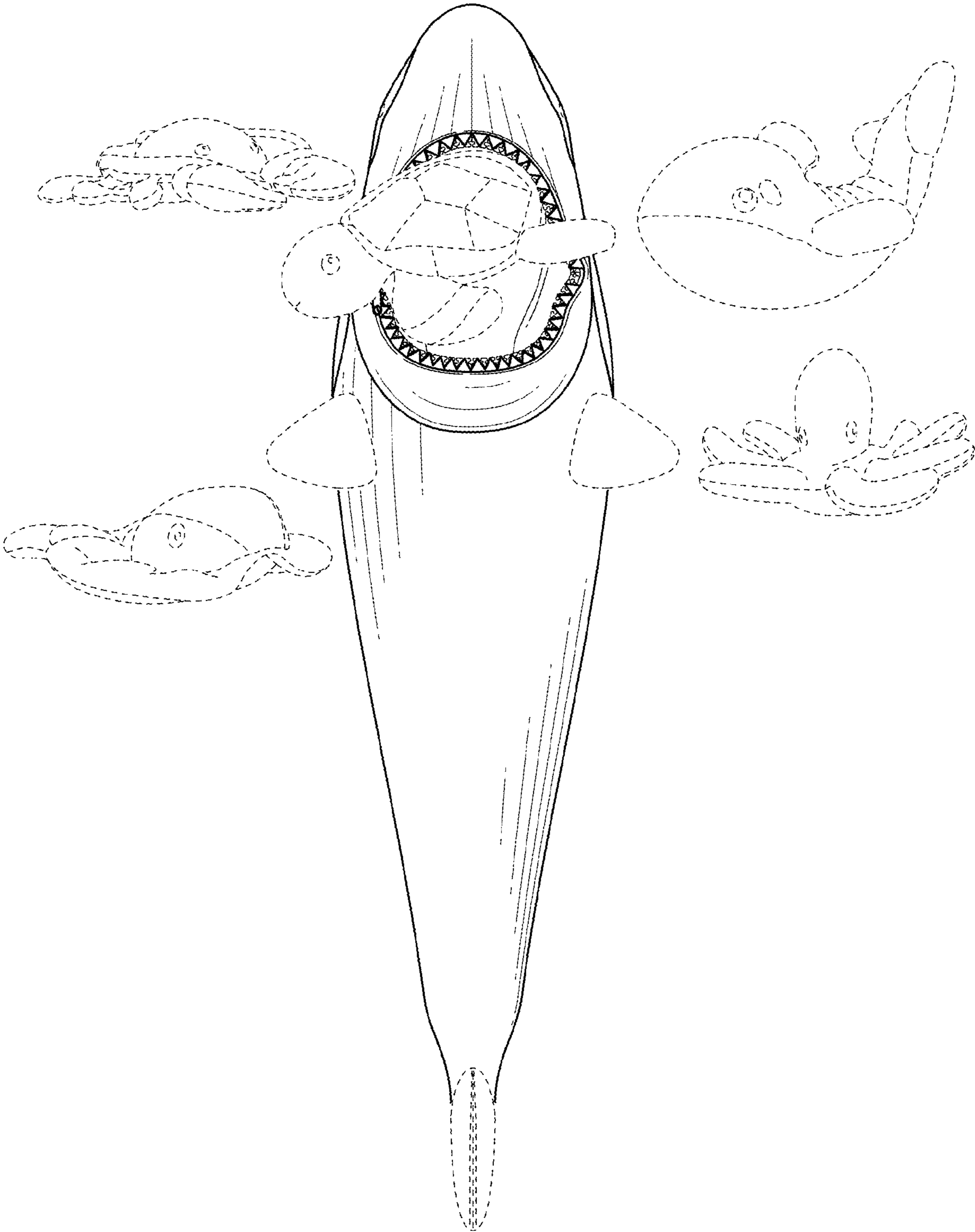
