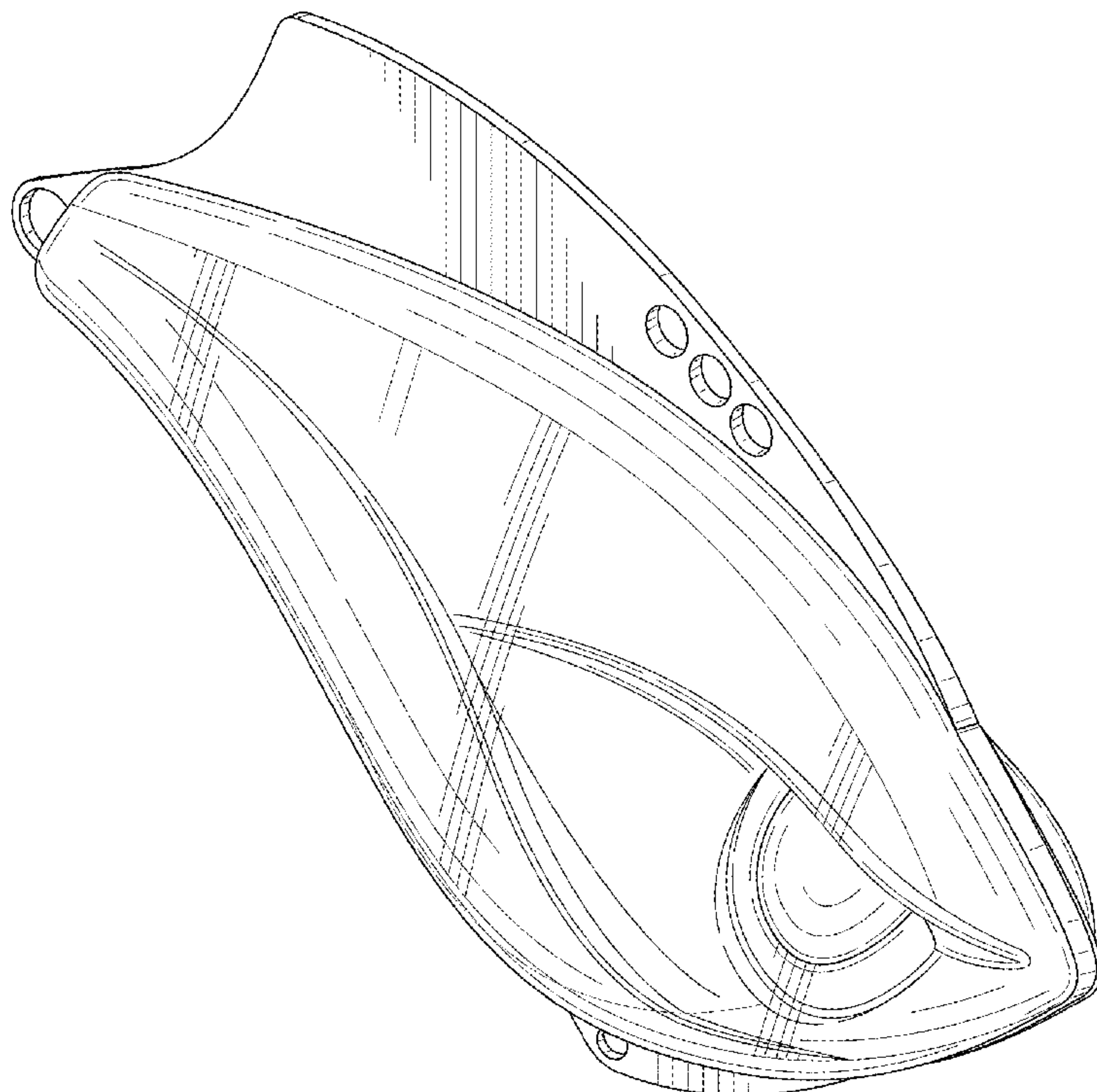
(57) **CLAIM**

The ornamental design for a blade bait fishing lure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the blade bait fishing lure; FIG. 2 is a side view of the blade bait fishing lure of FIG. 1; FIG. 3 is an opposite side view of the blade bait fishing lure of FIG. 1; FIG. 4 is a top view of the blade bait fishing lure of FIG. 1; FIG. 5 is a bottom side view of the blade bait fishing lure of FIG. 1; FIG. 6 is a front view of the blade bait fishing lure of FIG. 1; and, FIG. 7 is a rear view of blade bait fishing lure of FIG. 1.

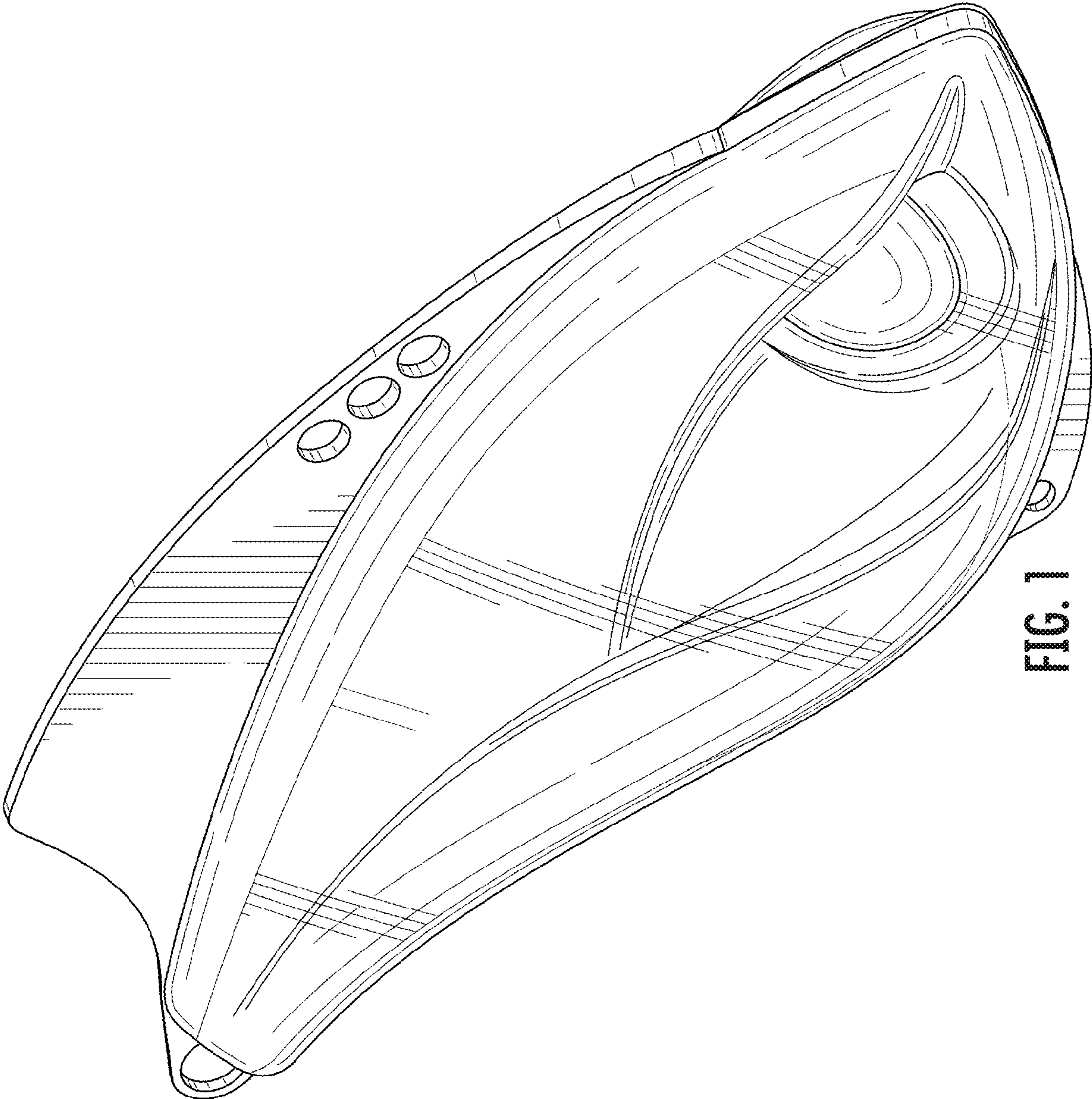

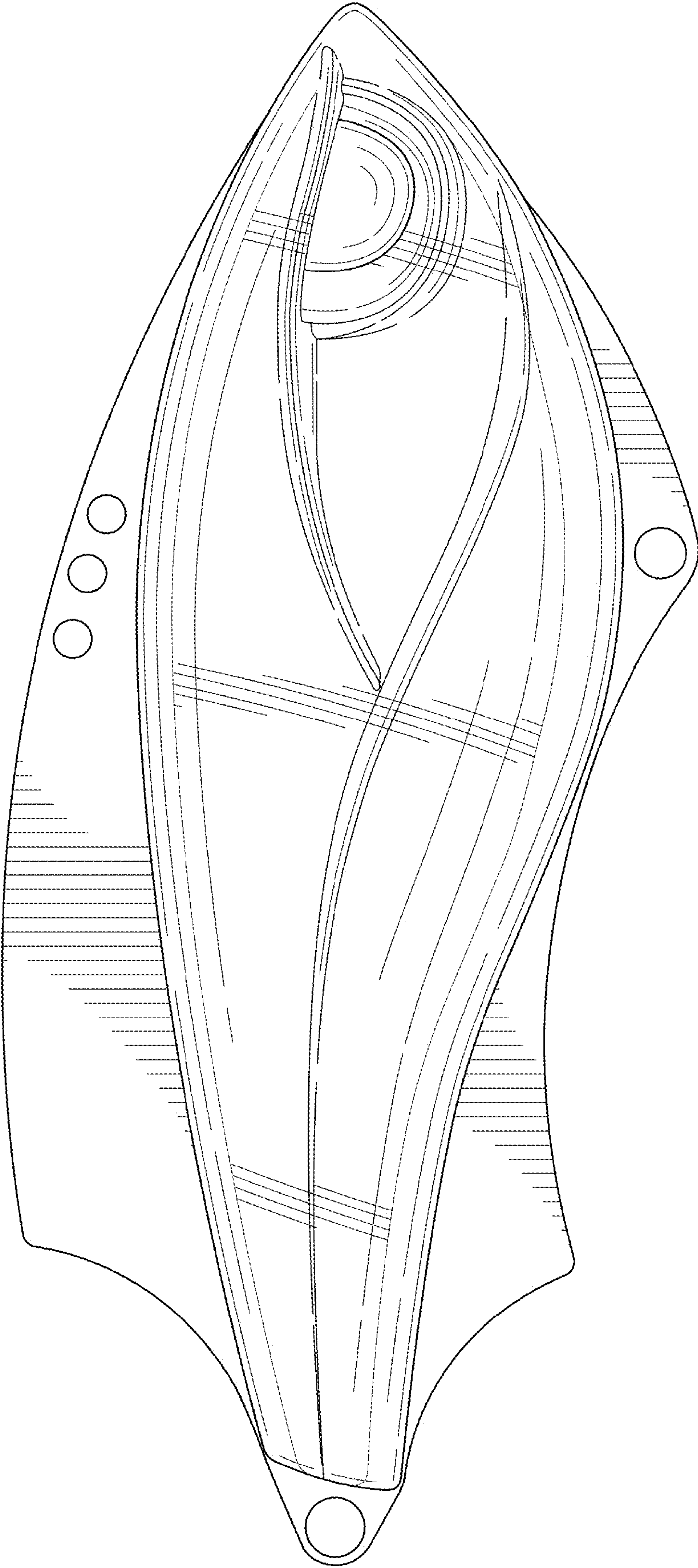

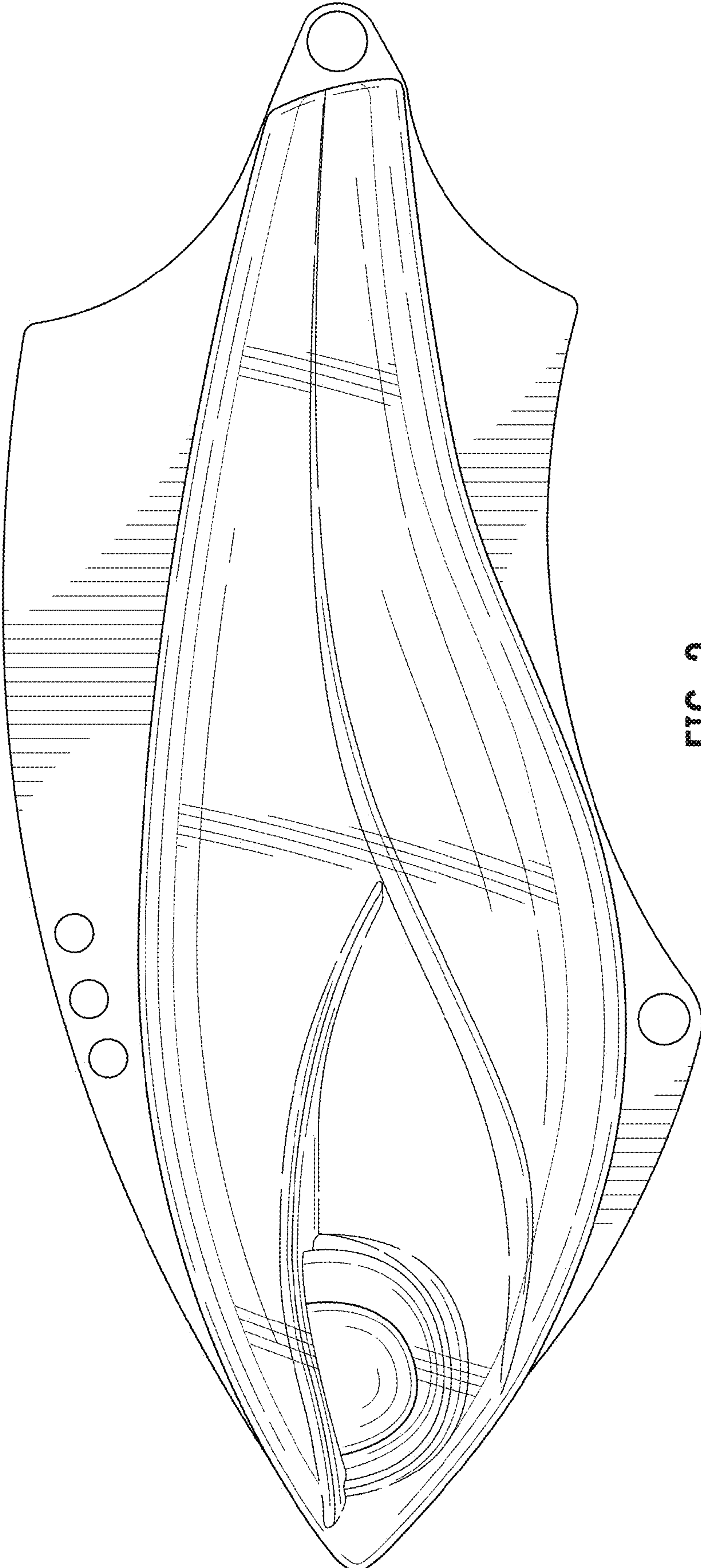

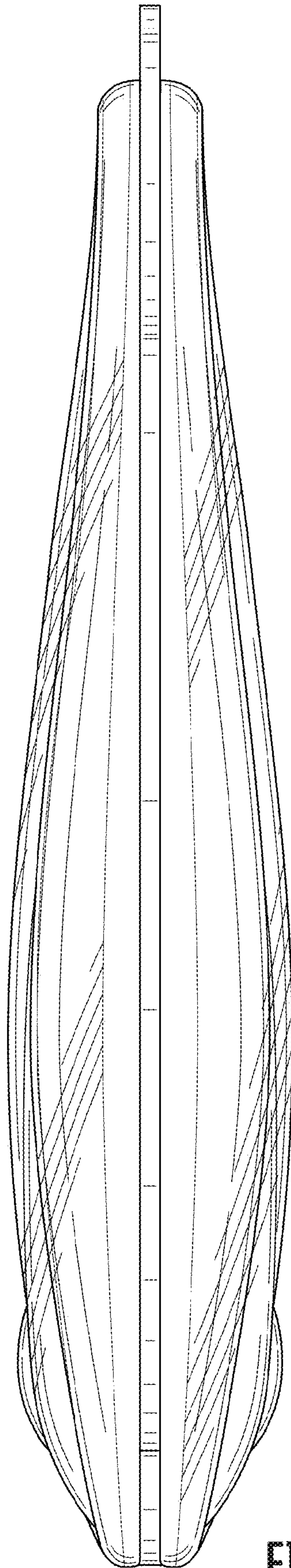

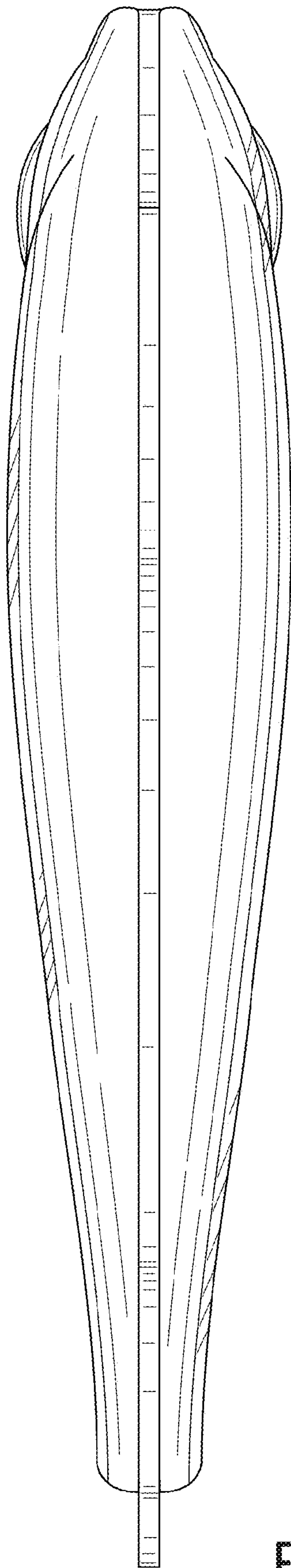

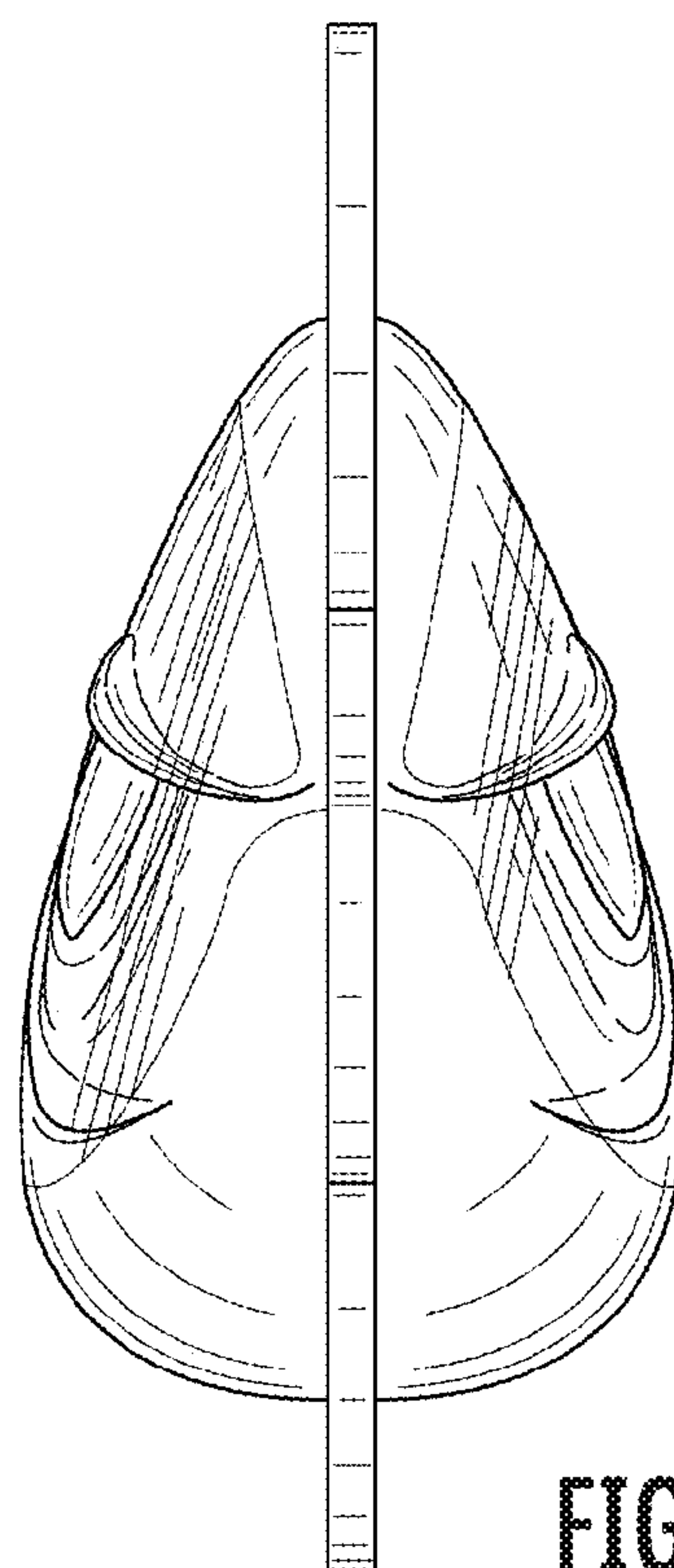

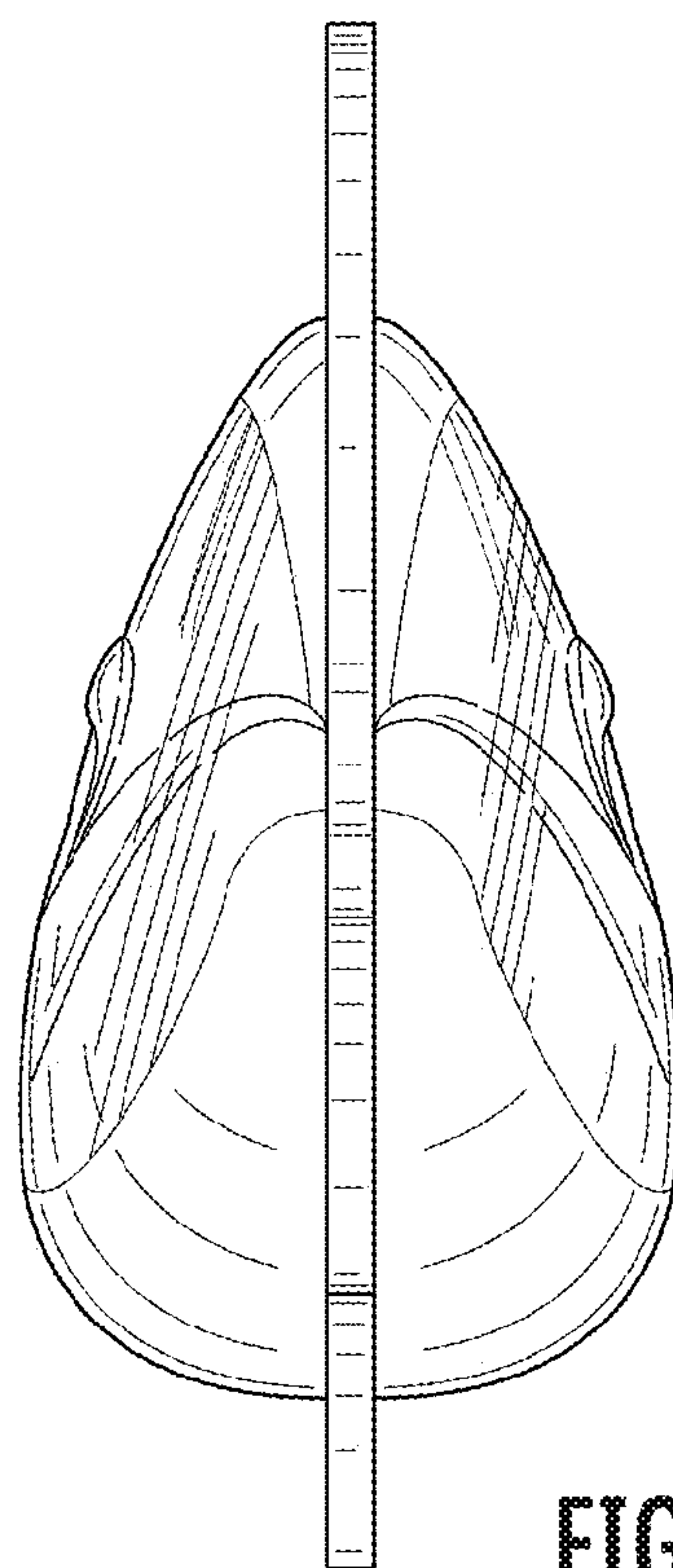
