FIG. 6 is a left elevational view thereof

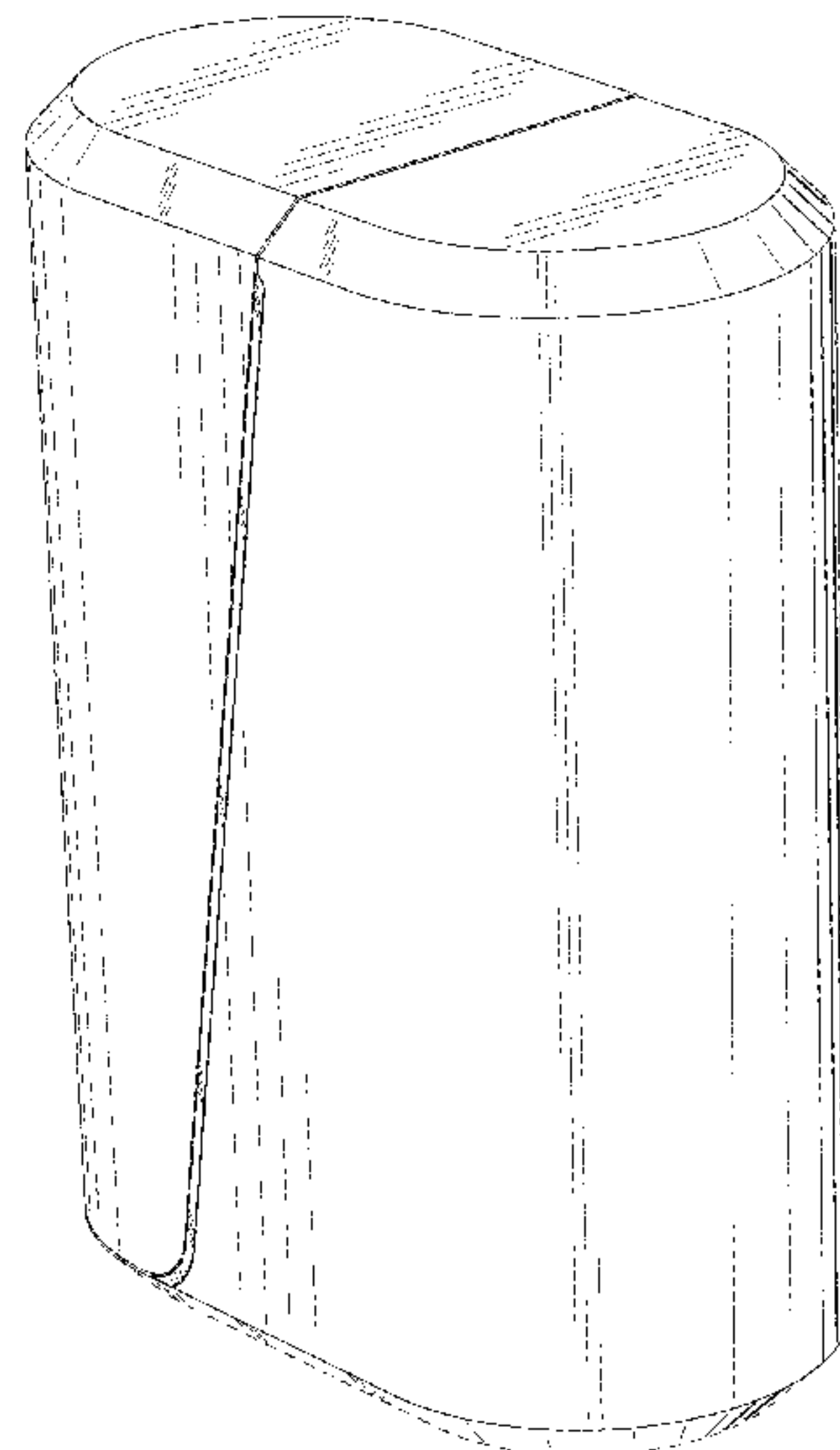
FIG. 7 is a top plan view thereof; and,

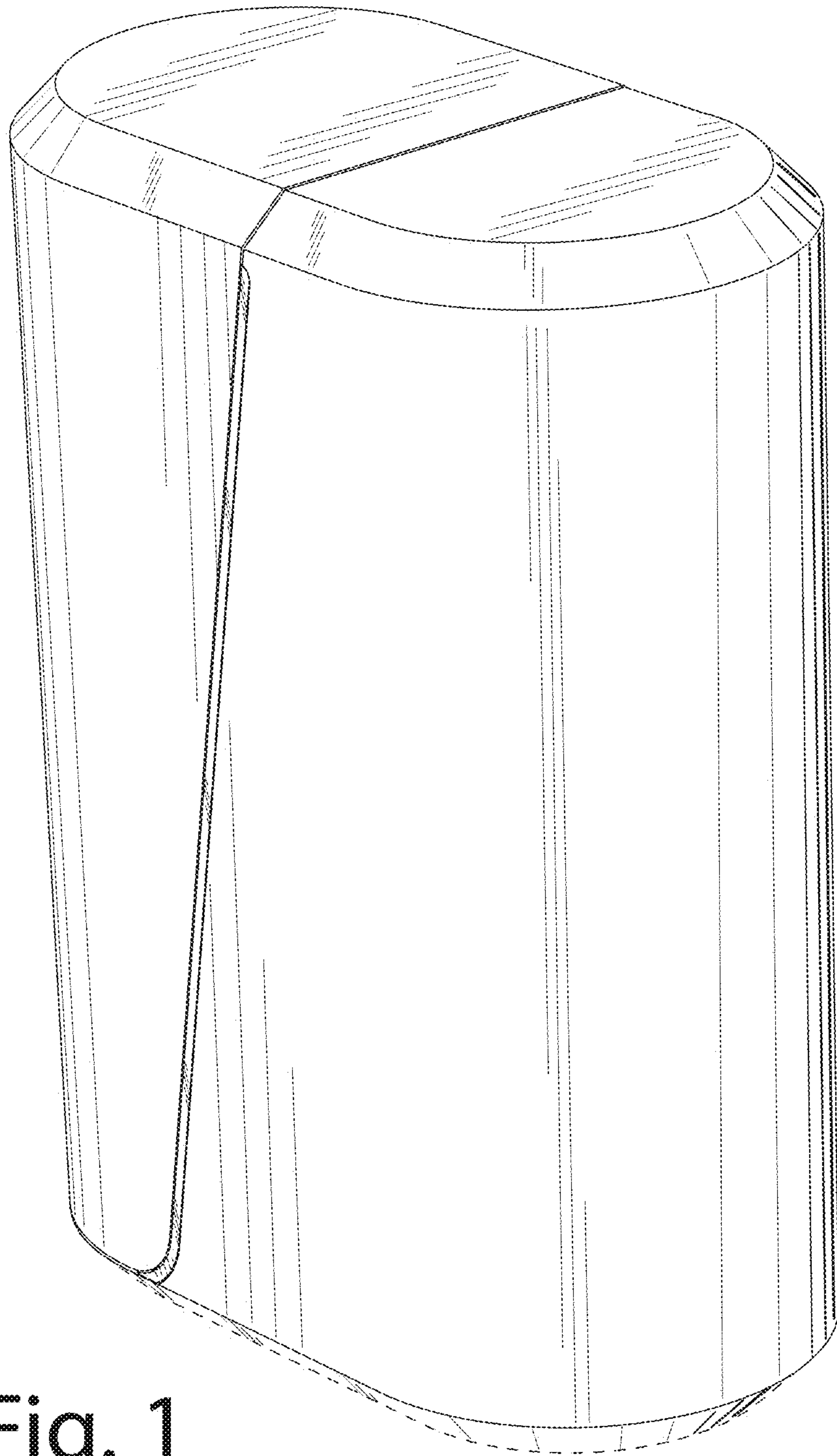

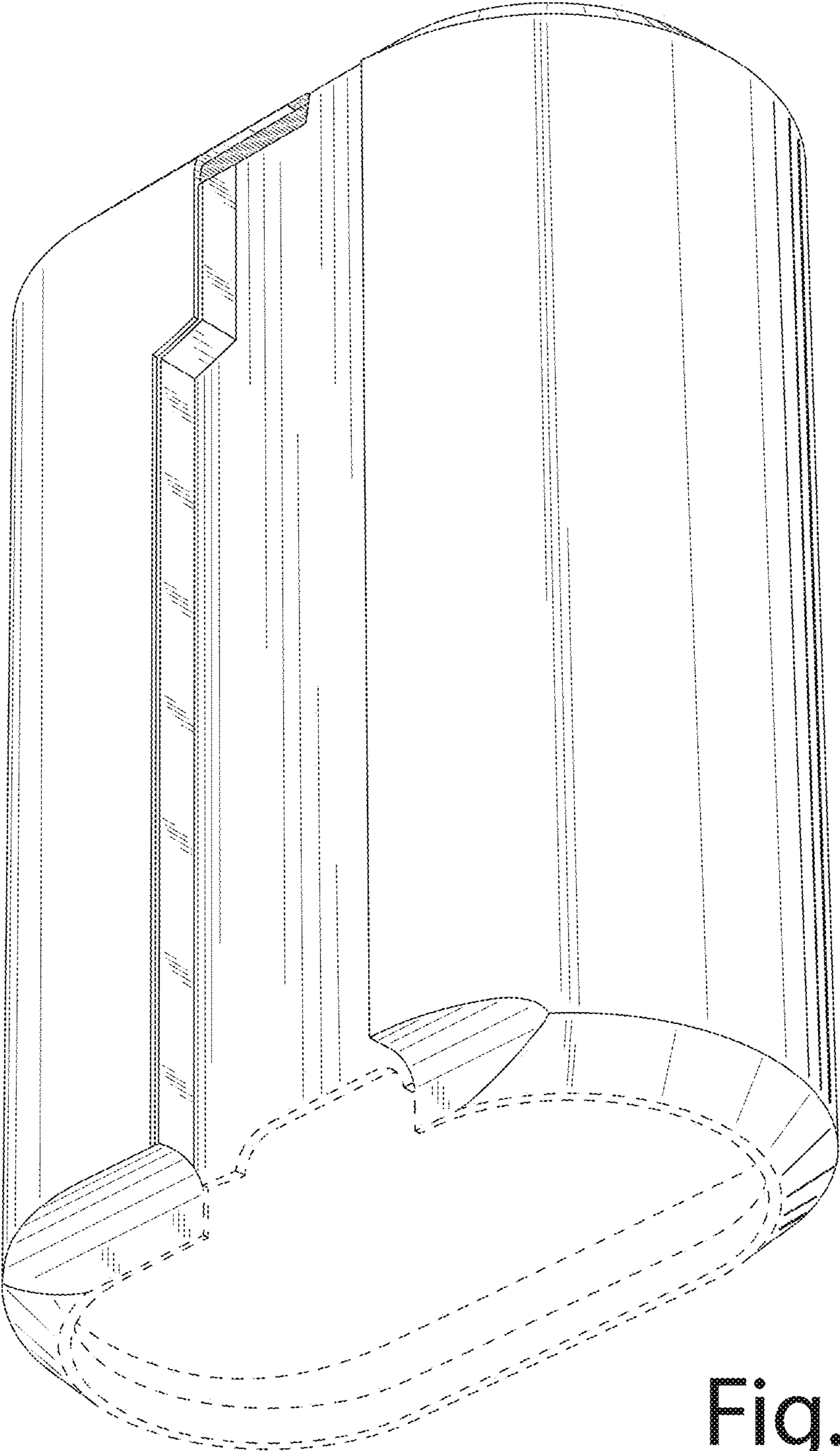

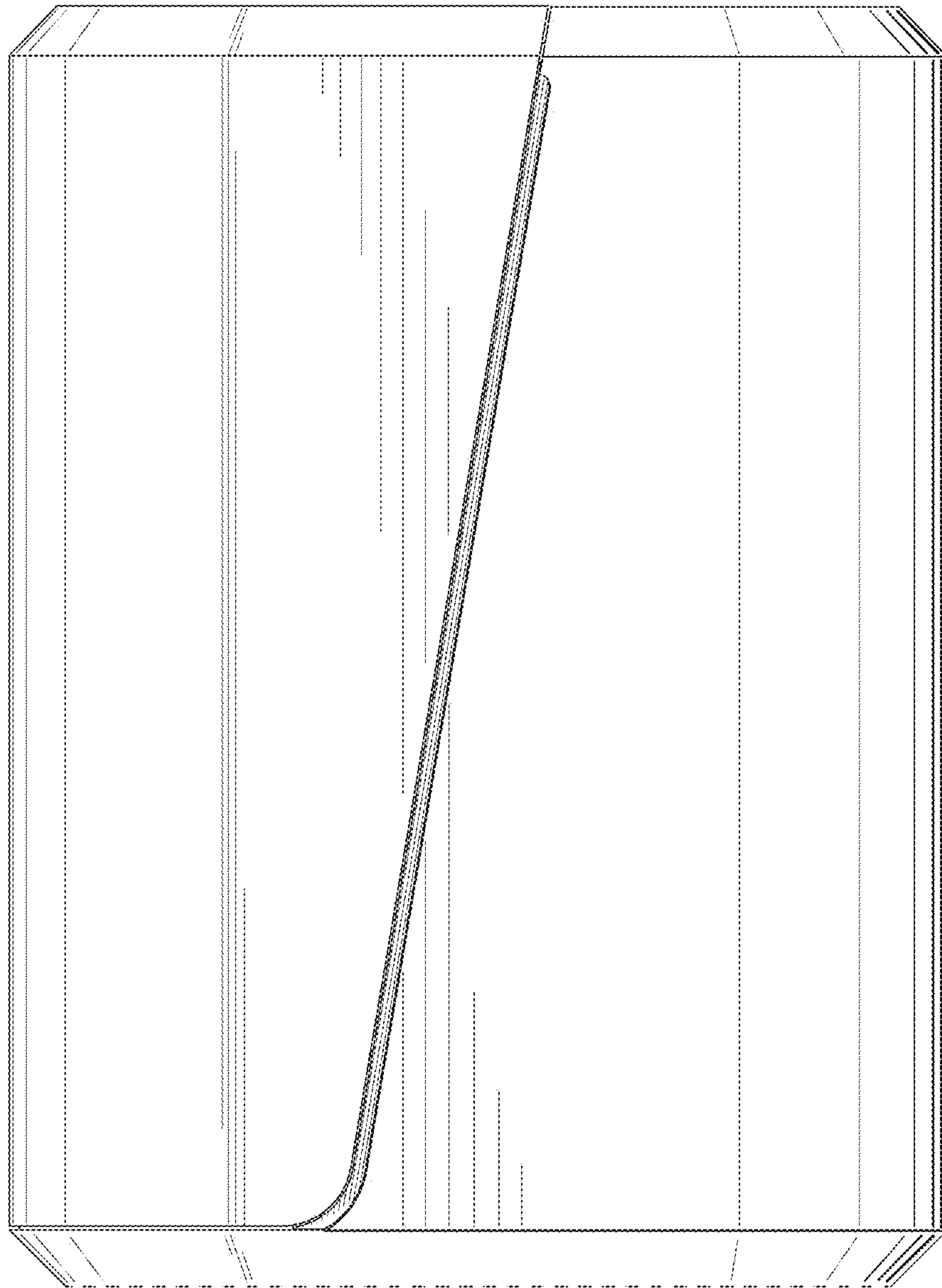

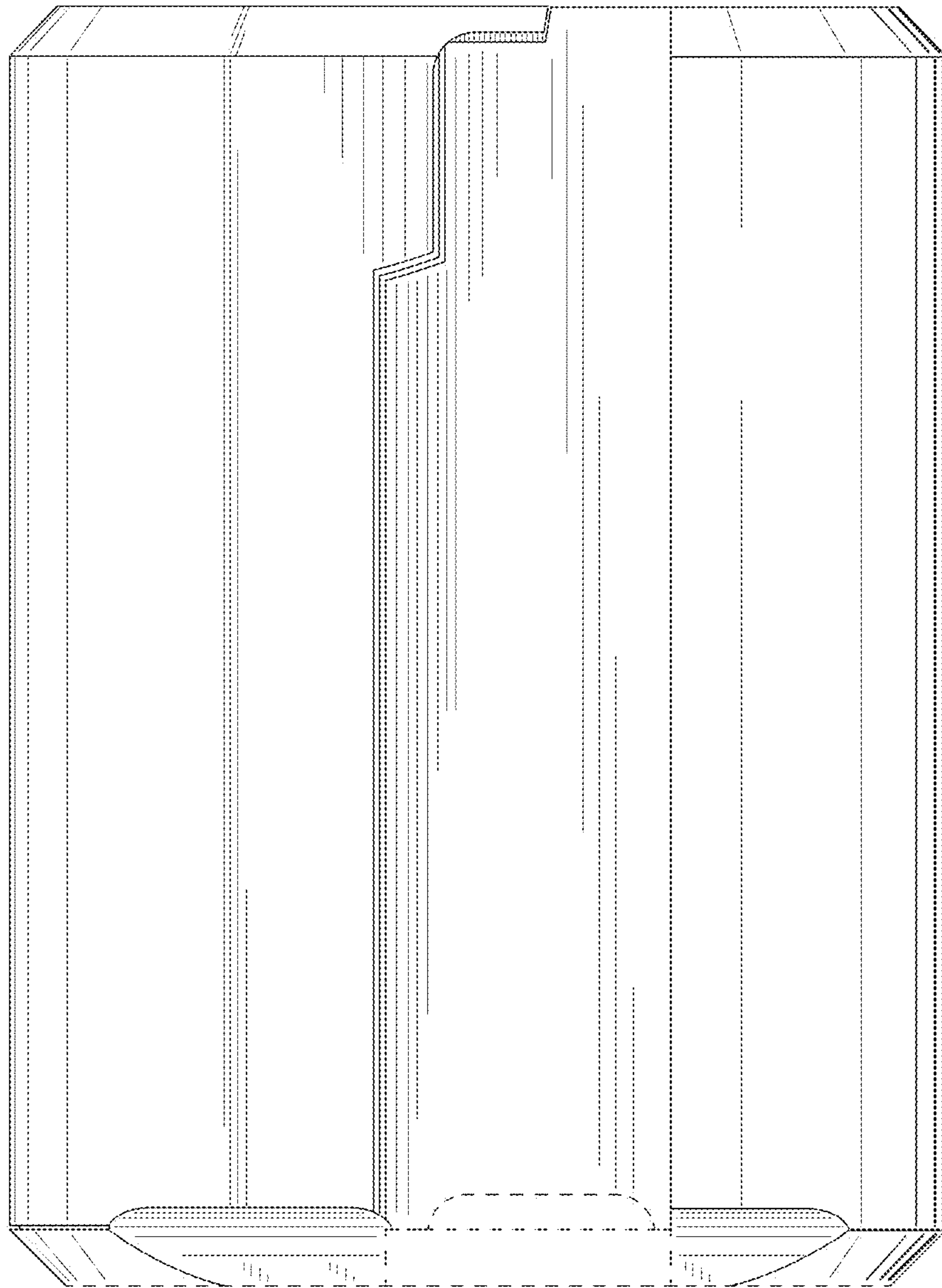

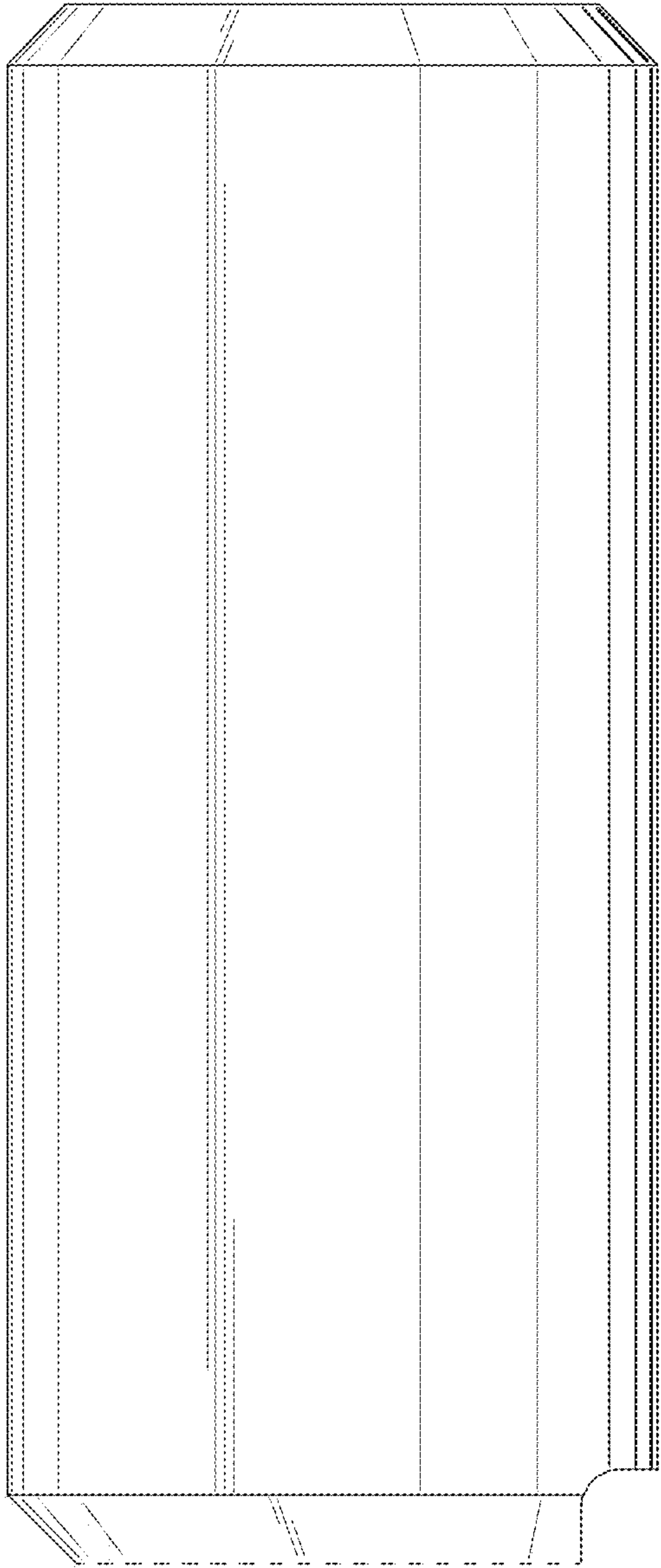

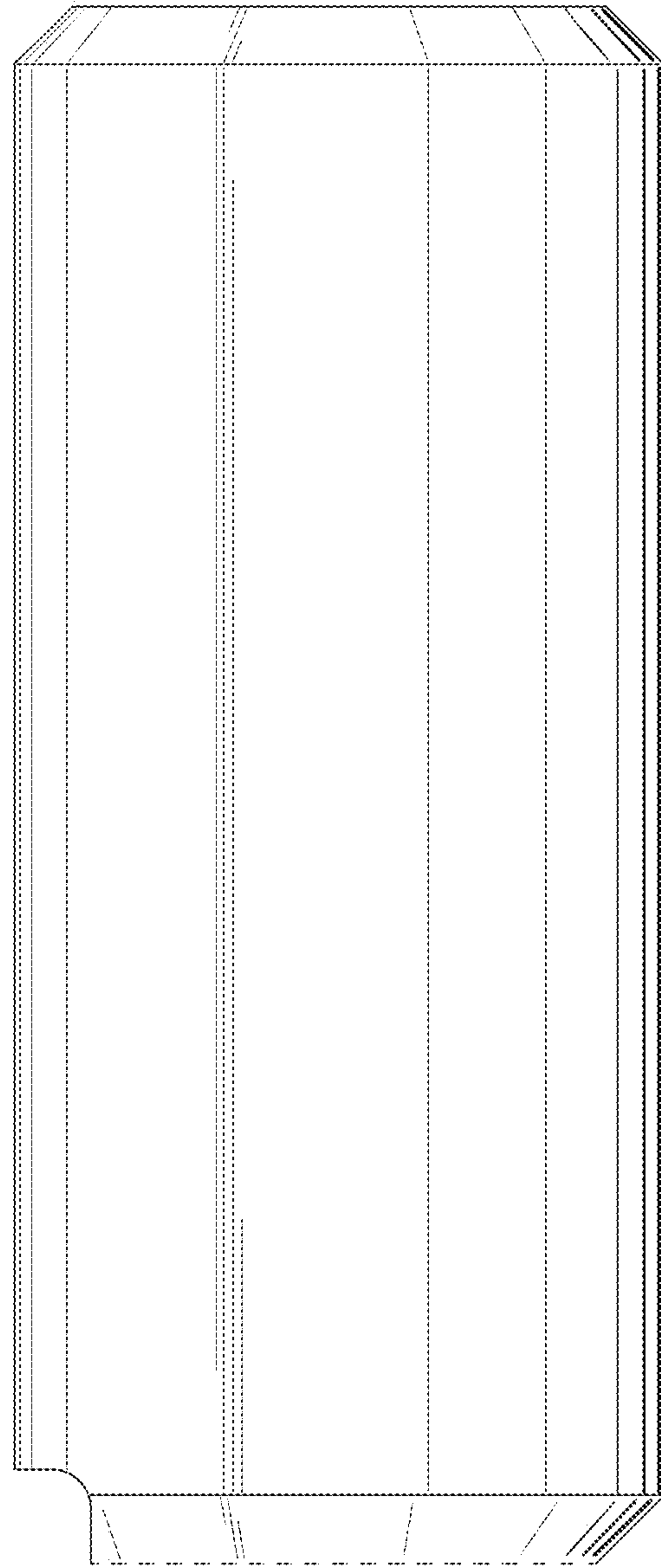

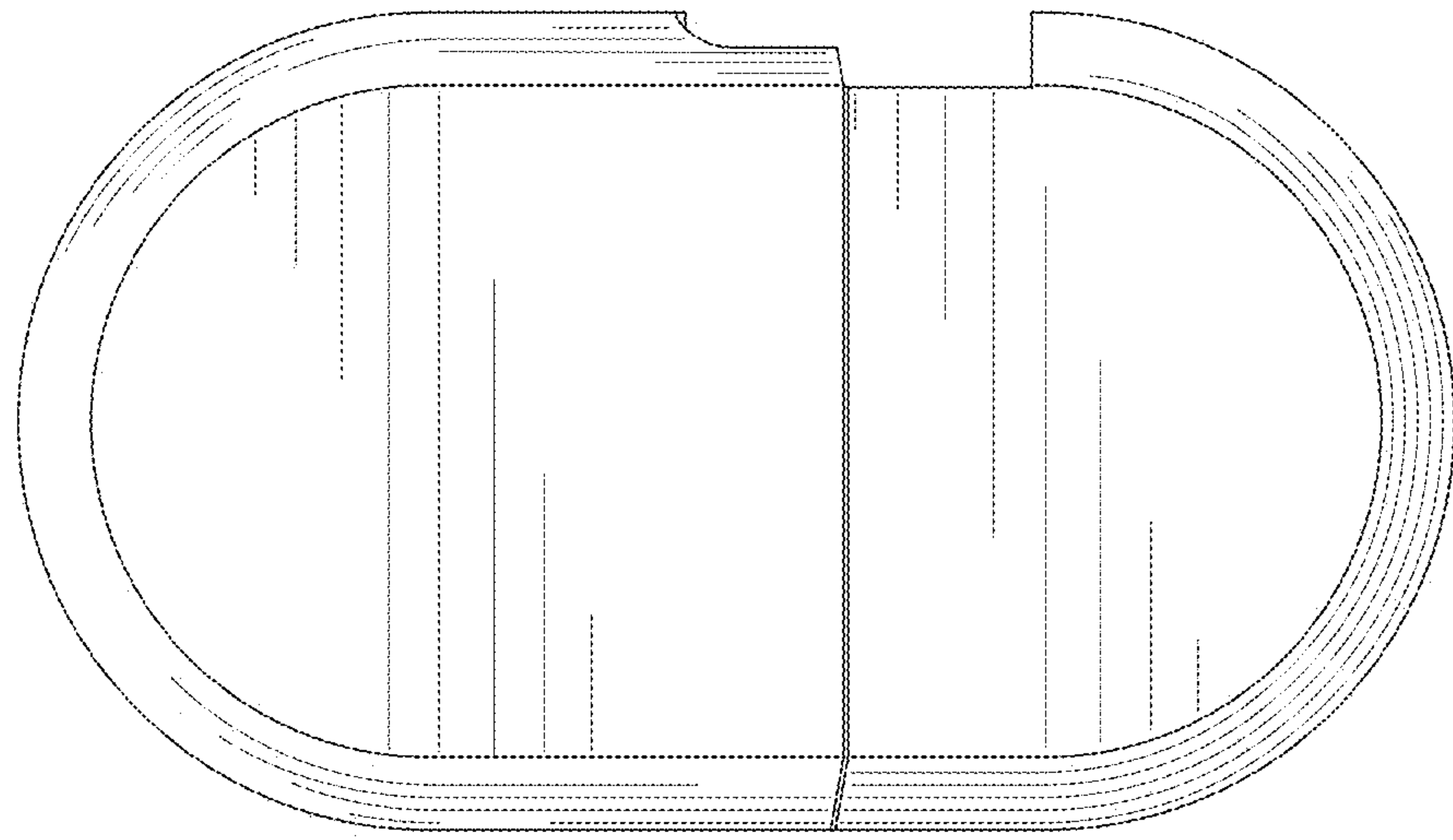

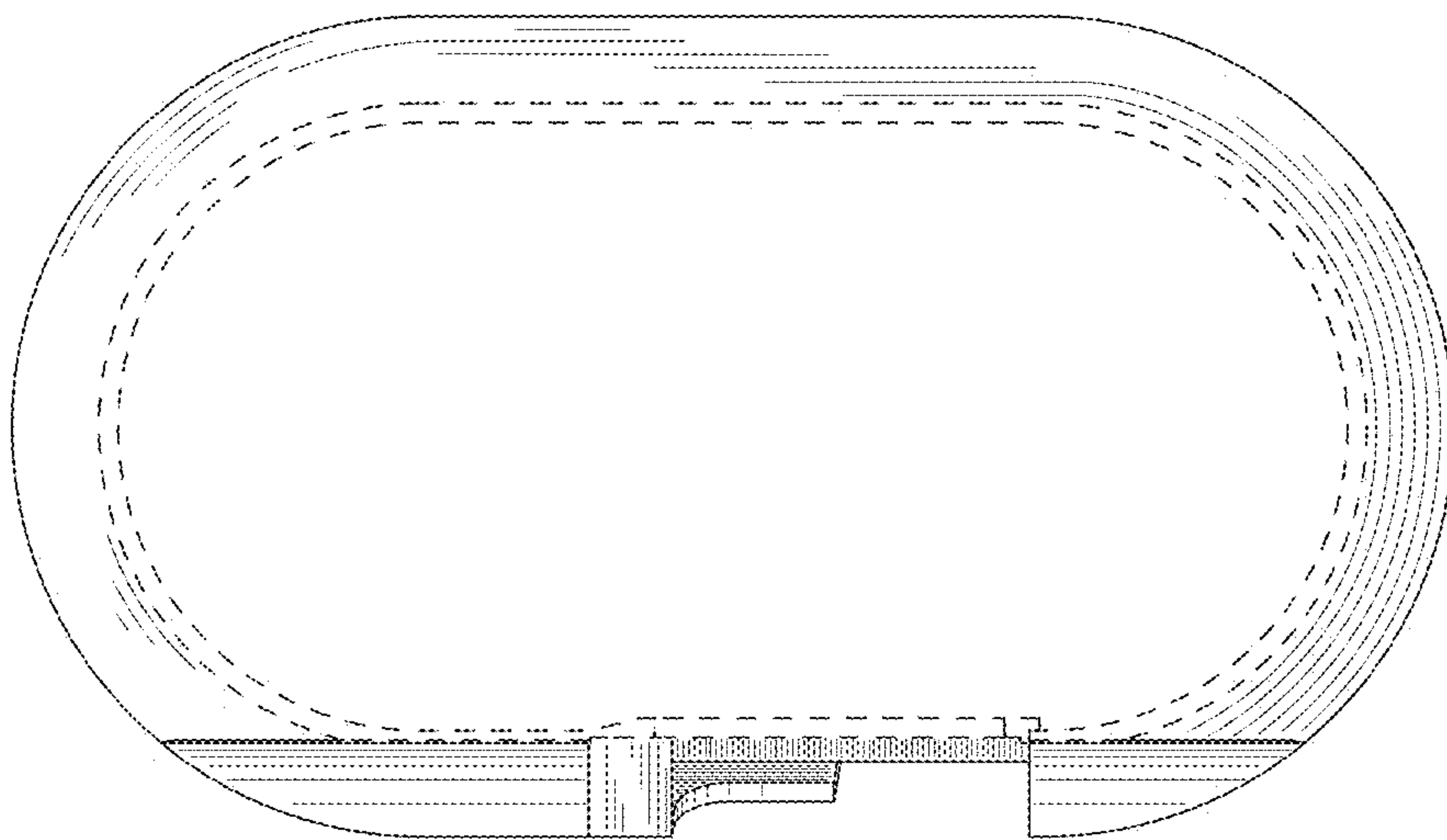
