(57) **CLAIM**

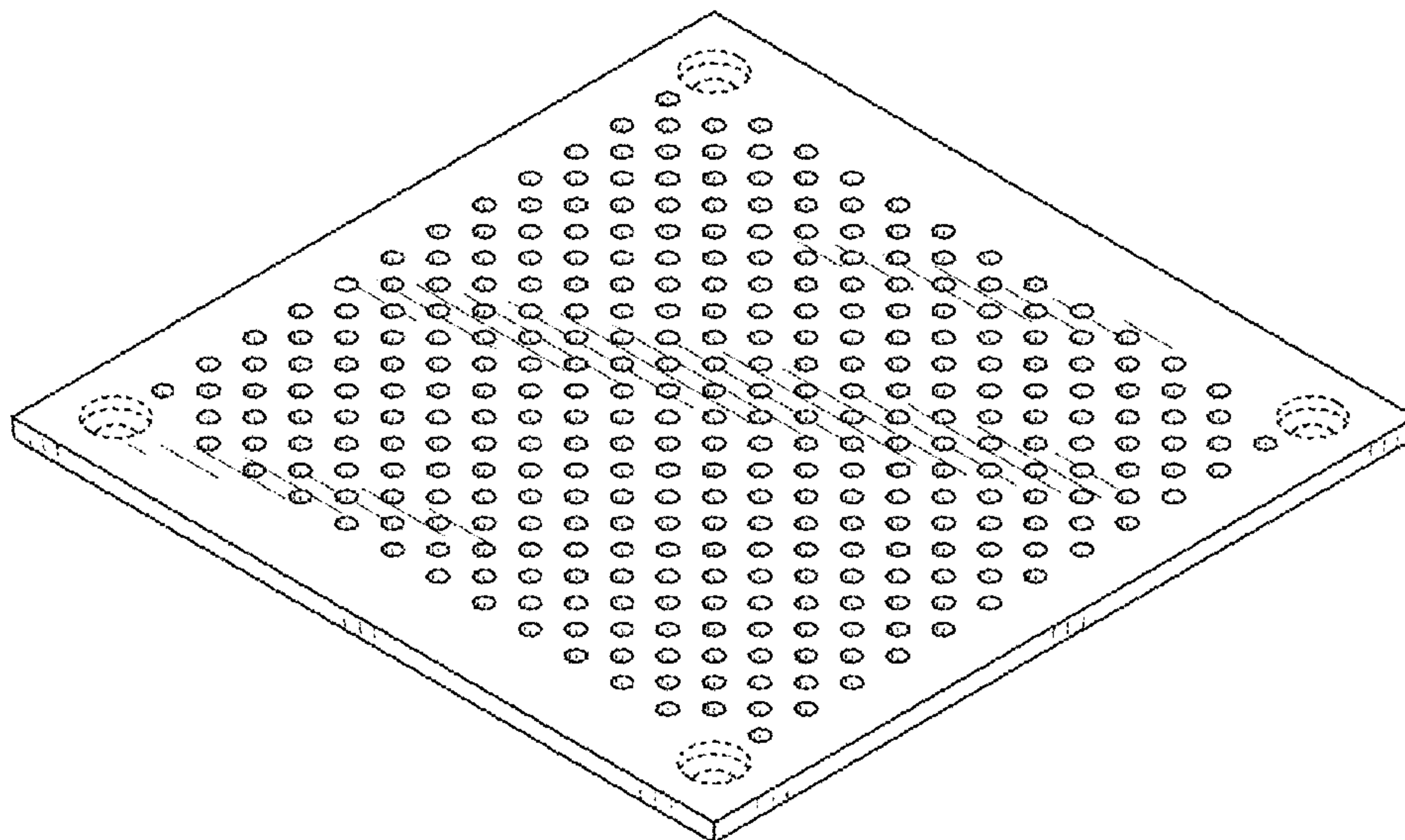
The ornamental design for a floor drain grate, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a floor drain grate embodying our new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a front side view of the floor drain grate seen in FIG. 1, the rear side view, left side view and right side view being mirror images thereof; and,
FIG. 5 is a sectional view of the floor drain grate taken along line 5-5 in FIG. 2.

The broken lines, and the areas within them, in the figures depict portions of the floor drain grate that form no part of the claimed design.

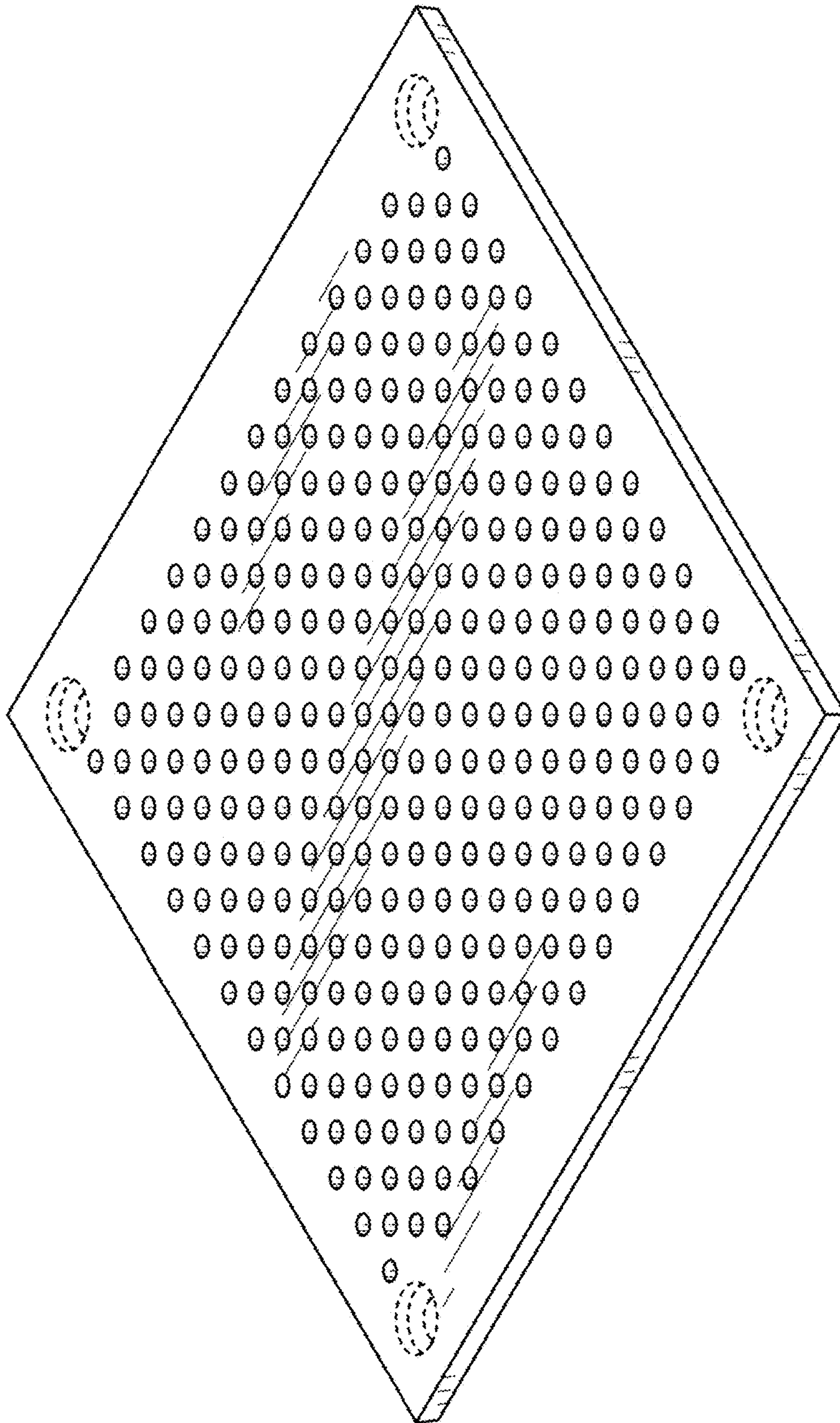

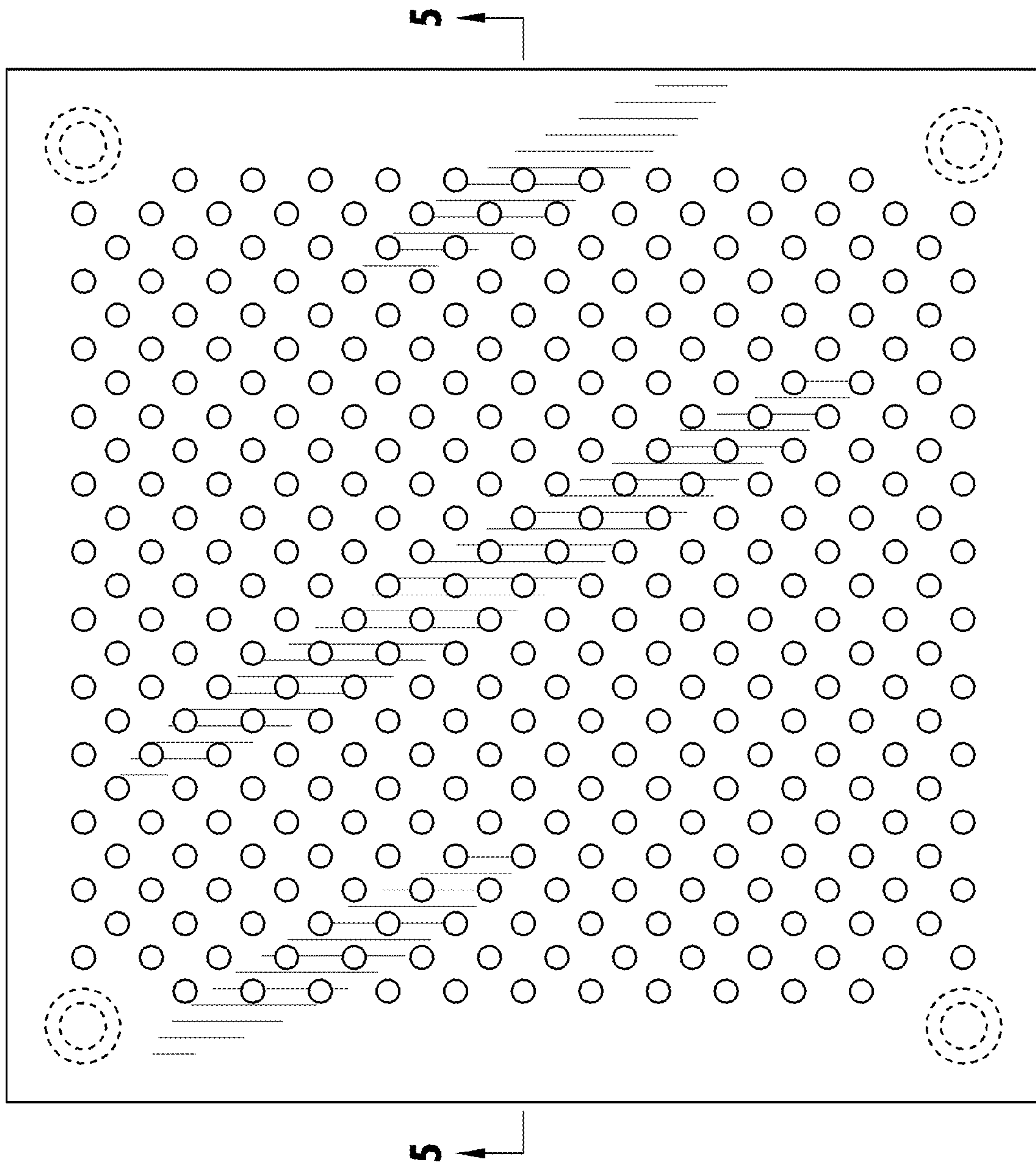

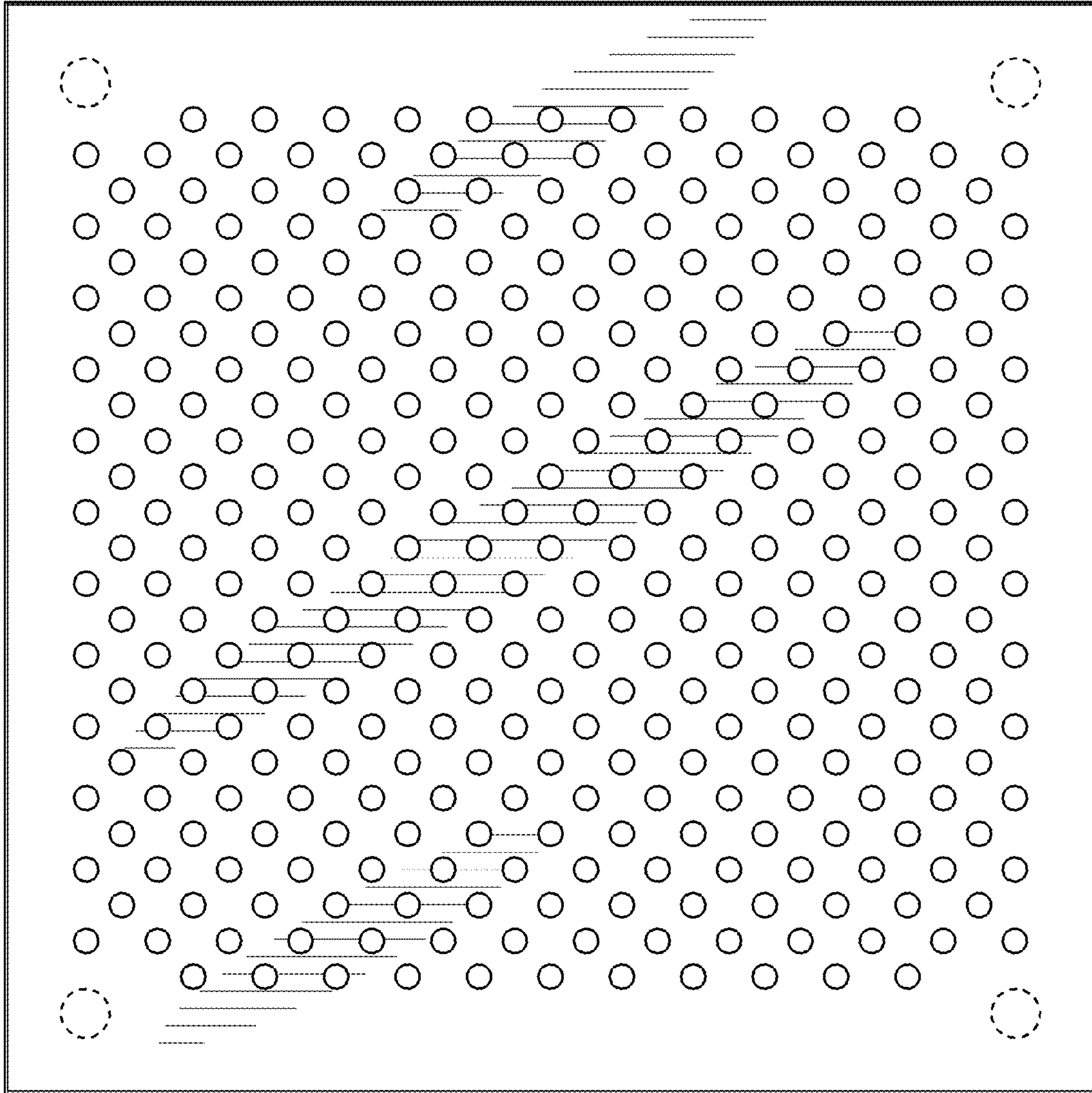
