(57) **CLAIM**

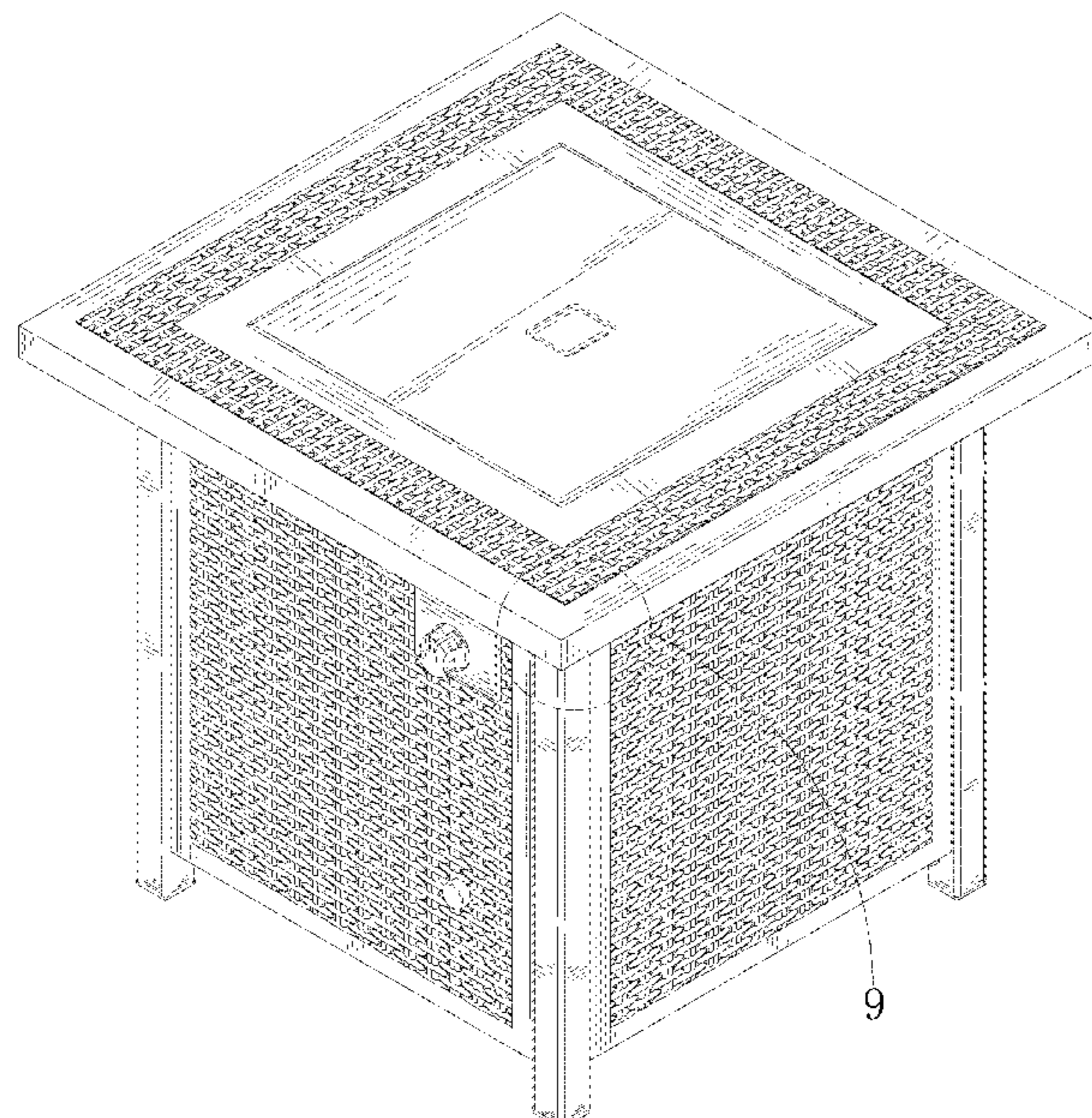
The ornamental design for a gas stove table, as shown and described.

**DESCRIPTION**

FIG. 1 is front, right, and top side perspective view of a gas stove table showing our new design;  
FIG. 2 is a rear, left, and bottom perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof;  
FIG. 7 is a top plan view thereof;  
FIG. 8 is a bottom plan view thereof; and,  
FIG. 9 is an enlarged view of portion 9 in FIG. 1.  
The broken lines in the drawings illustrate the portions of the gas stove table which form no part of the claimed design.

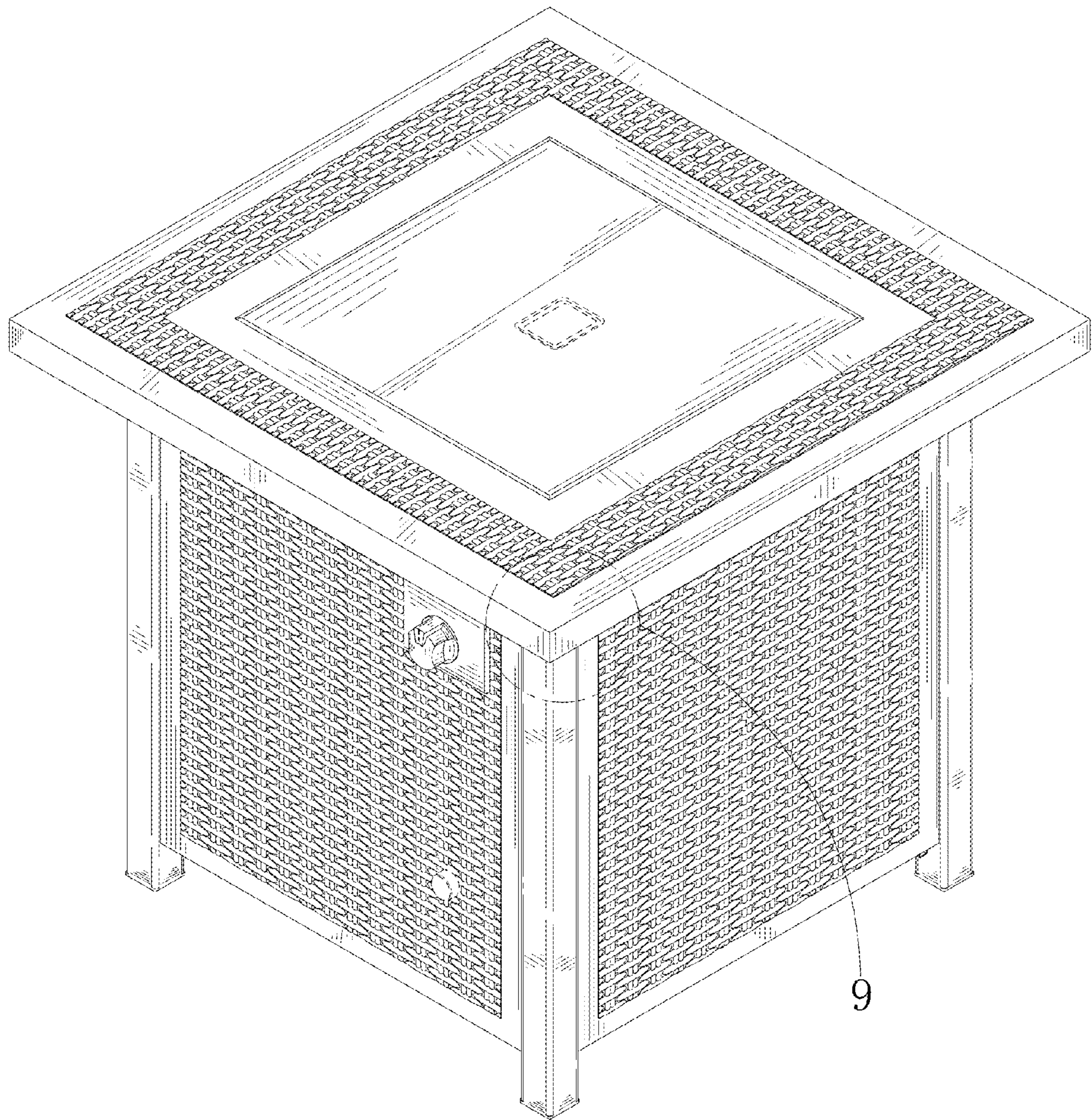

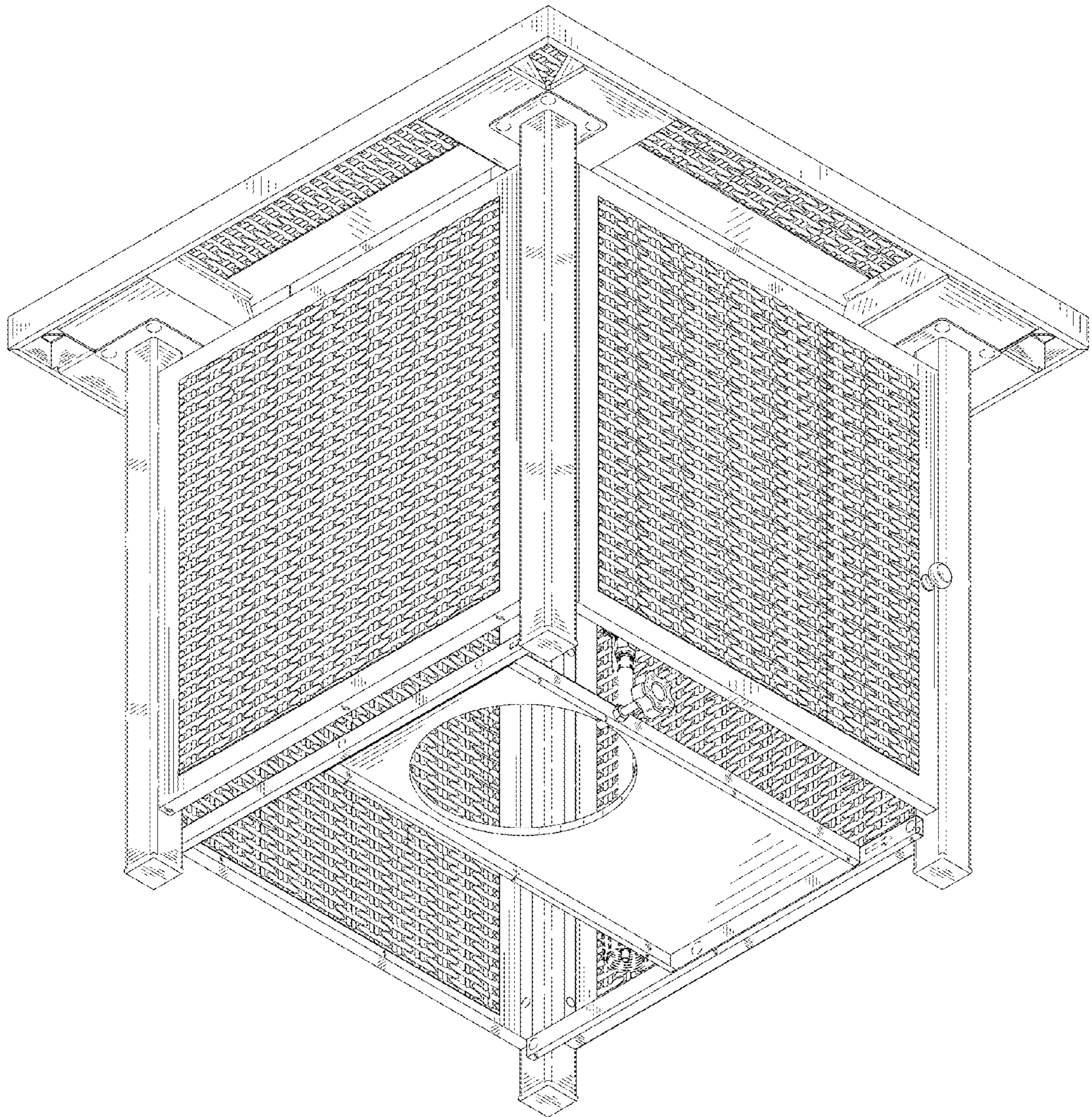

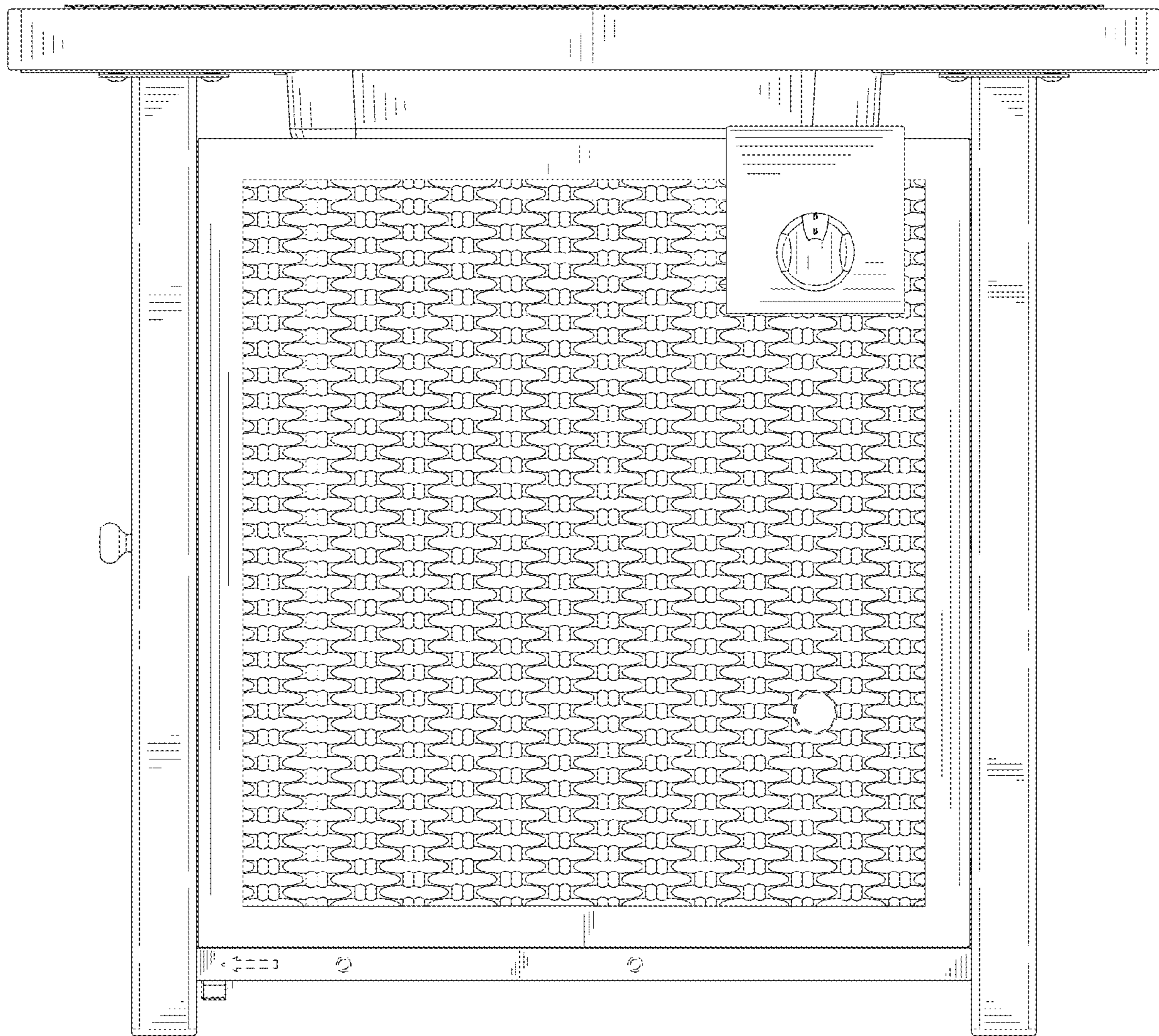

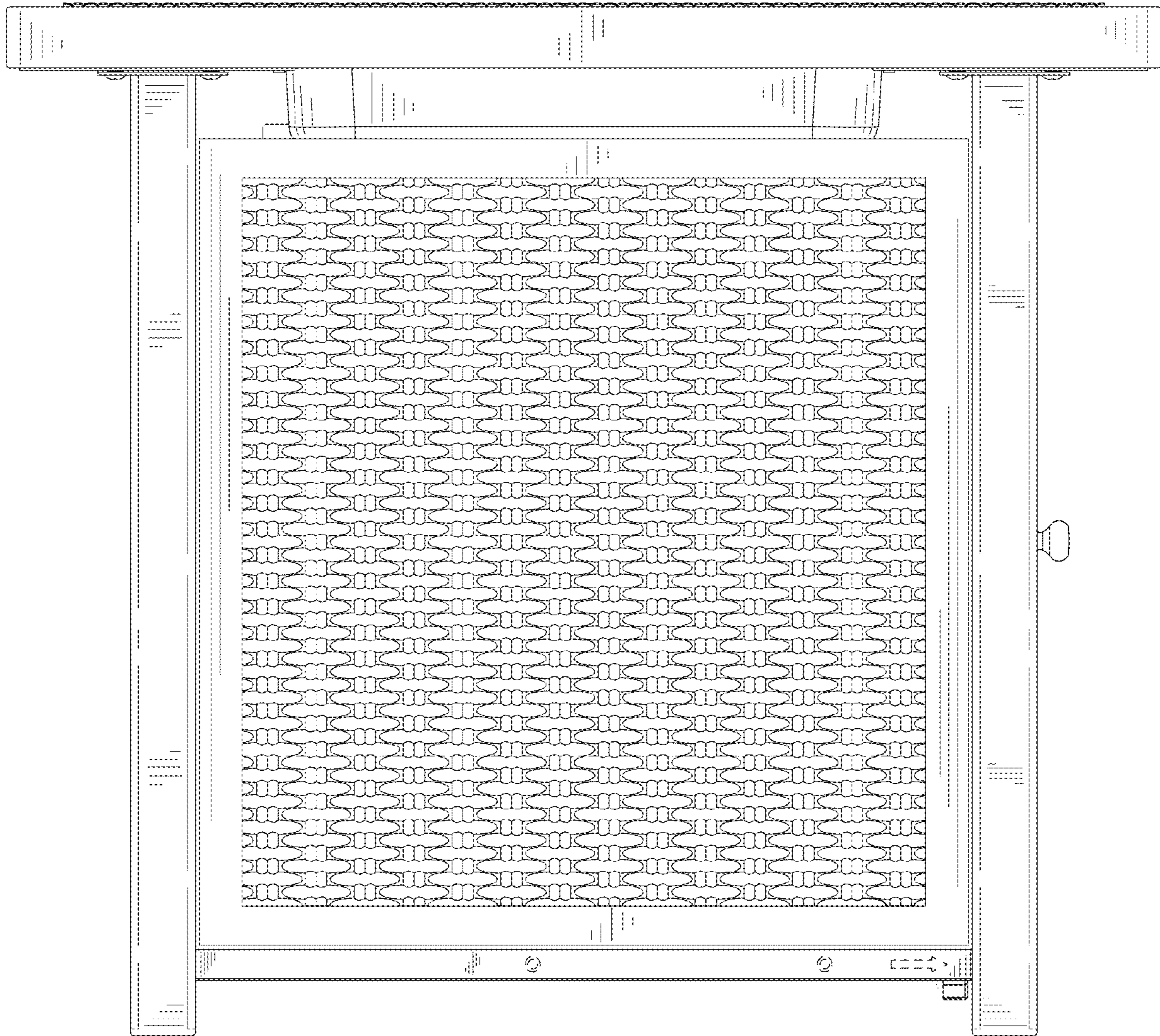

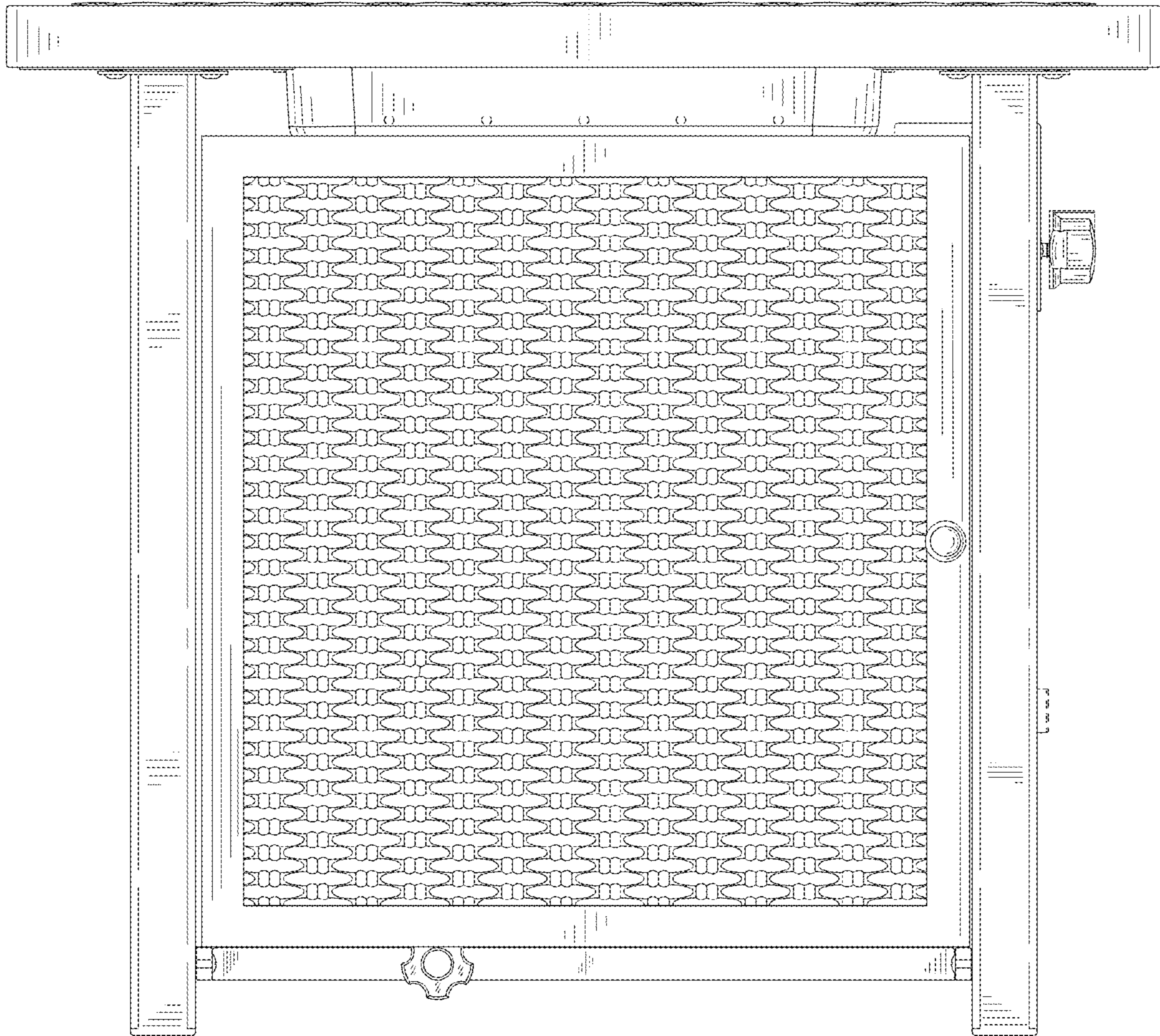

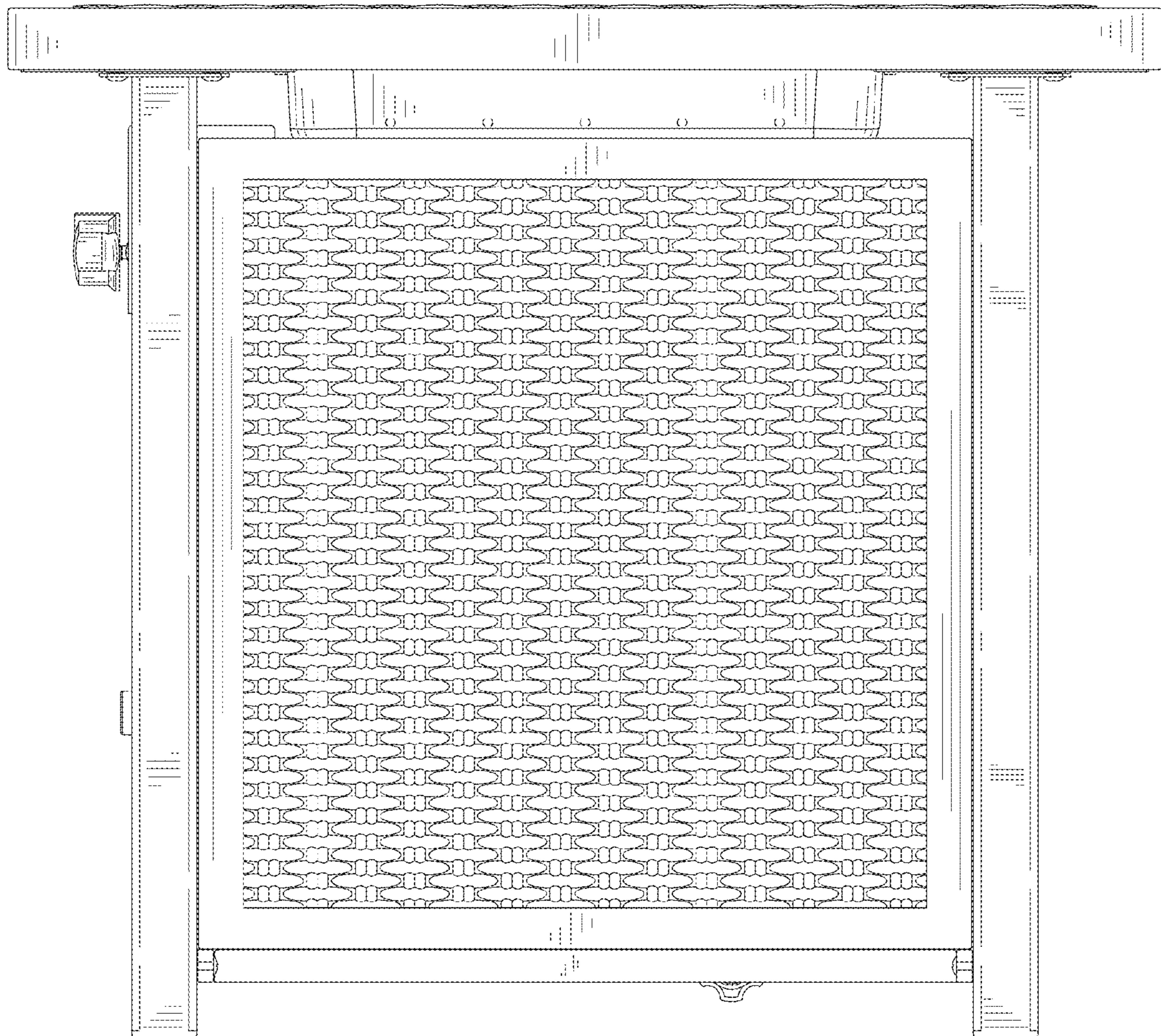

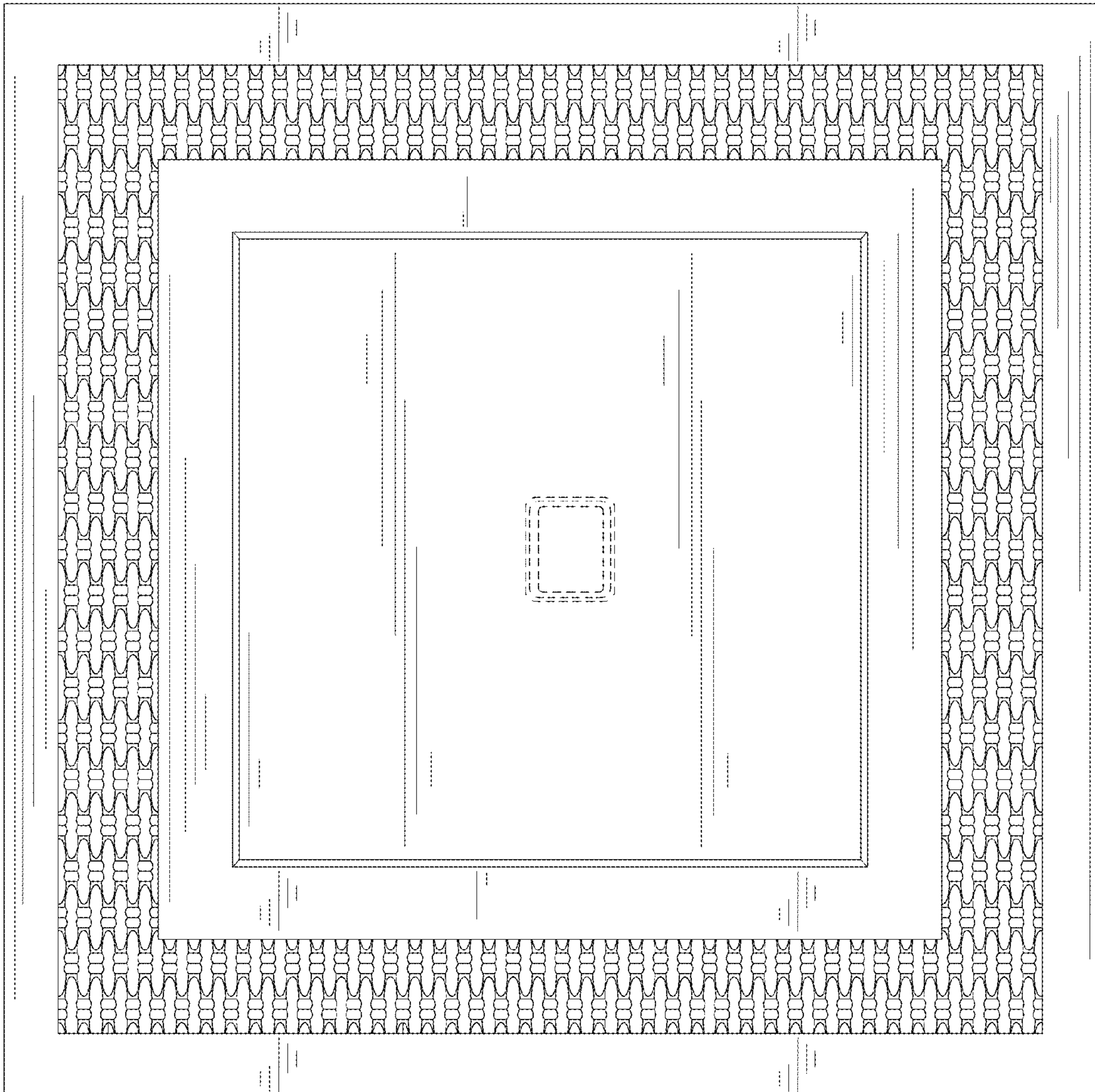

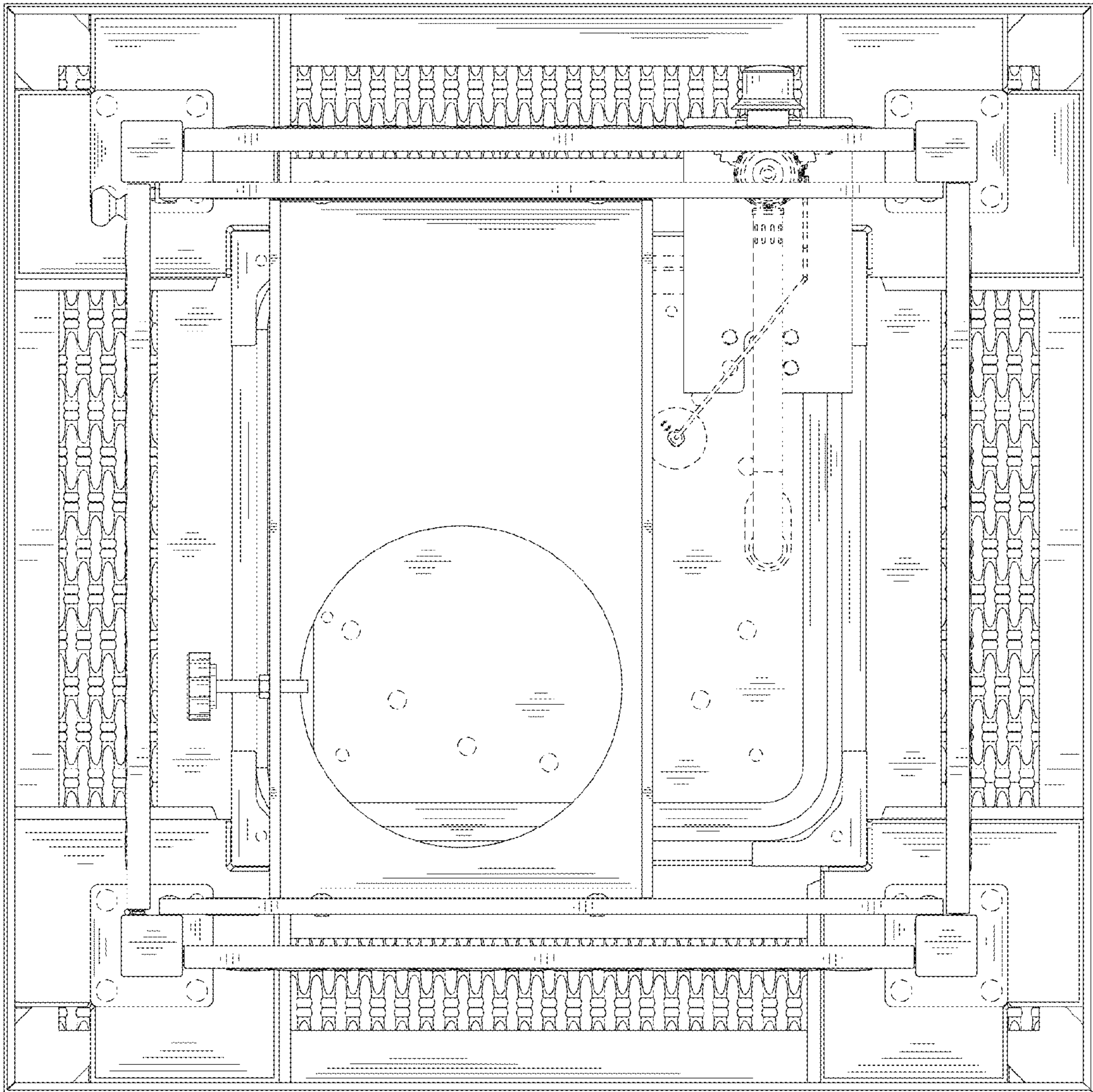

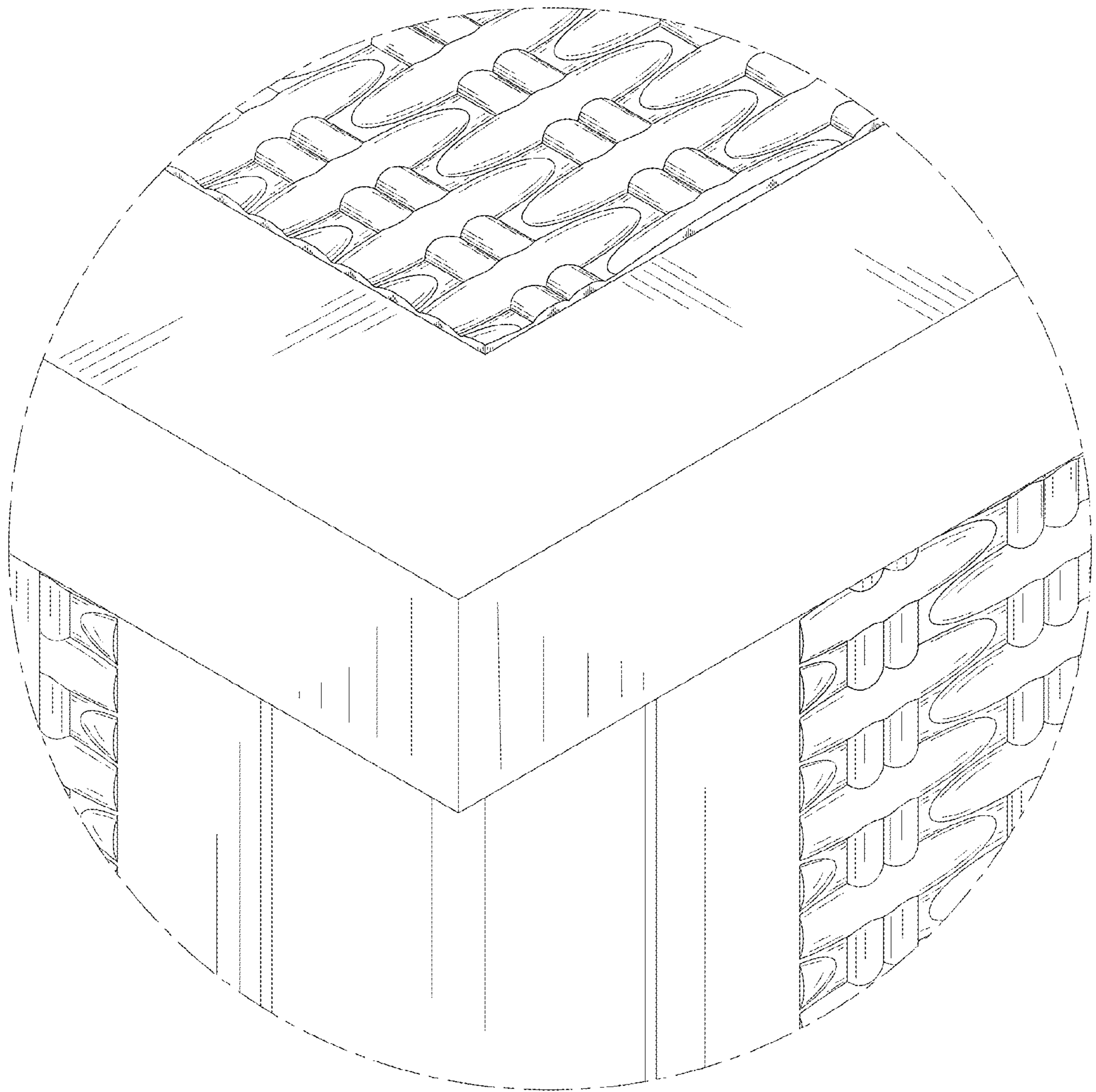
