(57) **CLAIM**

The ornamental design for a fabric head covering, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fabric head covering for holding electroencephalogram (EEG) sensors.

FIG. 2 is a top view of the fabric head covering of FIG. 1.

FIG. 3 is a bottom view of the fabric head covering of FIG. 1.

FIG. 4 is a right side view of the fabric head covering of FIG. 1.

FIG. 5 is a left side view of the fabric head covering of FIG. 1.

FIG. 6 is a front view of the fabric head covering of FIG. 1.

FIG. 7 is a rear view of the fabric head covering of FIG. 1.

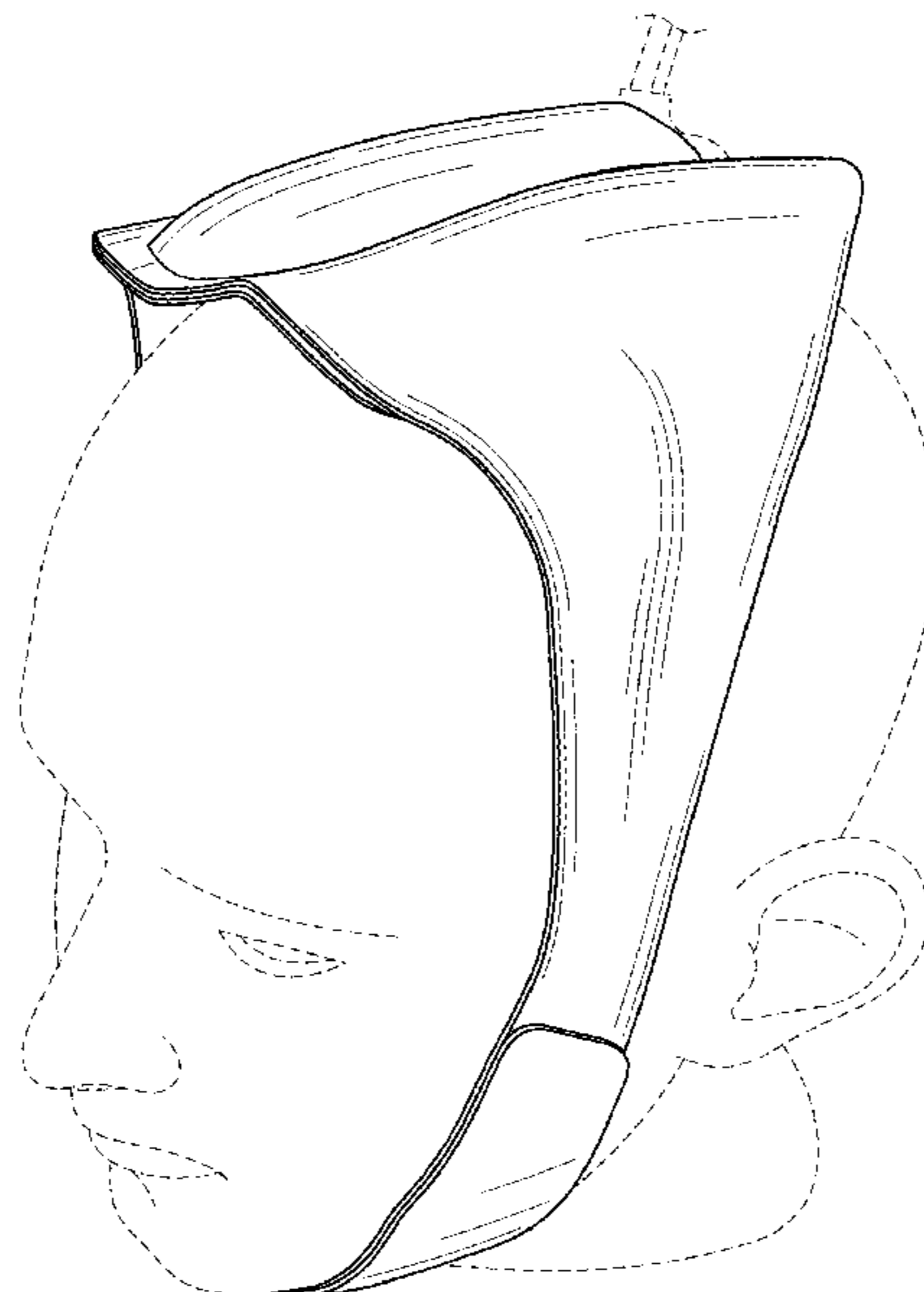
FIG. 8 is a perspective view of the fabric head covering of FIG. 1 as worn on a user's head that is formed from a stiff type of fabric material.

FIG. 9 is a left side view of the fabric head covering of FIG. 1 as worn on a user's head; and,

FIG. 10 is a rear view of the fabric head covering of FIG. 1 as worn on a user's head.

The broken lines in each figure illustrate features that form no part of the claimed design. In FIGS. 8-10 the fabric head covering is illustrated as being worn on a user's head. The user's head is illustrated as an environmental feature and forms no part of the claimed design.

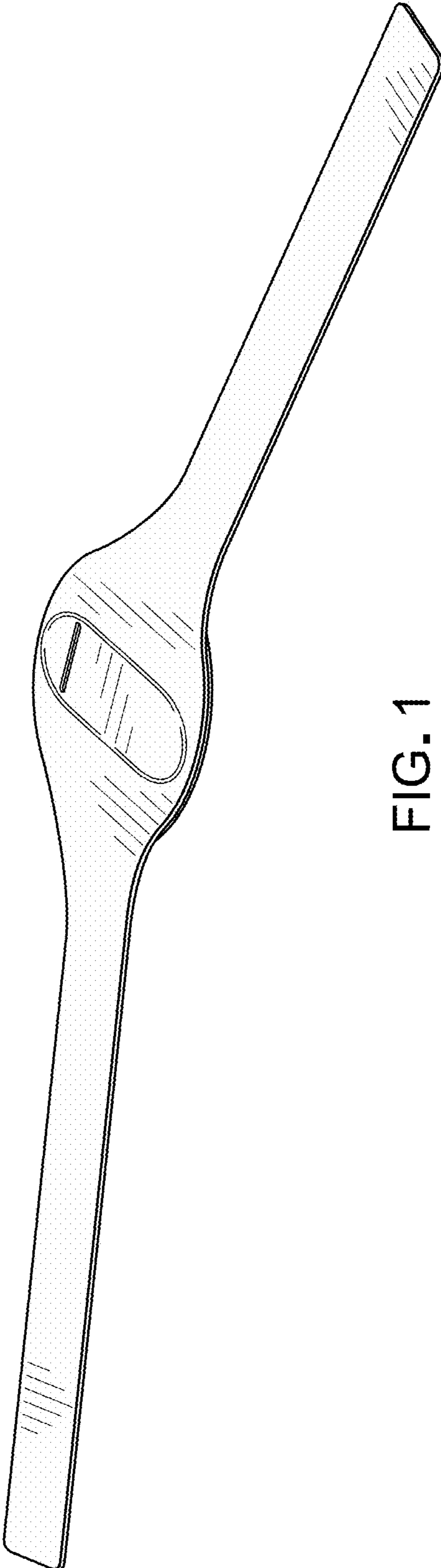

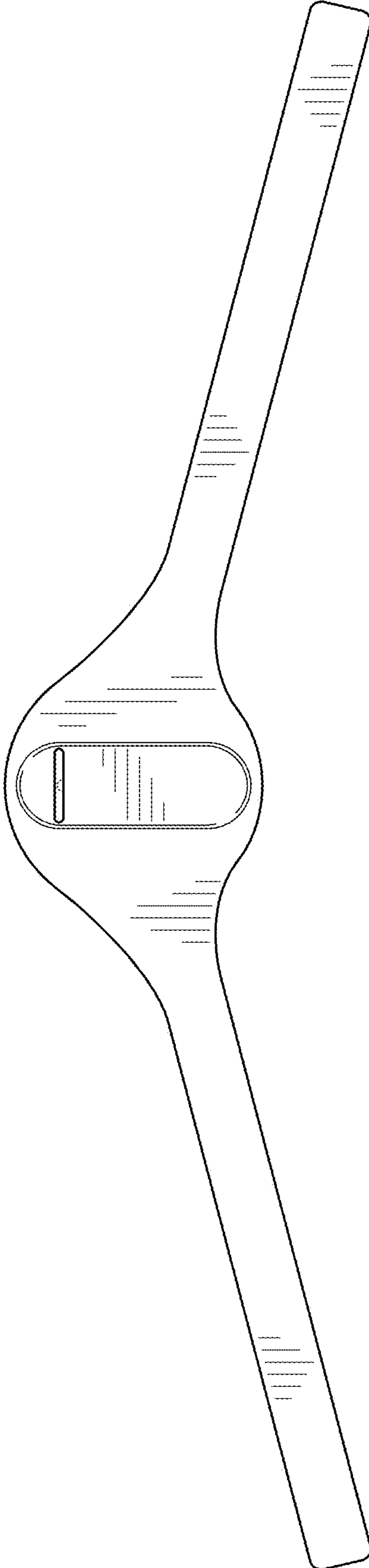

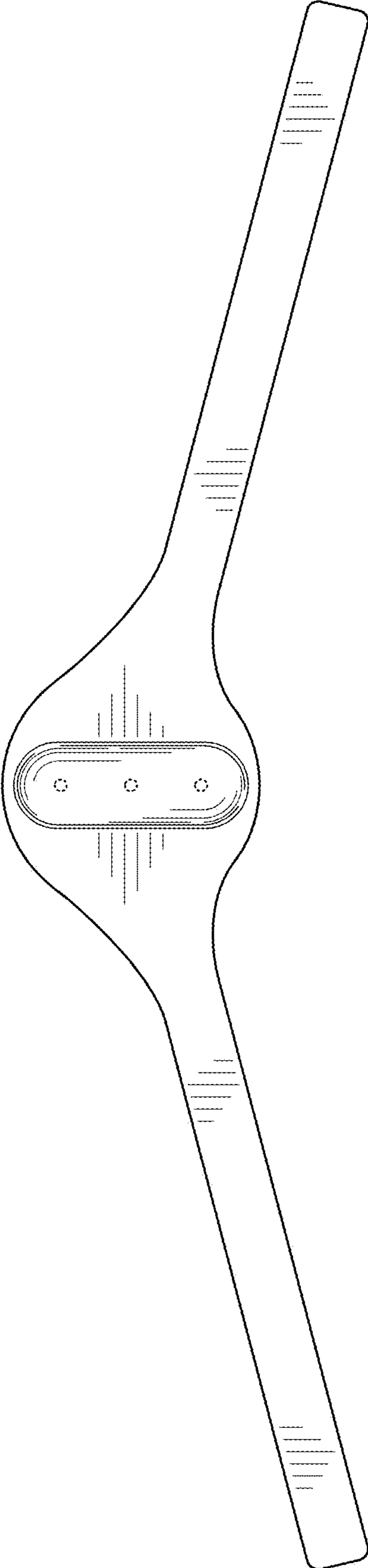

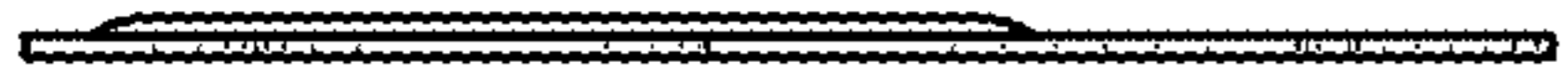

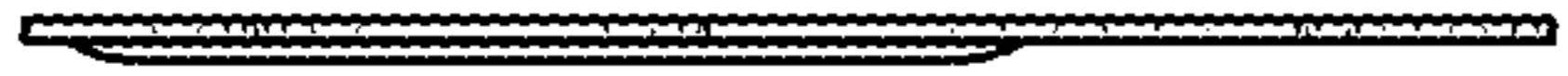

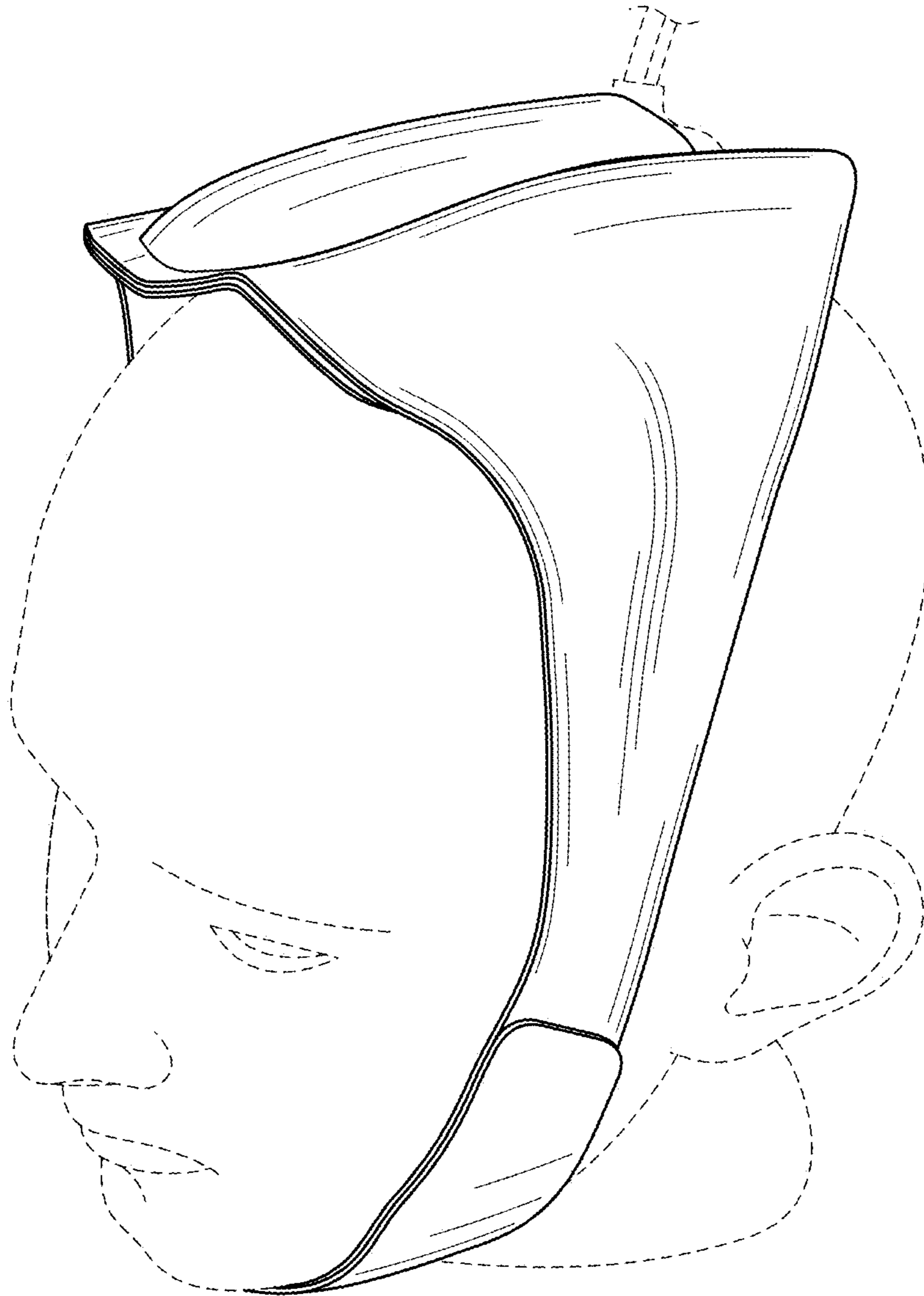

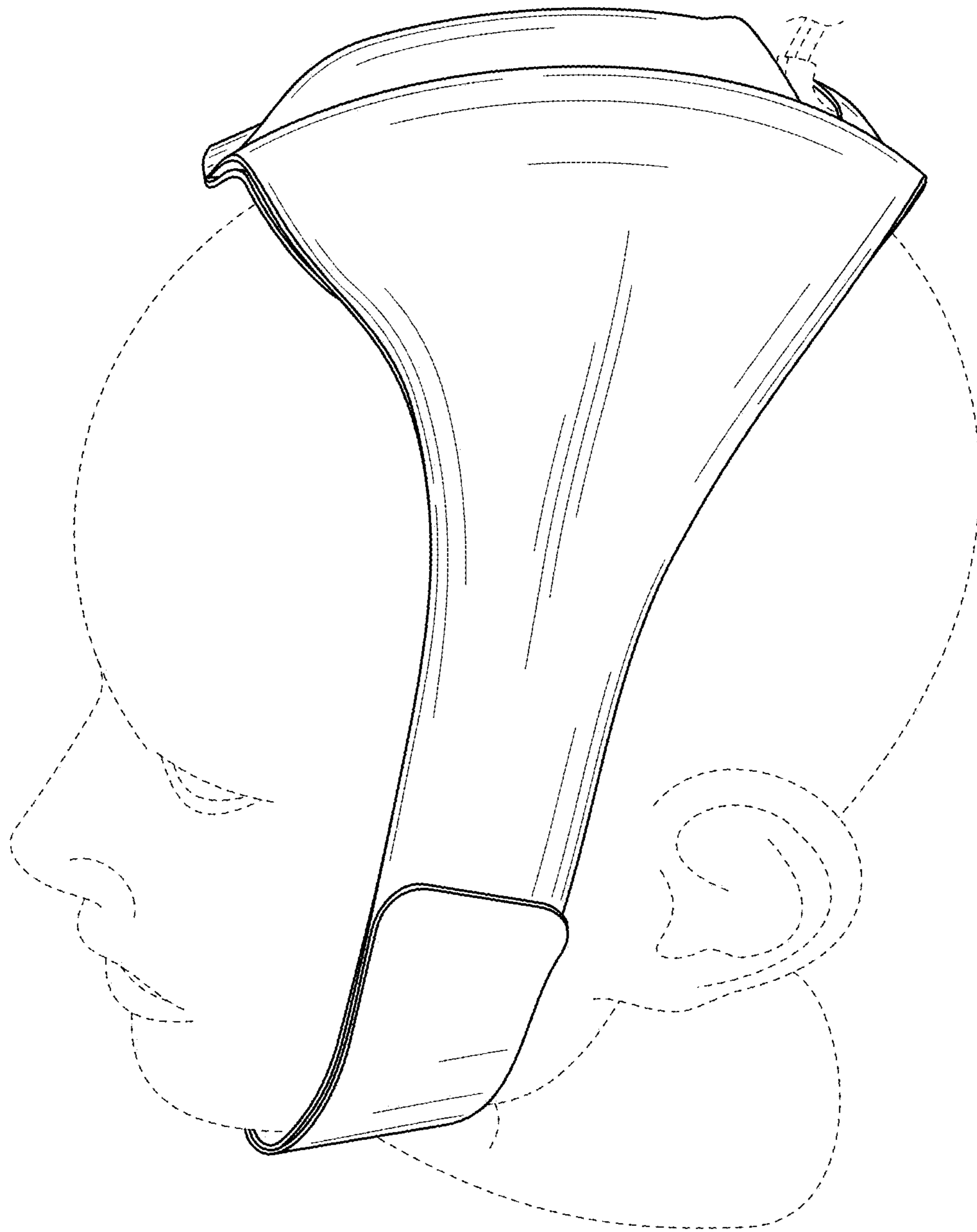

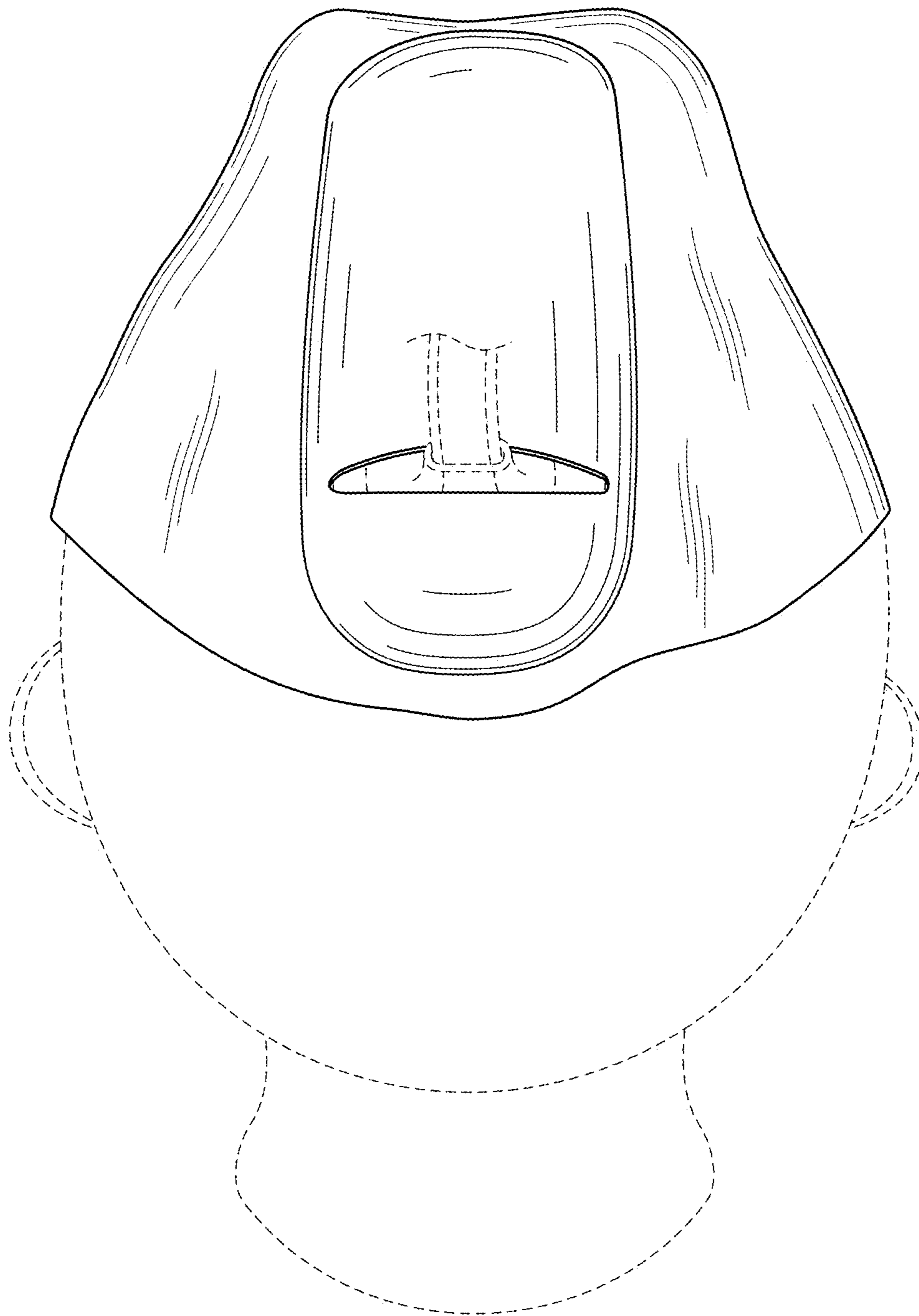
