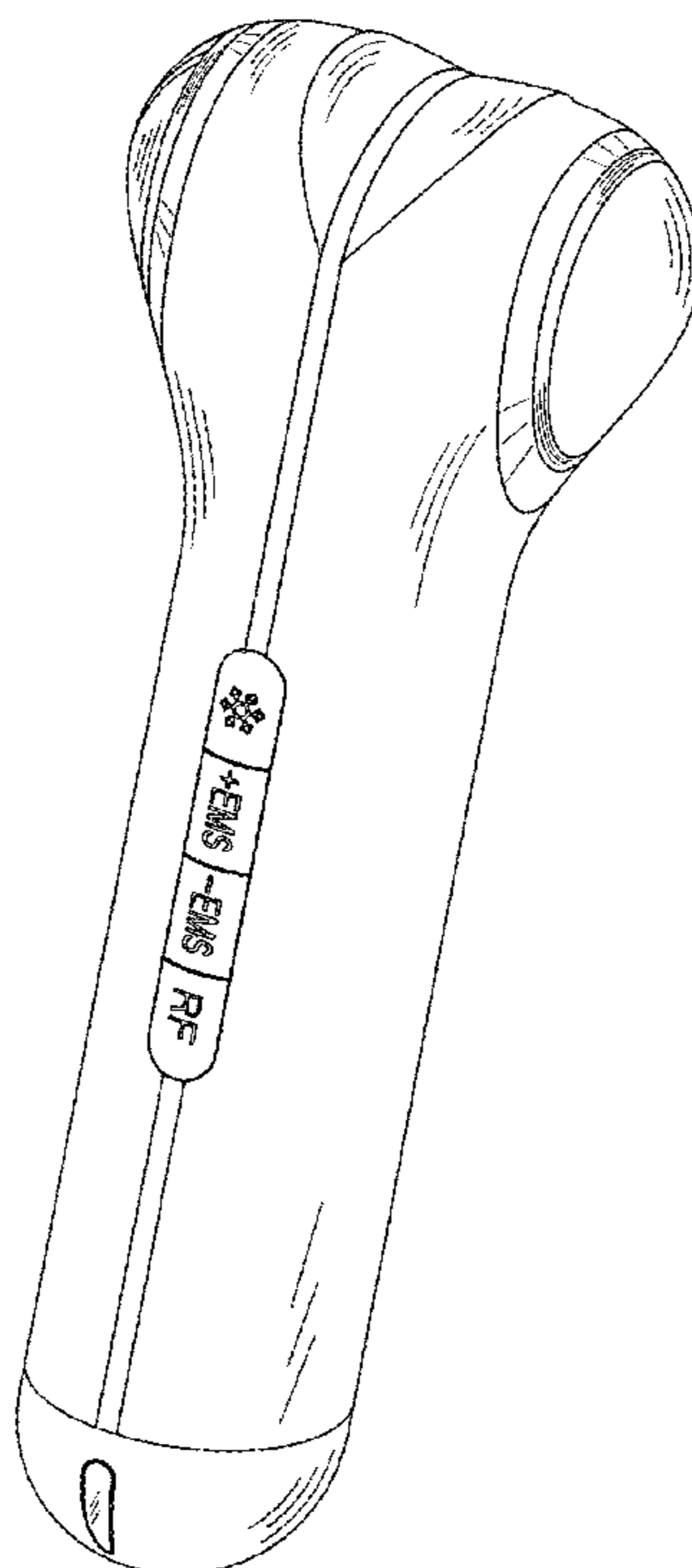
(57) **CLAIM**

I claim the ornamental design for a skin care massager, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a skin care massager showing my new design;

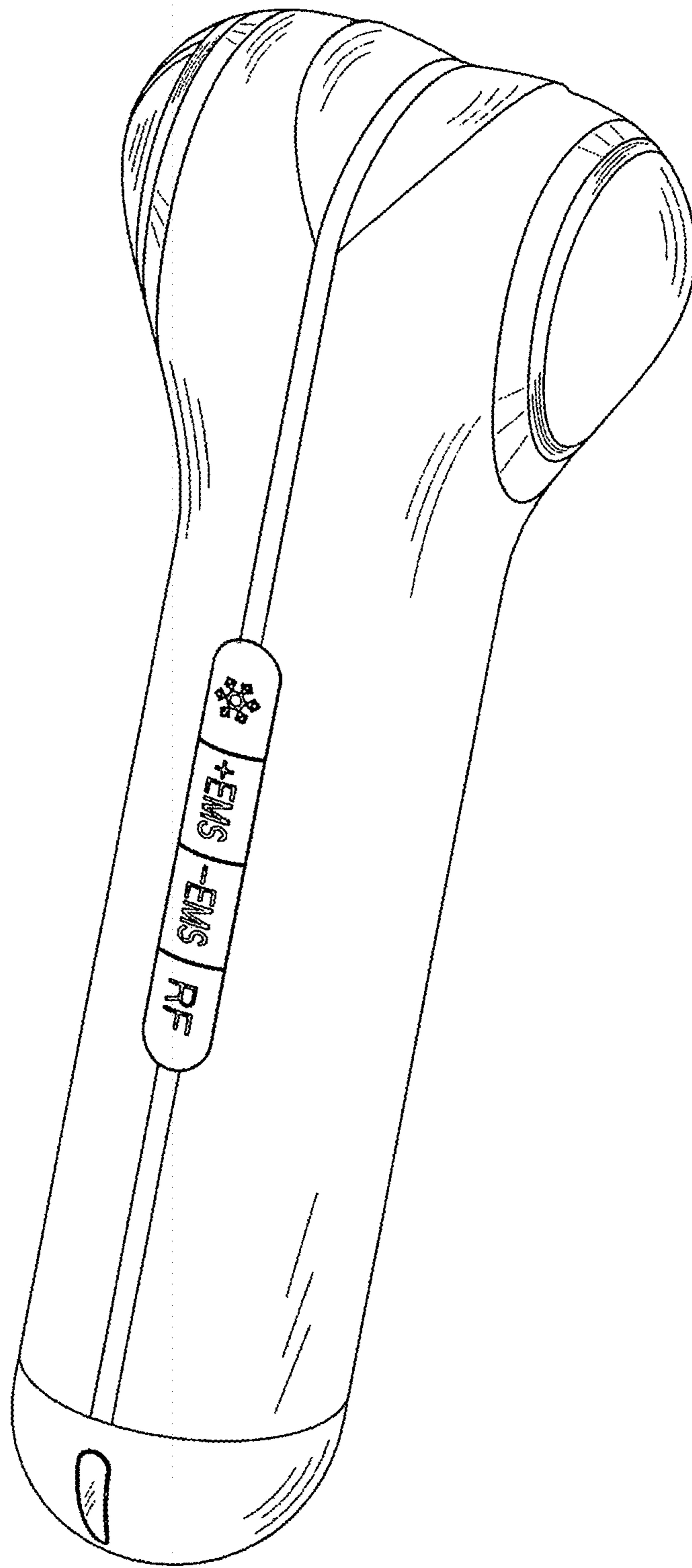

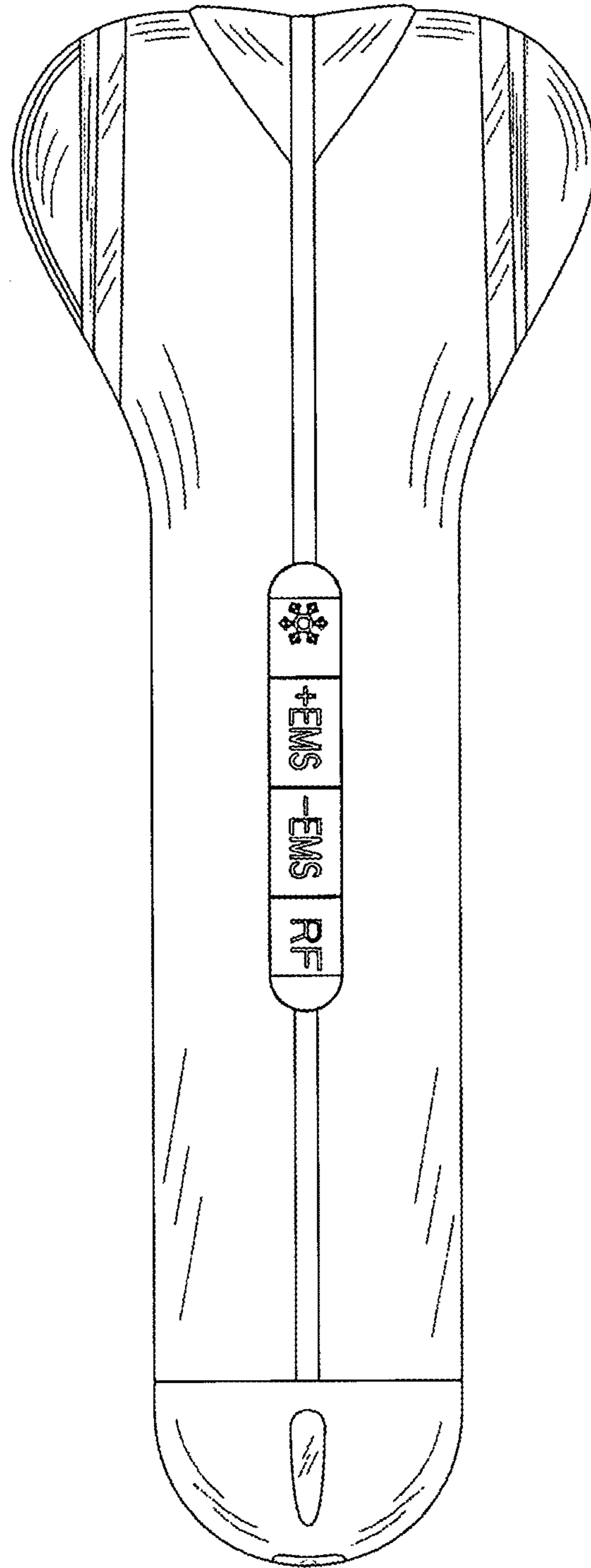

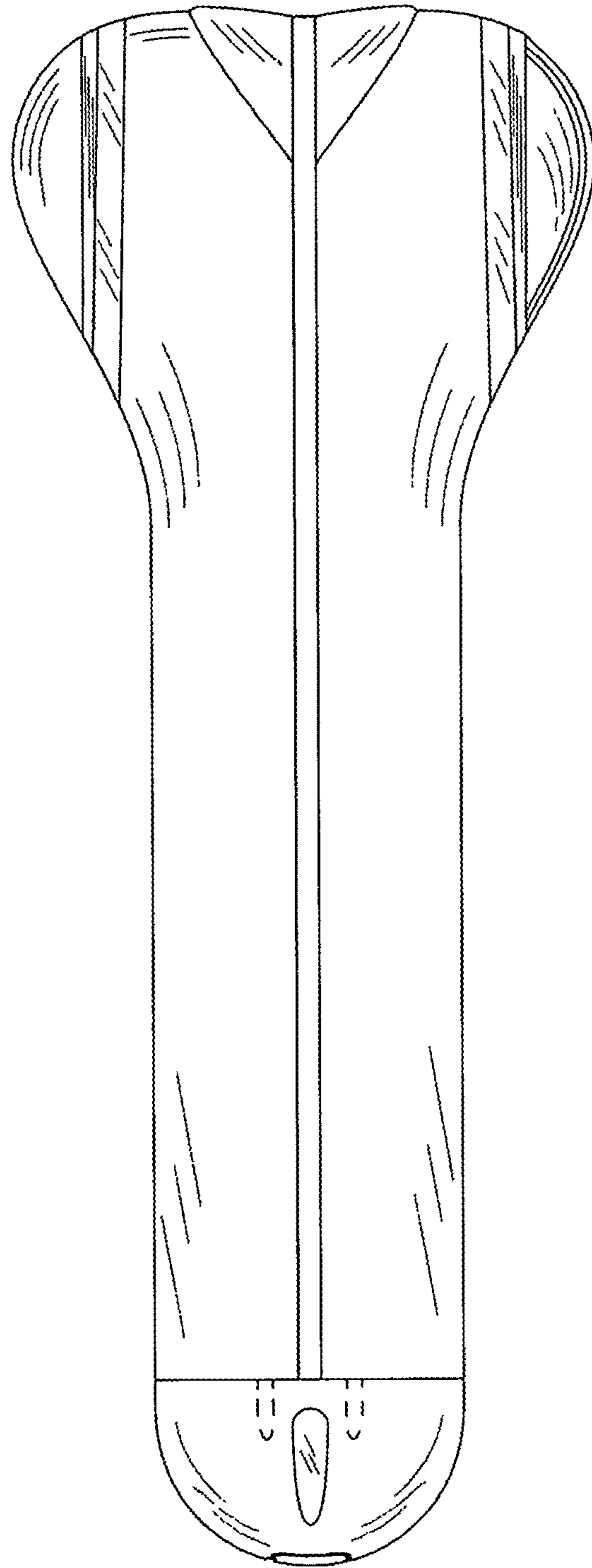

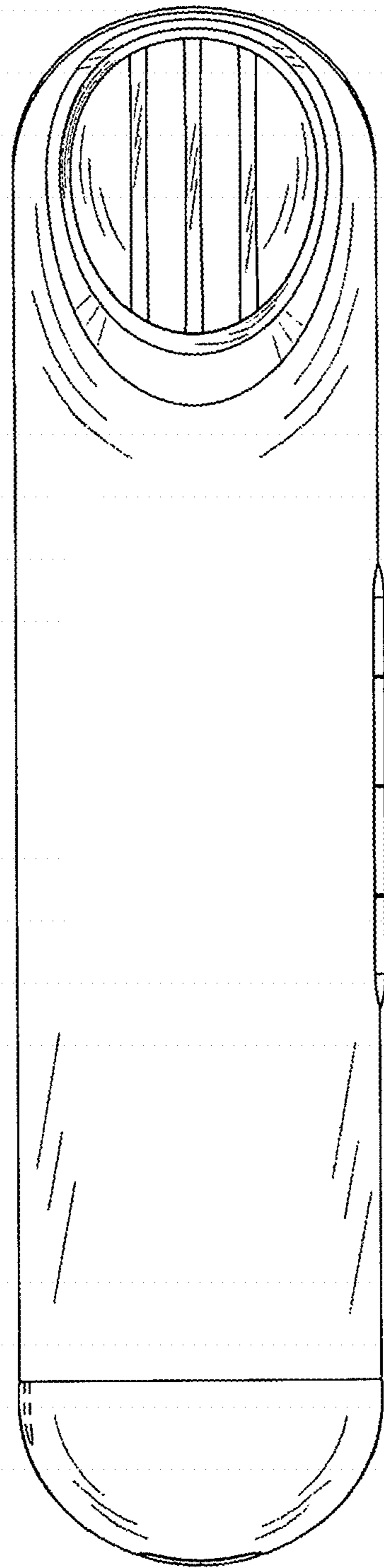

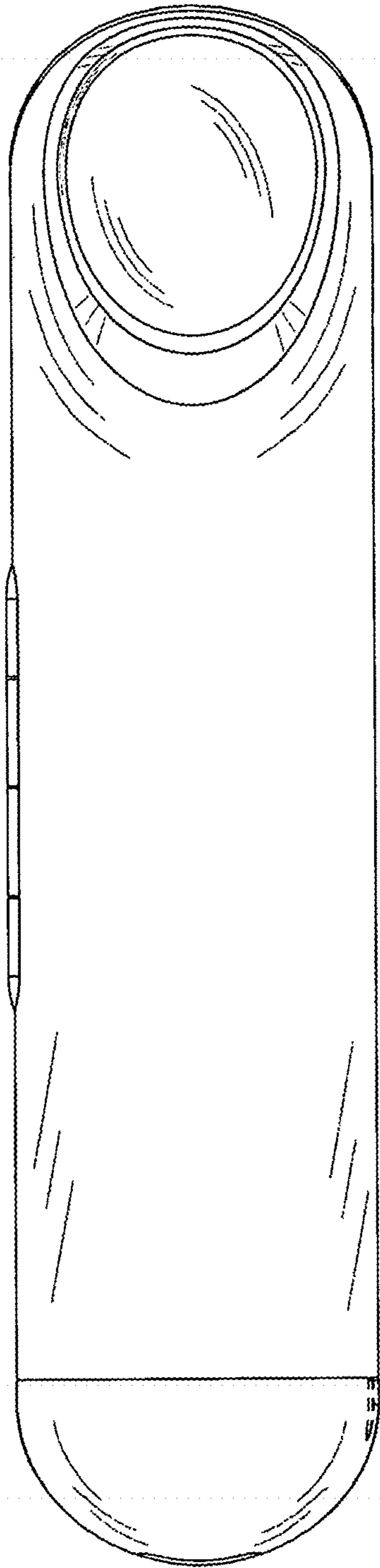

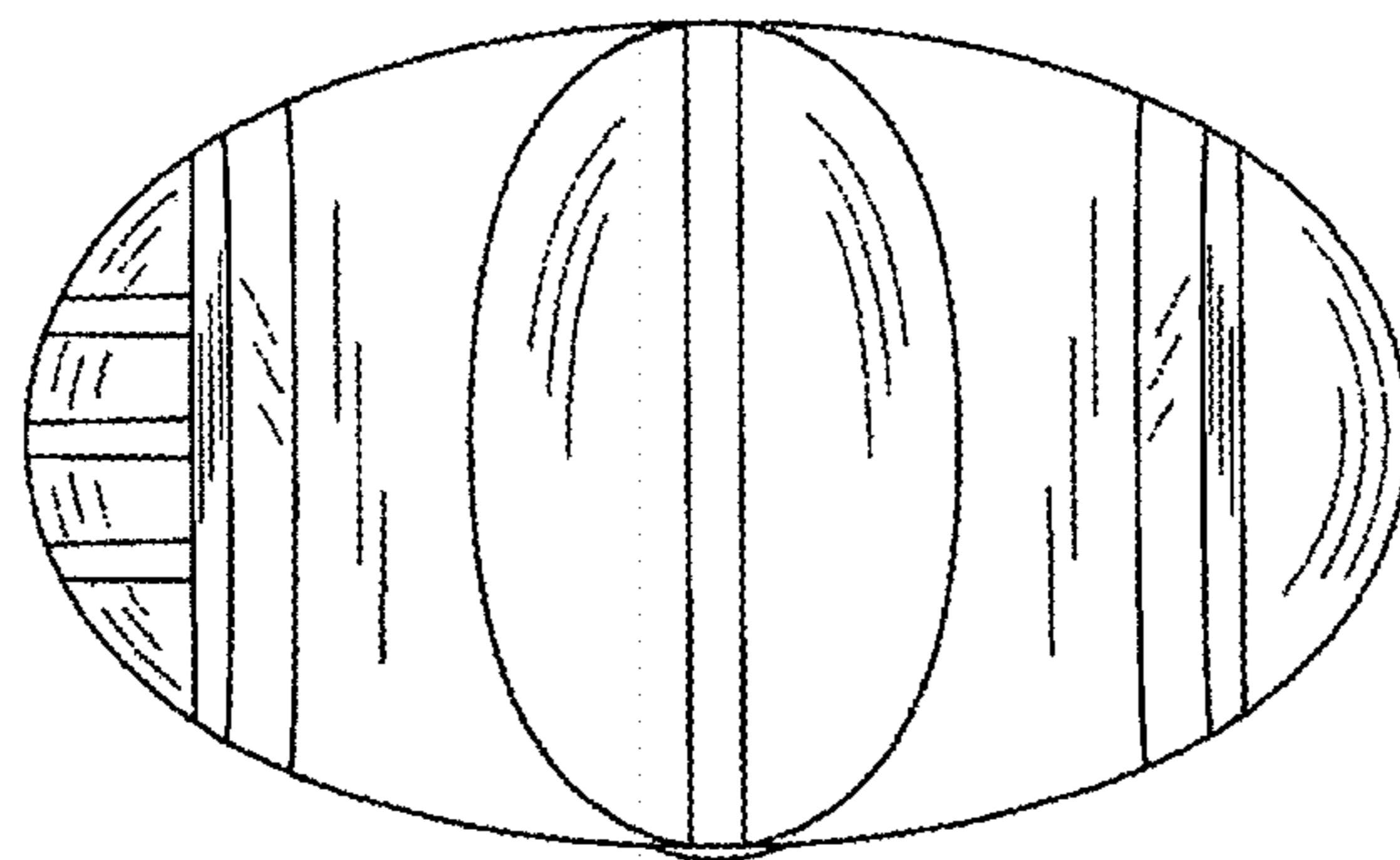

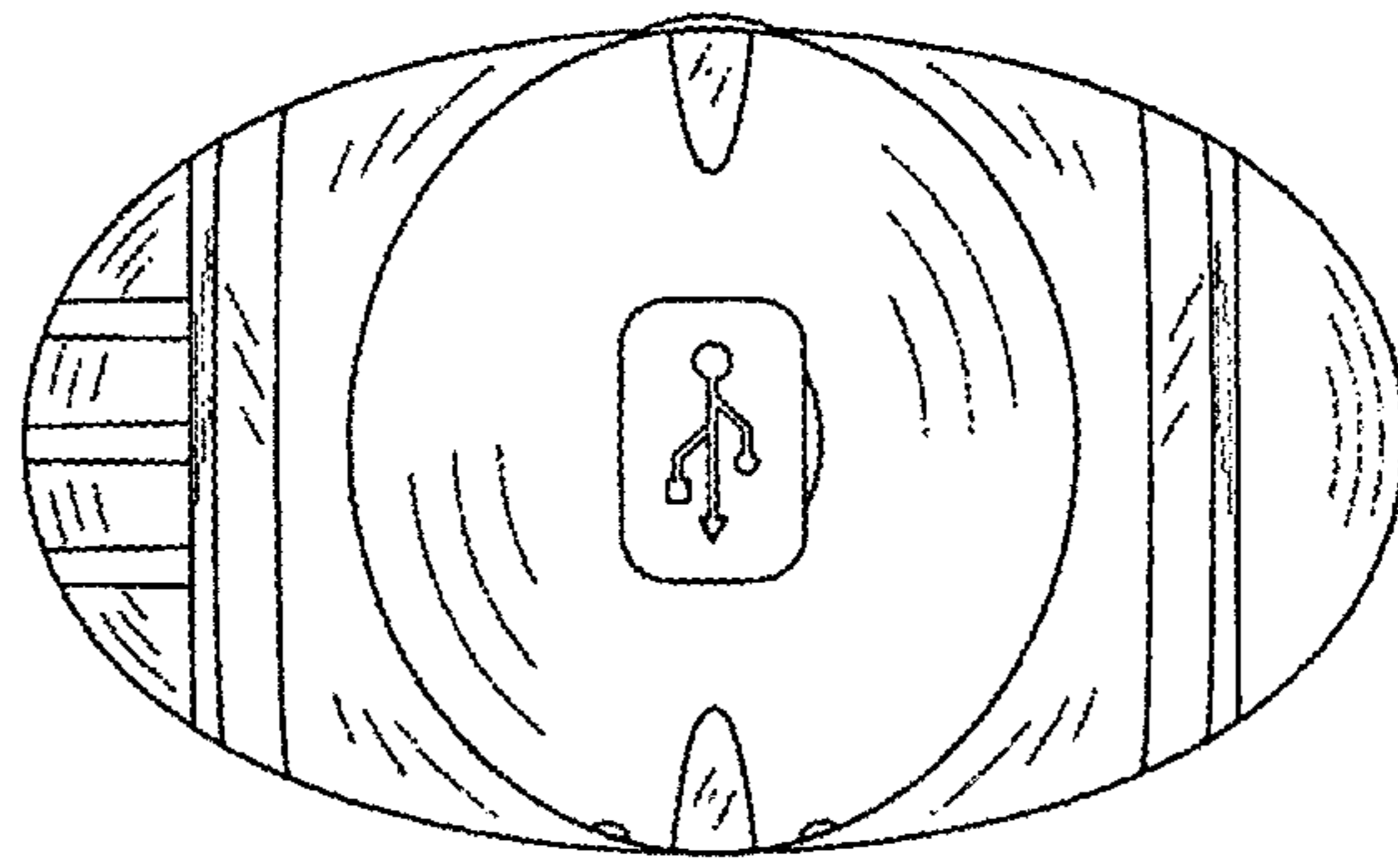
