FIG. 8 is a top view of the floor cleaning pad showing a sixth embodiment of my new design;

FIG. 9 is an enlarged view of a top surface thereof;

FIG. 10 is a bottom view thereof;

FIG. 11 is an enlarged view of a bottom surface thereof;

FIG. 12 is a front view thereof;

FIG. 13 is a right-side view thereof; and

FIG. 14 is a top-front perspective view thereof.

The back and left-side views of the embodiments of my new design for the floor cleaning pad are substantially the same as the front and right side views, respectively. In the second embodiment (FIGS. 8-14) of my new design for the floor cleaning pad the grayscale shading indicates color contrast.

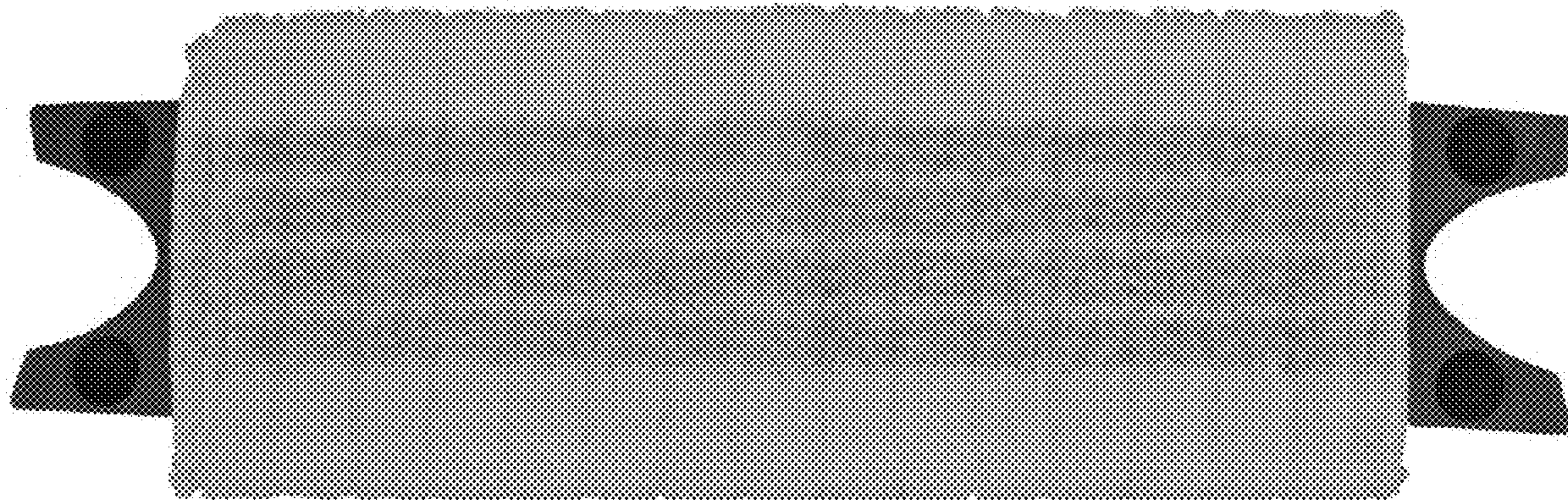

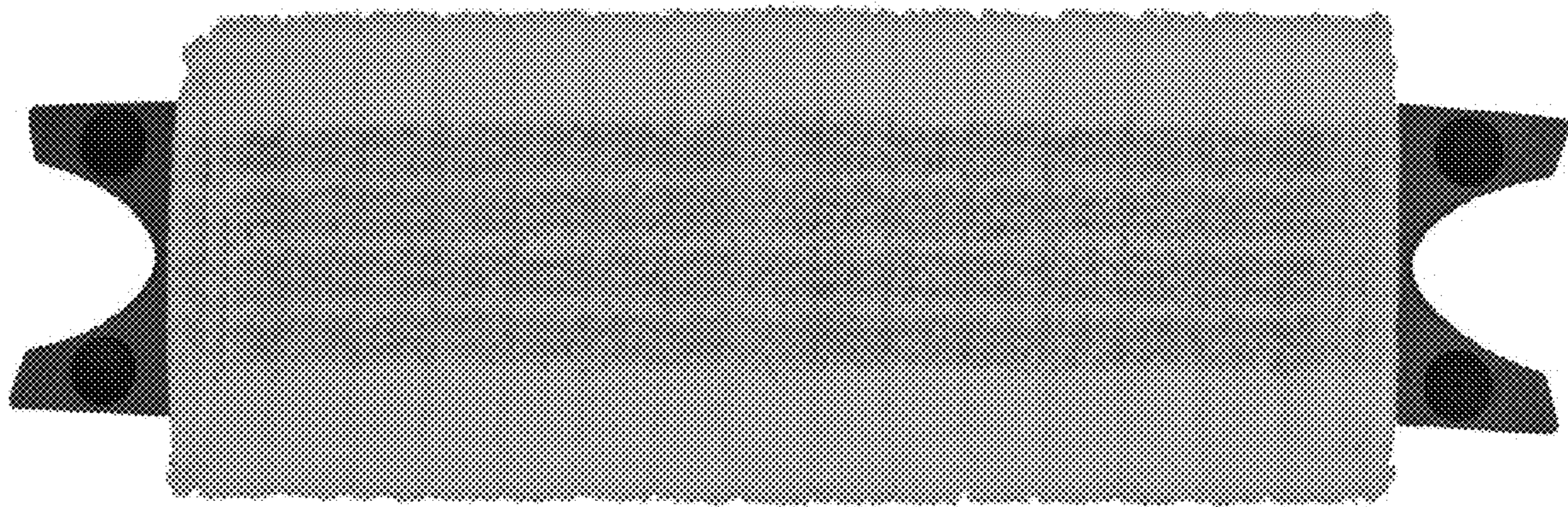

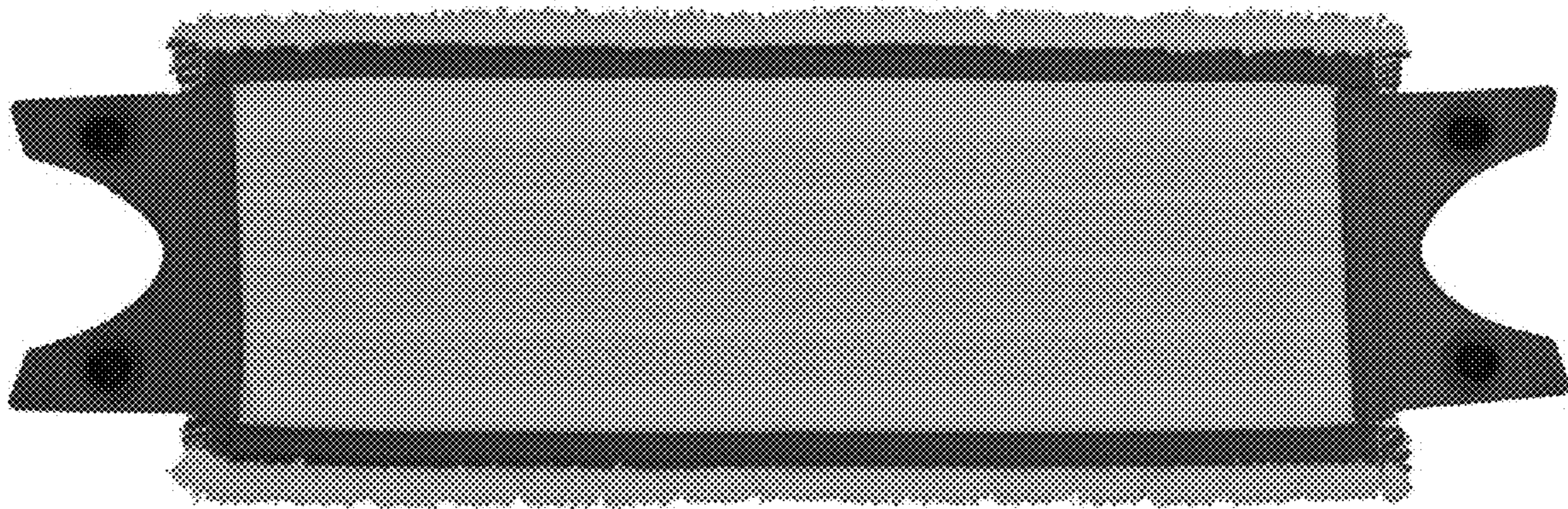

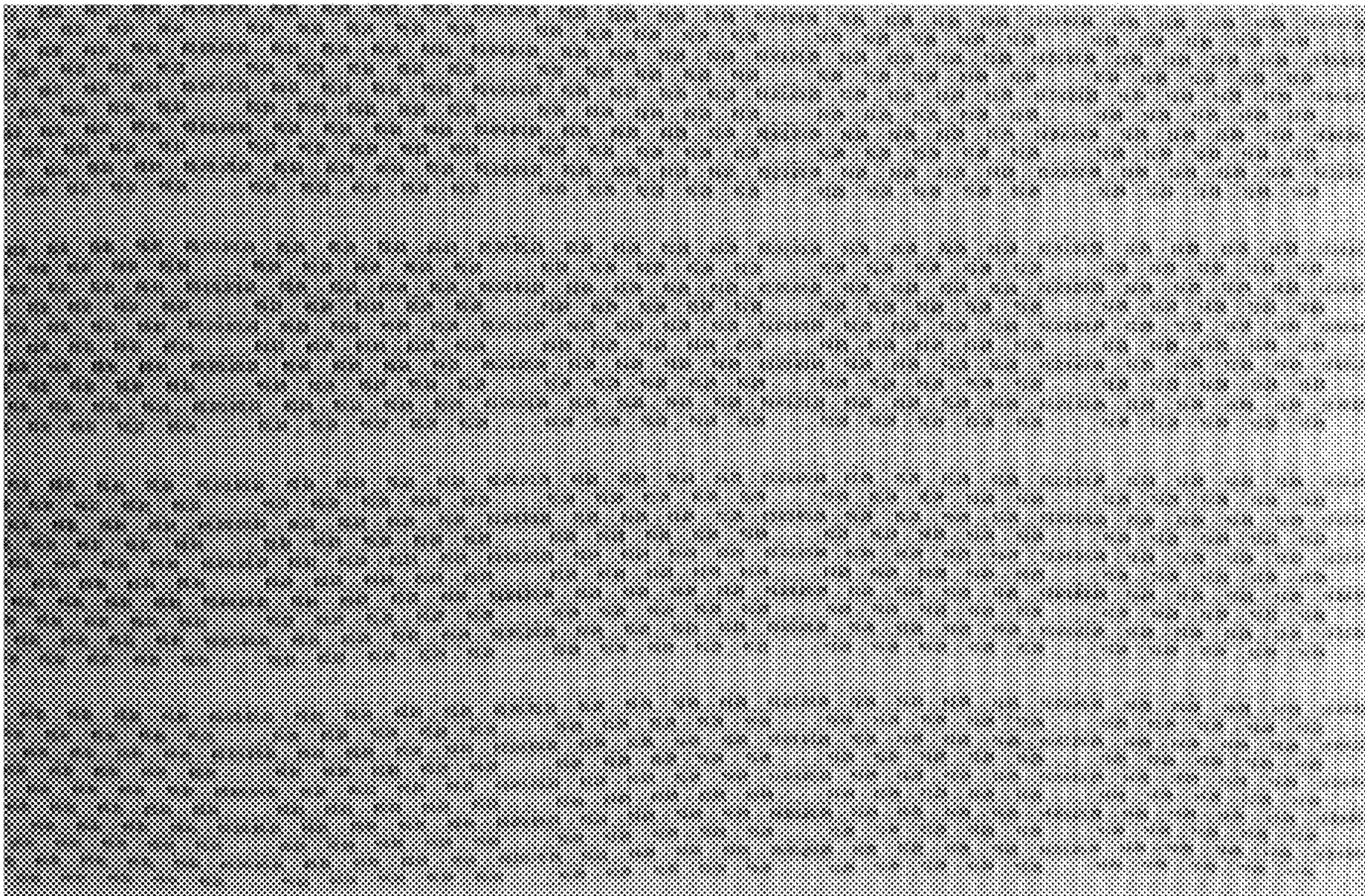

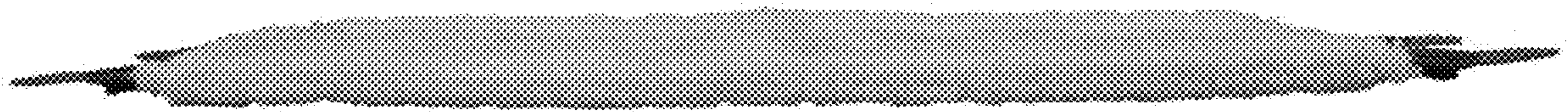

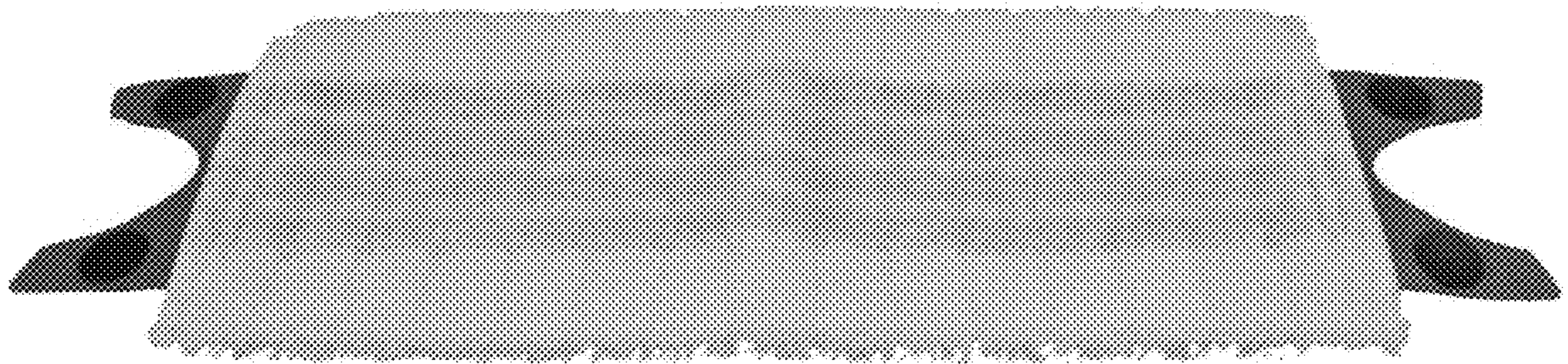

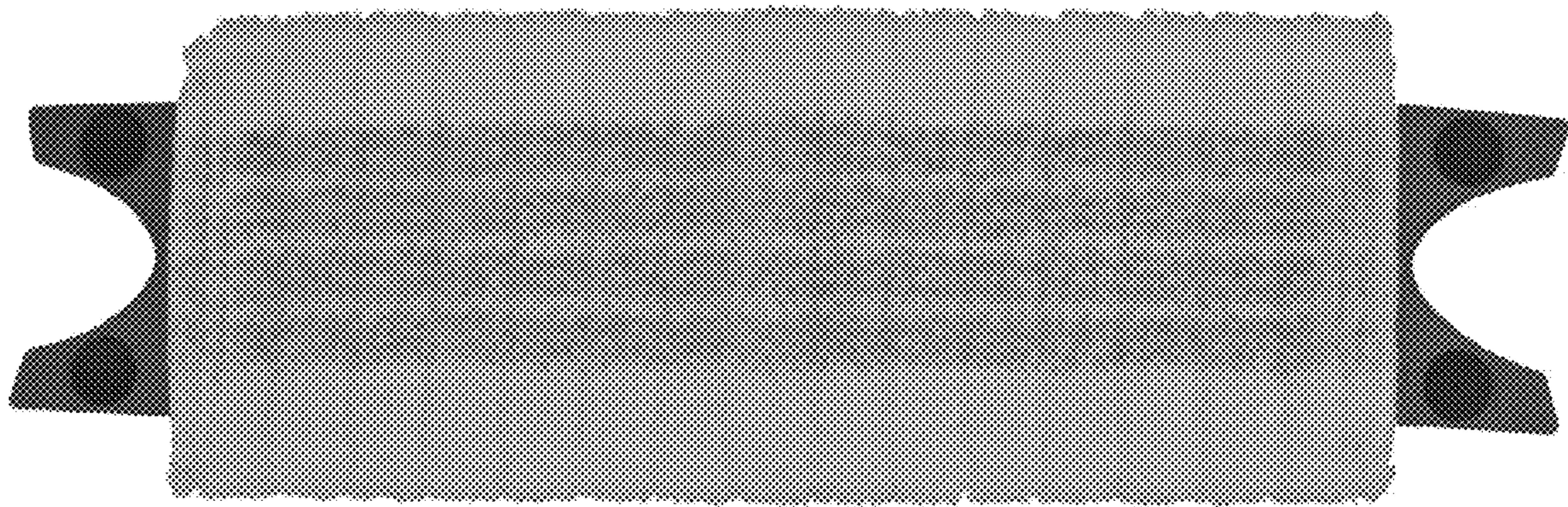

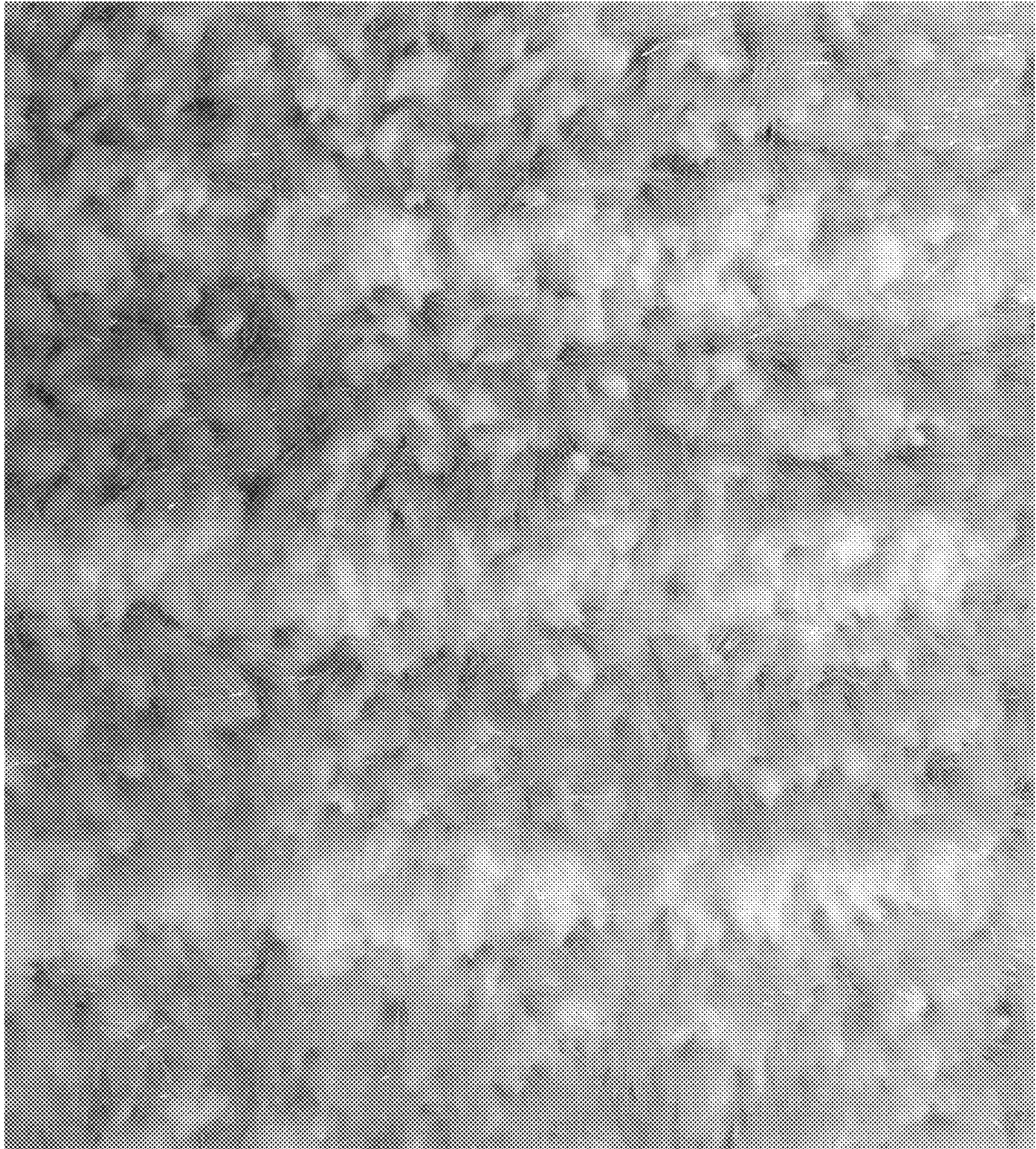

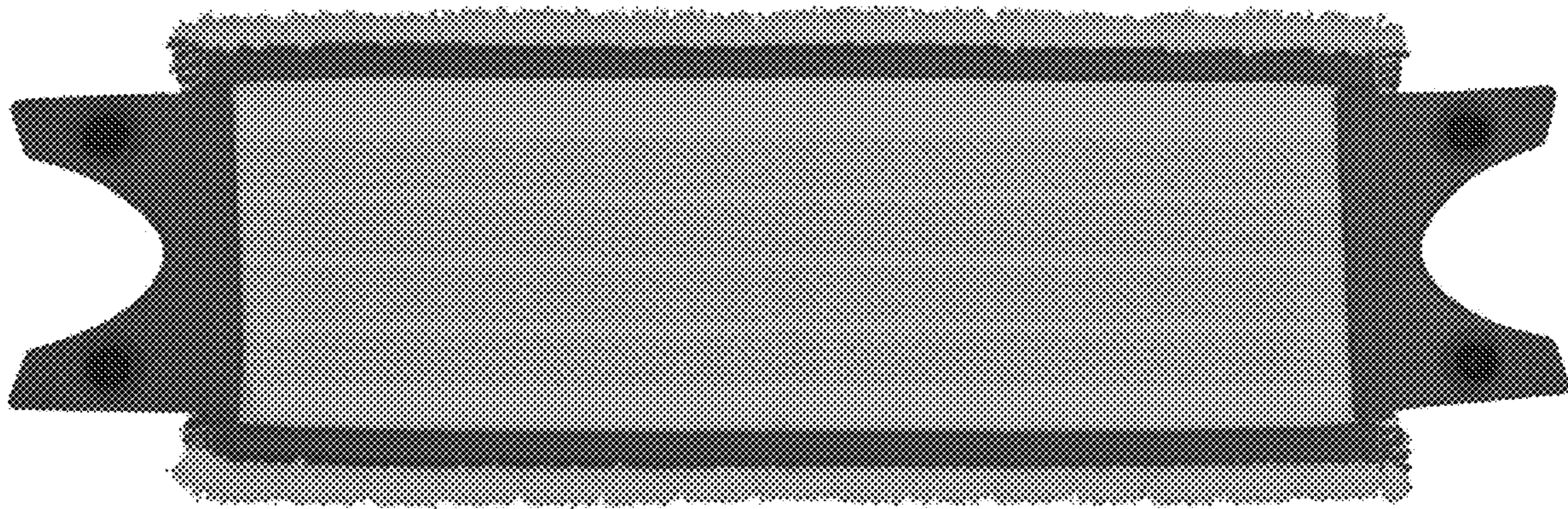

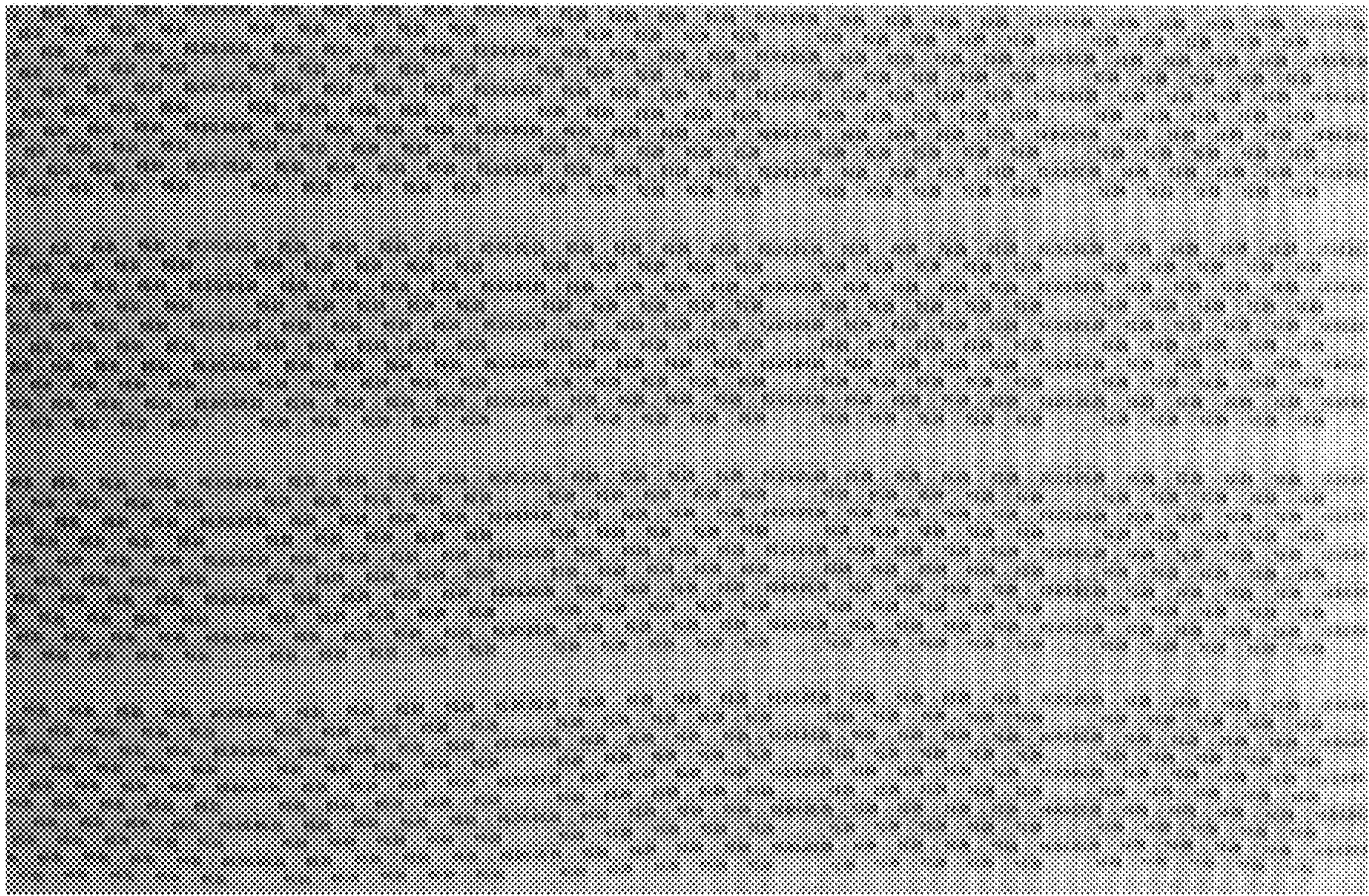

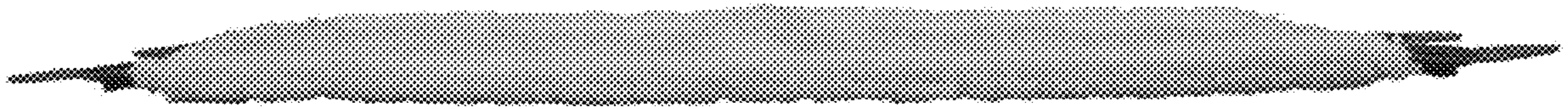

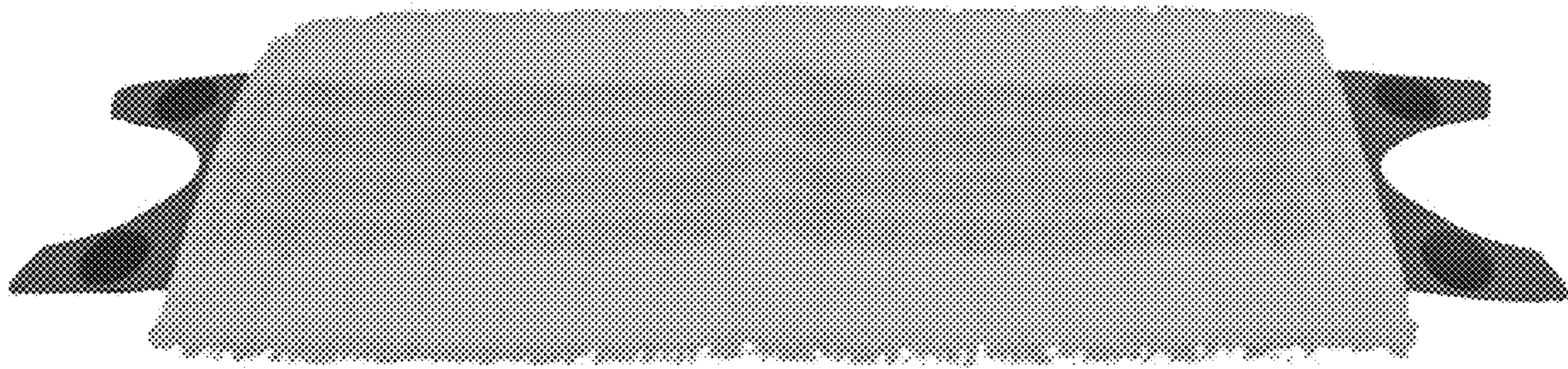
