(57) **CLAIM**

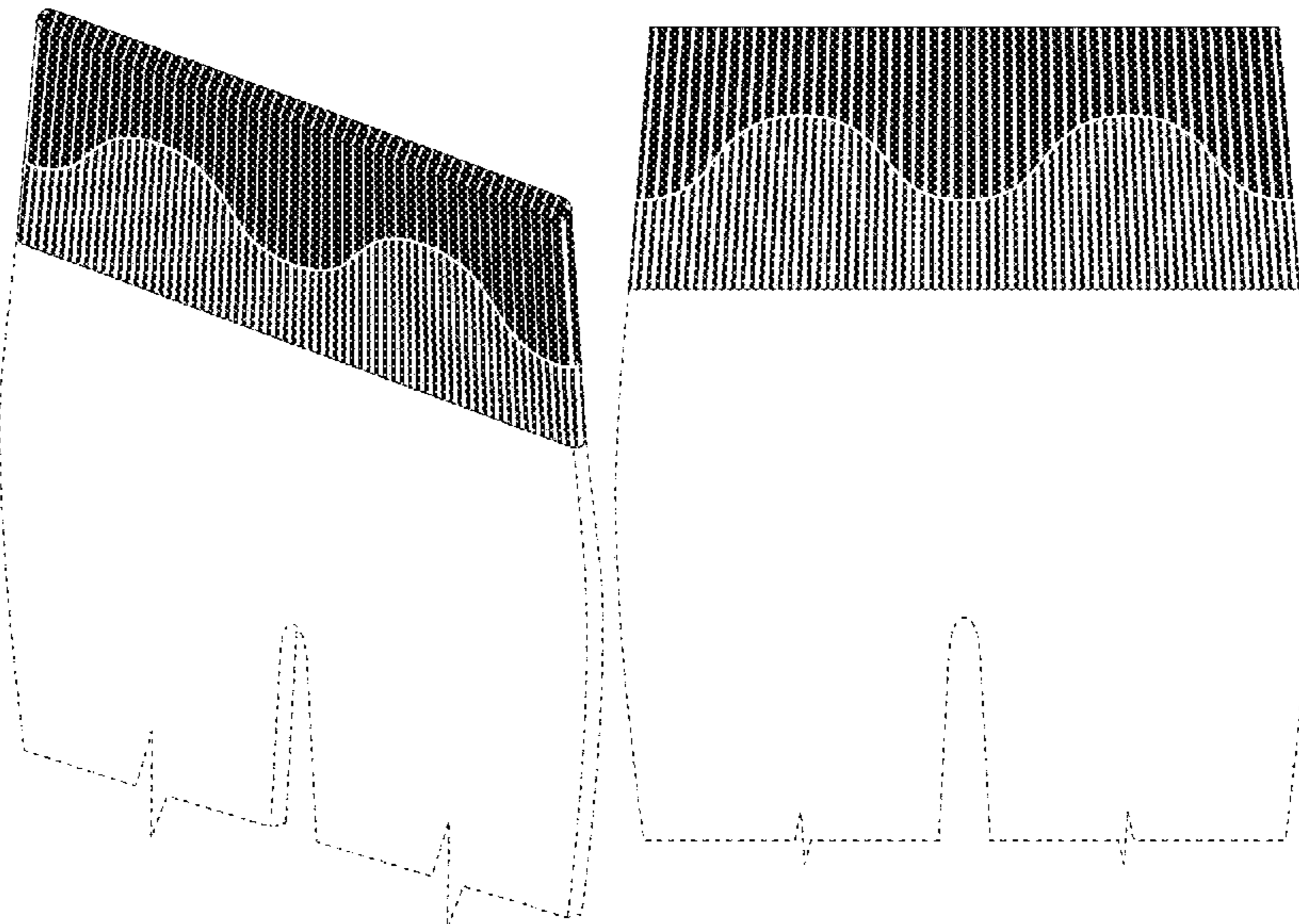
The ornamental design for a lower body garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lower body garment of the present design;  
FIG. 2 is a front view thereof;

FIG. 6 is a top view thereof; and,

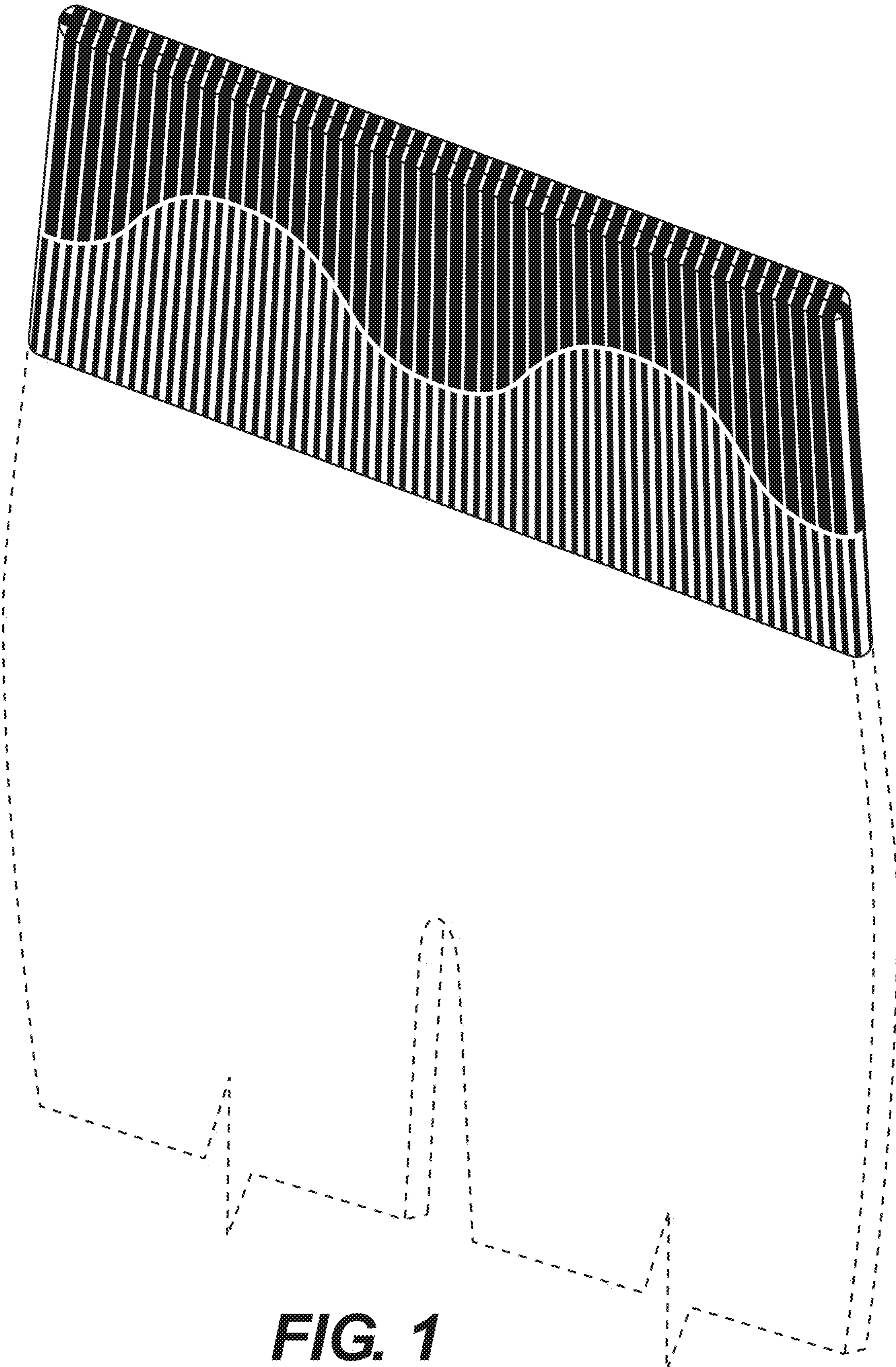

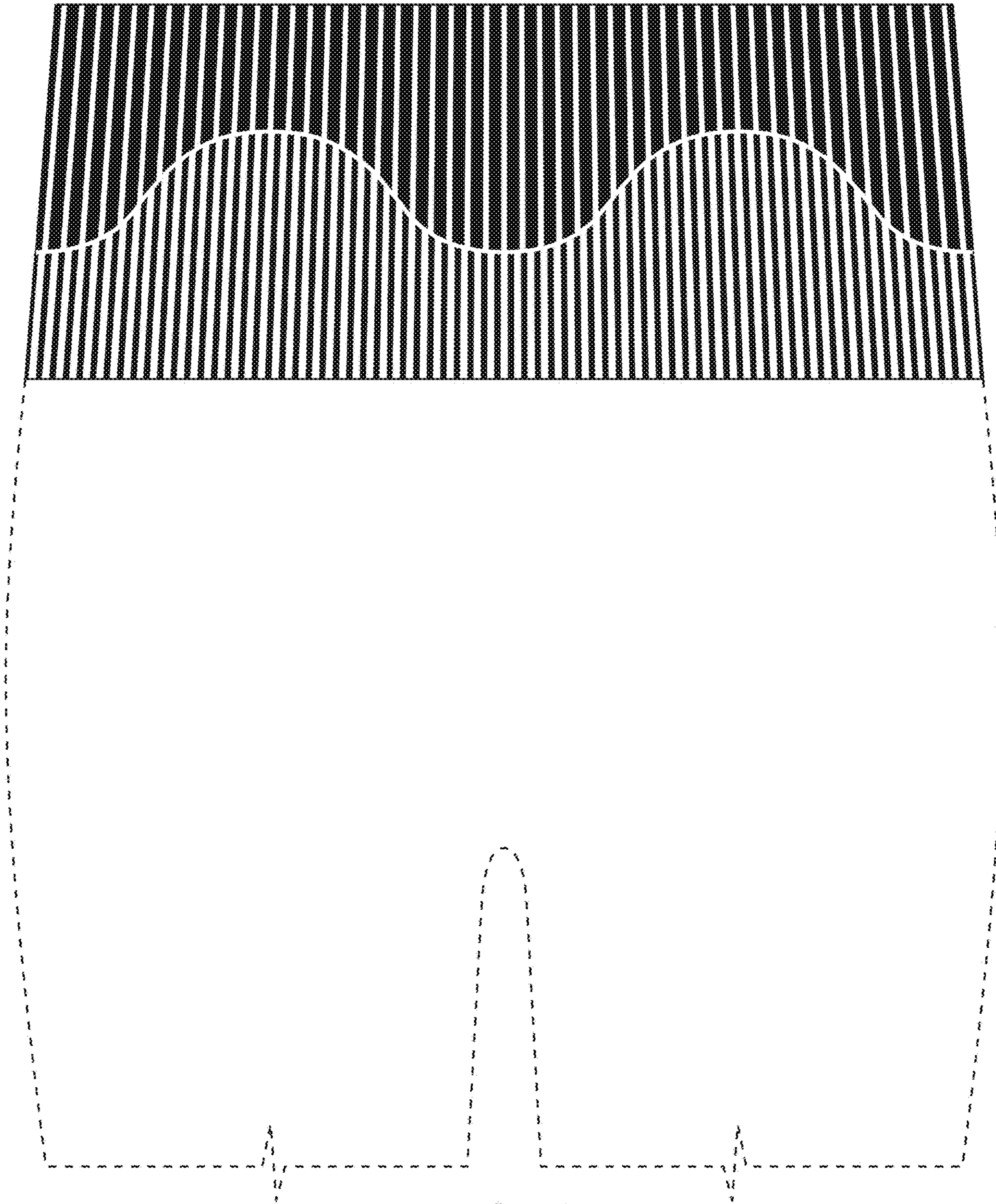

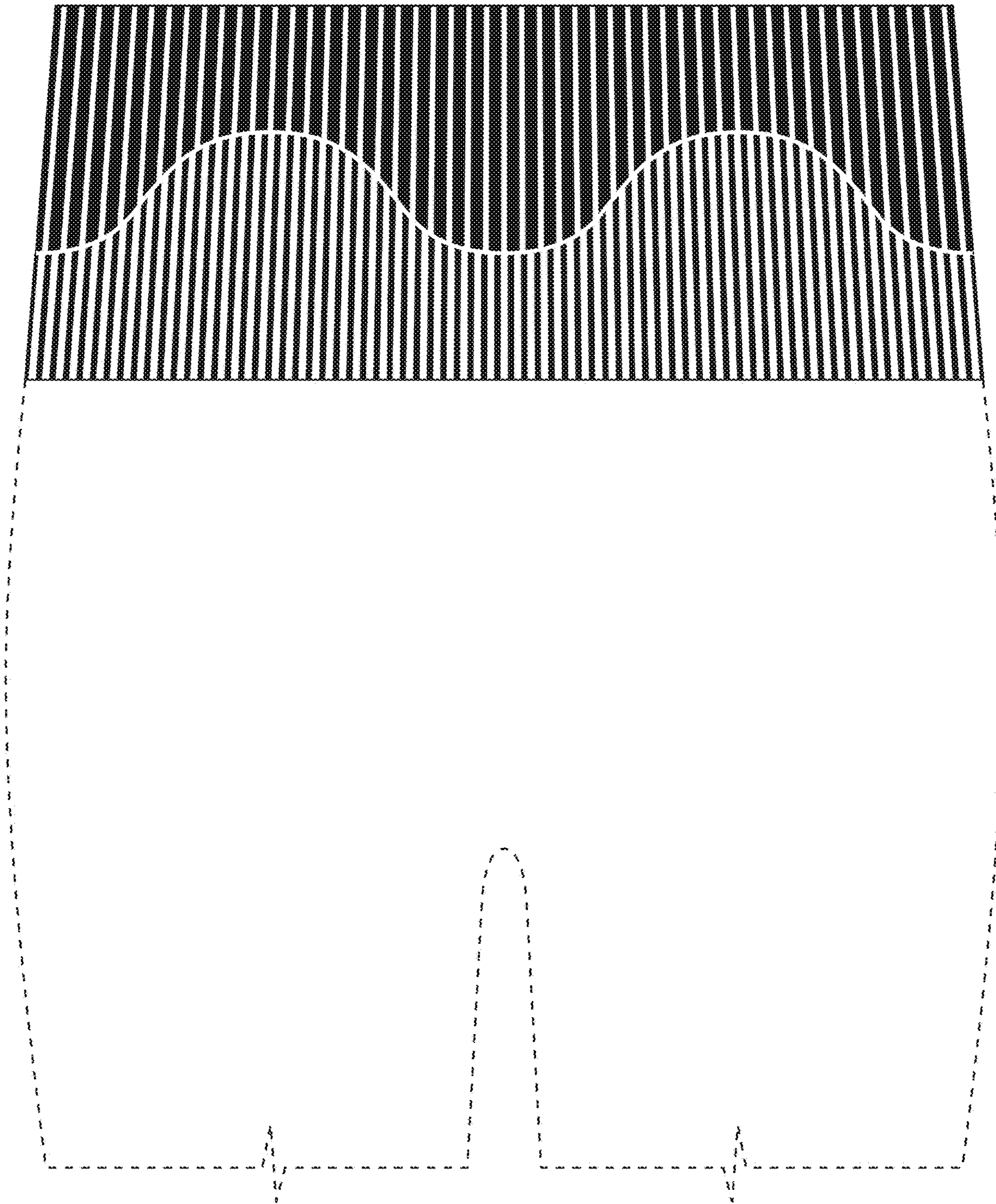

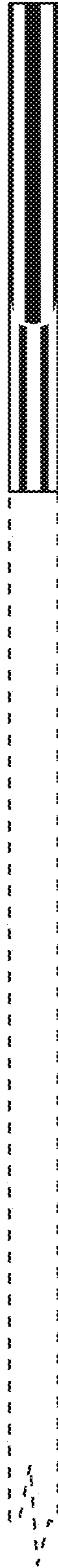
