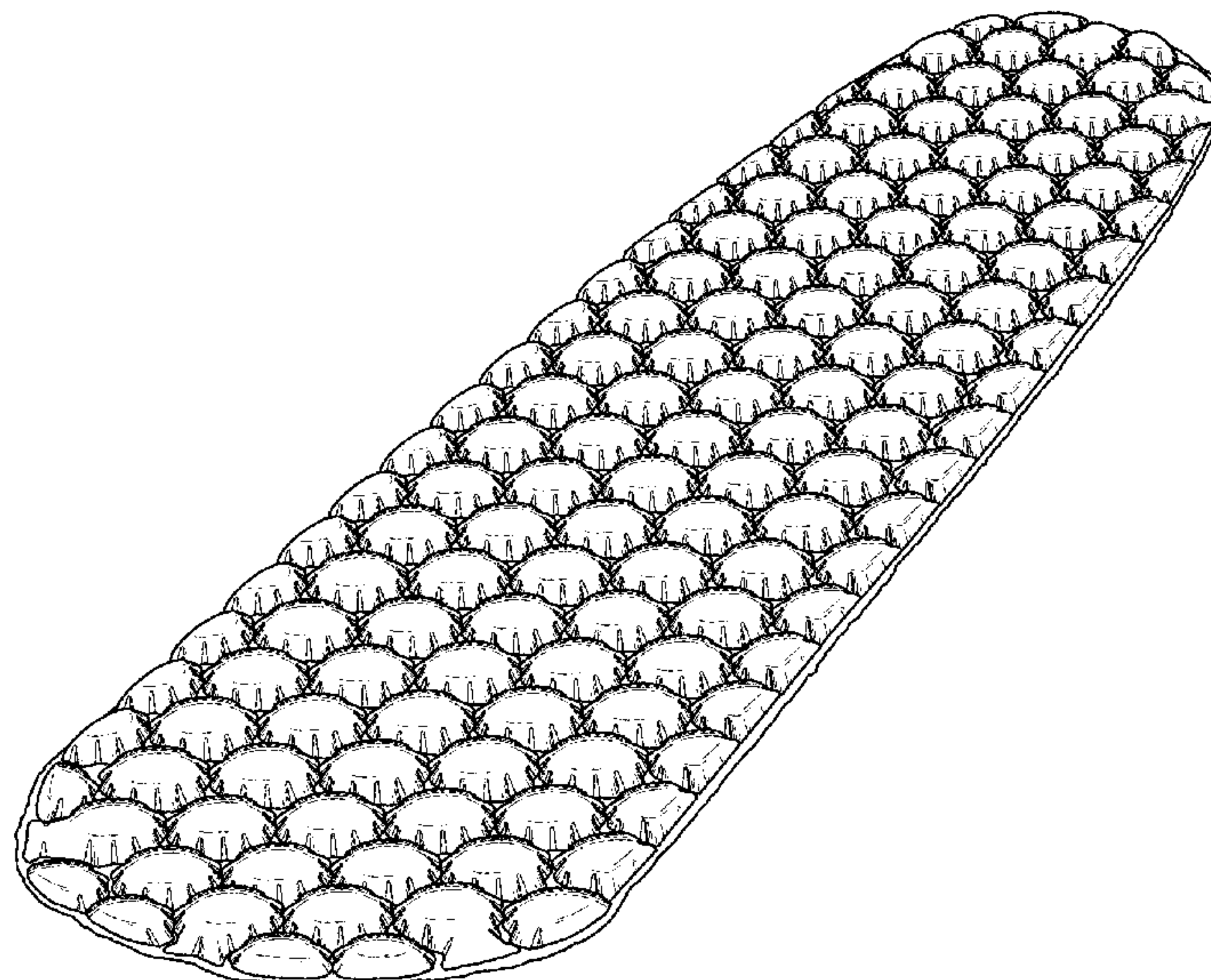
FIG. 1 is an isometric view of the claimed inflatable sleeping pad in an inflated configuration, embodying the present design;

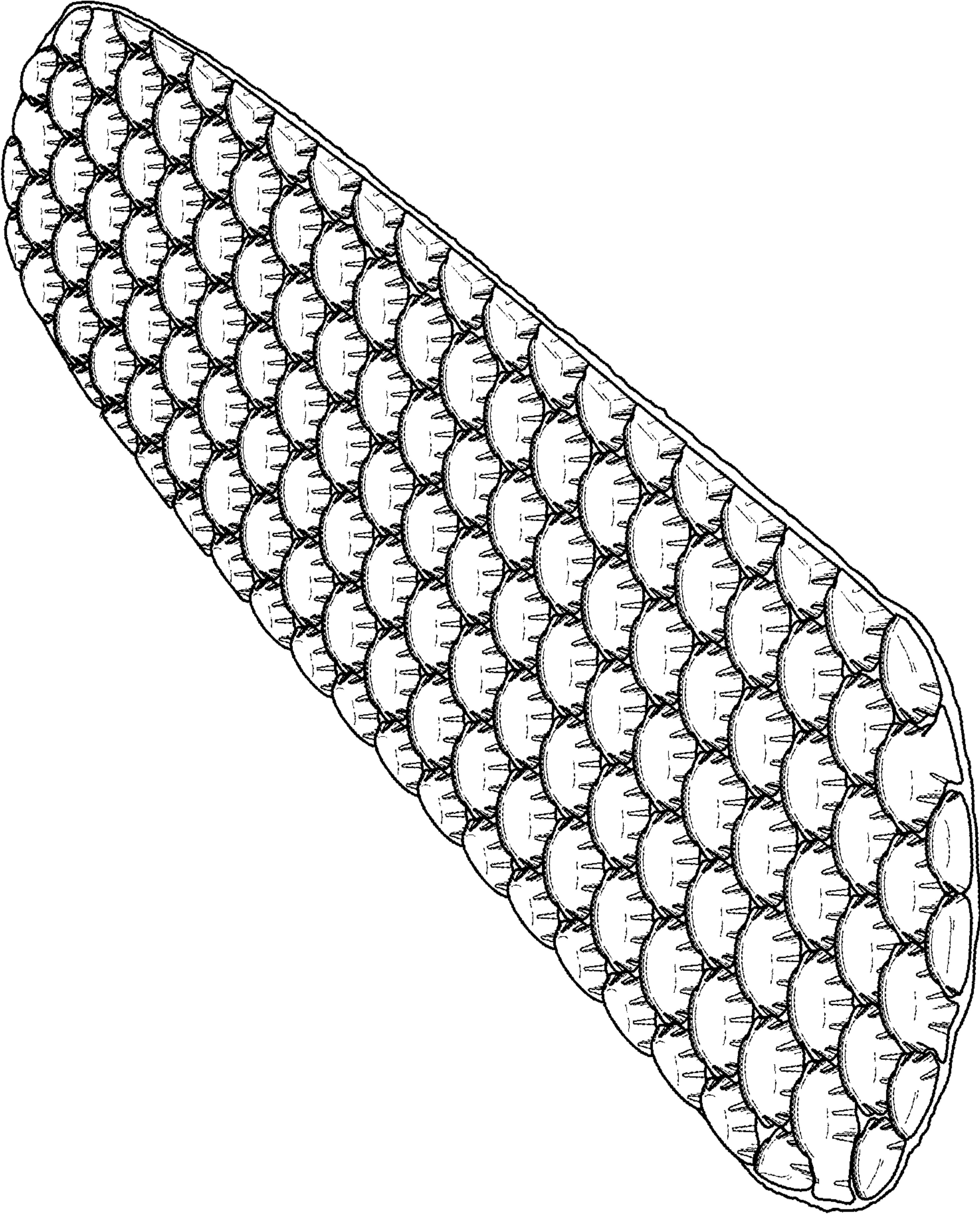

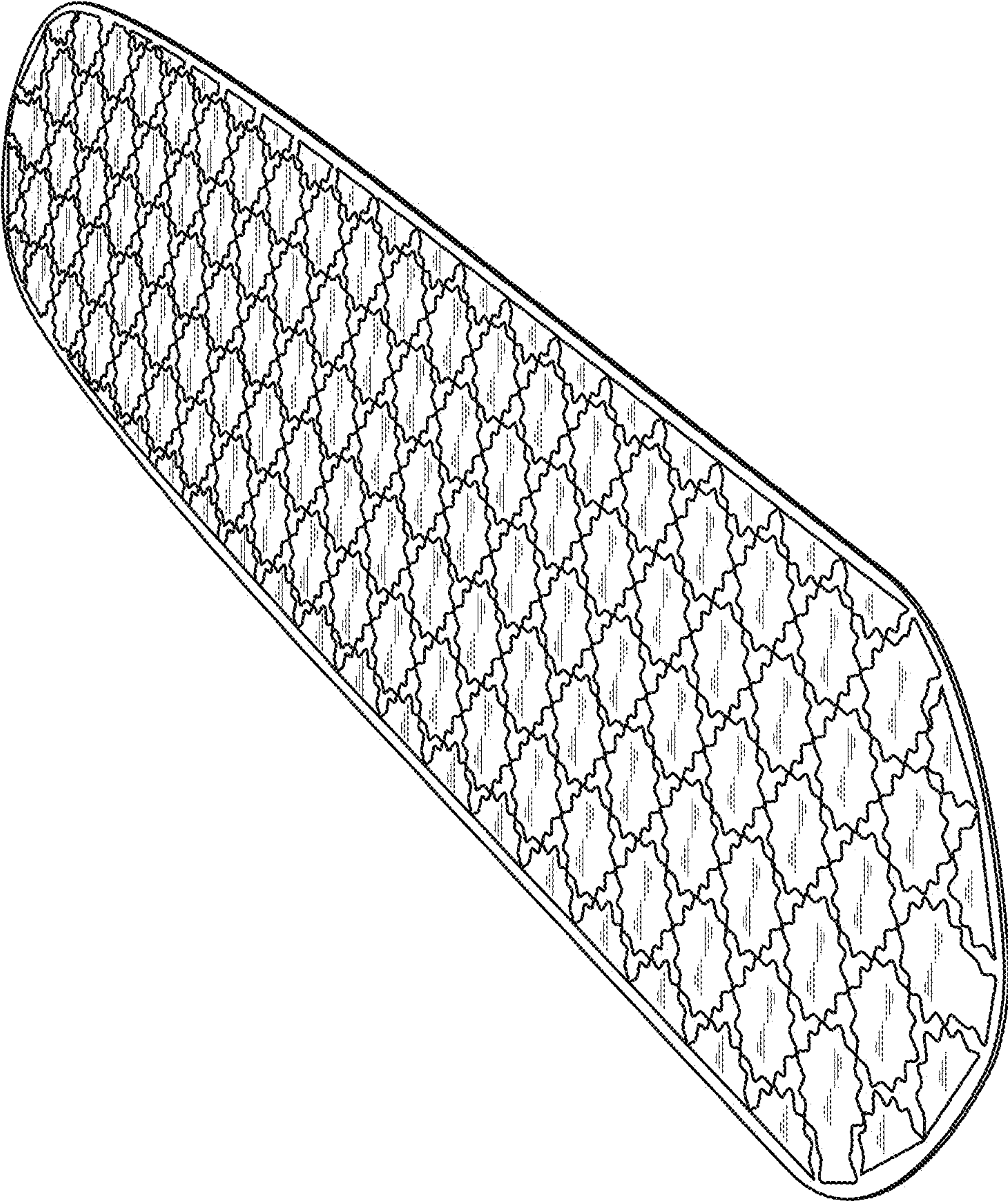

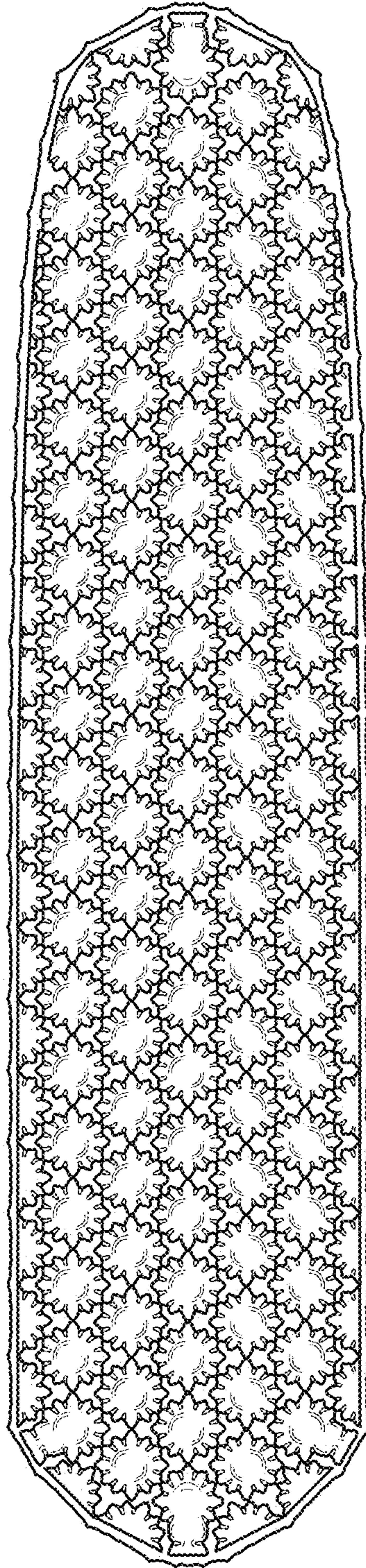

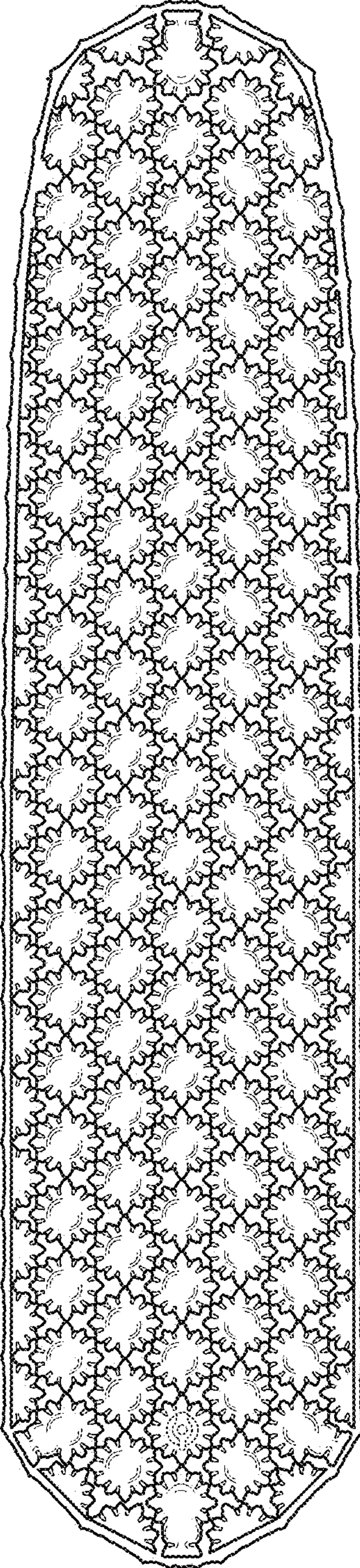

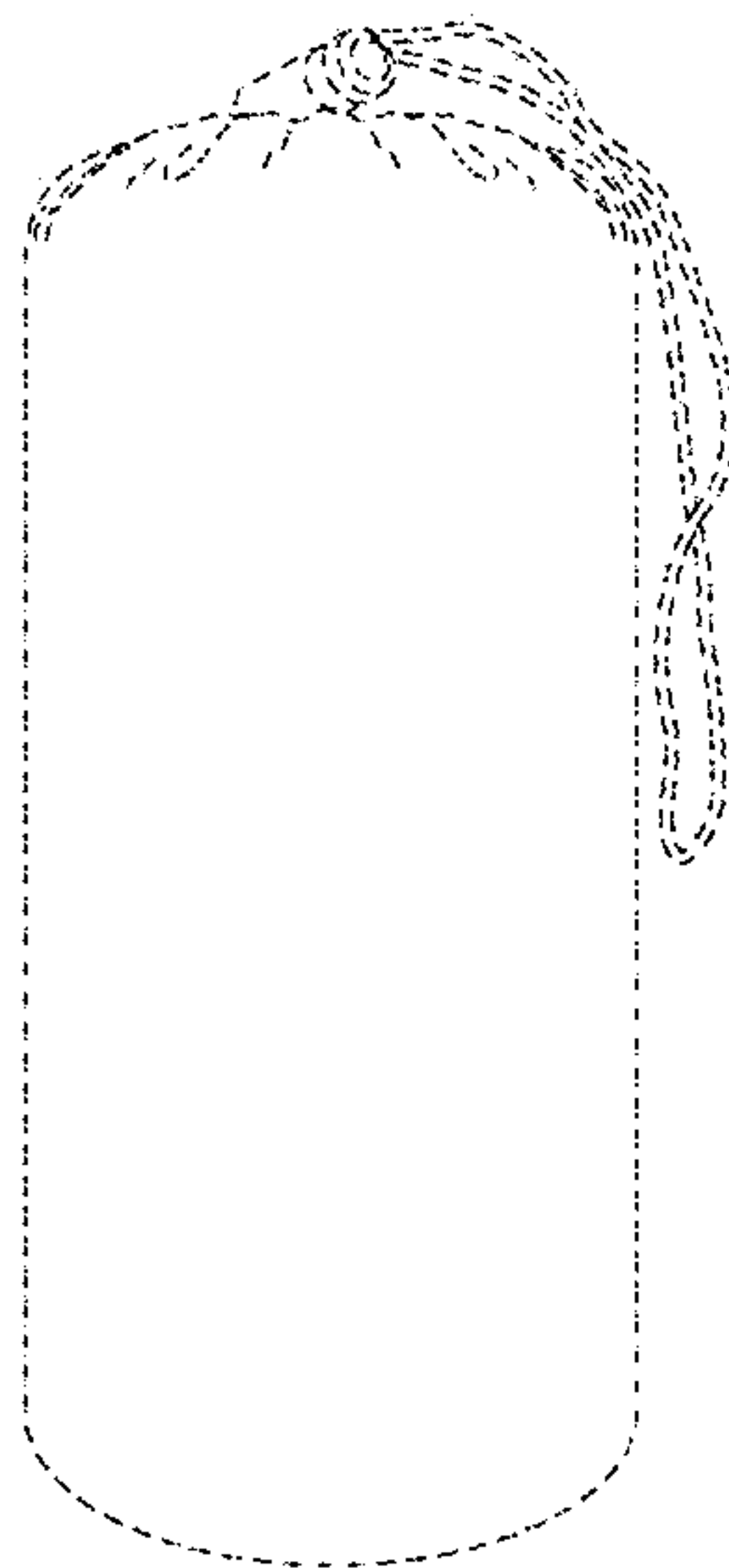
