DESCRIPTION

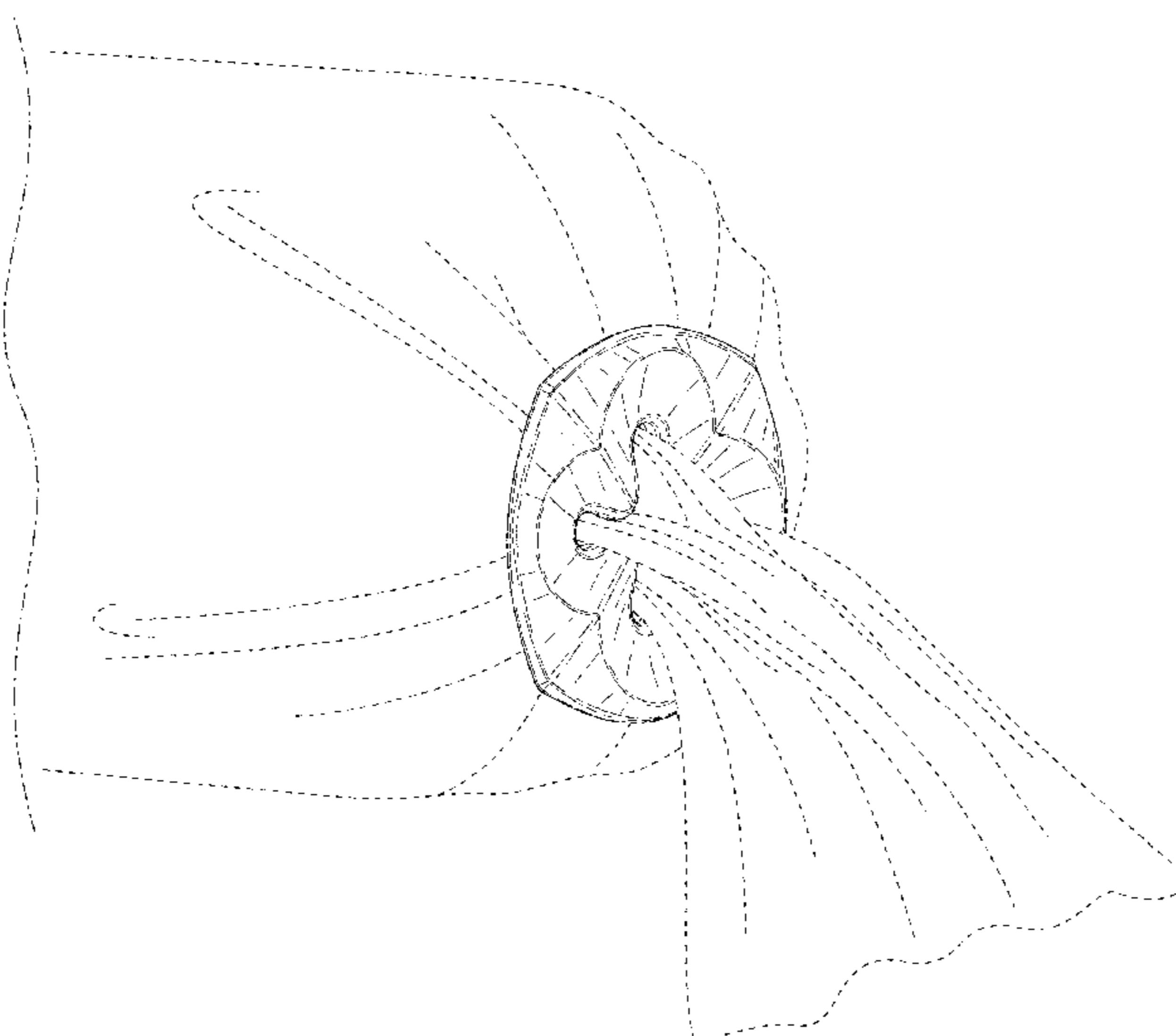
FIG. 1 is a perspective view of a pillow fastener, showing my new design, illustrated on a pillow;

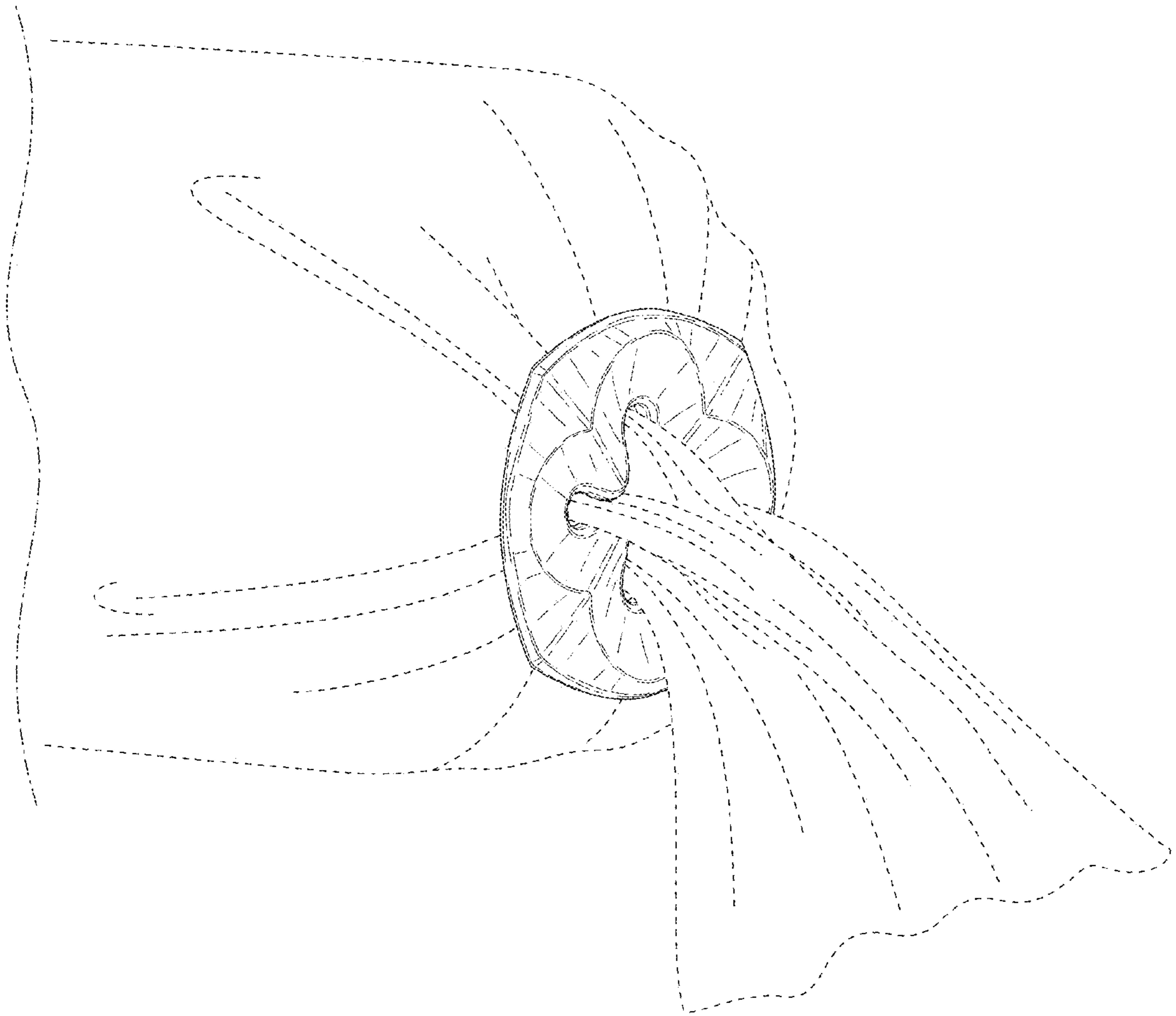

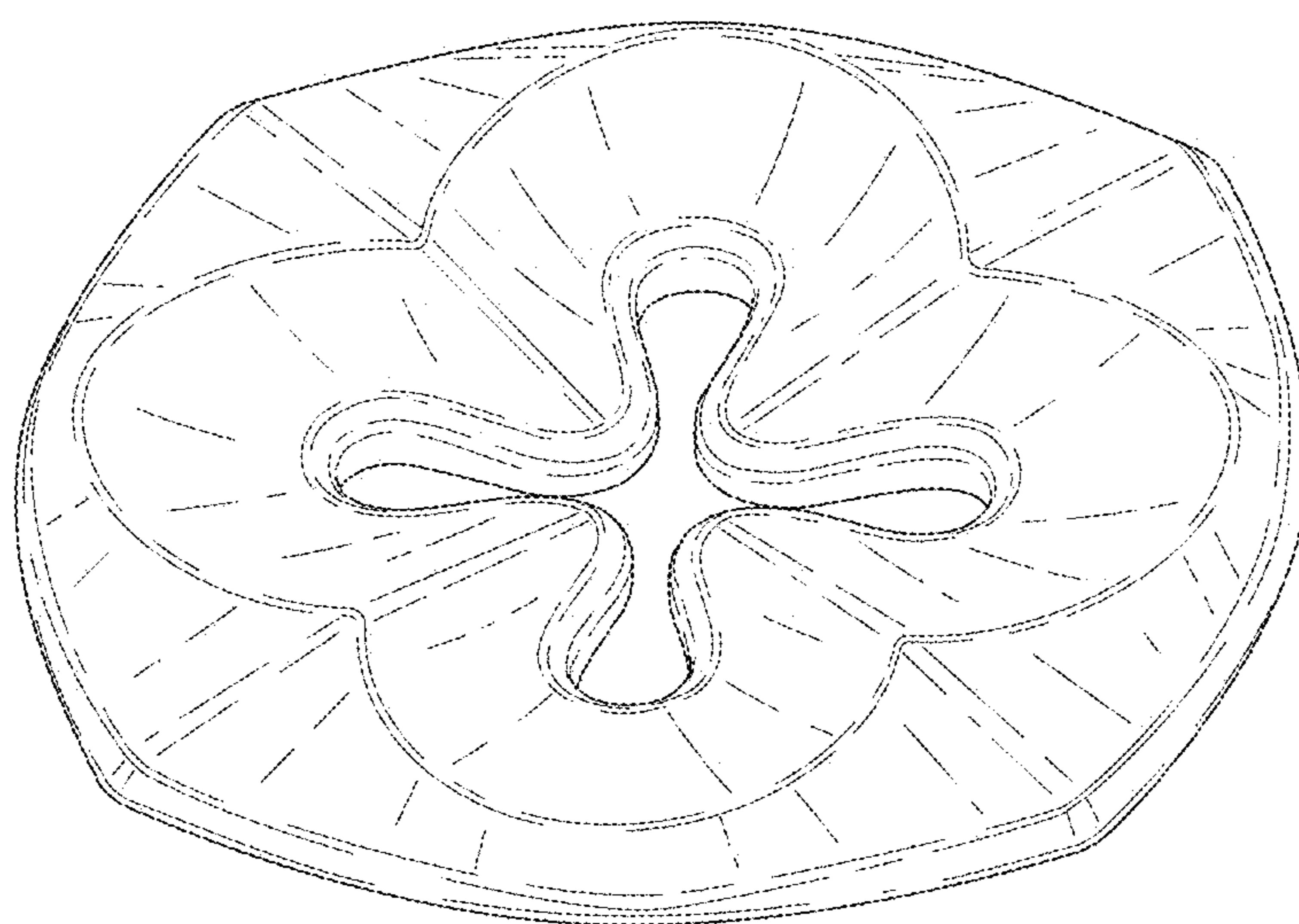

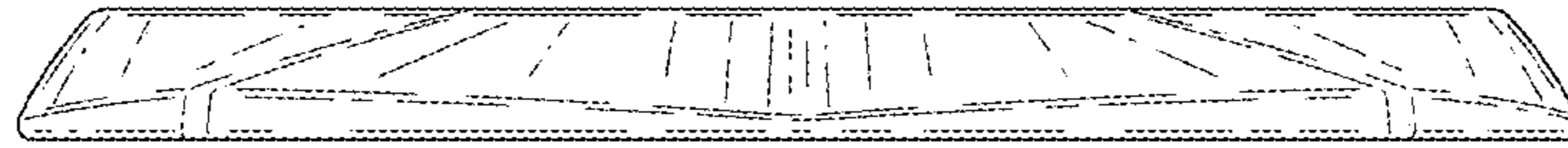

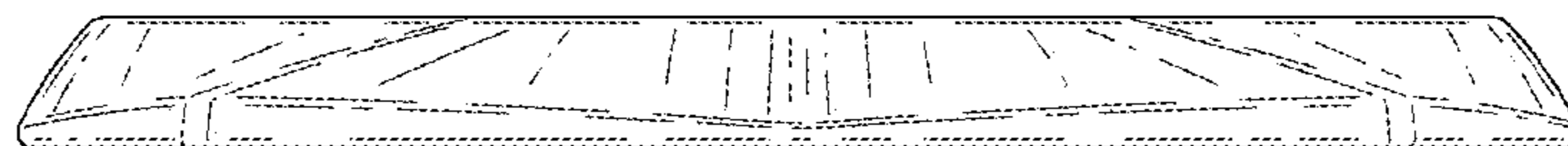

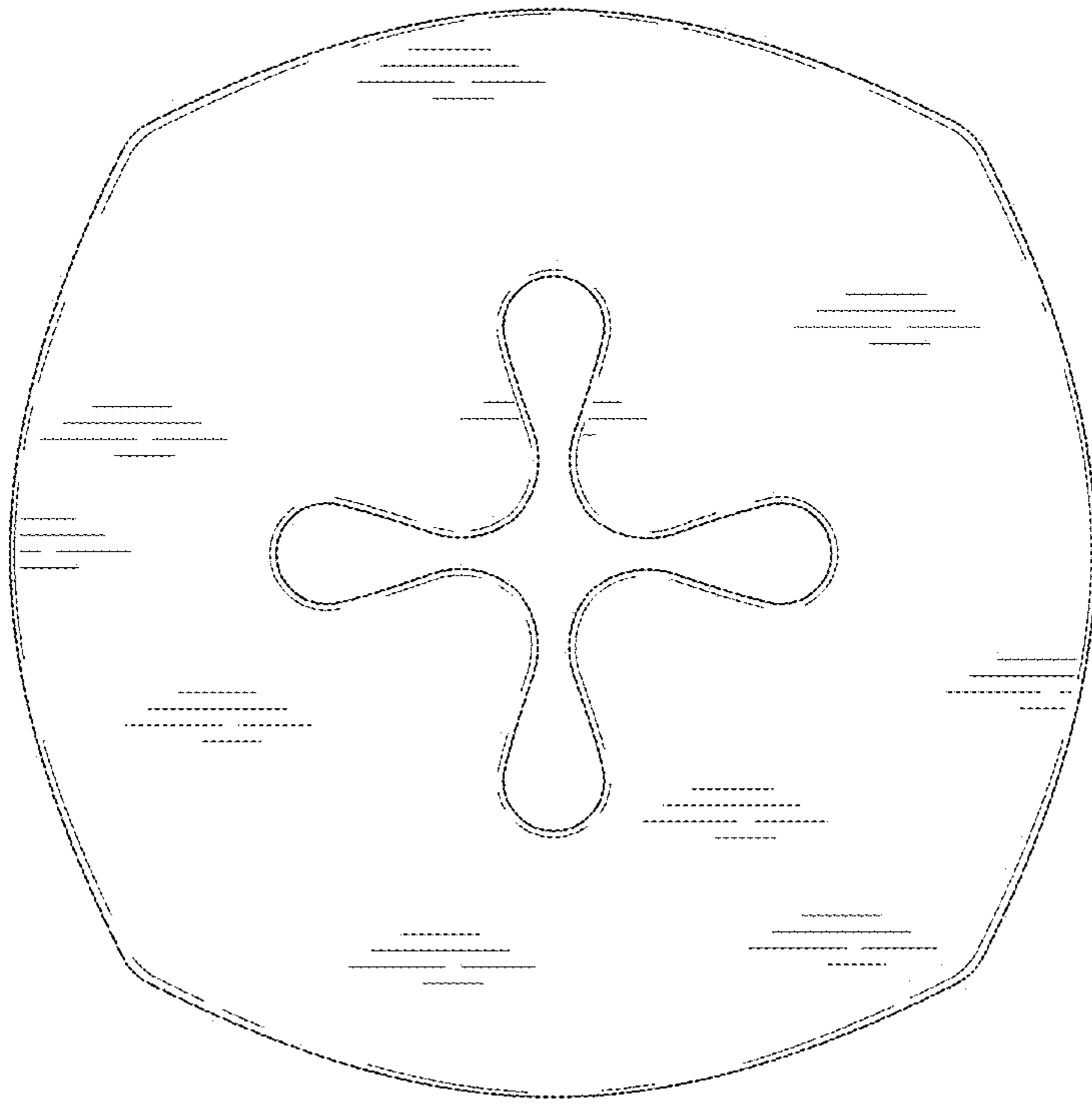

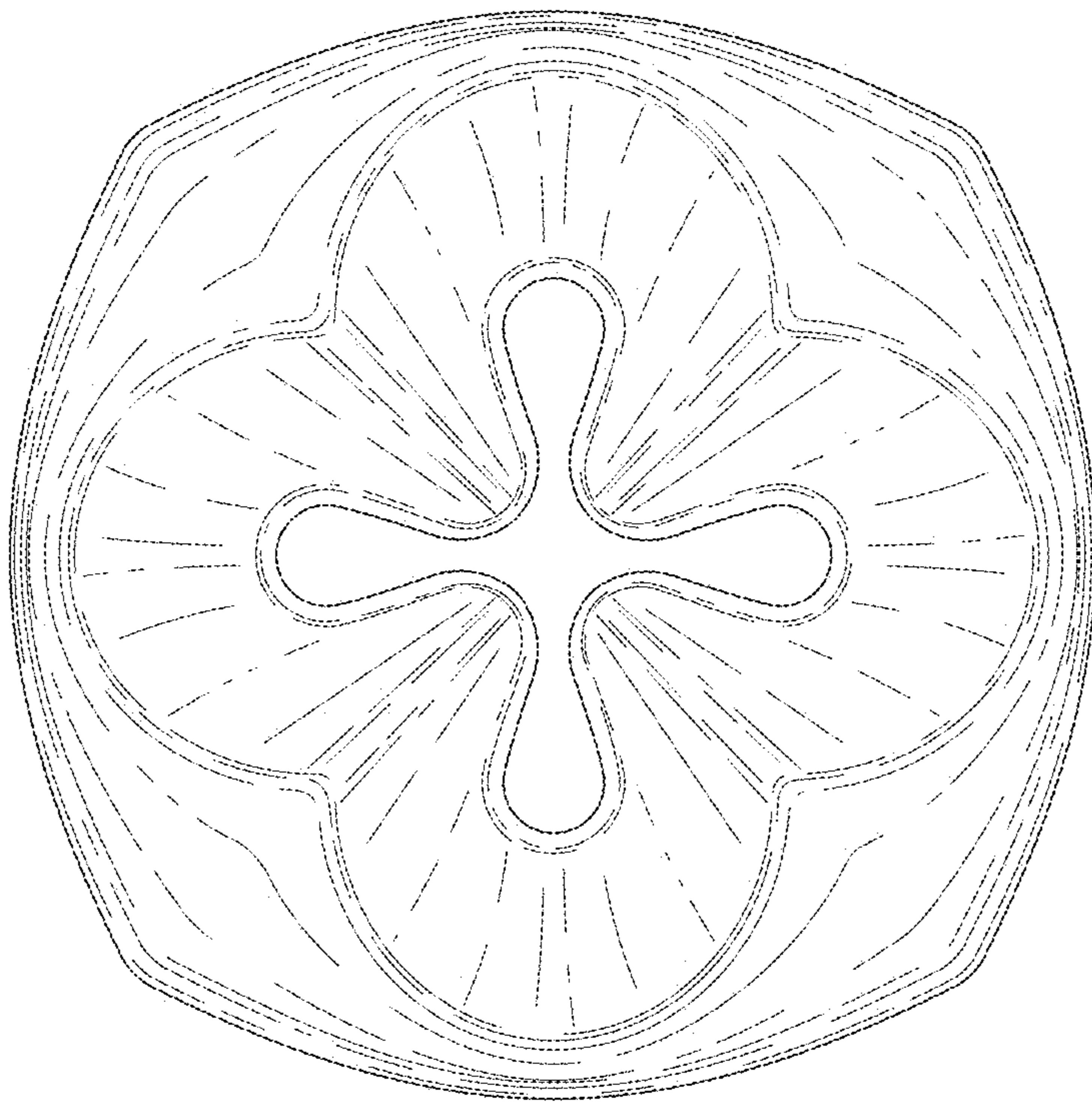
