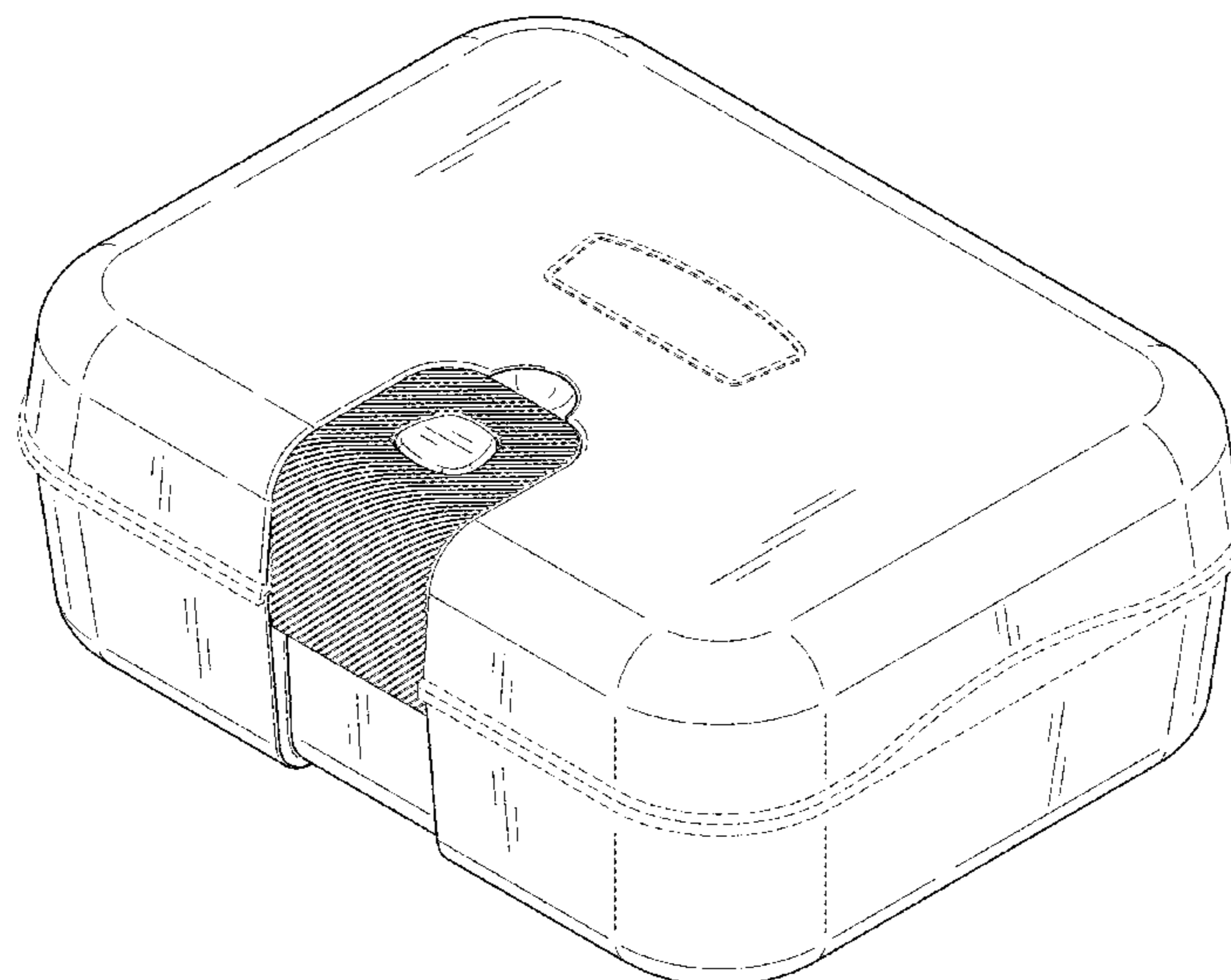
FIG. 14 is a left side view of the second embodiment of the food container.

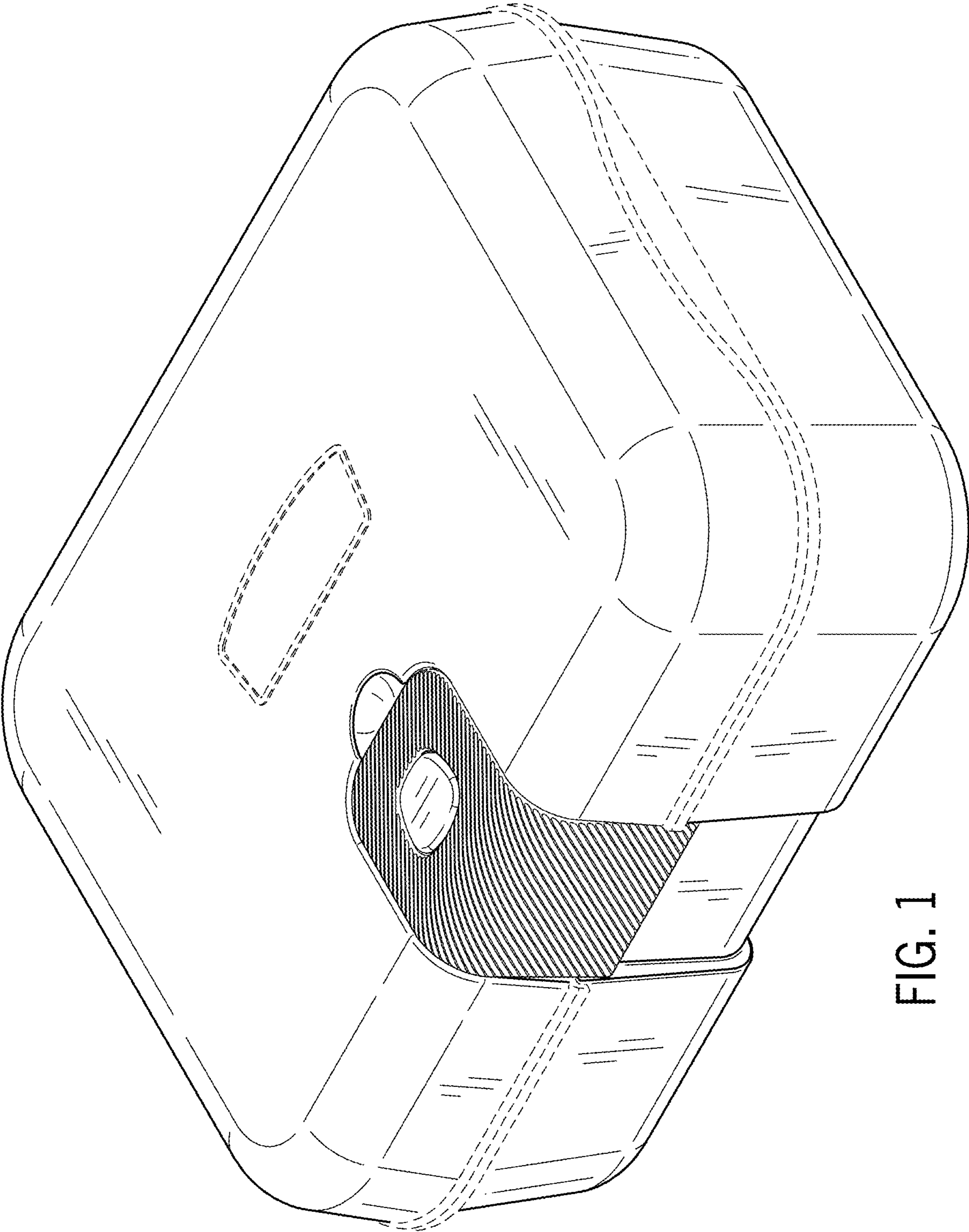

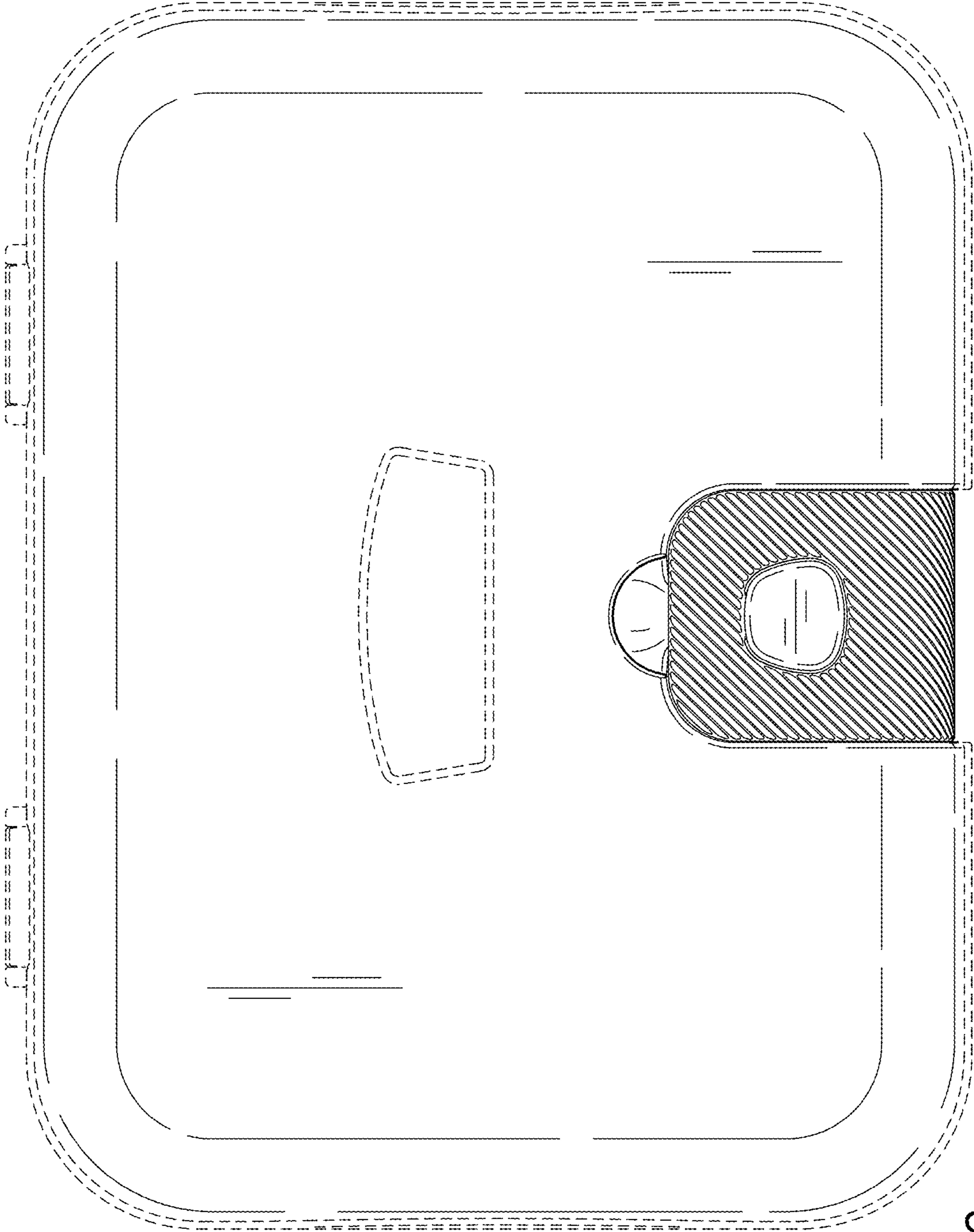

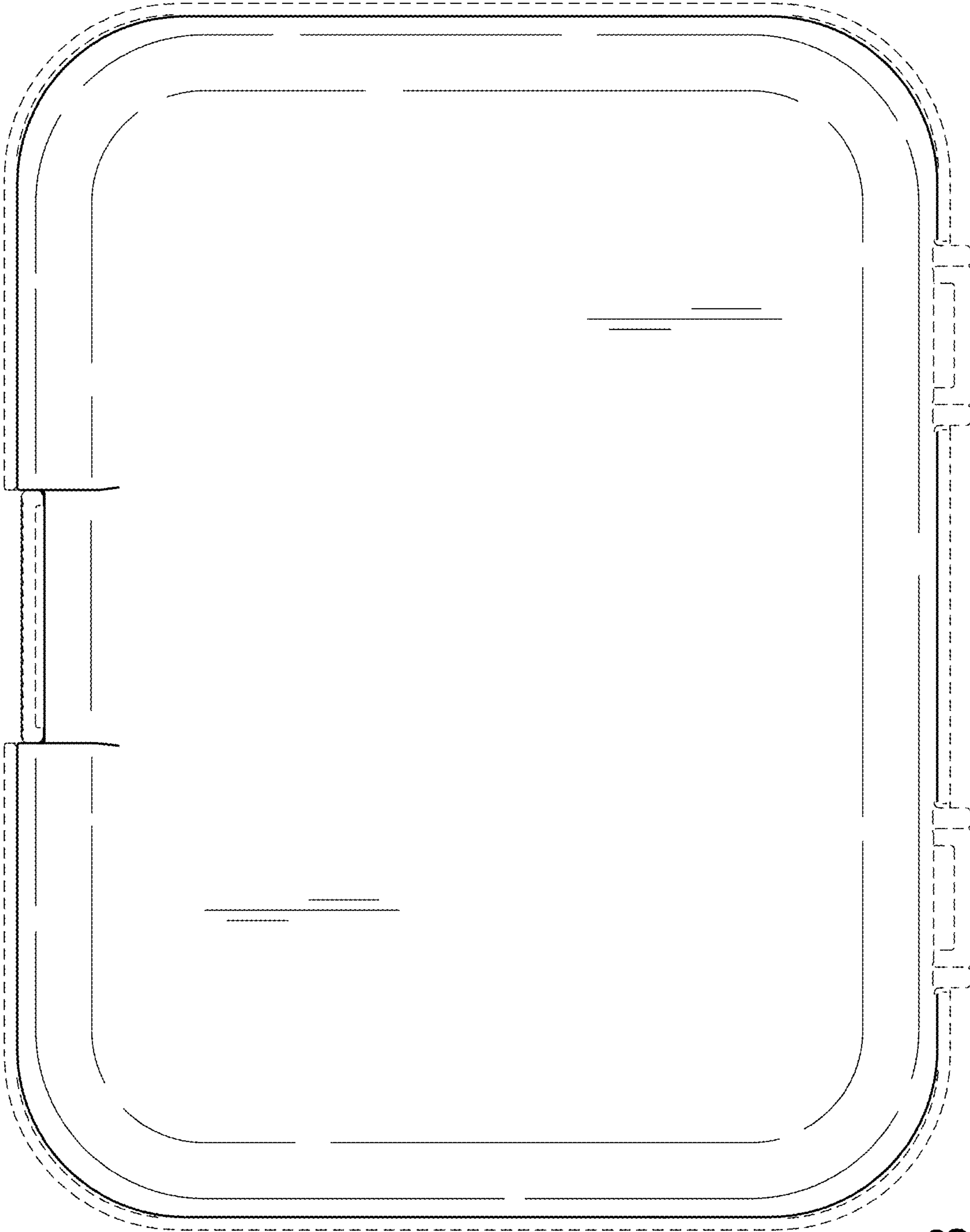

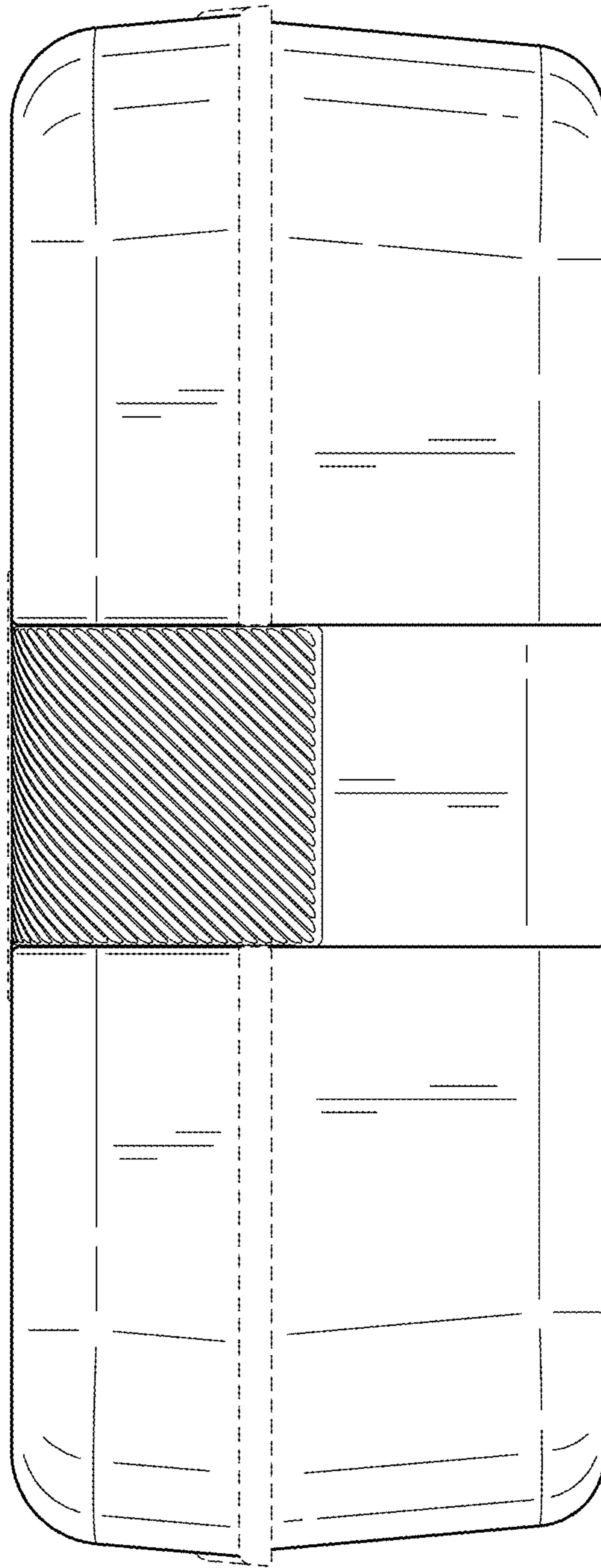

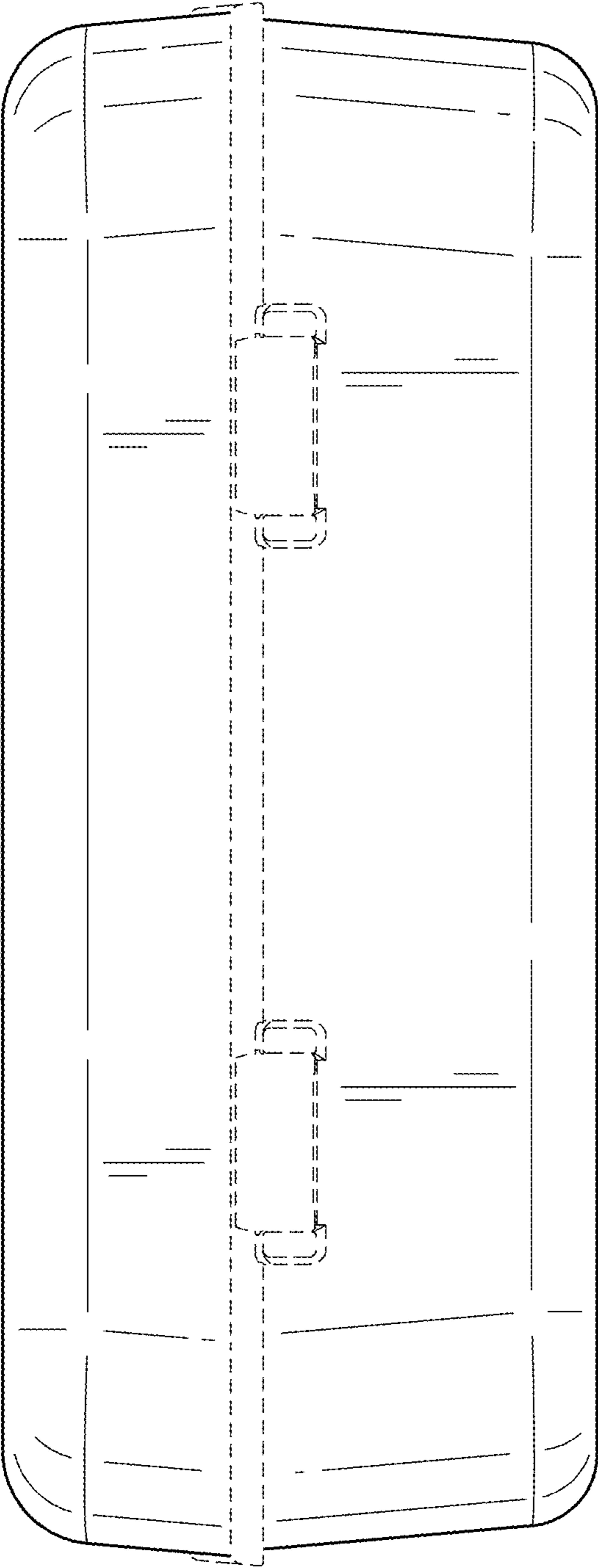

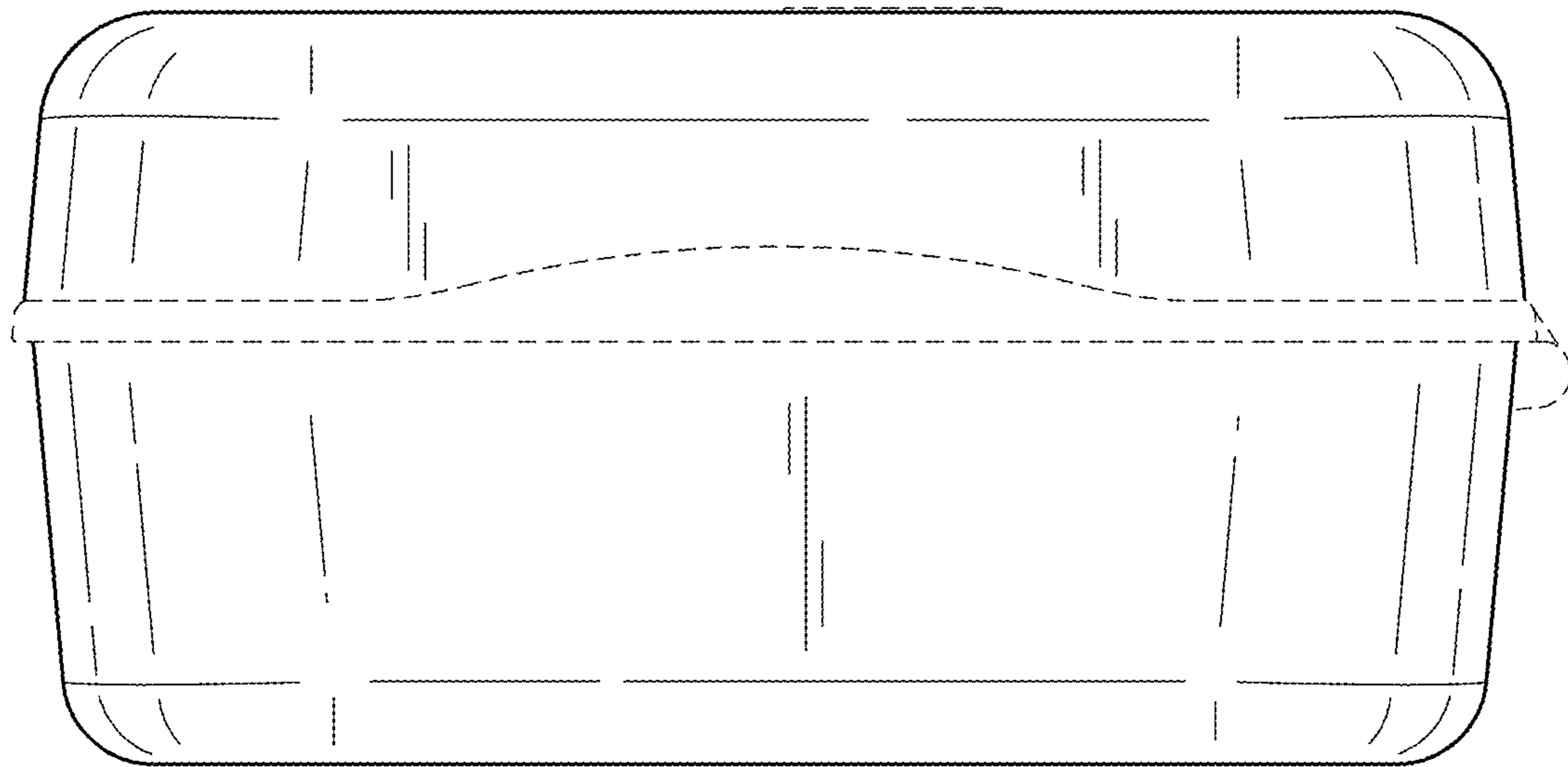

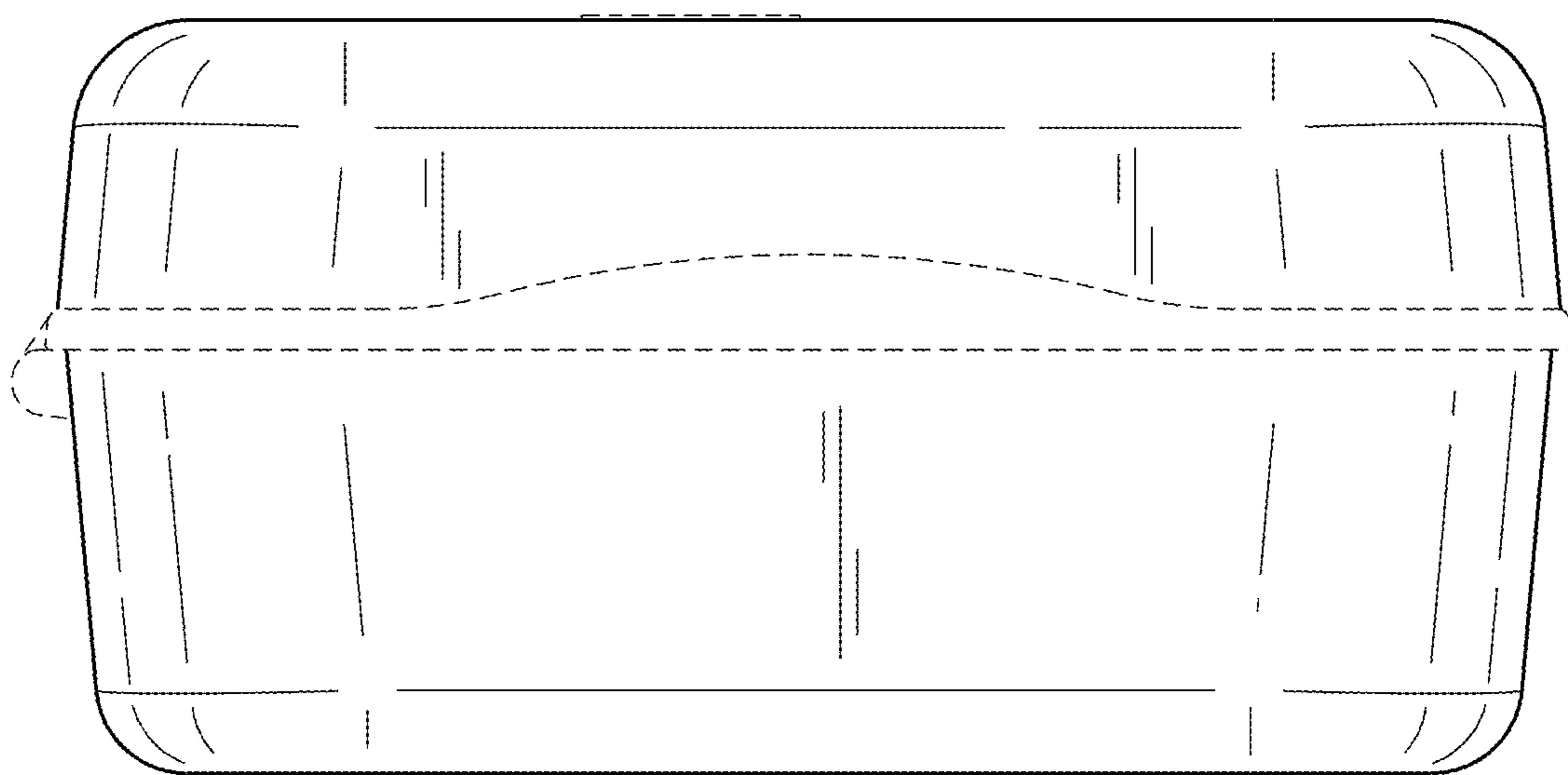

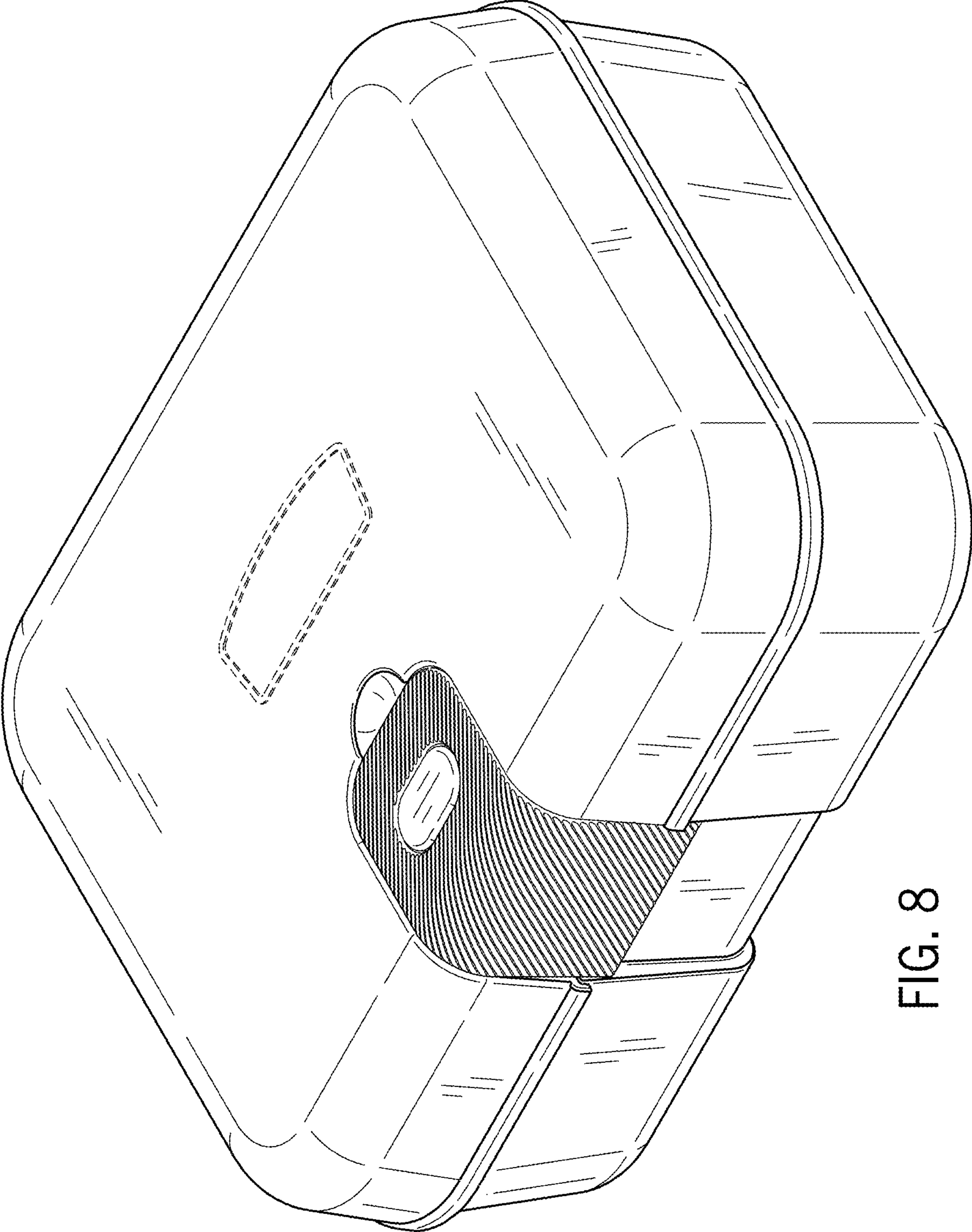

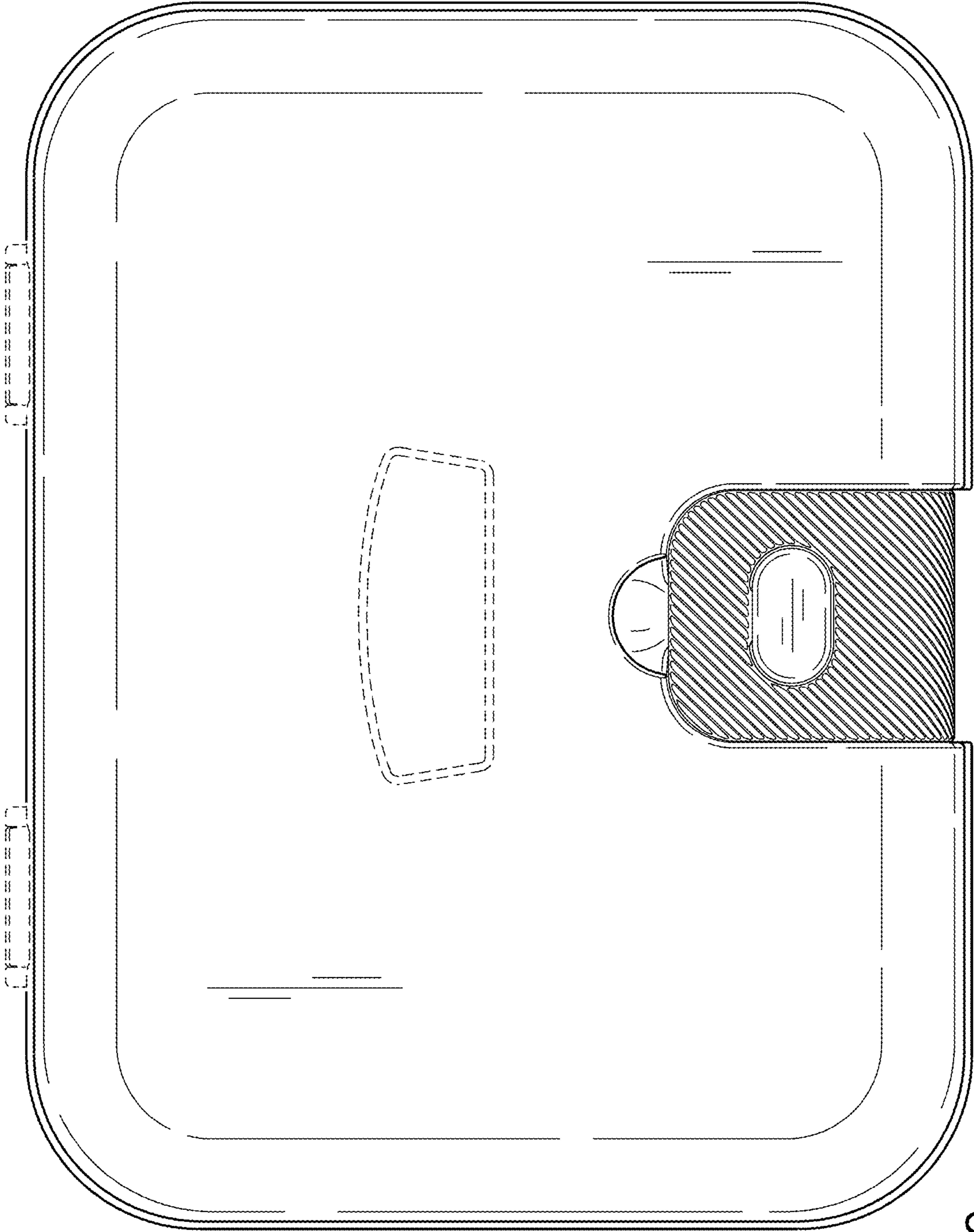

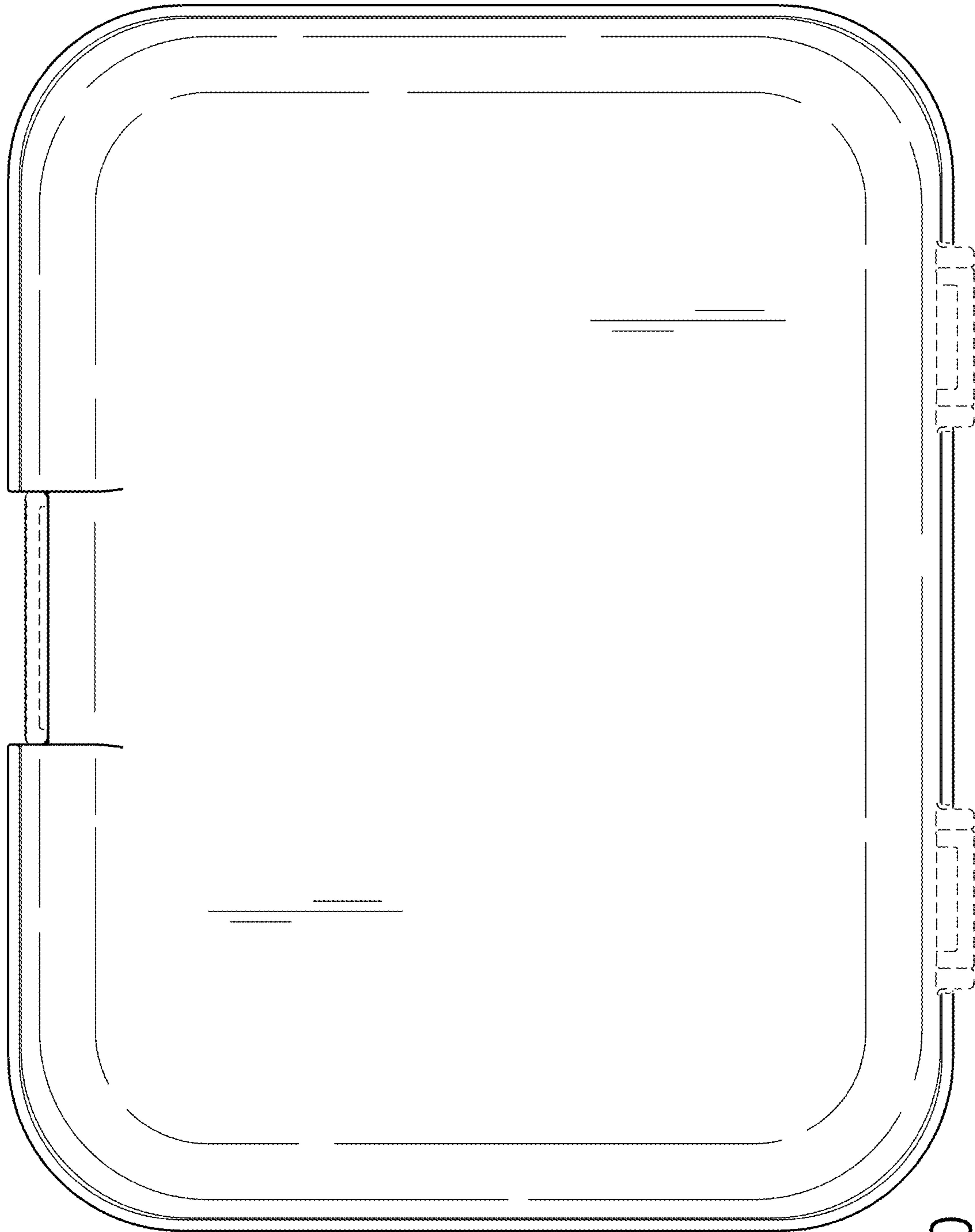

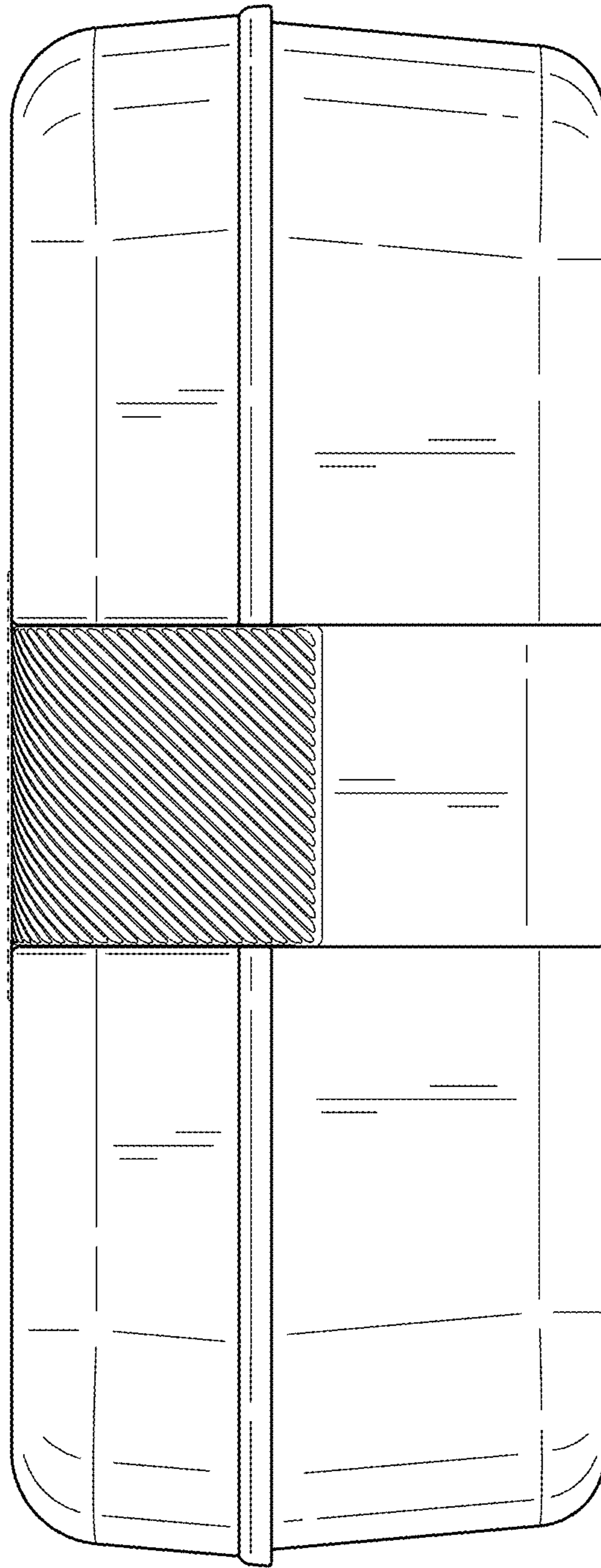

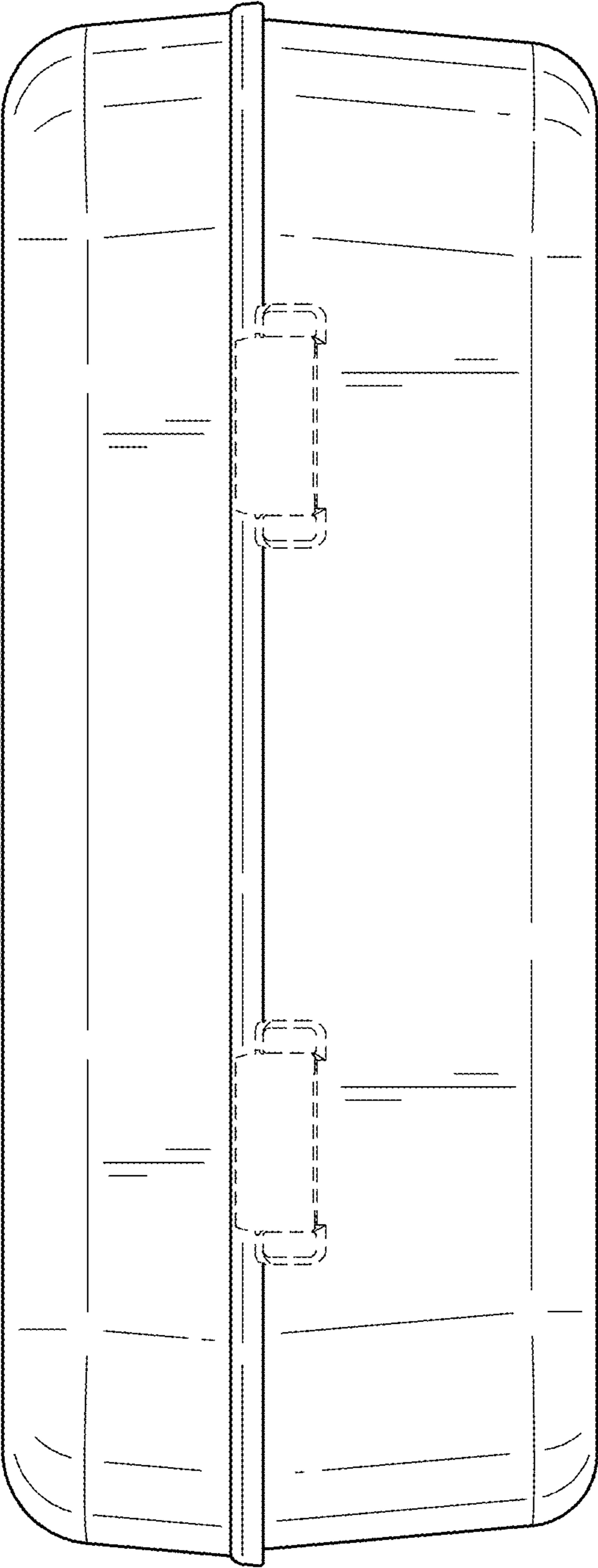

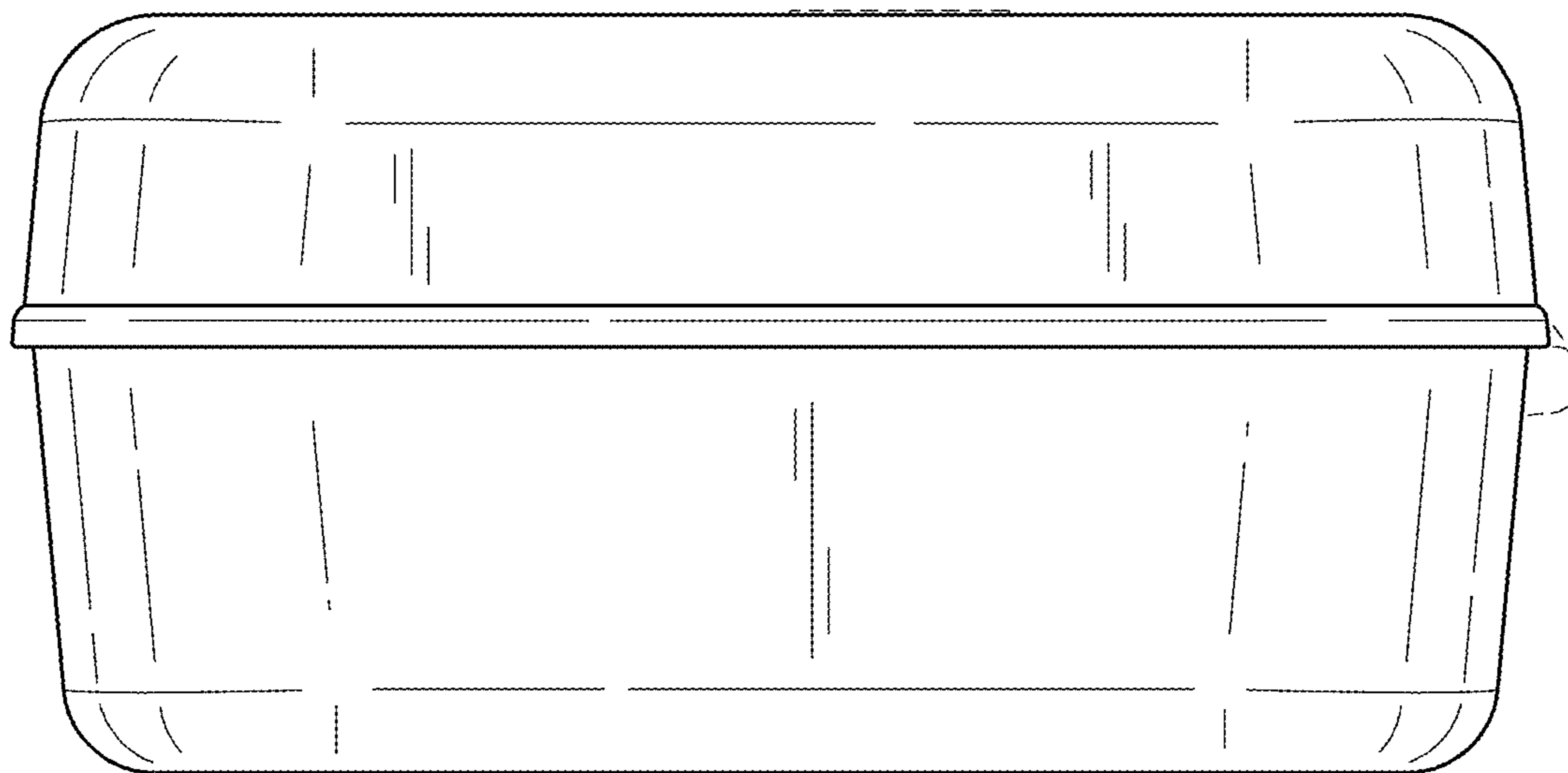

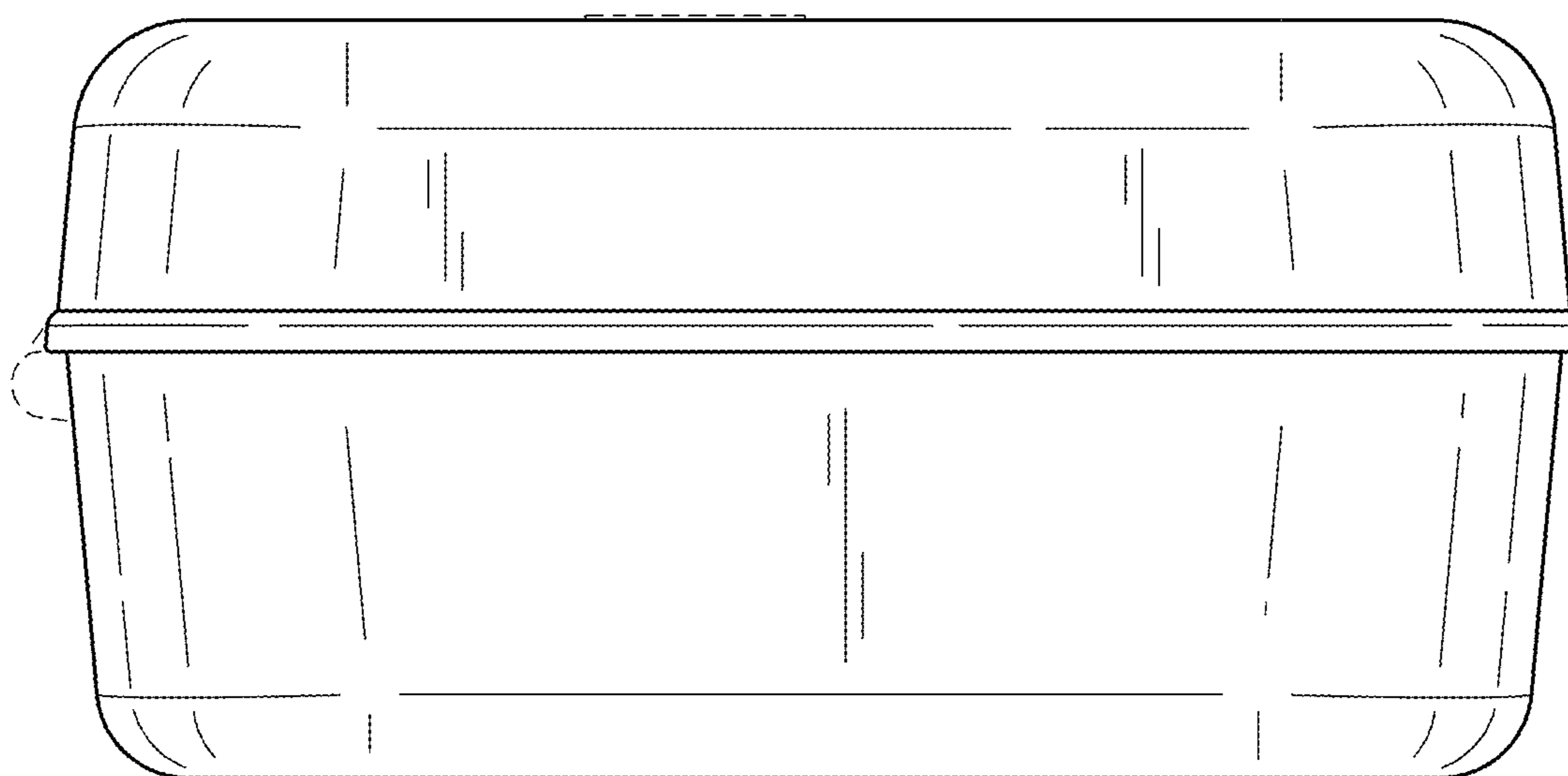
