(57) **CLAIM**

The ornamental design for a handle hanger, as shown and
described.

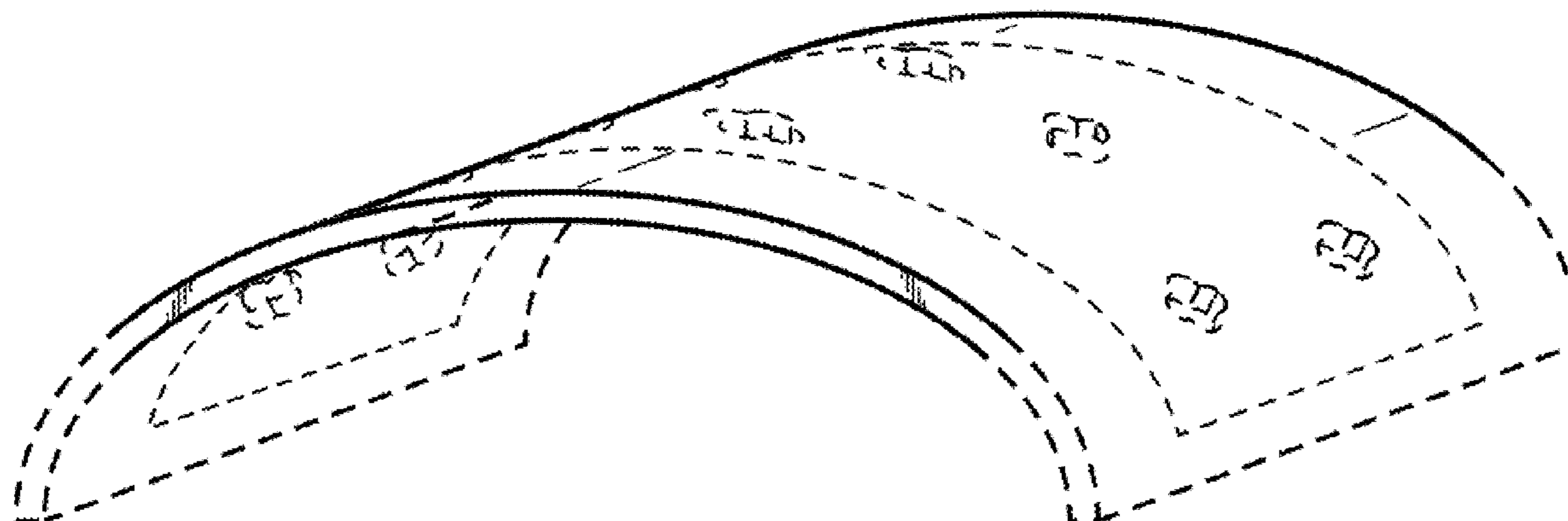

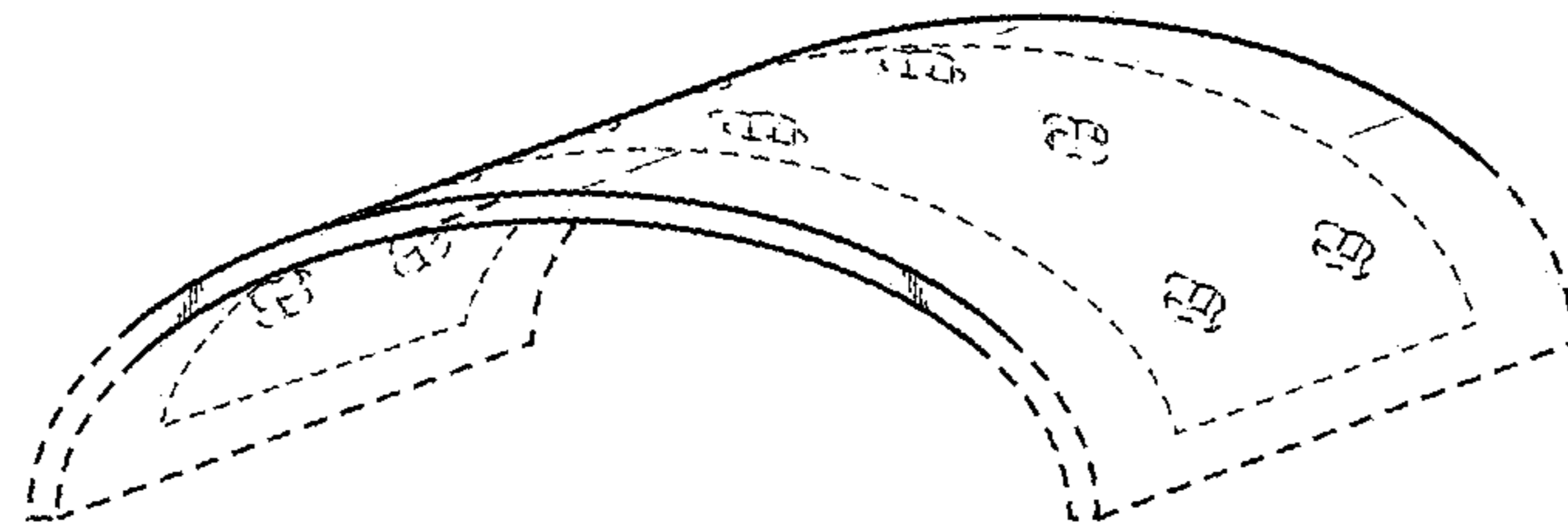

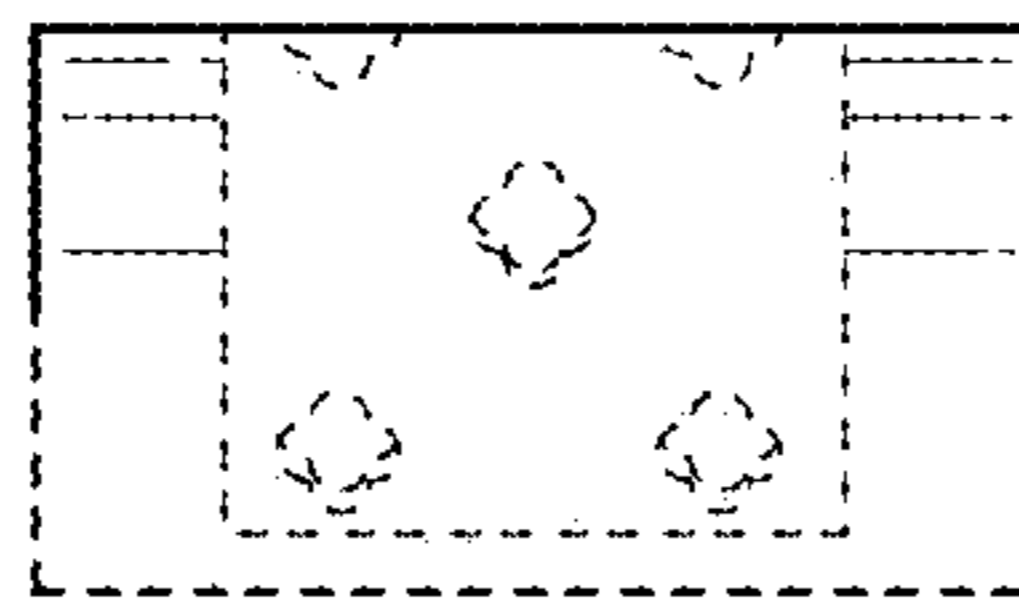

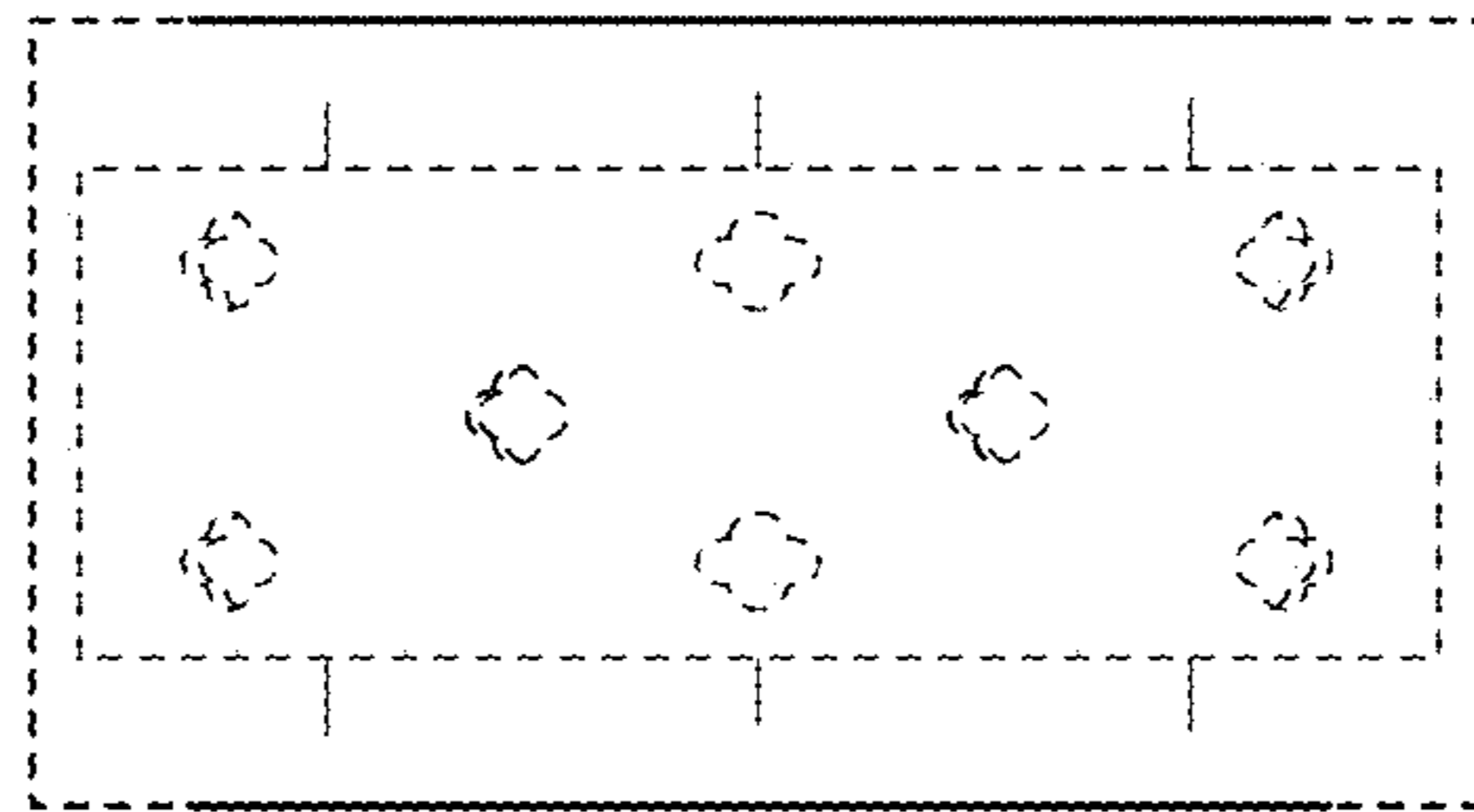

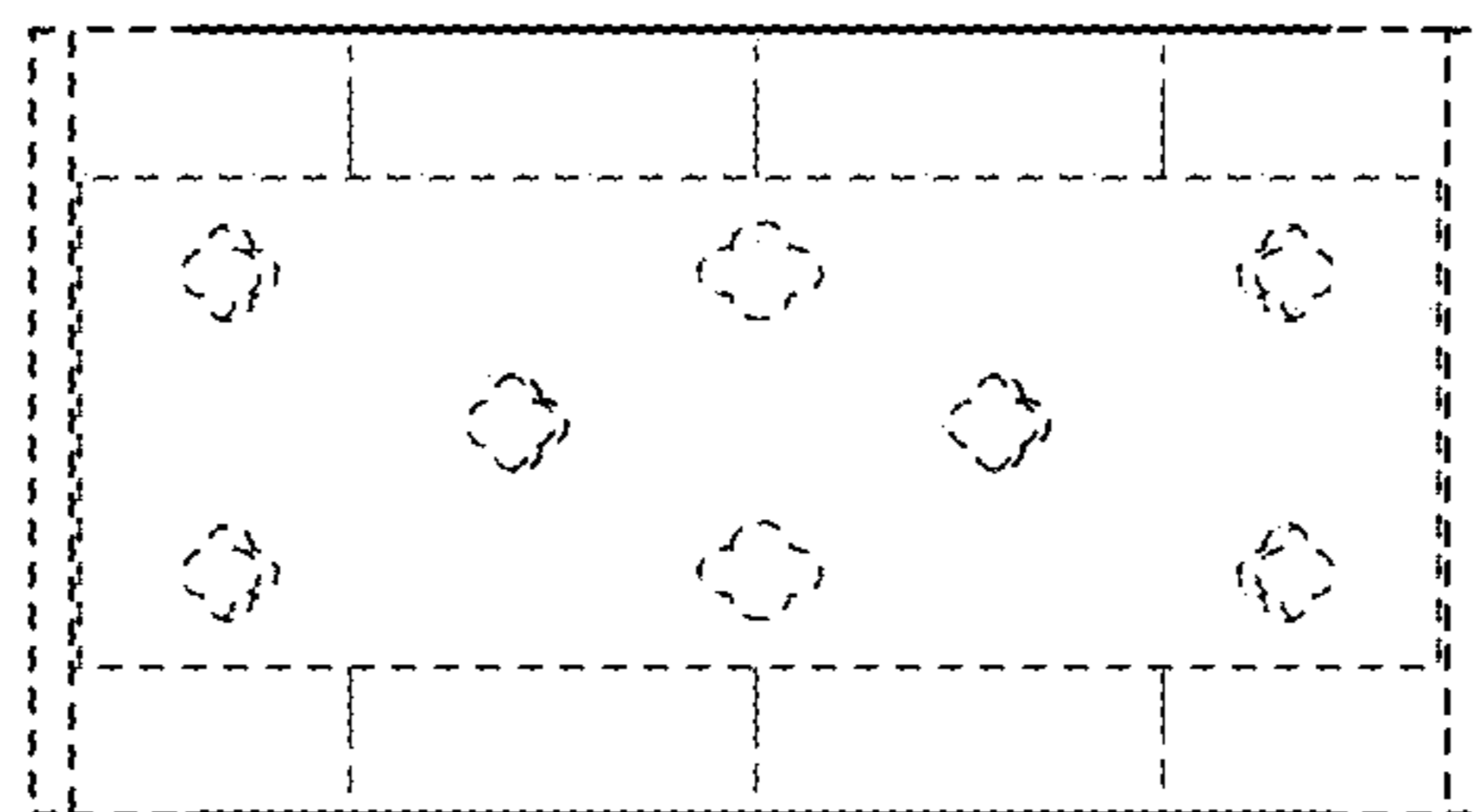

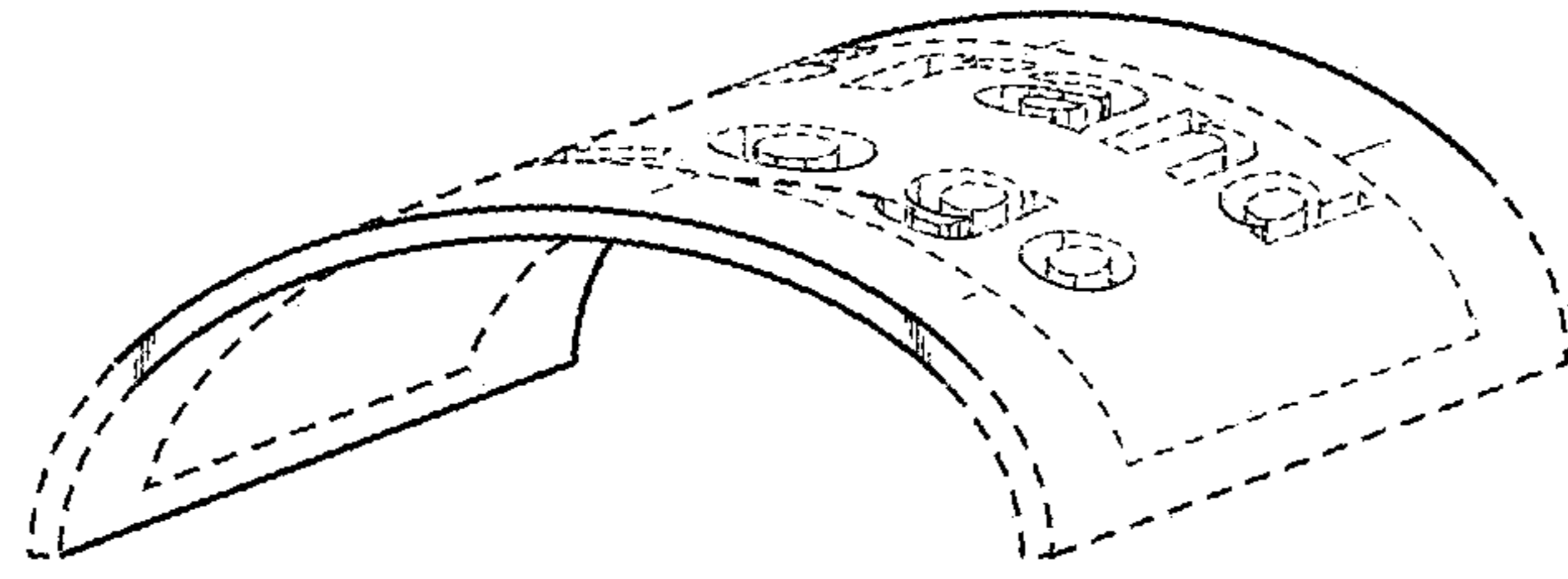

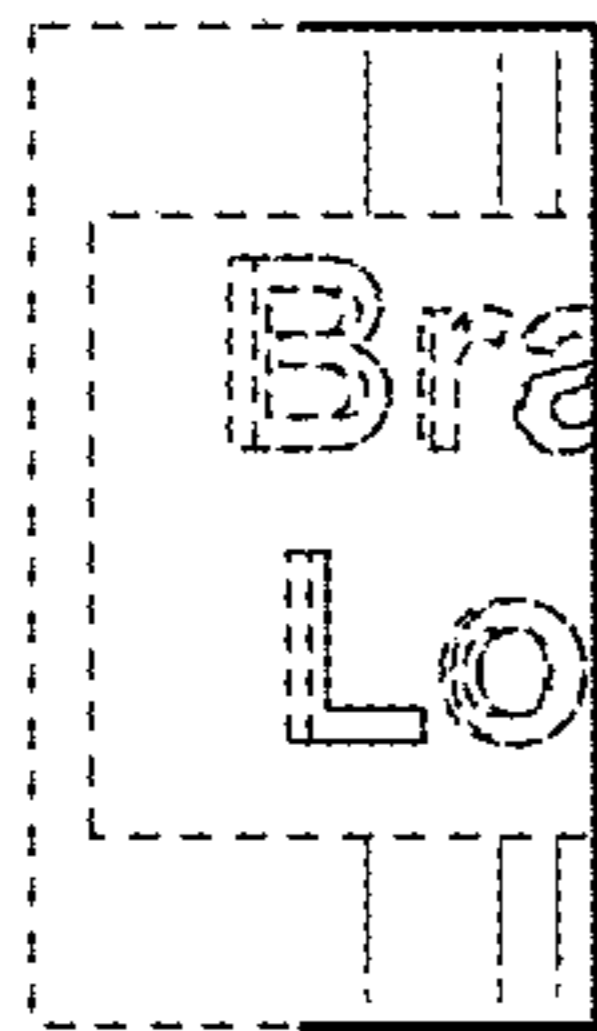

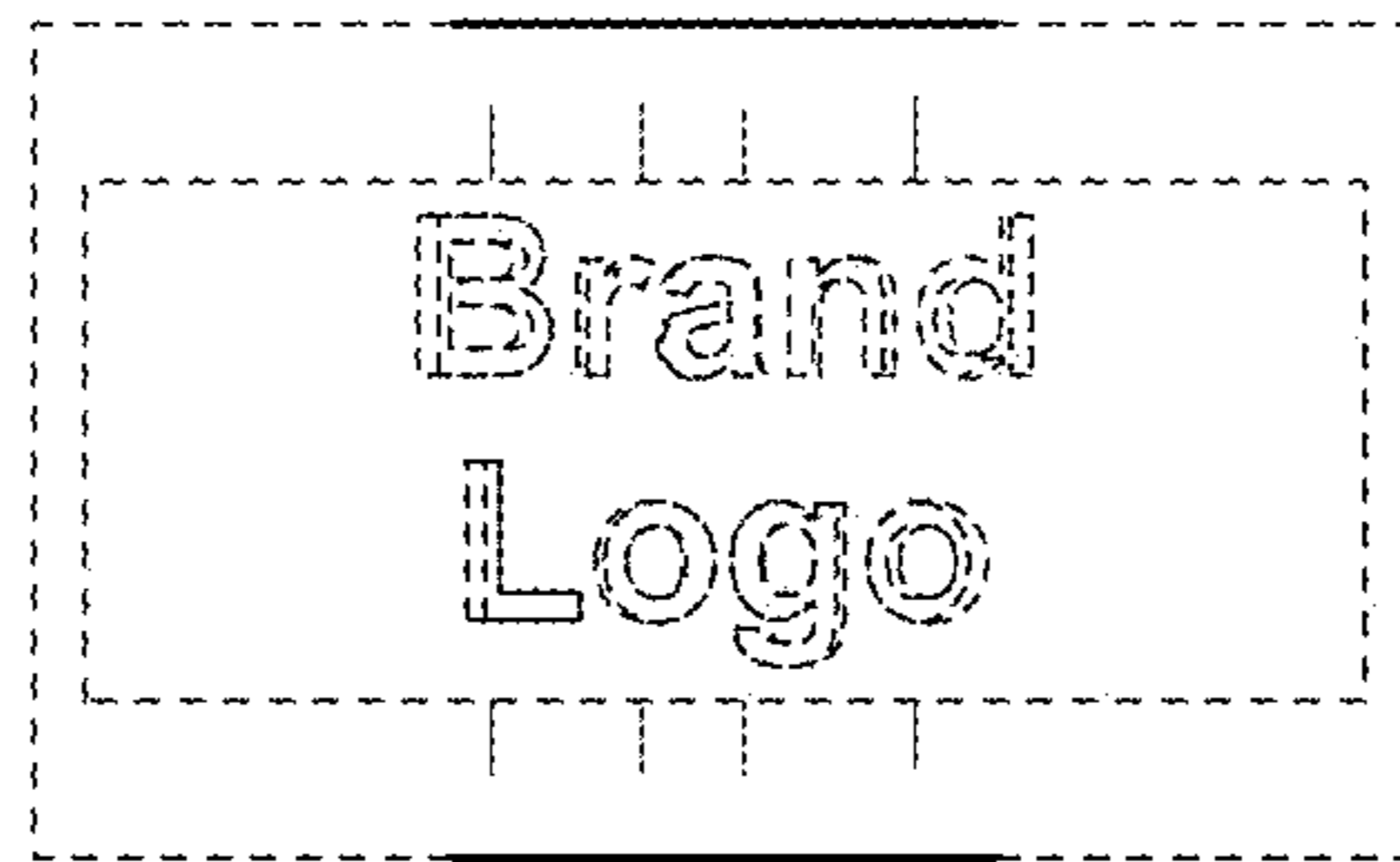

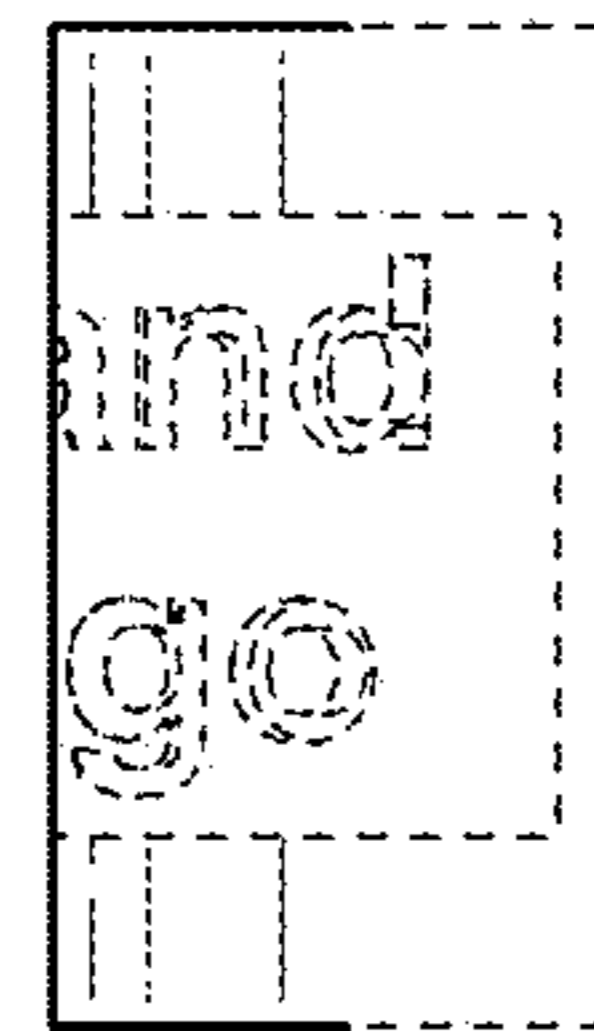

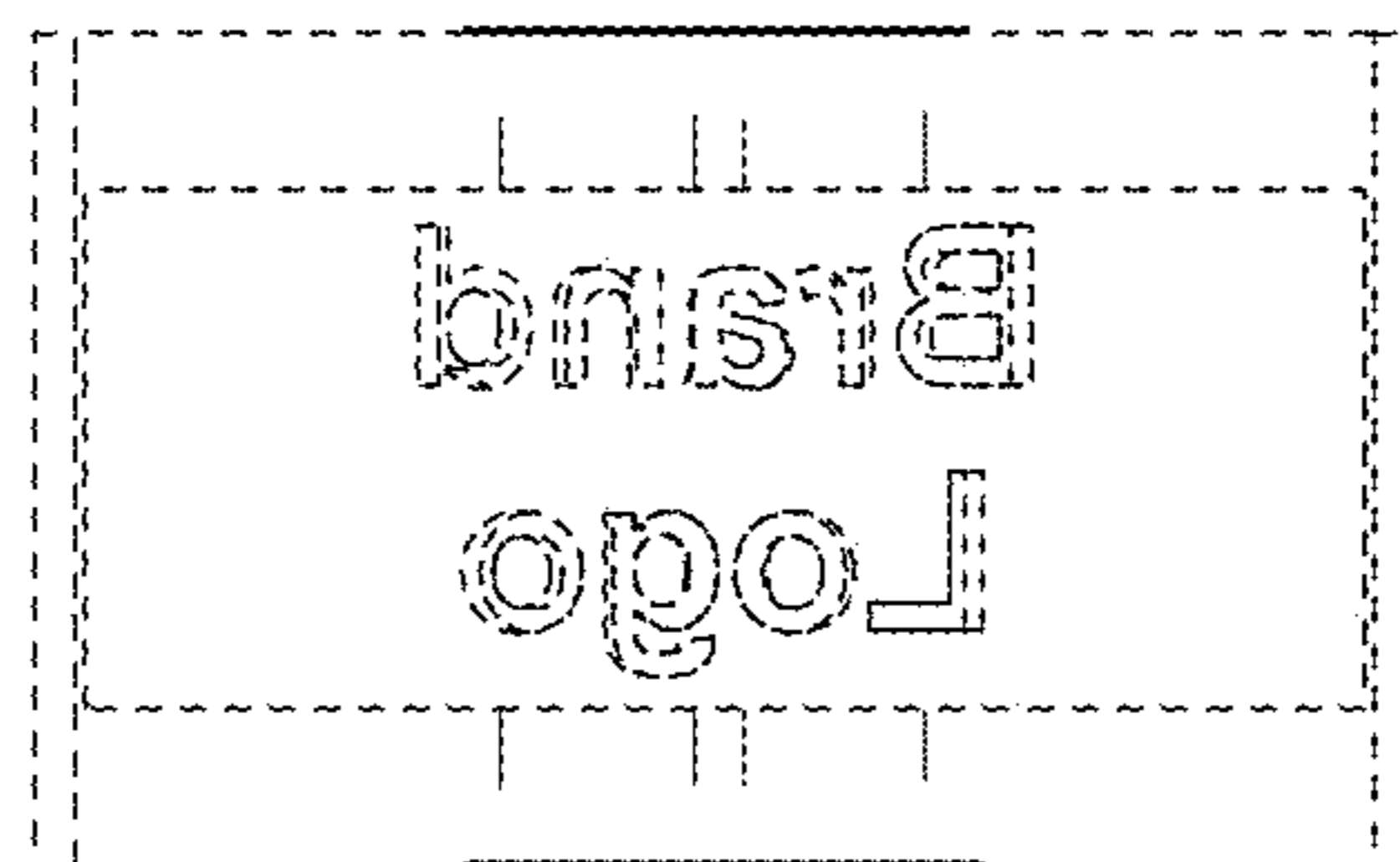

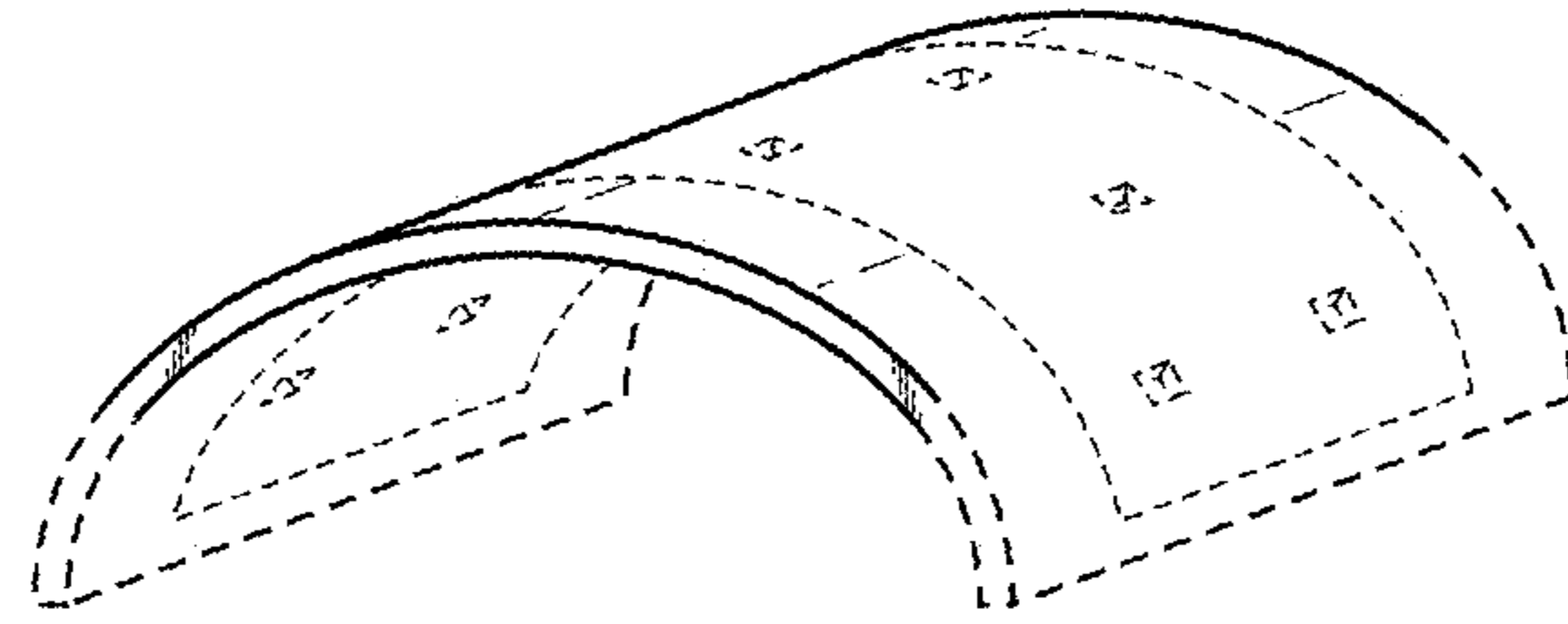

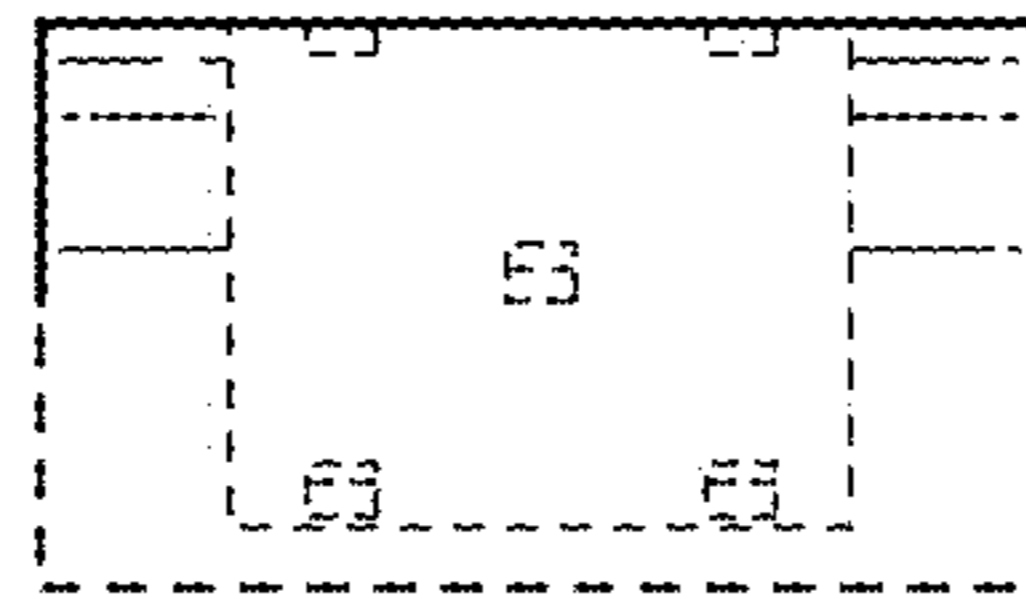

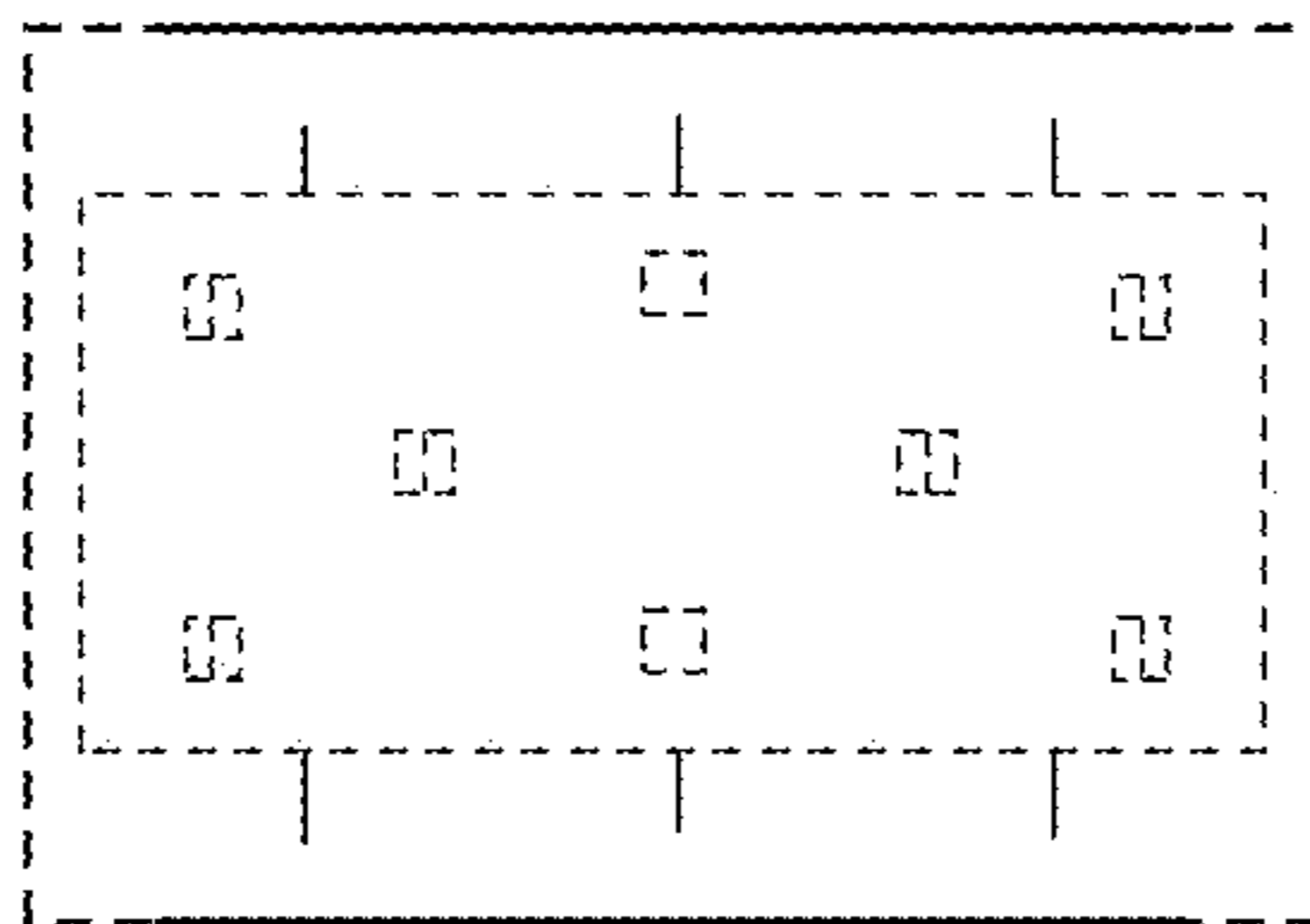

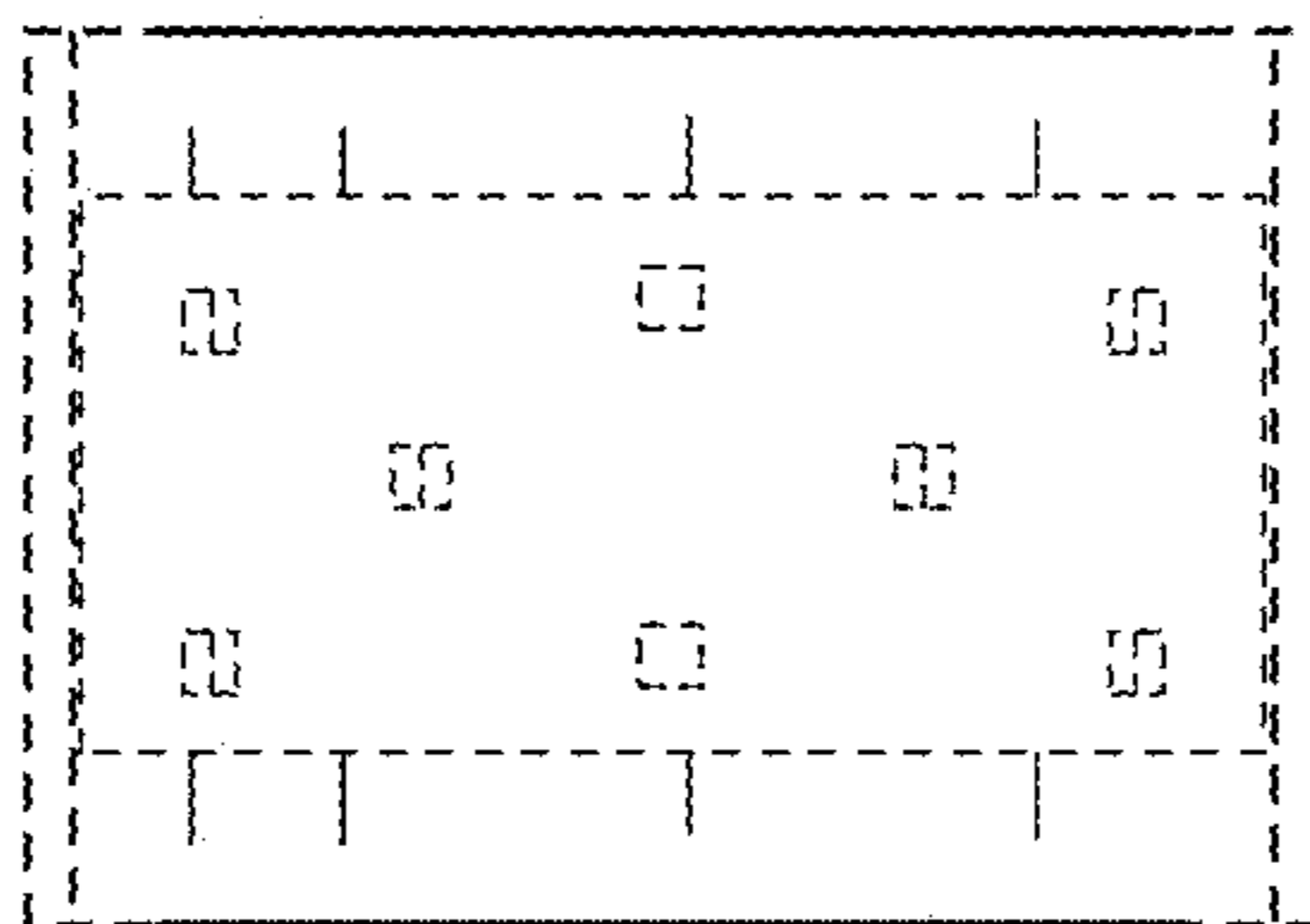

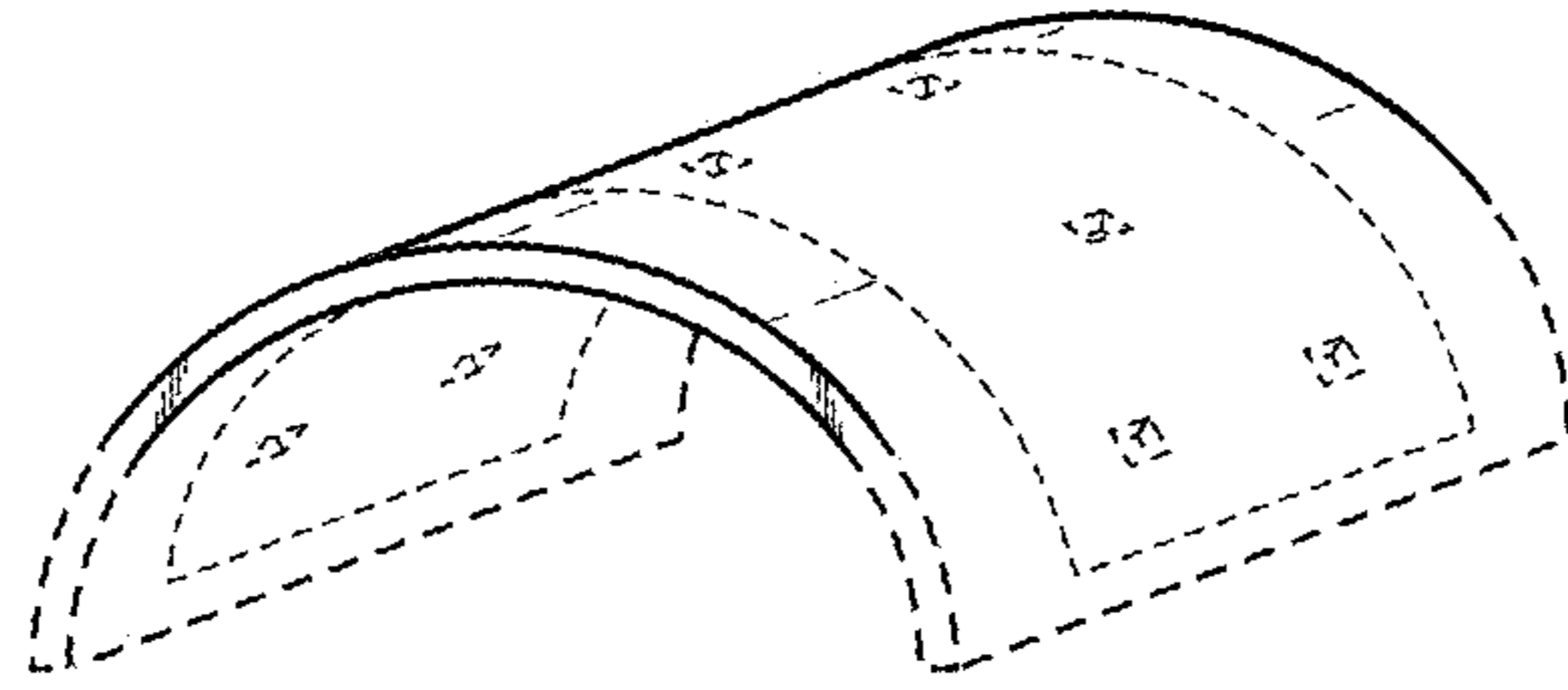

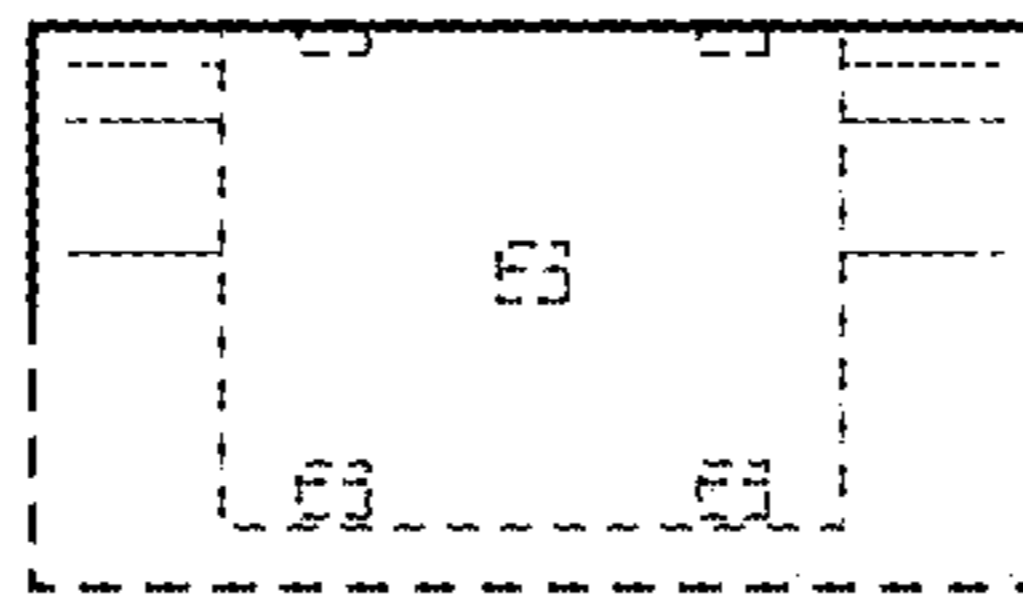

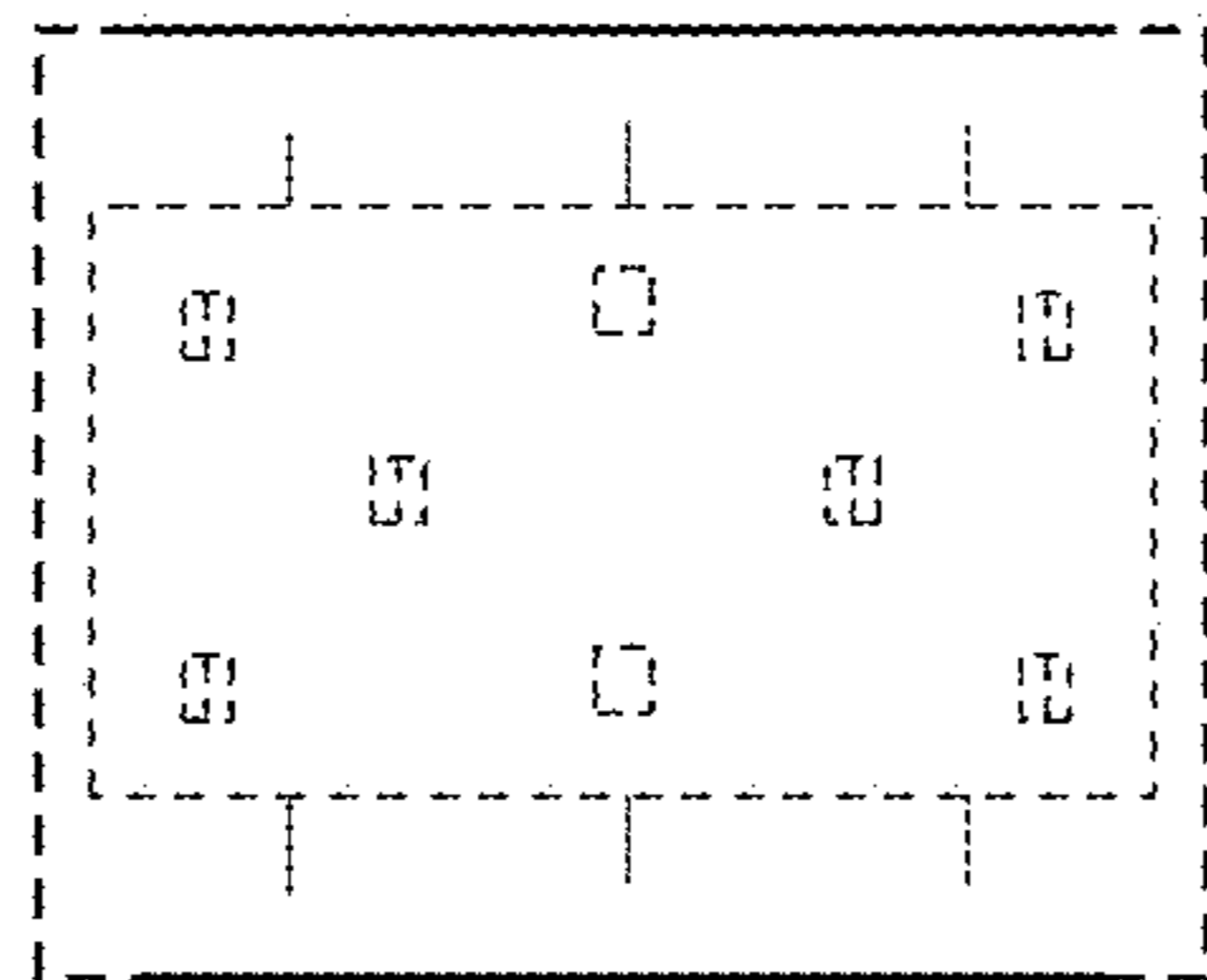

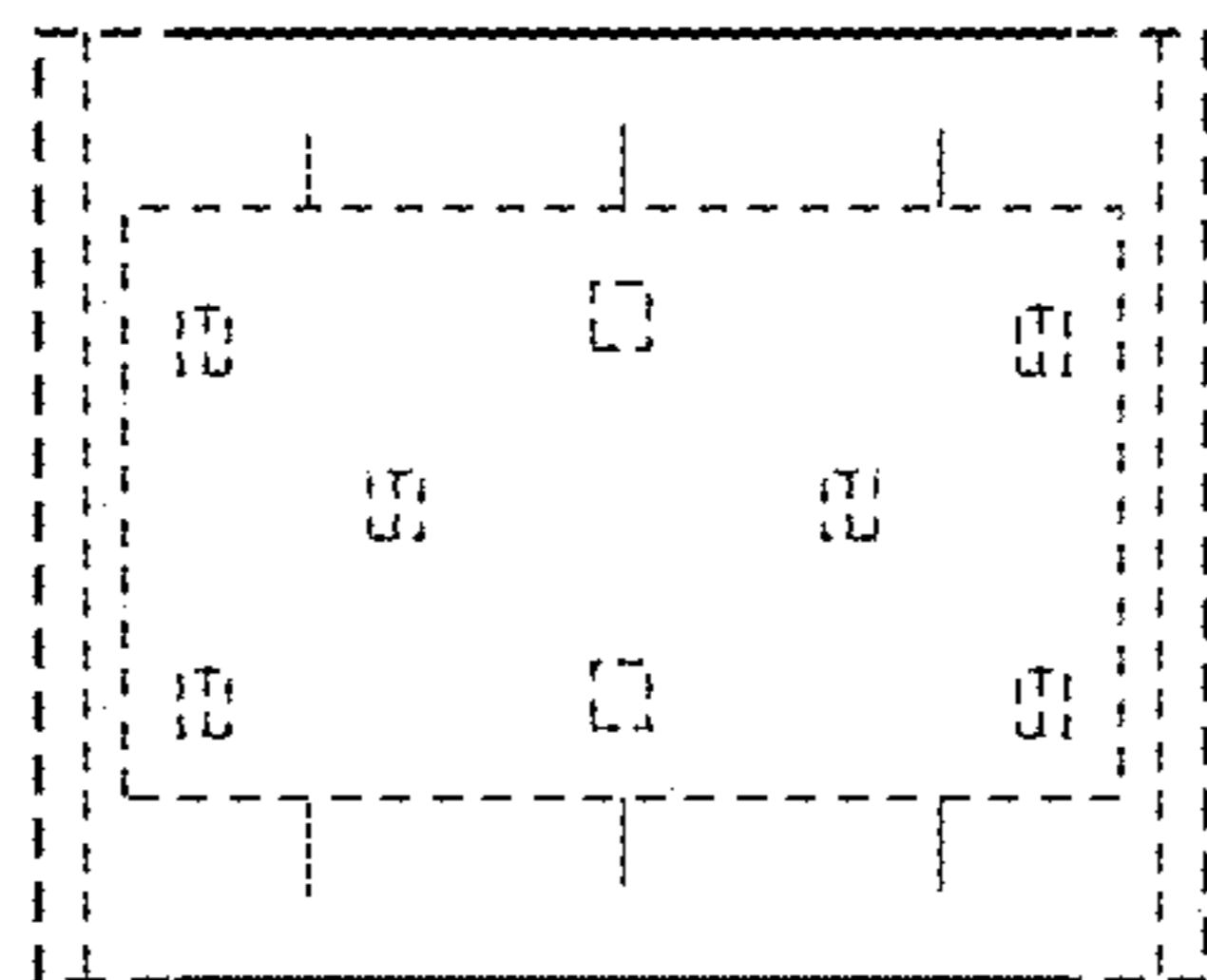

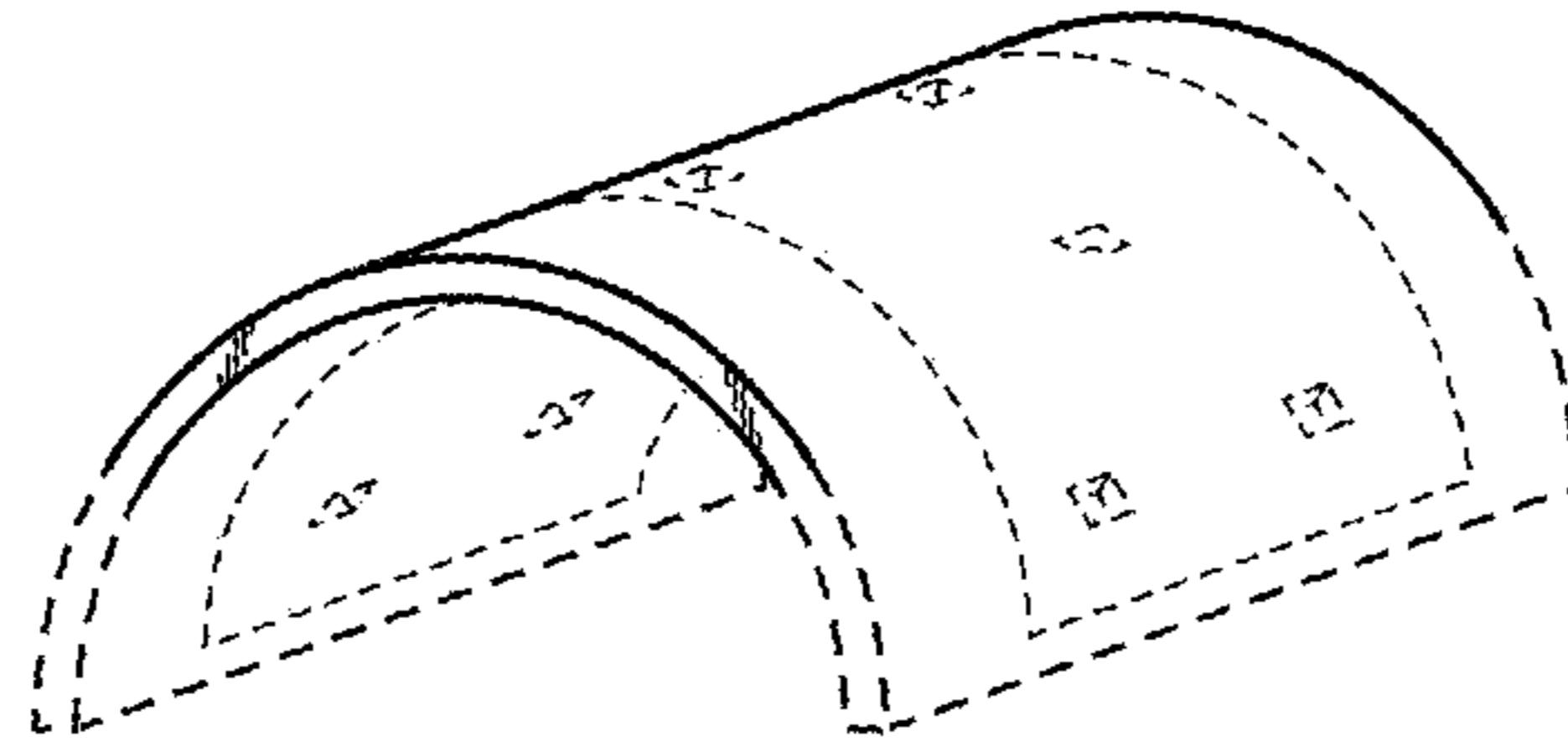

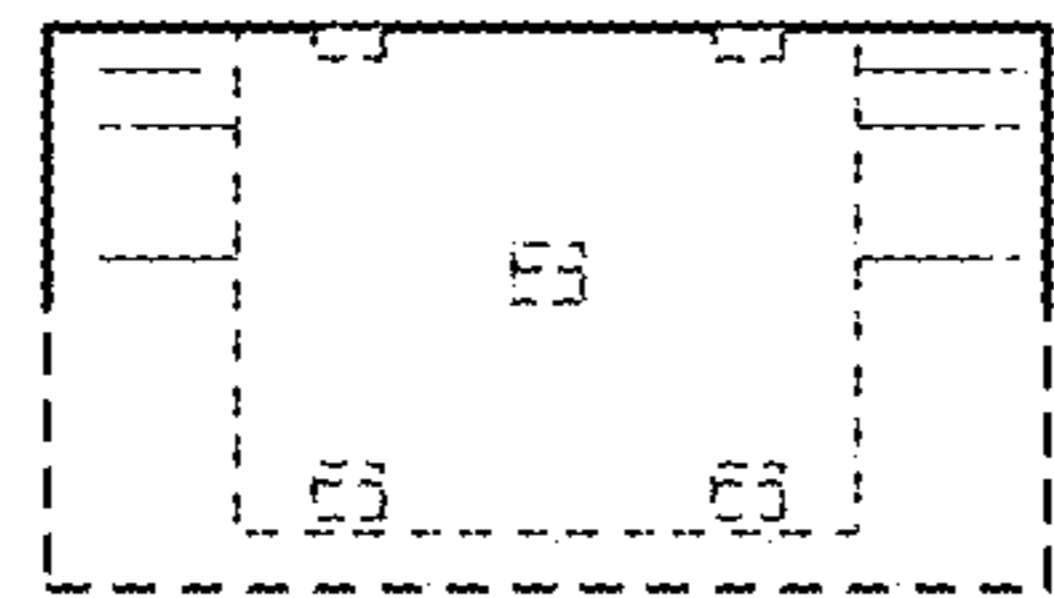

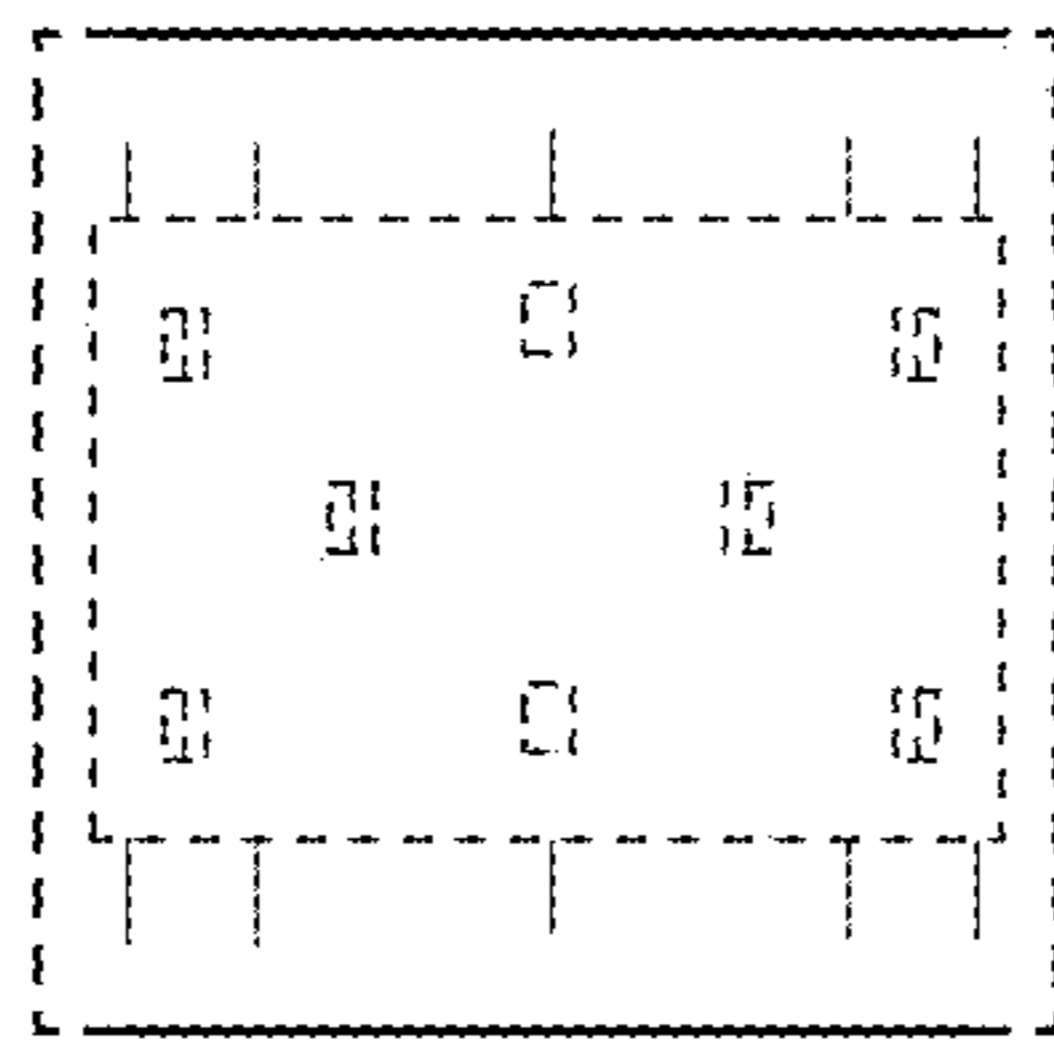

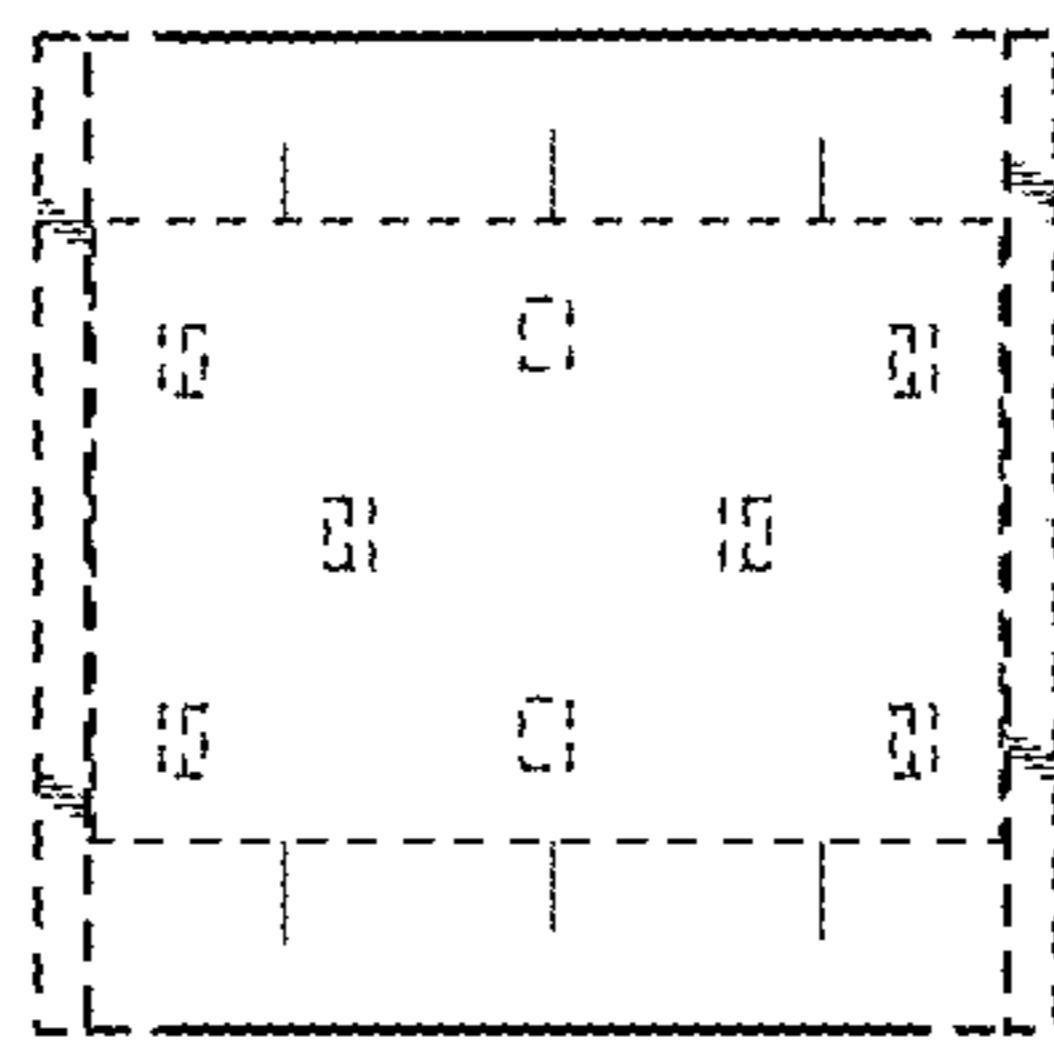

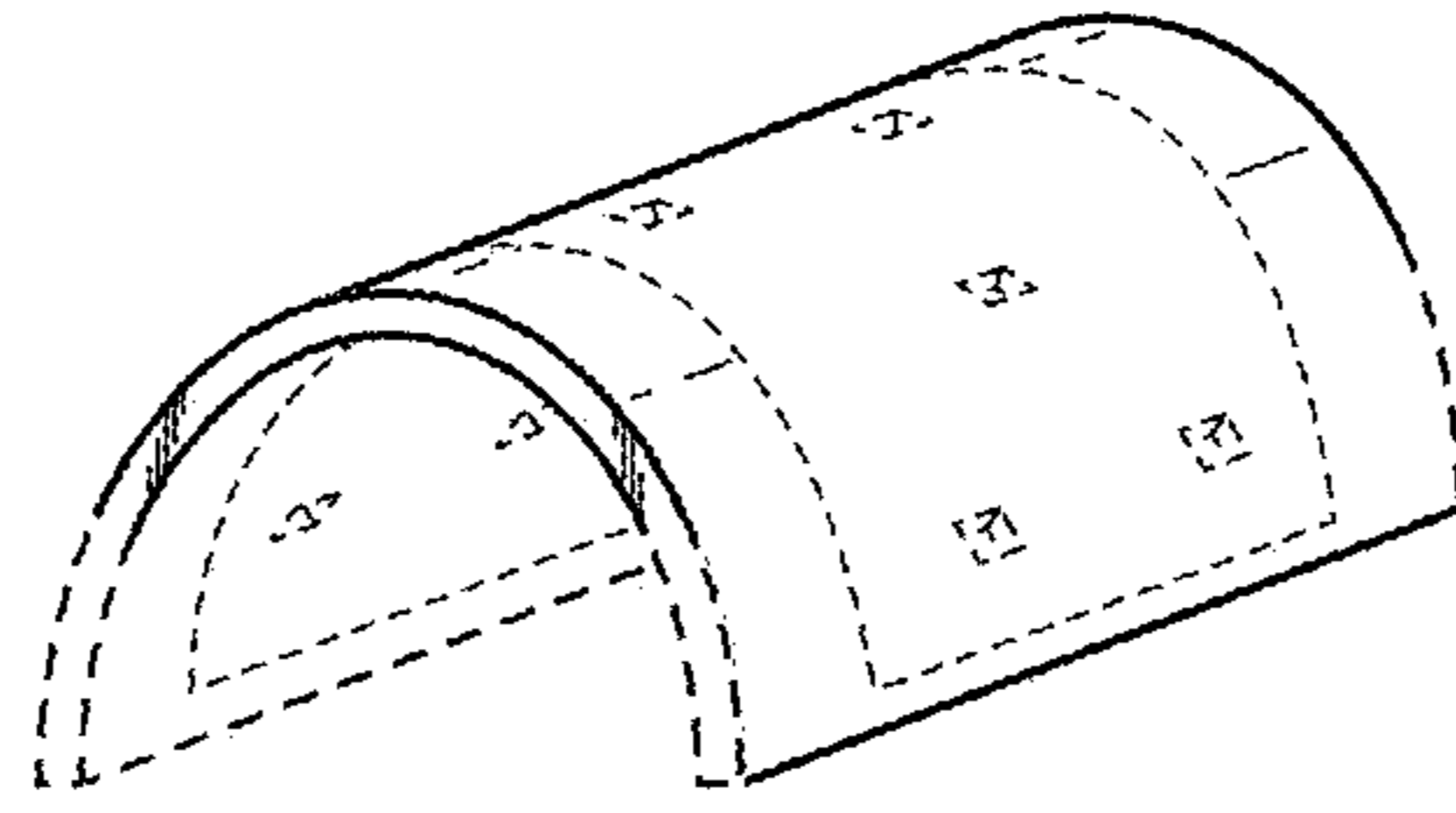

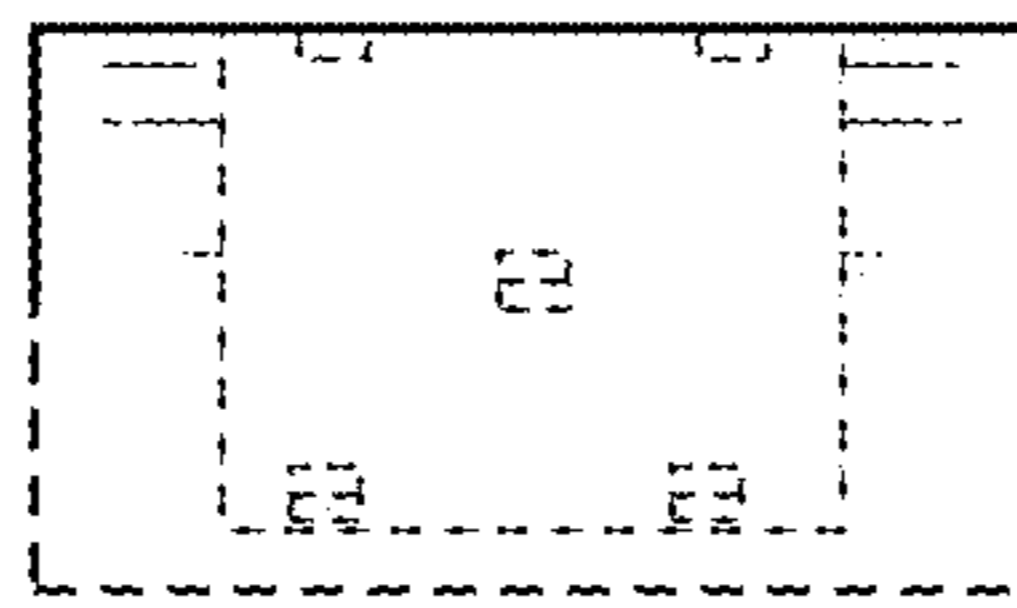

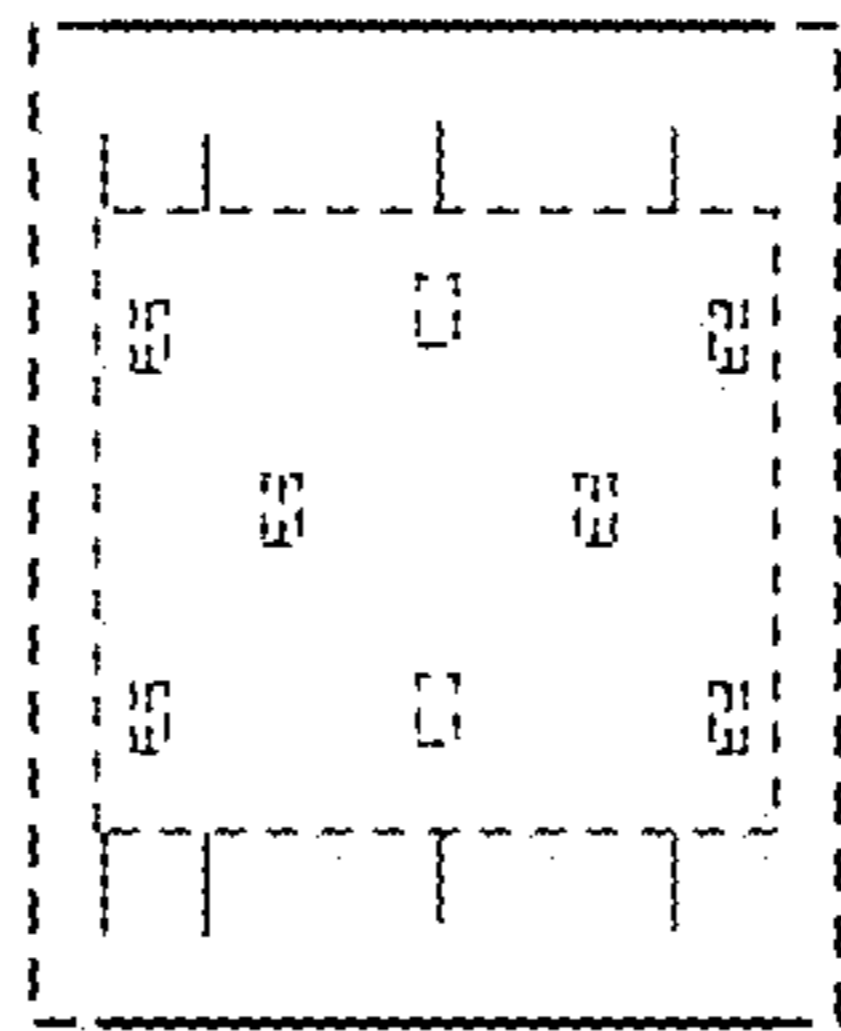

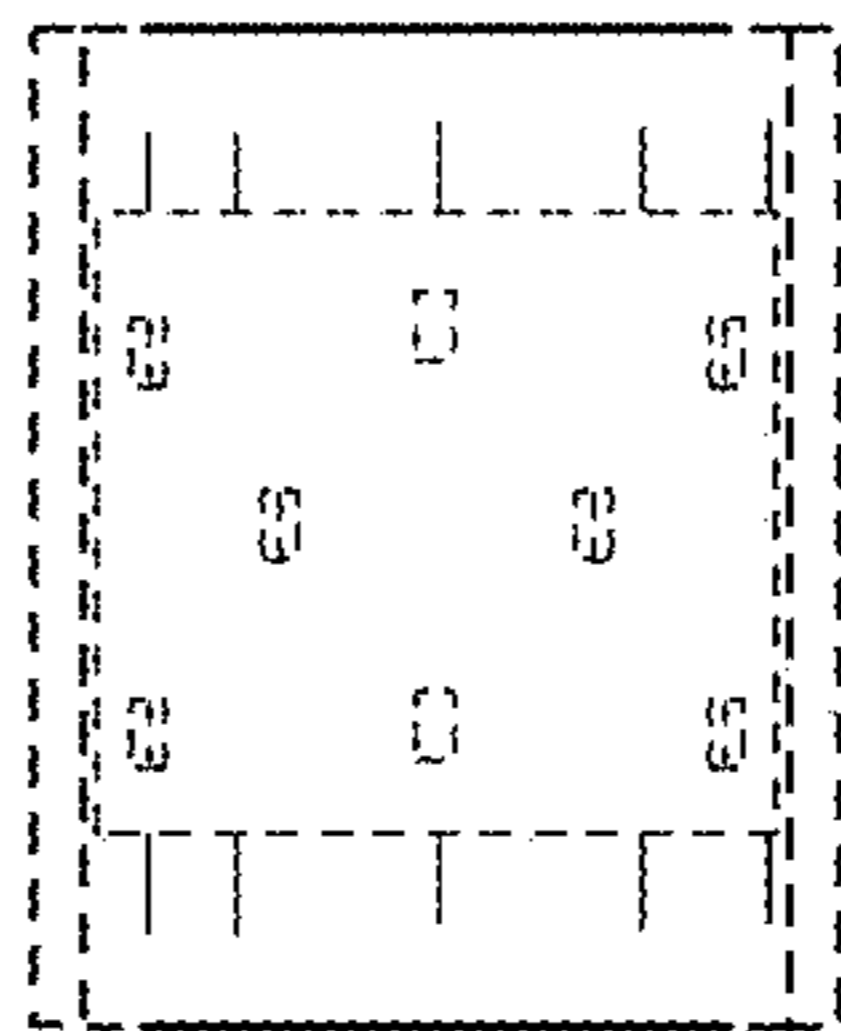

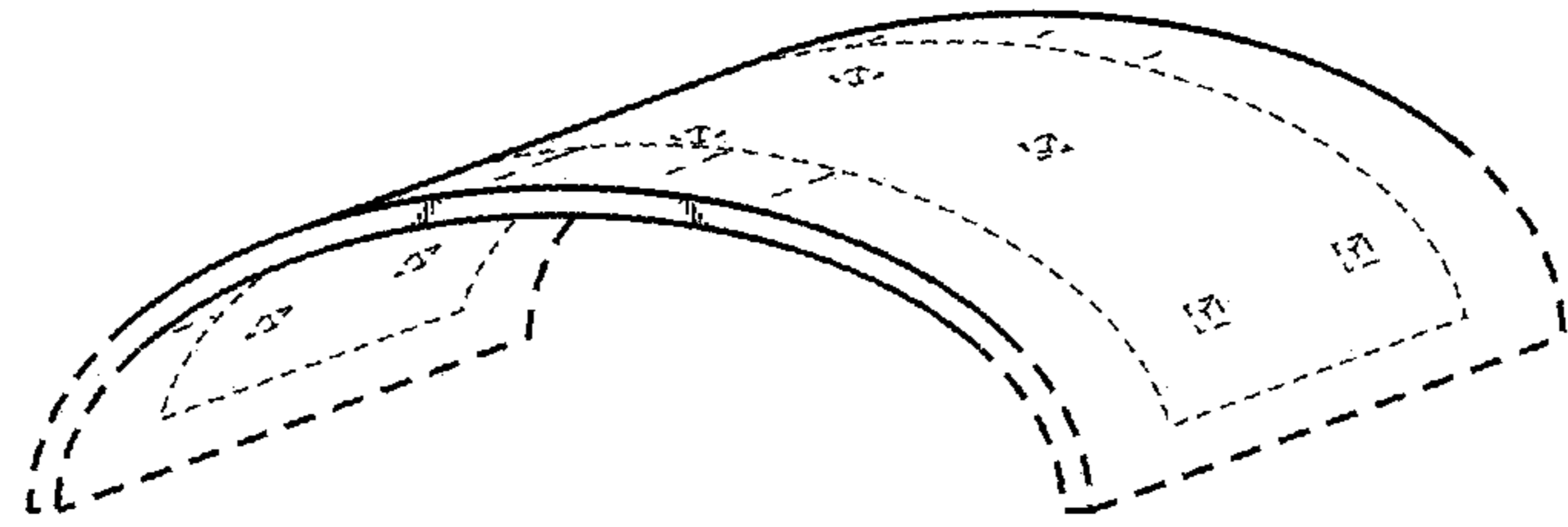

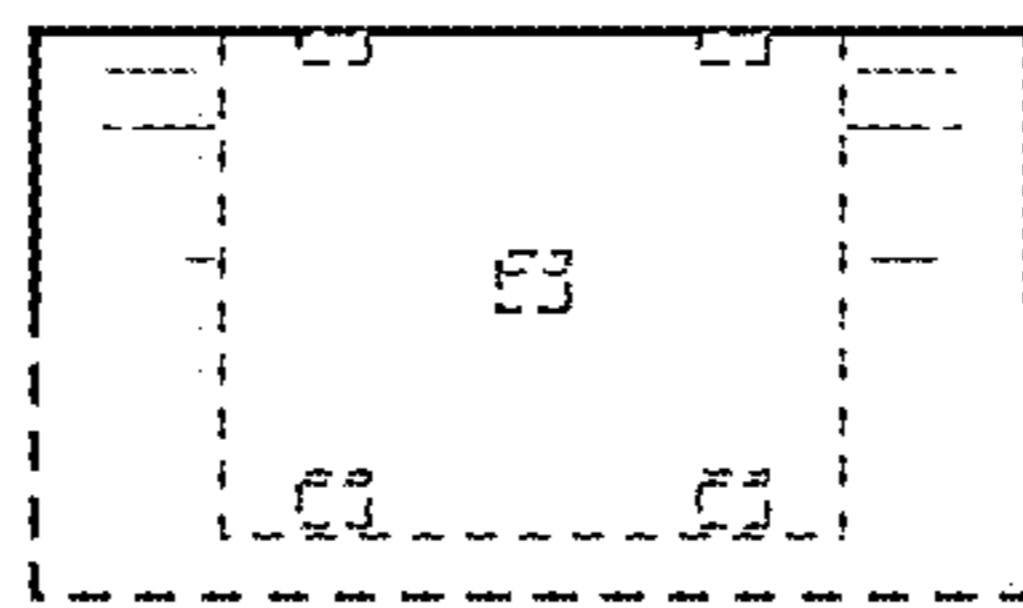

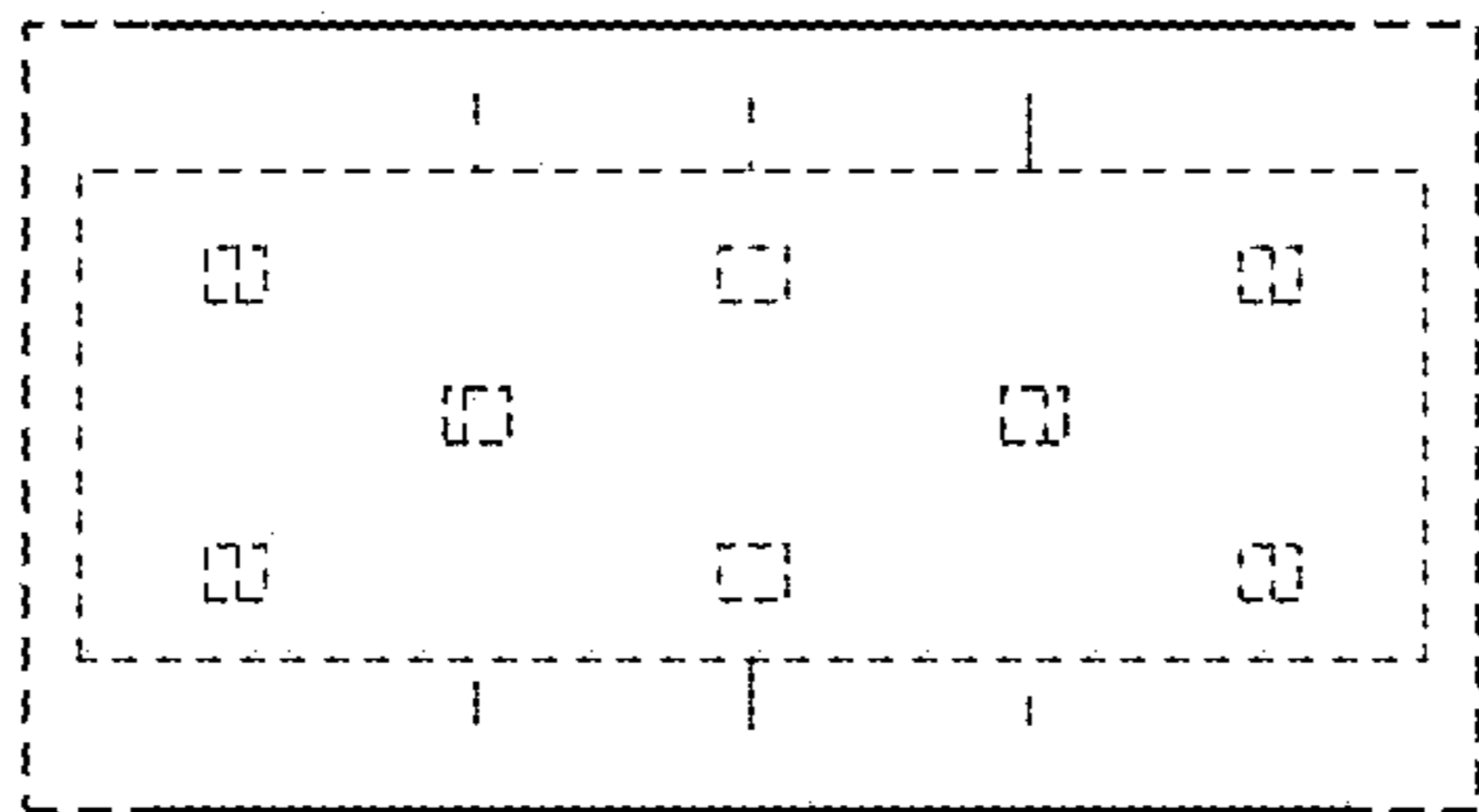

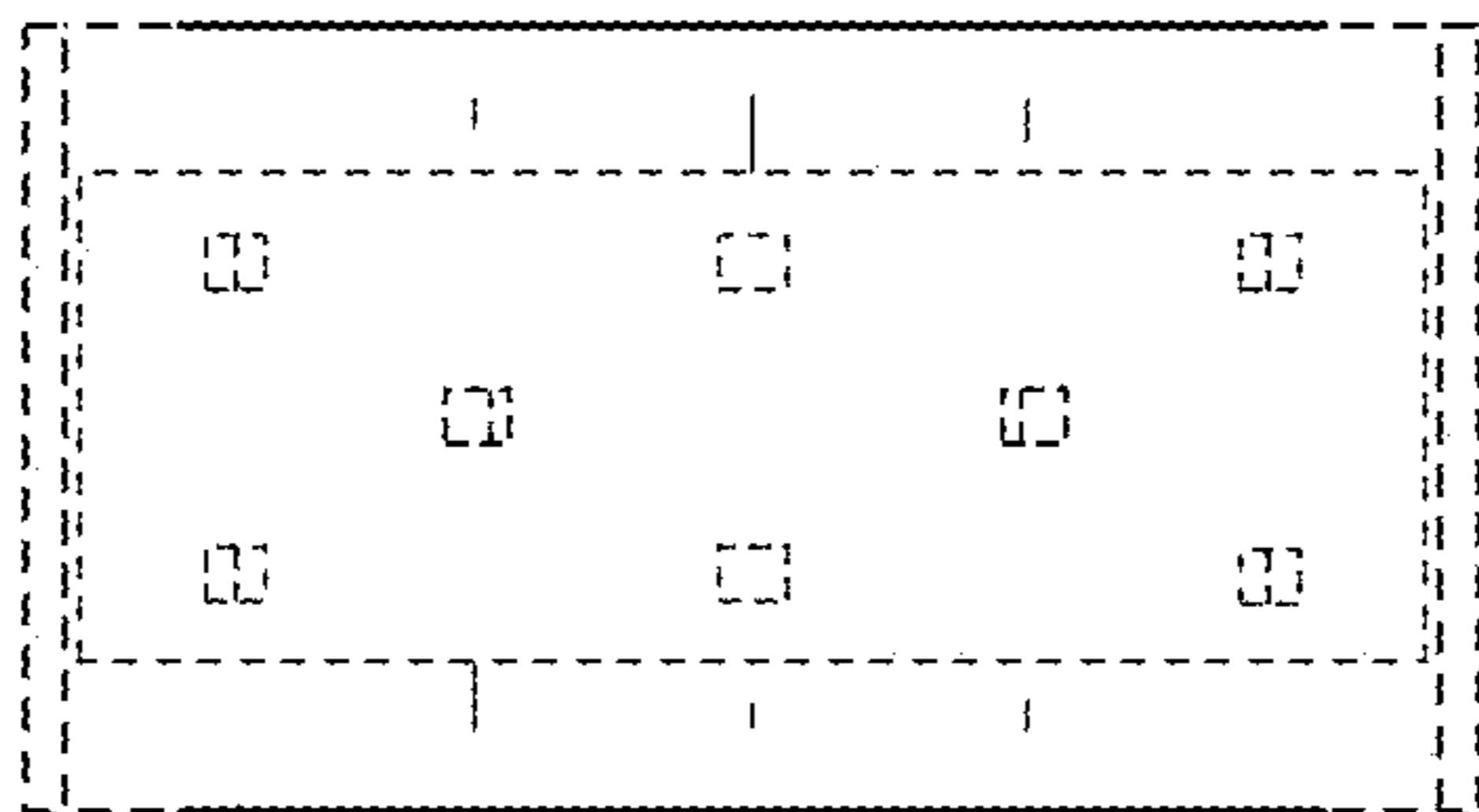
