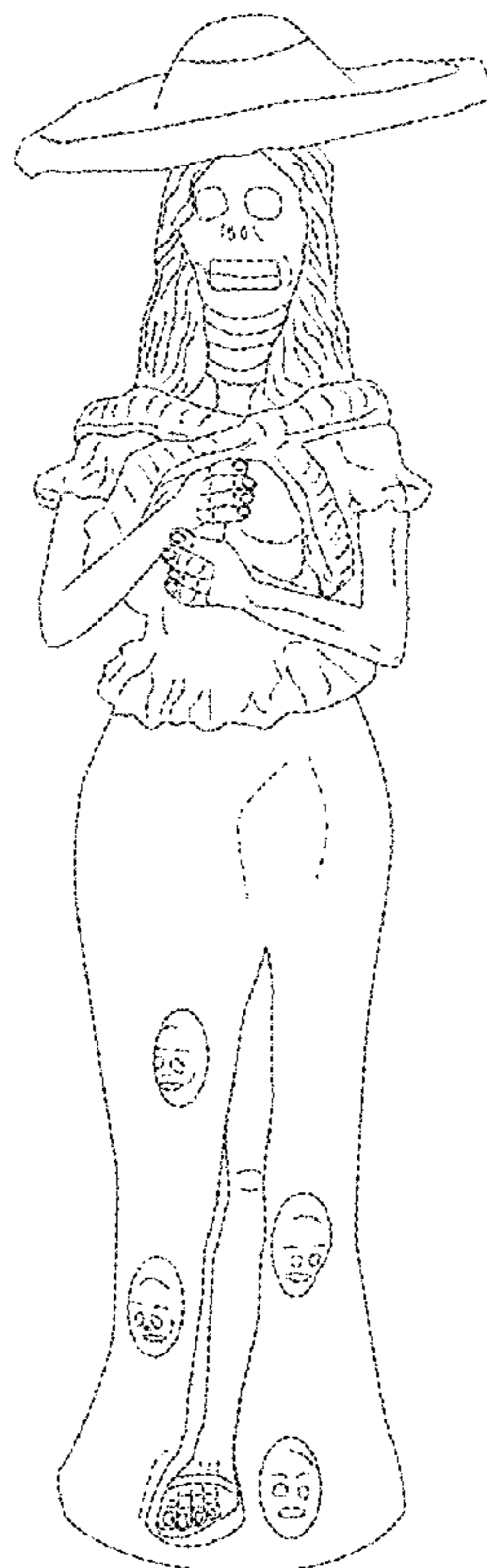
(57) **CLAIM**

We claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the bottle;

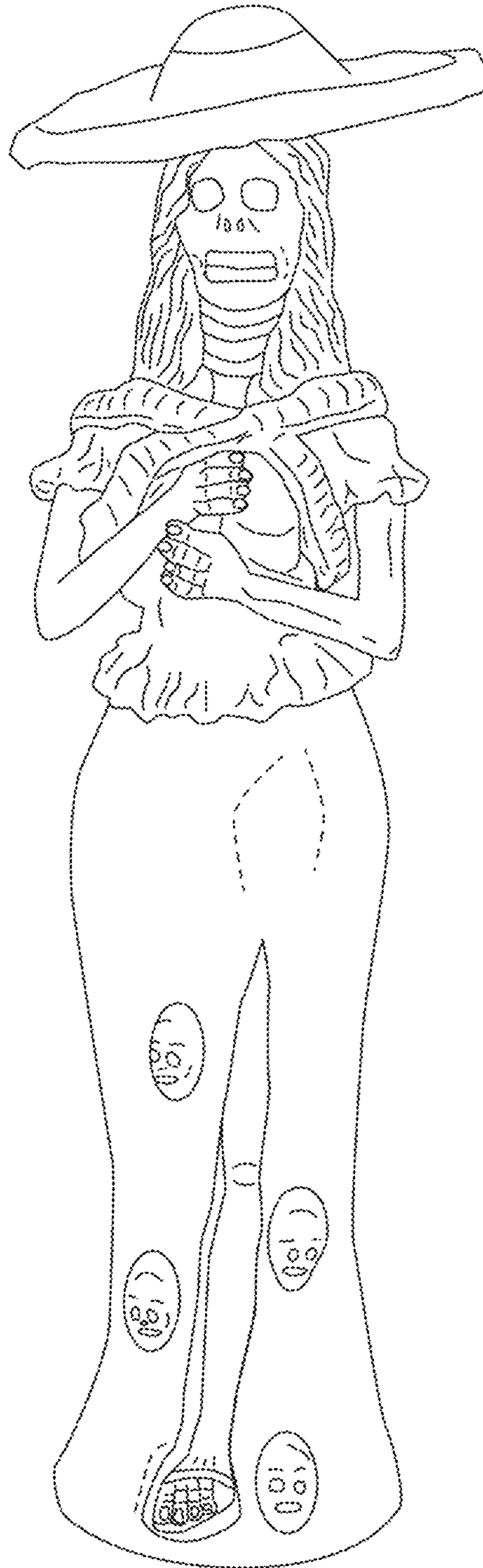

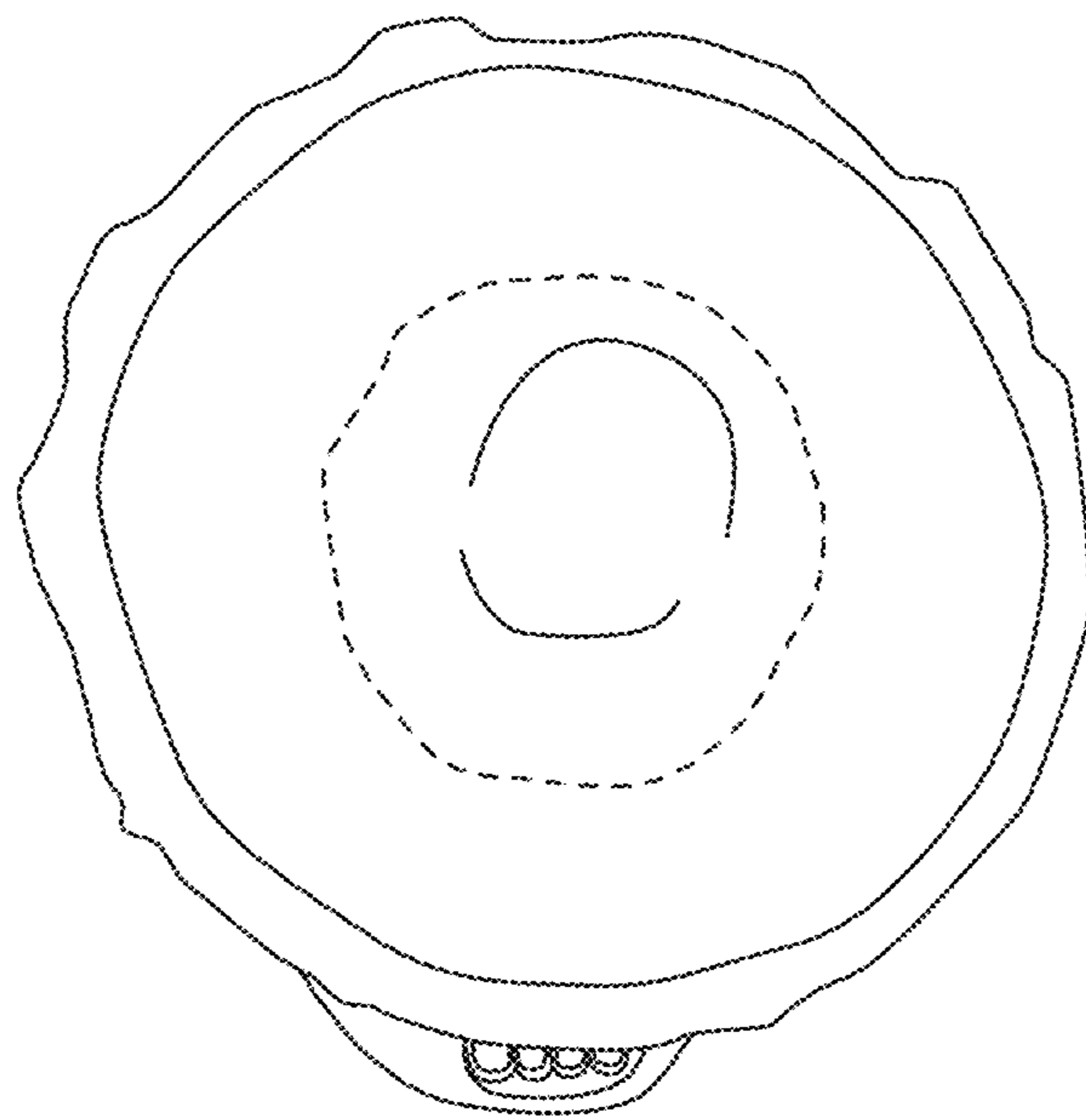

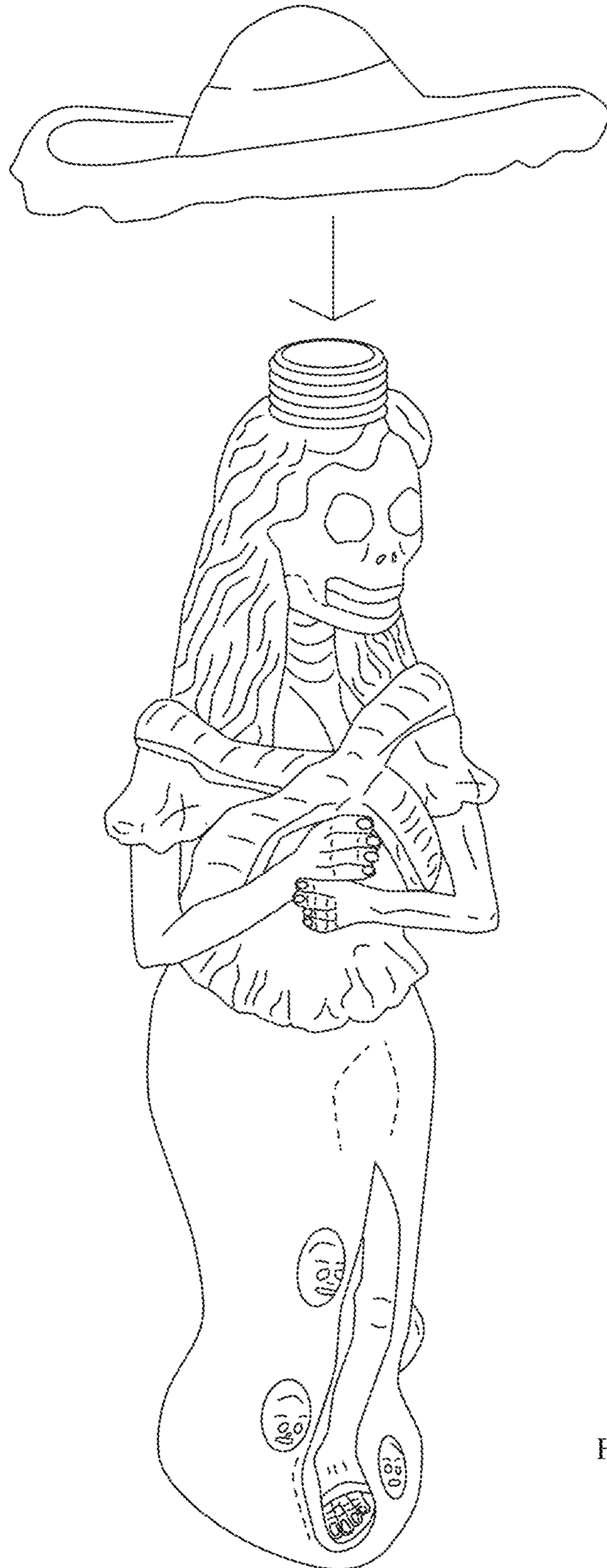
