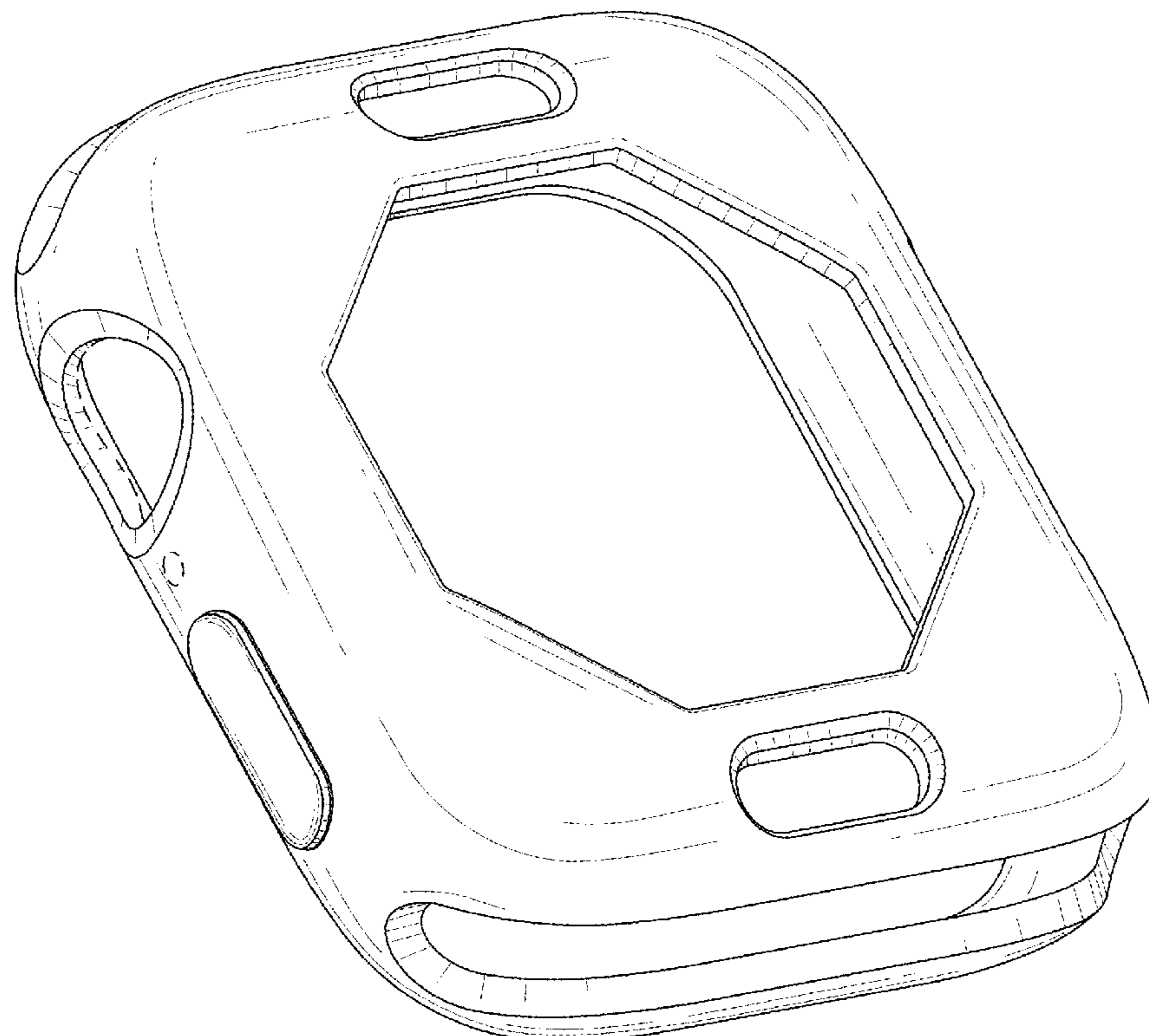
The ornamental design for a watch case, as shown and described.

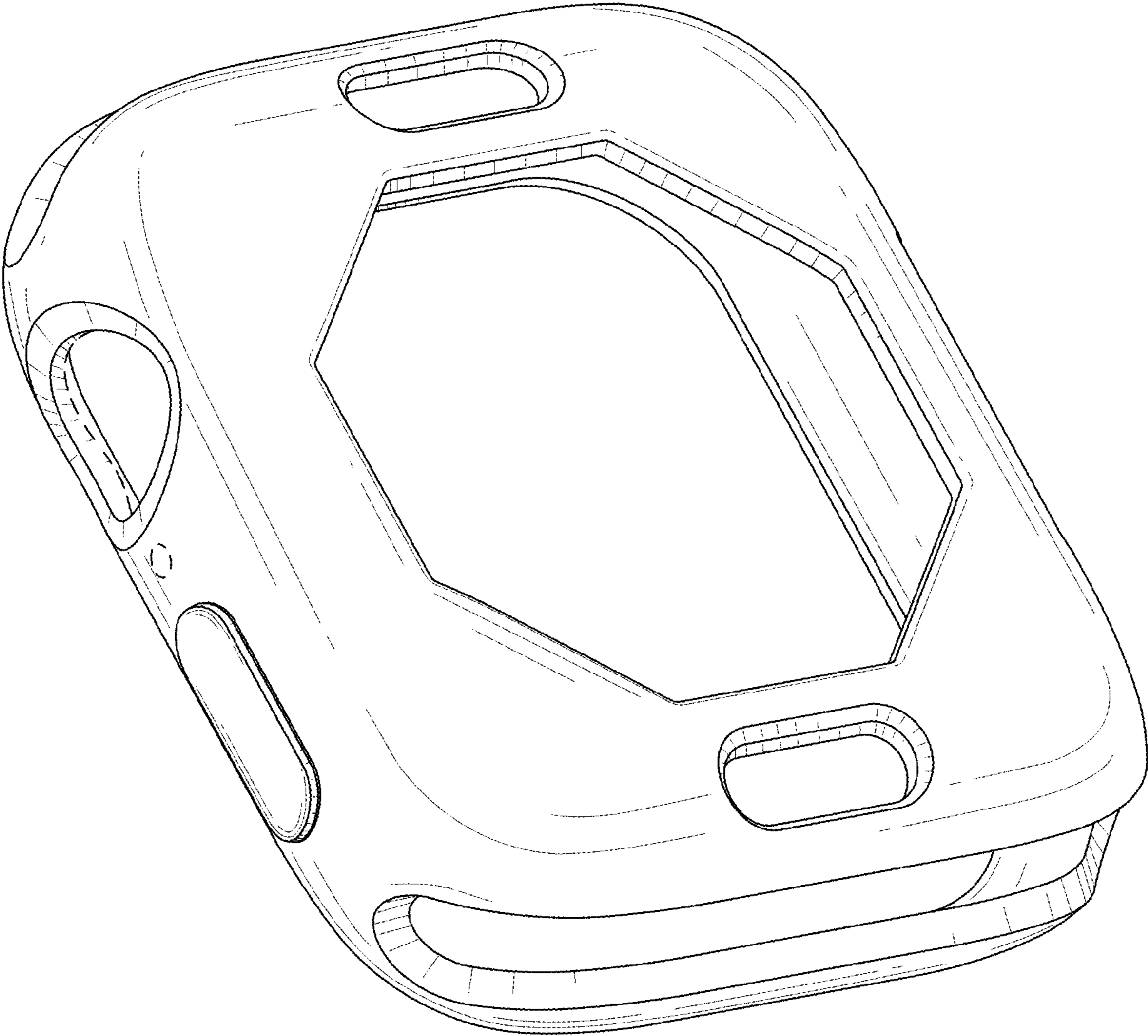

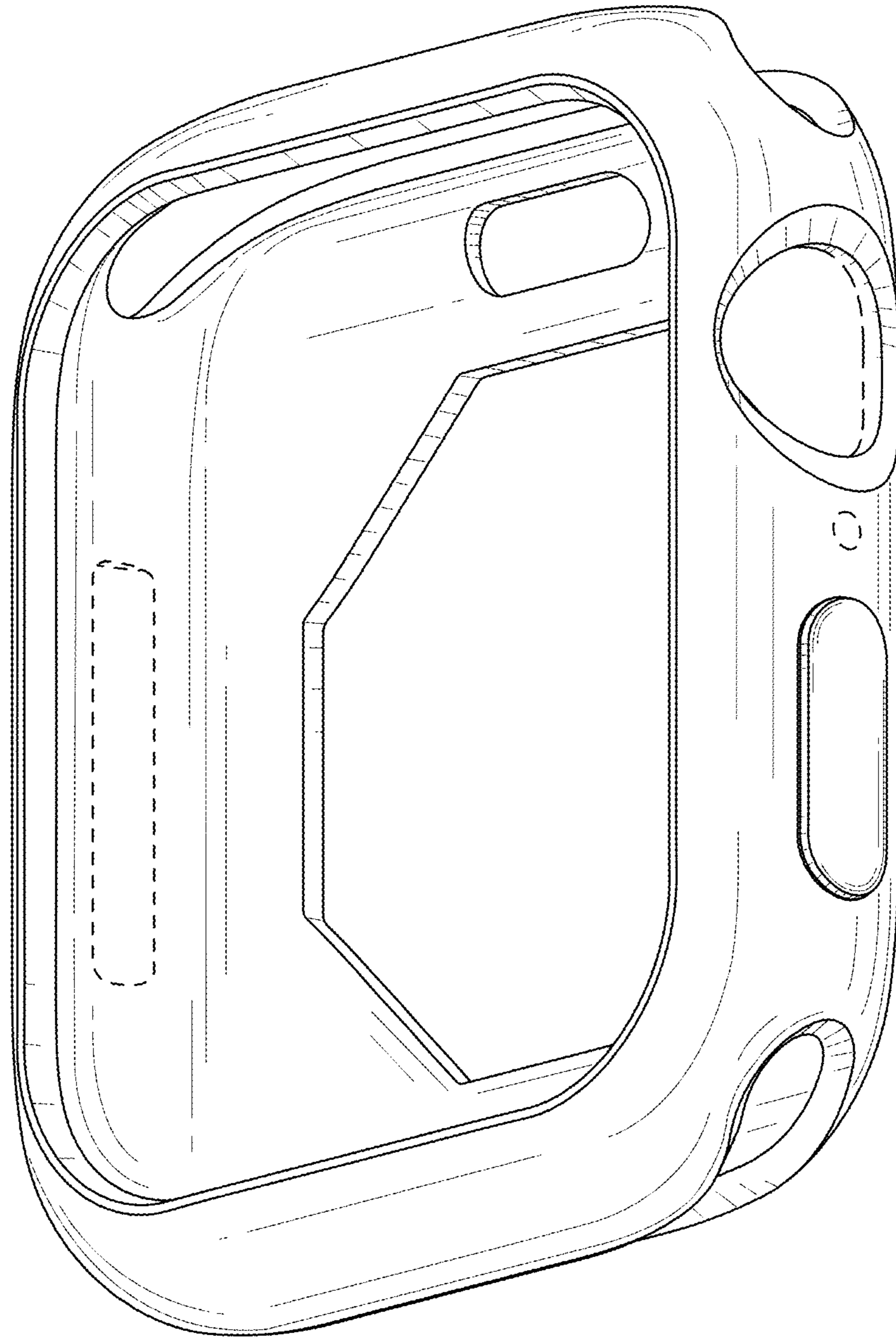

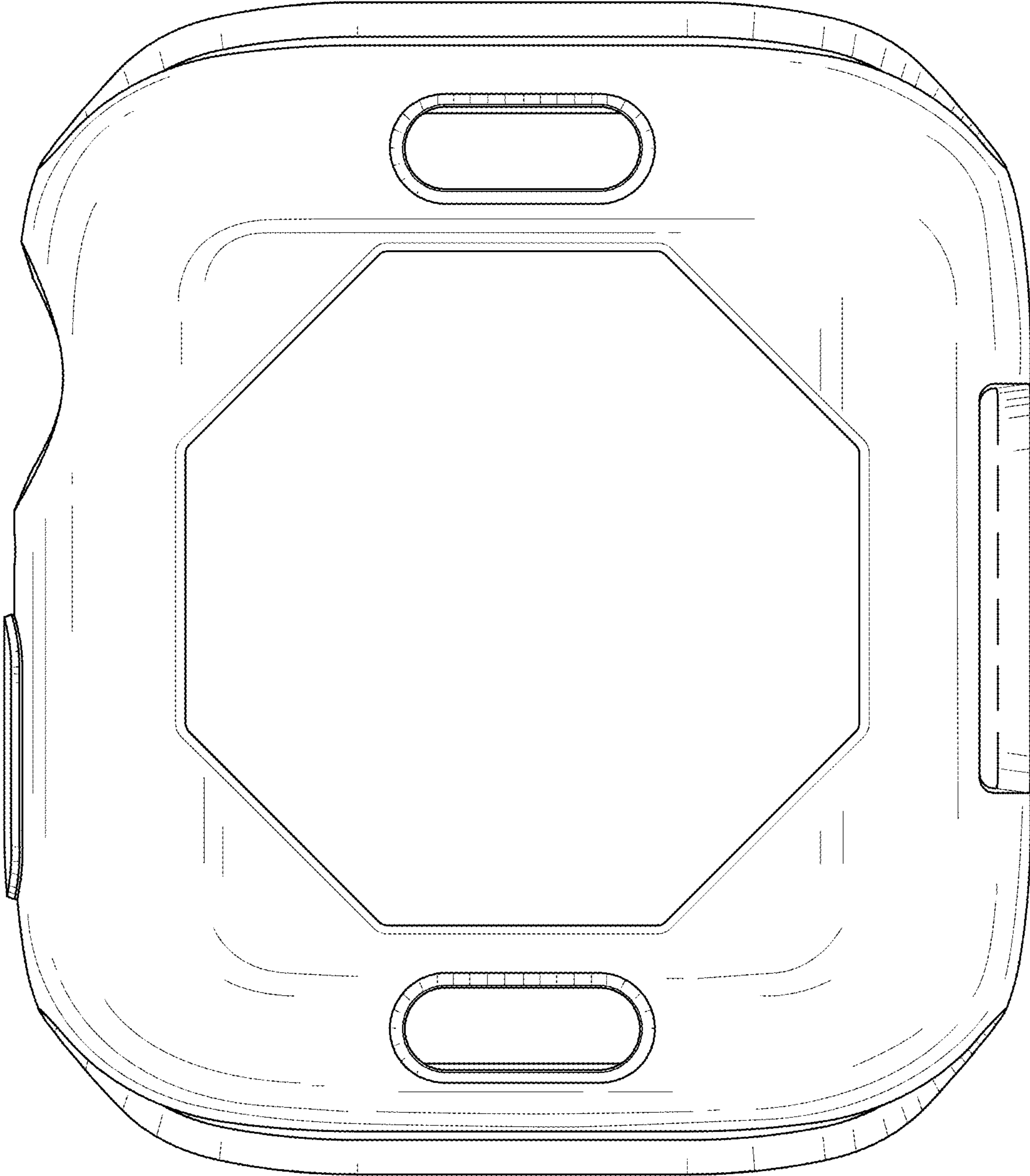

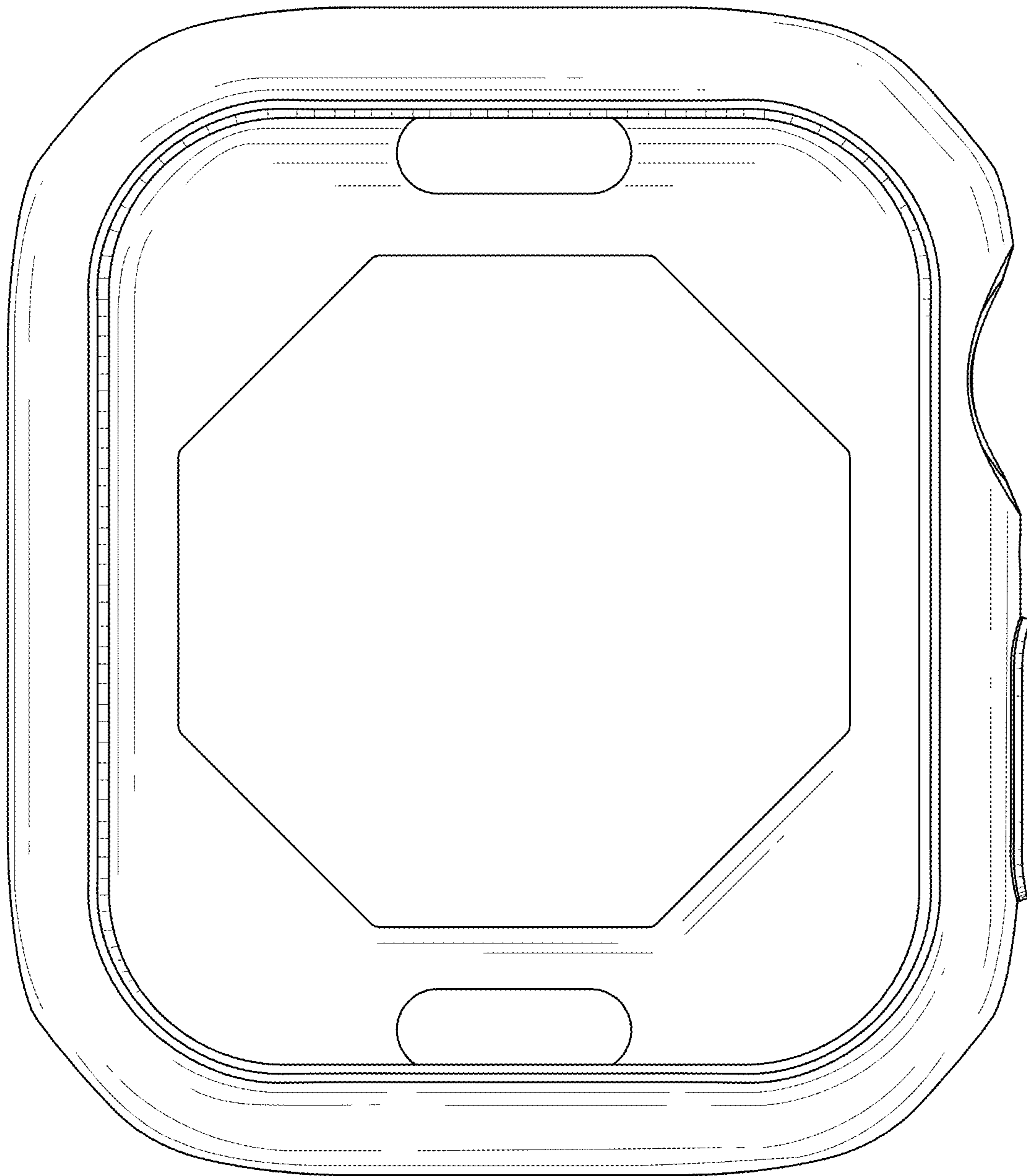

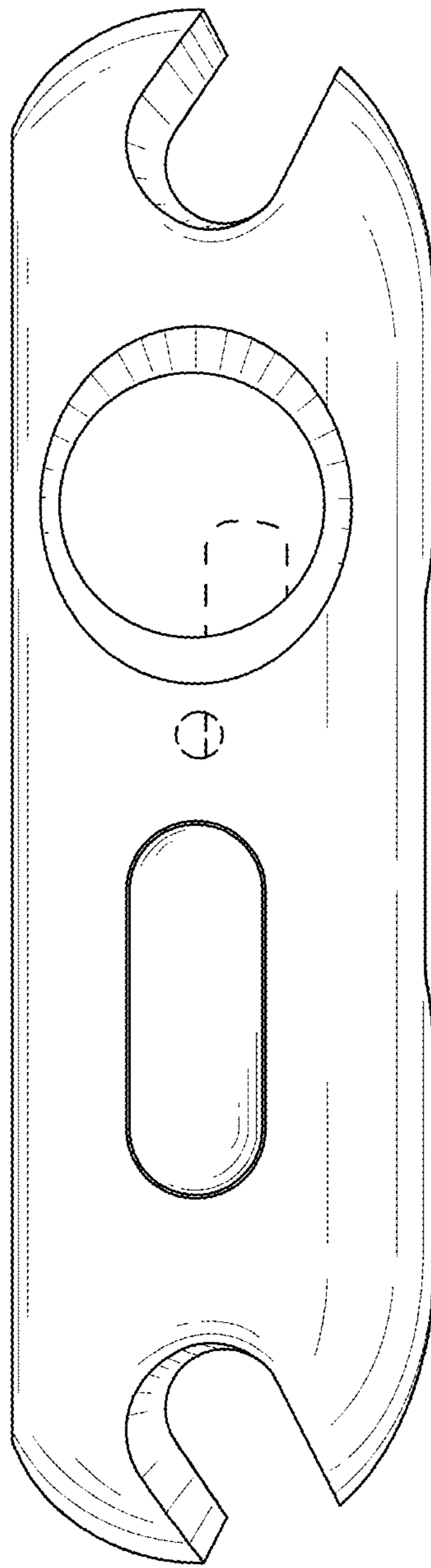

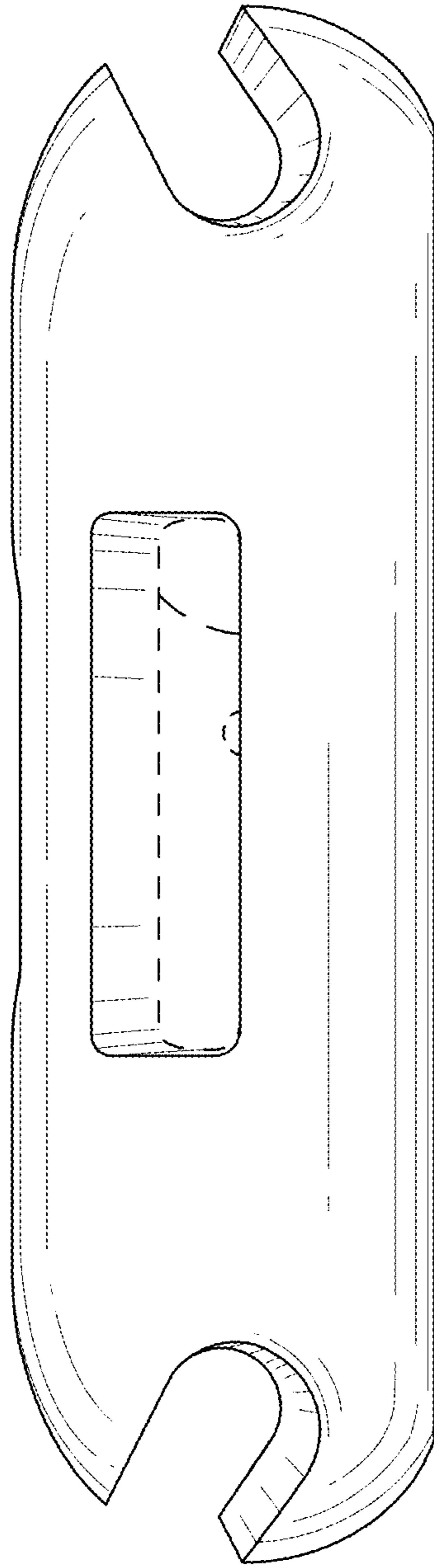

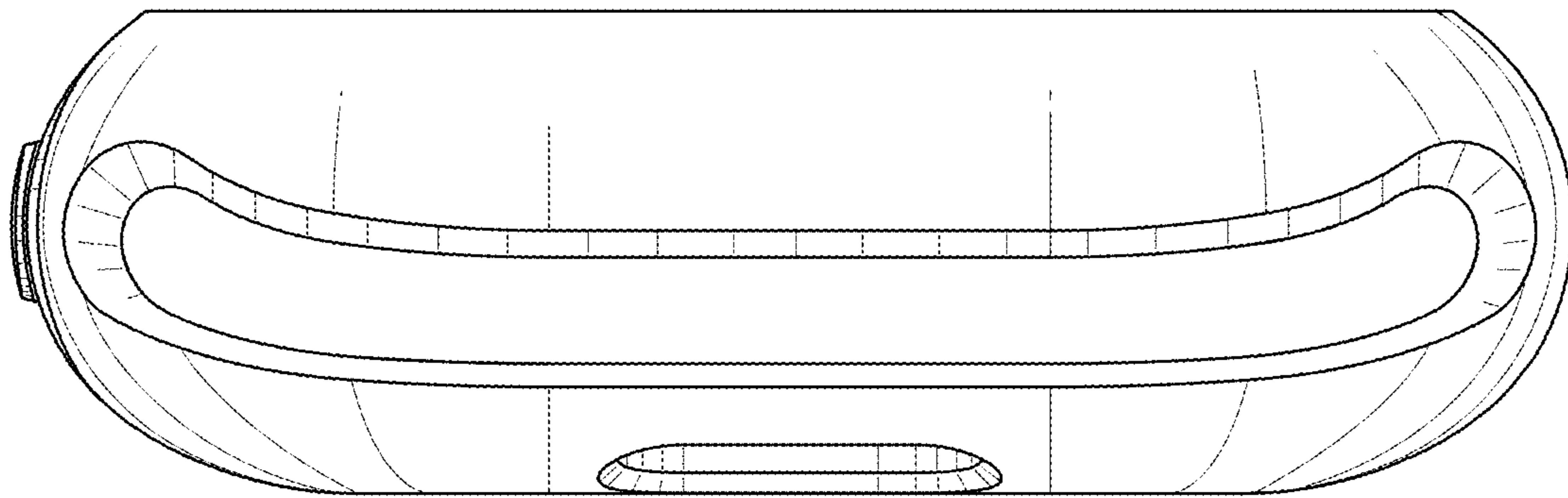

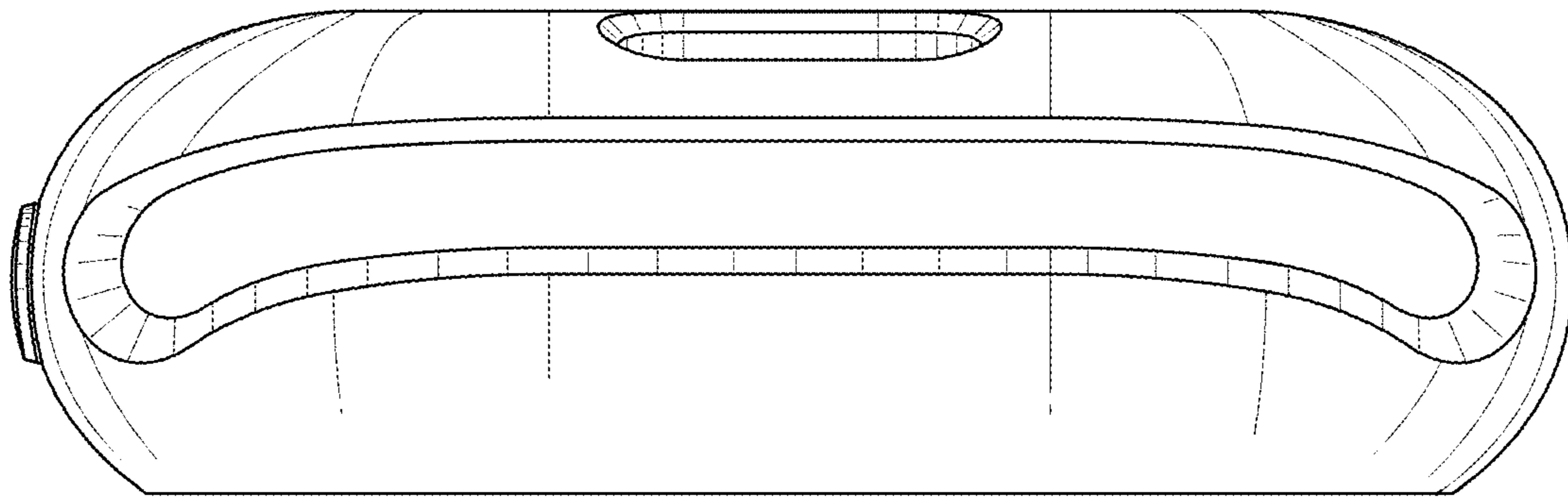
