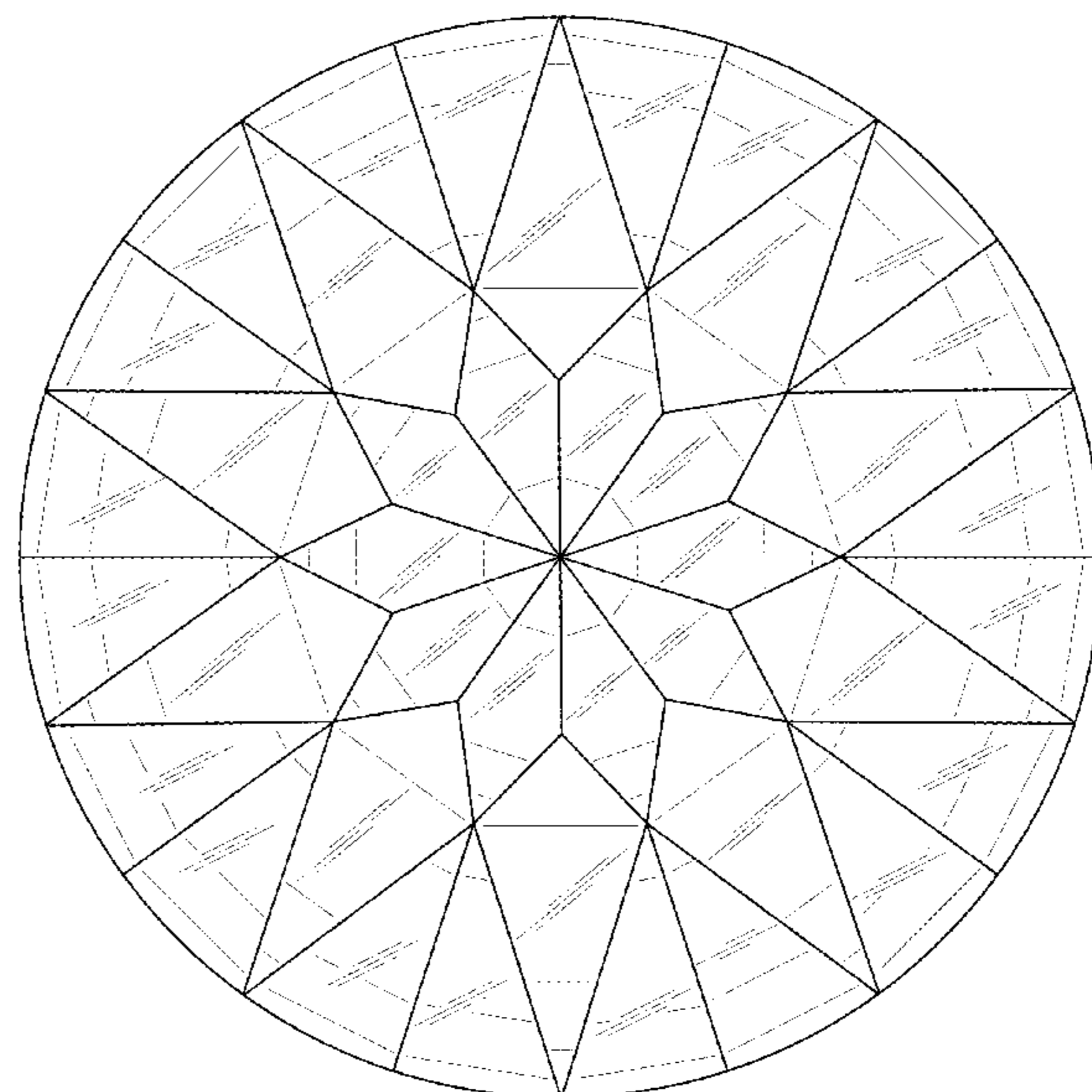
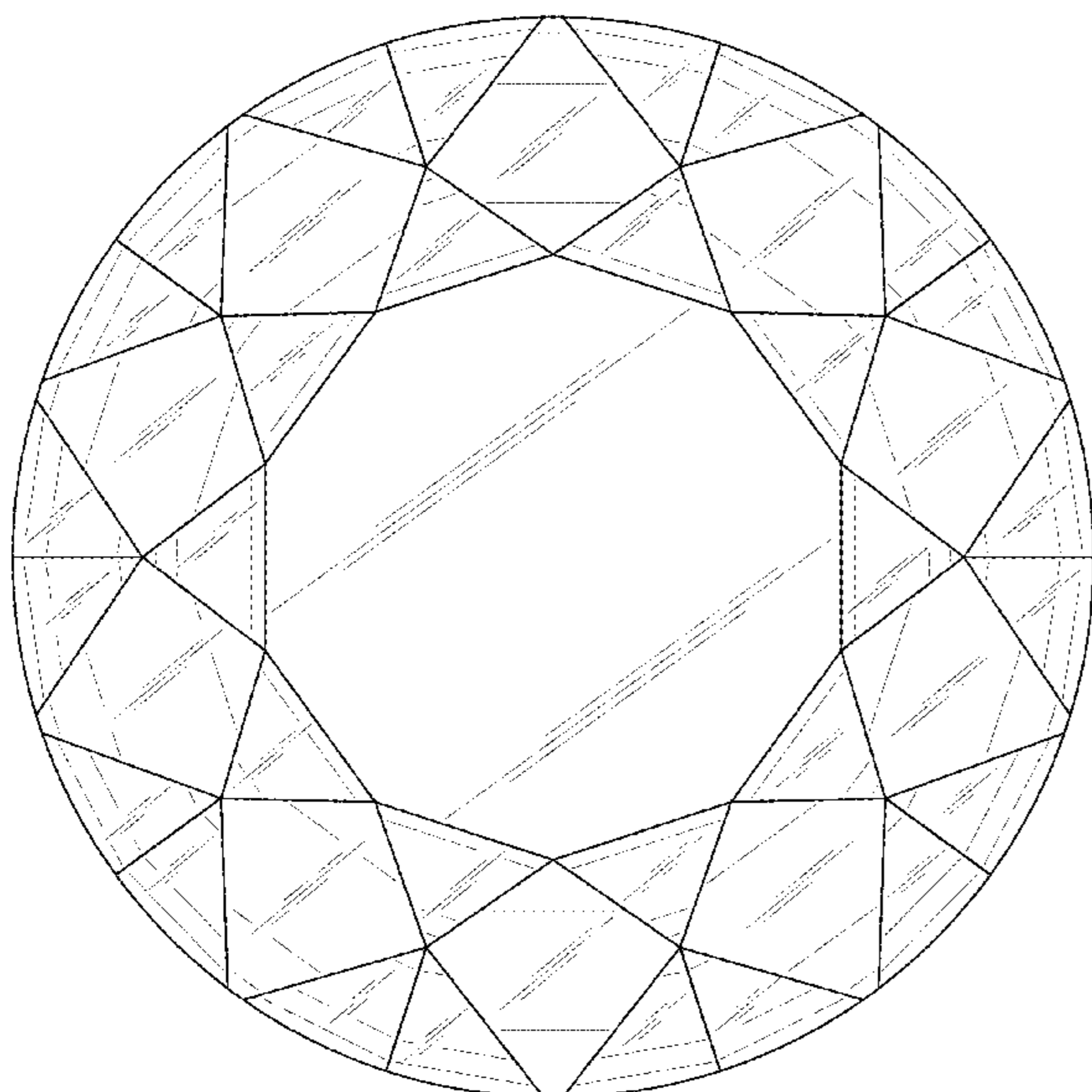
(57) **CLAIM**

The ornamental design for a gemstone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a gemstone in accordance with the present design;
FIG. 2 is a front view thereof, wherein the rear view is a mirror image of the front view;
FIG. 3 is a right side view thereof, wherein the left side view thereof is a mirror image of the right side view;
FIG. 4 is a top view thereof; and,

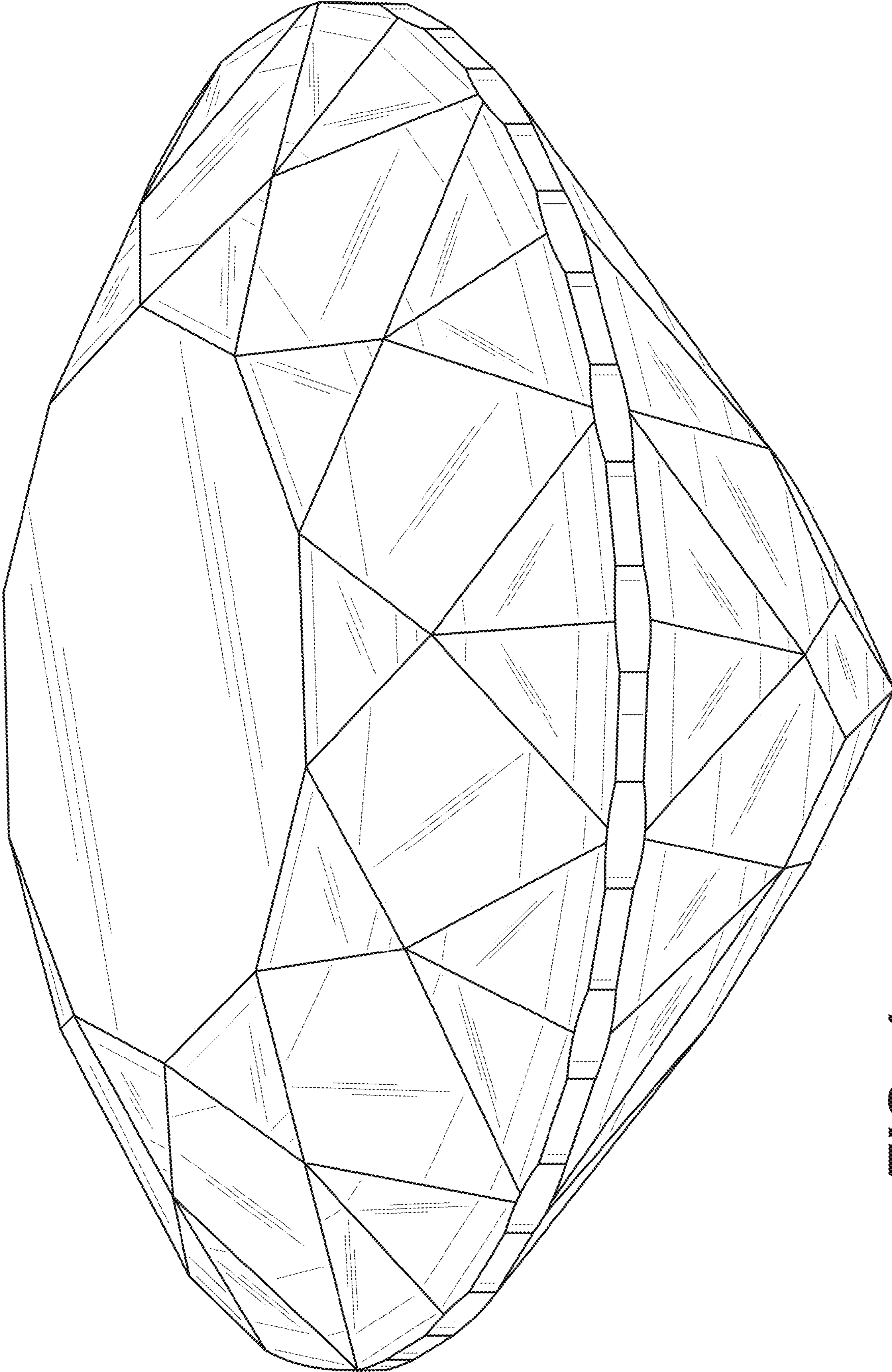

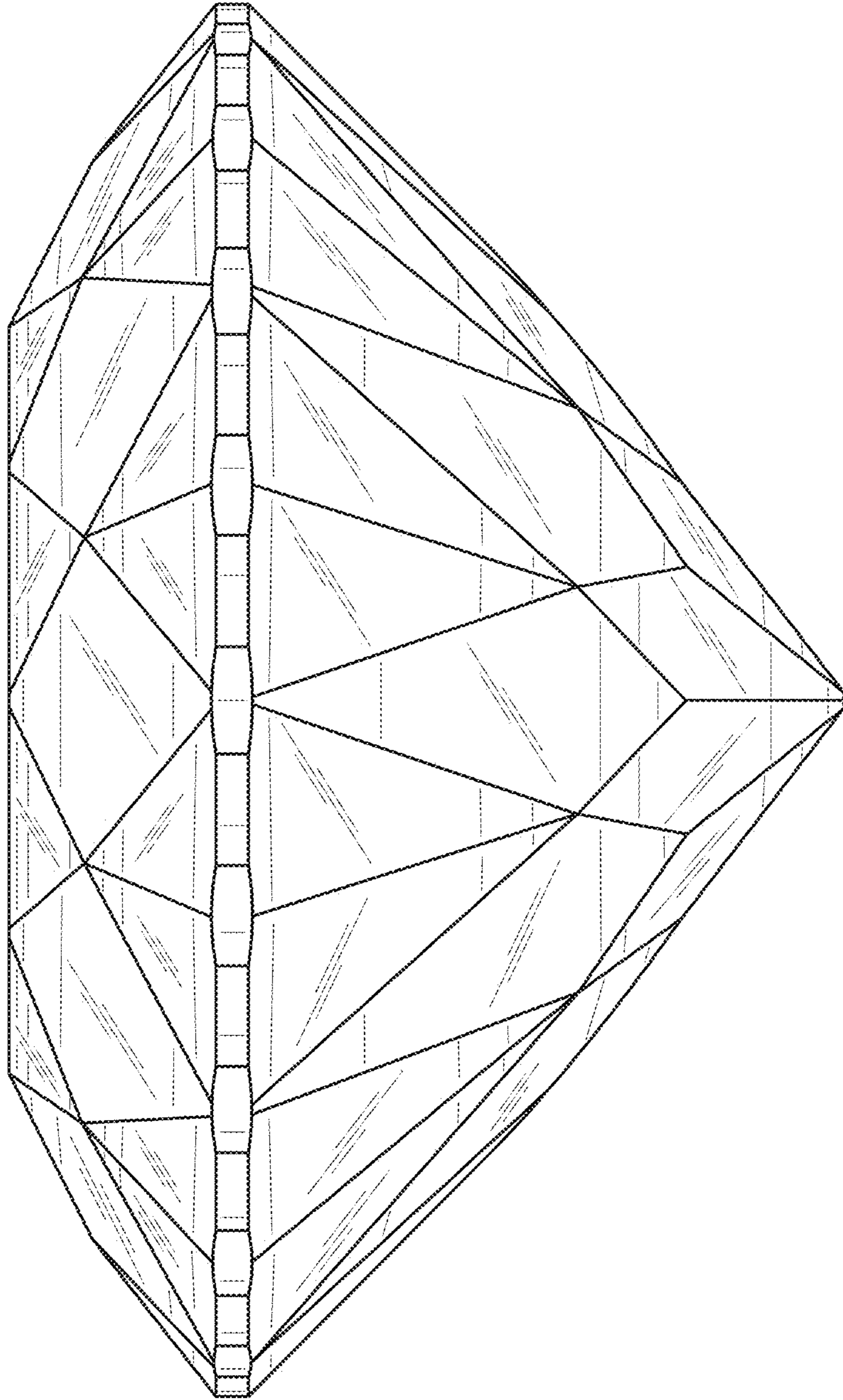

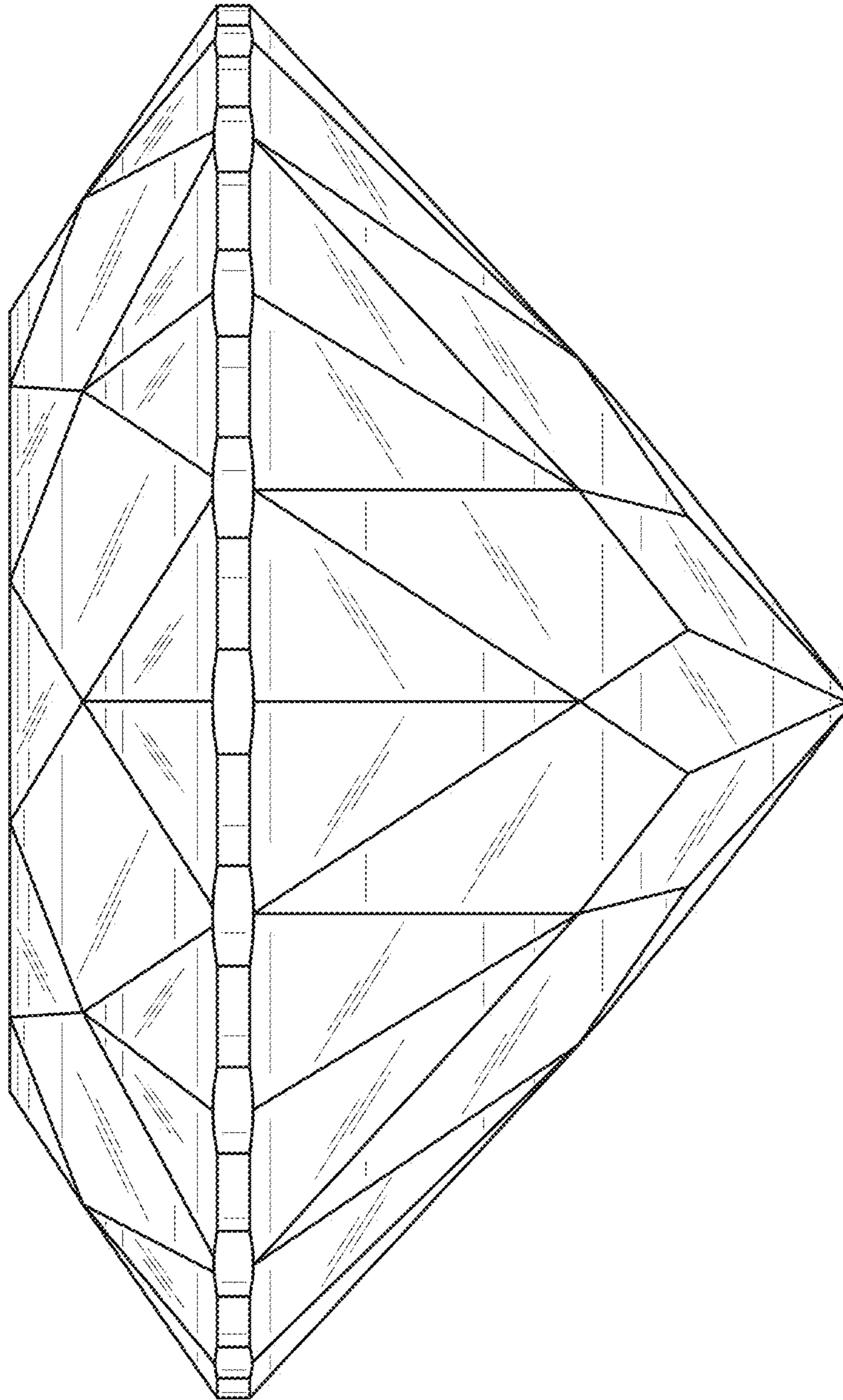

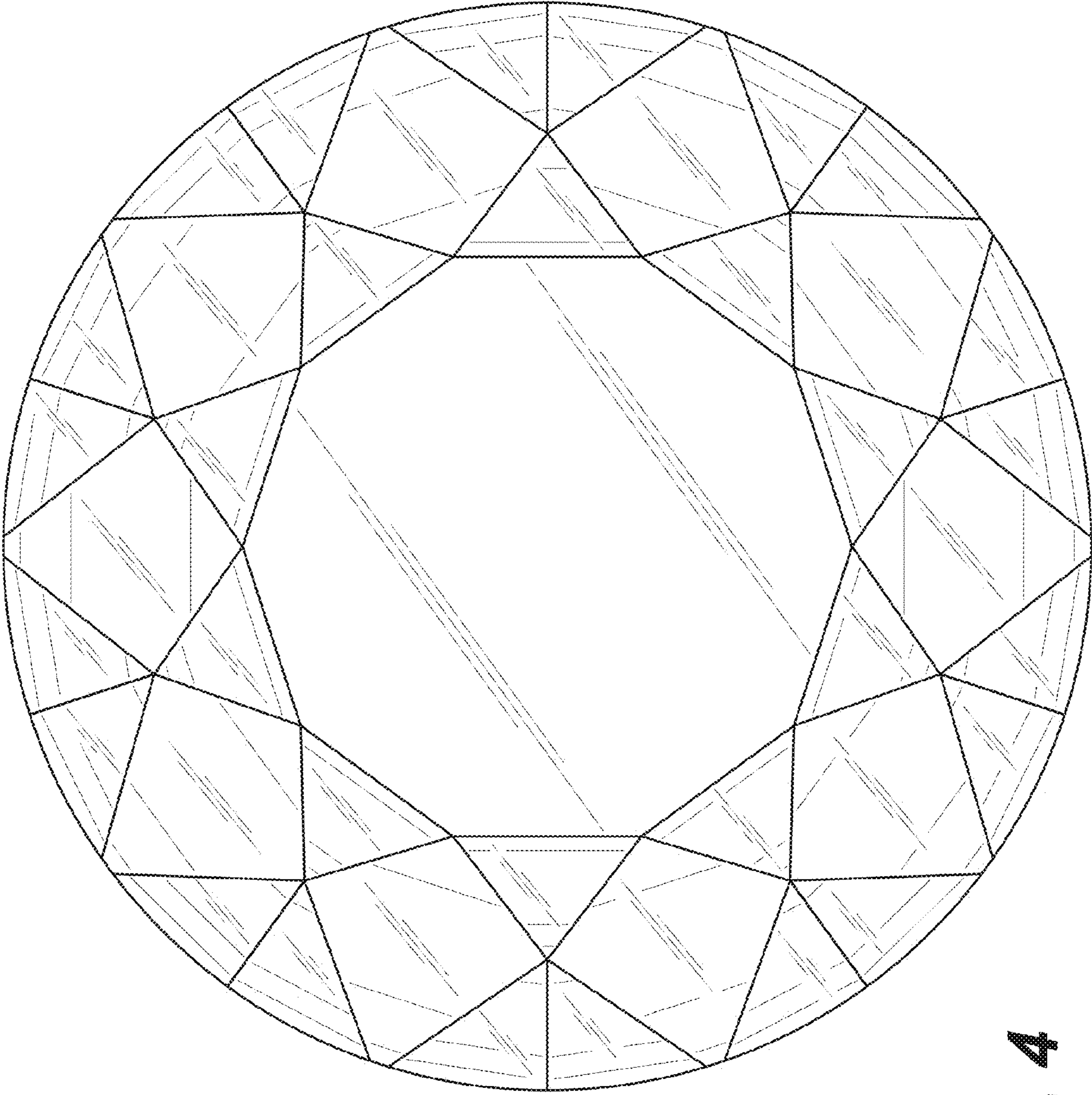

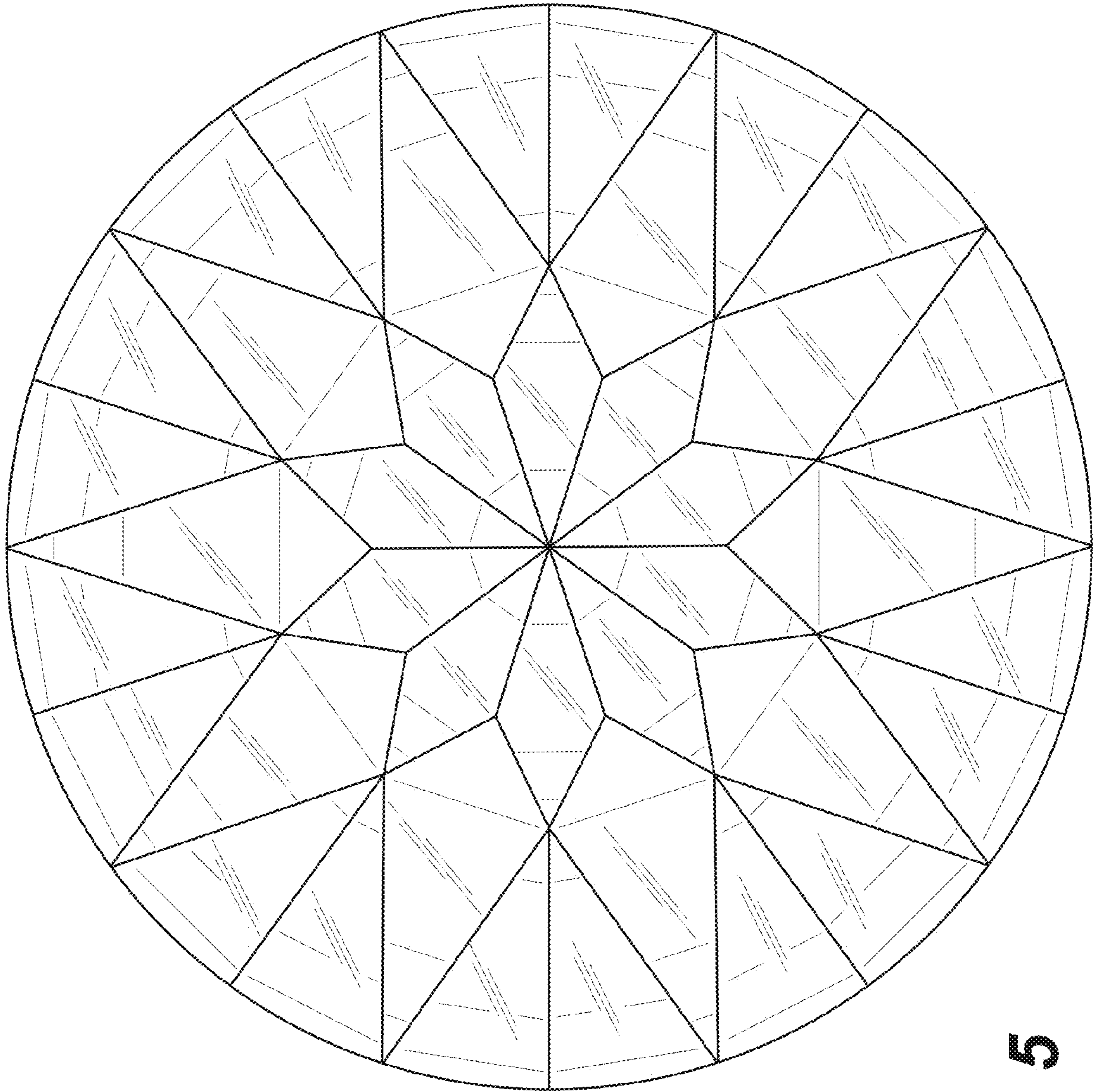
