(57) **CLAIM**

The ornamental design for a nursery pot, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a nursery pot wherein a lid and a body of the nursery pot are in an assembled configuration;

FIG. 14 is a top view of the lid shown without the body for convenience;

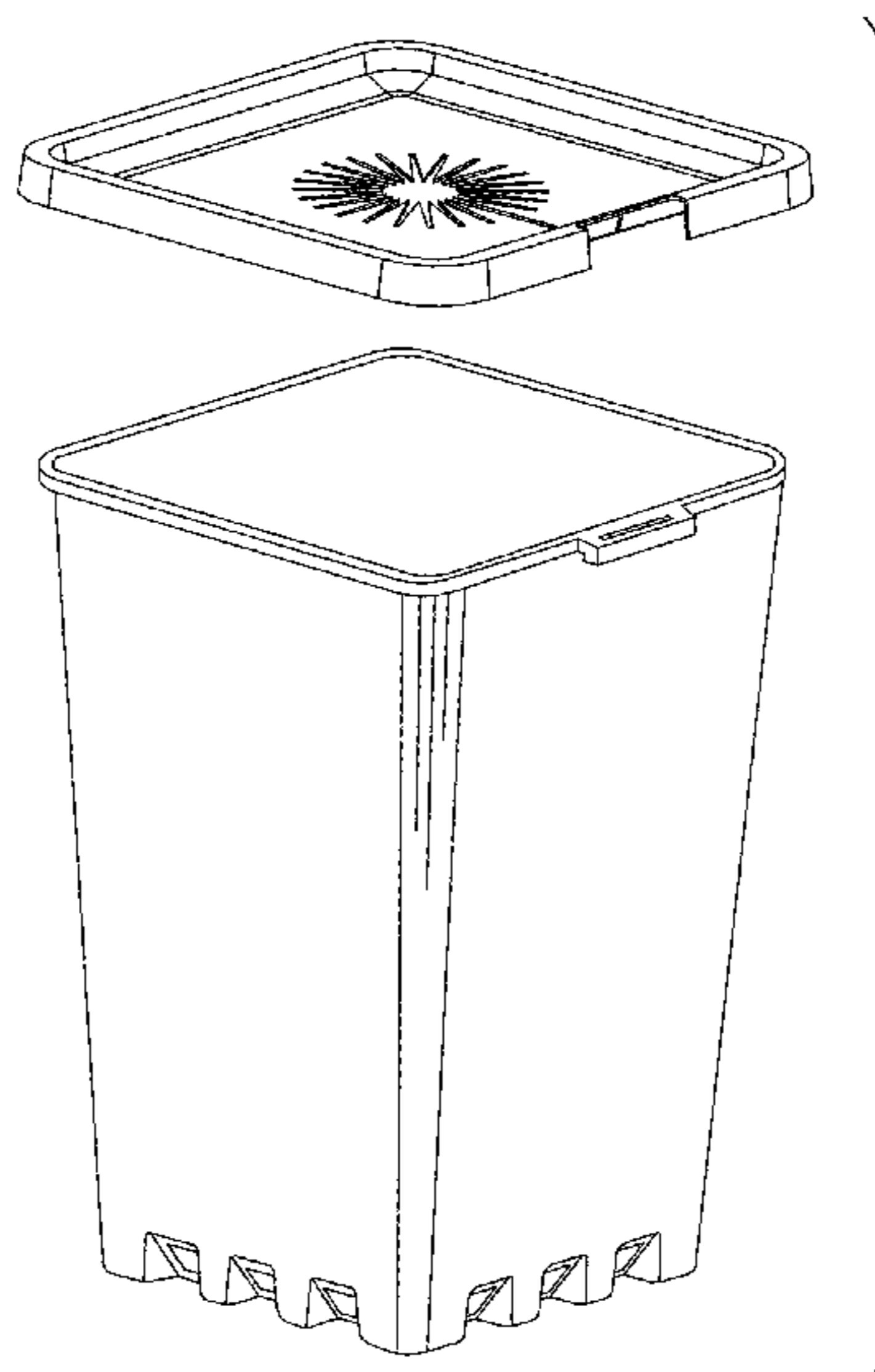
FIG. 15 is a bottom perspective view thereof;

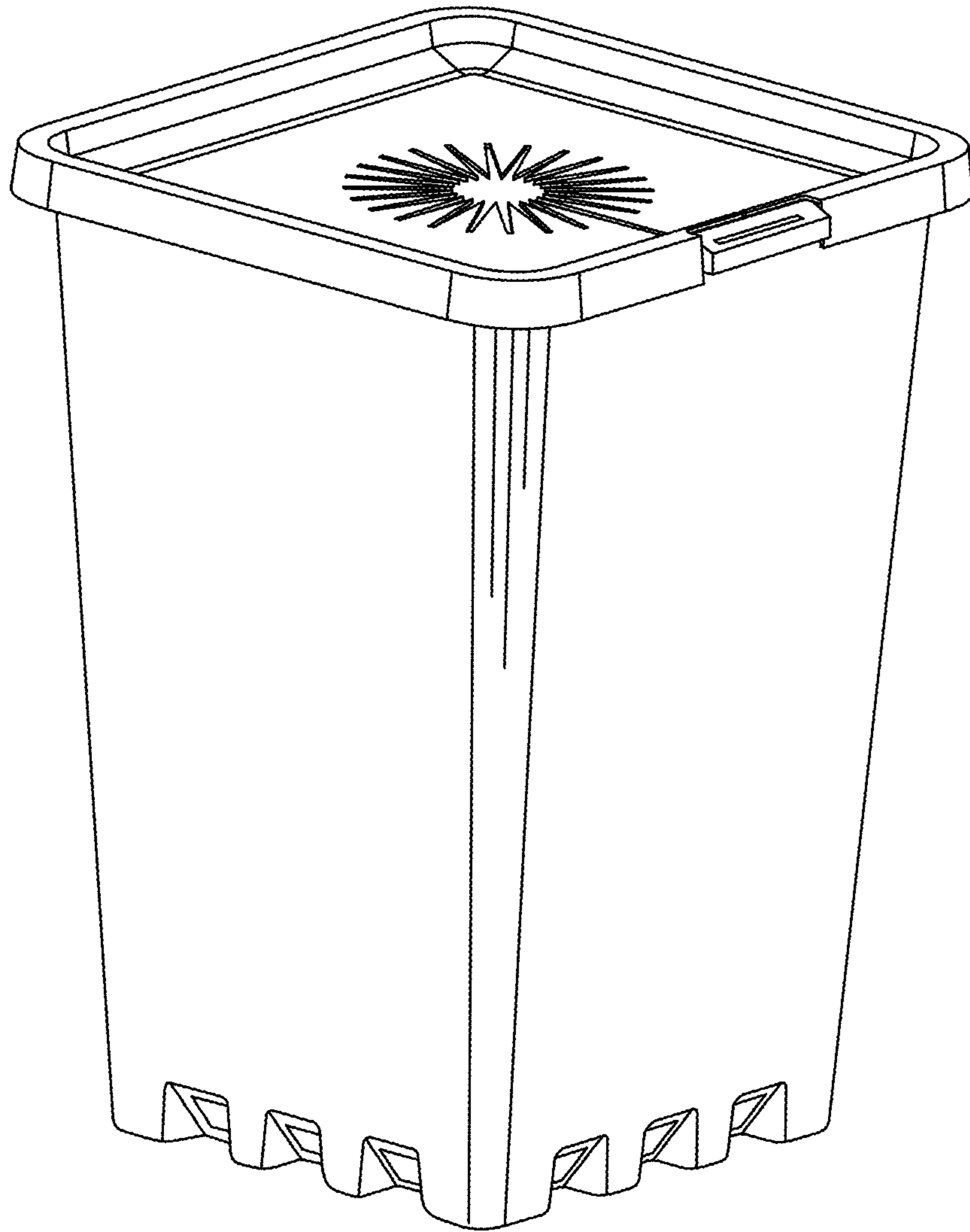

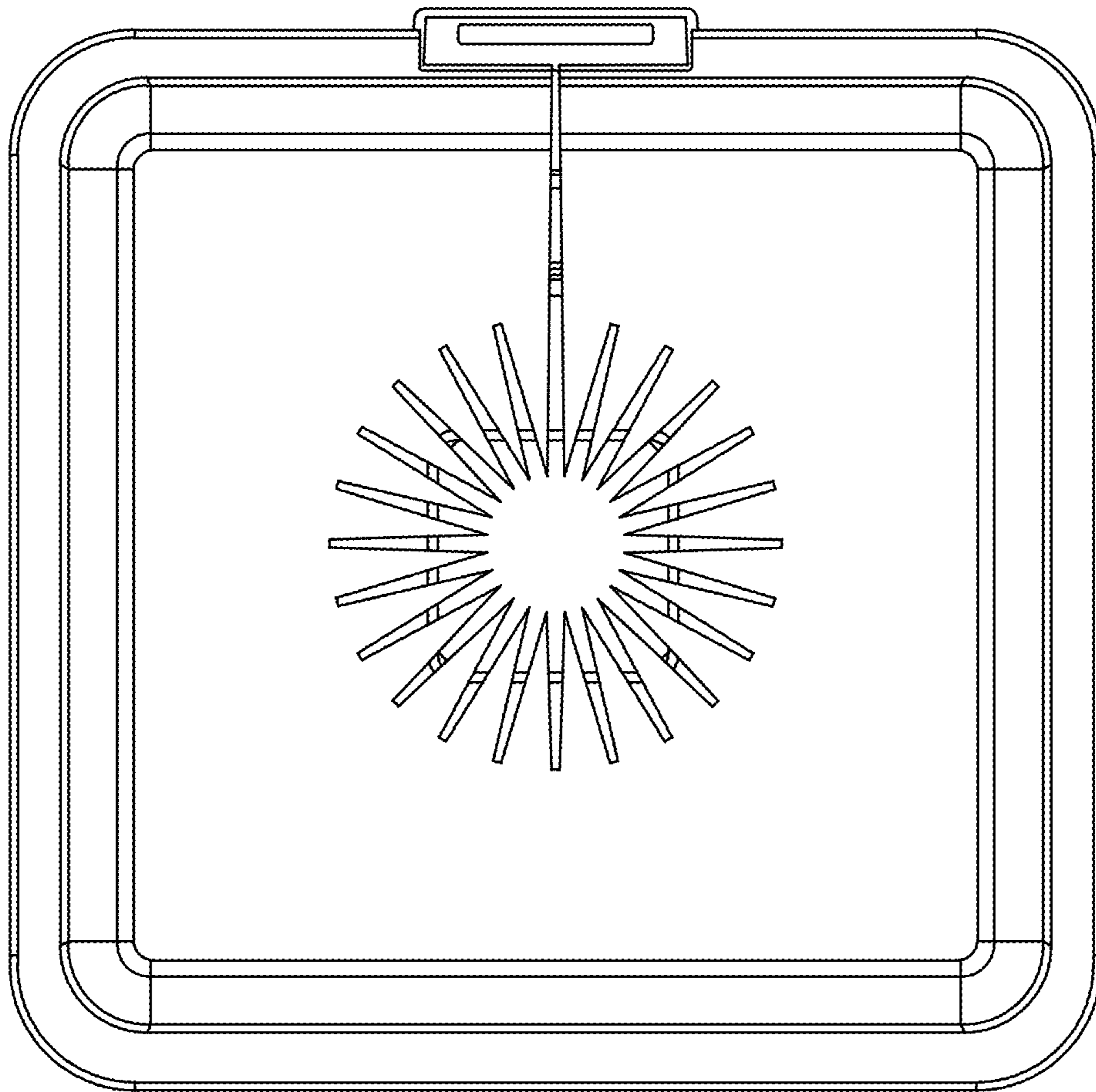

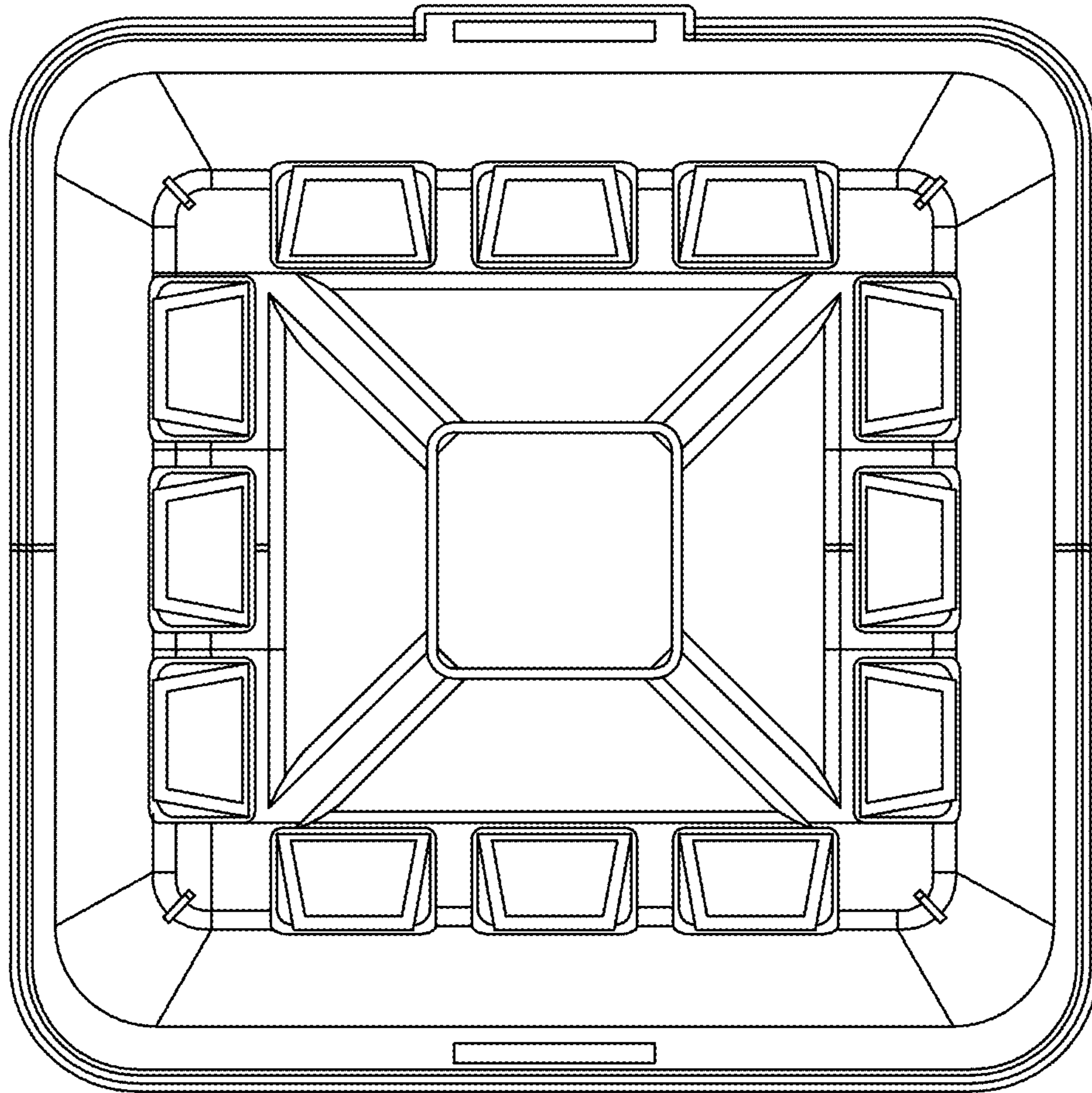

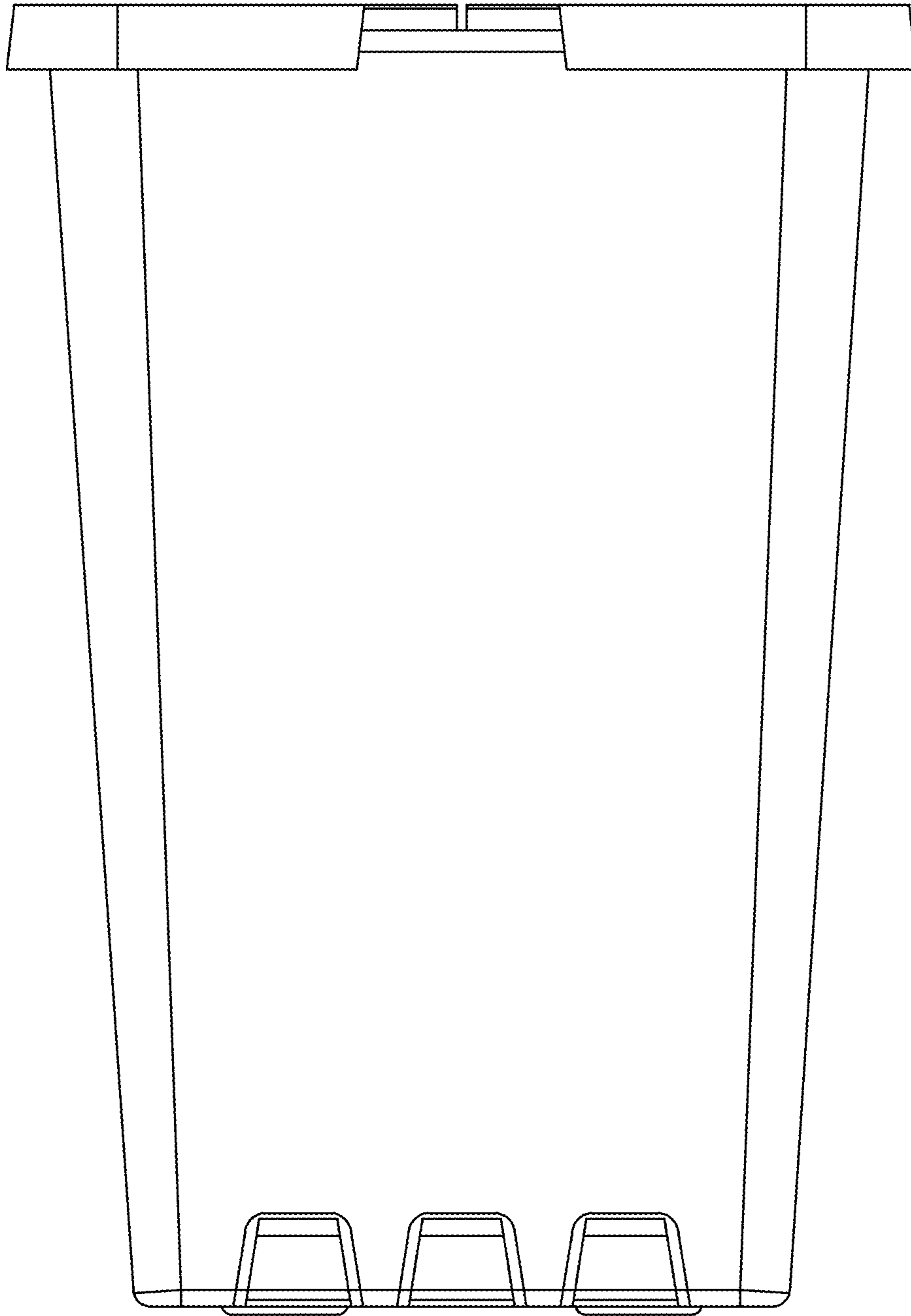

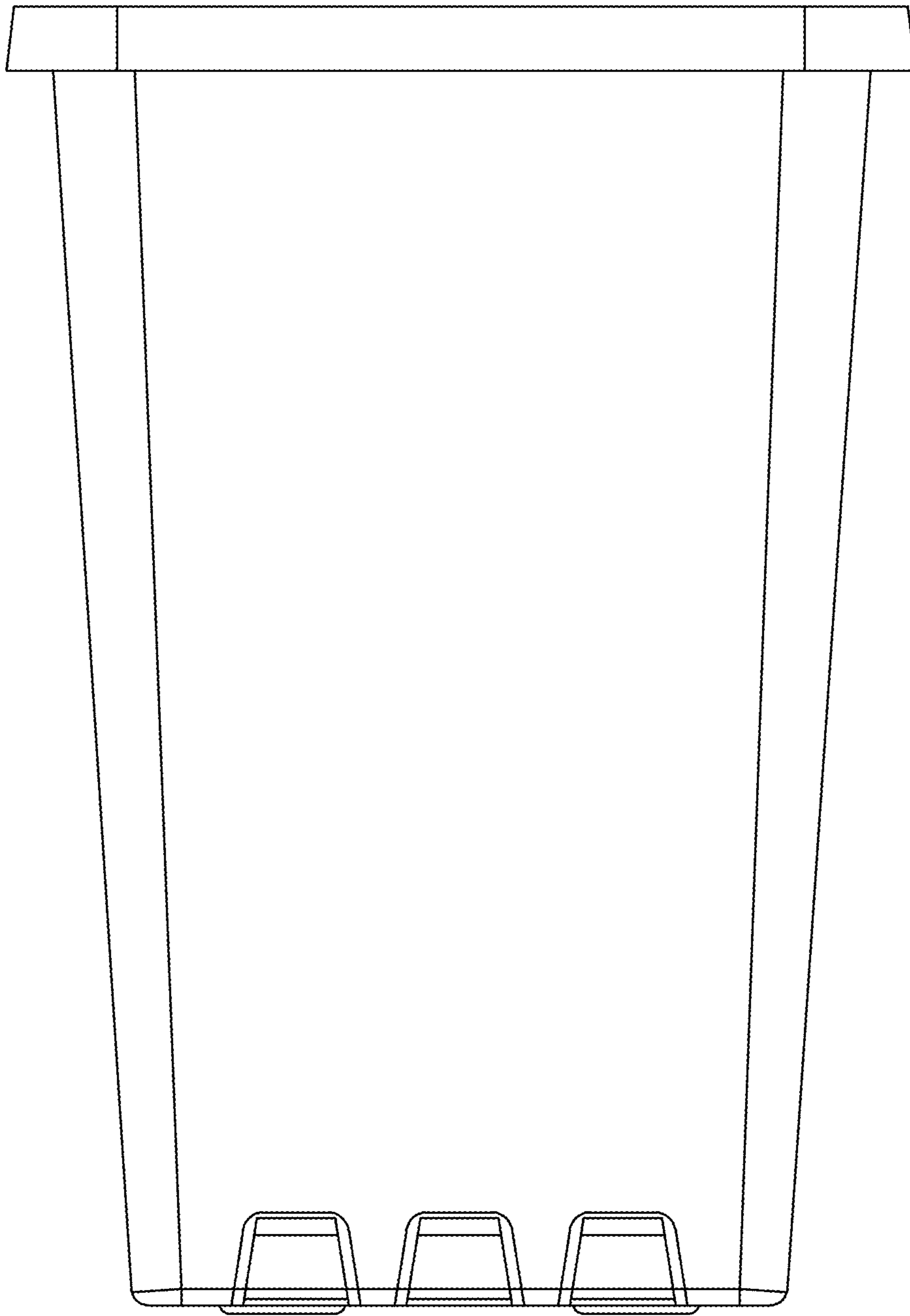

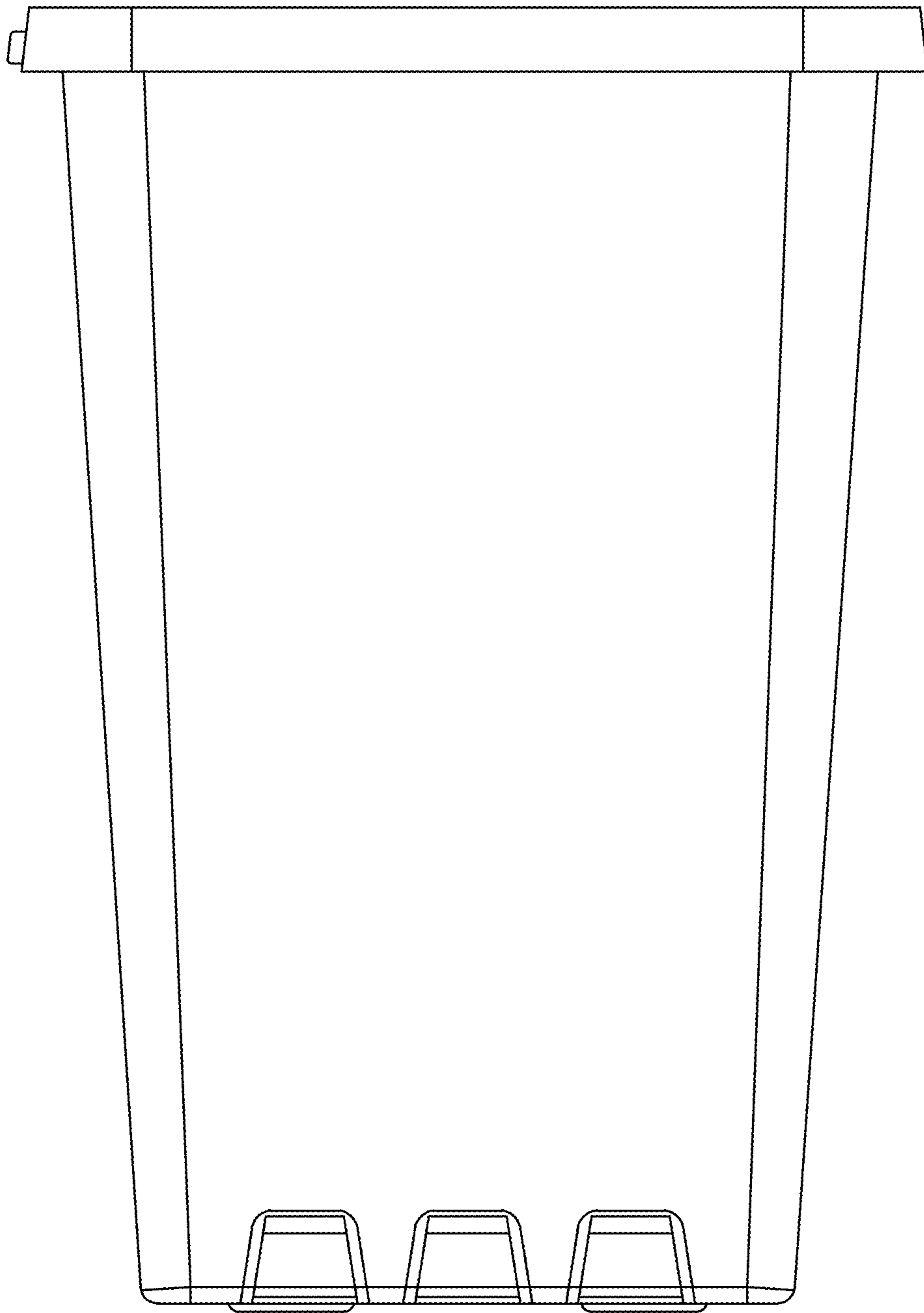

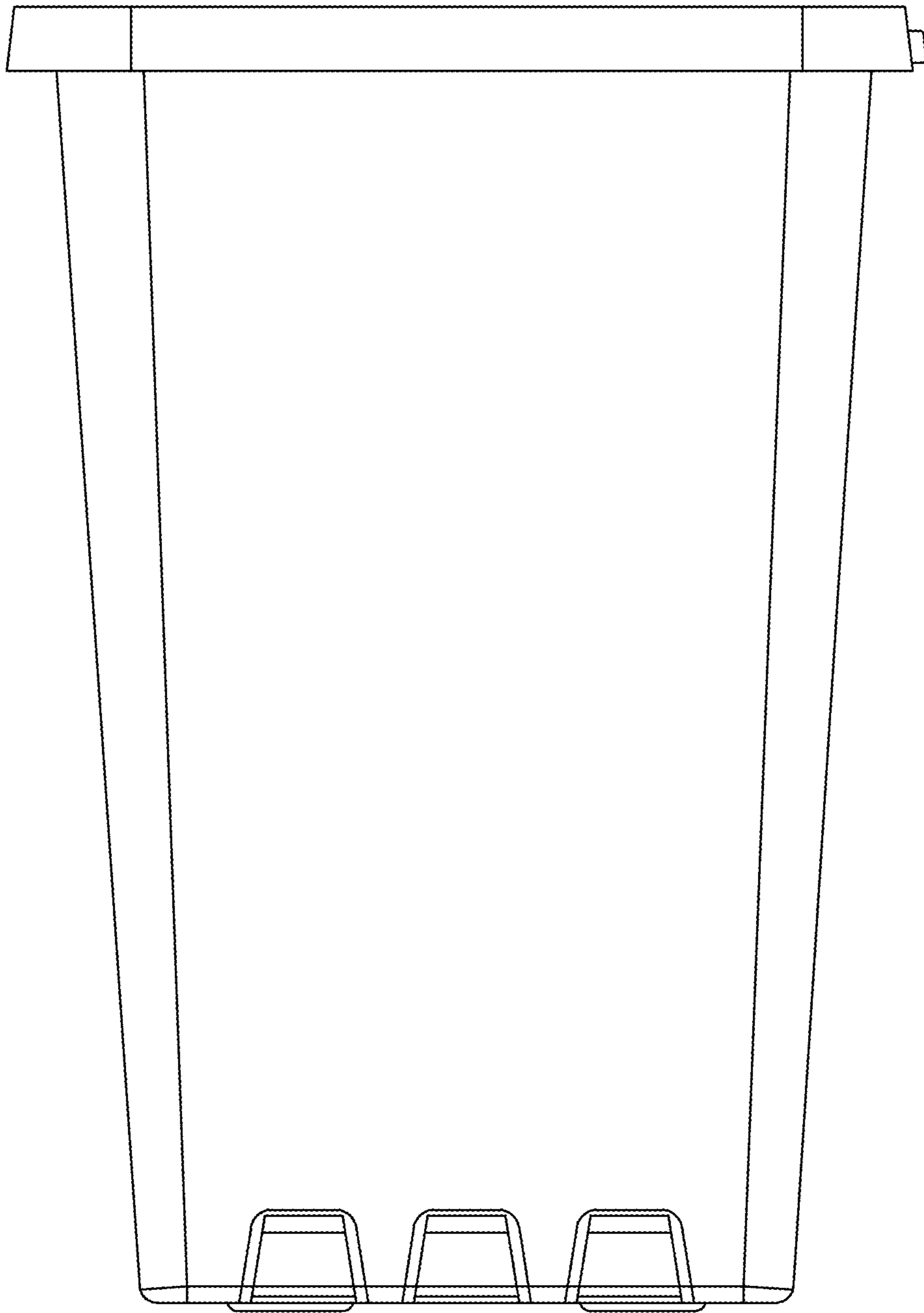

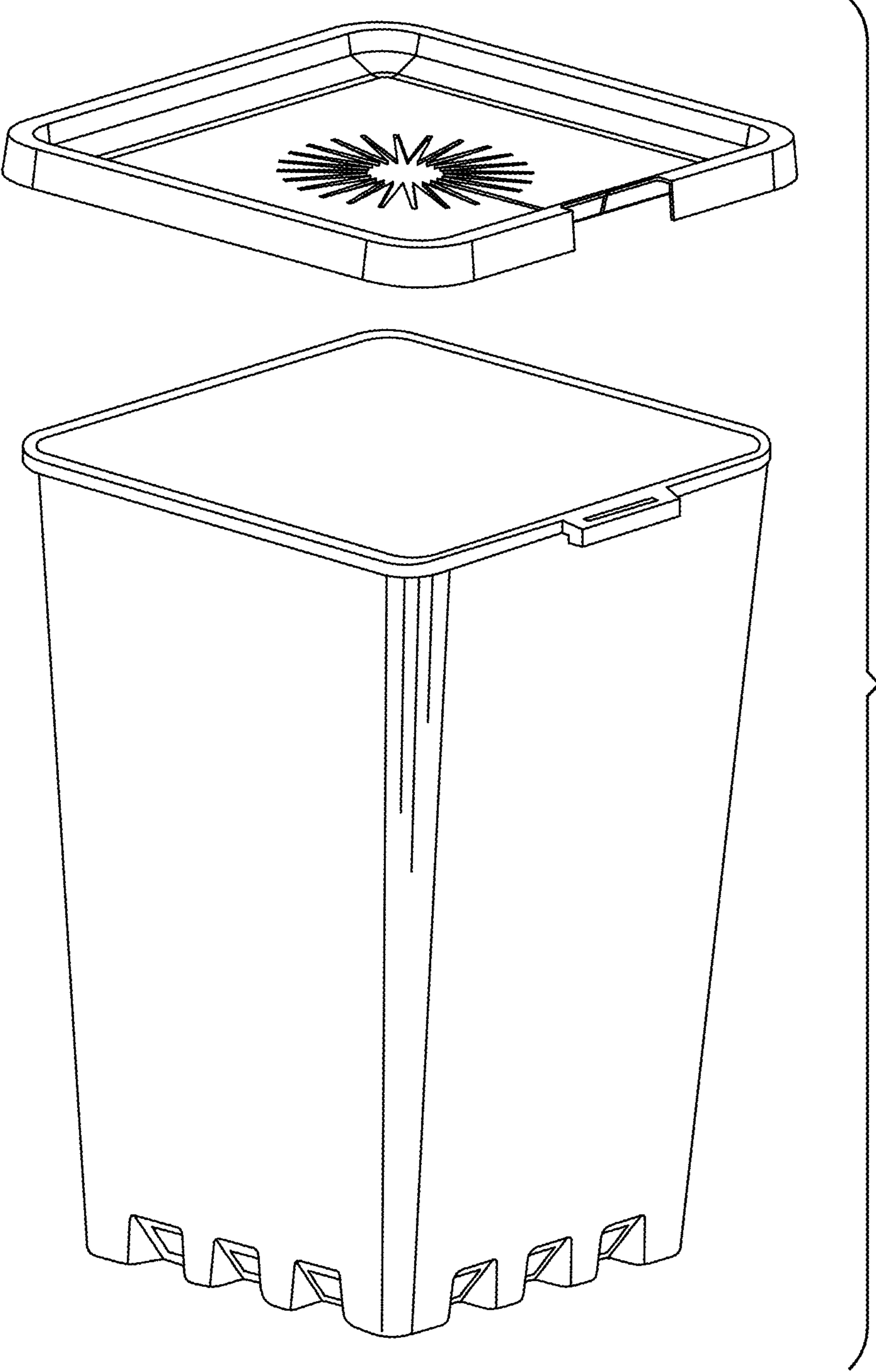

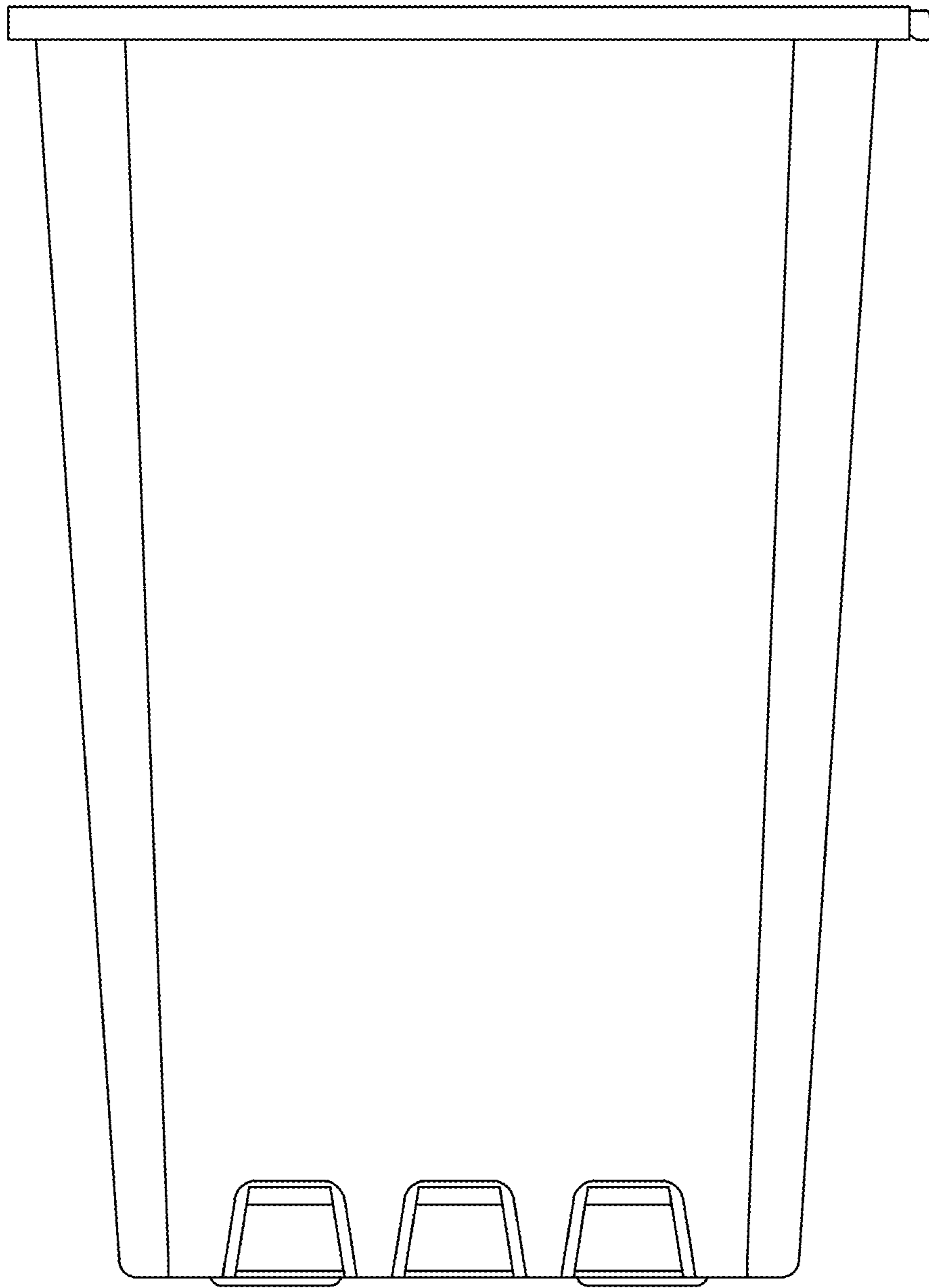

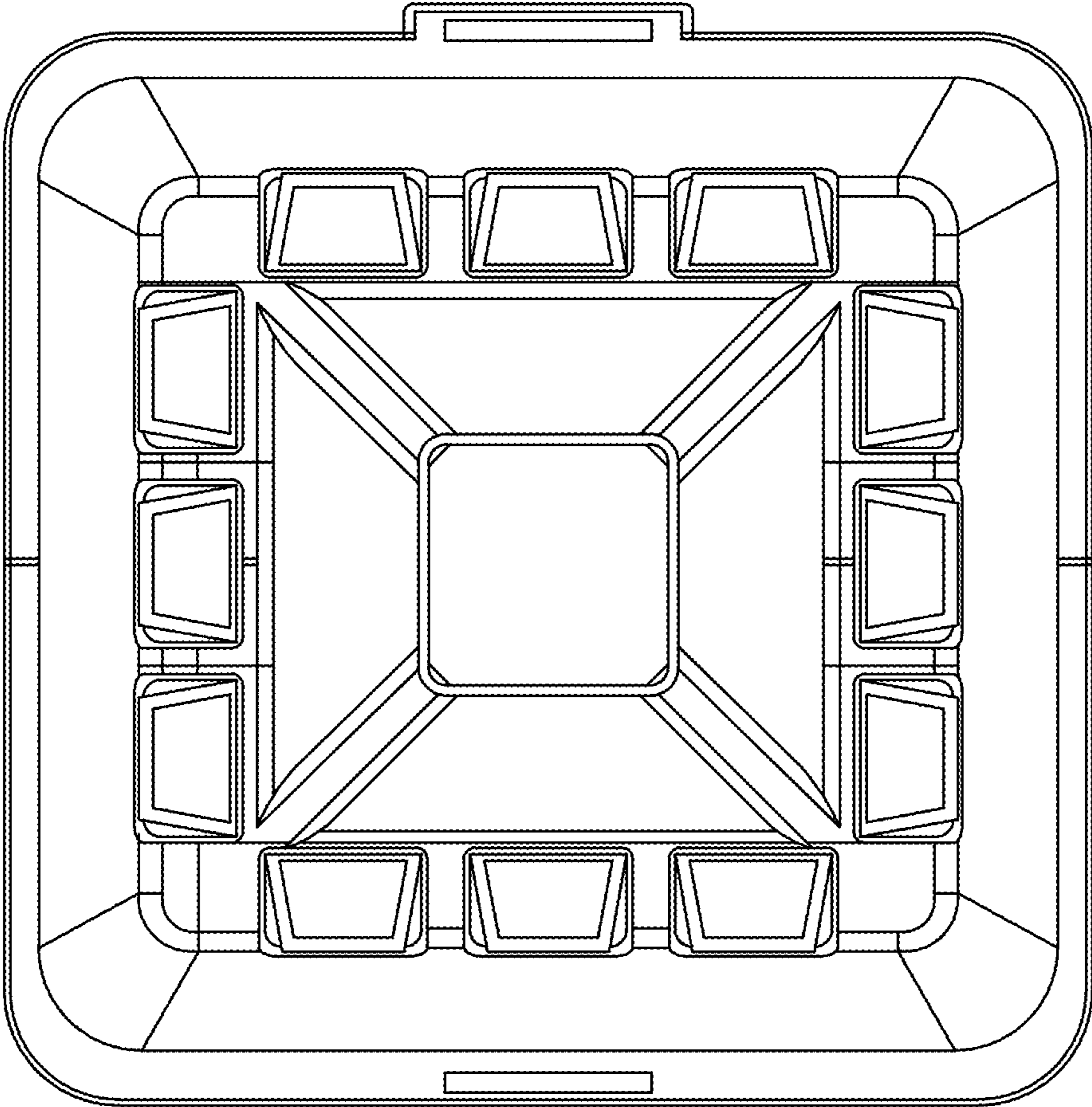

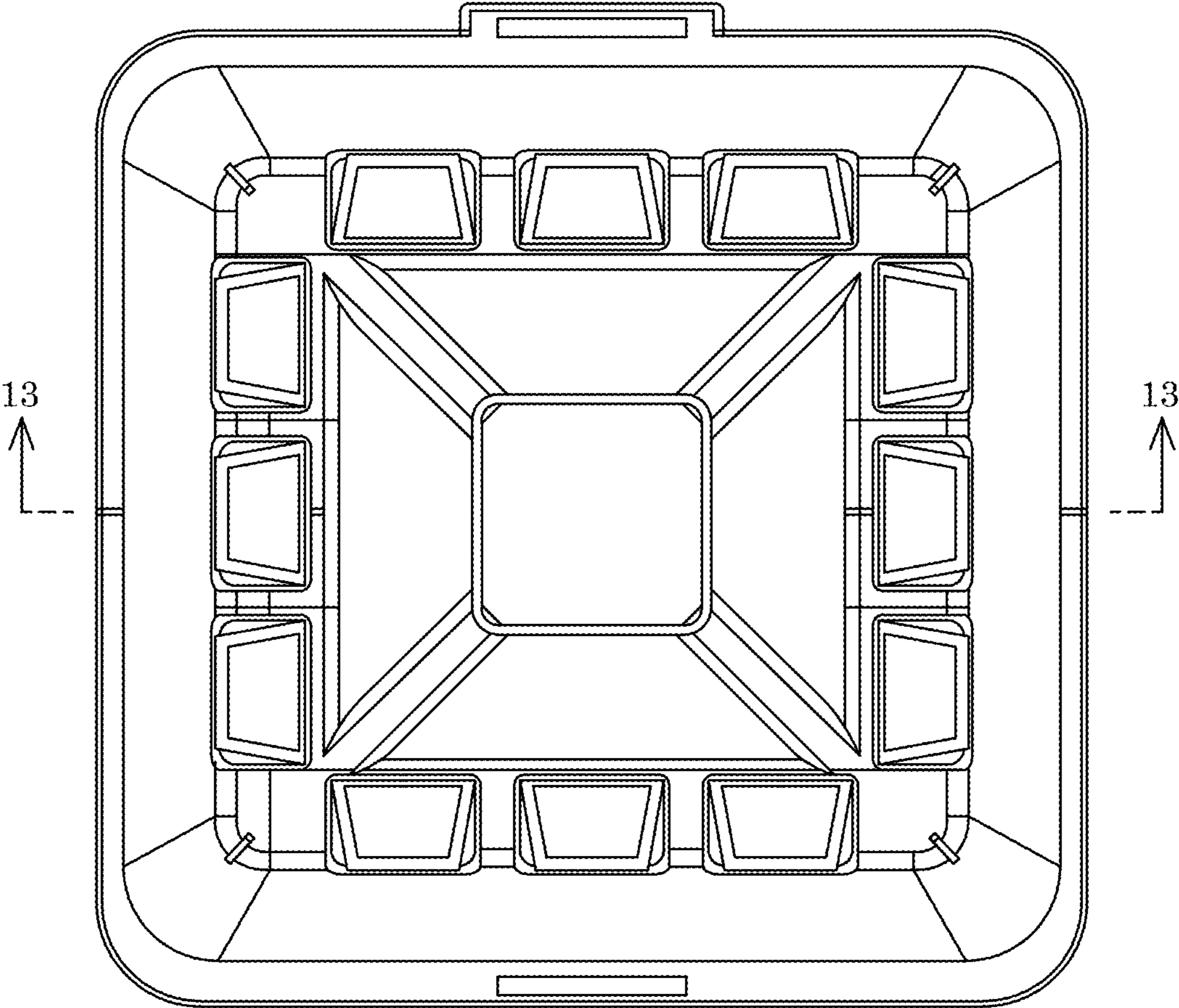

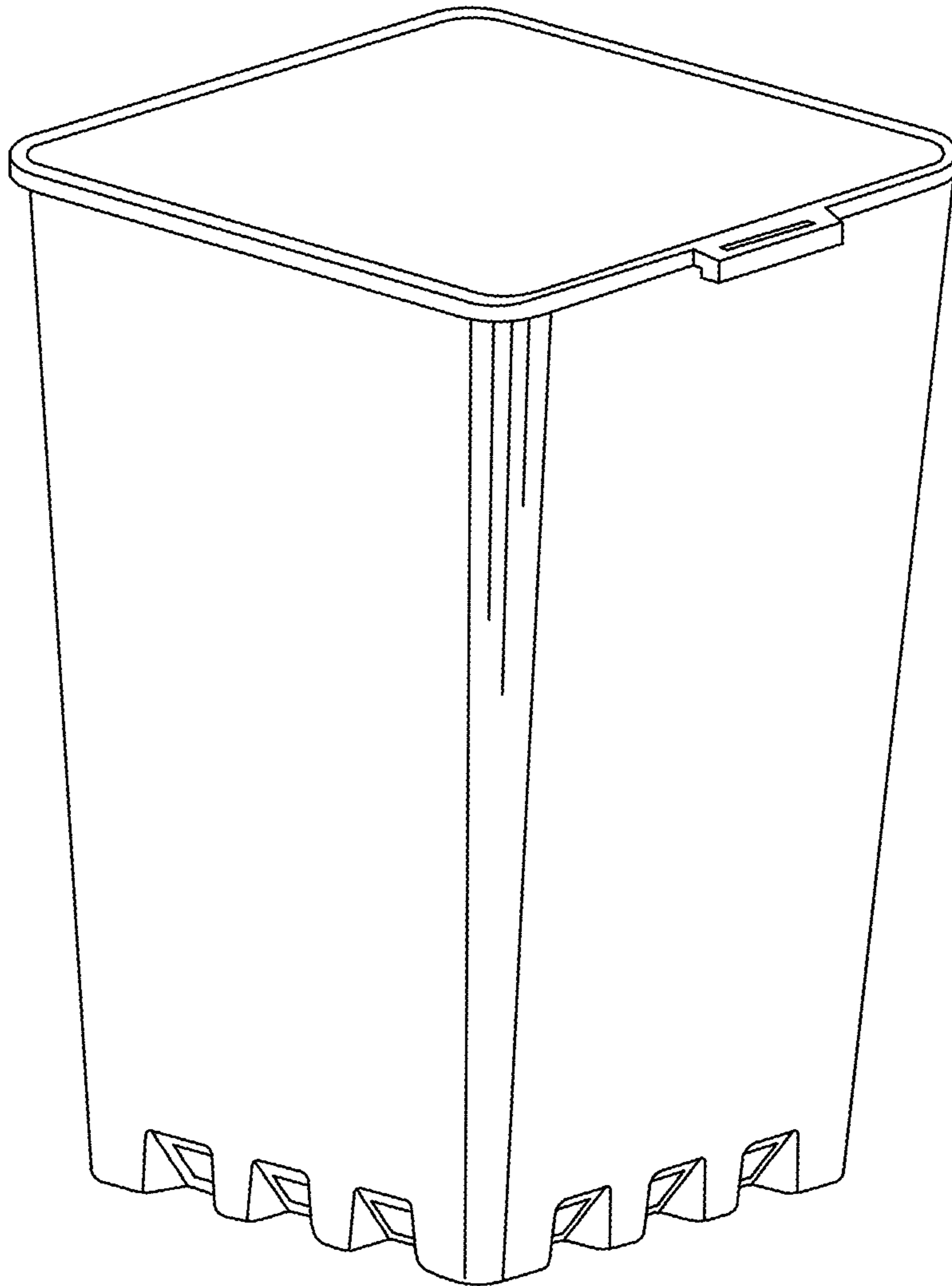

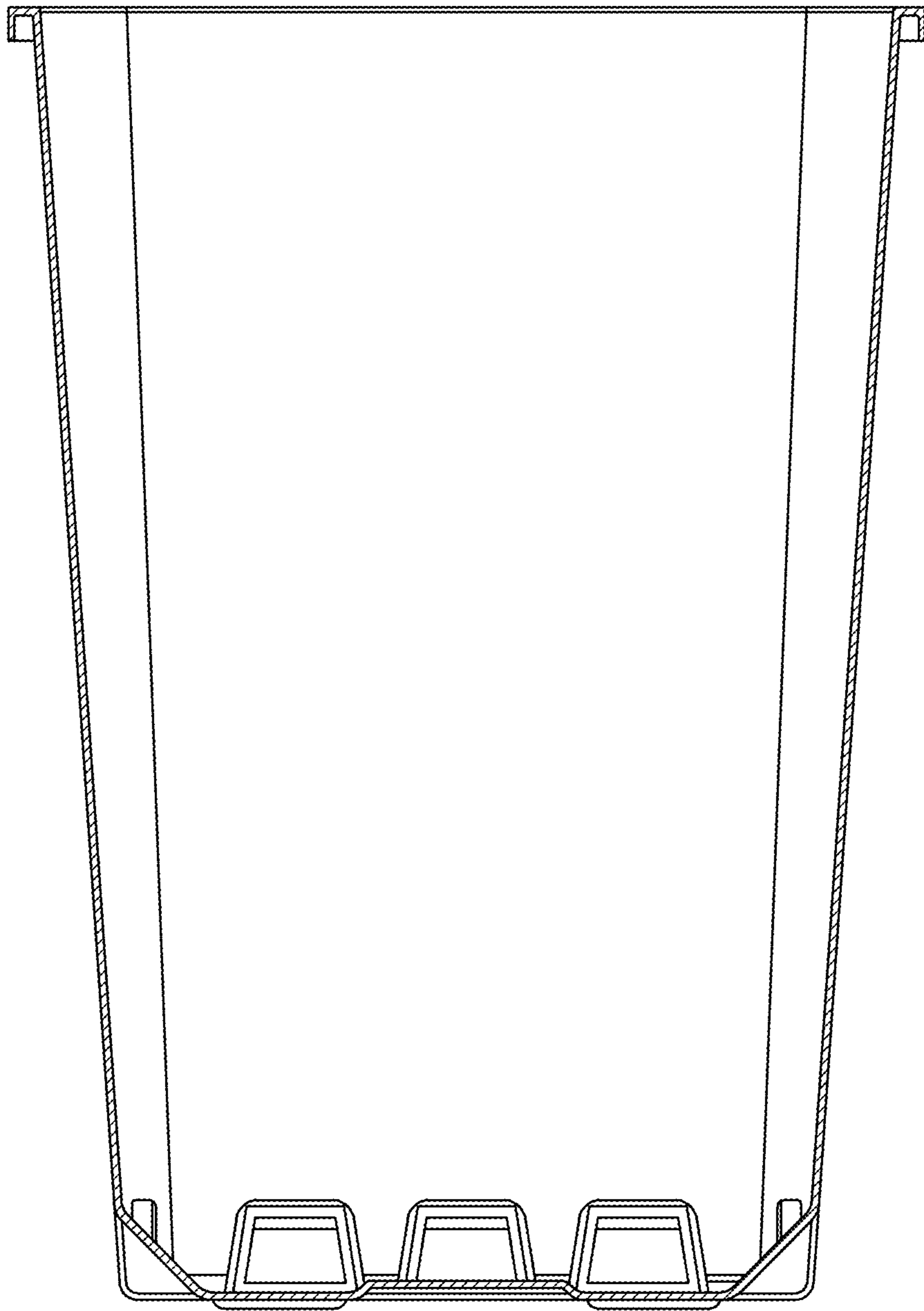

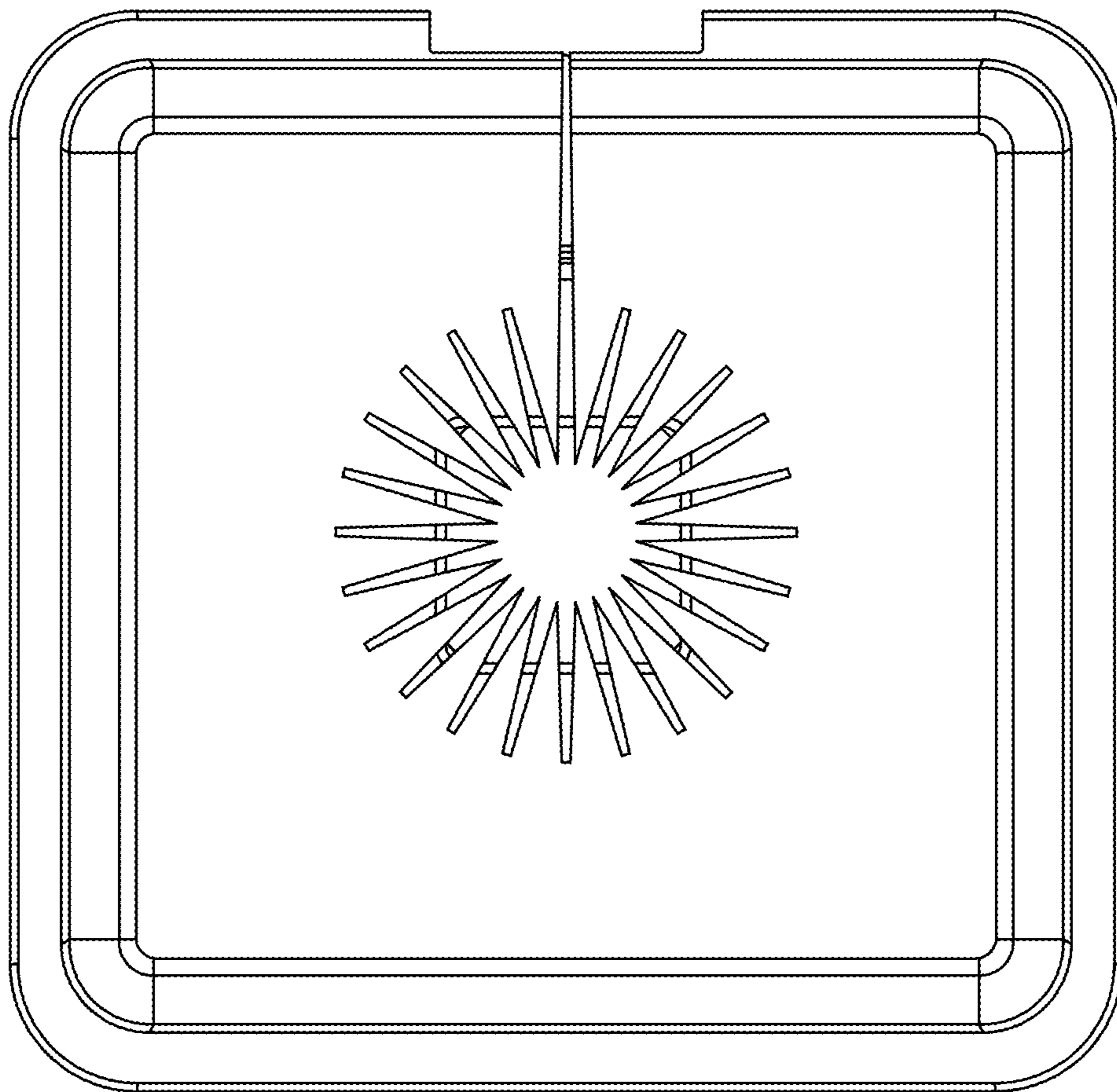

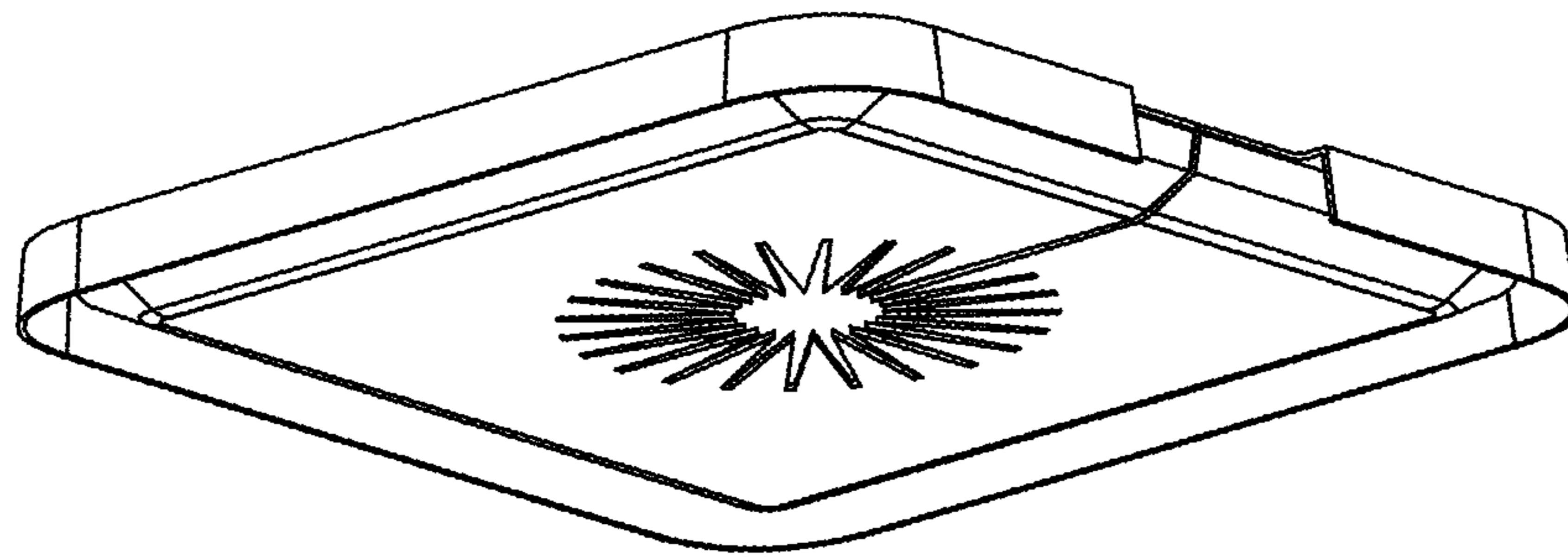

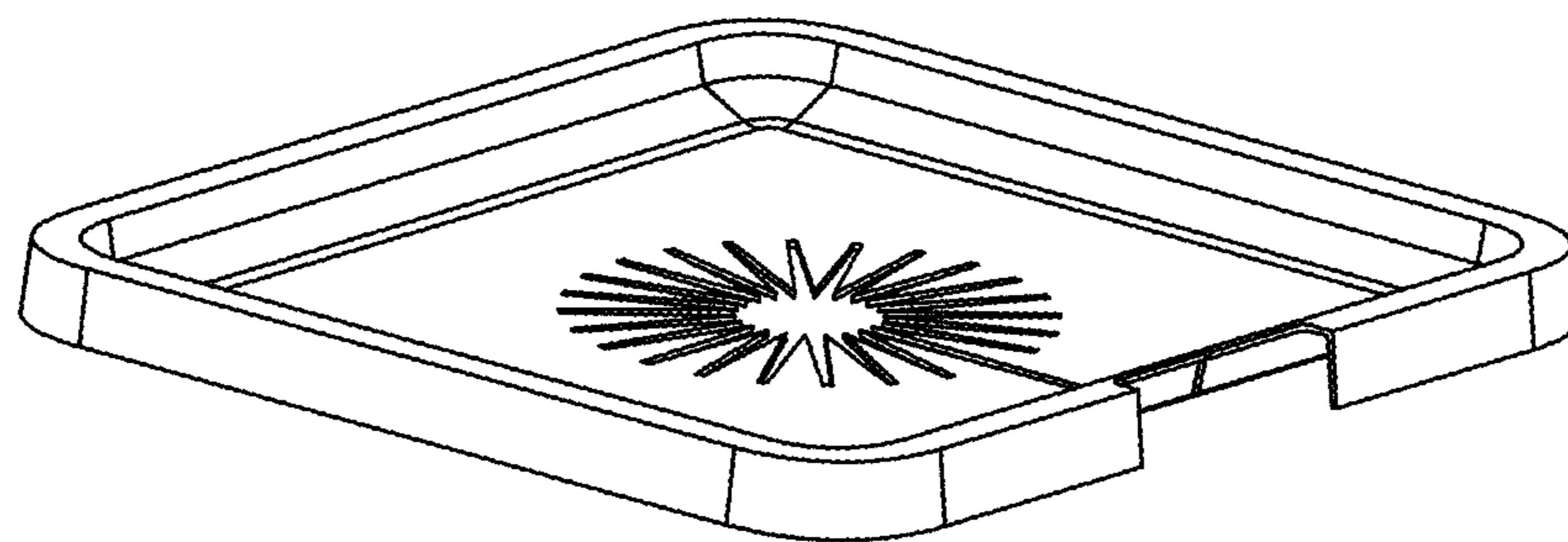

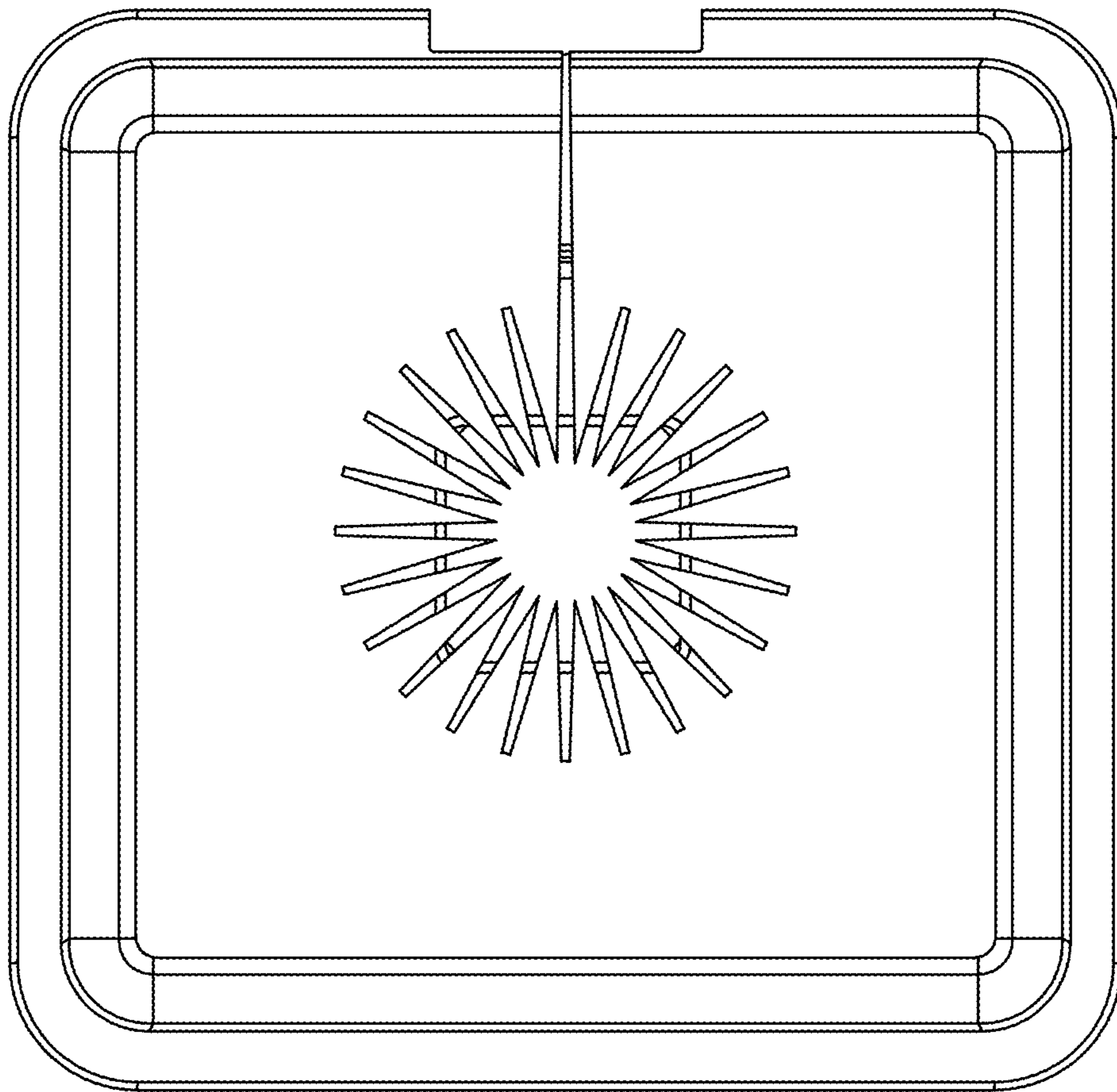
