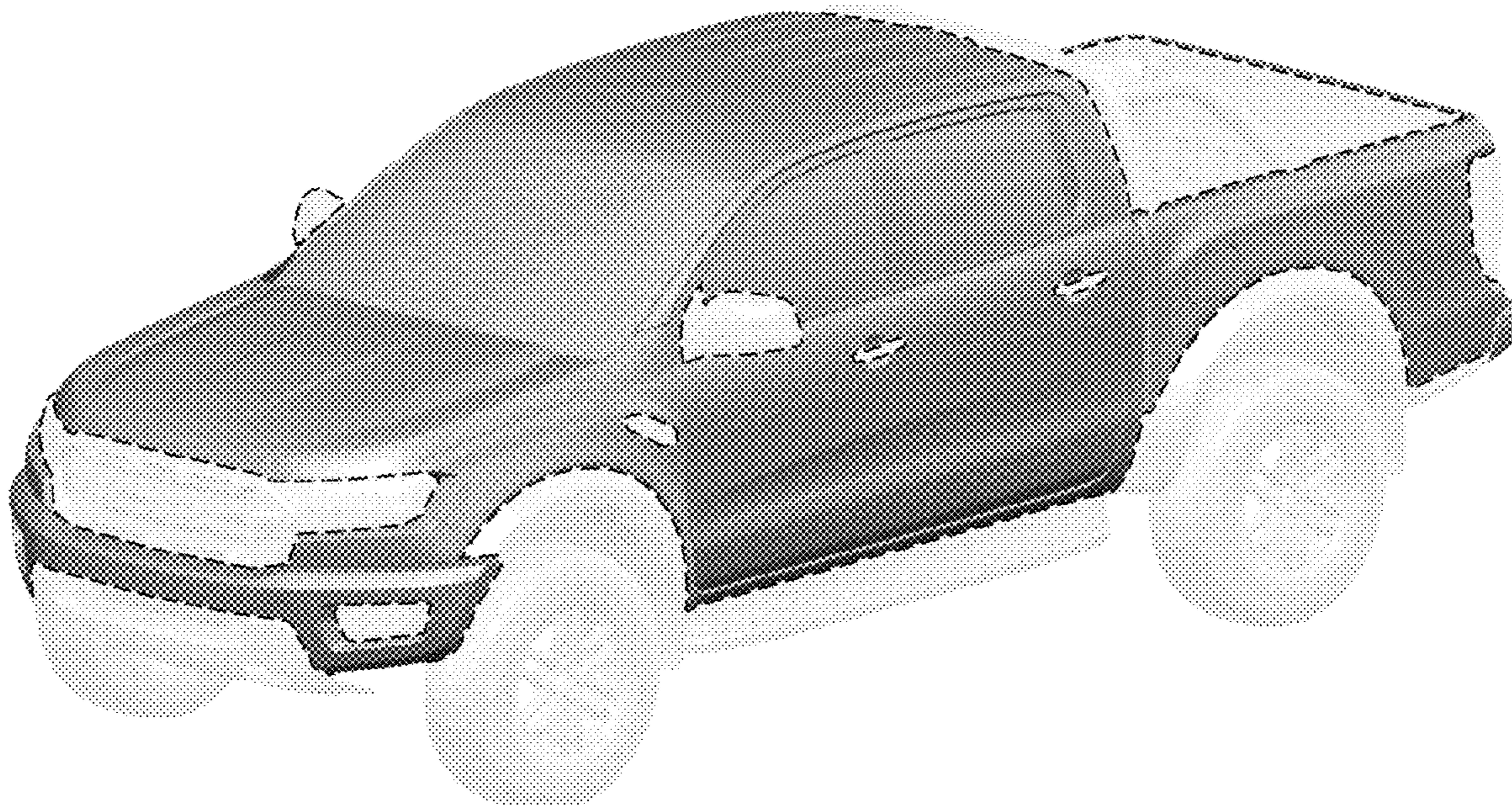
(57) **CLAIM**

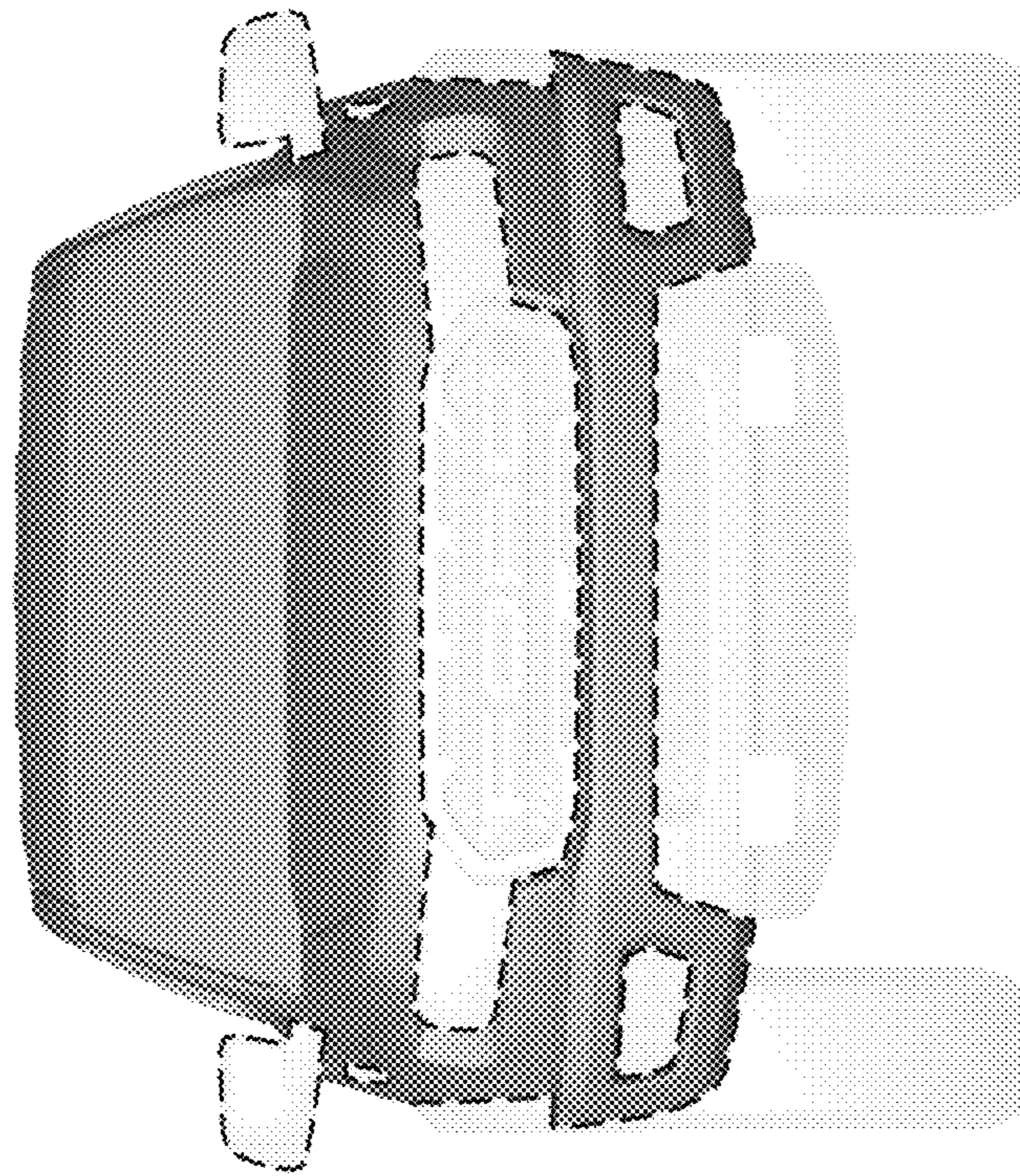
The ornamental design for a motor vehicle body, toy vehicle body replica and/or other replica, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a vehicle exterior motor vehicle body, toy vehicle body replica and/or other replica showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a top, front, and left side perspective view thereof; and,

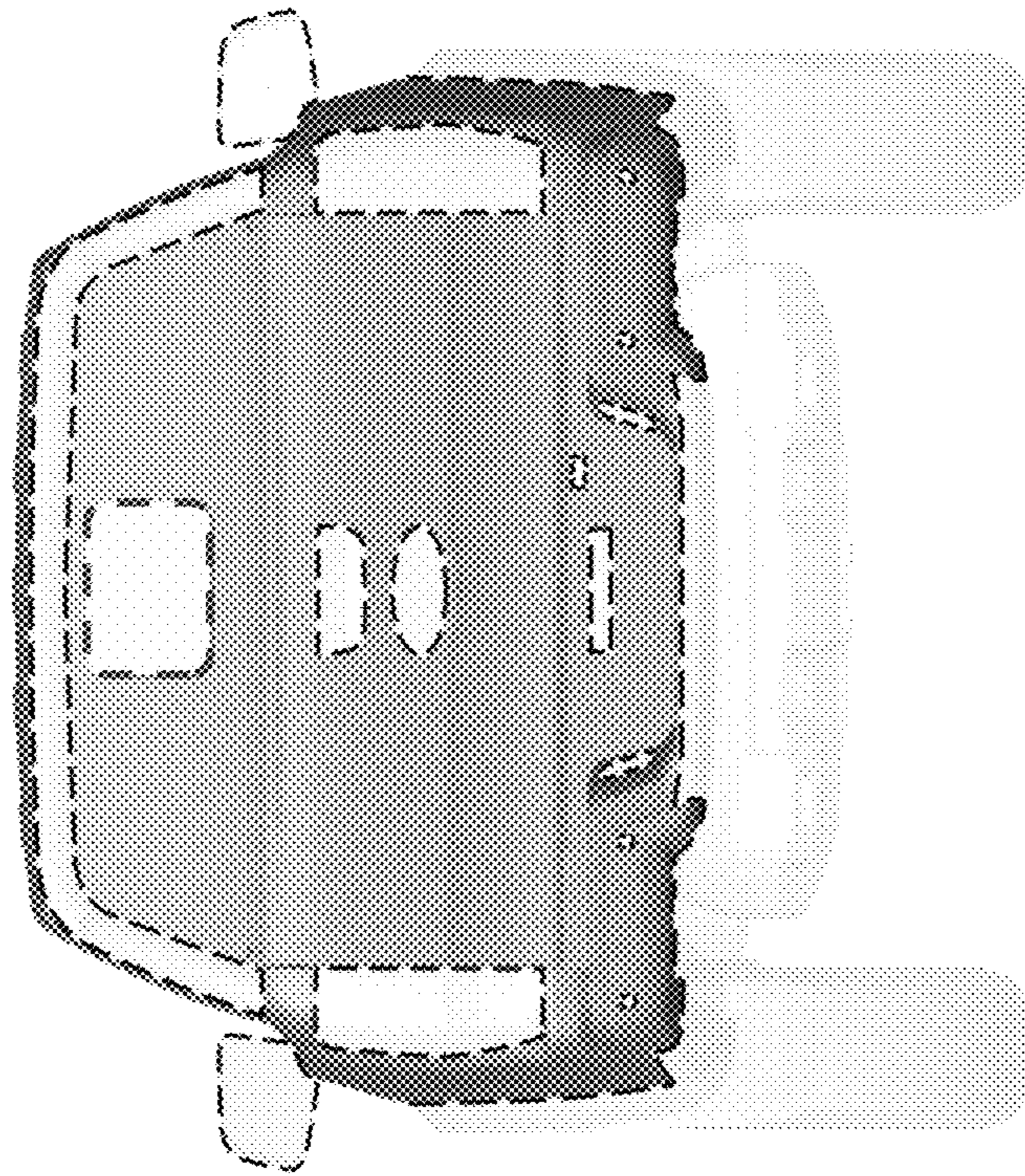

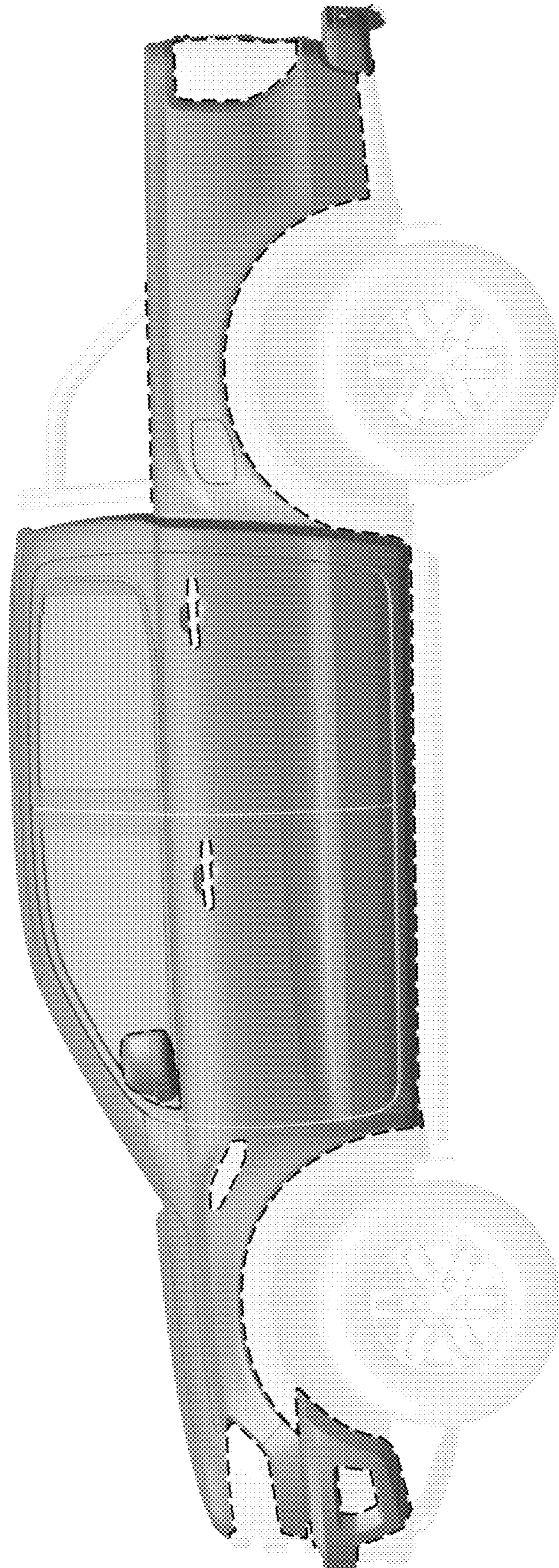

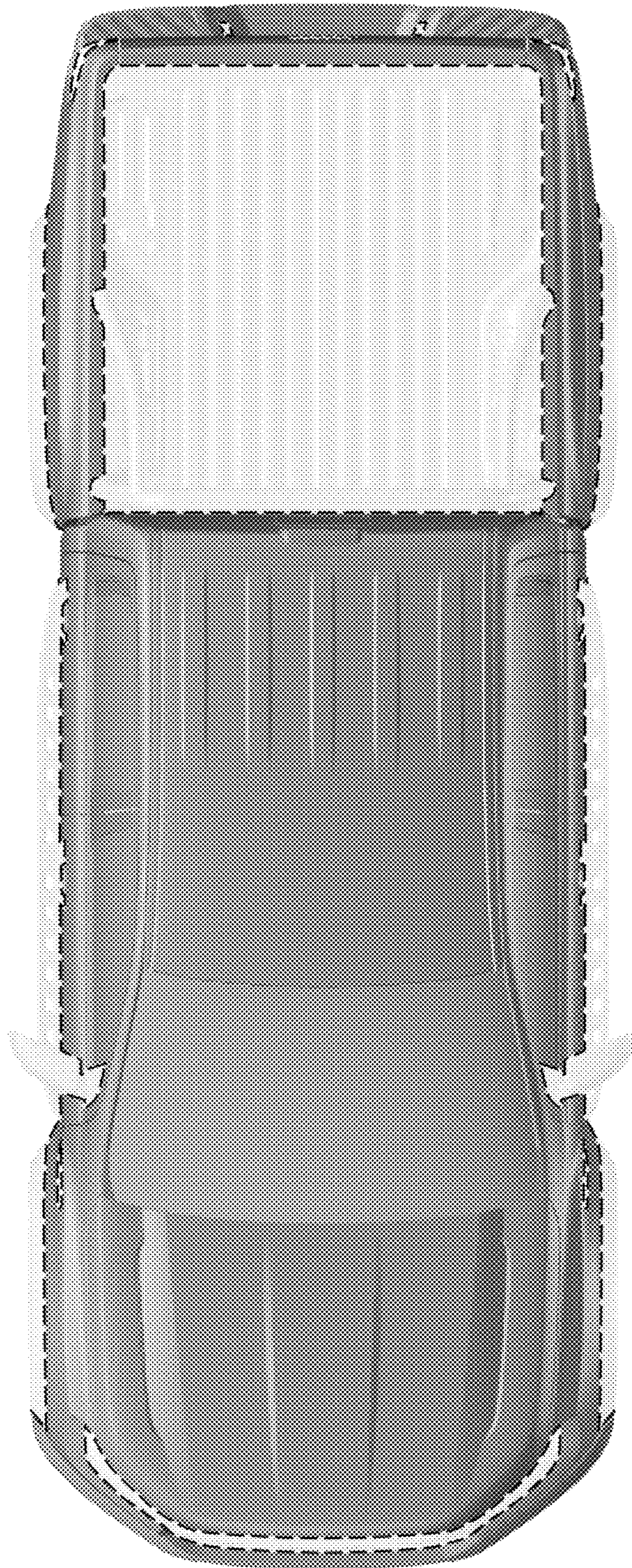
