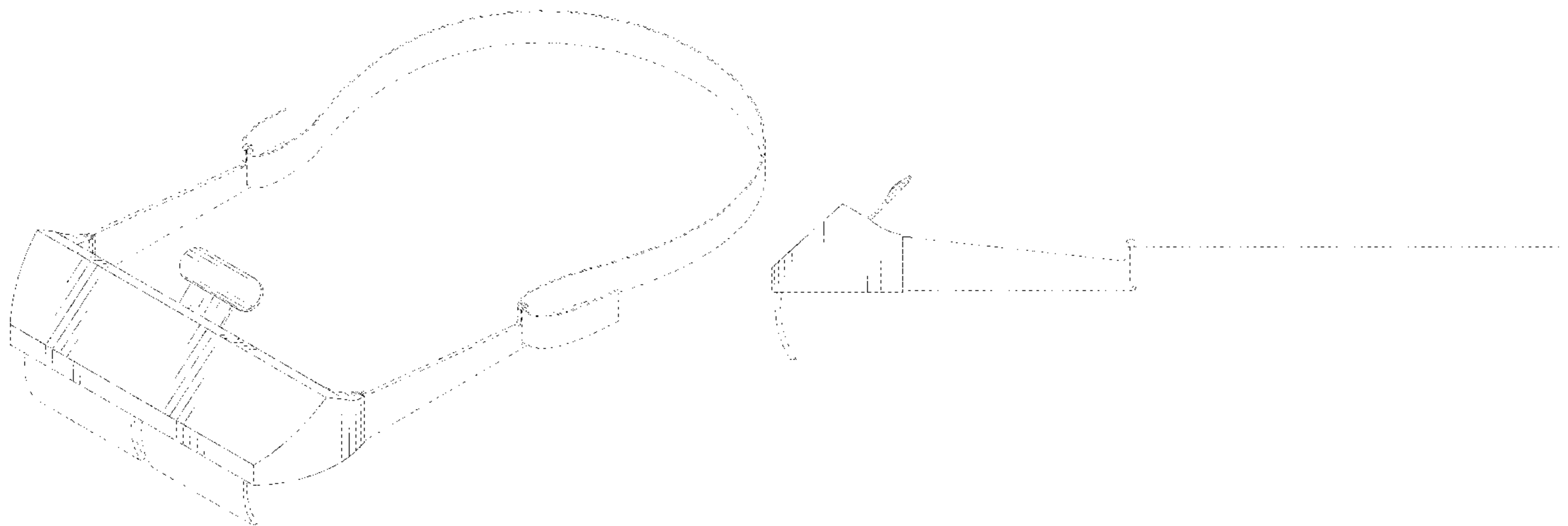
(57) **CLAIM**

The ornamental design for a near eye display, as shown and described.

**DESCRIPTION**

FIG. 1 is a front top right perspective view of a near eye display;  
FIG. 2 is a rear left bottom perspective view thereof;  
FIG. 3 is a rear right bottom perspective view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a top plan view thereof;

FIG. 9 is a left elevational view thereof.

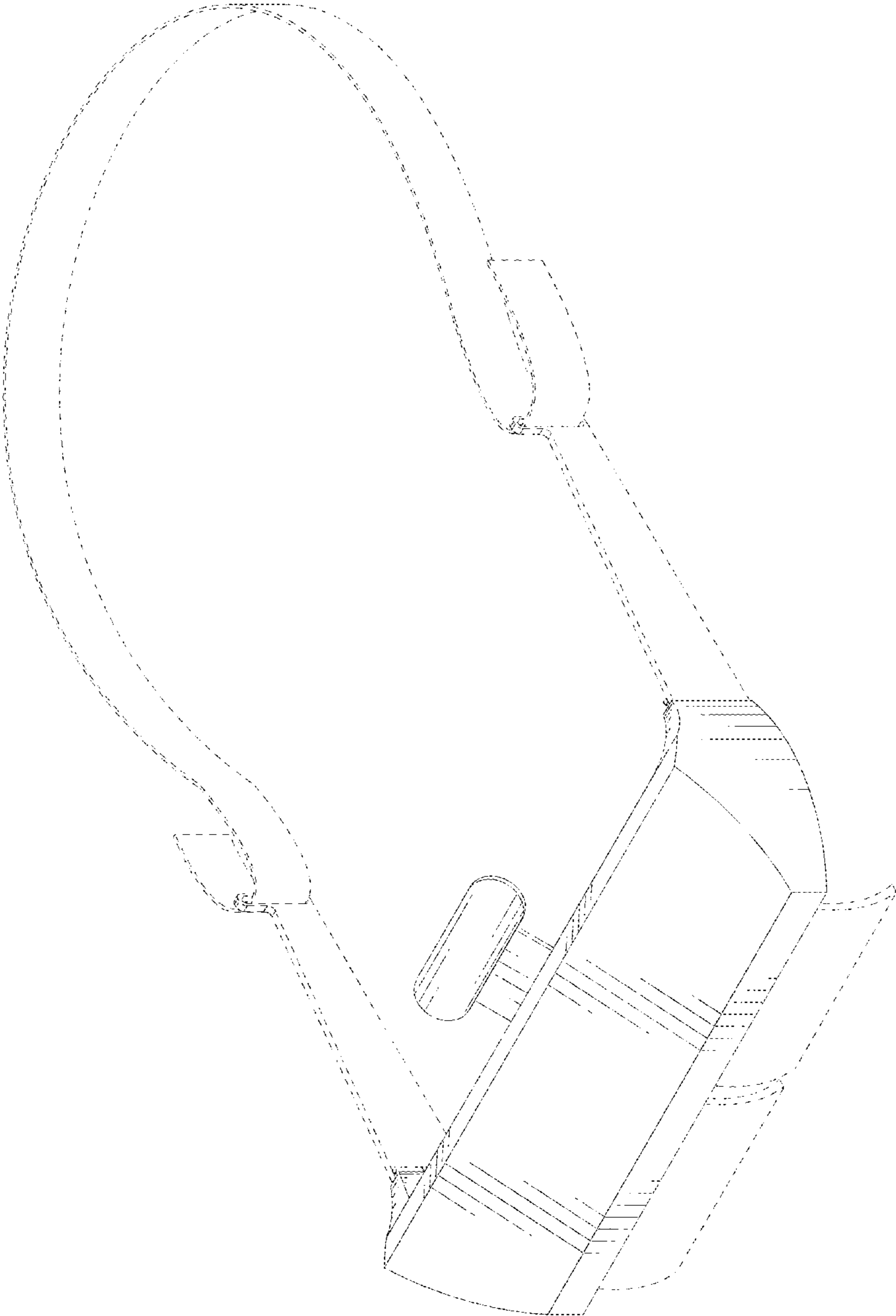

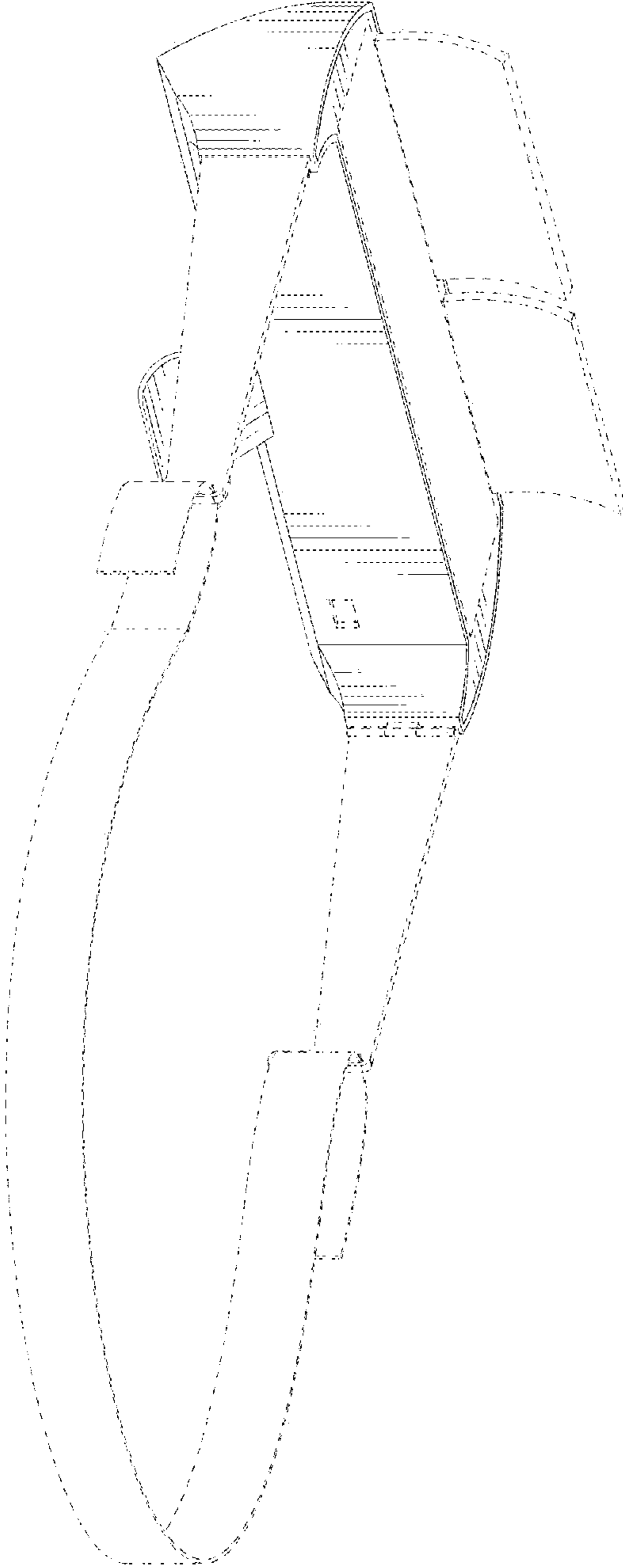

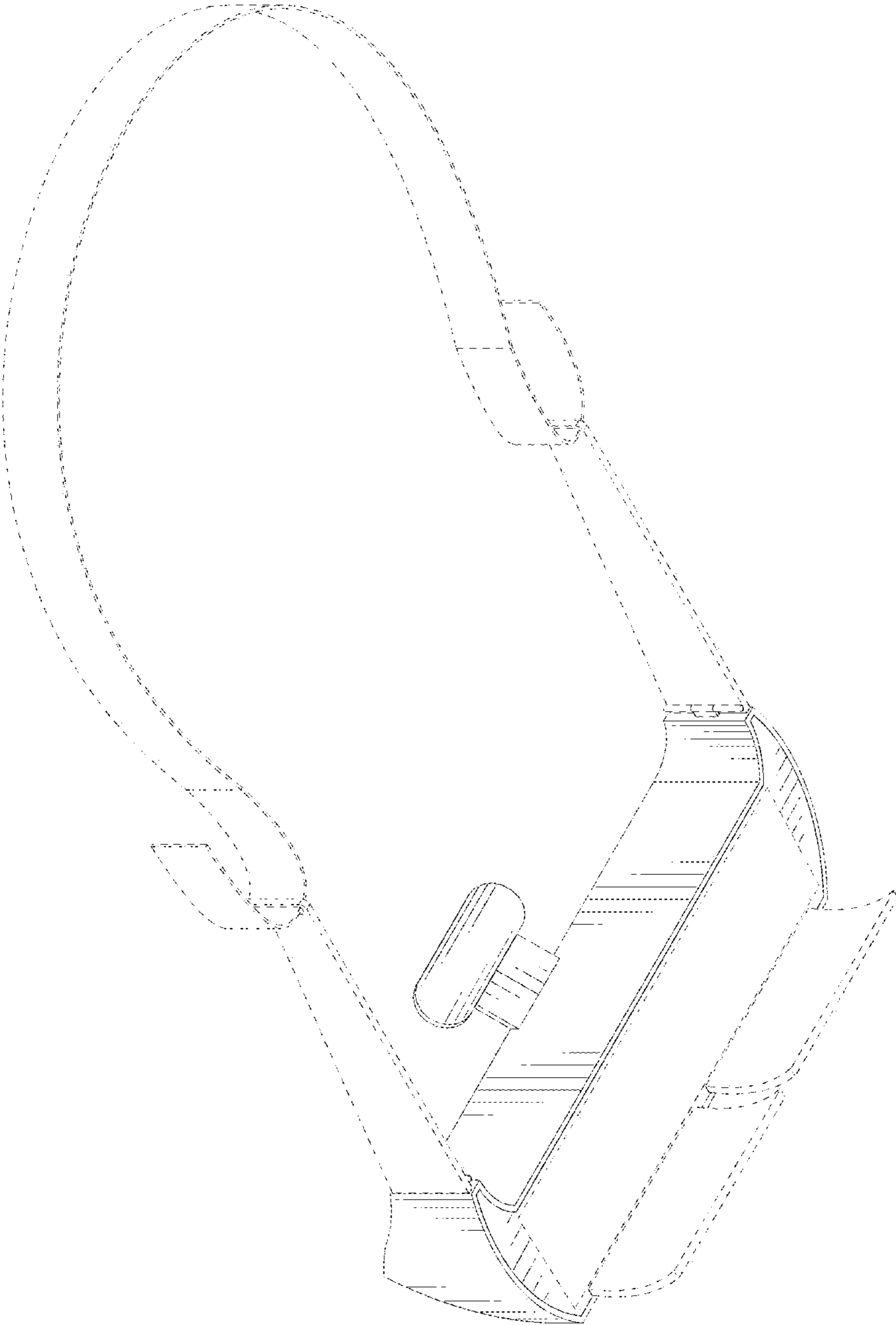

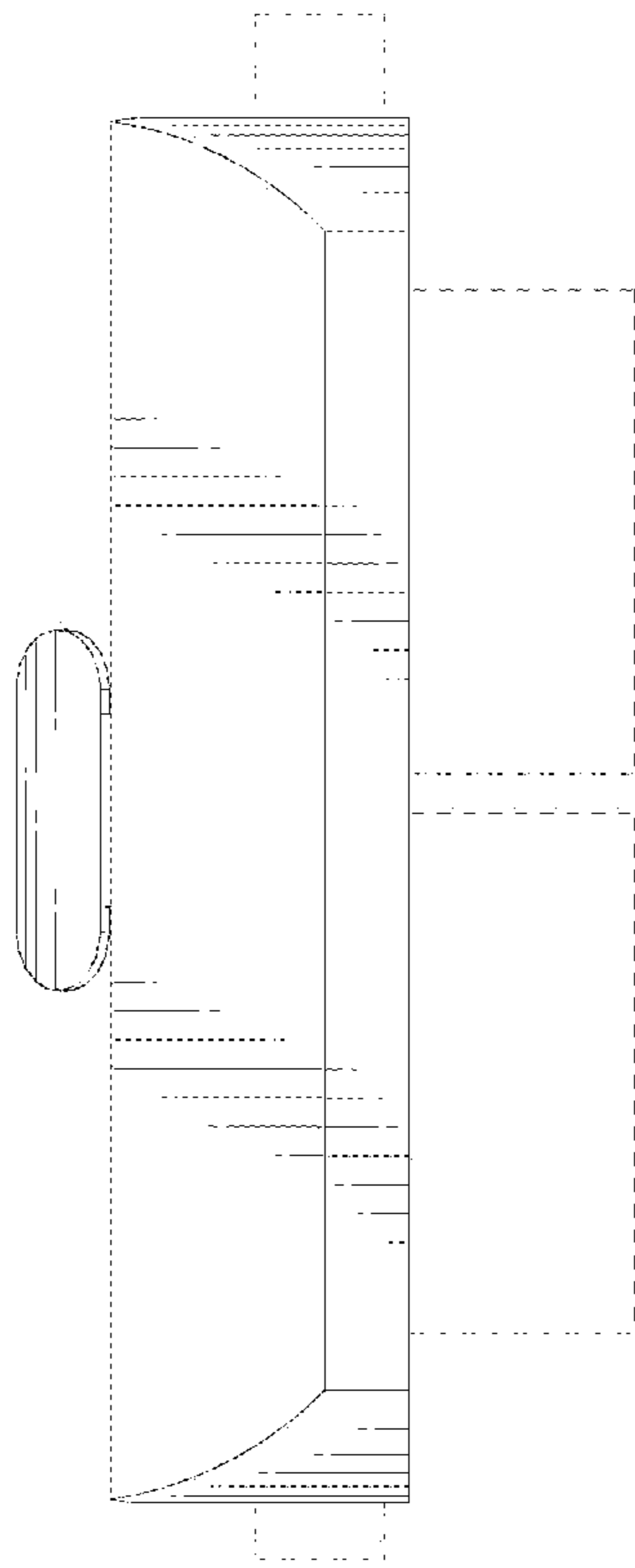

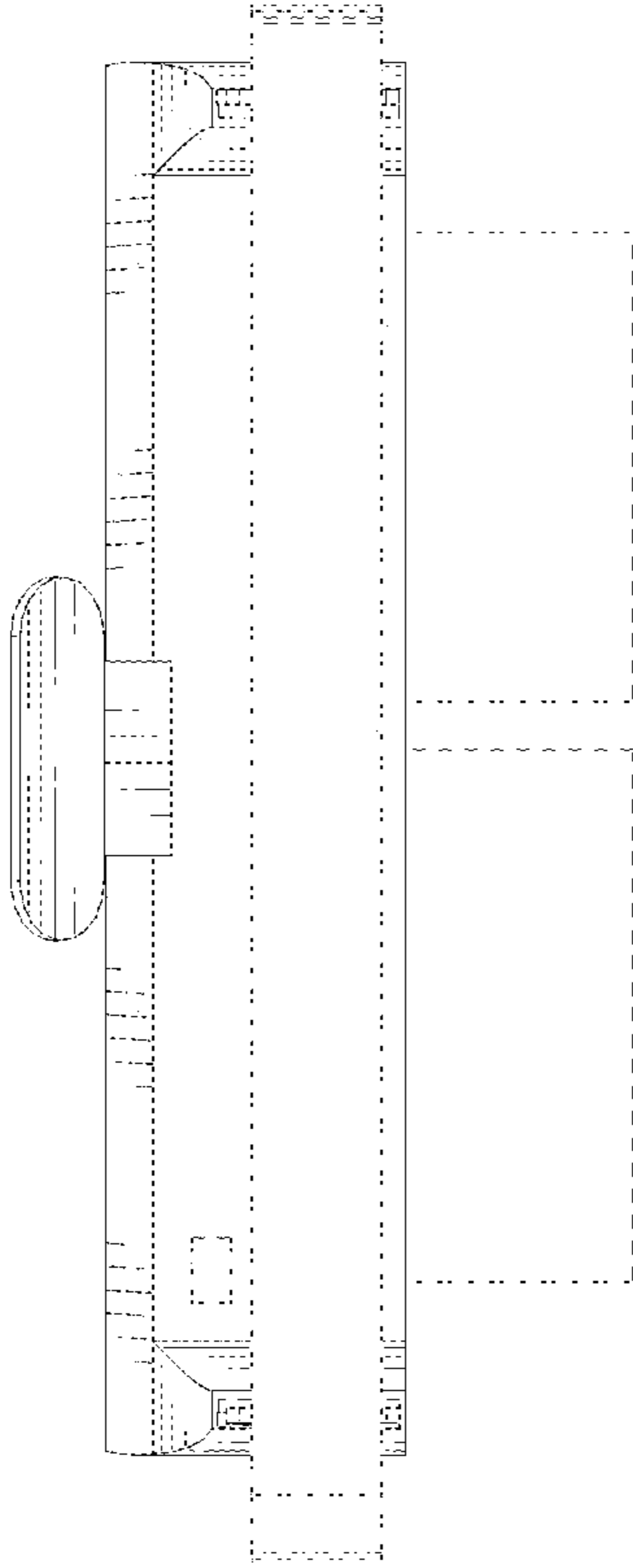

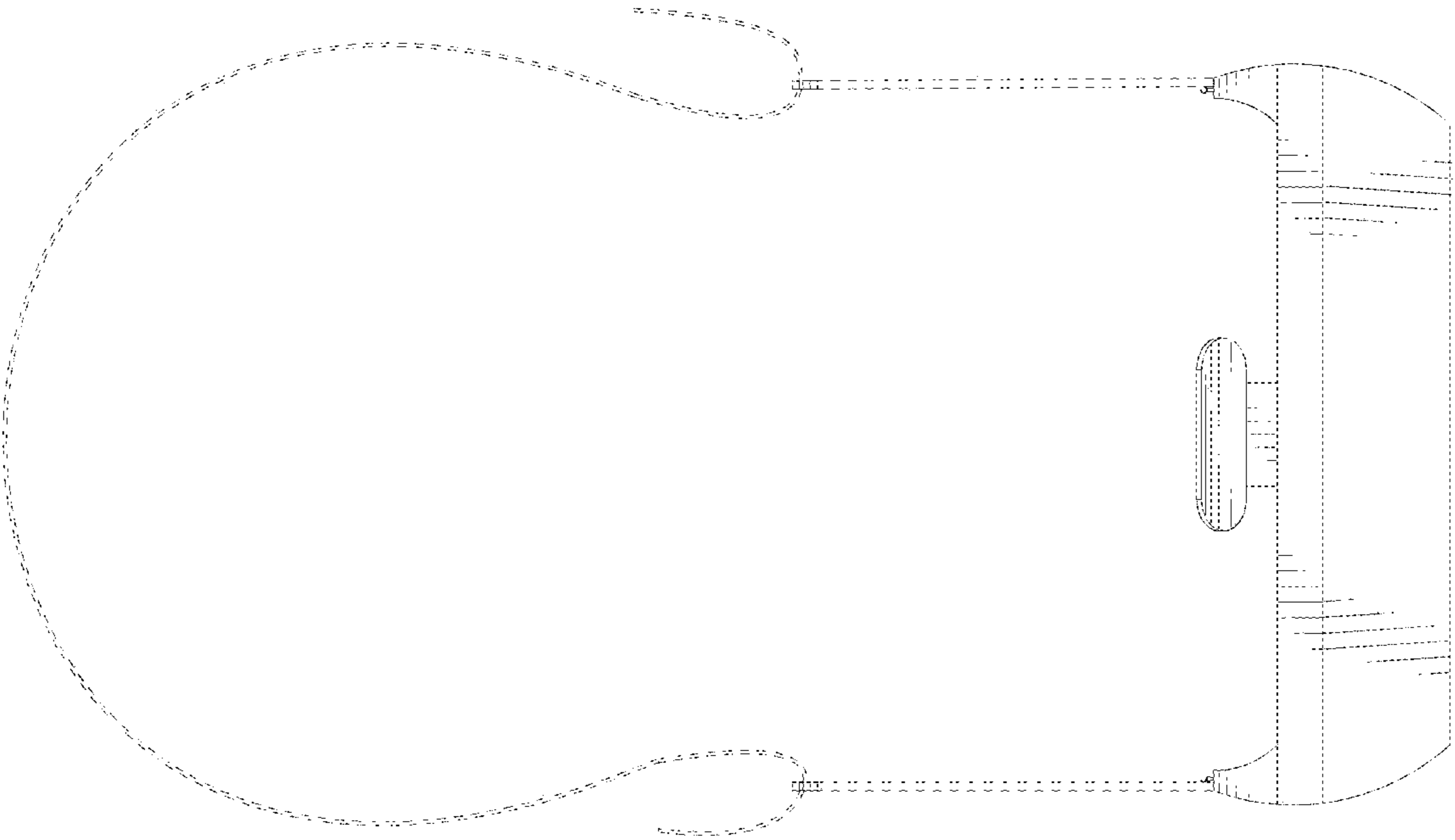

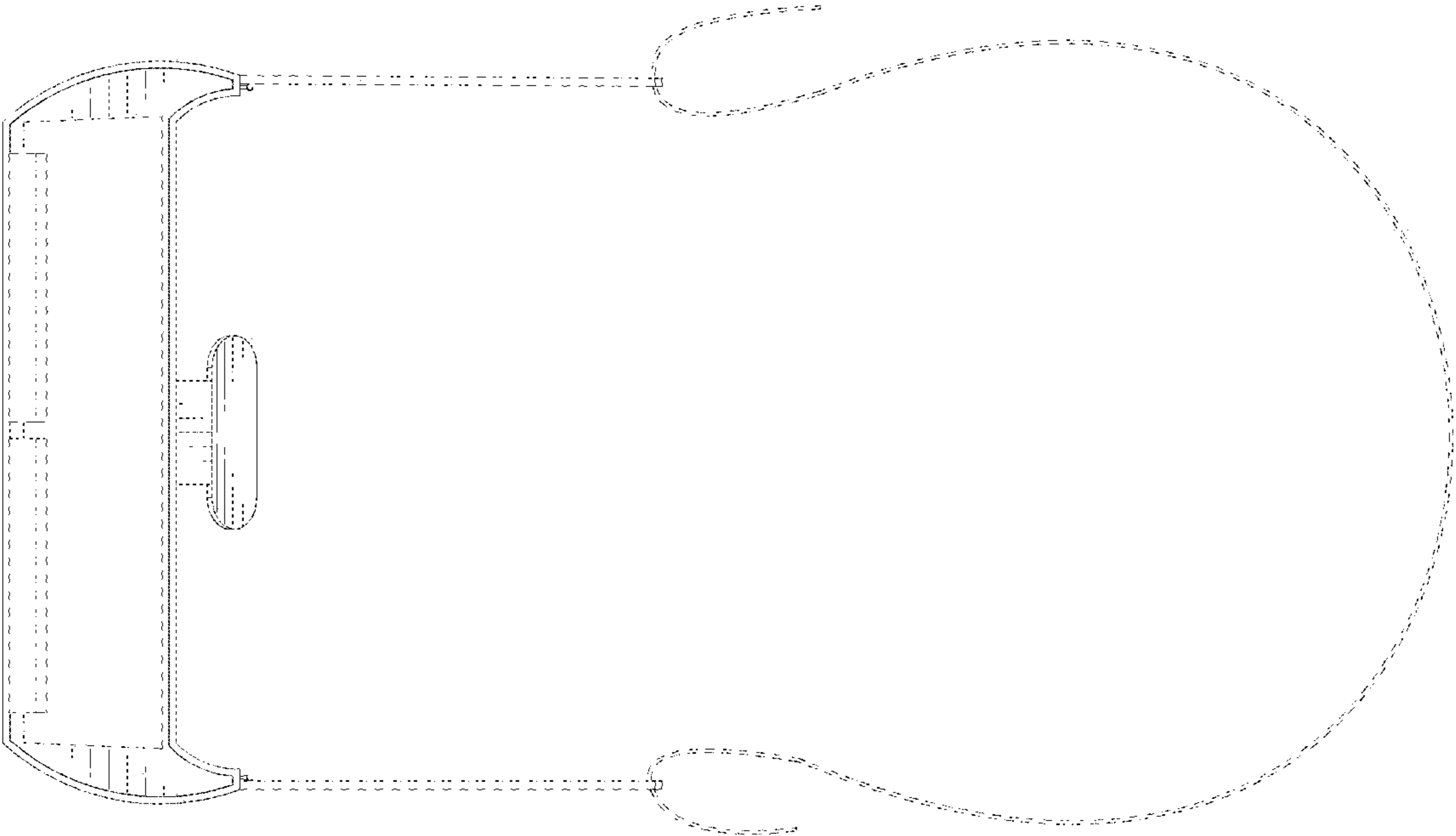

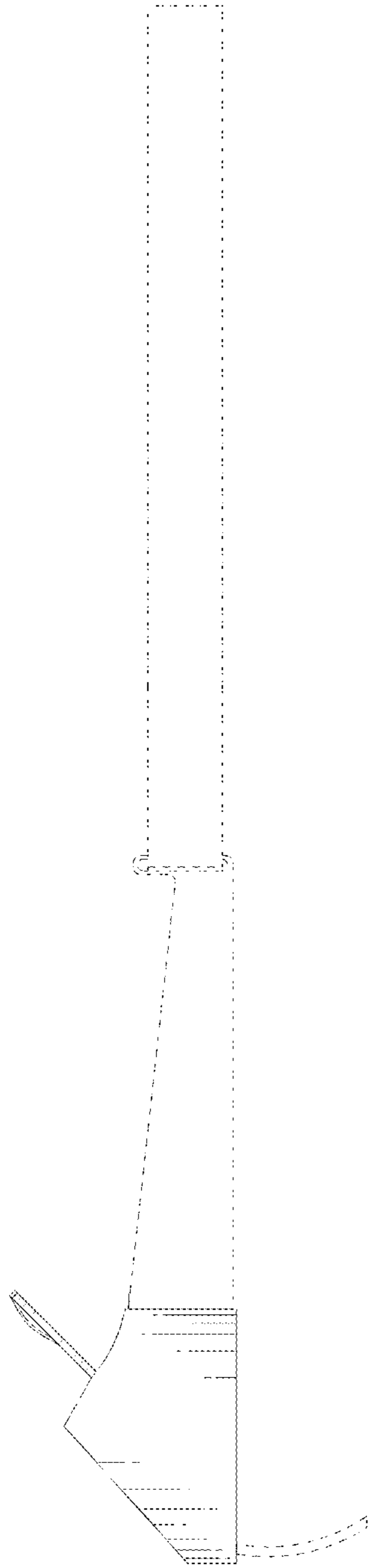

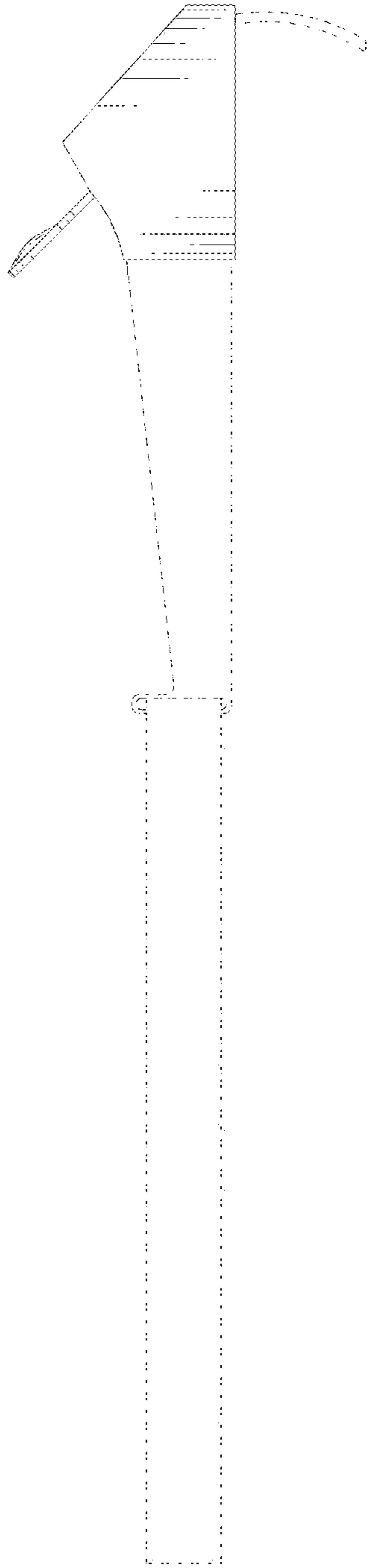
