DESCRIPTION

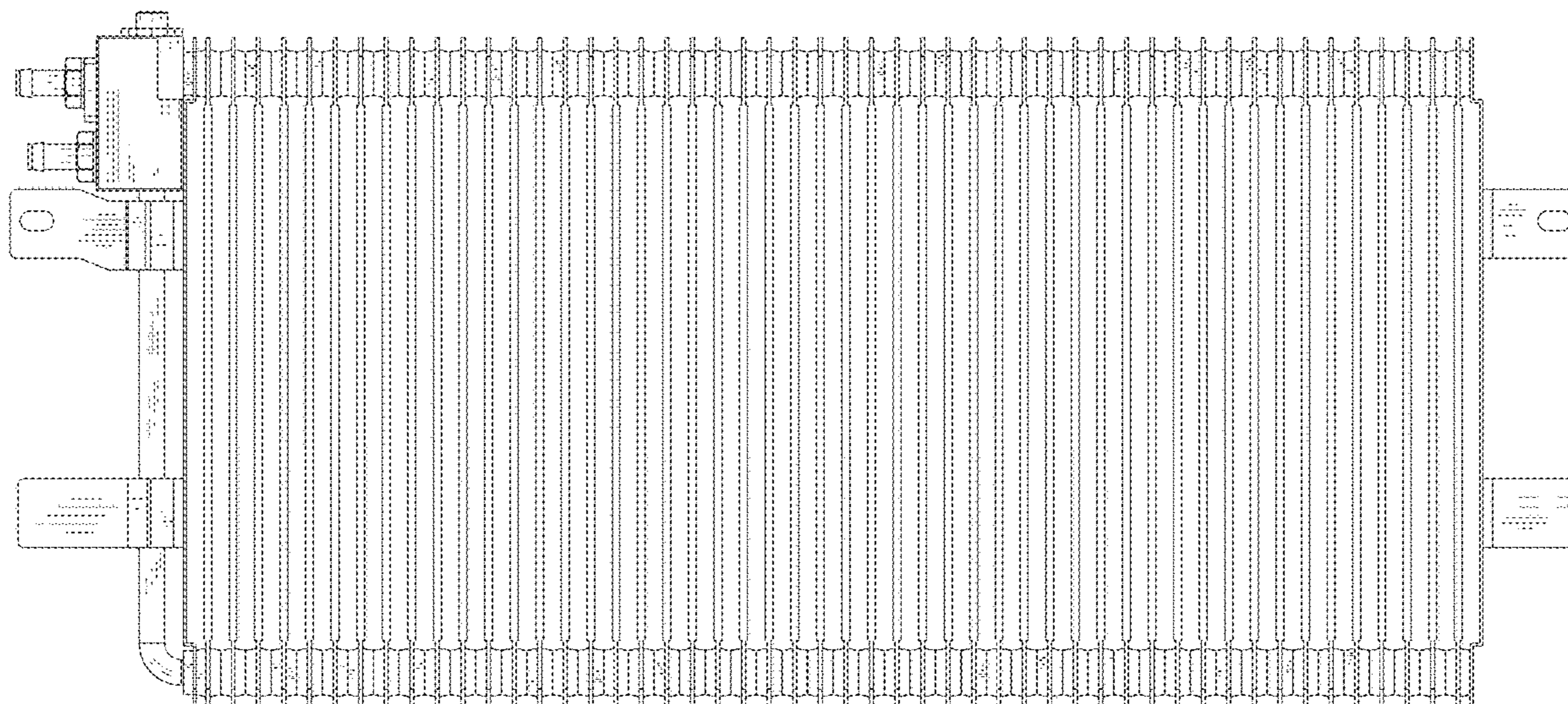
FIG. 1 is a front view of a transmission cooler for automotive applications showing our new design;

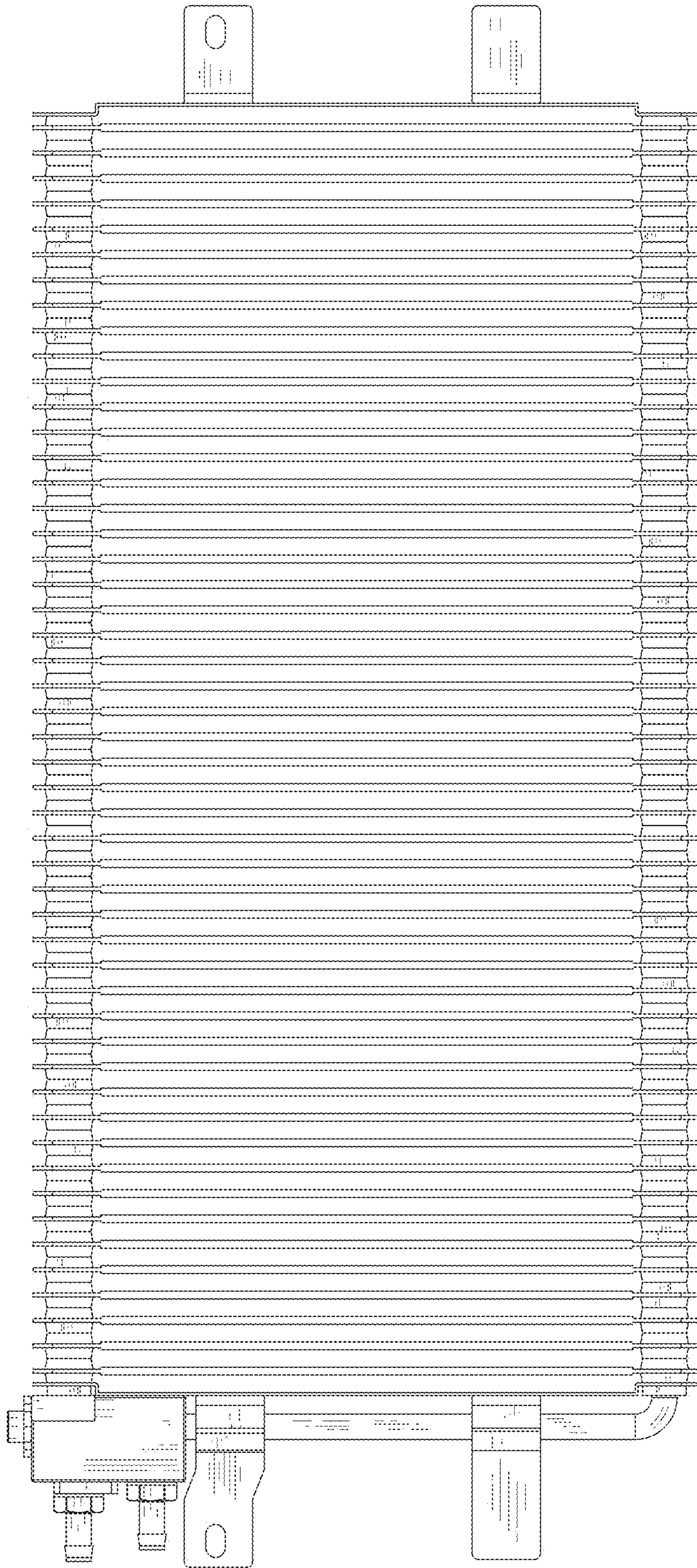

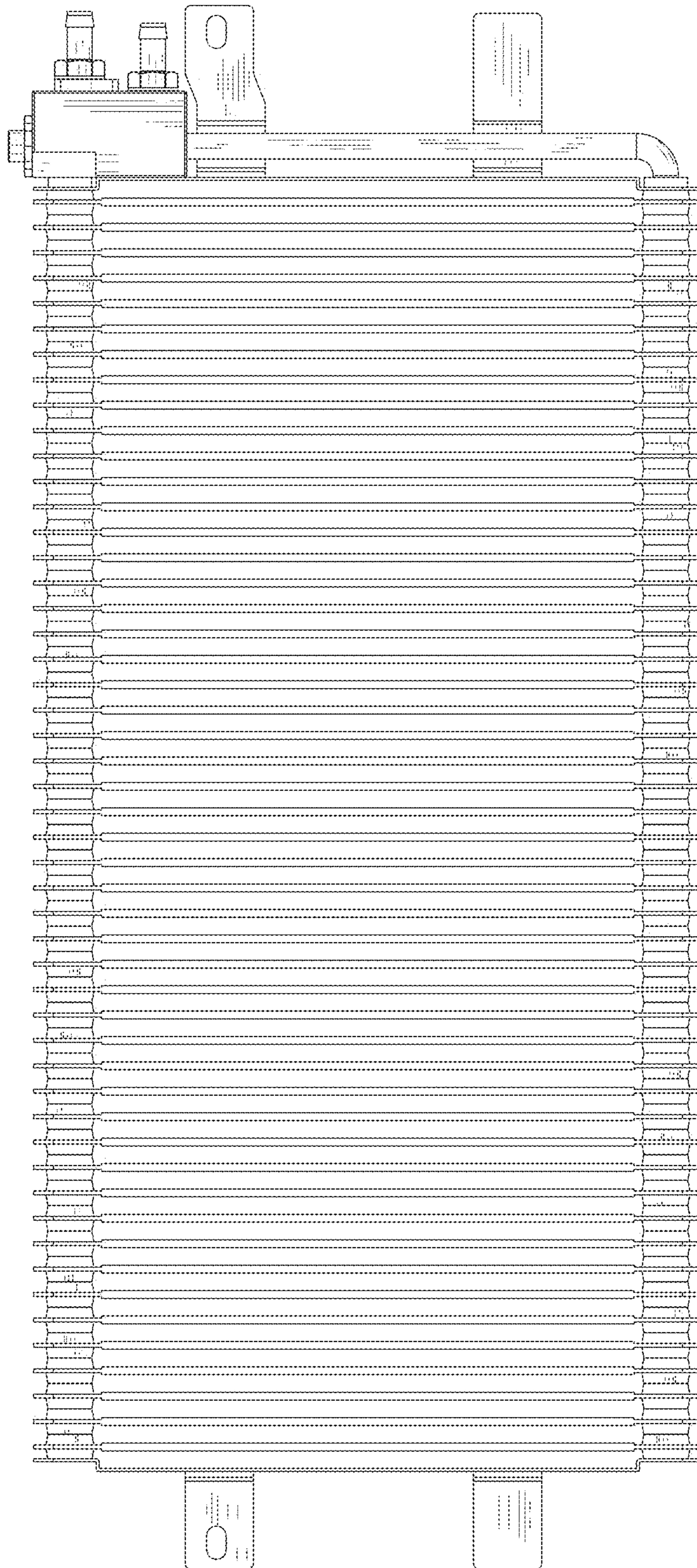

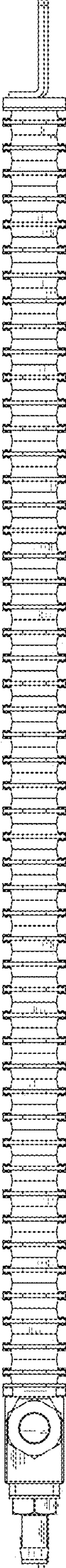

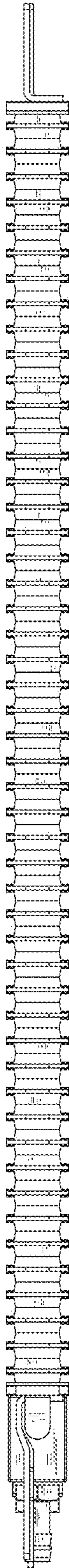

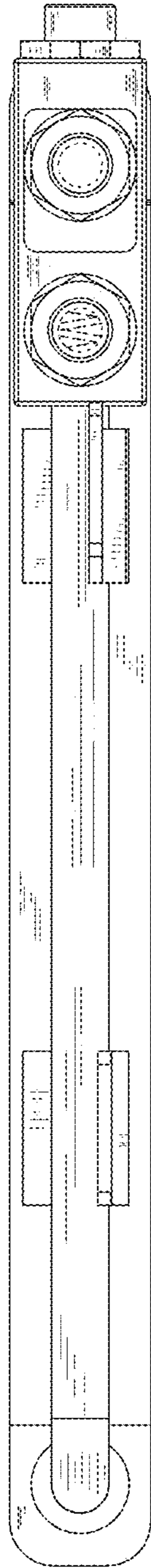

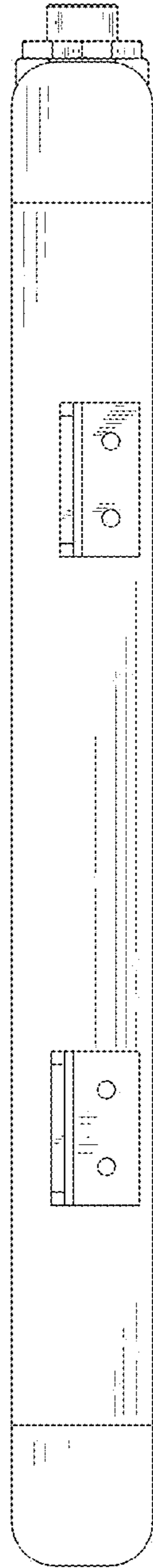

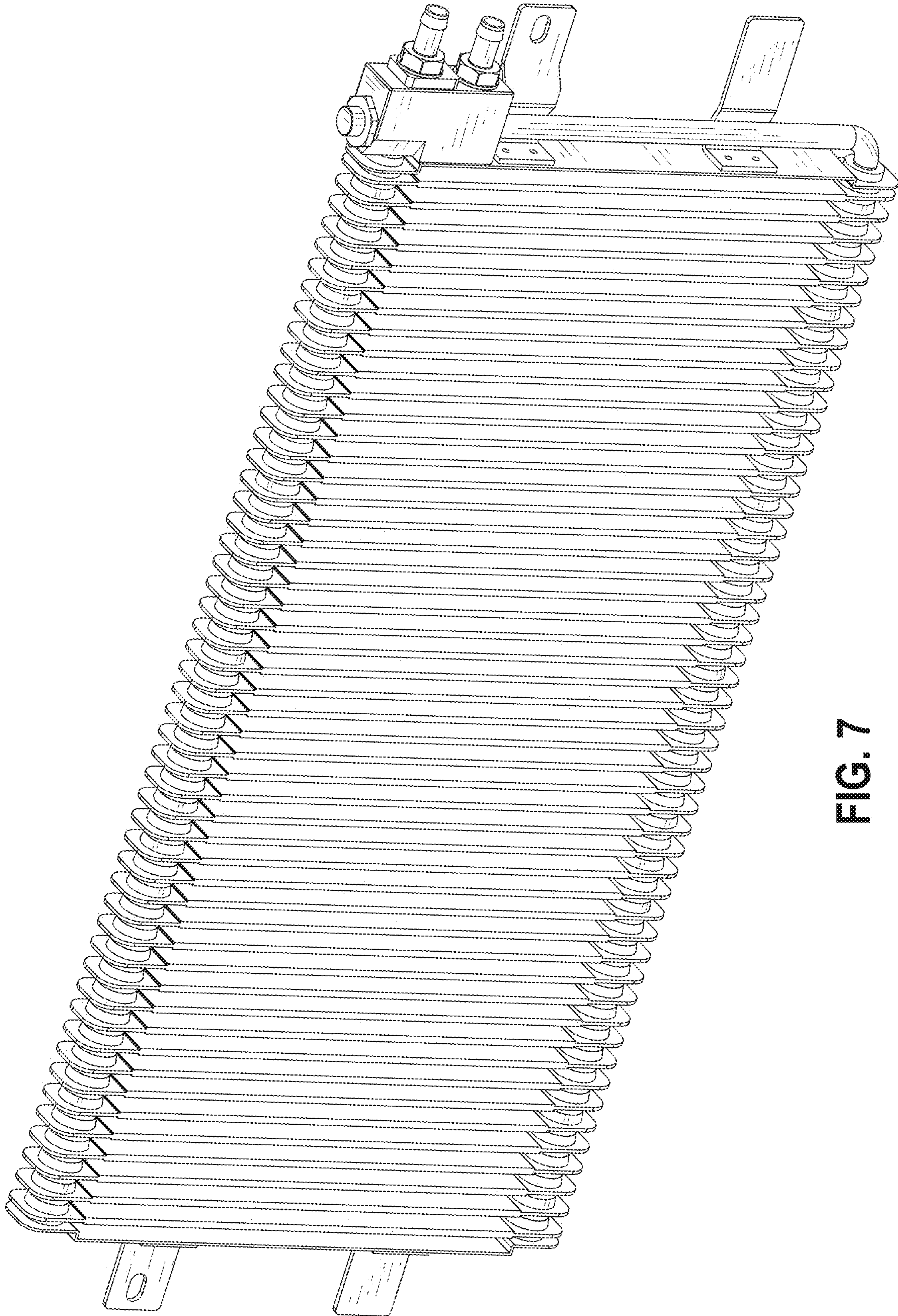

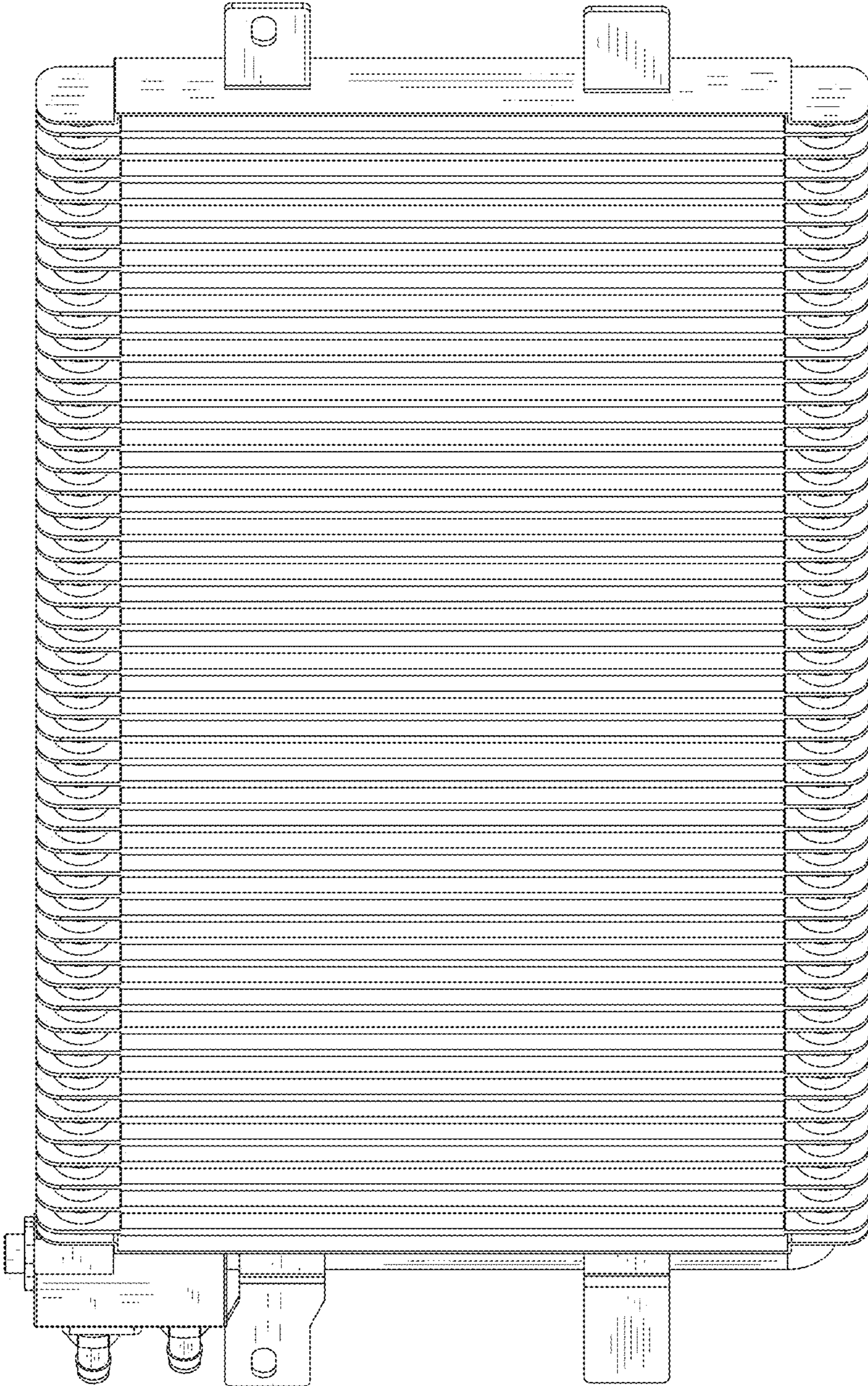
