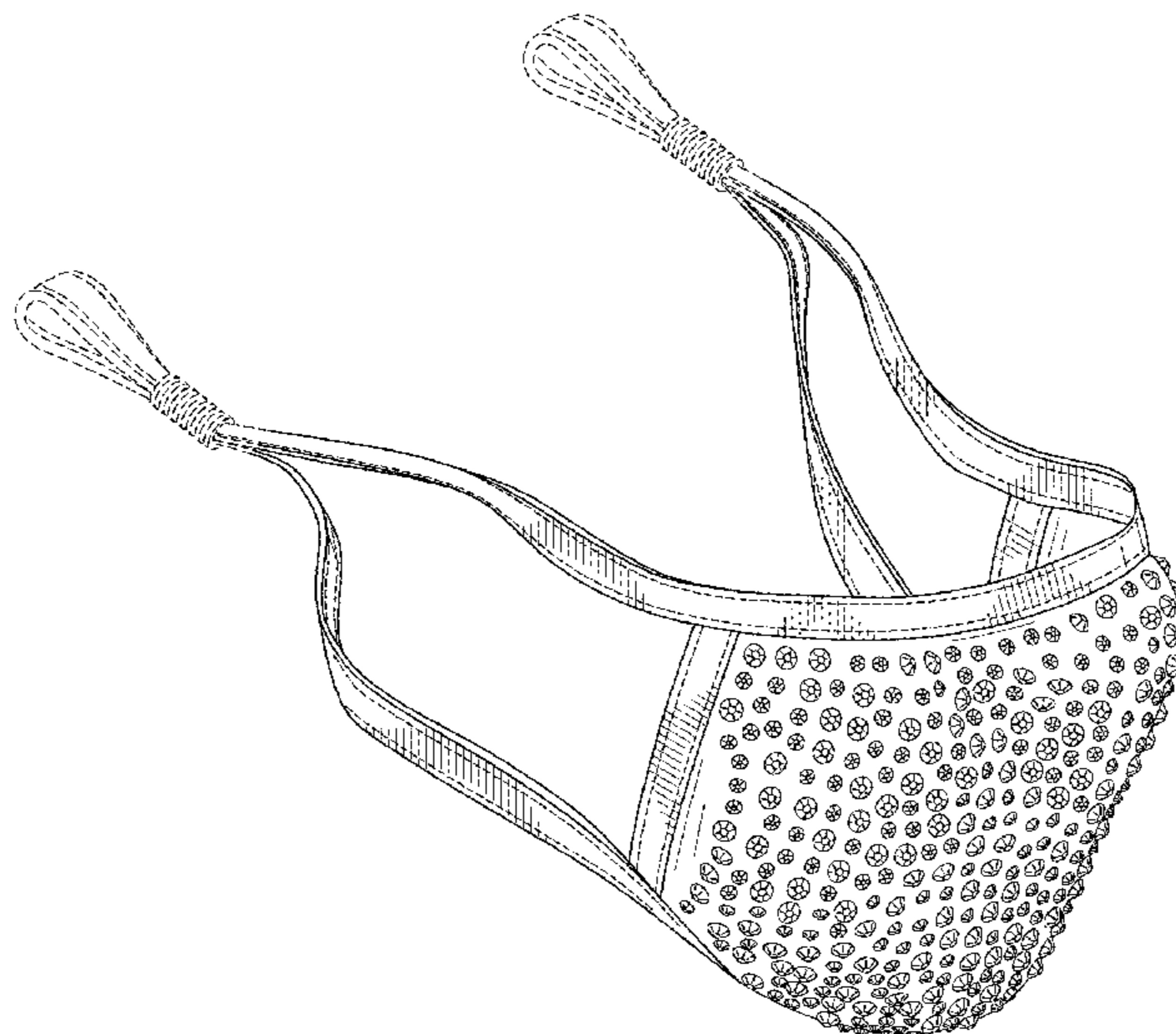
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a mask showing my new design;  
FIG. 2 is a front view of the mask;  
FIG. 3 is a right view of the mask;  
FIG. 4 is a left side view of the mask;  
FIG. 5 is a top view of the mask;  
FIG. 6 is a rear view of the mask; and,  
FIG. 7 is a bottom side view of the mask.

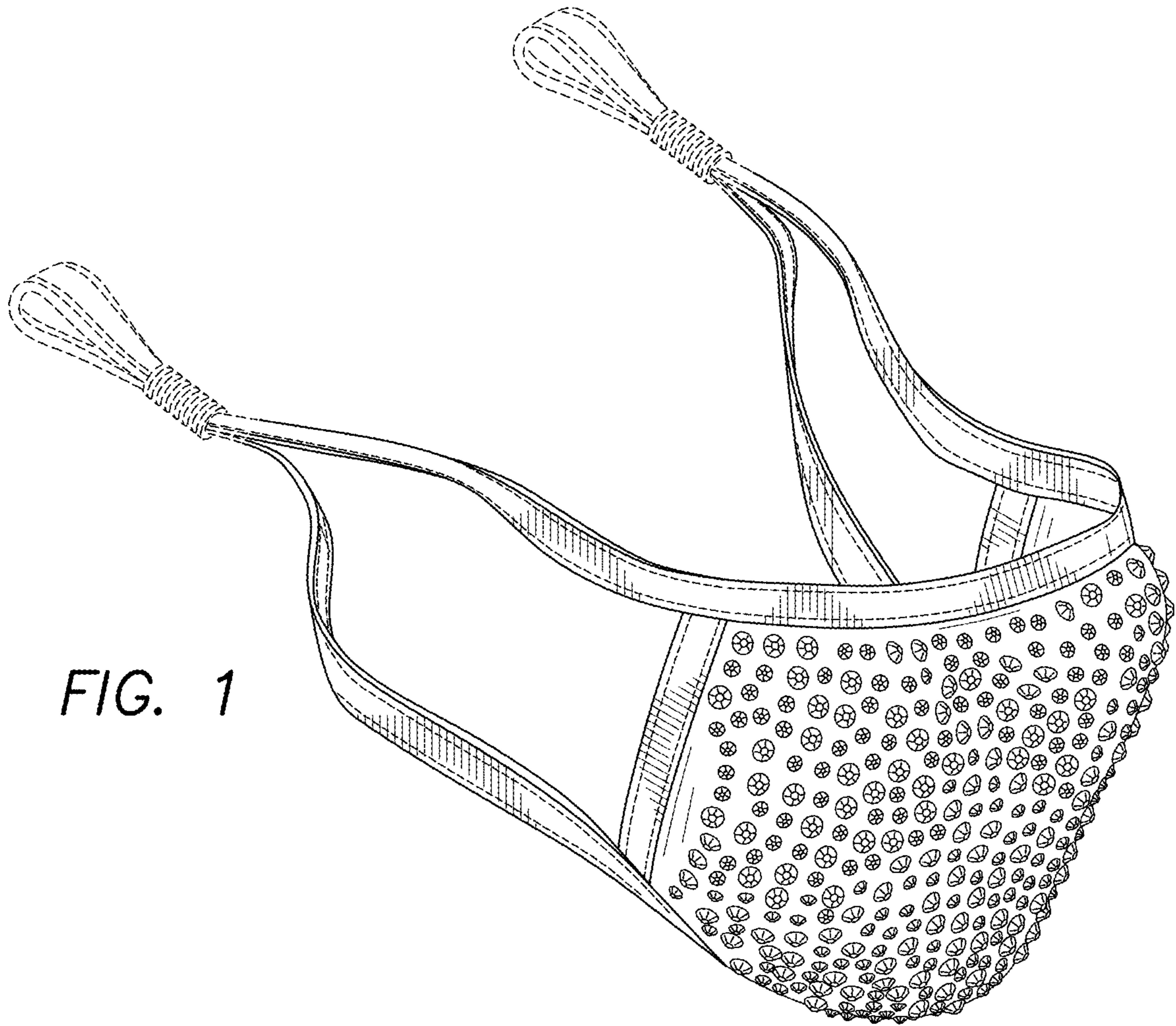

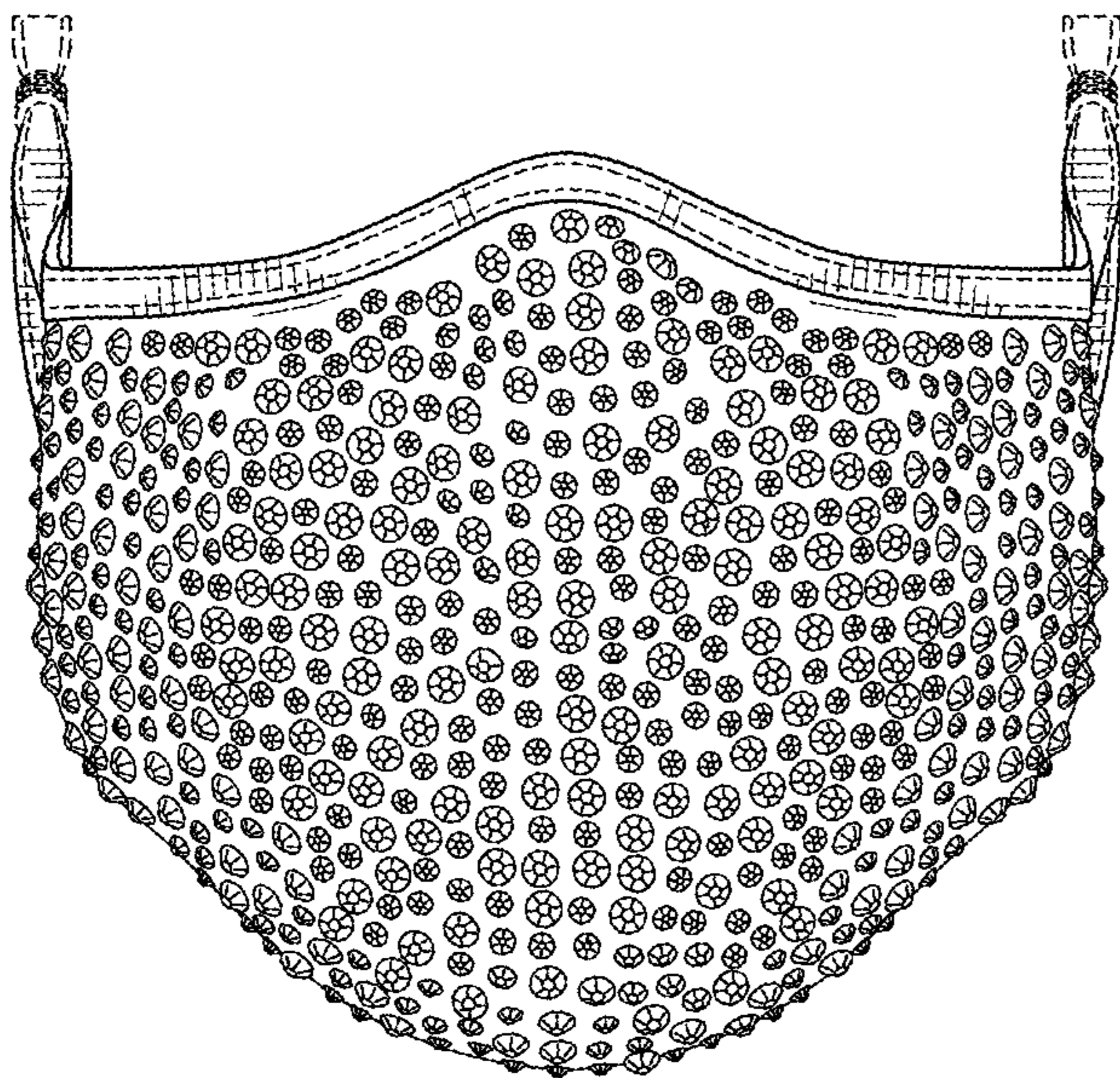

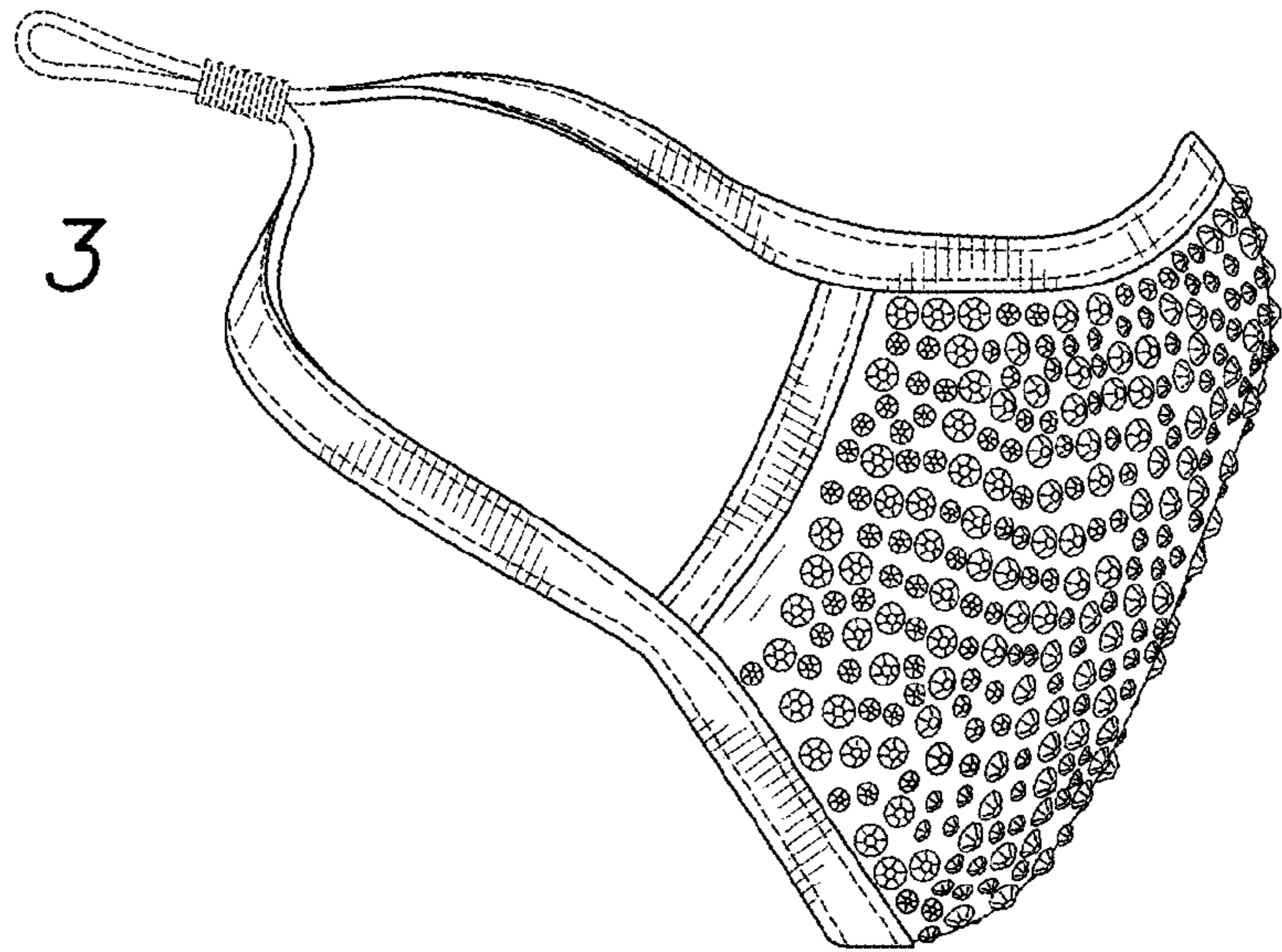

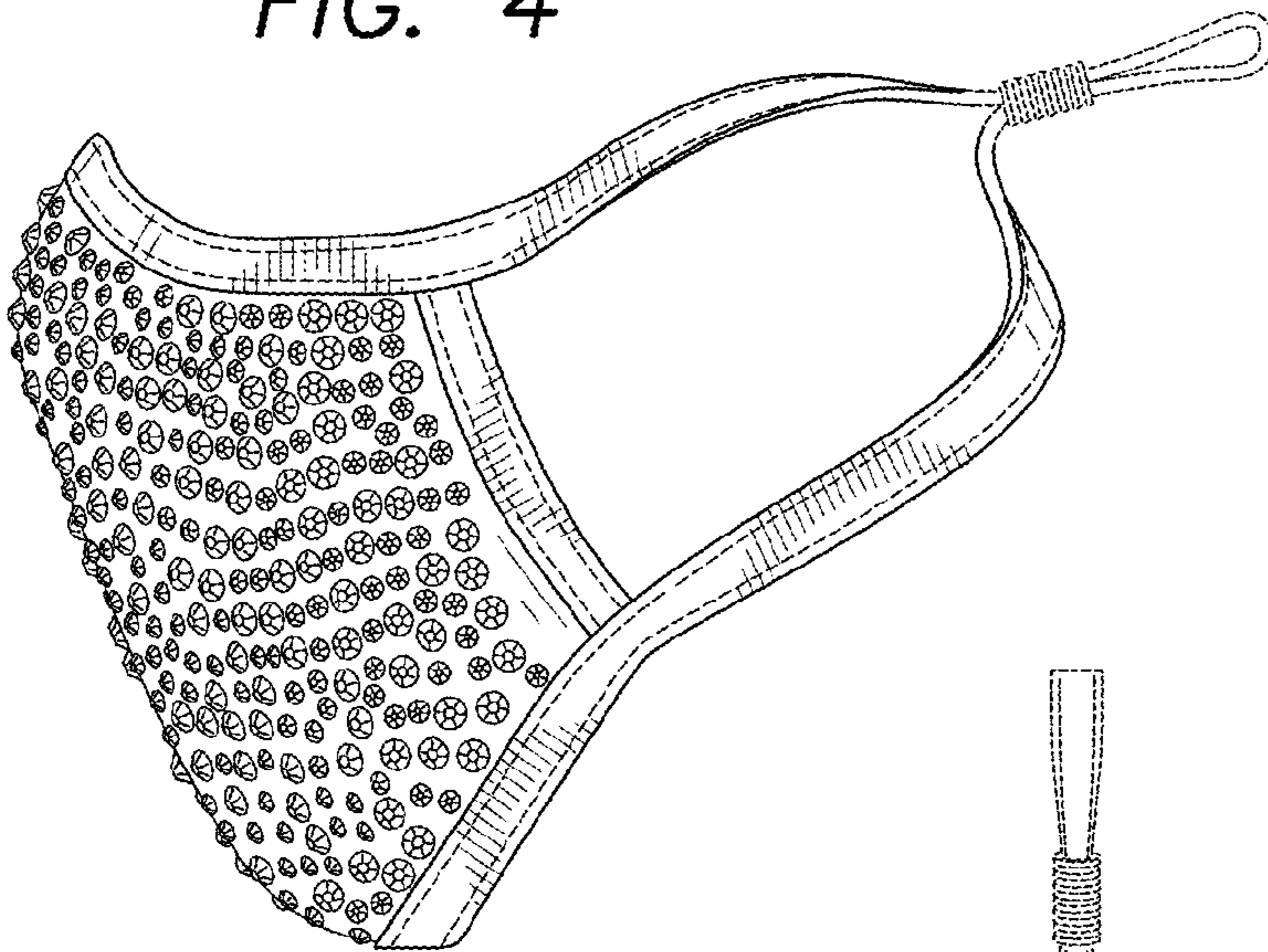
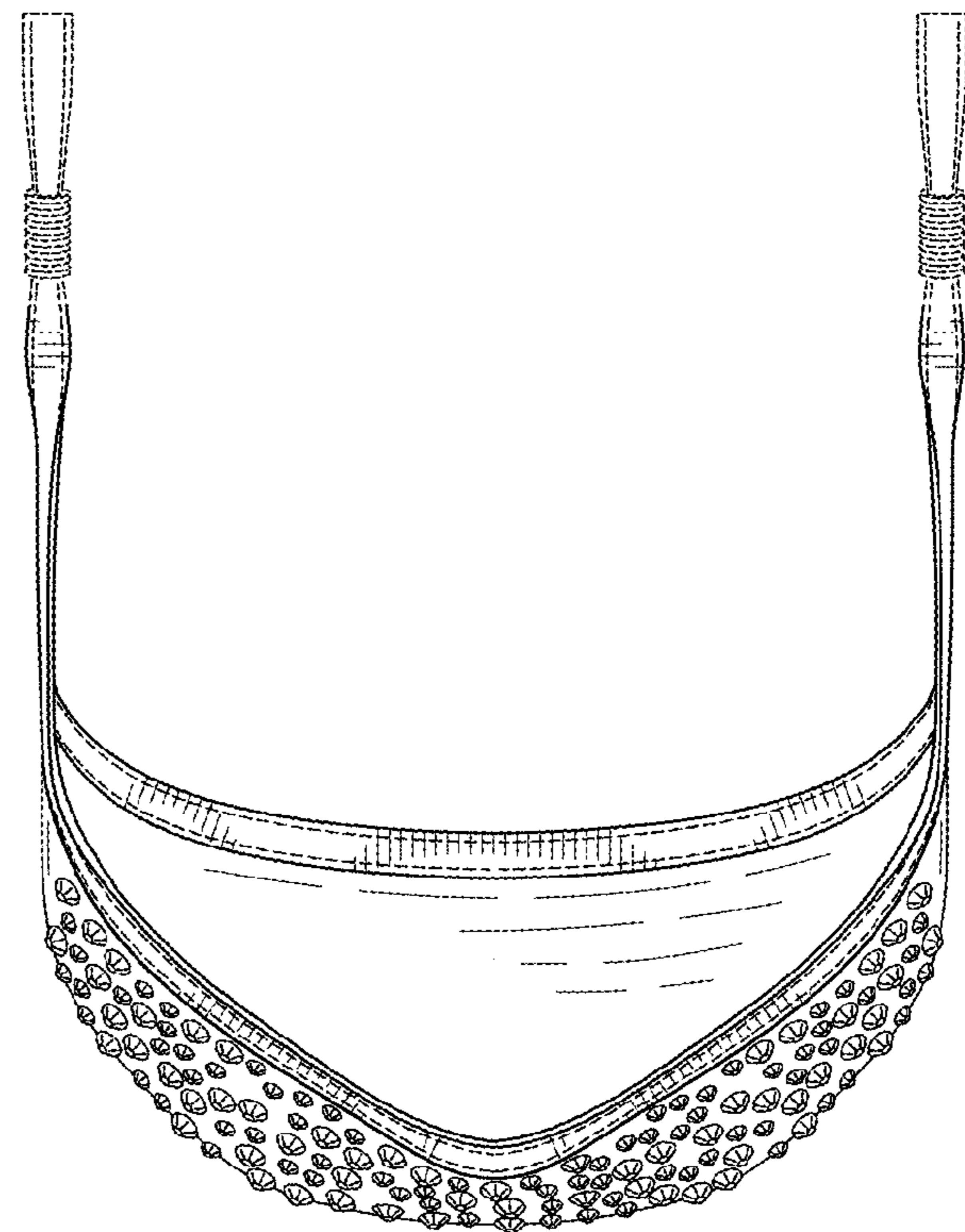

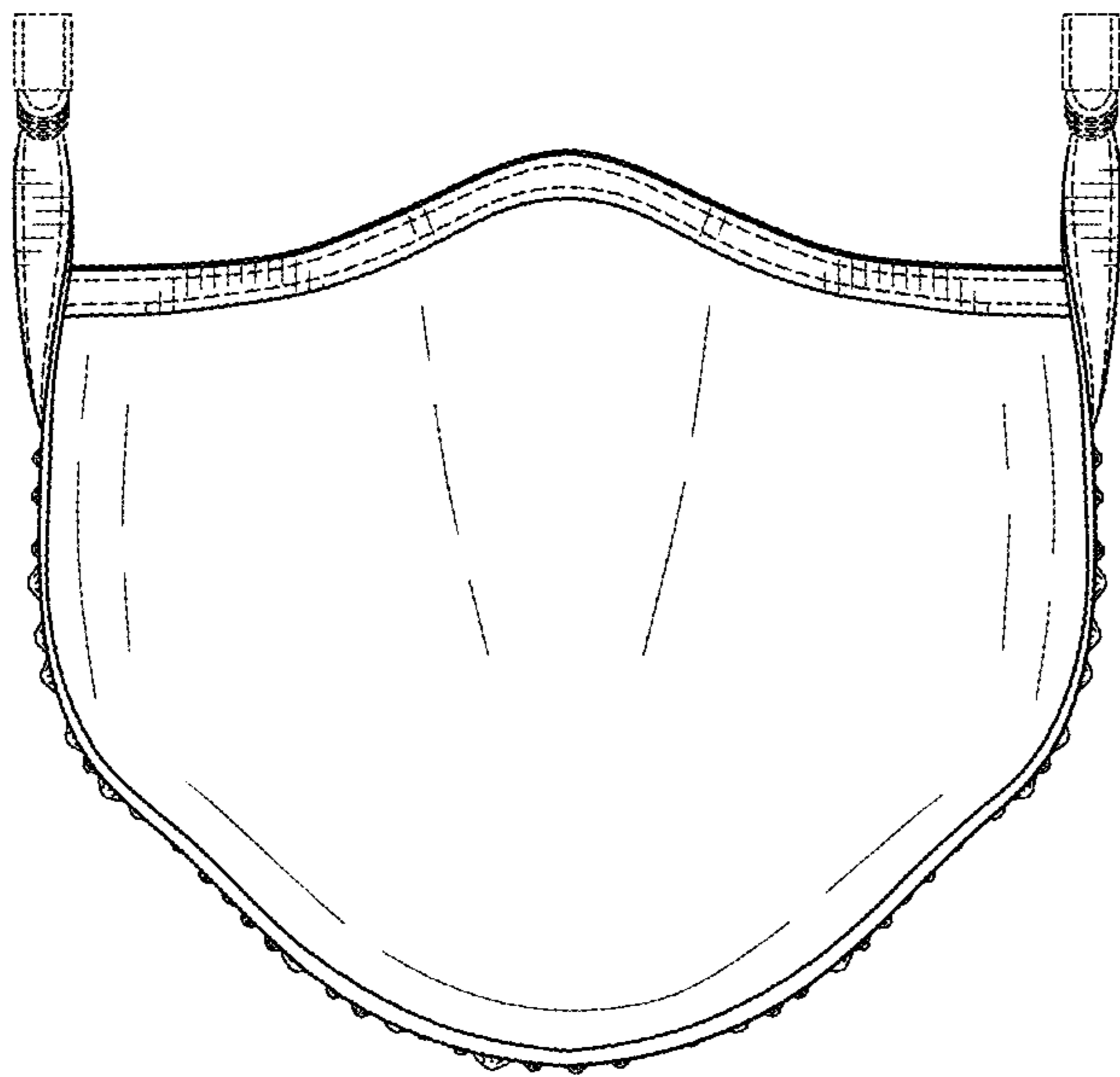

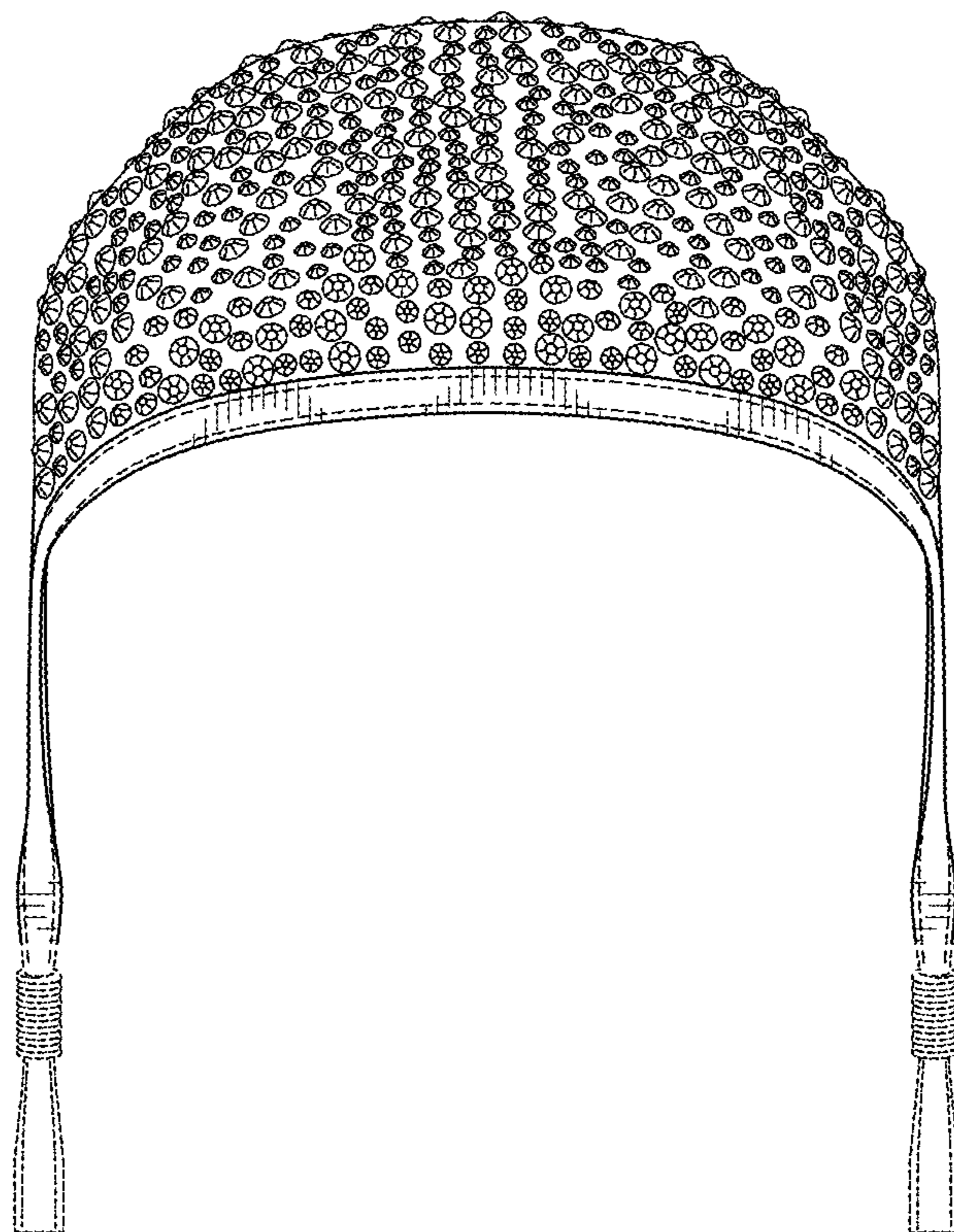
