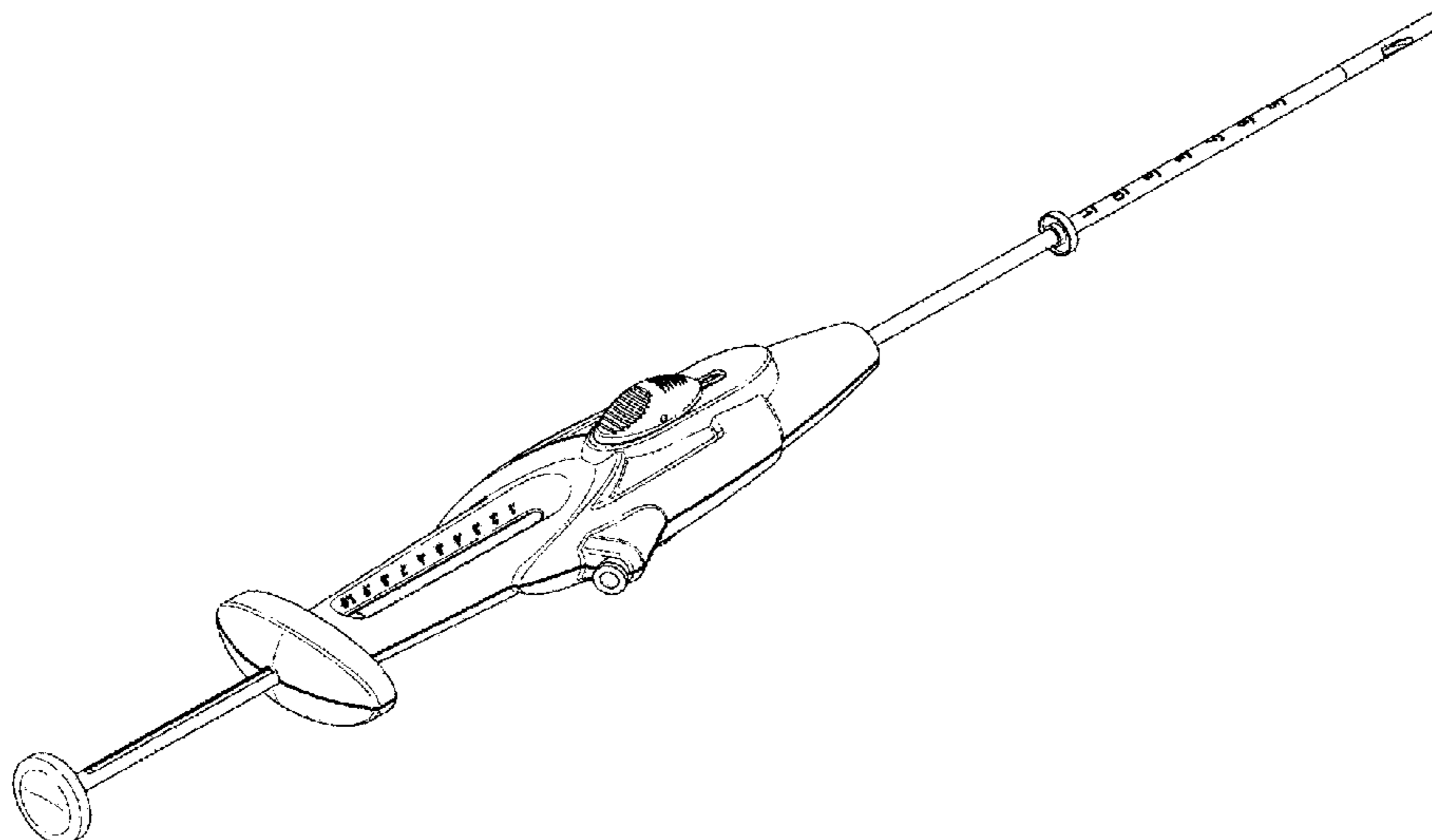
The ornamental design for a device for delivery of medical solutions, as shown and described.

DESCRIPTION

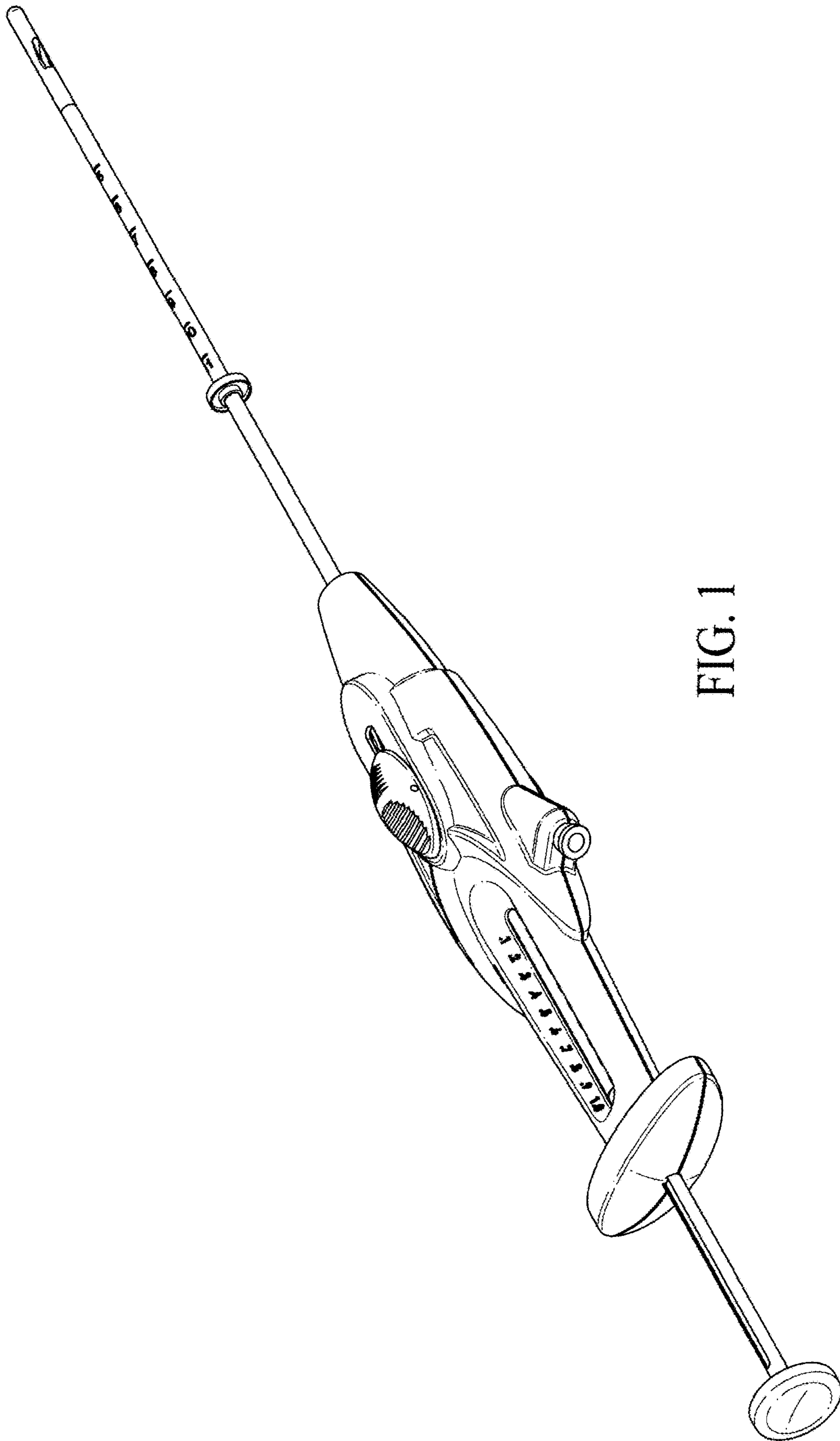

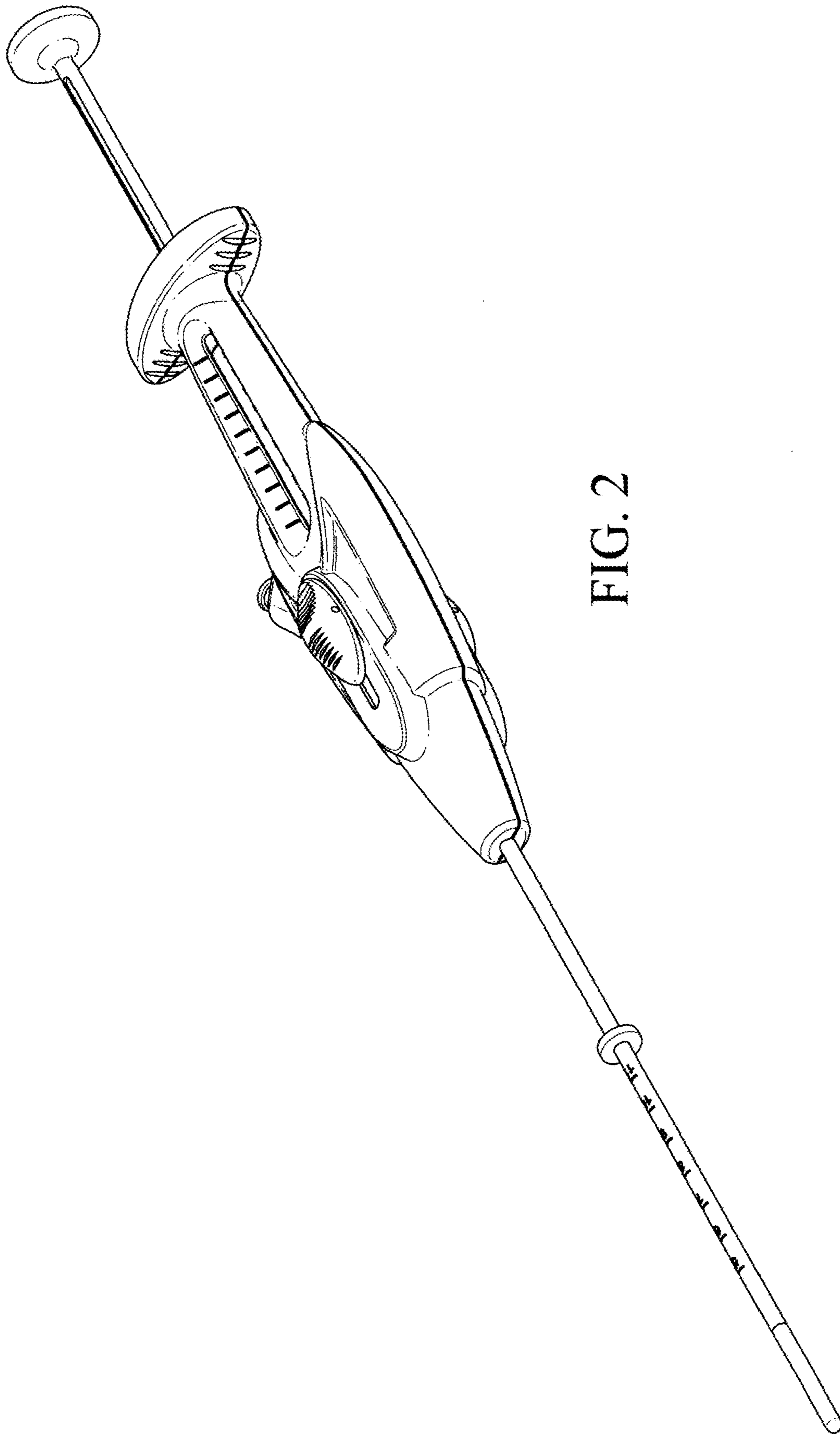

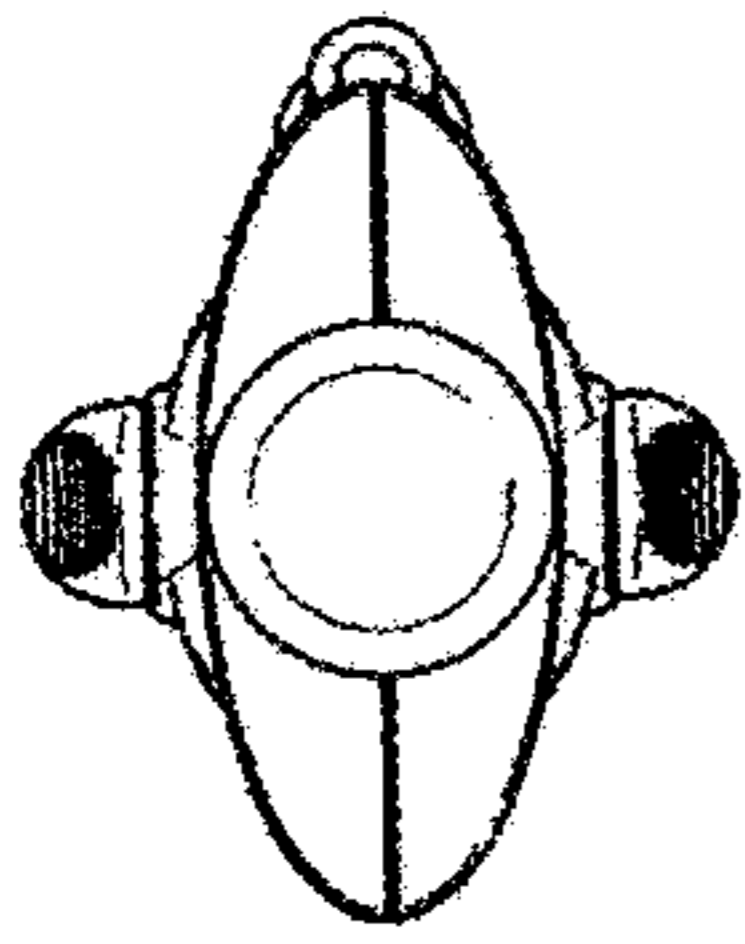

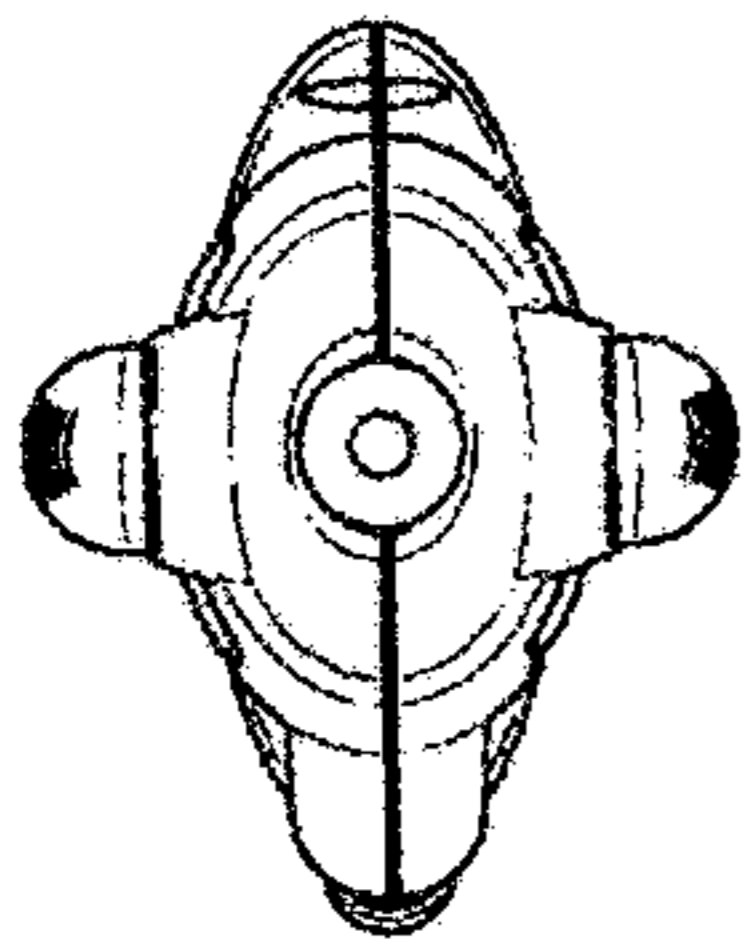

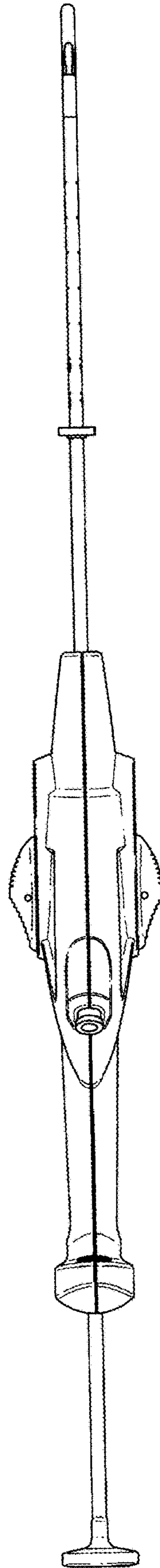

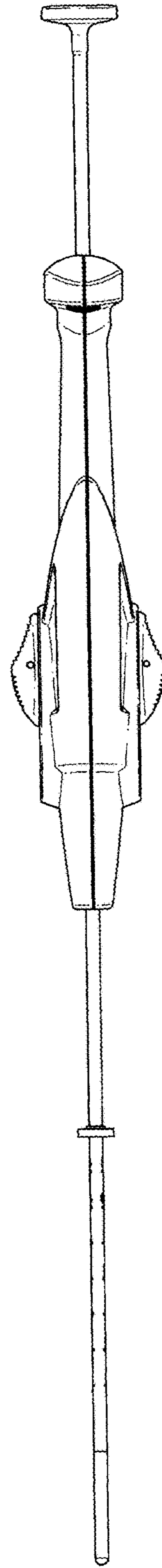

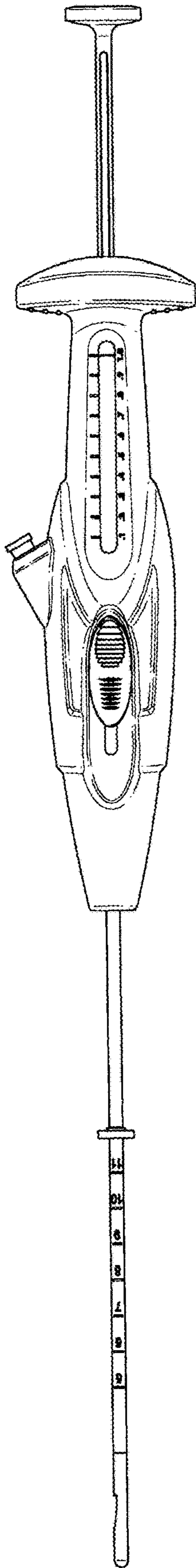

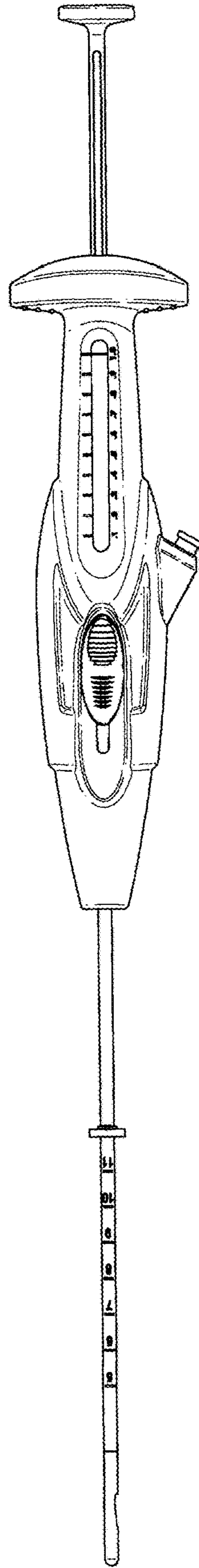

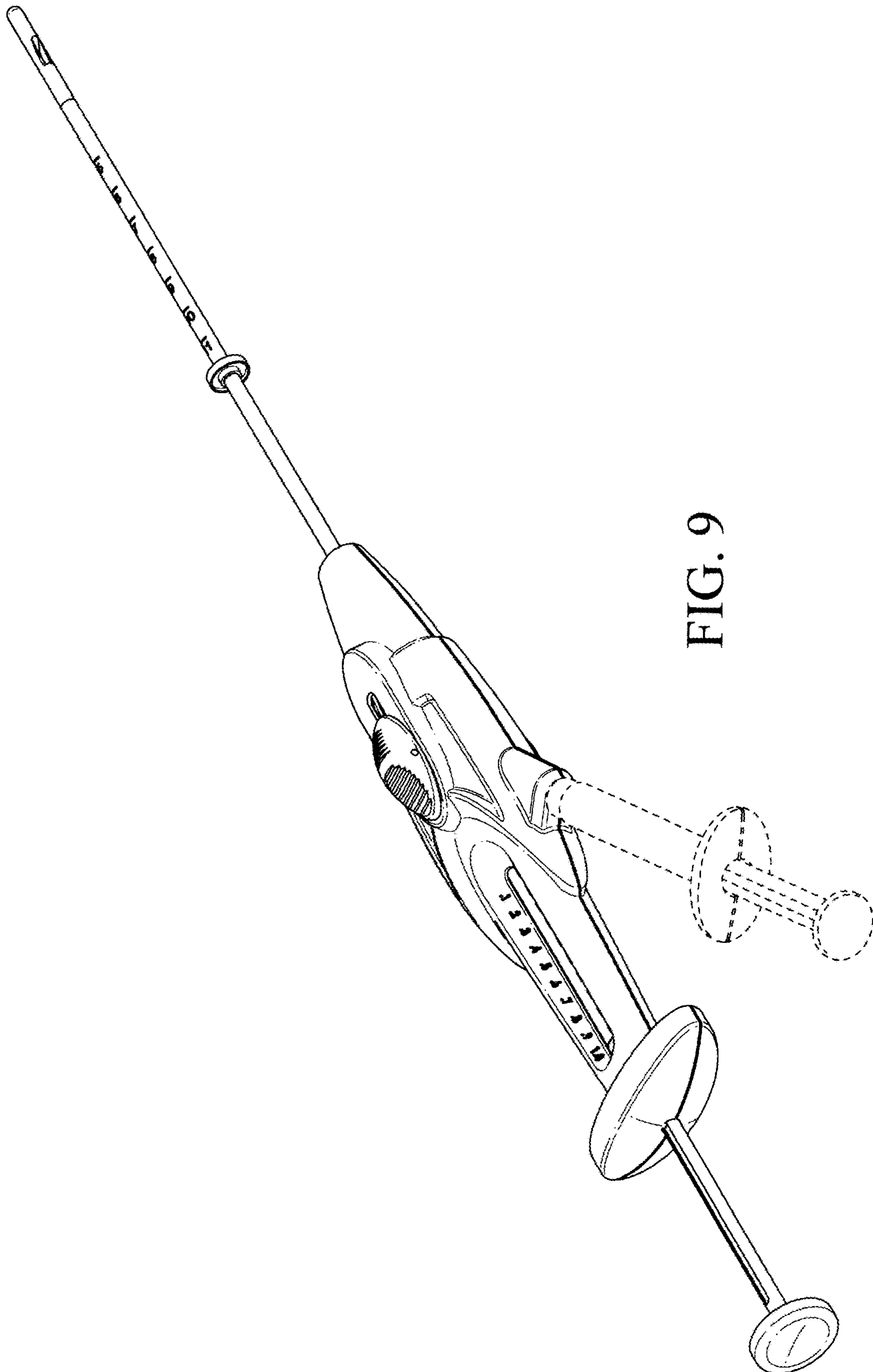

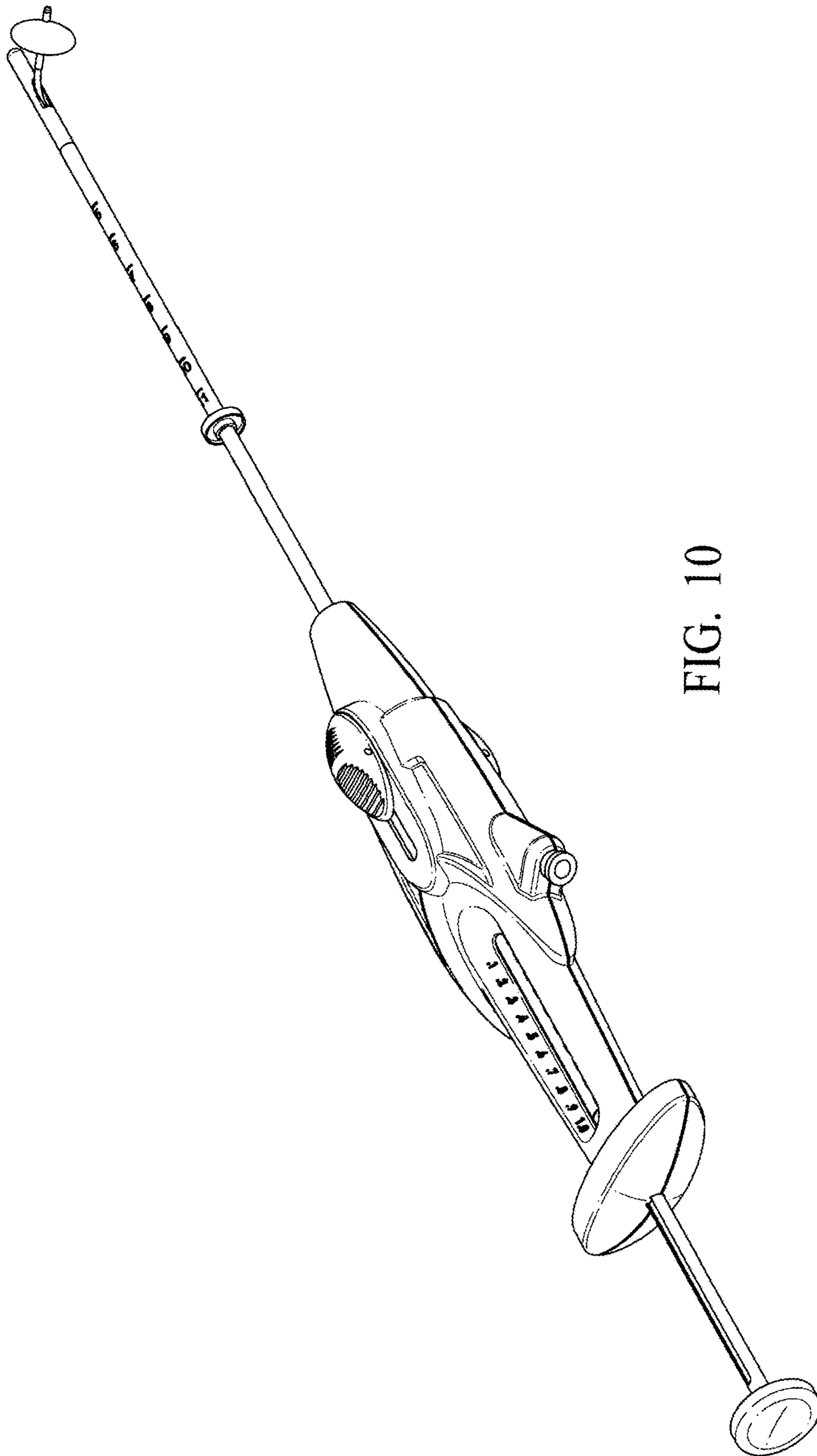

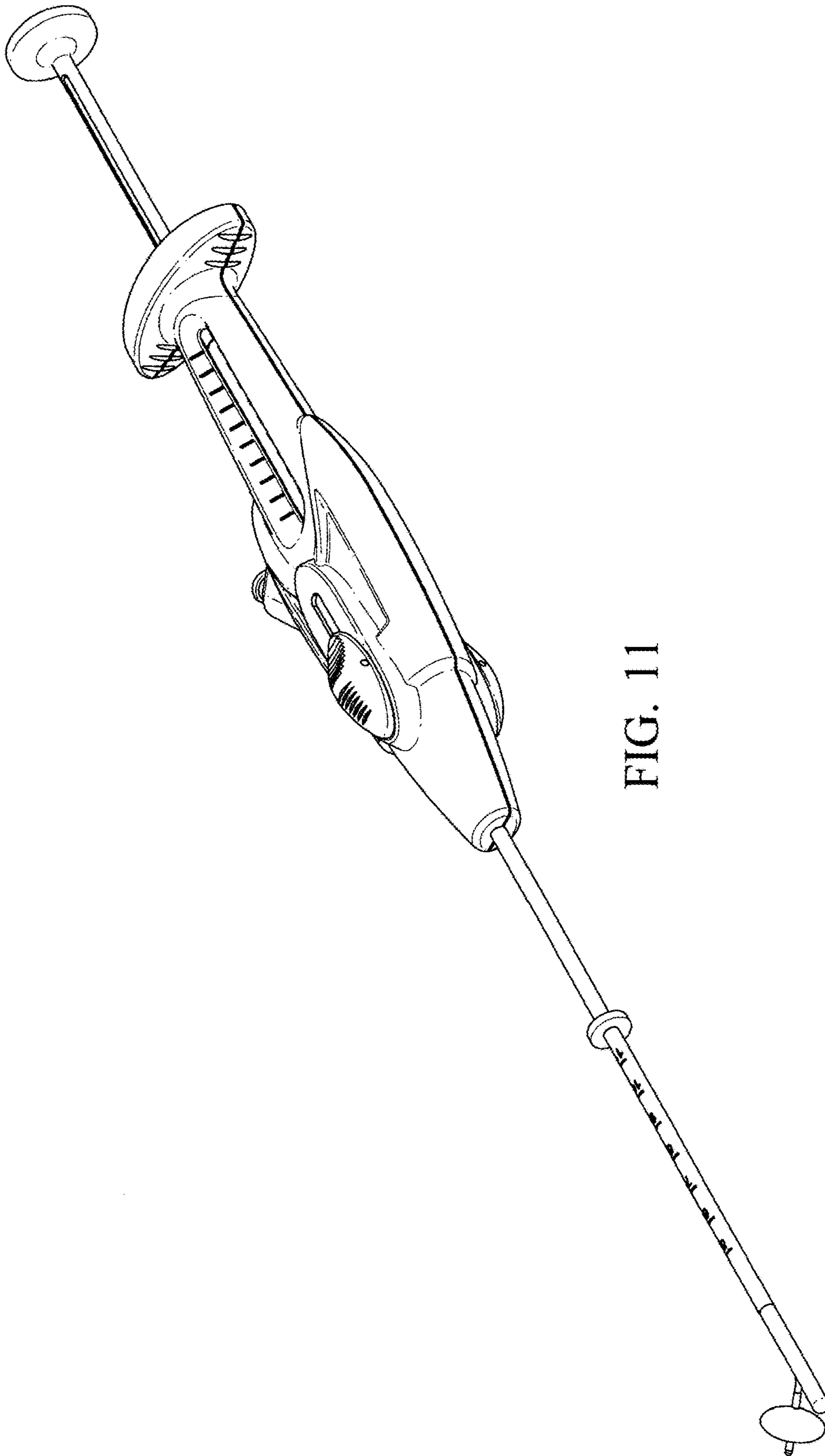

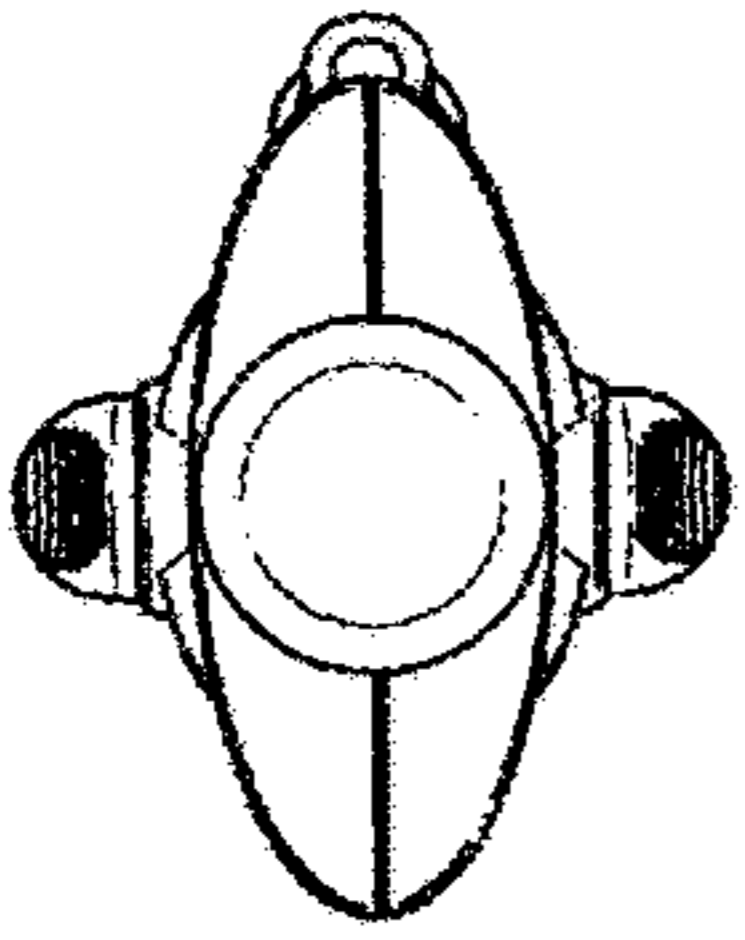

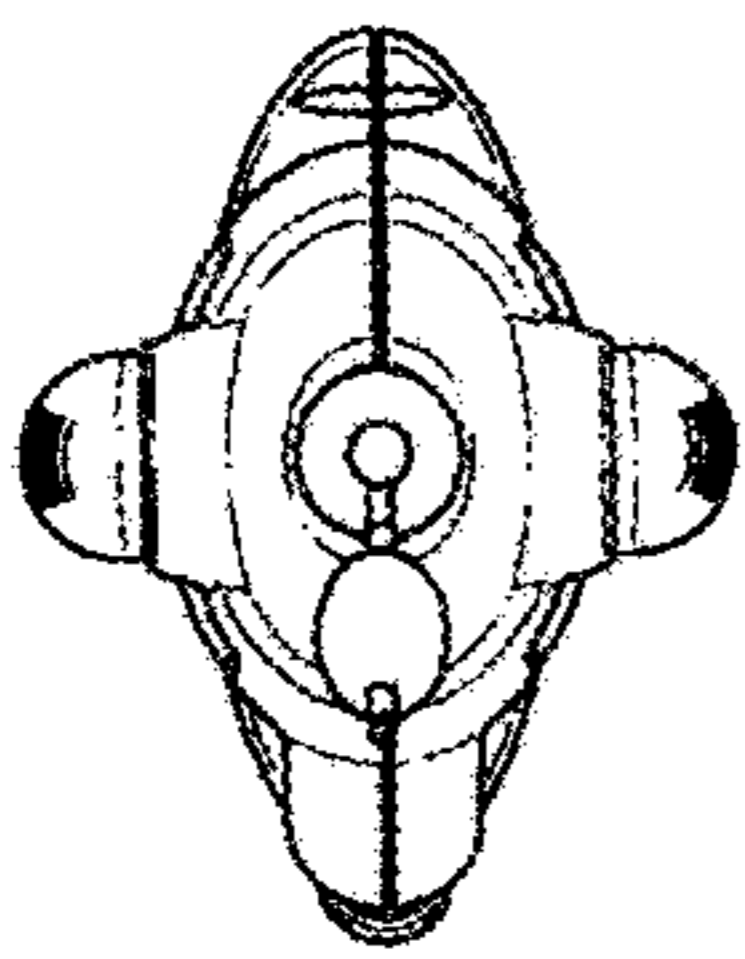

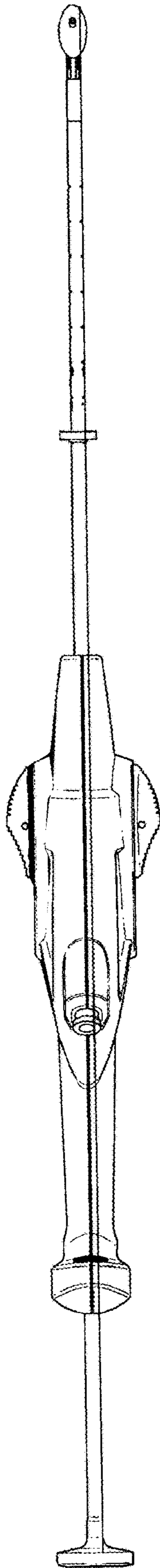

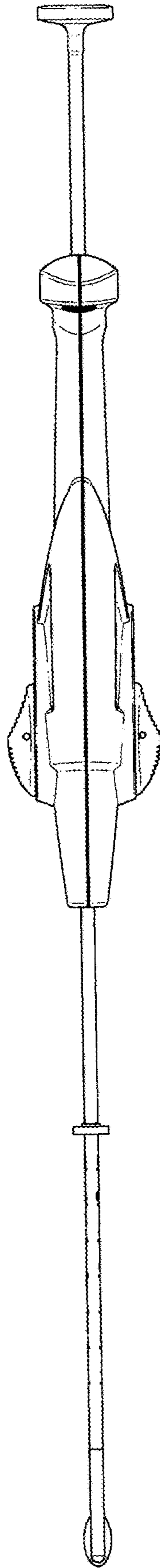

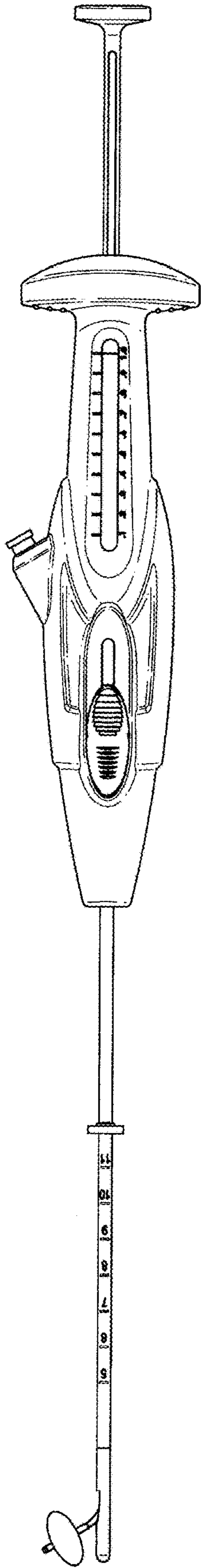

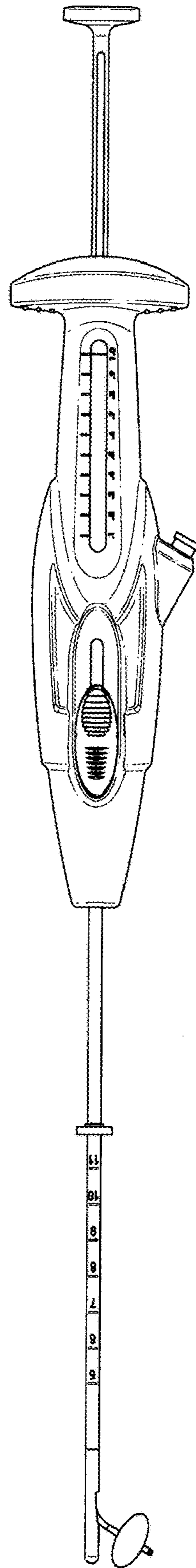

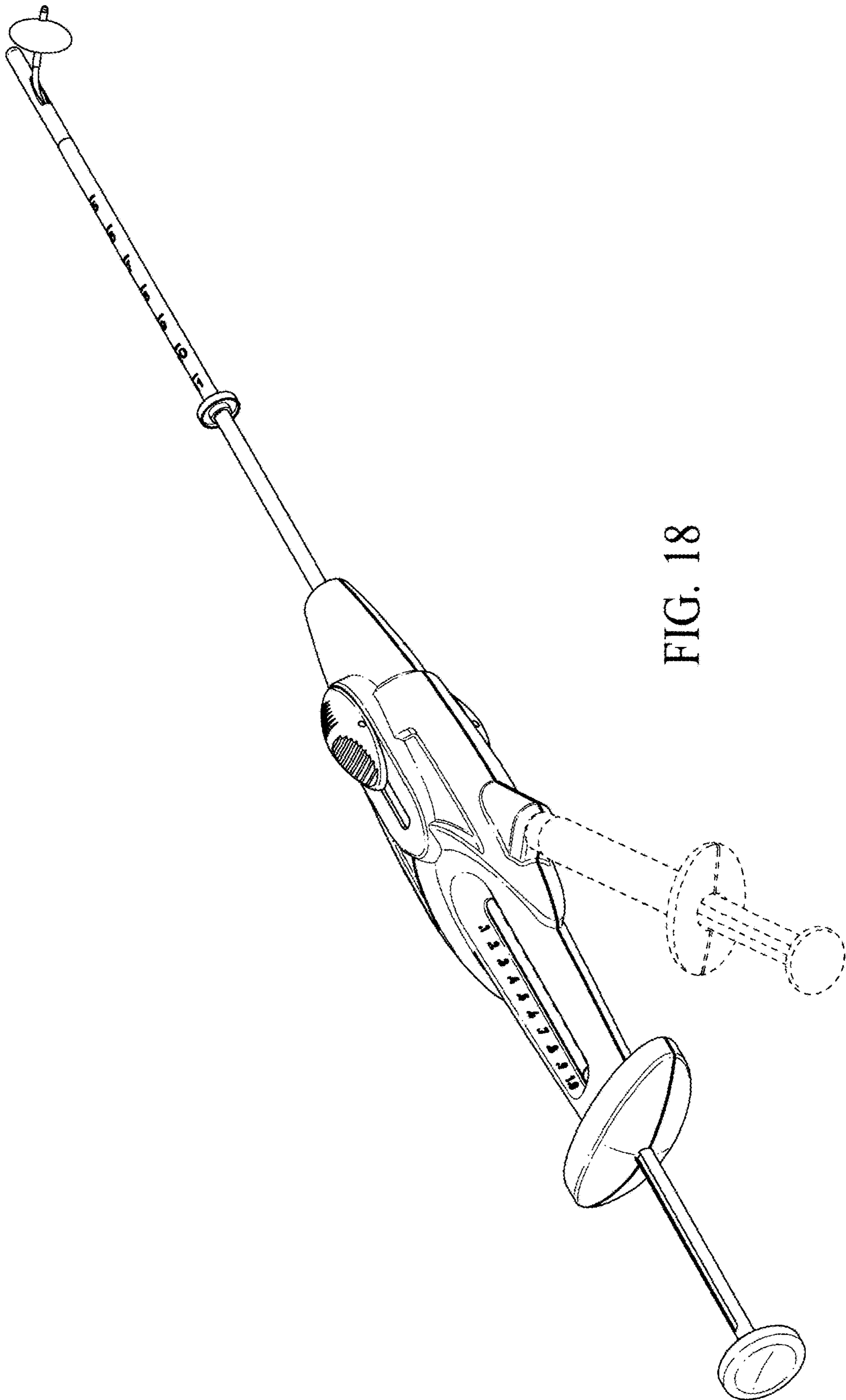

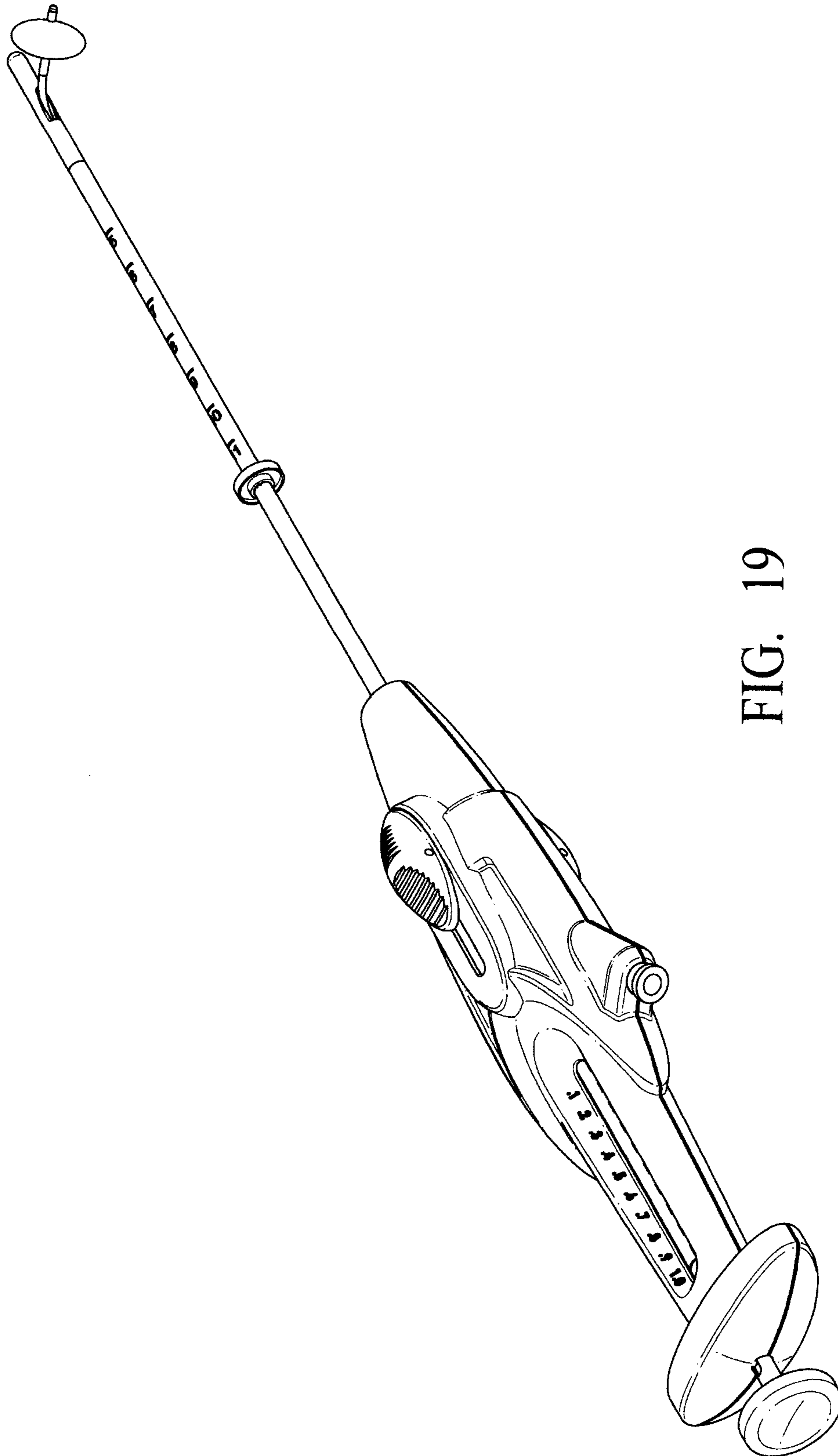

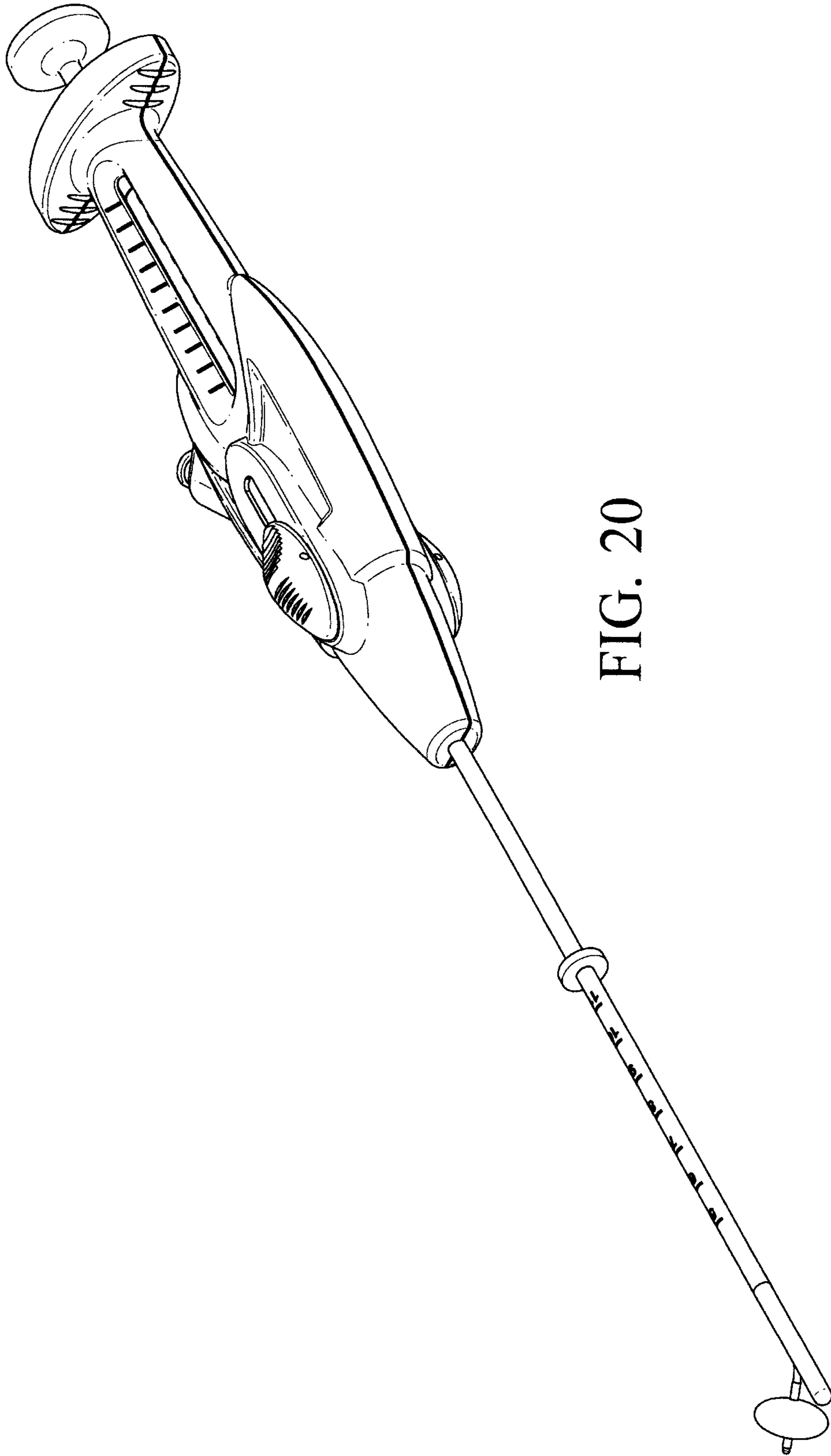

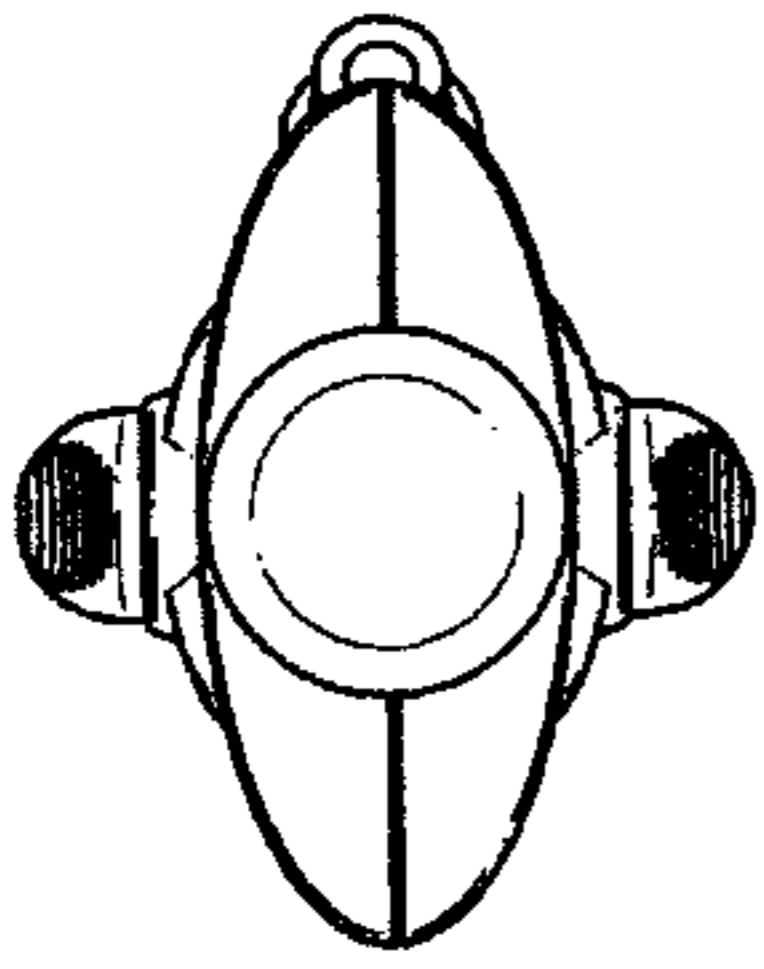

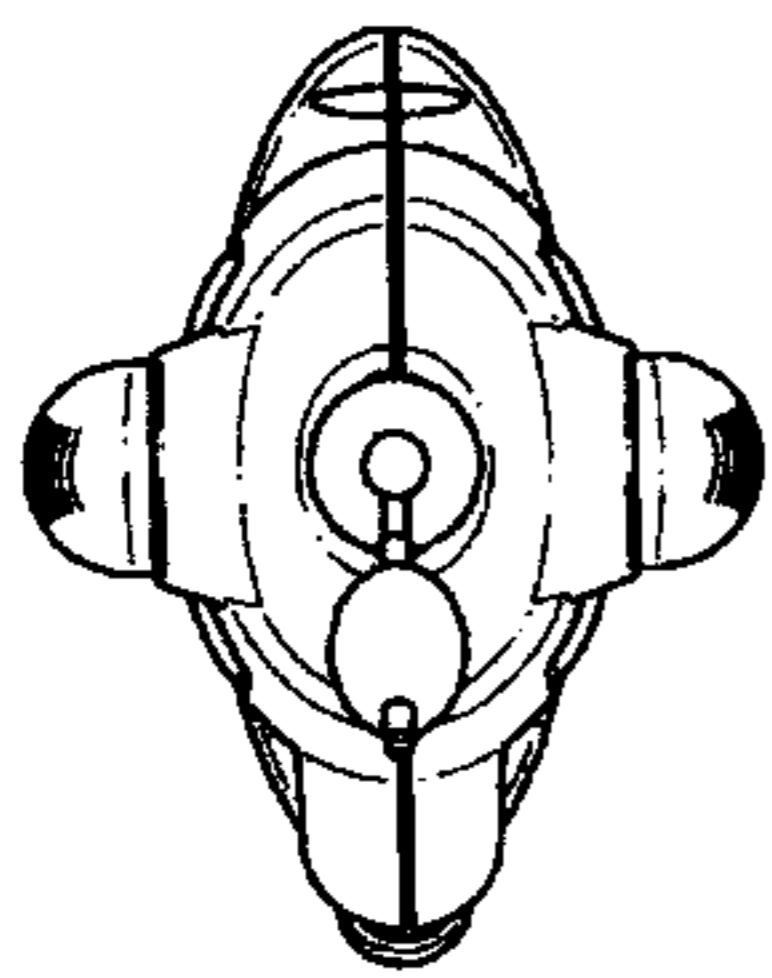

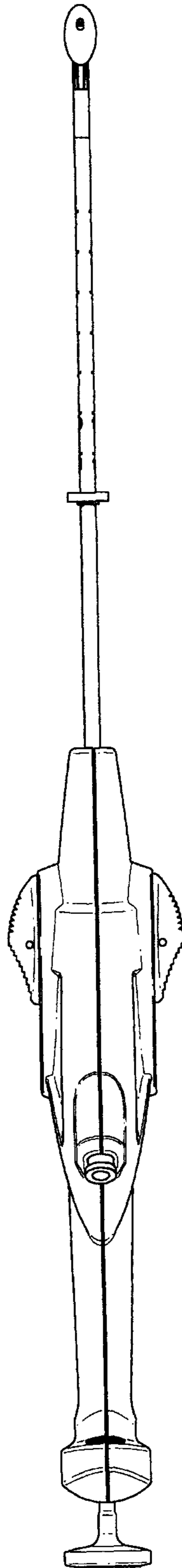

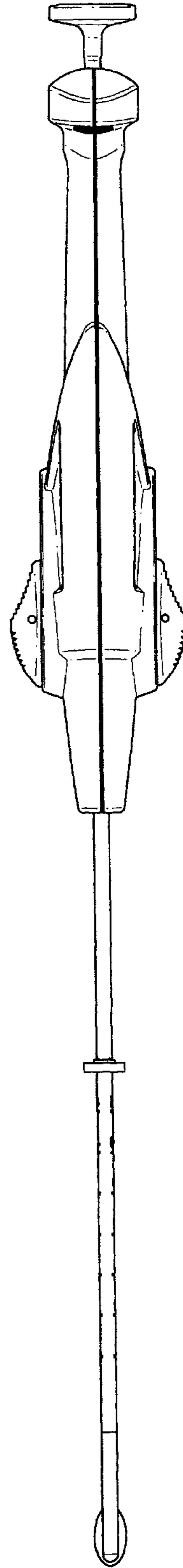

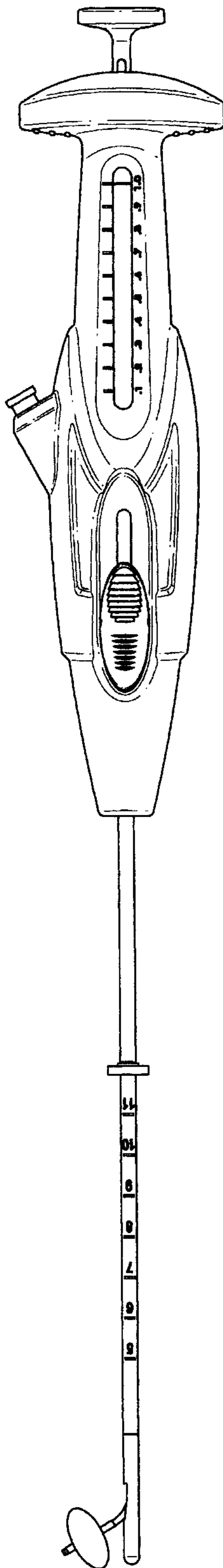

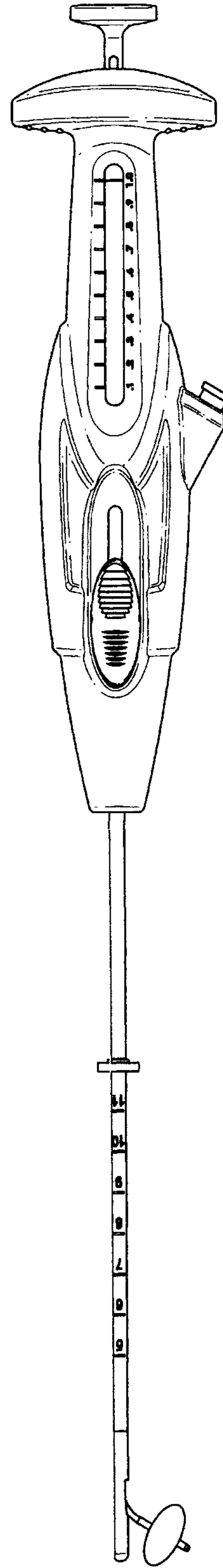

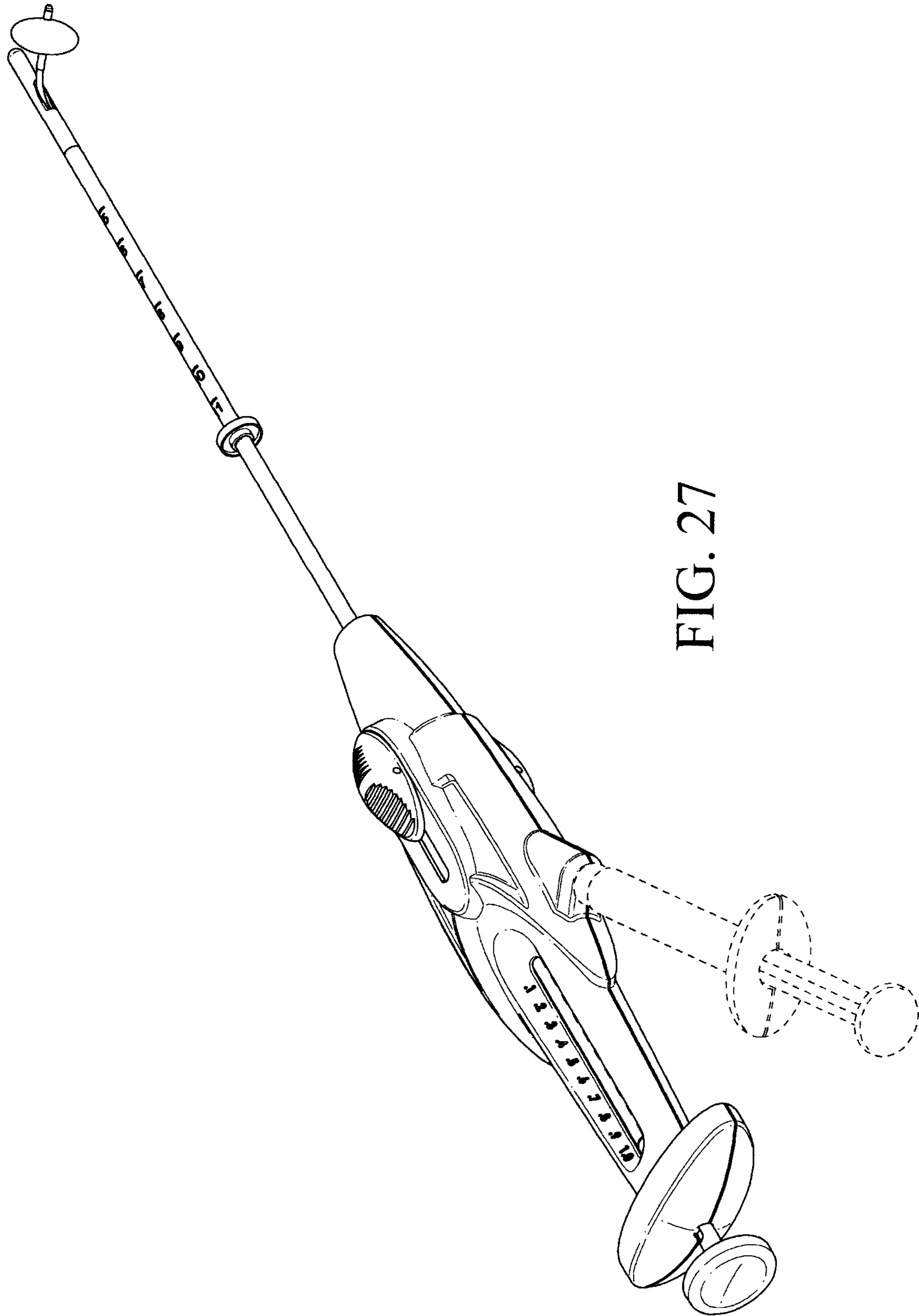
