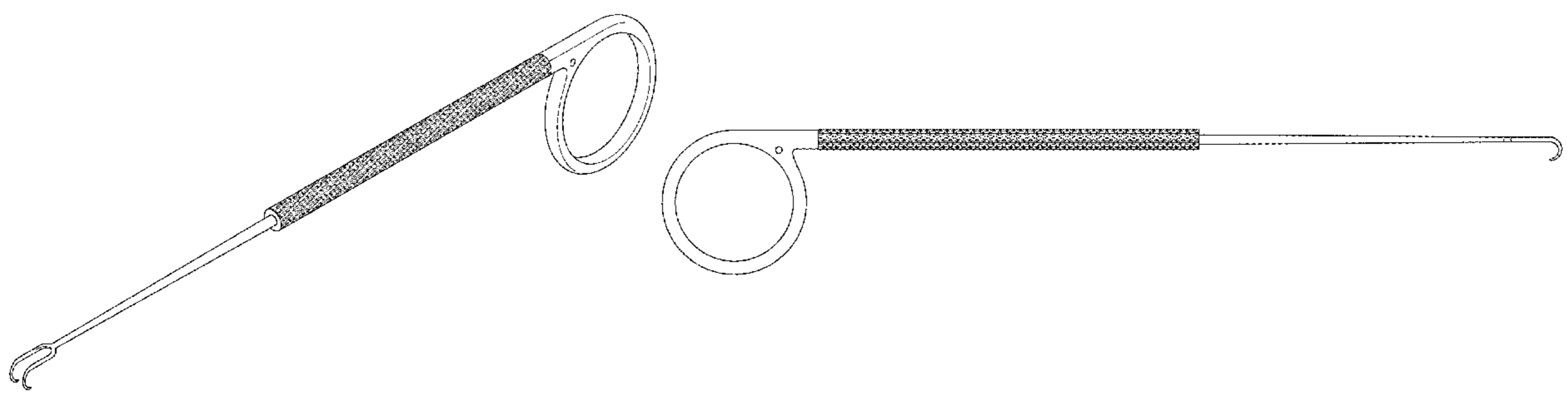

We claim the ornamental design for a looped skin hook, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-front-right perspective view of a looped skin hook;

FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;

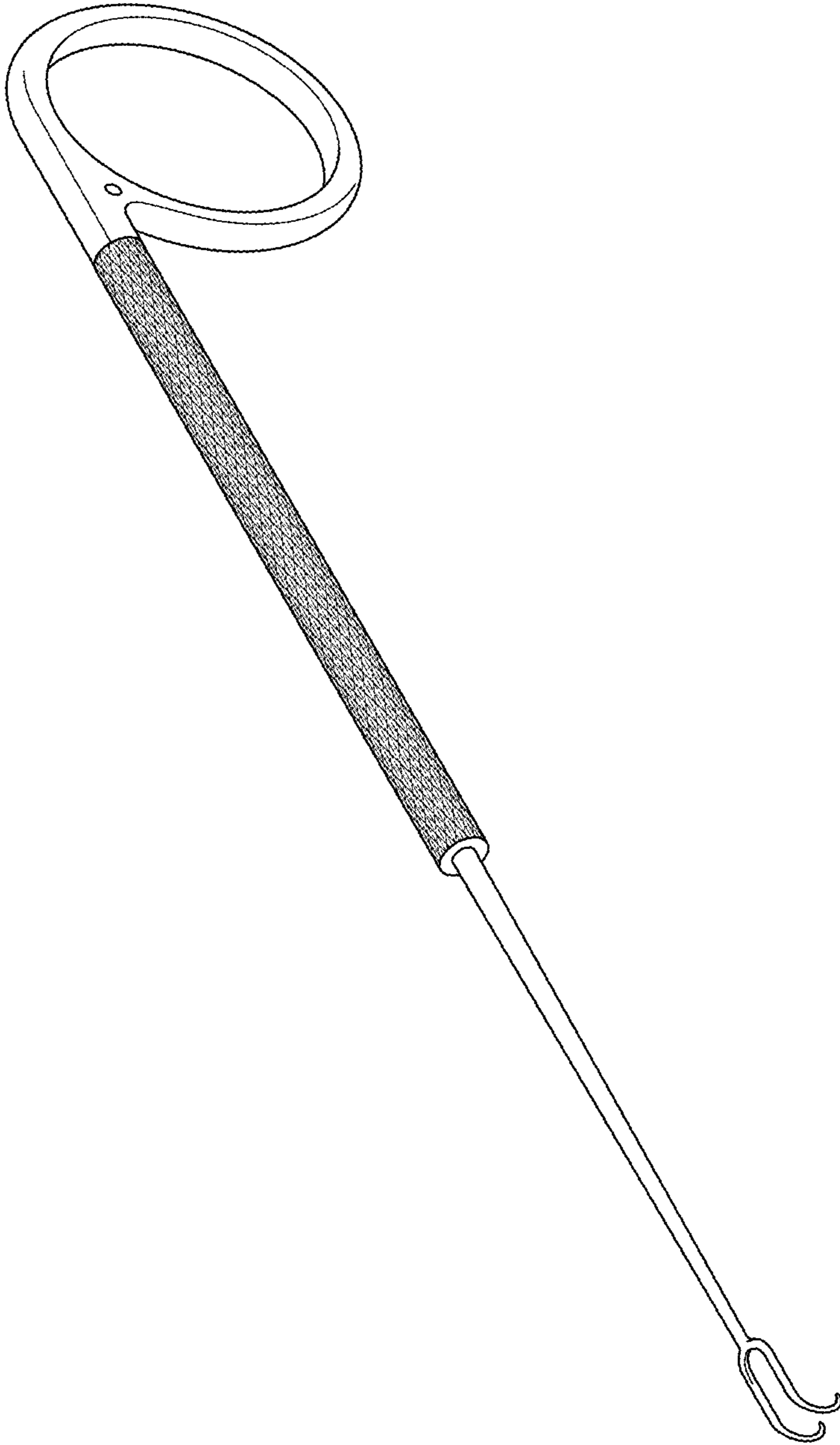

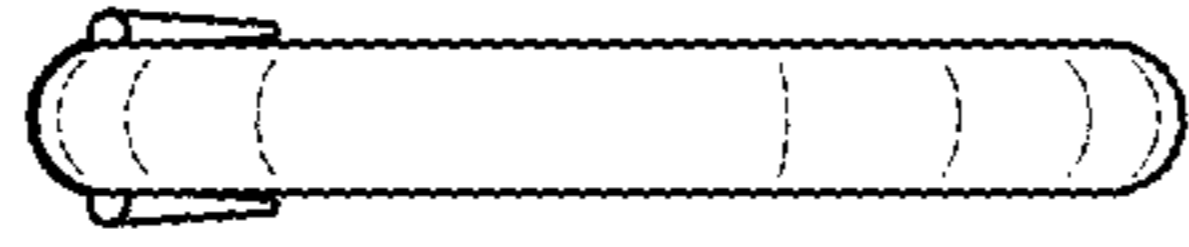

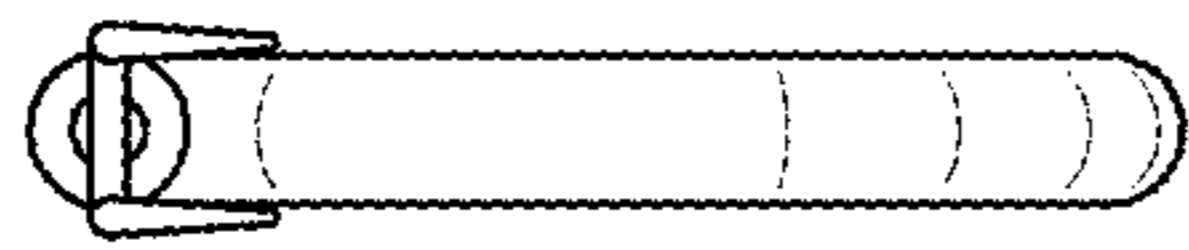

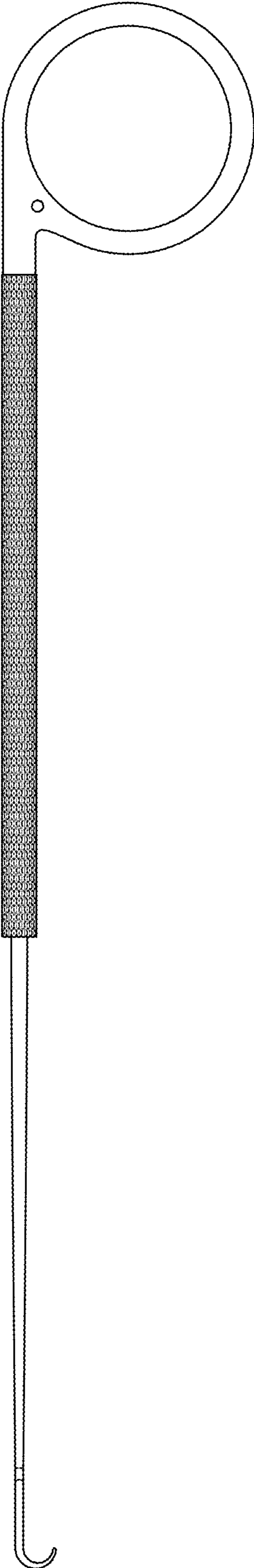

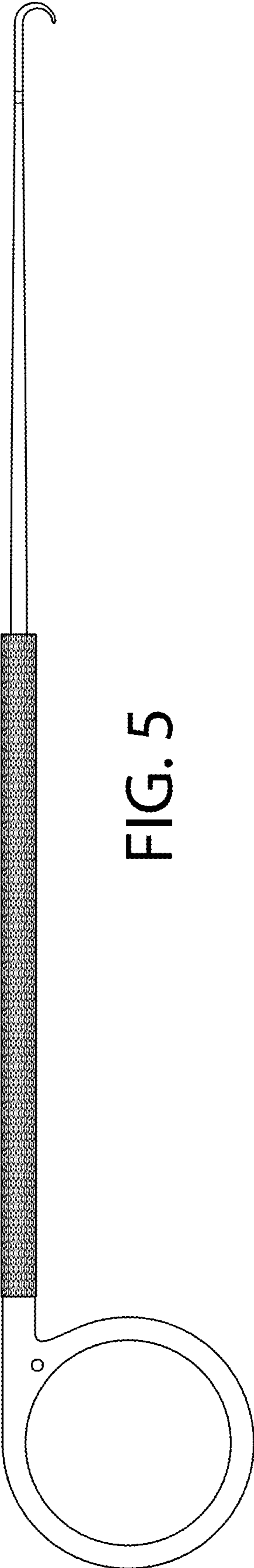

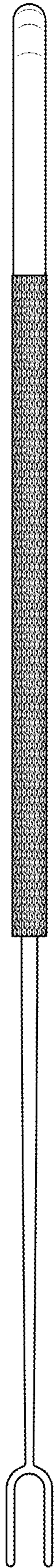

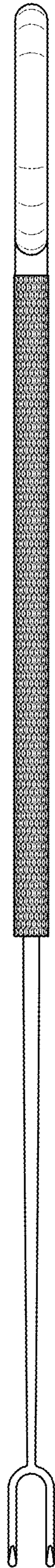
