FIG. 12 is a back view of the test strip of the second embodiment.

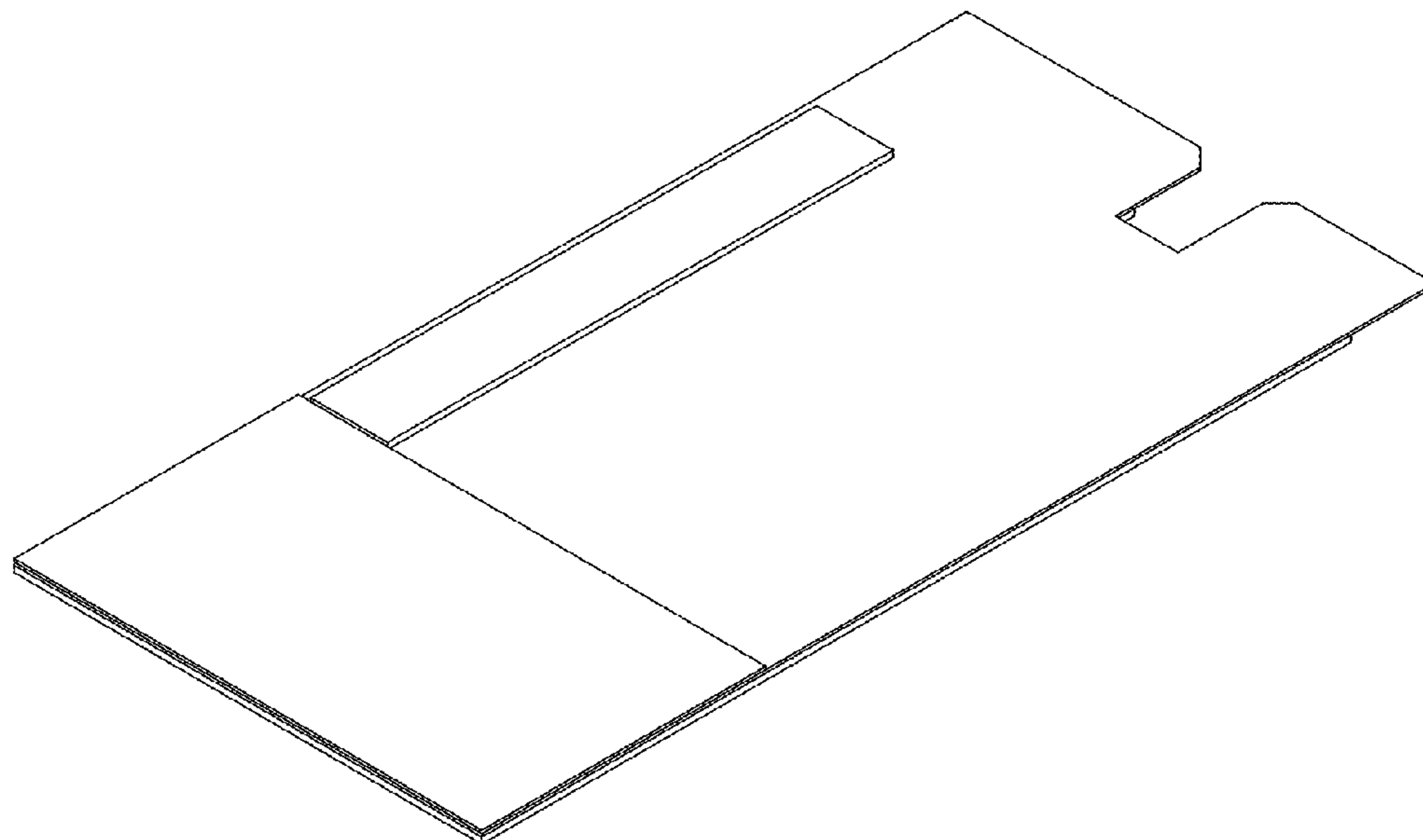
FIG. 13 is a right side view of the test strip of the second embodiment.

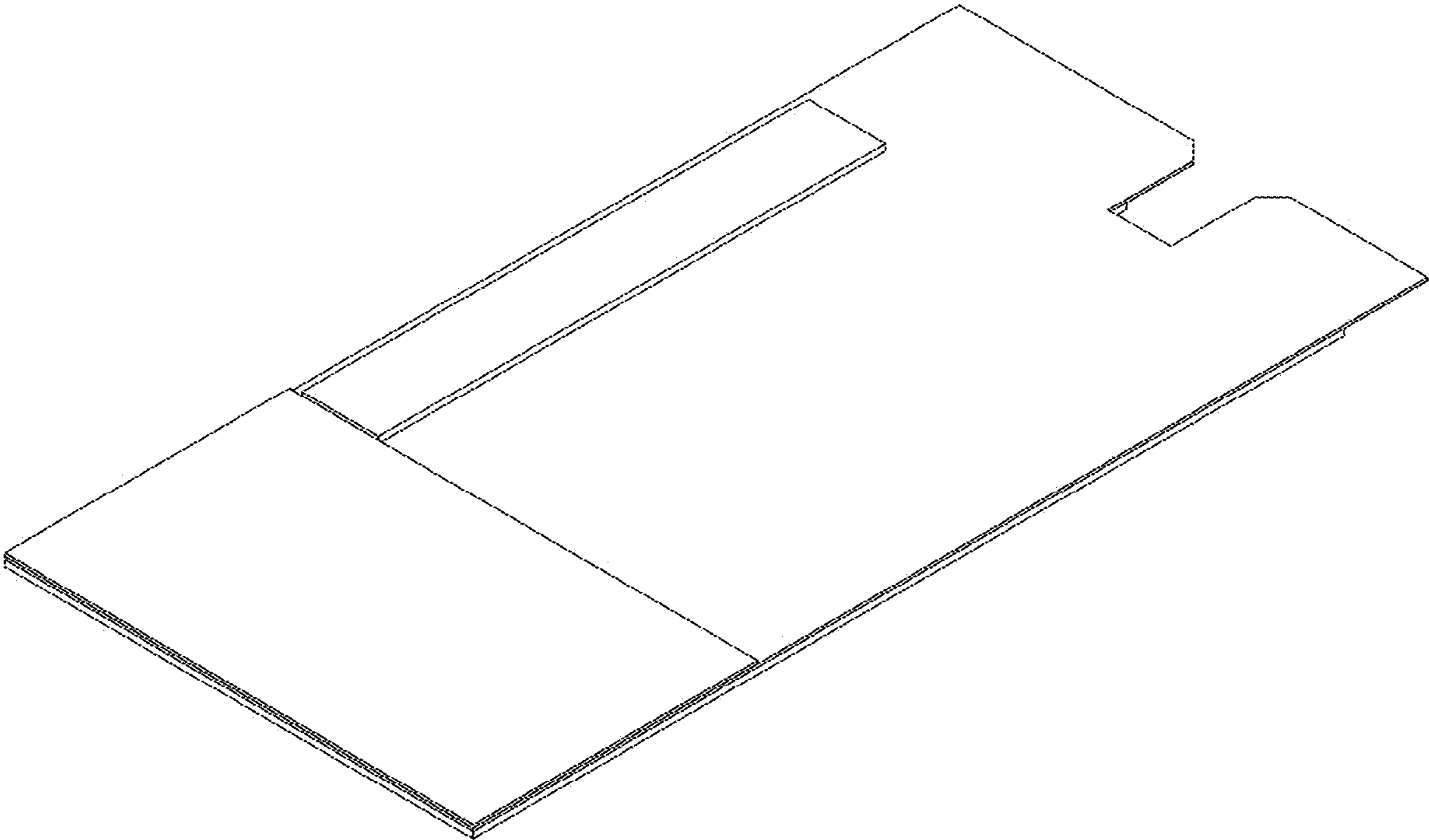

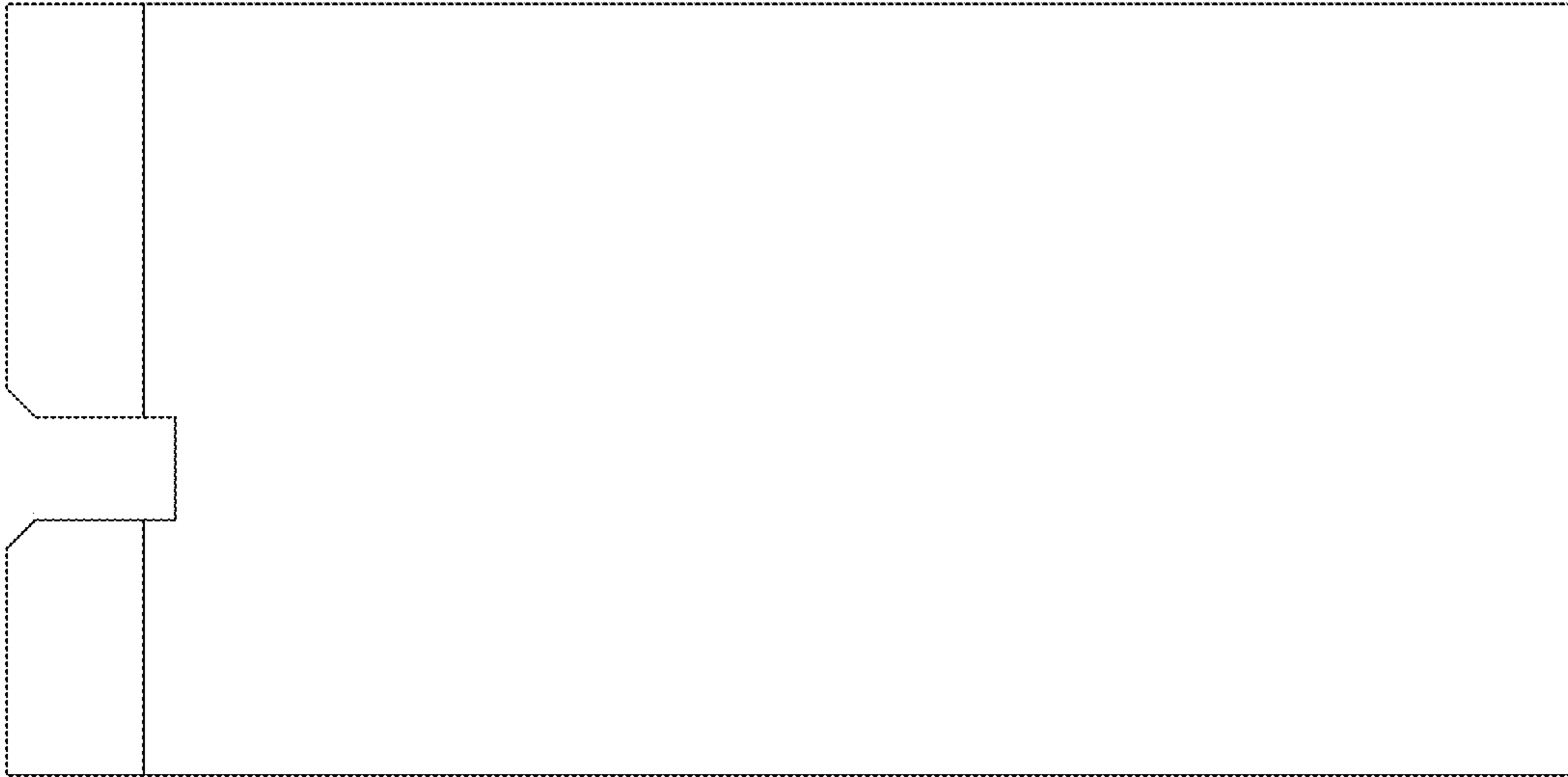

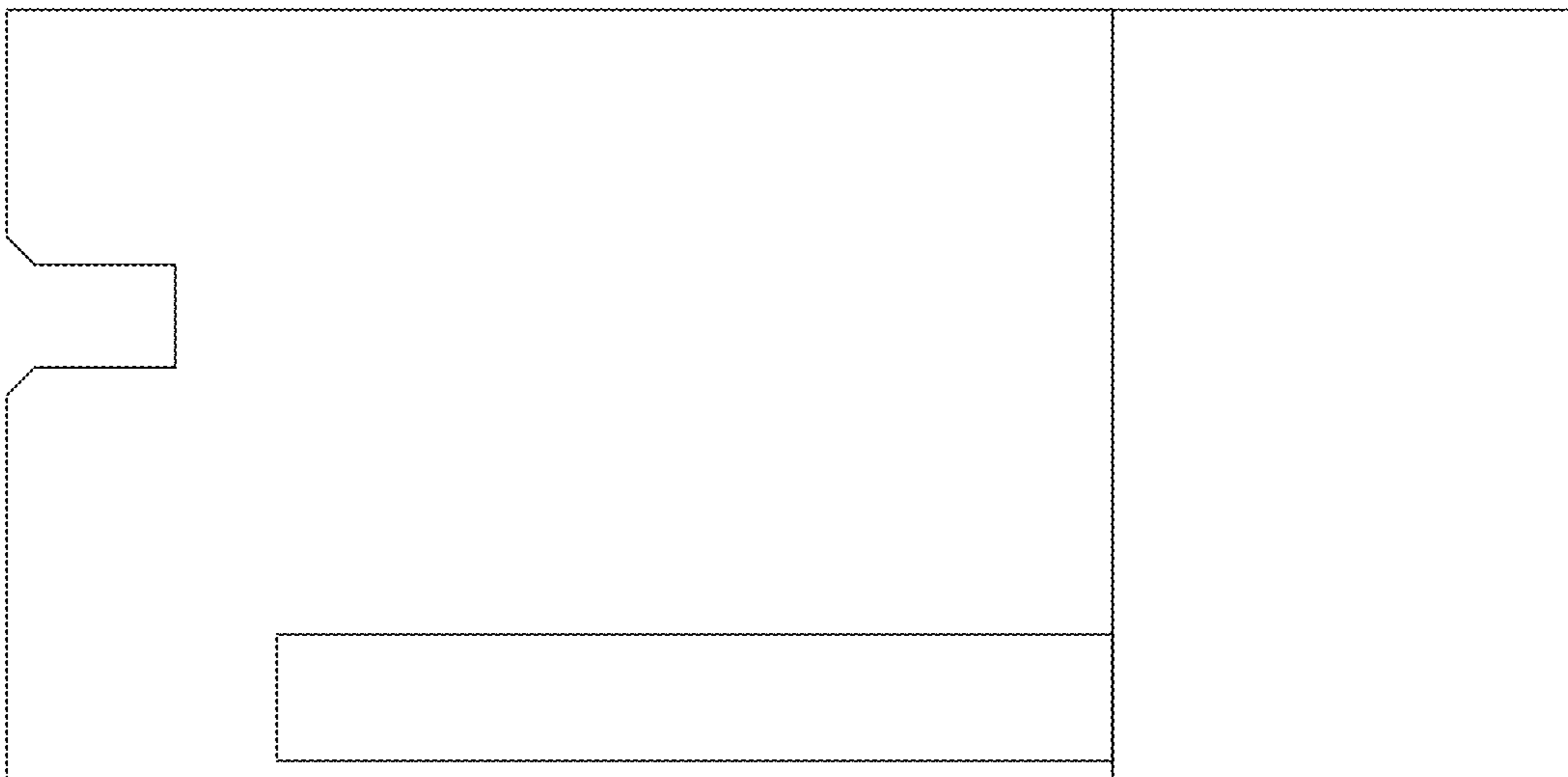

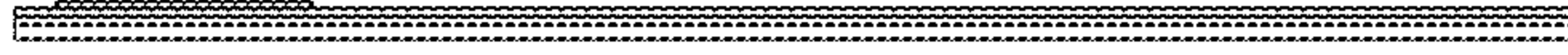

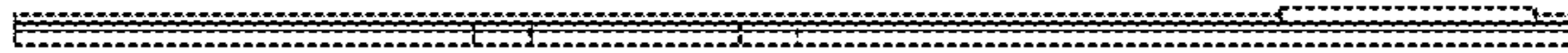

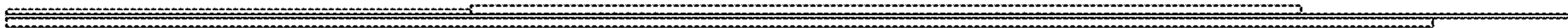

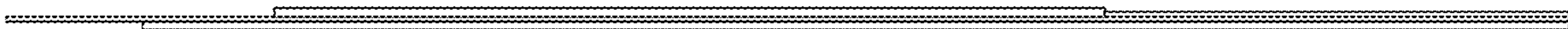

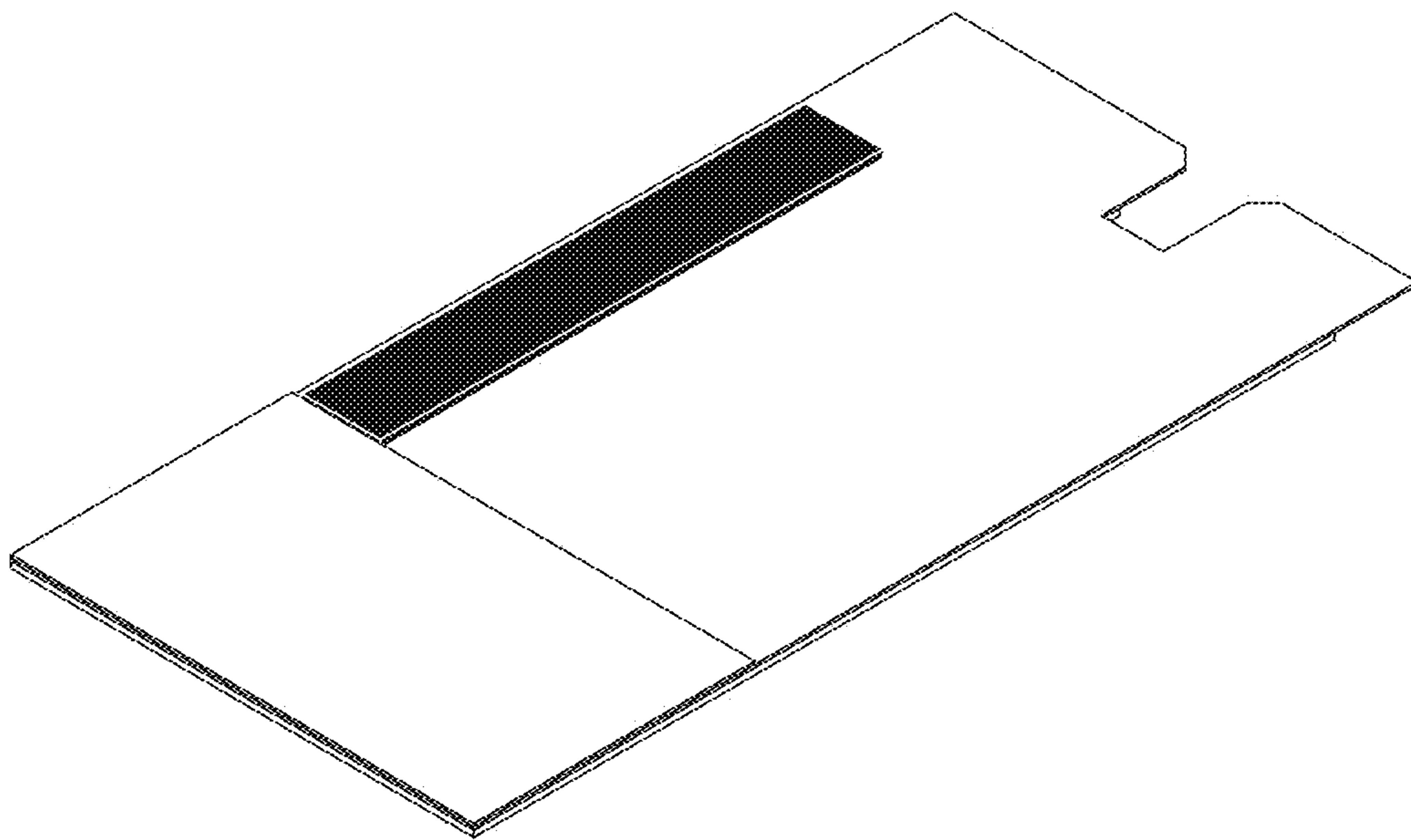

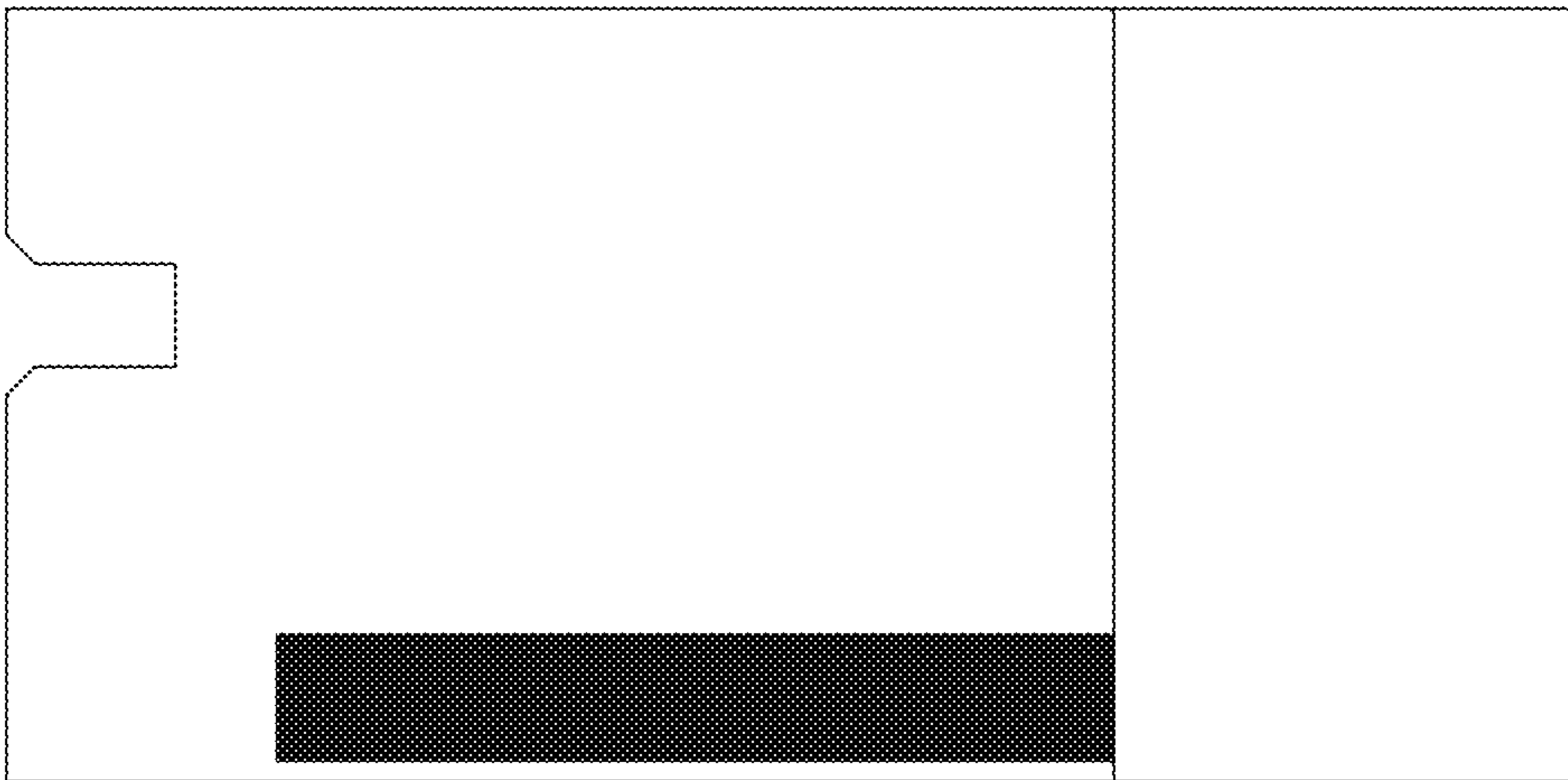

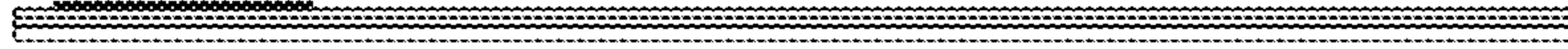

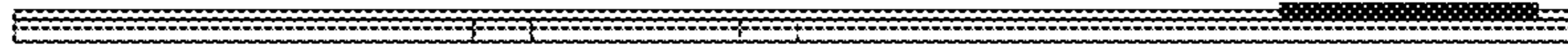

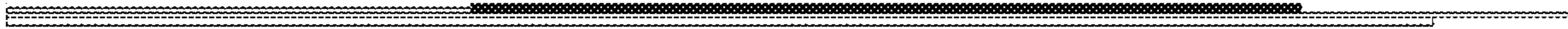

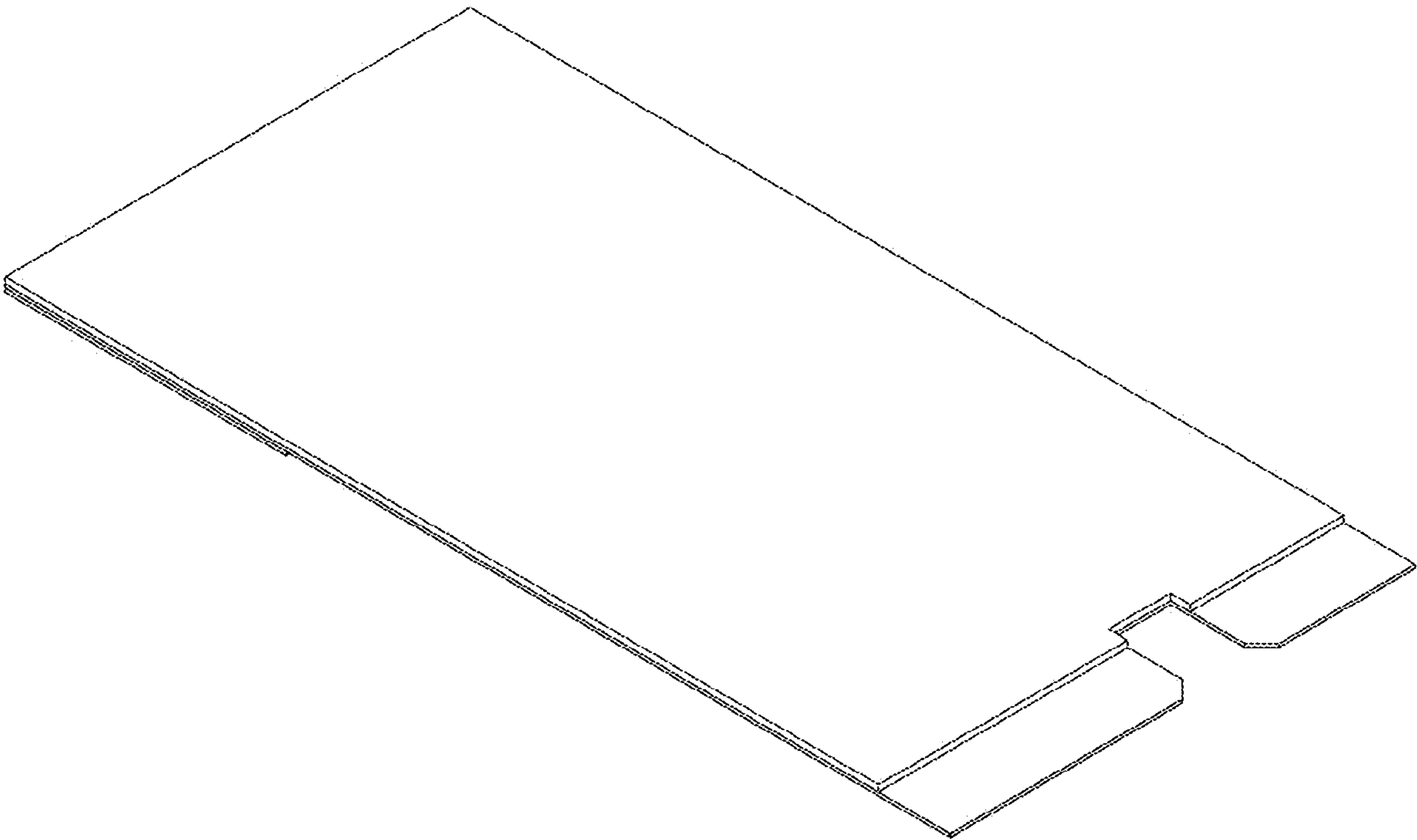
